(57) **CLAIM**

The ornamental design for feminine hygiene product package, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a feminine hygiene product package showing our new design. The medium stippled shading represents an area having a teal color. The lighter stippled shading represents an area having a lighter teal color. The darker stippled shading represents an area having a navy blue color.

FIG. 2 is a front view of the feminine hygiene product package as shown in FIG. 1;

FIG. 3 is a left side view of the feminine hygiene product package as shown in FIG. 1;

FIG. 4 is a right side view of the feminine hygiene product package as shown in FIG. 1;

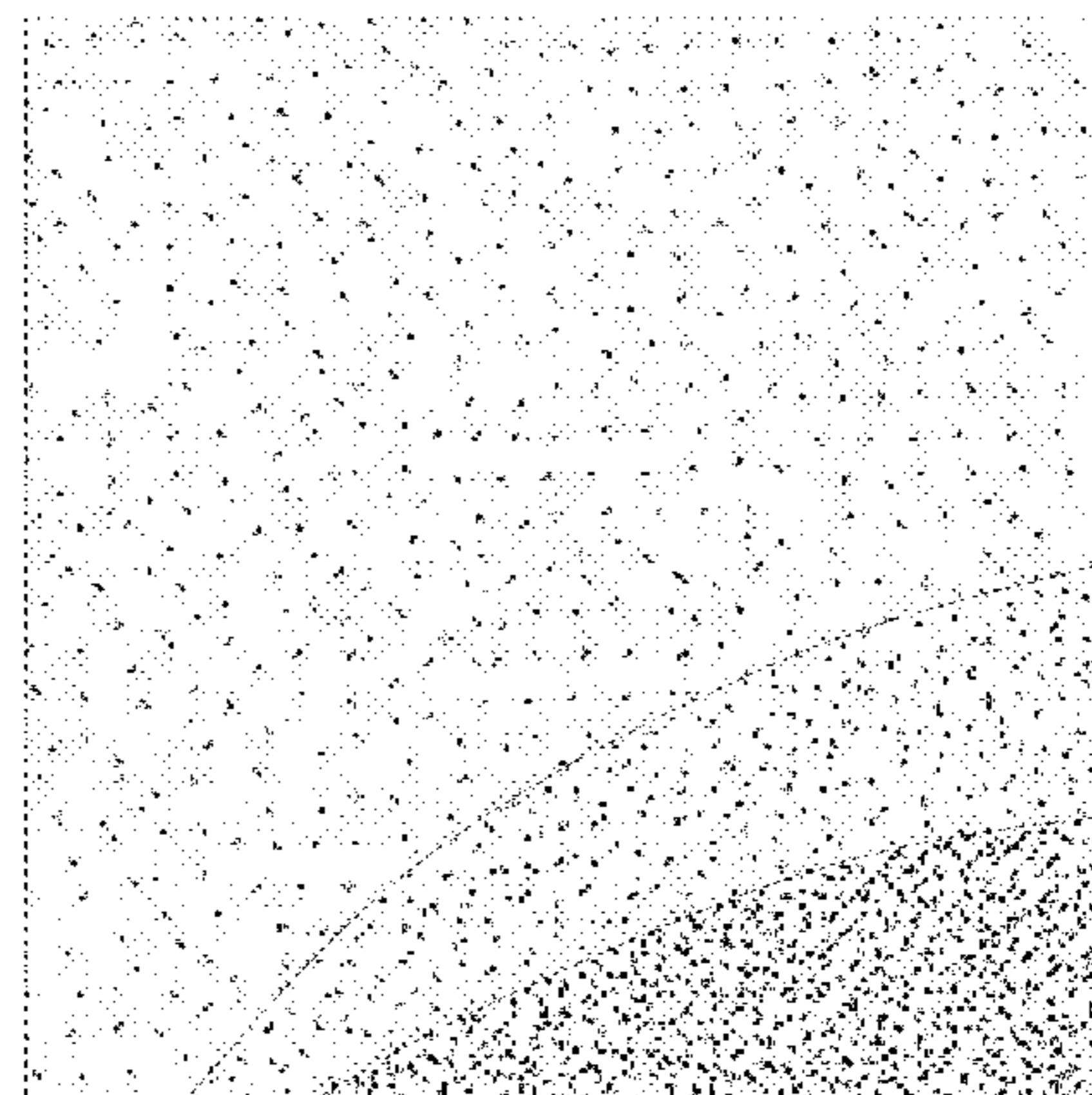
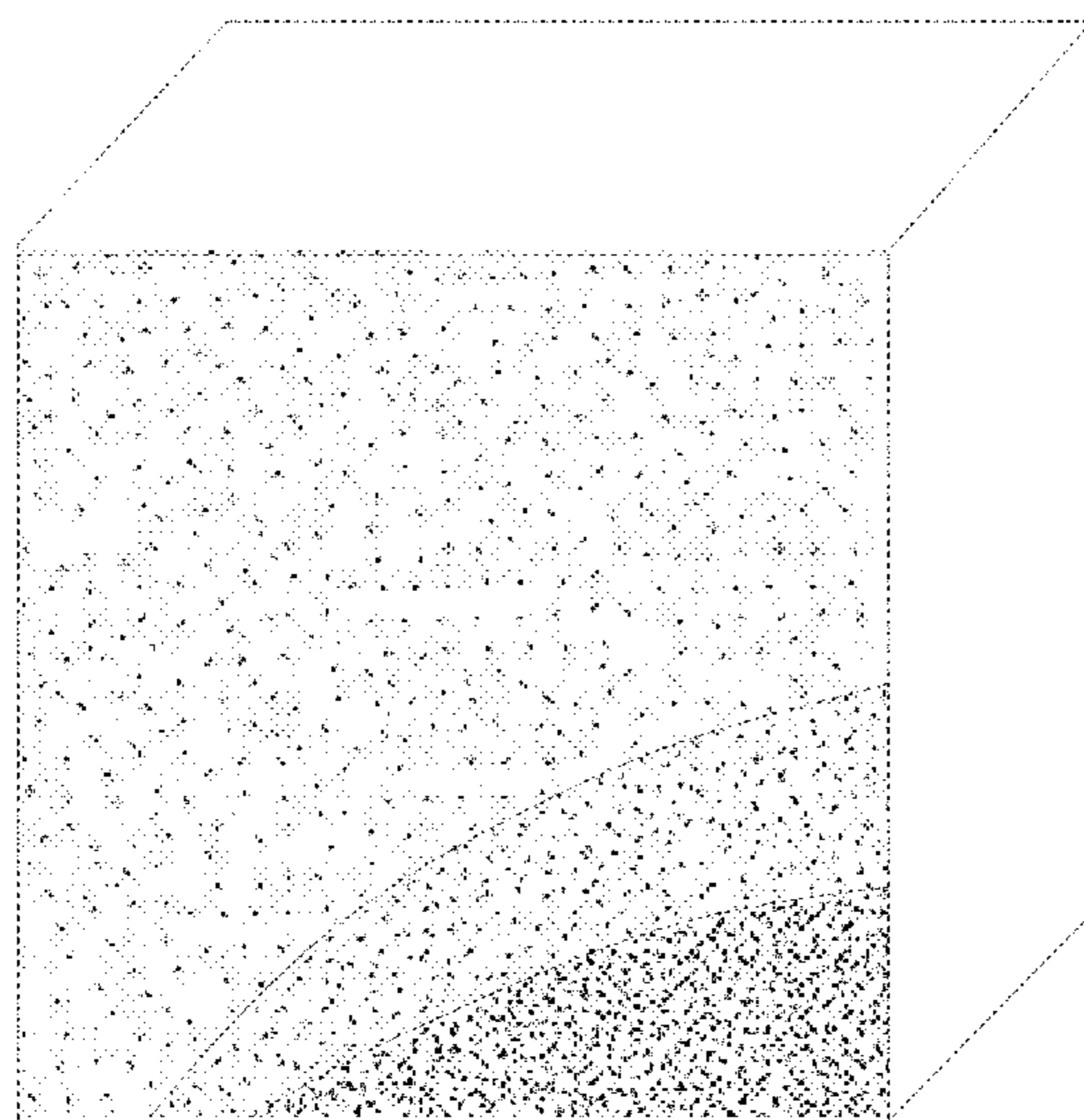
FIG. 5 is a top view of the feminine hygiene product package as shown in FIG. 1;

FIG. 6 is a bottom view of the feminine hygiene product package as shown in FIG. 1; and,

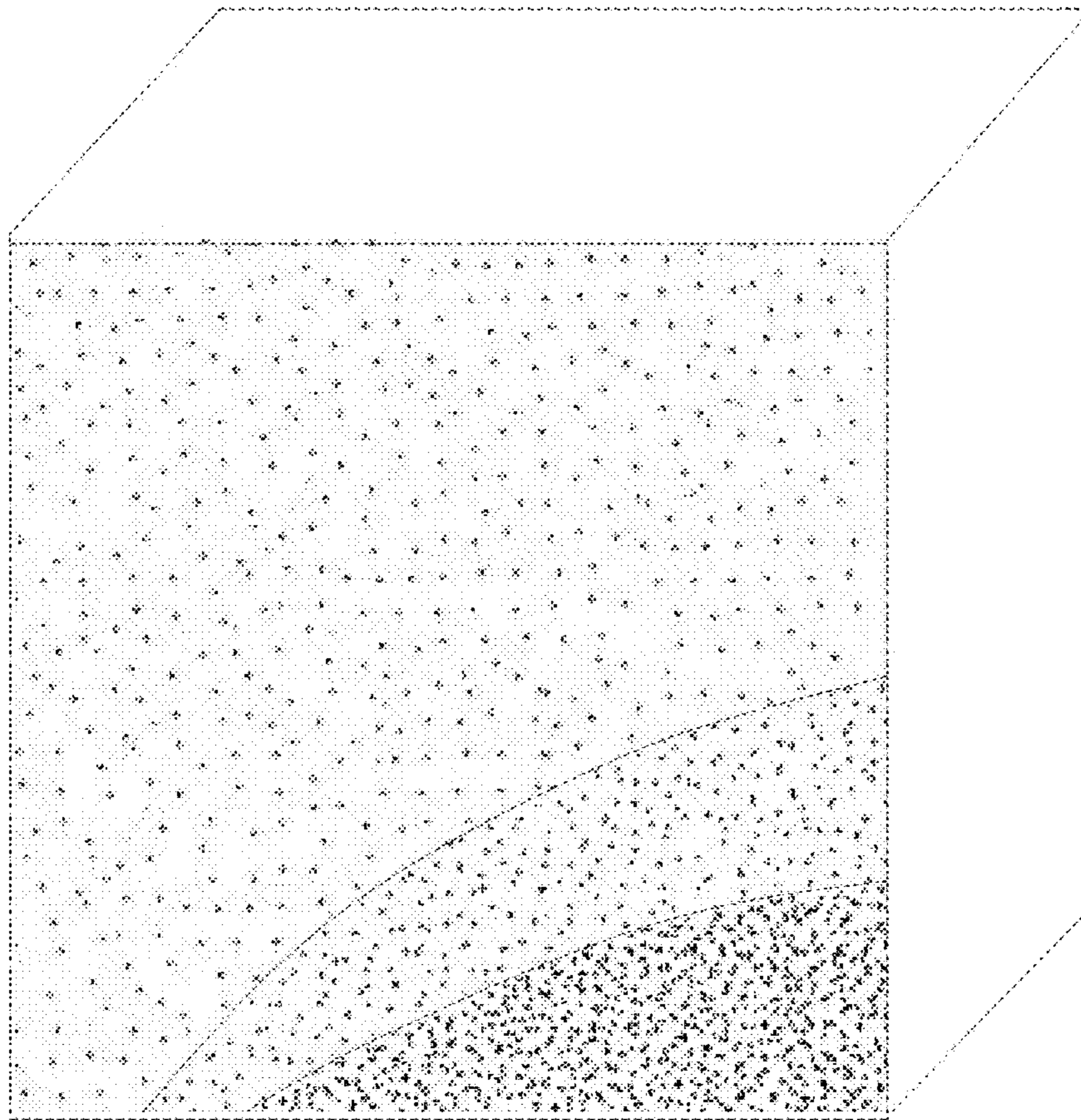

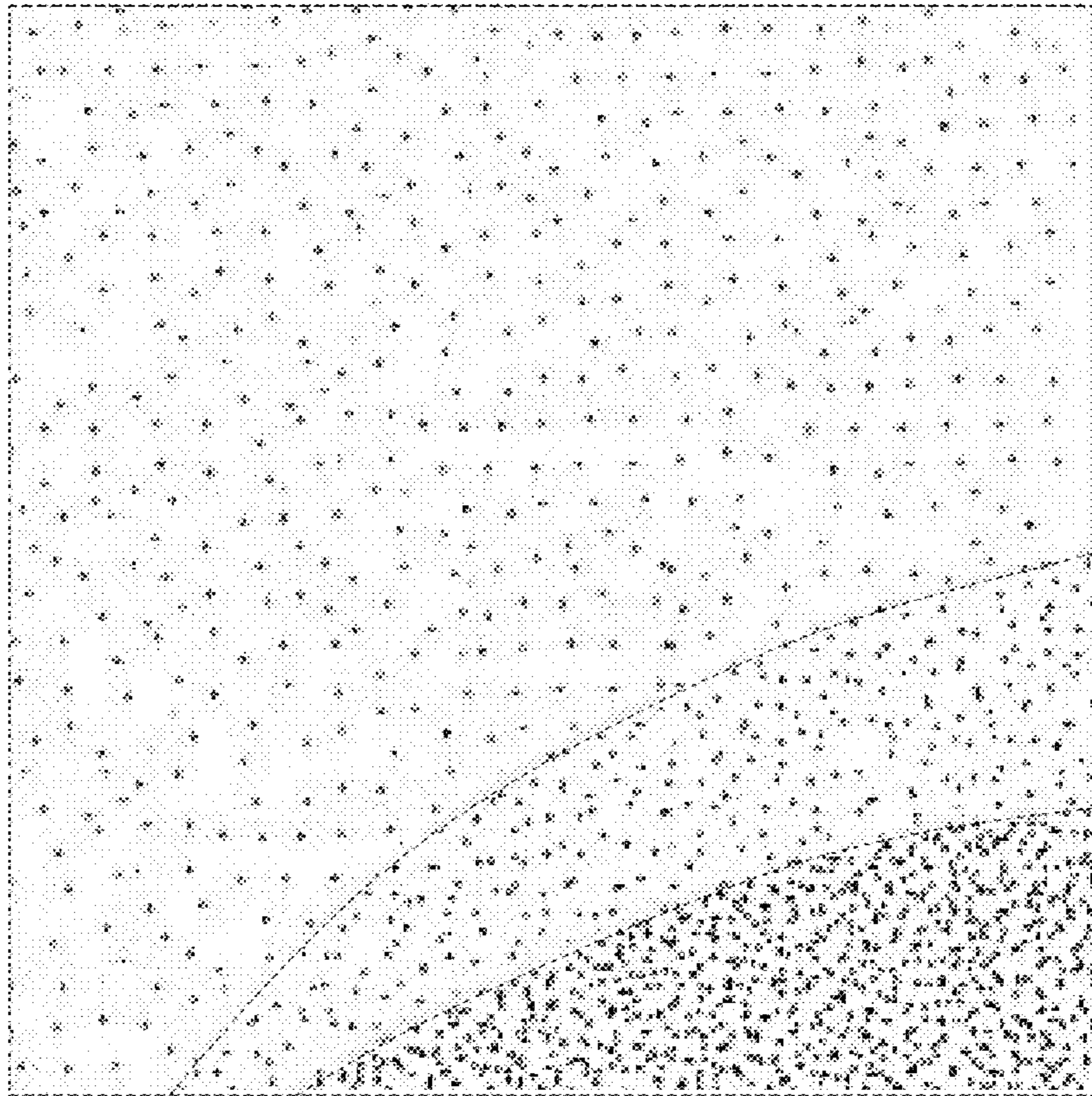

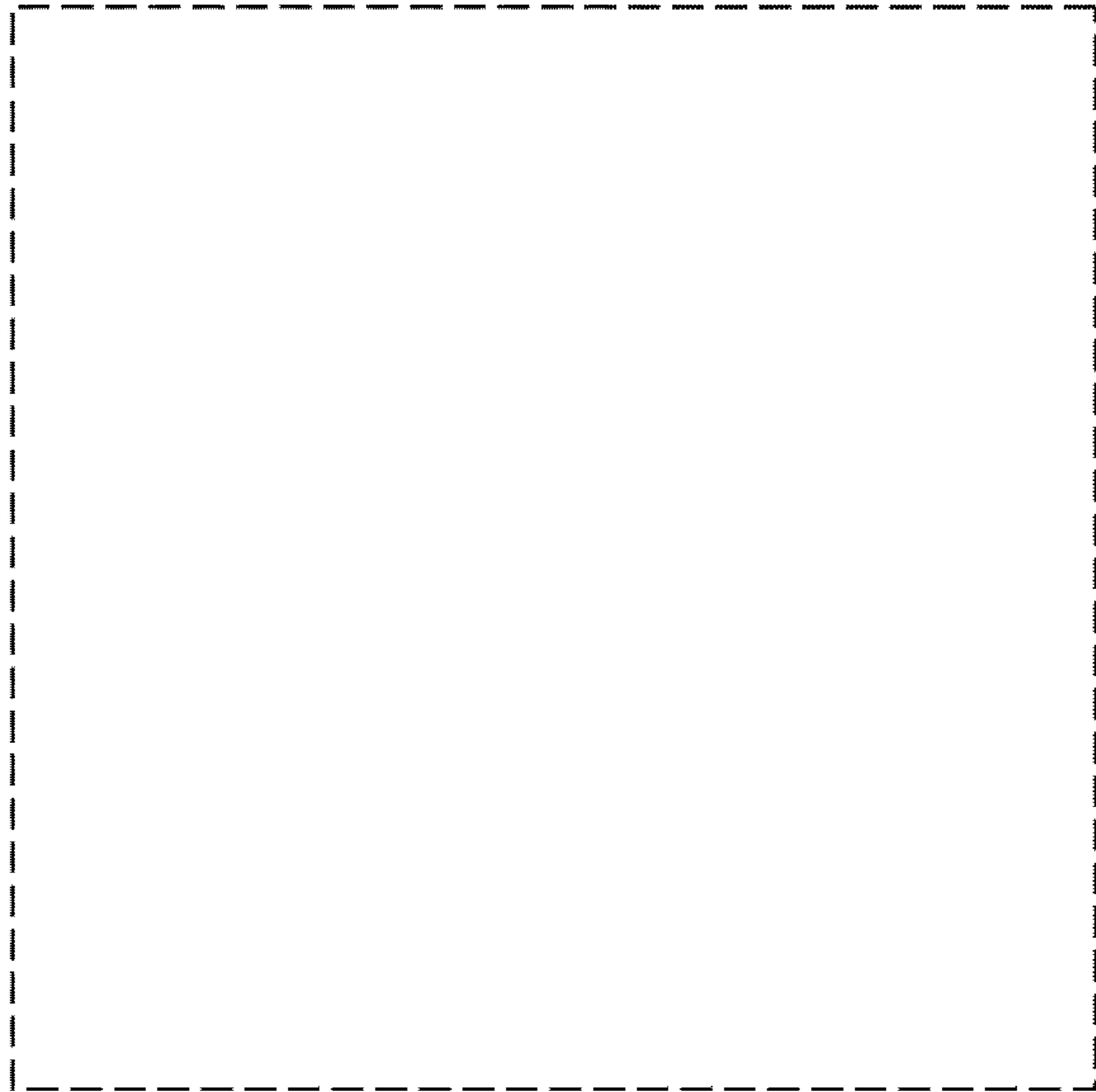
