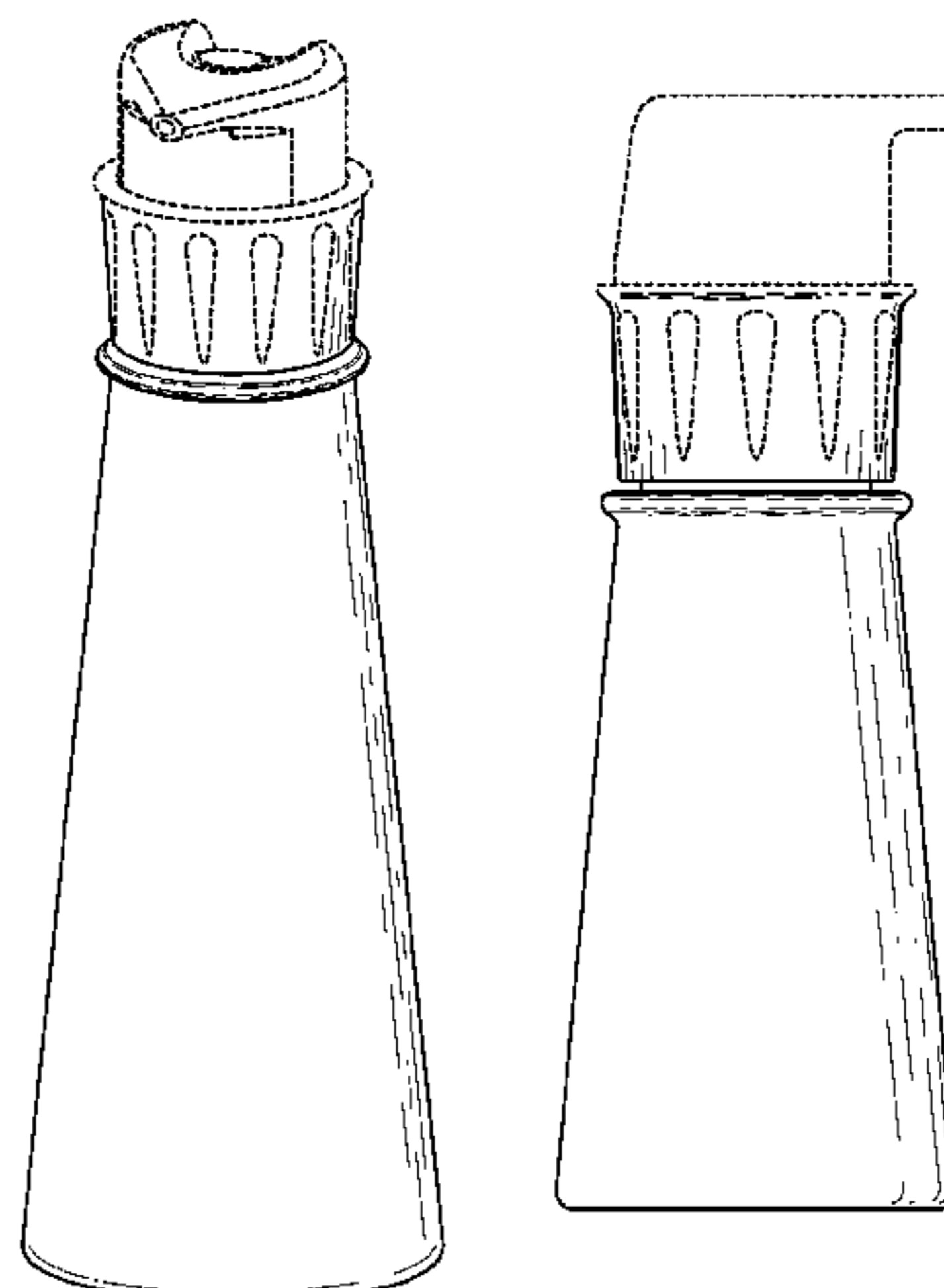
(57) **CLAIM**

The ornamental design for a bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a first embodiment of a bottle showing my new design; FIG. 2 is a side view thereof, the opposite side view being a mirror image thereof; FIG. 3 is a rear view thereof; FIG. 4 is a front view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a front perspective view of a second embodiment of a bottle showing my new design; FIG. 7 is a side view thereof, the opposite side view being a mirror image thereof; FIG. 8 is a rear view thereof; FIG. 9 is a front view thereof; and, FIG. 10 is a top plan view thereof. The dashed broken lines in the Figures are included for the purpose of illustrating portions of the bottle and/or associated environmental structure that form no part of the claimed design.

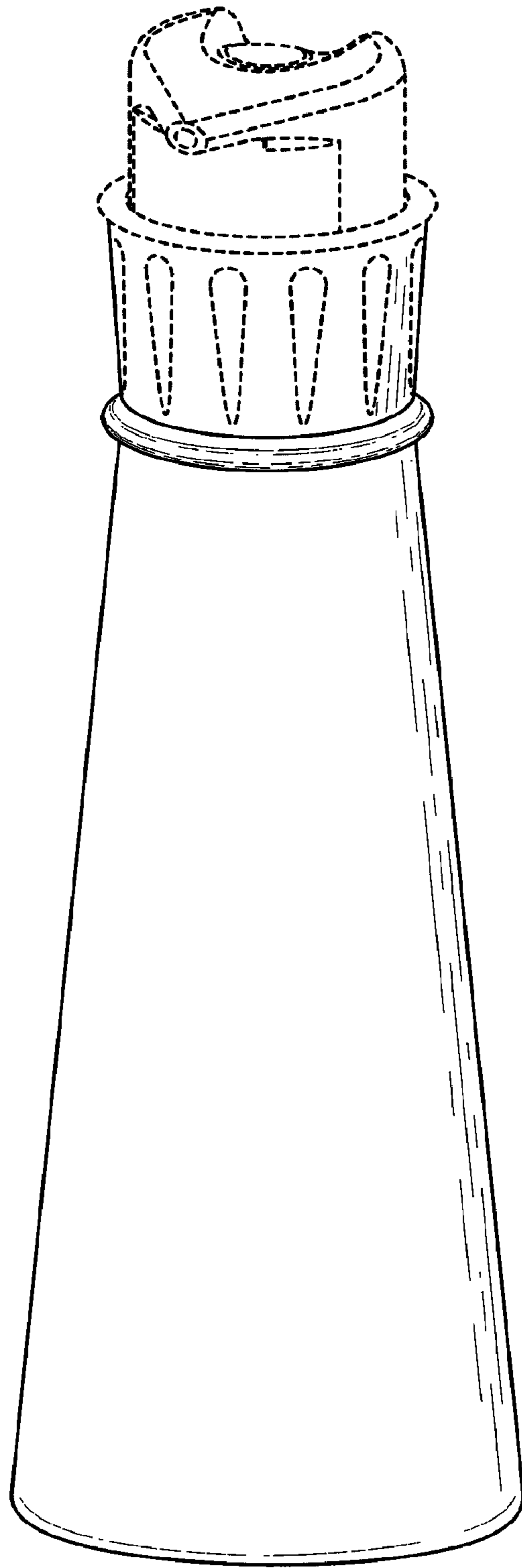

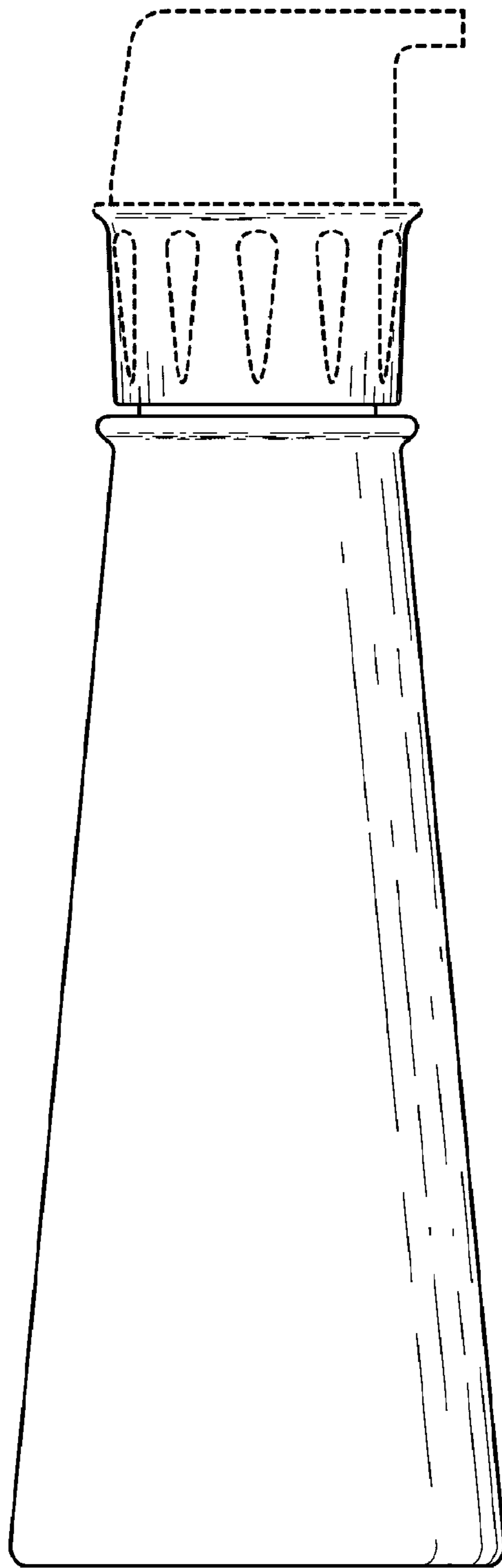

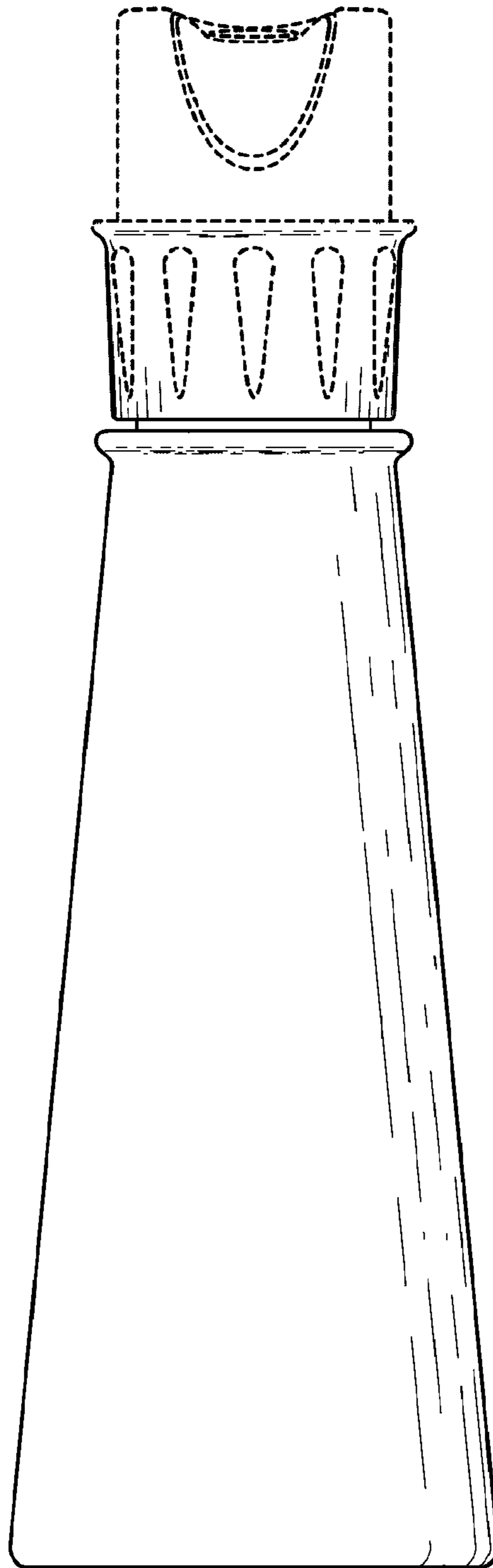

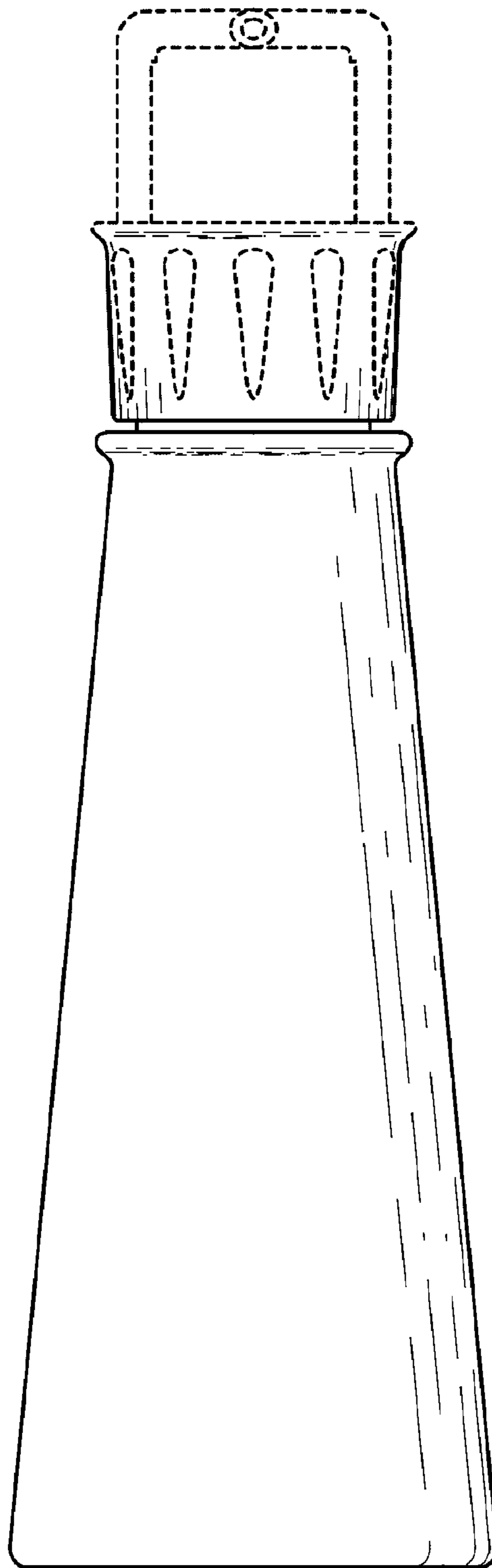

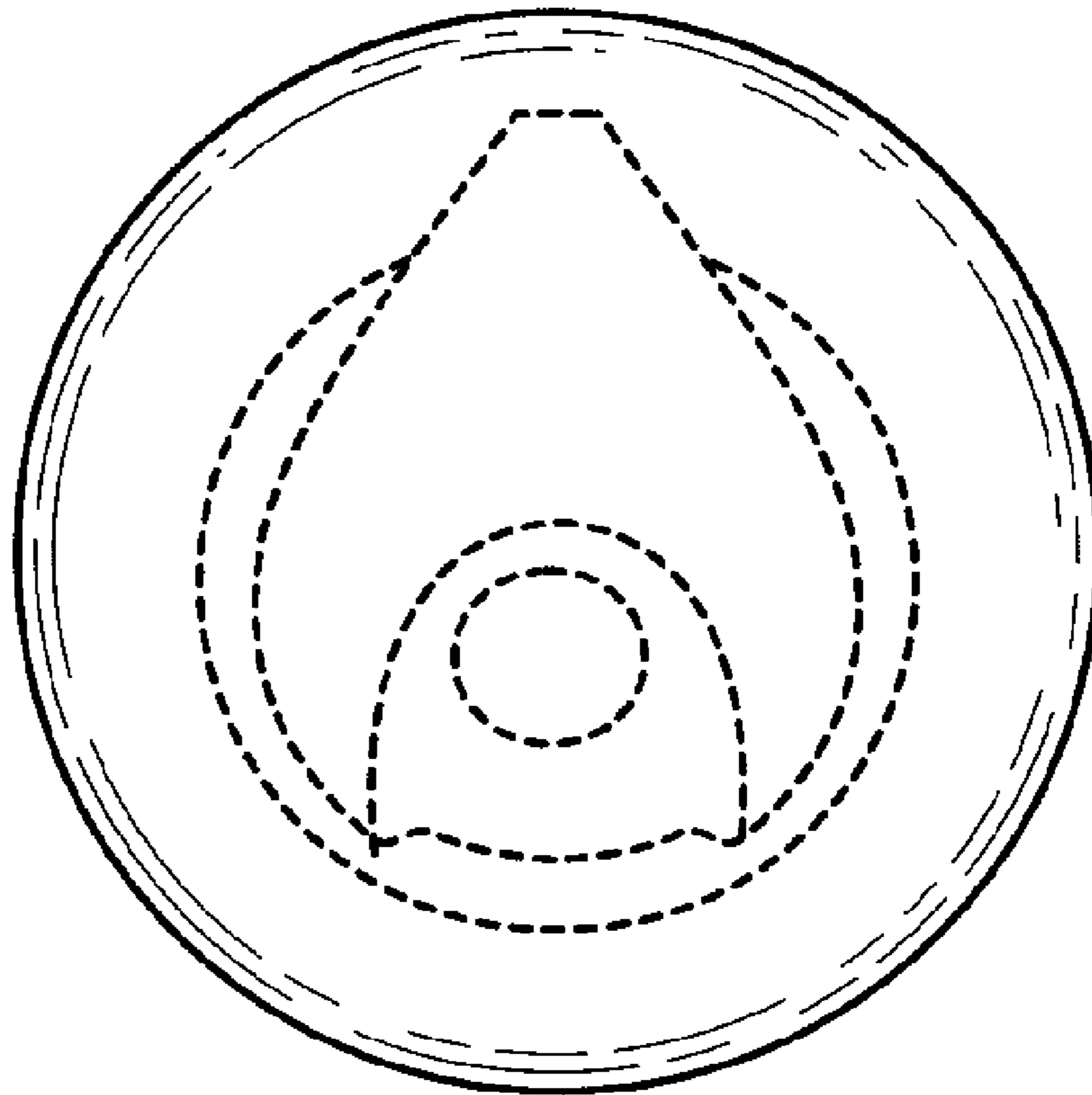

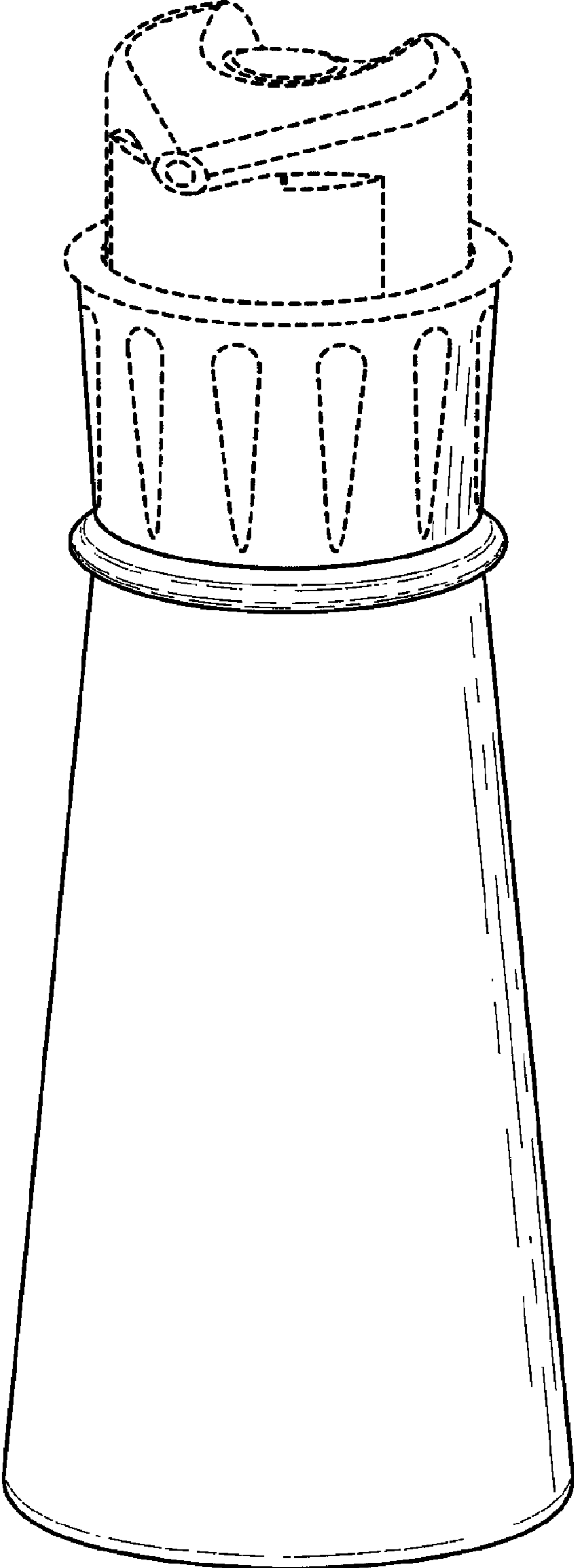

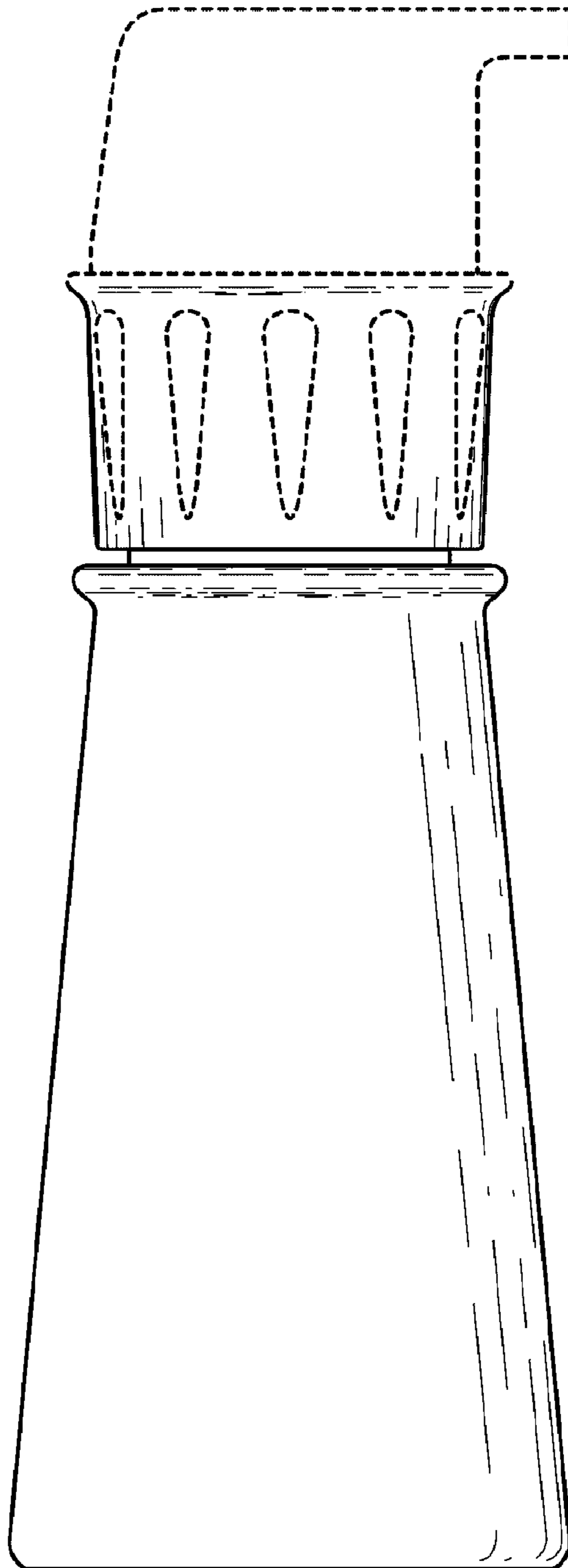

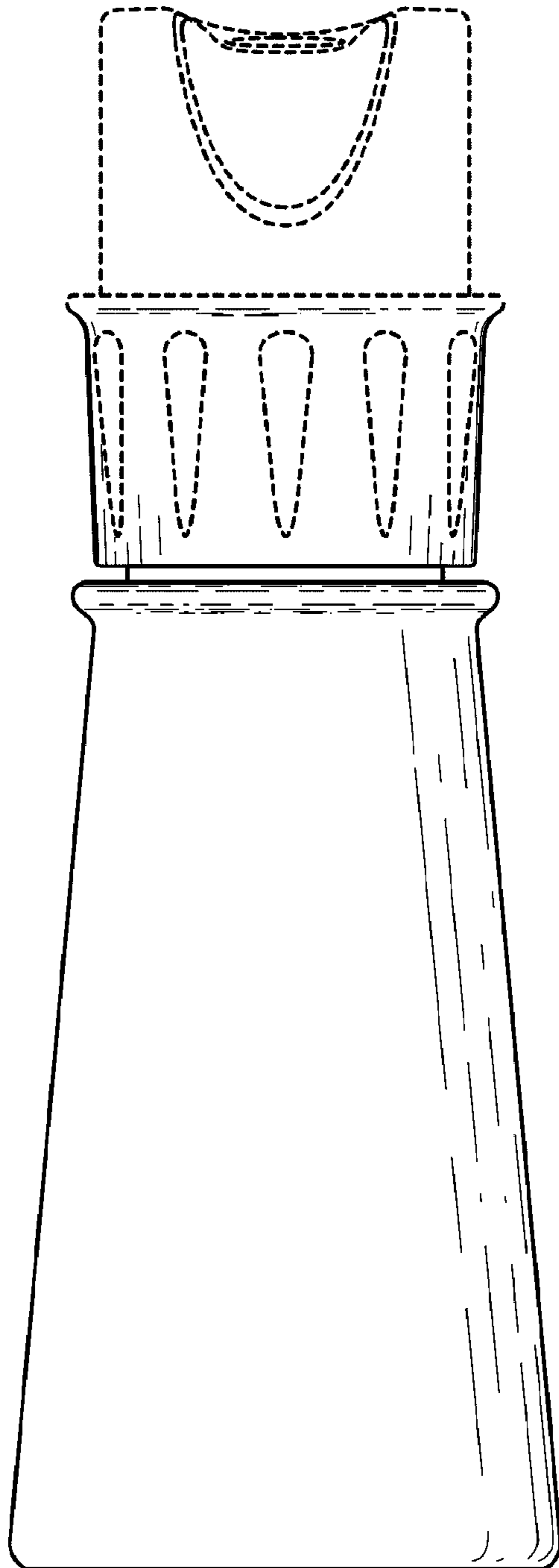

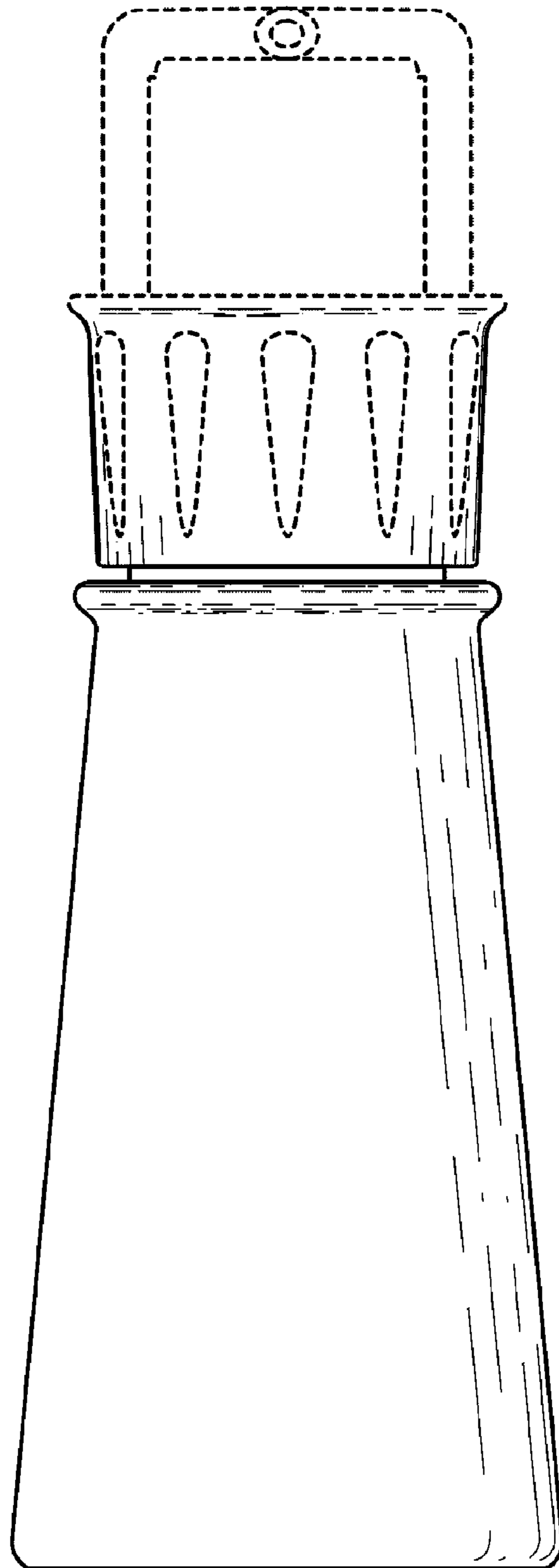




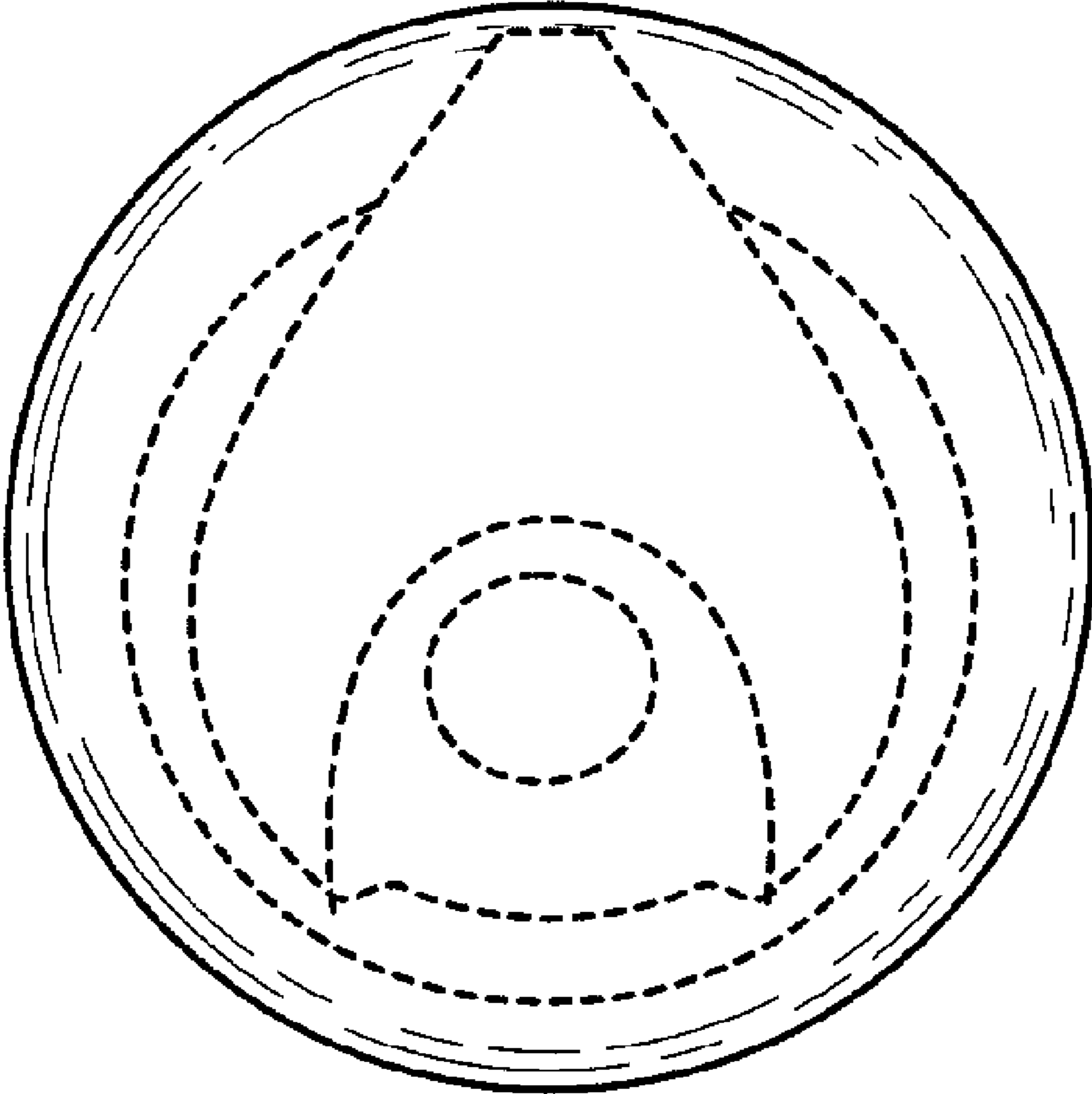
