(57) **CLAIM**

The ornamental design for a cellular phone casing, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a cellular phone casing showing our new design;

FIG. 2 is a bottom plan view of the cellular phone casing;

FIG. 3 is a top plan view of the cellular phone casing;

FIG. 4 is a first side view of the cellular phone casing;

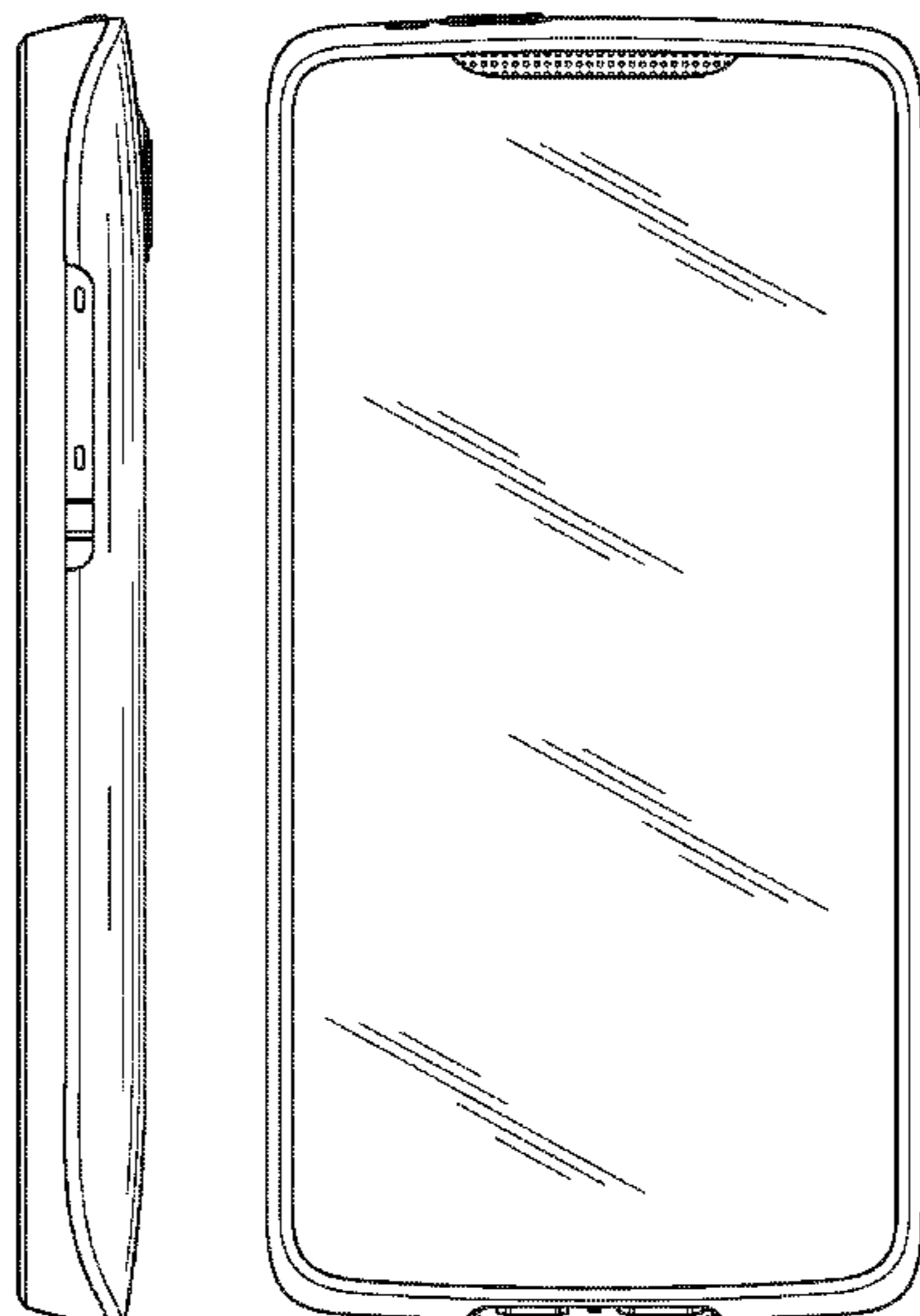
FIG. 5 is a second side view of the cellular phone casing;

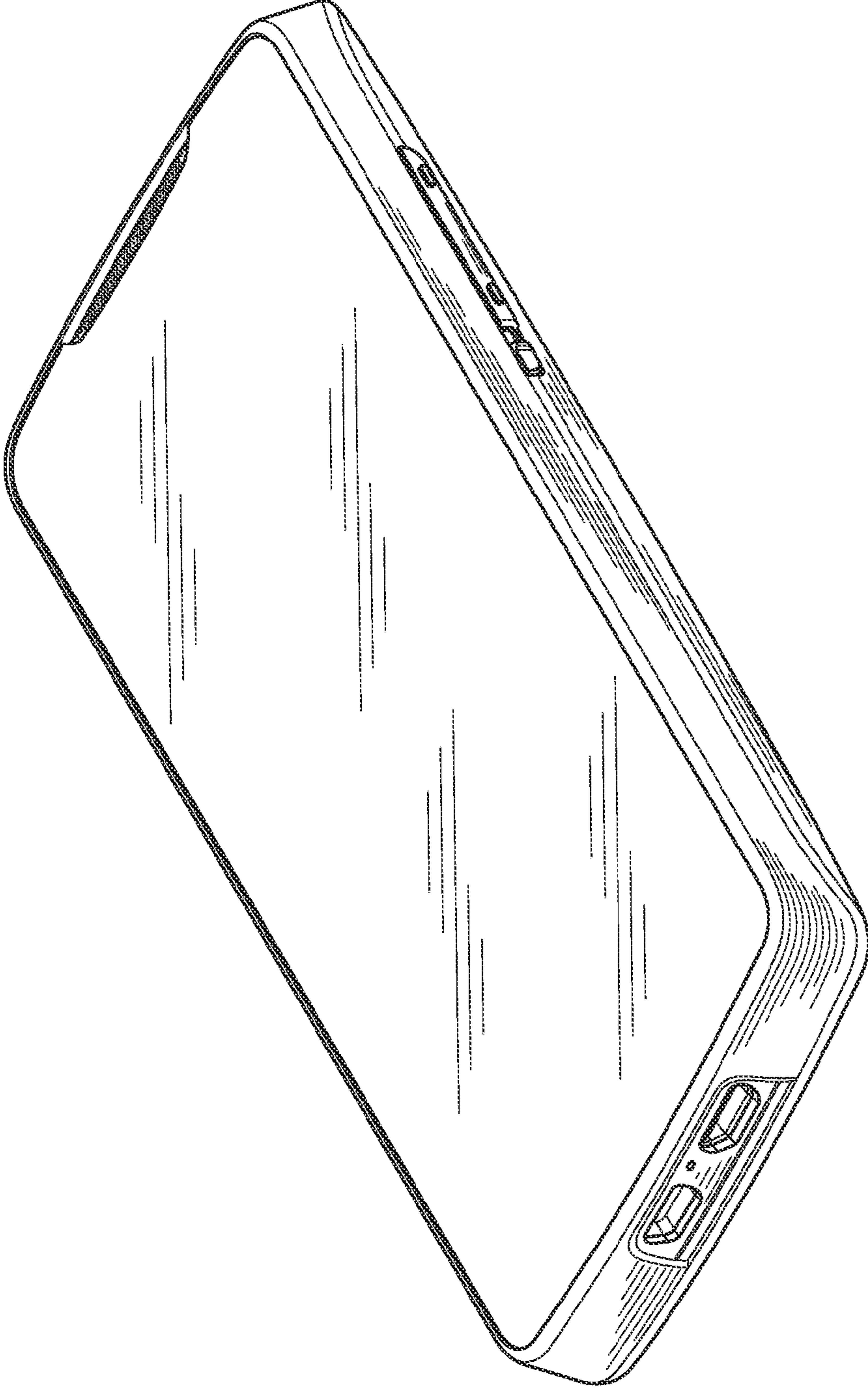

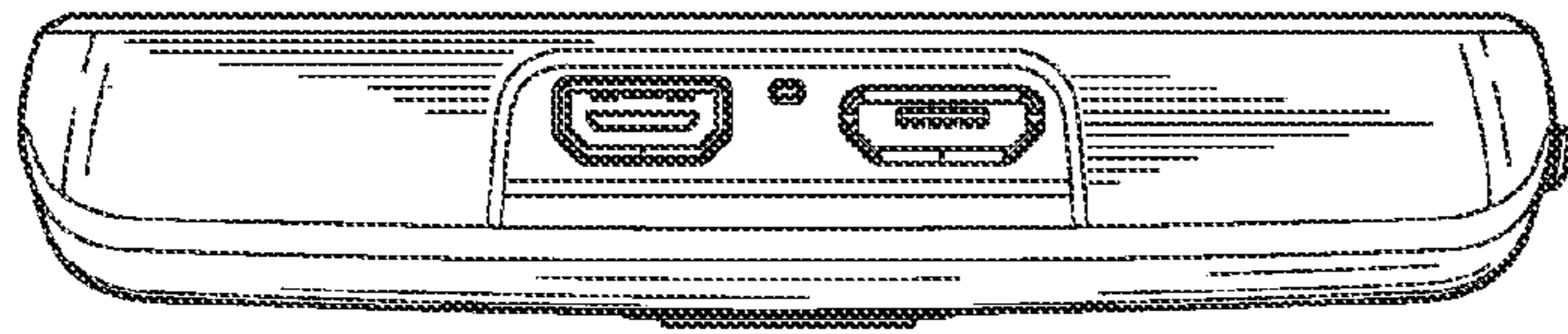

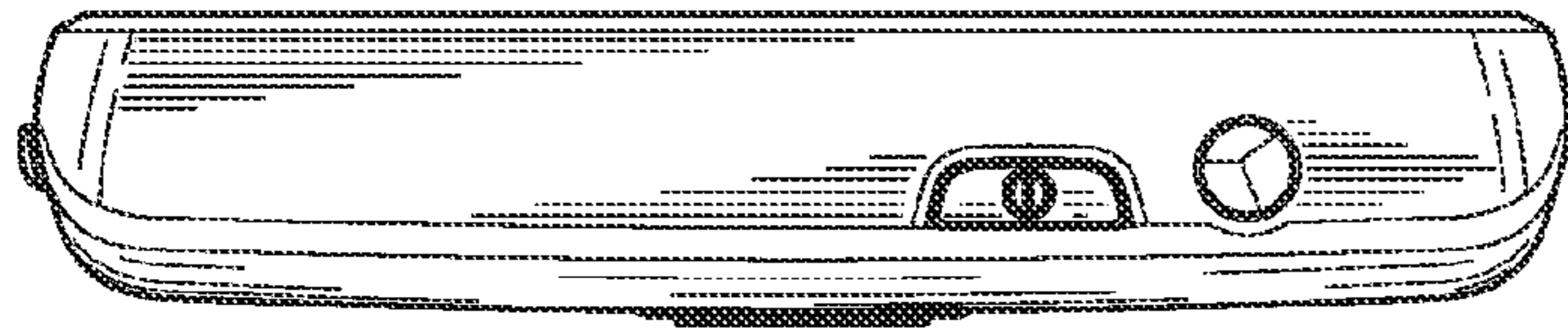

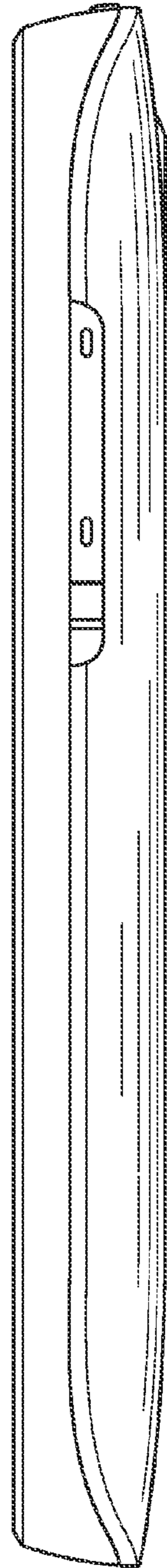

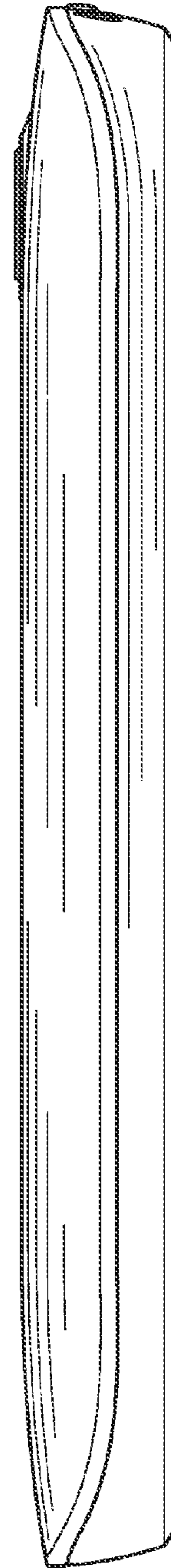

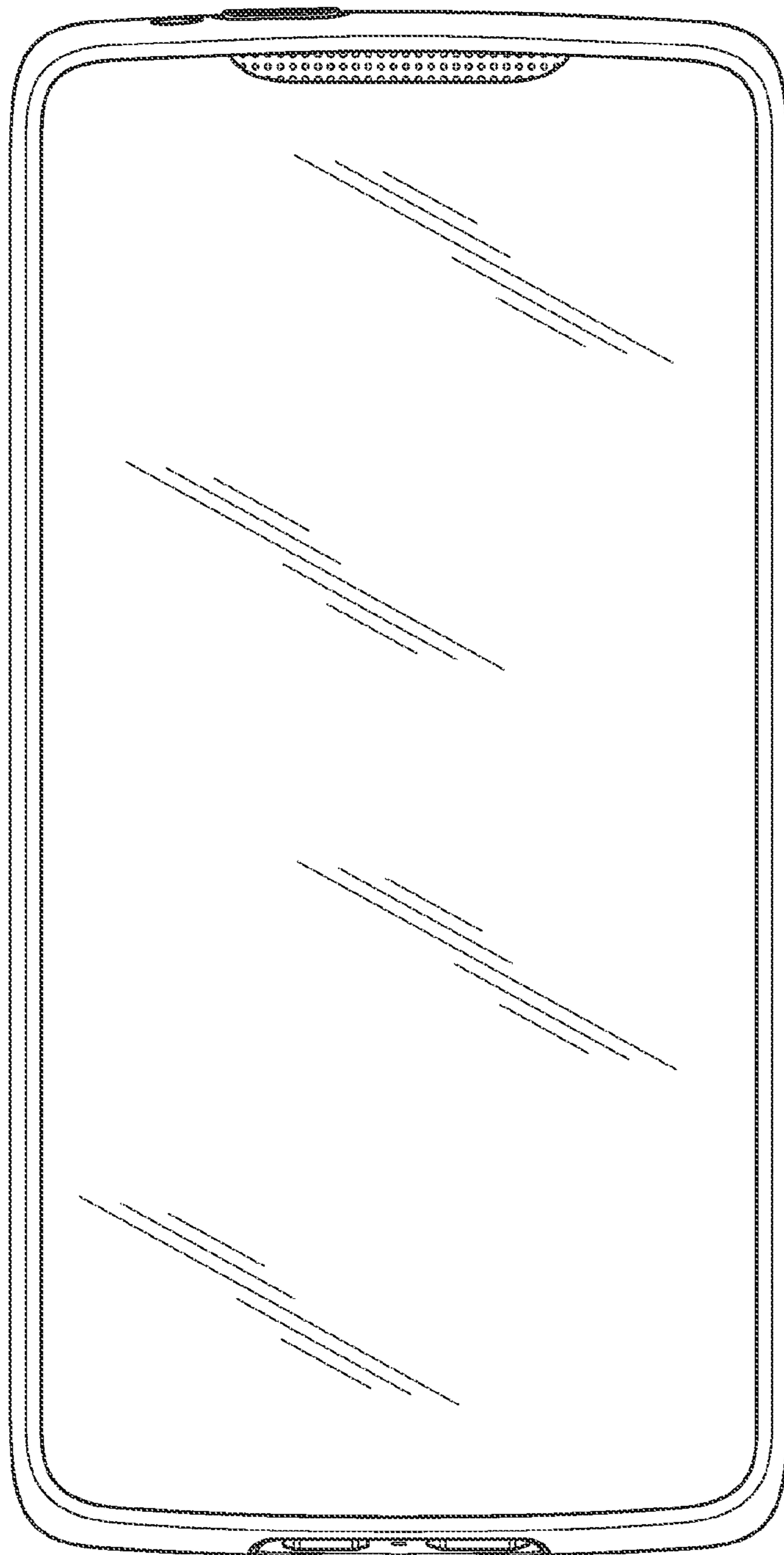

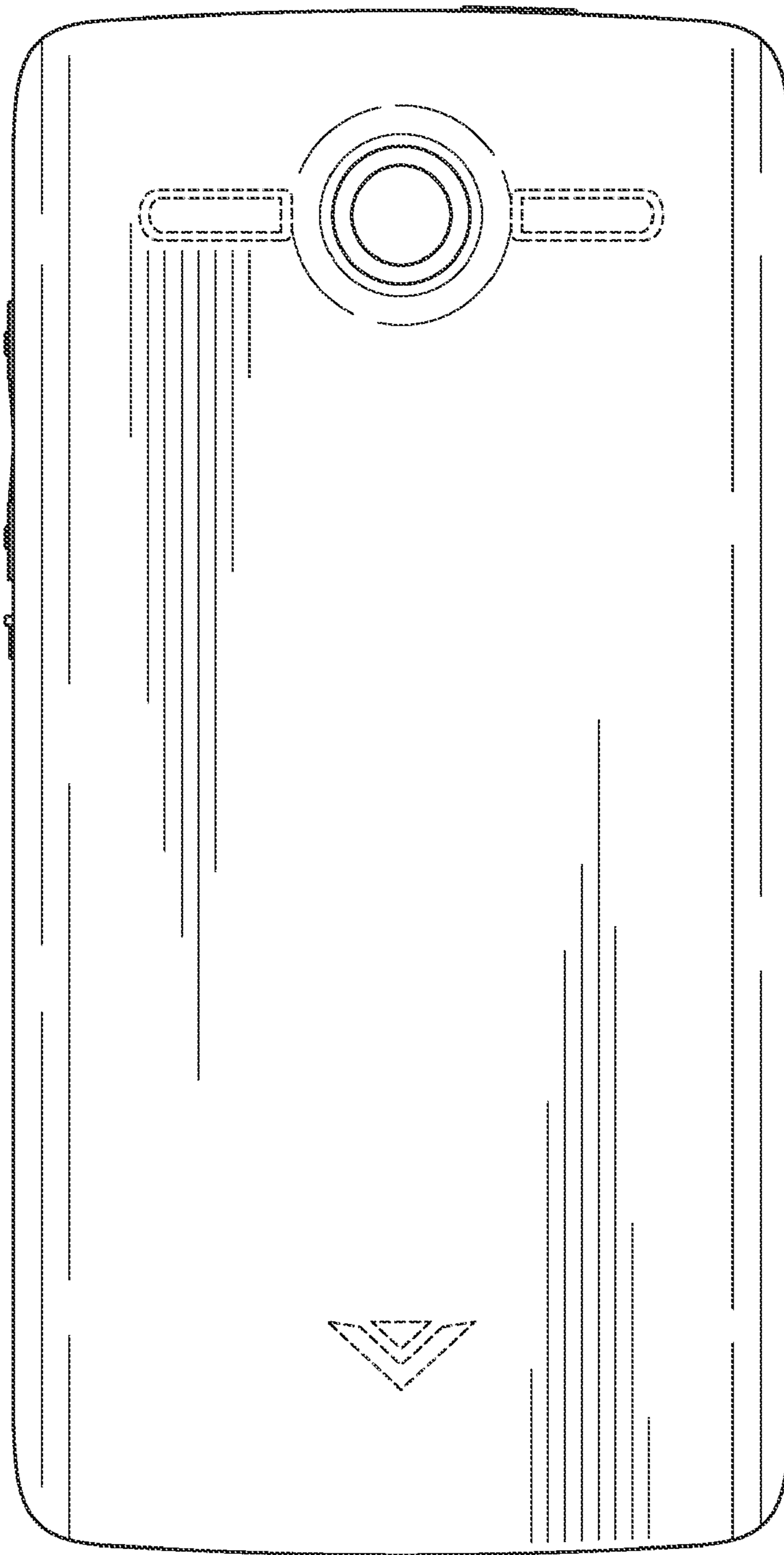
