(57) **CLAIM**

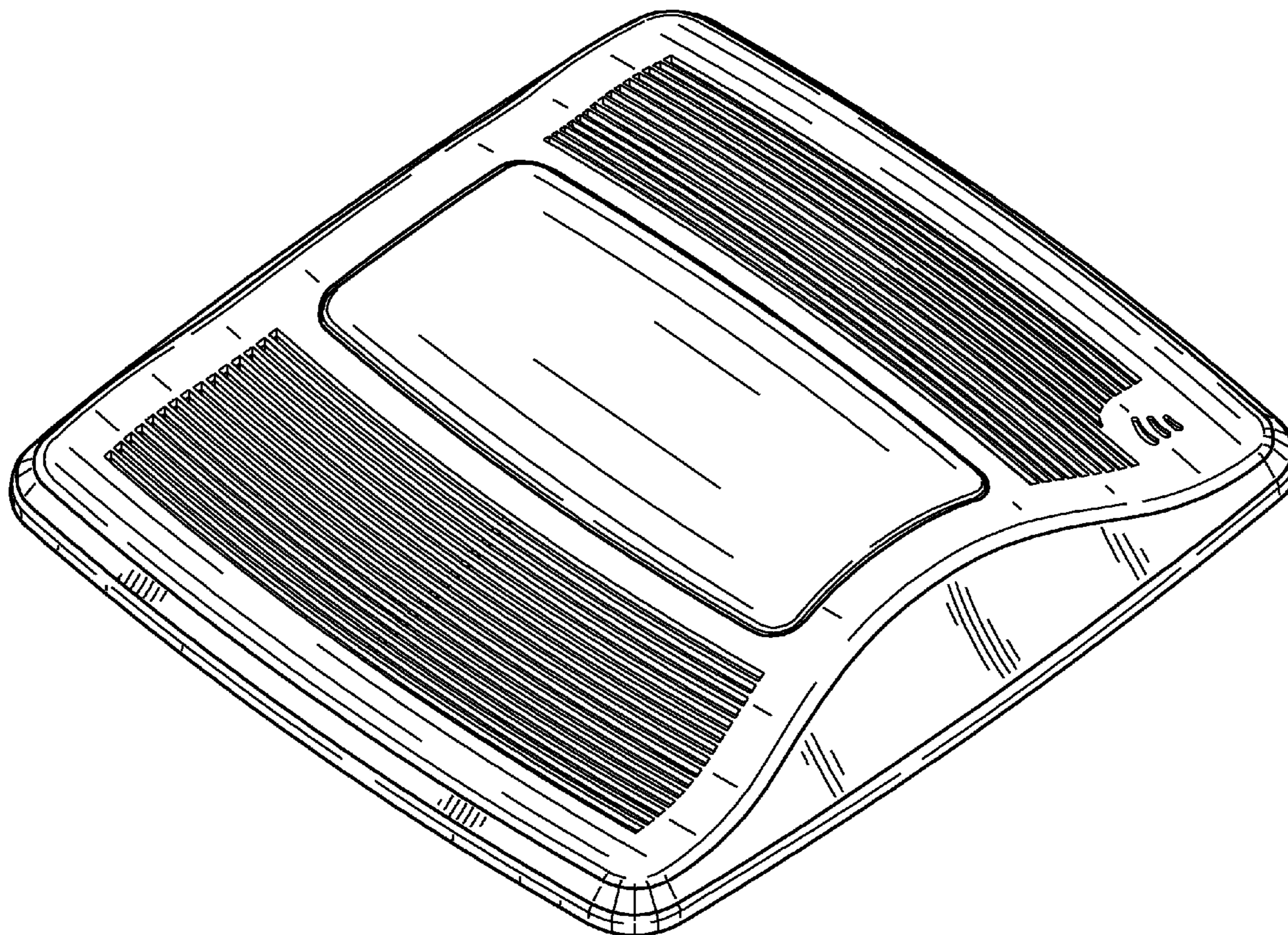
We claim the ornamental design for a grille, as shown and described.

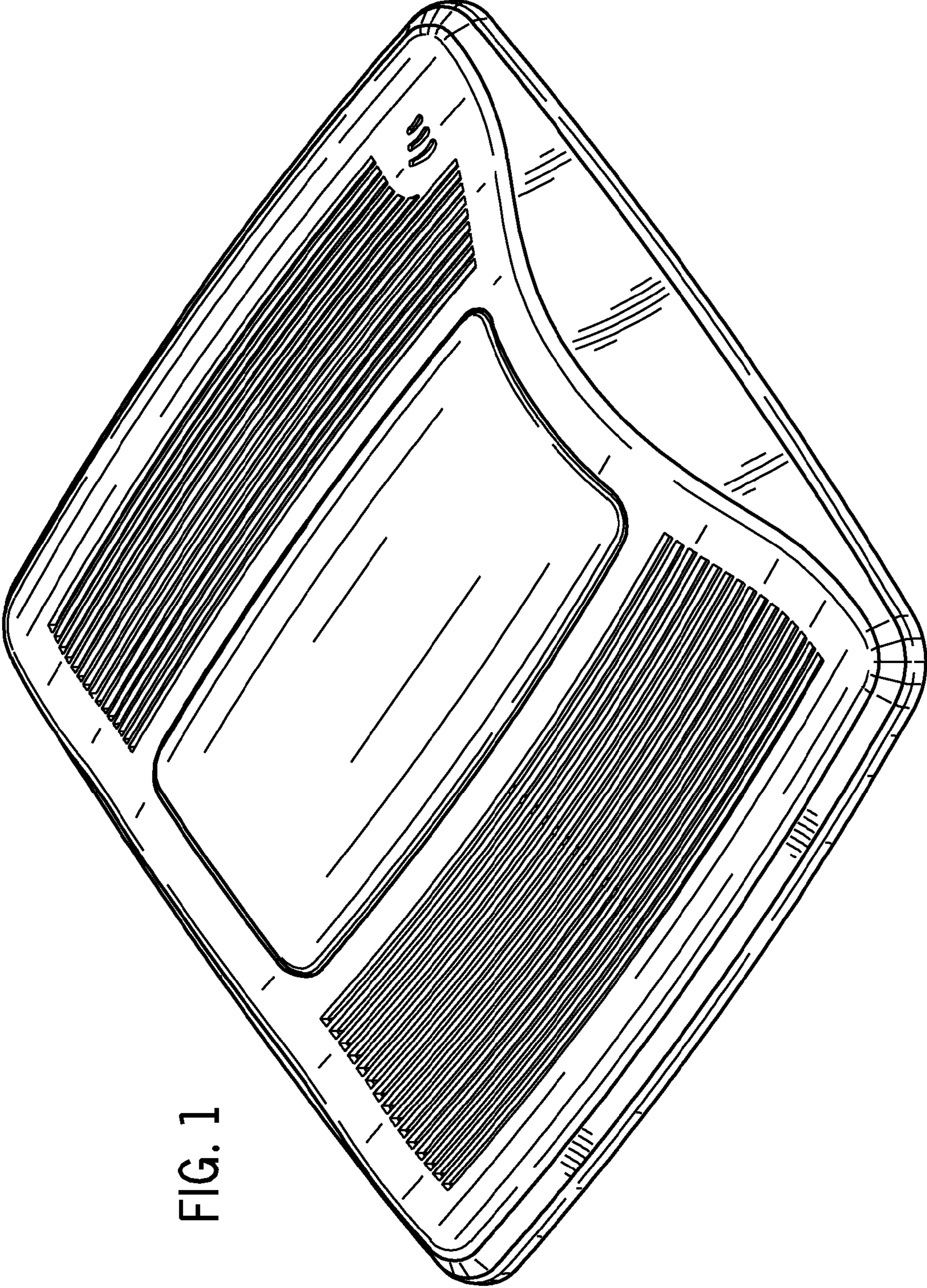

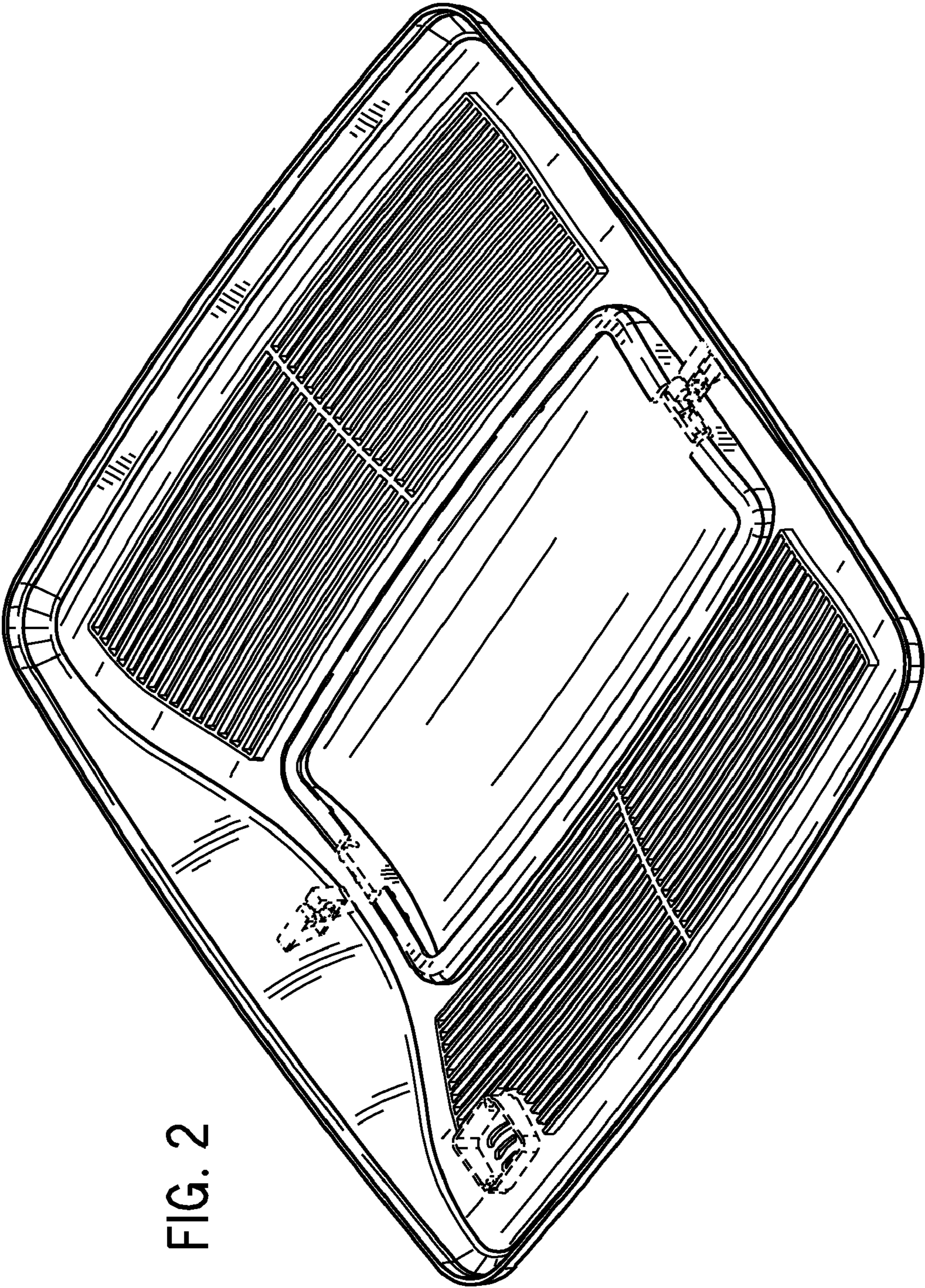

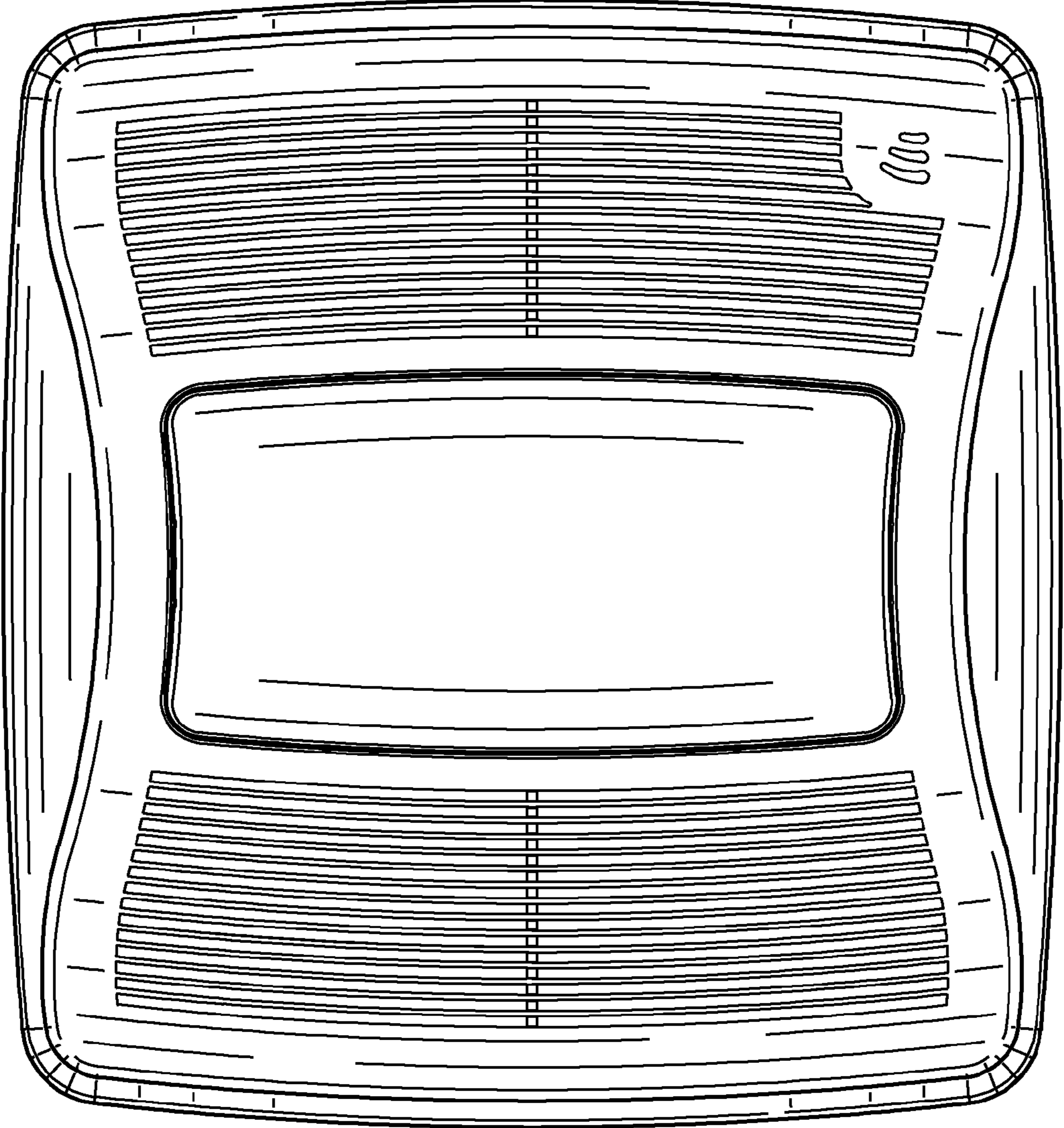

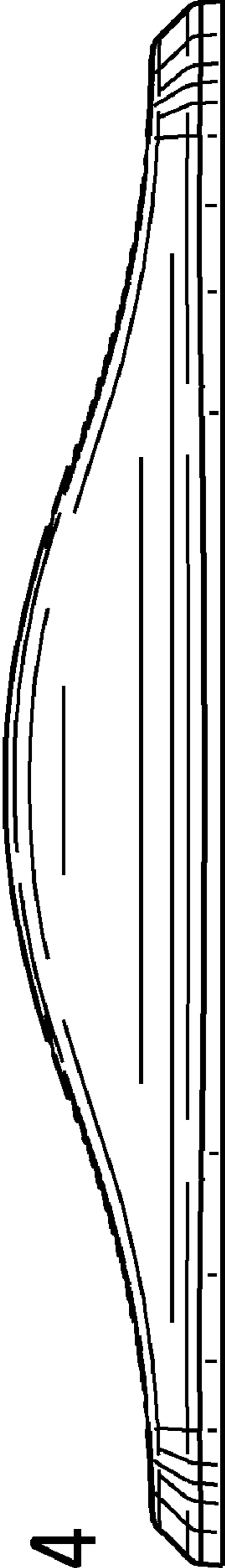

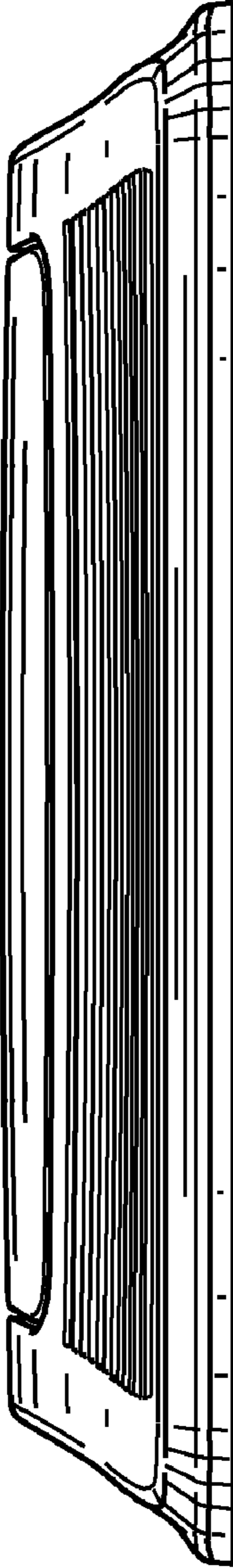

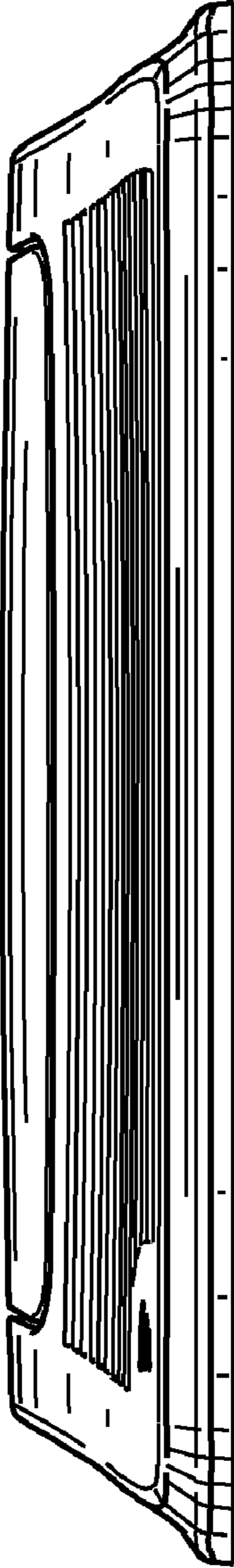

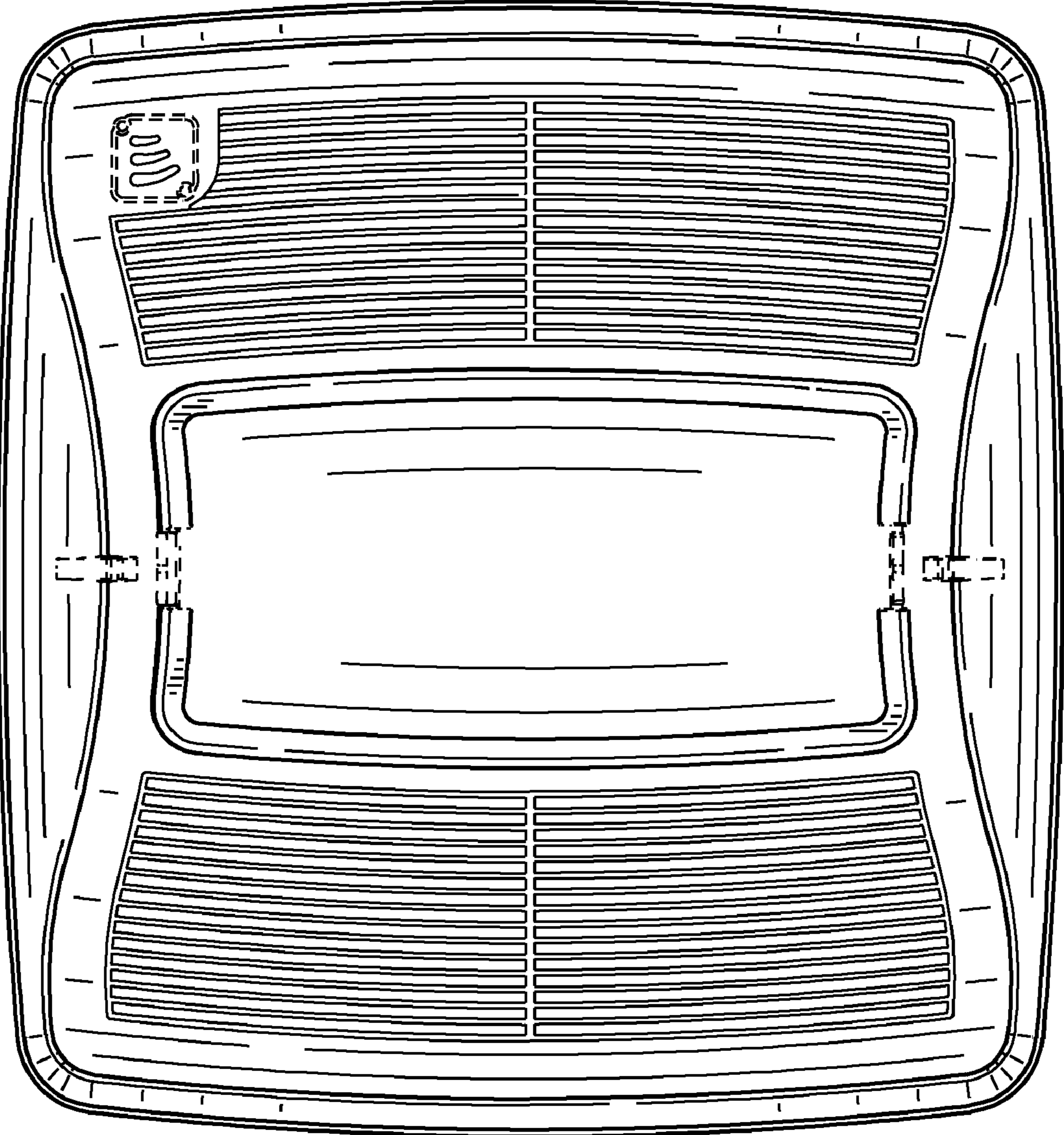
