FIG. 2 is a front view of the light device;

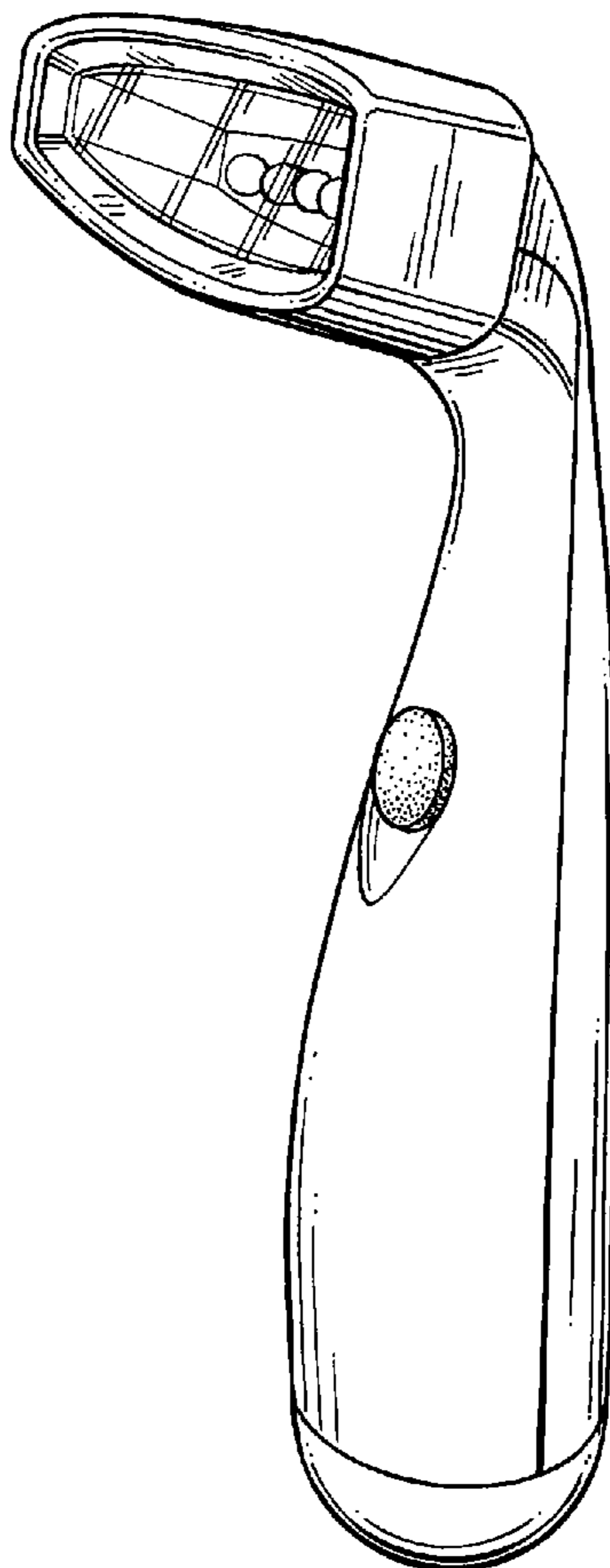
FIG. 3 is a rear view of the light device;

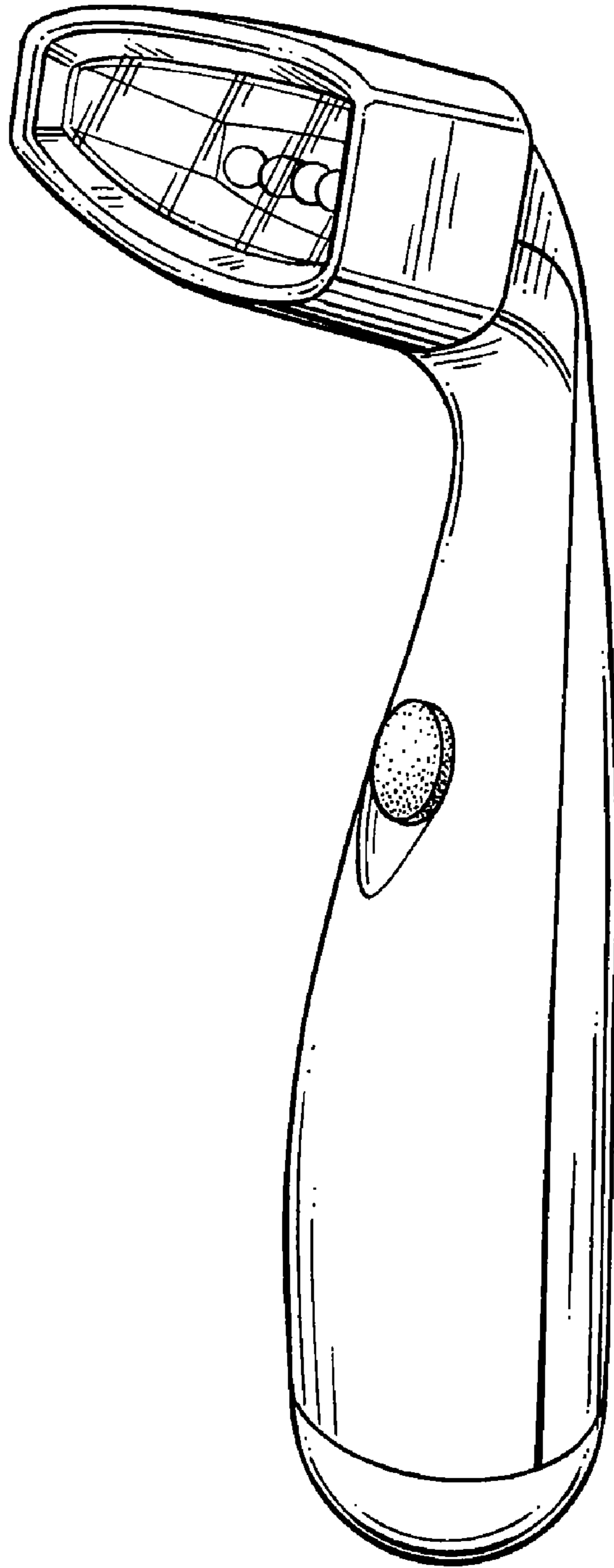
FIG. 4 is a left side view of the light device;

FIG. 5 is a top view of the light device; and,

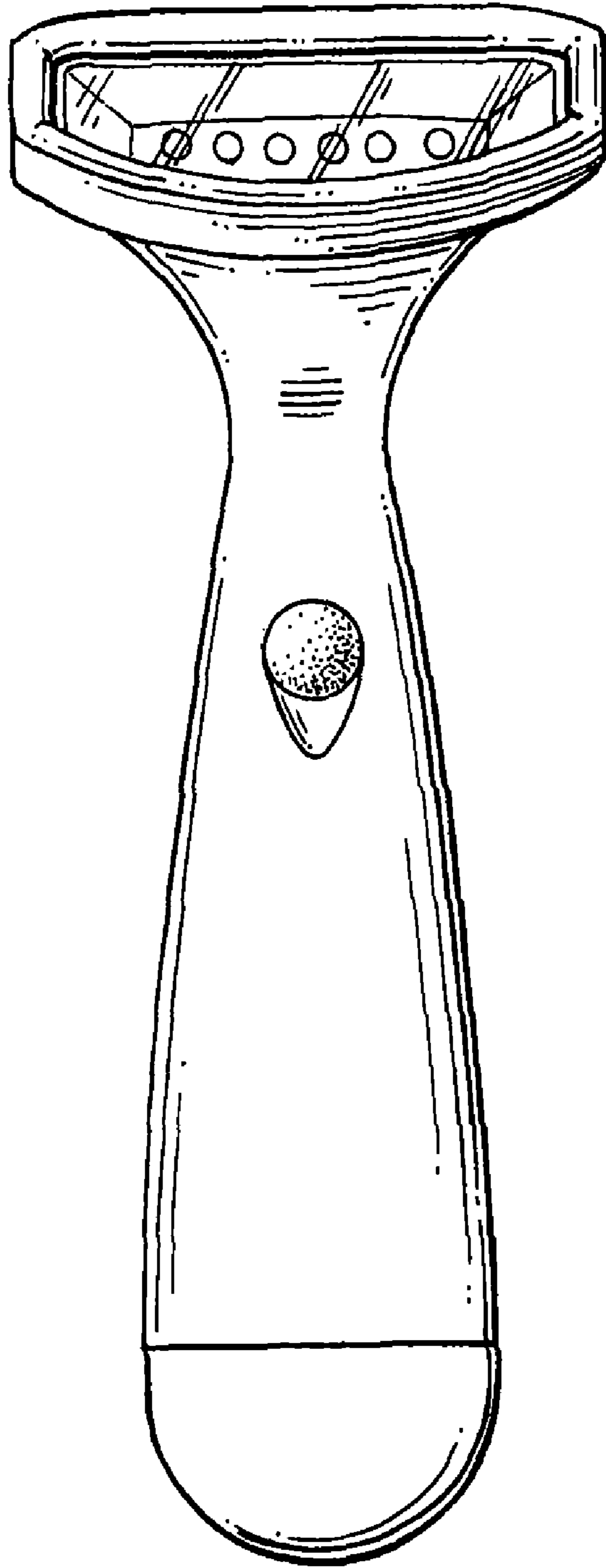
FIG. 6 is a bottom view of the light device.

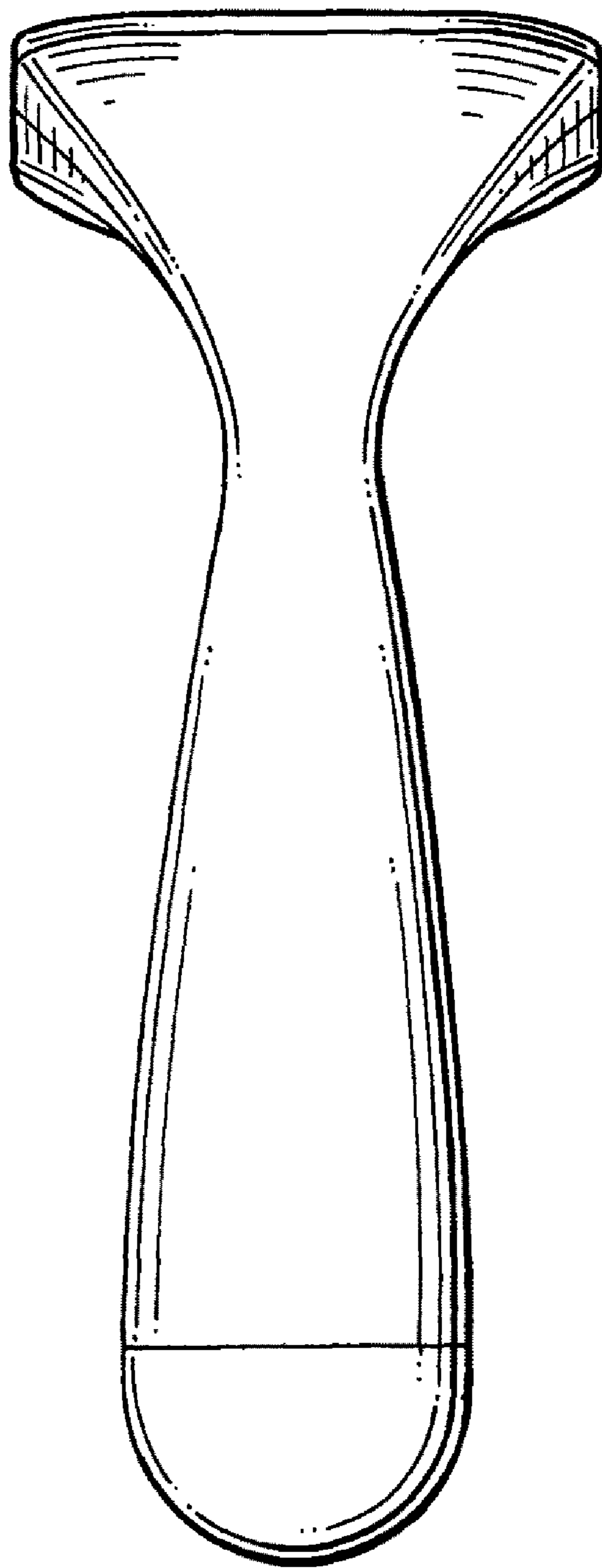




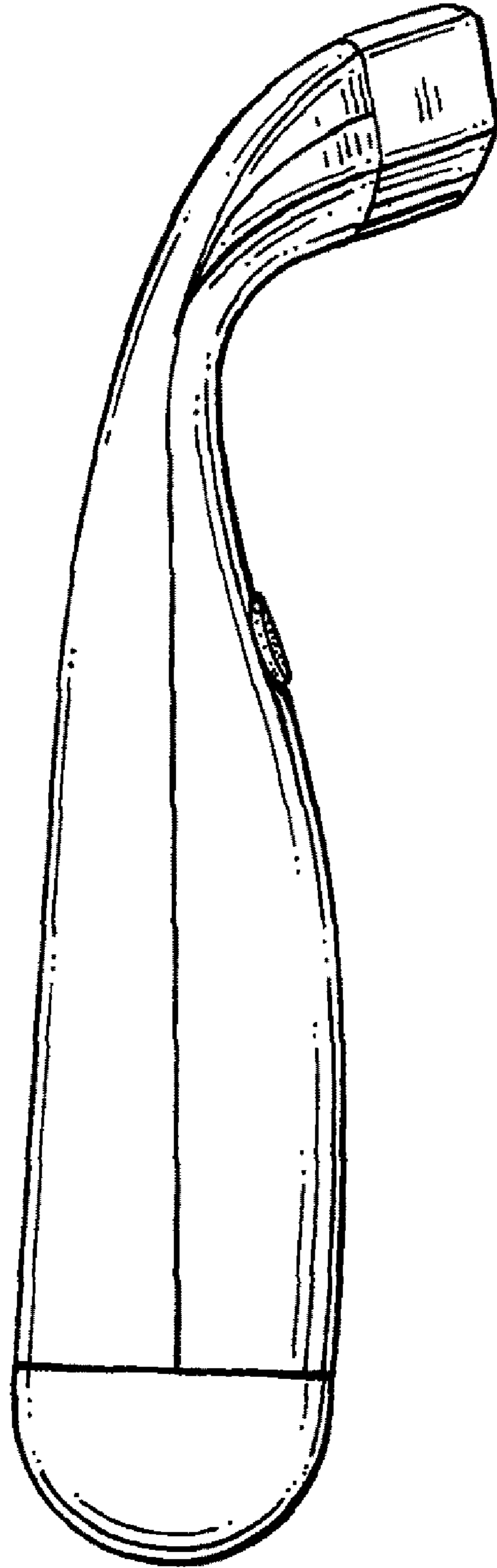

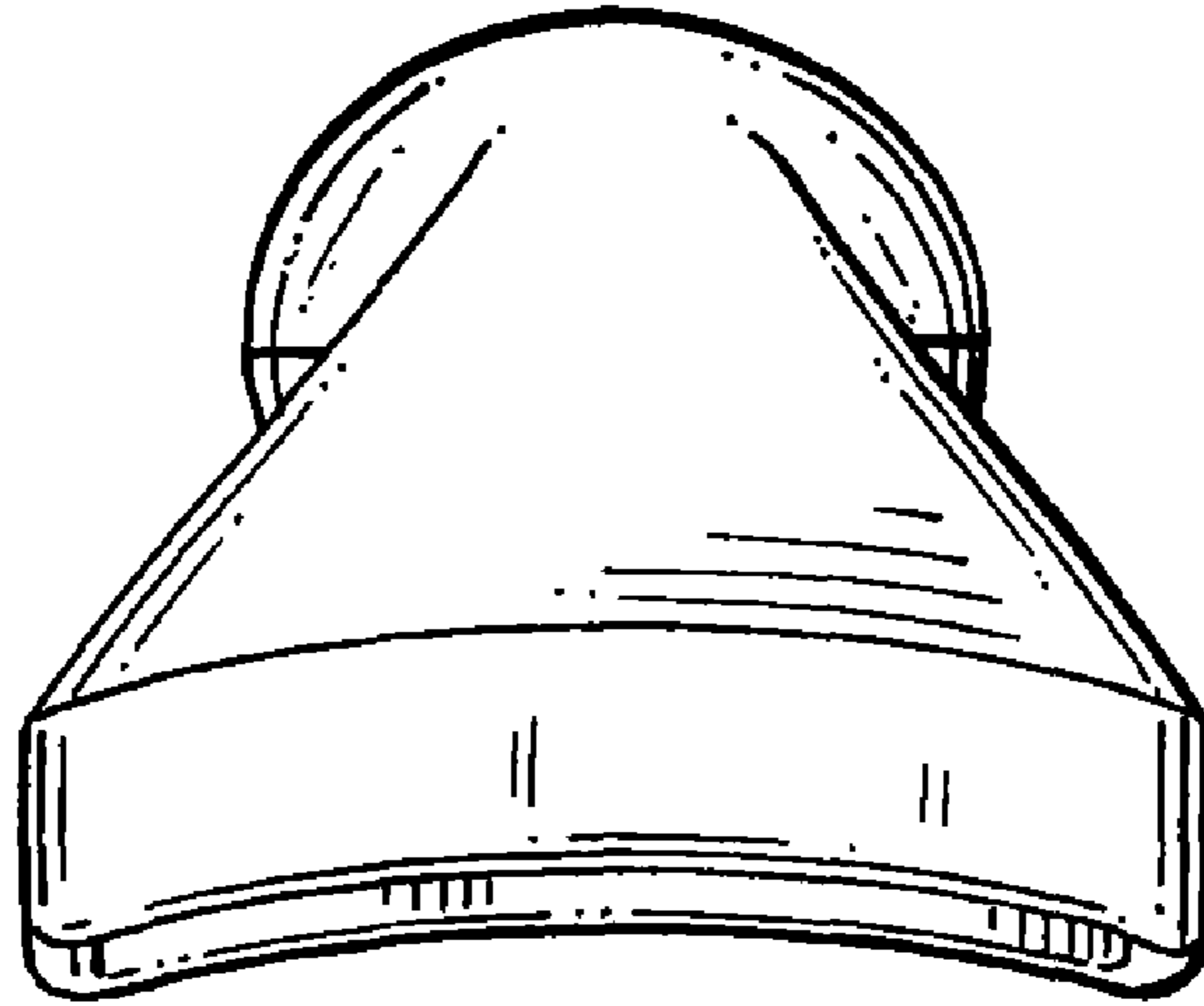

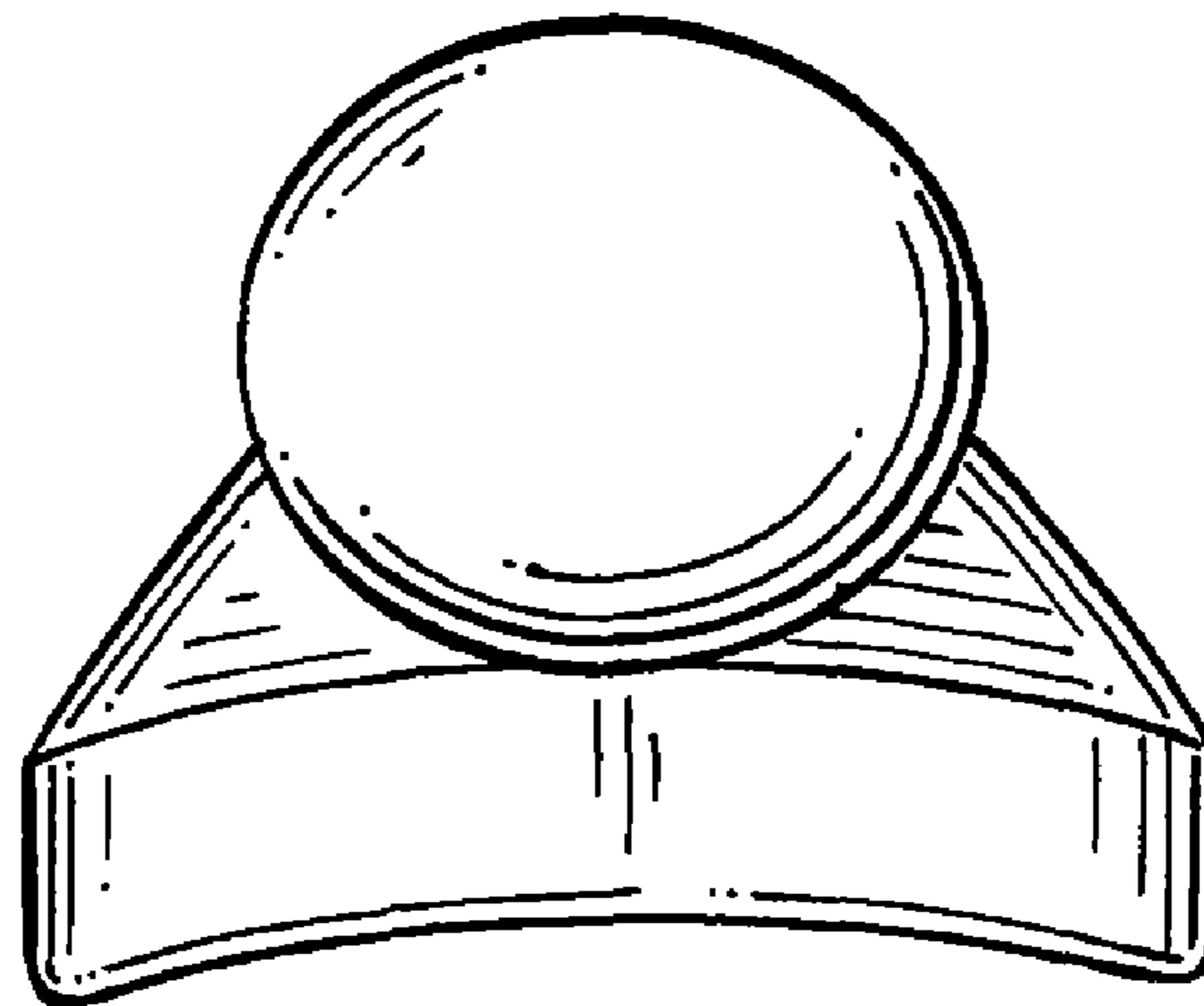
