**DESCRIPTION**

FIG. 1 is a perspective view of a leadware assembly showing  
our new design;

connector removed for clarity of illustration;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a right side elevational view thereof;

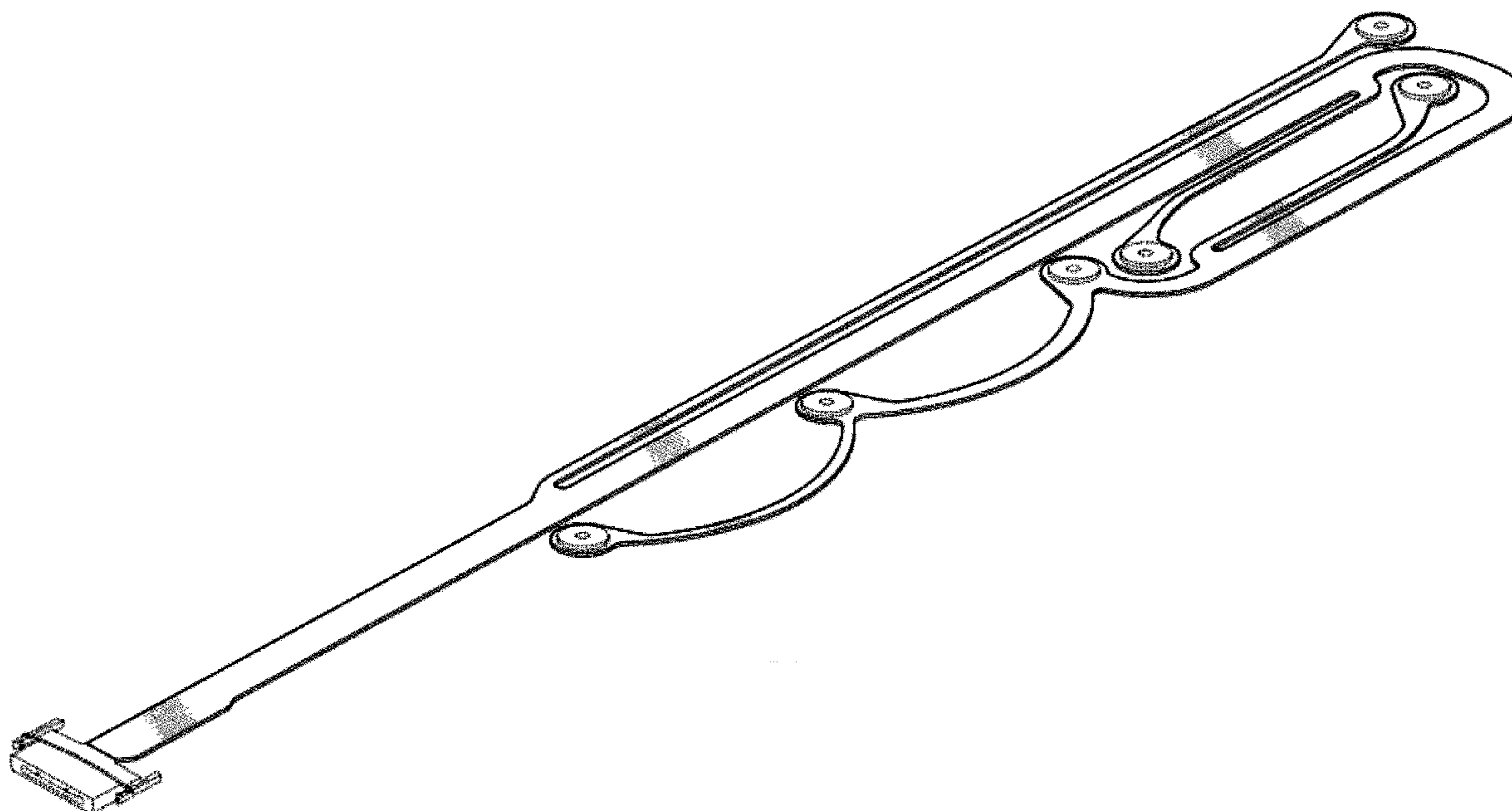
FIG. 5 is a left side elevational view thereof;

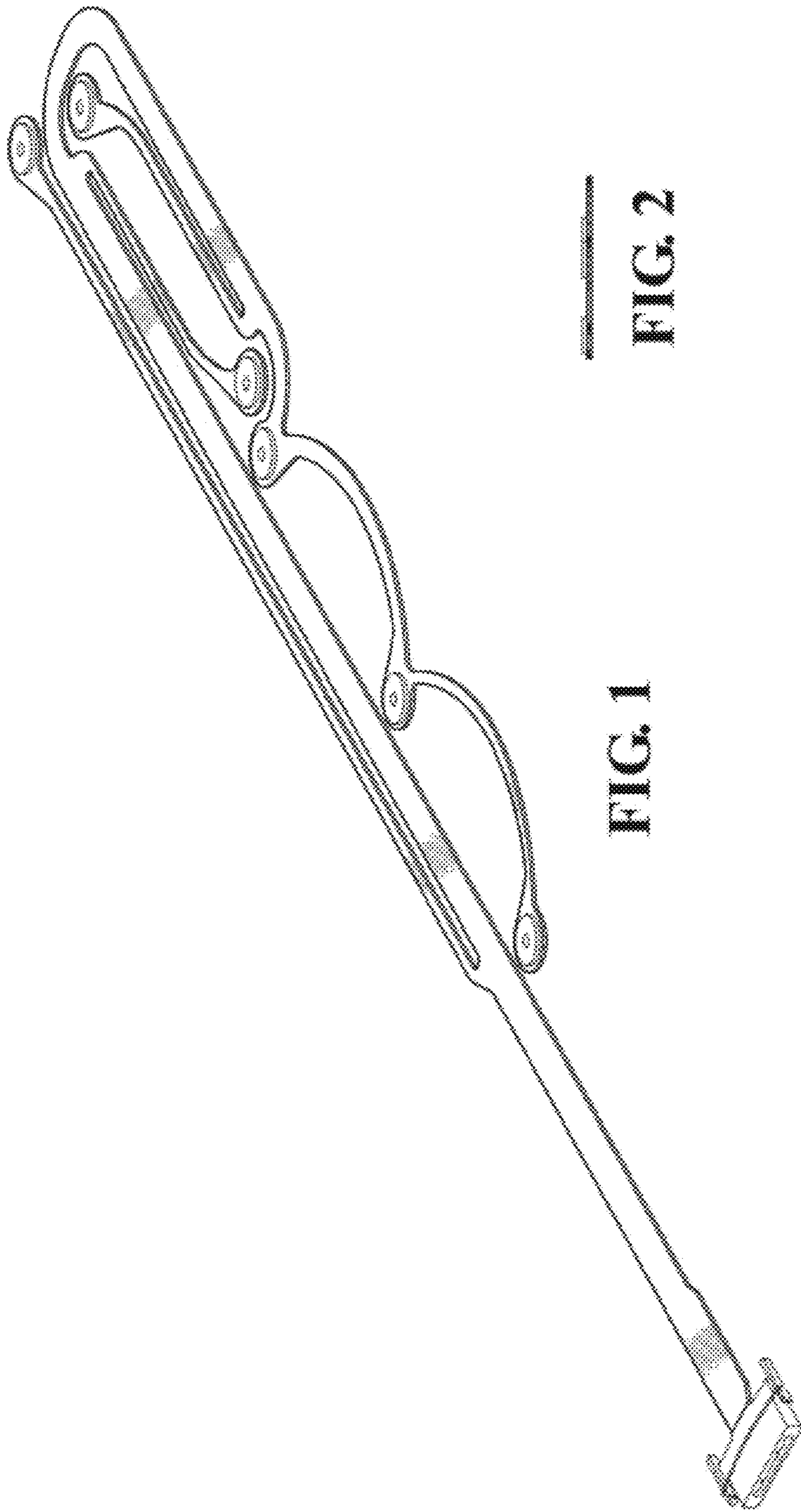

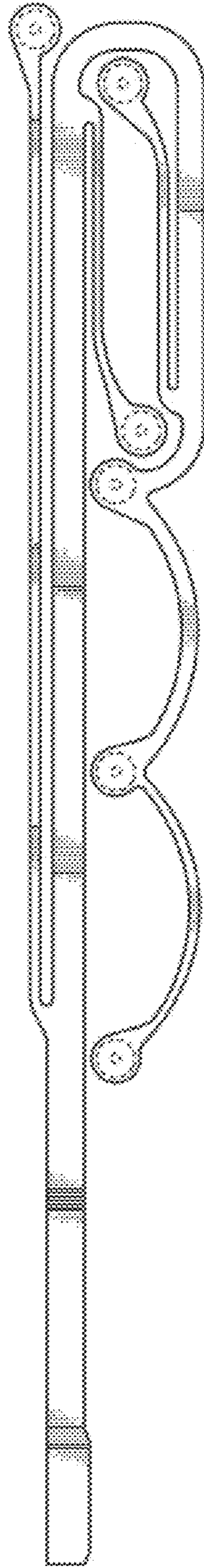

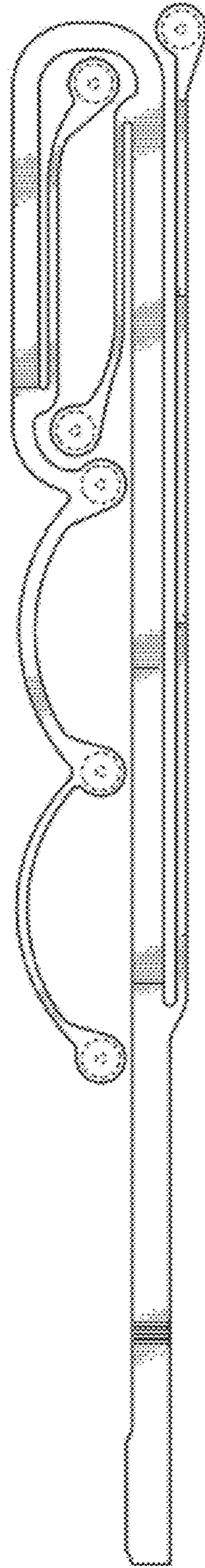
