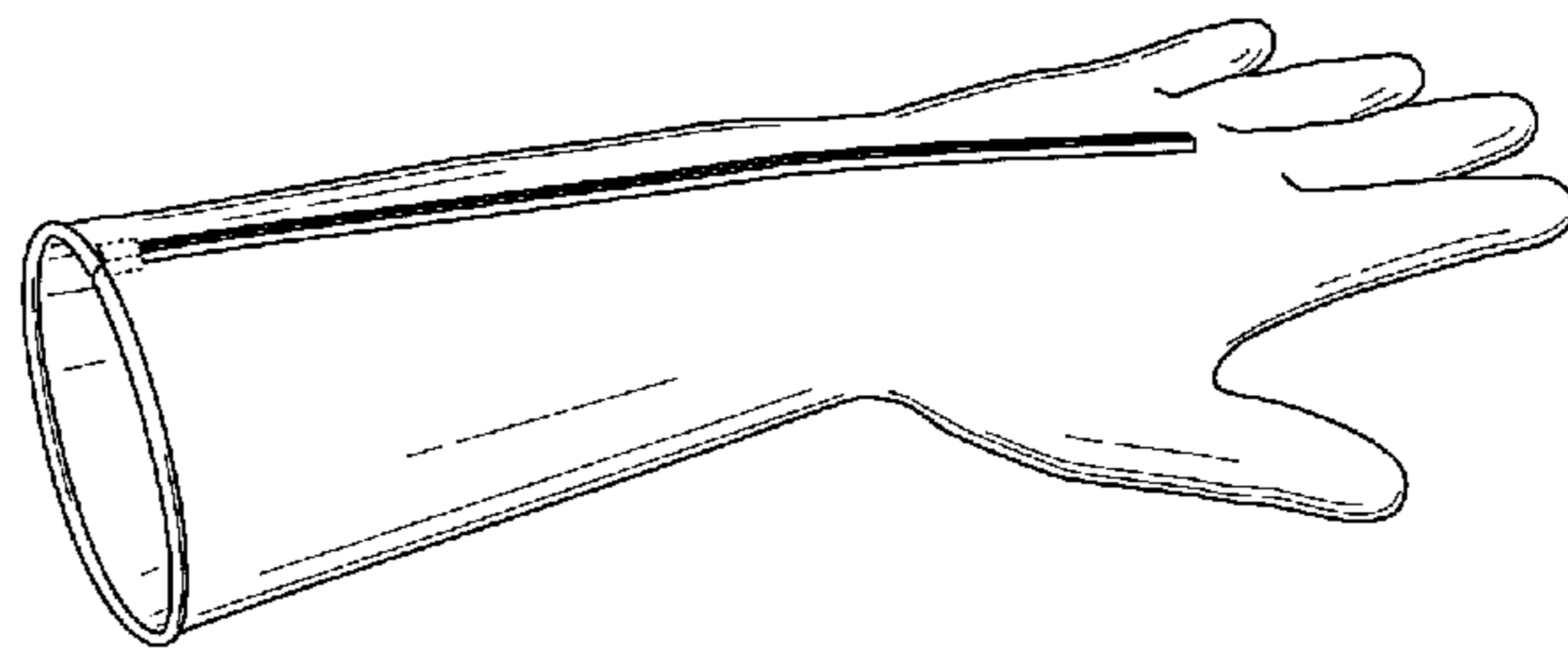
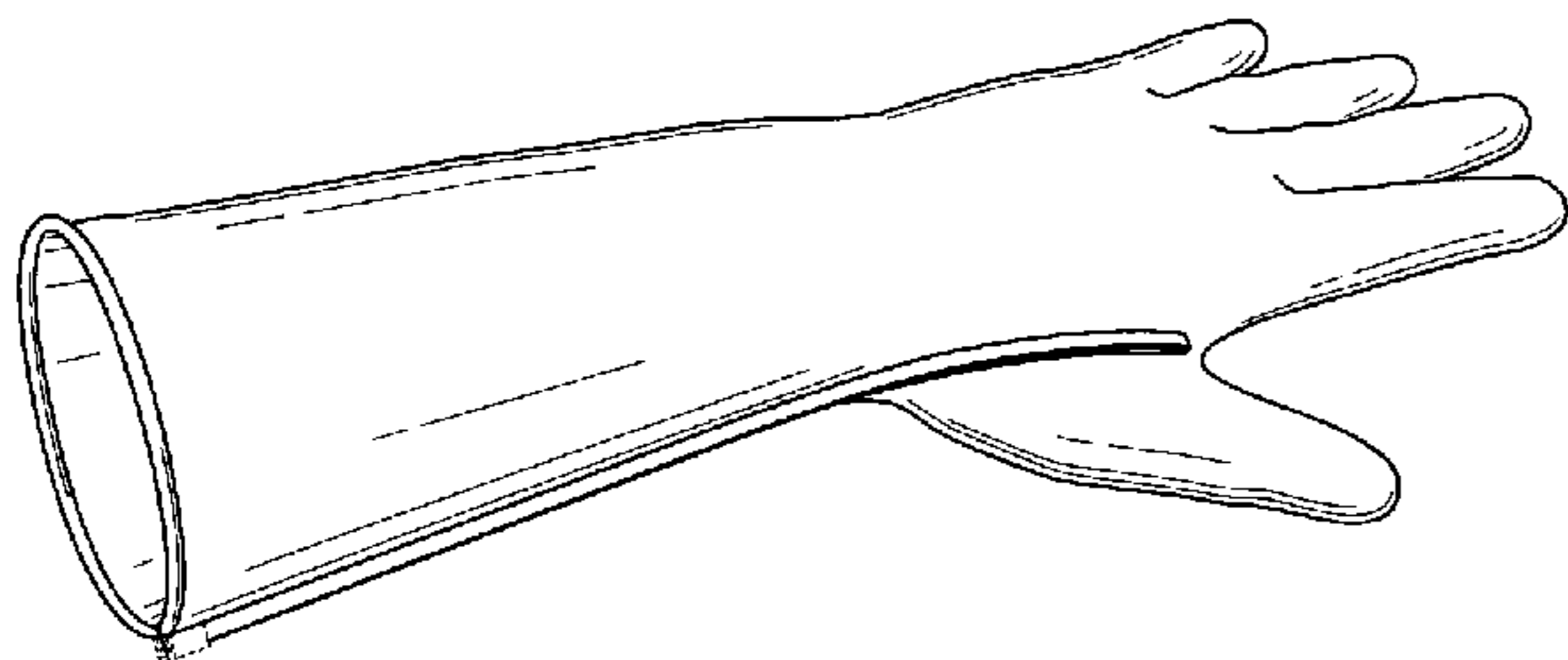
(57) **CLAIM**

The ornamental design for an easy fit sanitary glove, as shown and described.

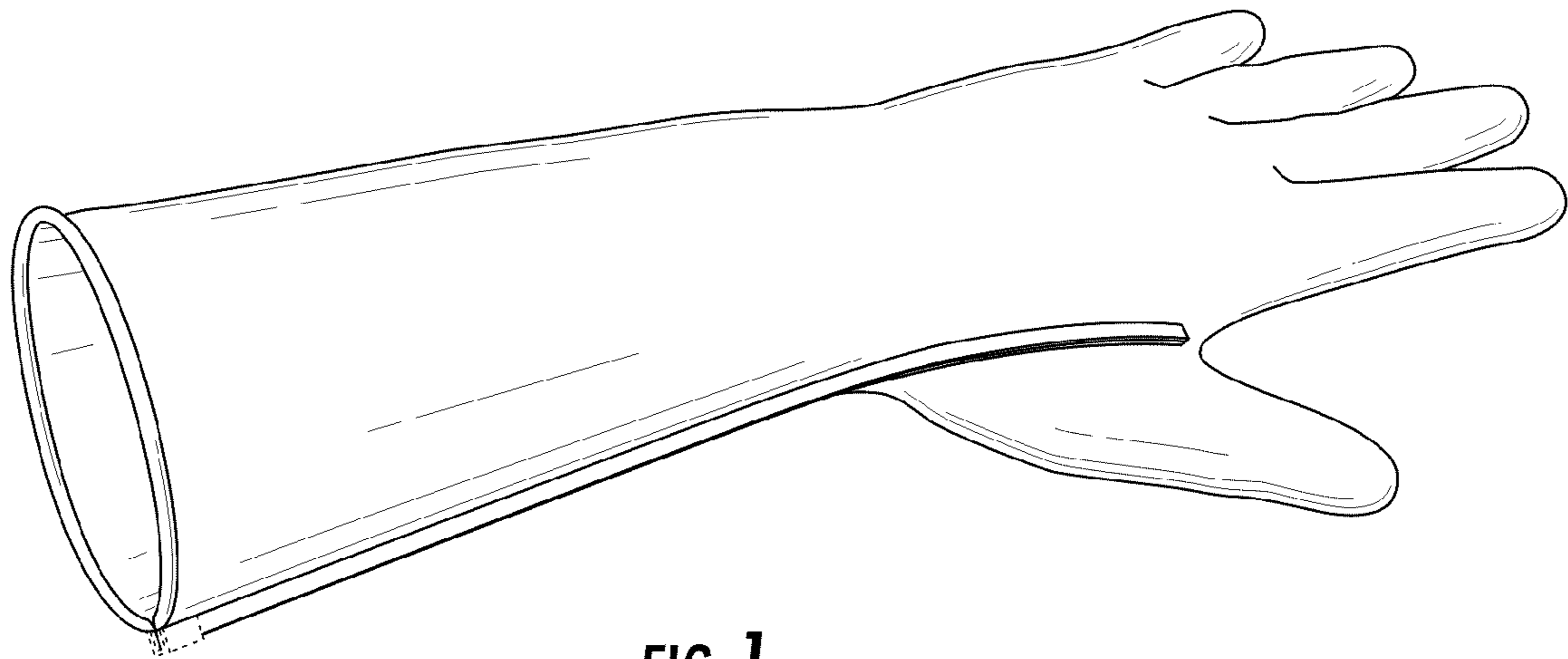

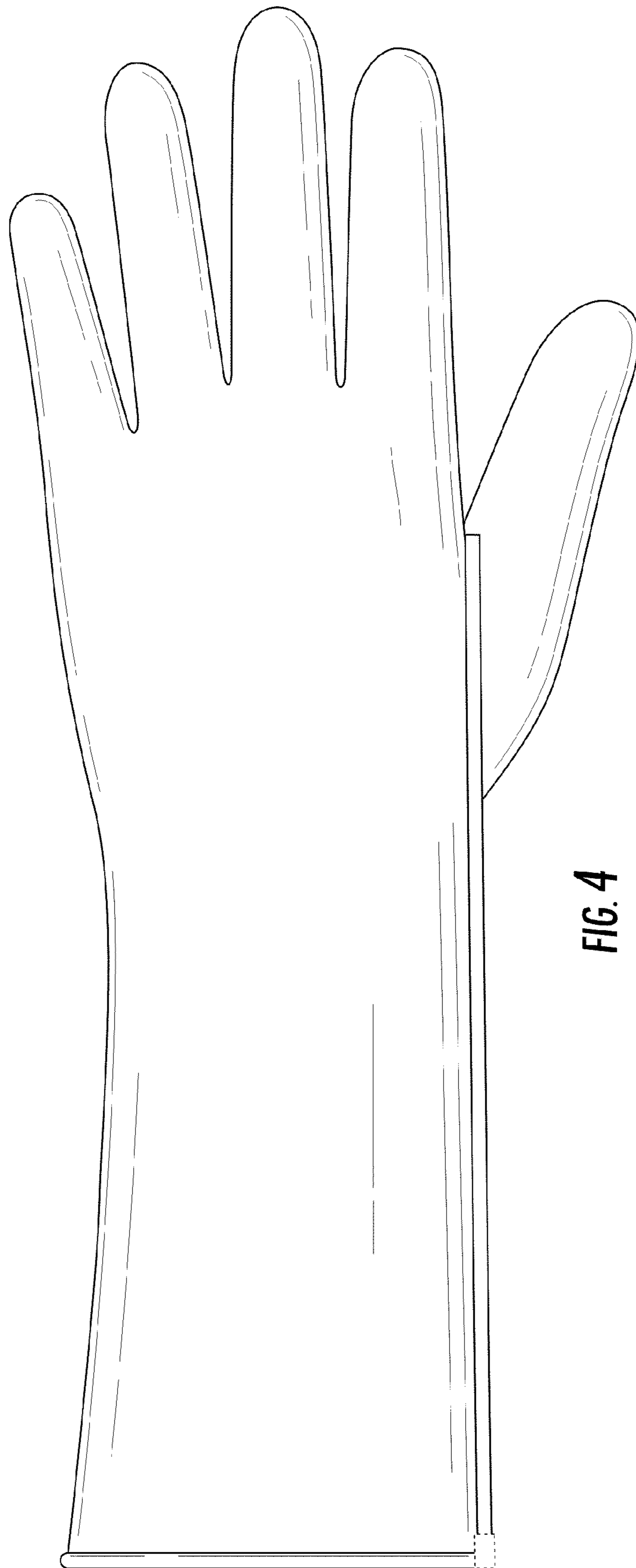

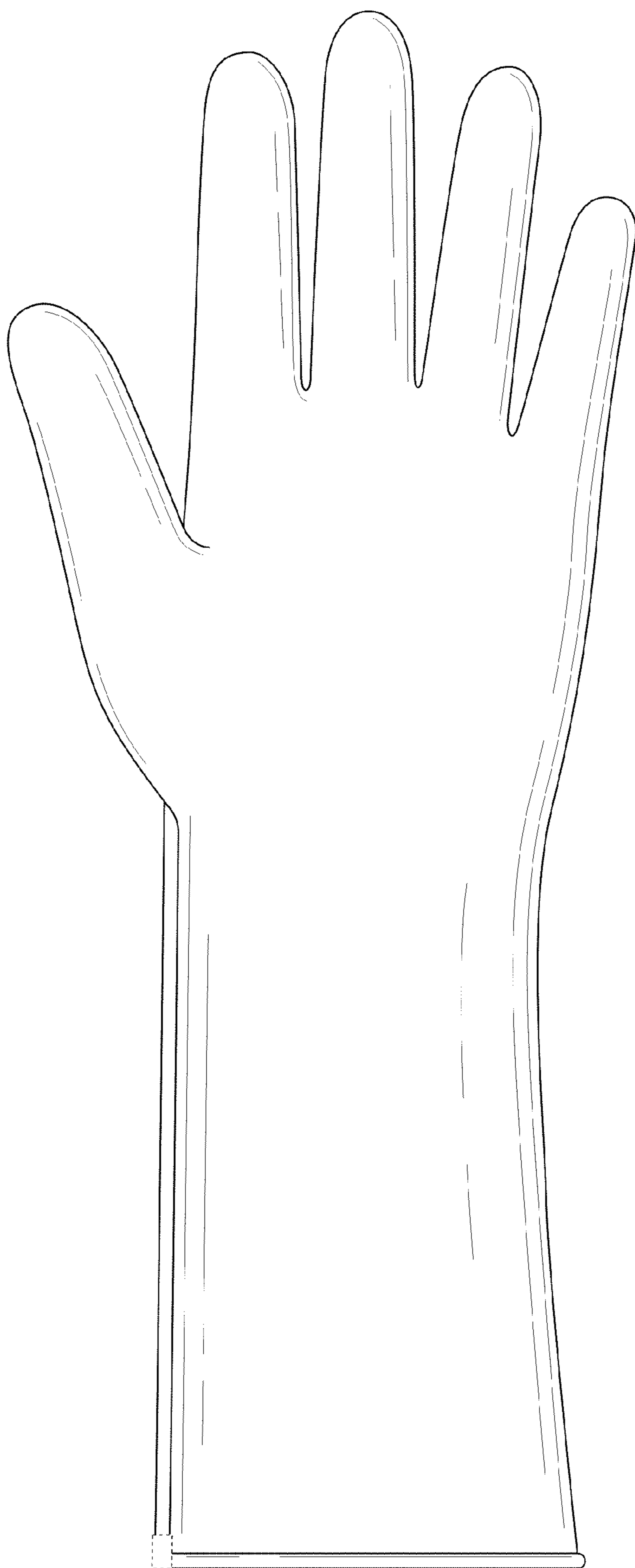

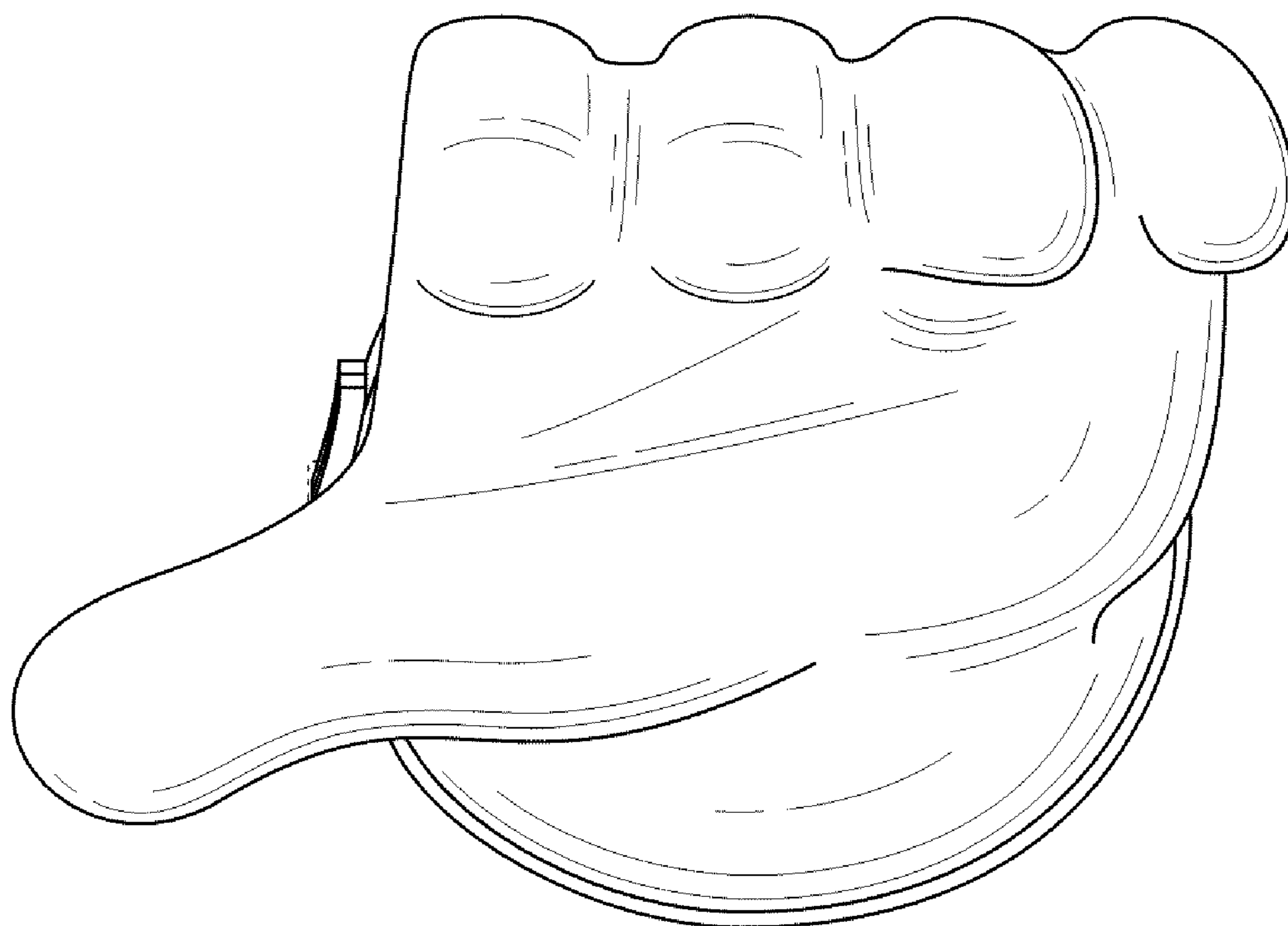

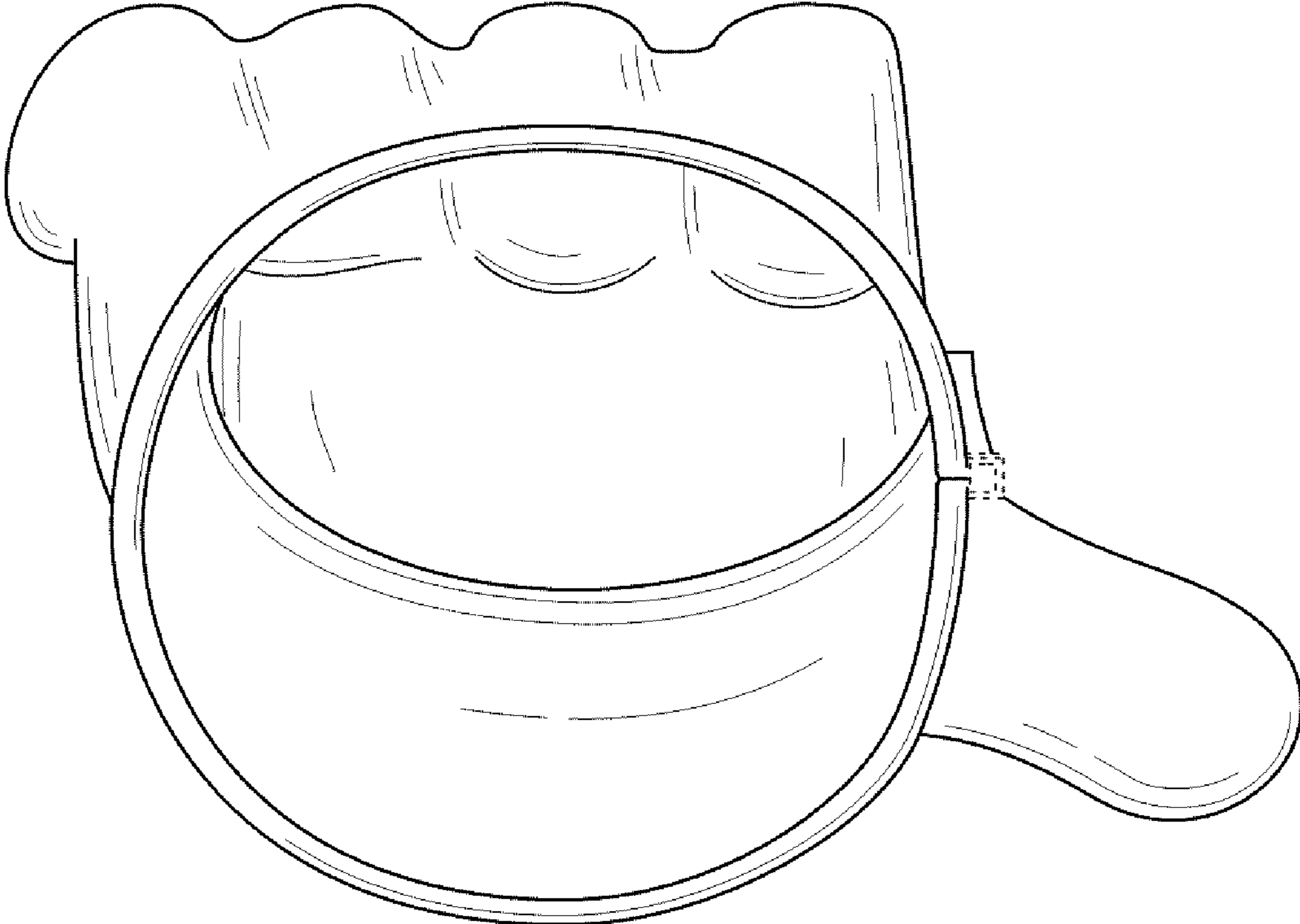

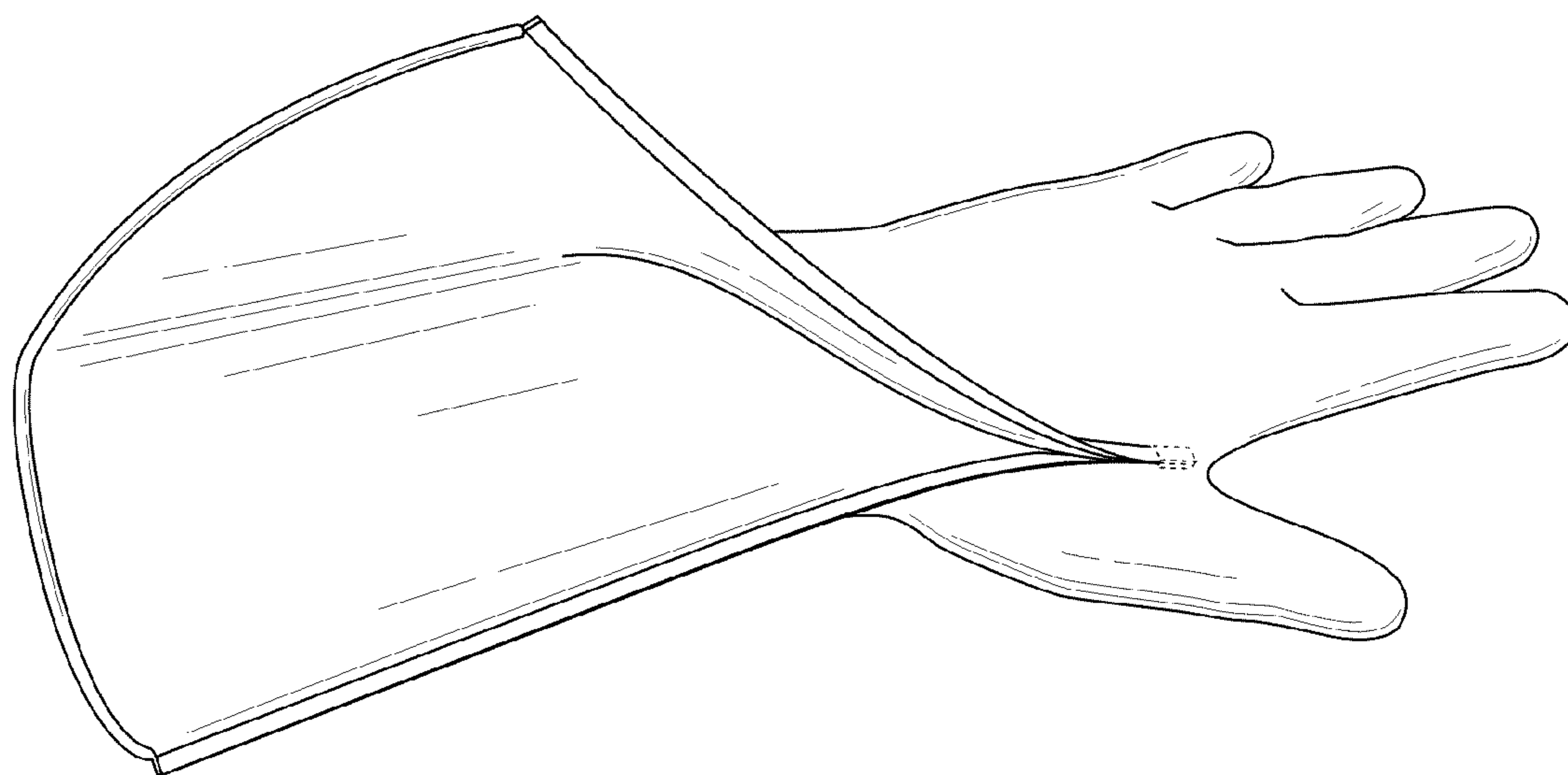

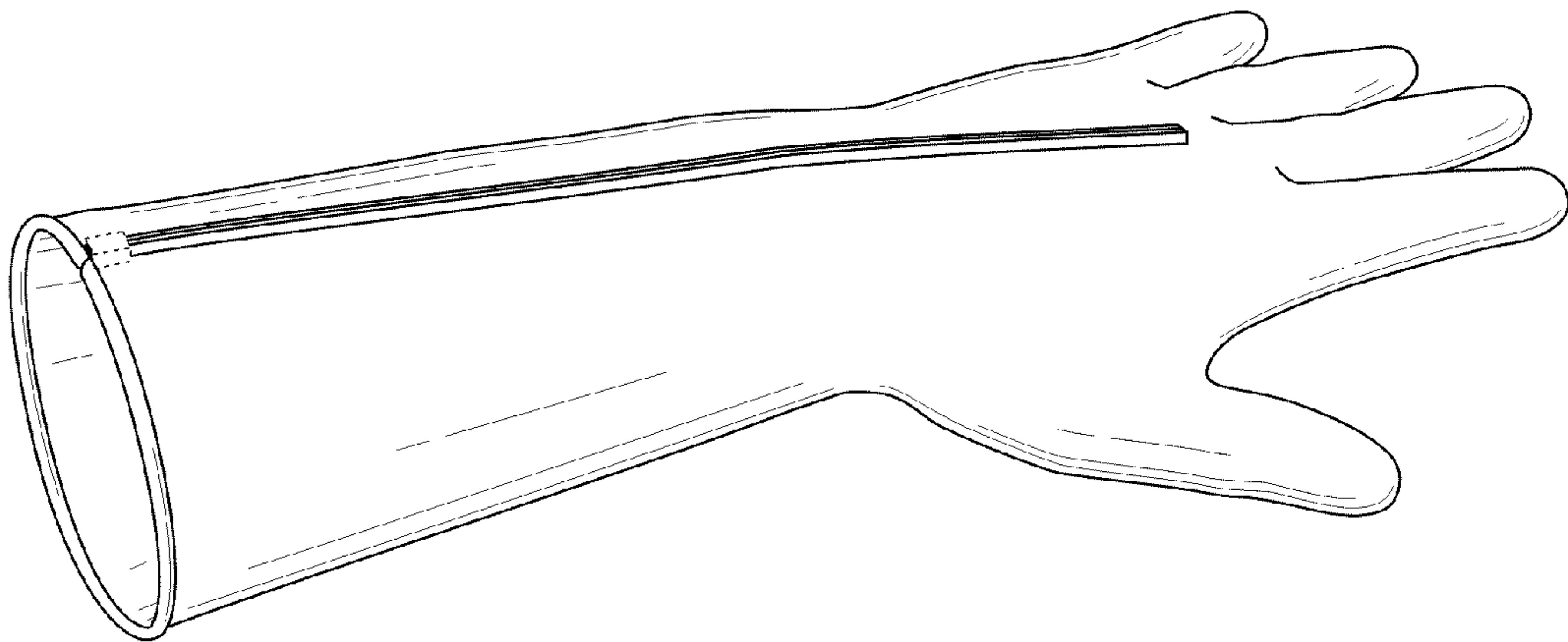

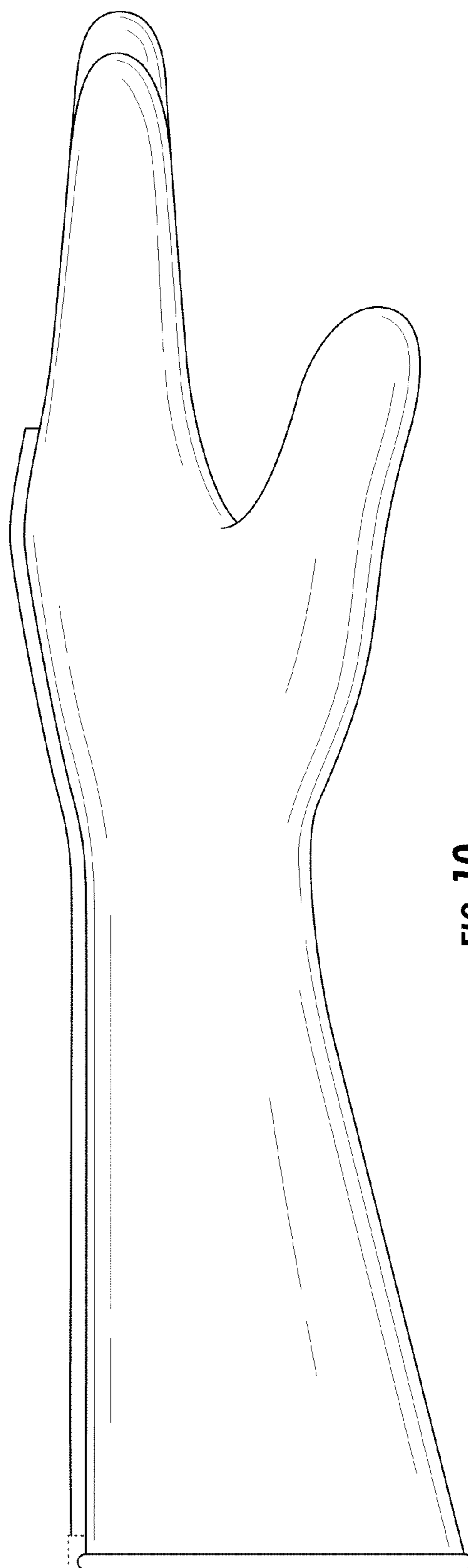

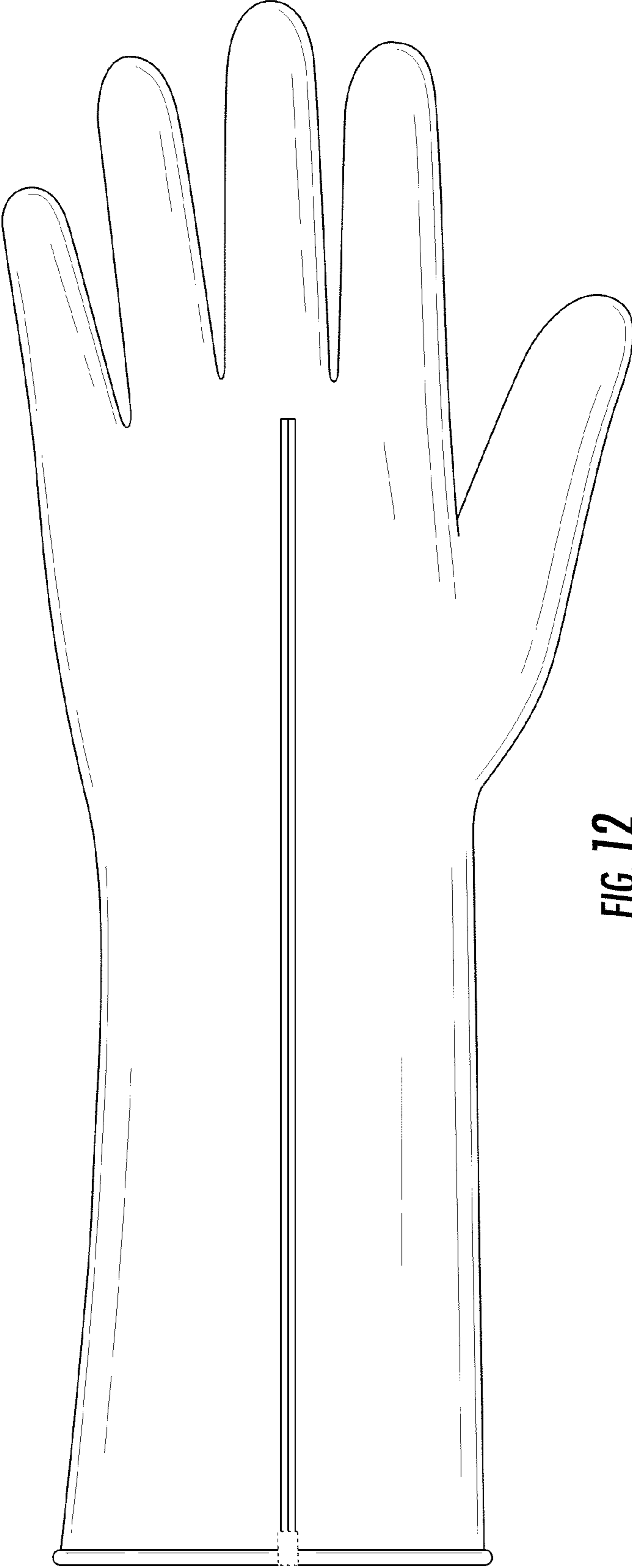

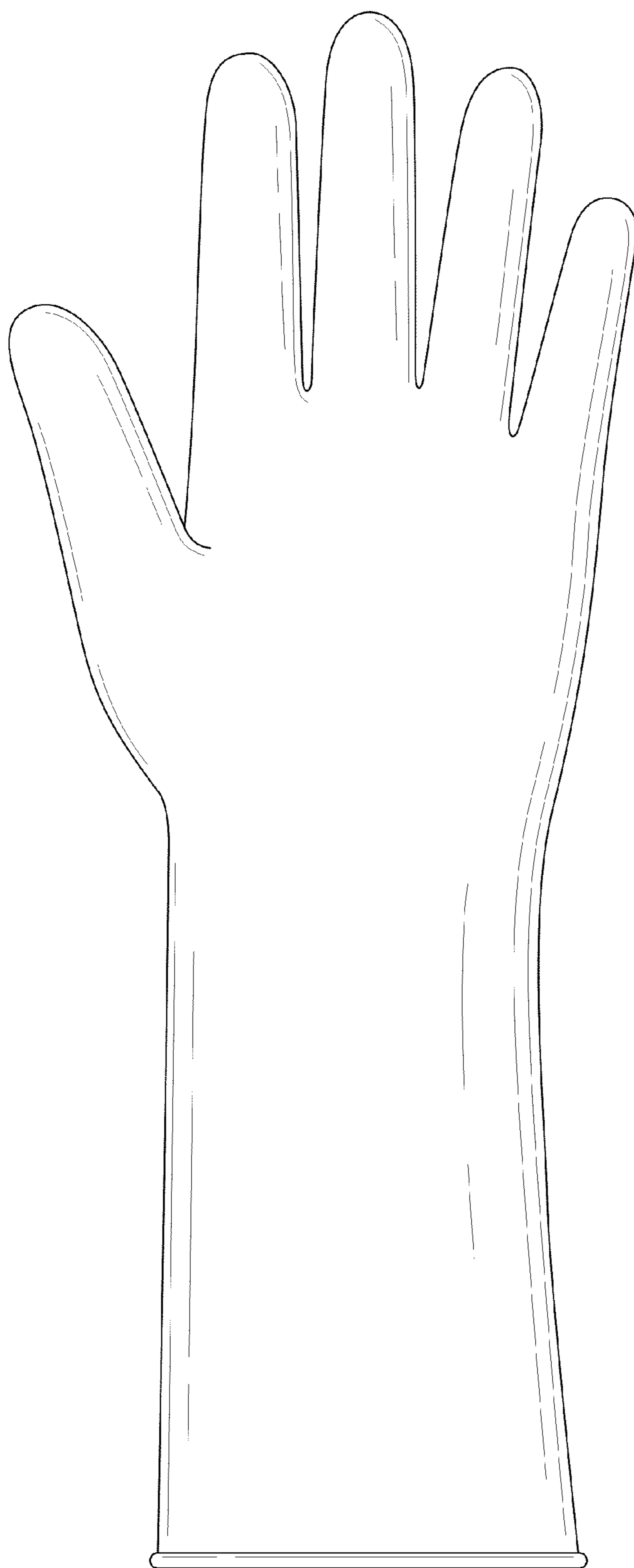

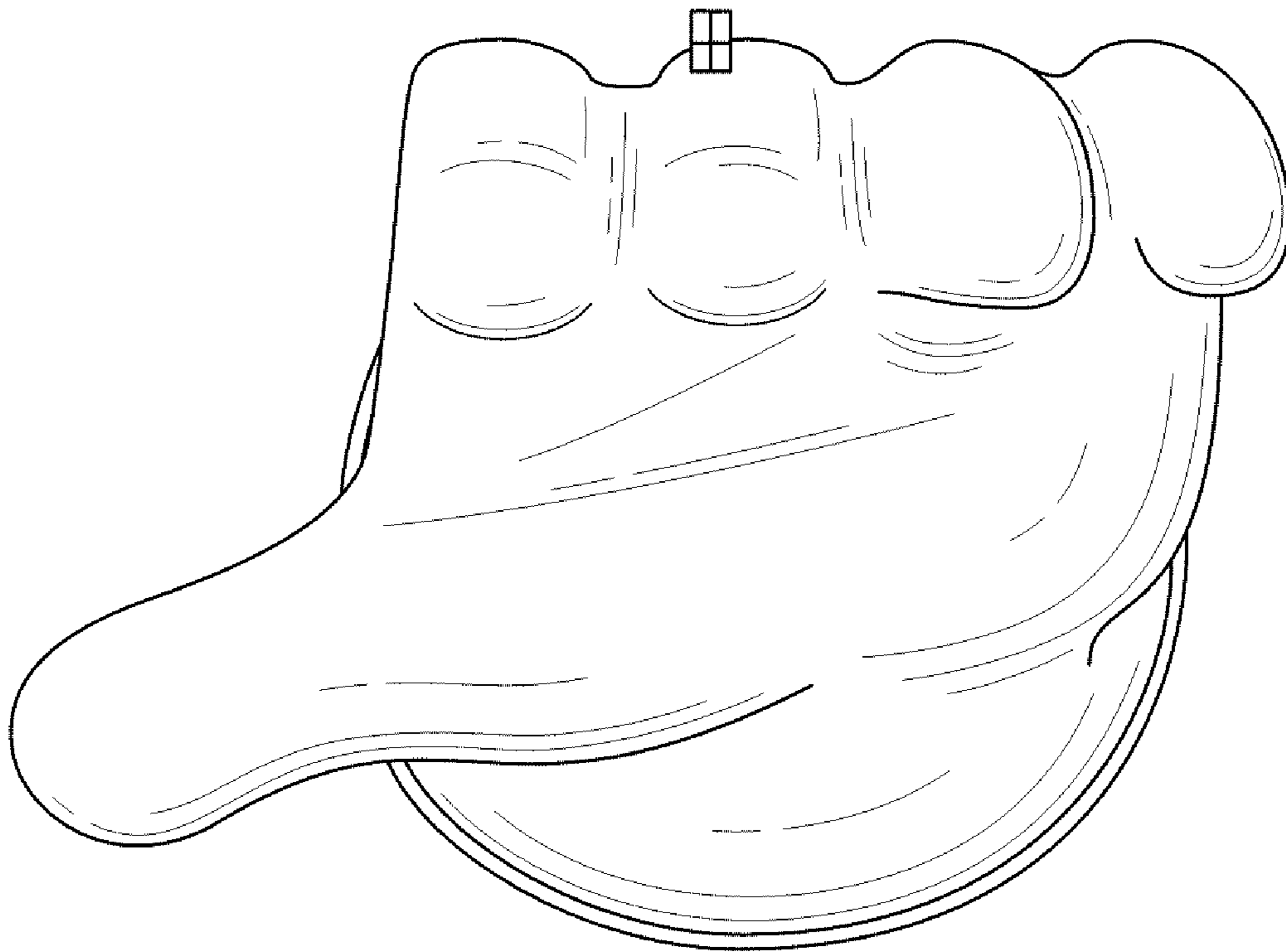

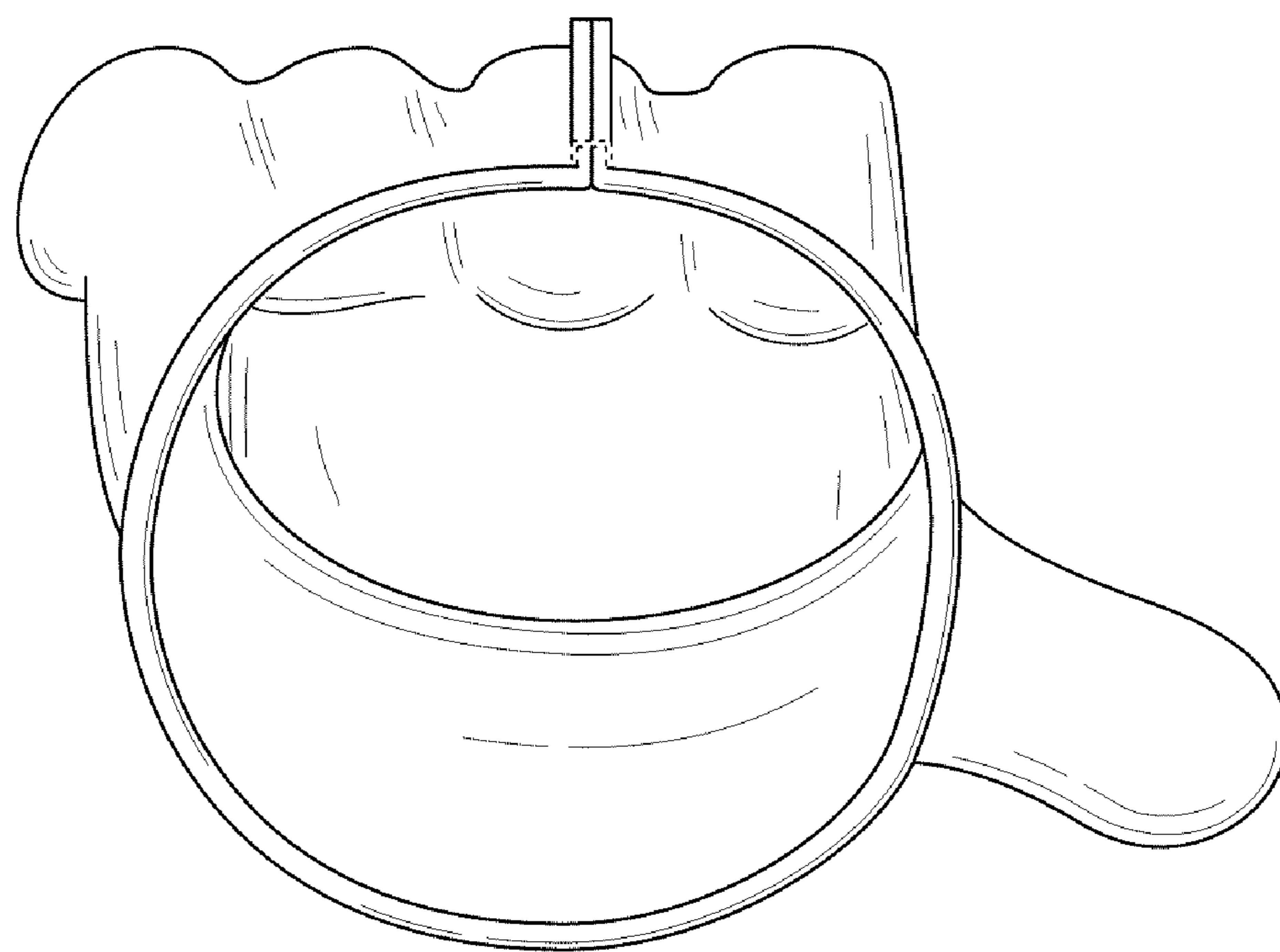

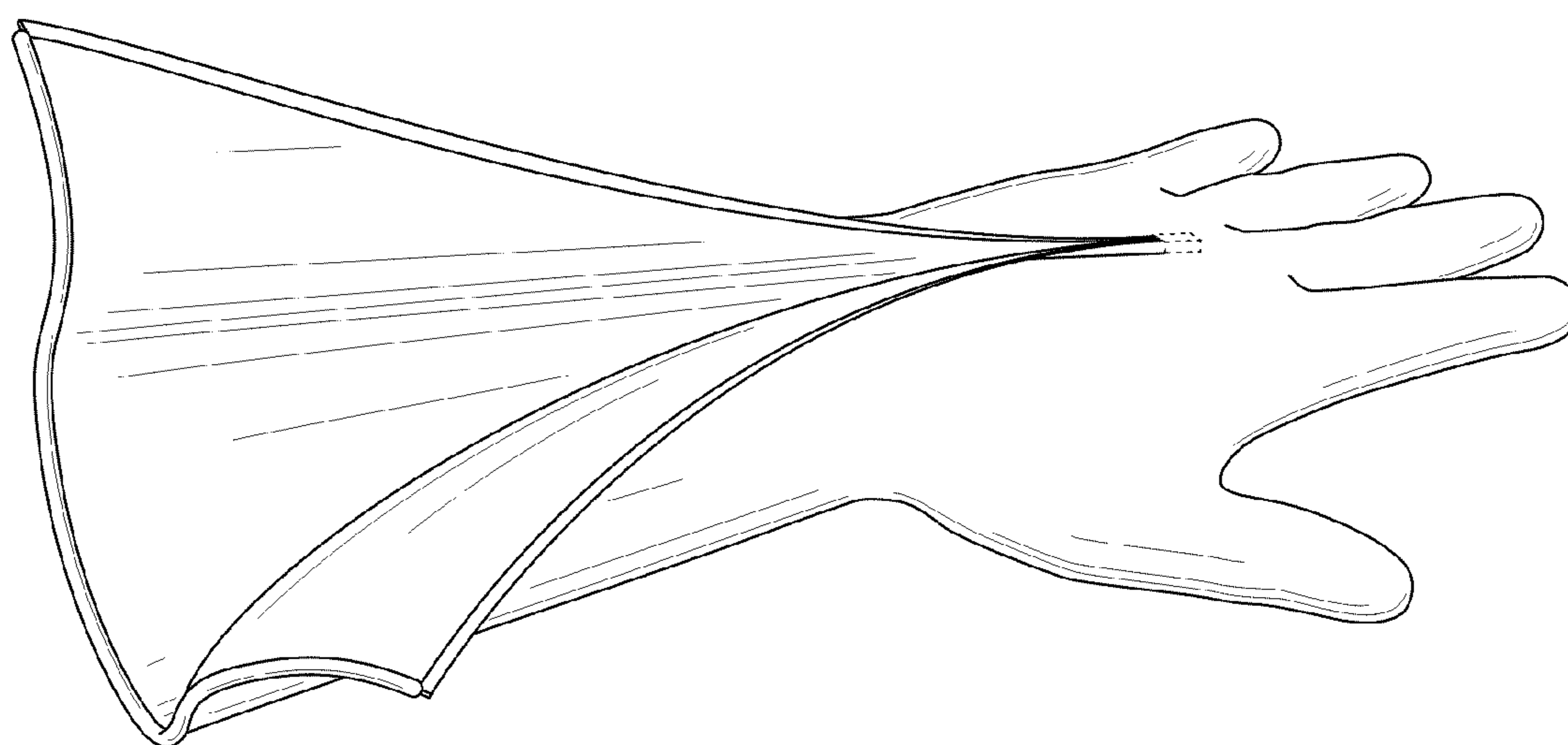
