The ornamental design for a pet food dish, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a pet food dish incorporating our new design, viewed from in front of, above, and from the left side thereof;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a right side elevation view thereof, with the left side being a mirror image of the right side;

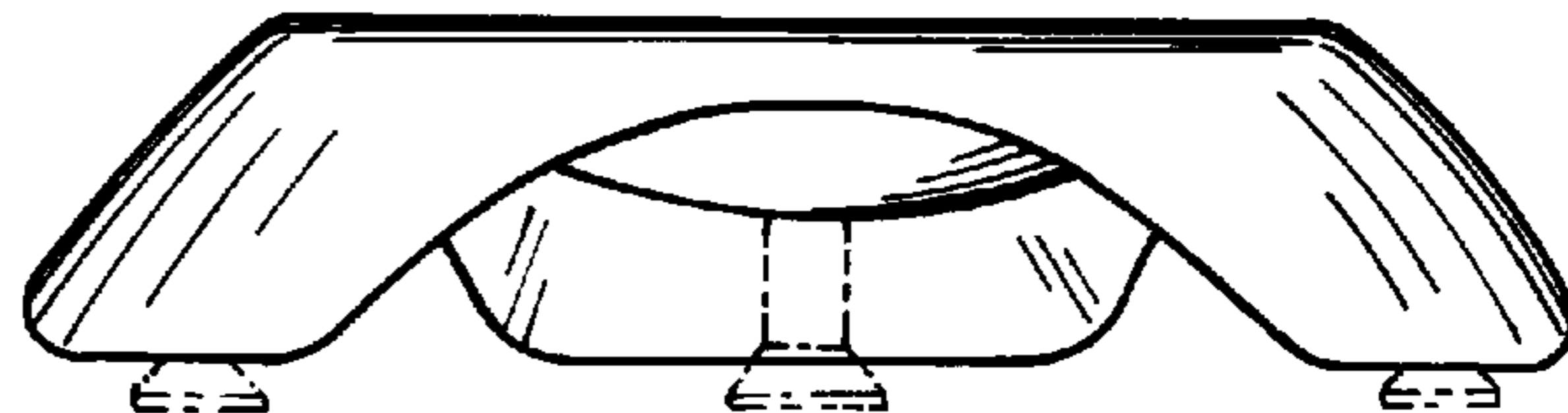
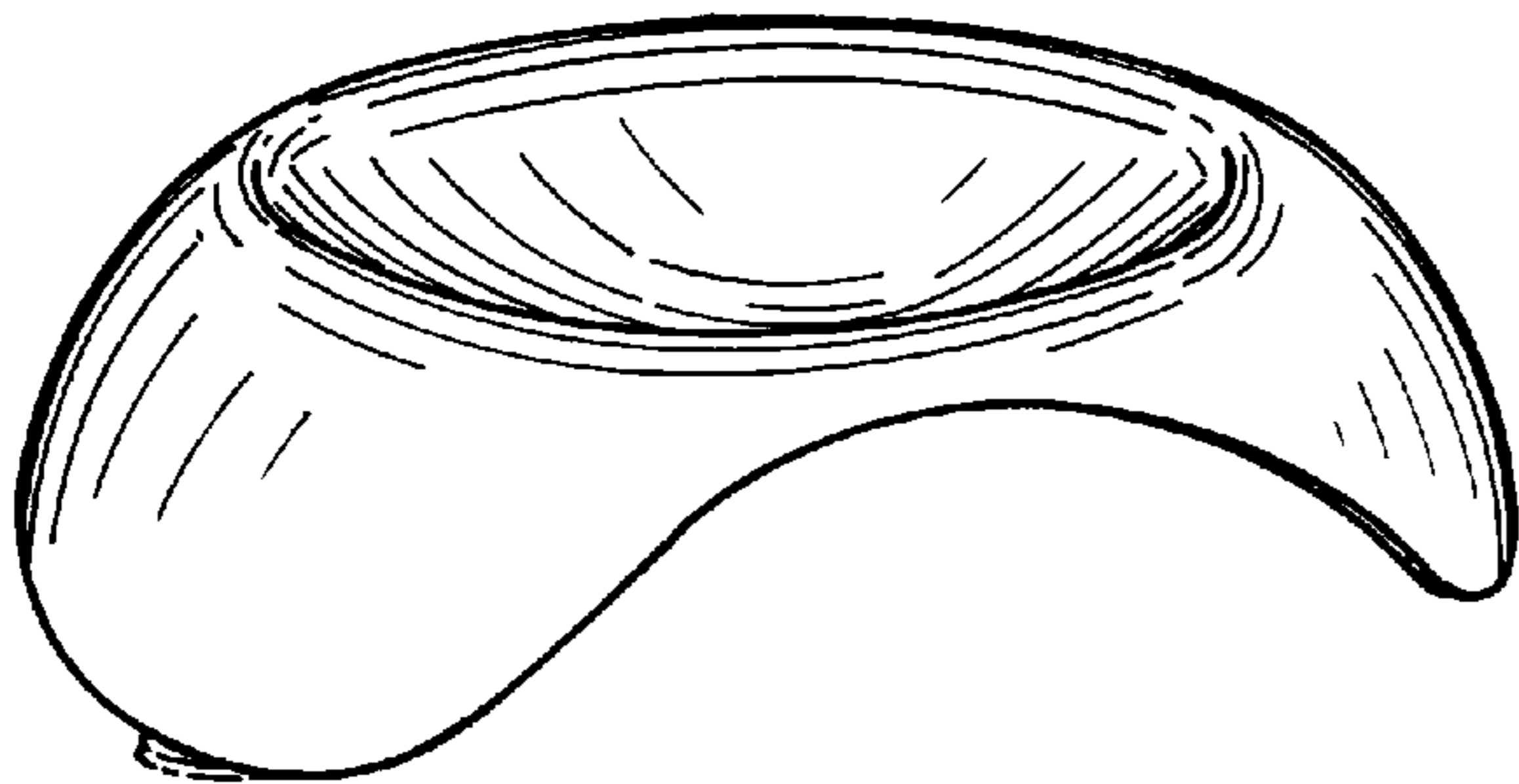
FIG. 4 is a rear elevation view thereof;

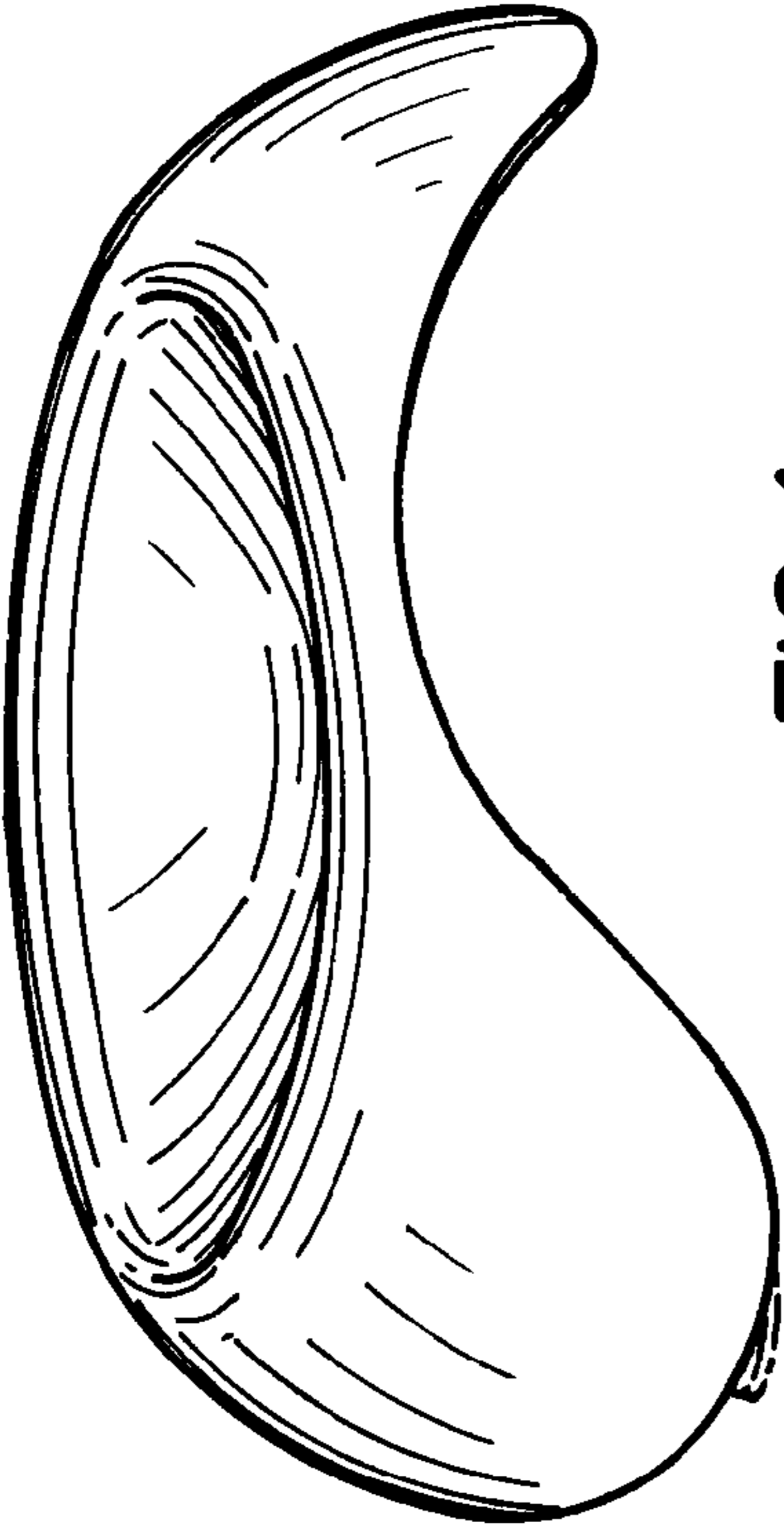

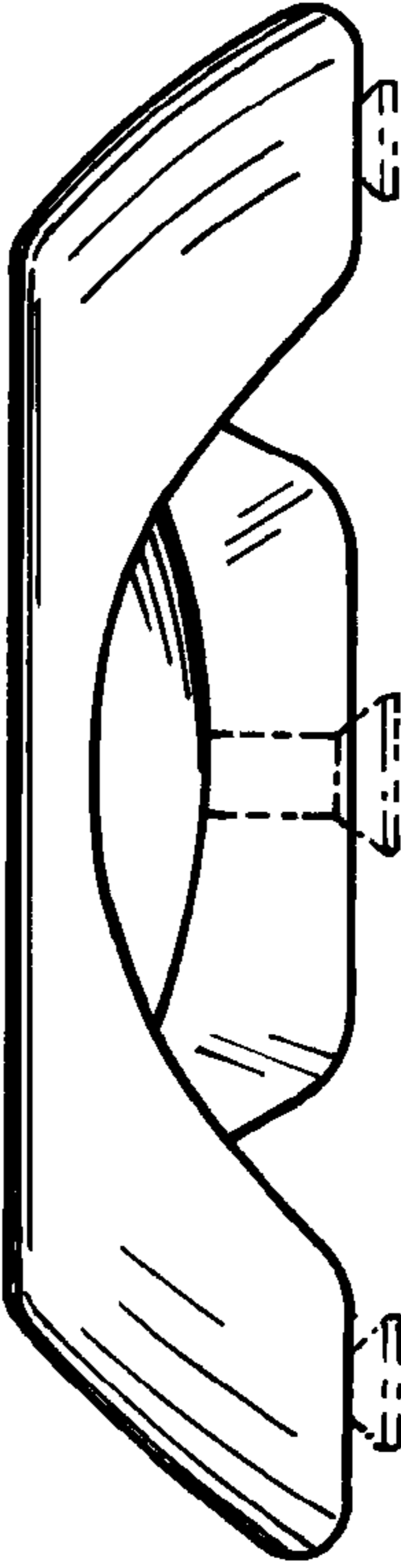

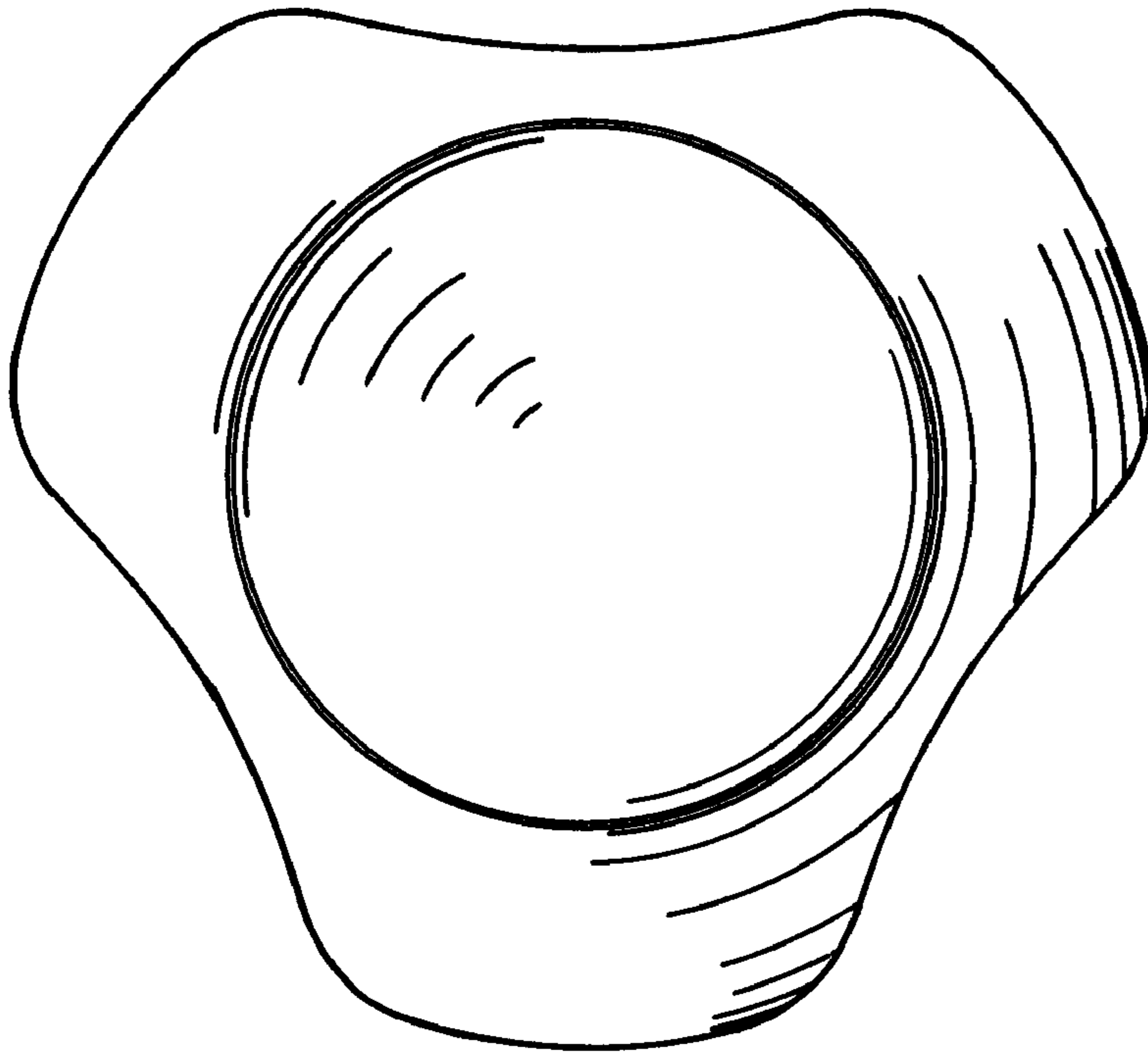

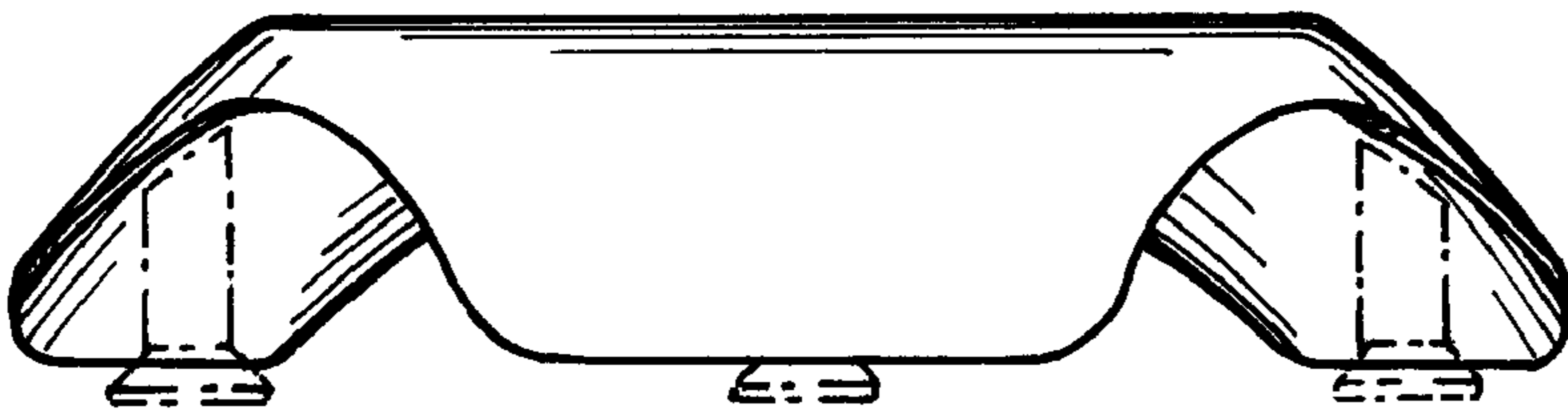

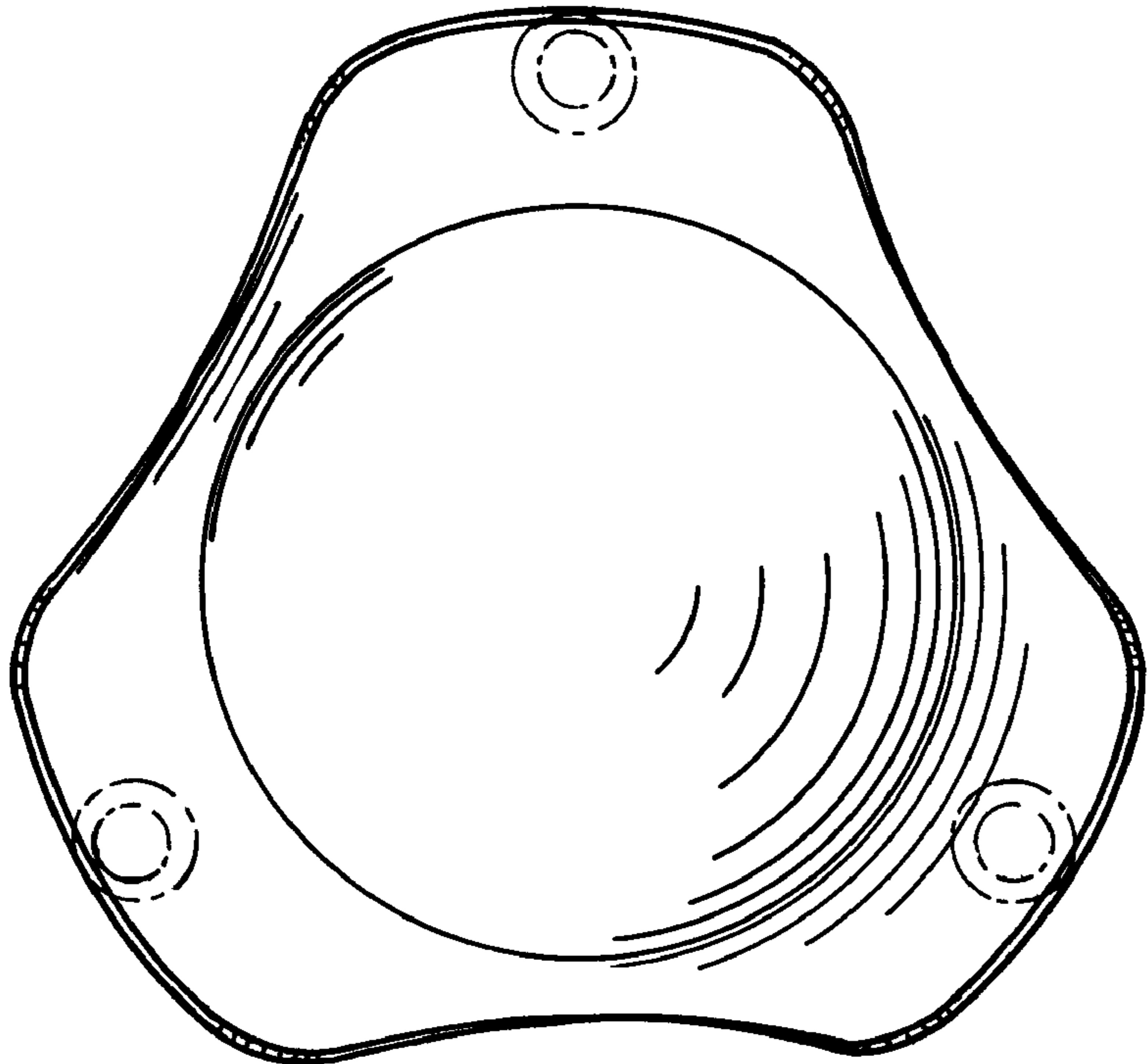
