FIG. 5 is a bottom view of the confectionary shown in FIG. 1.

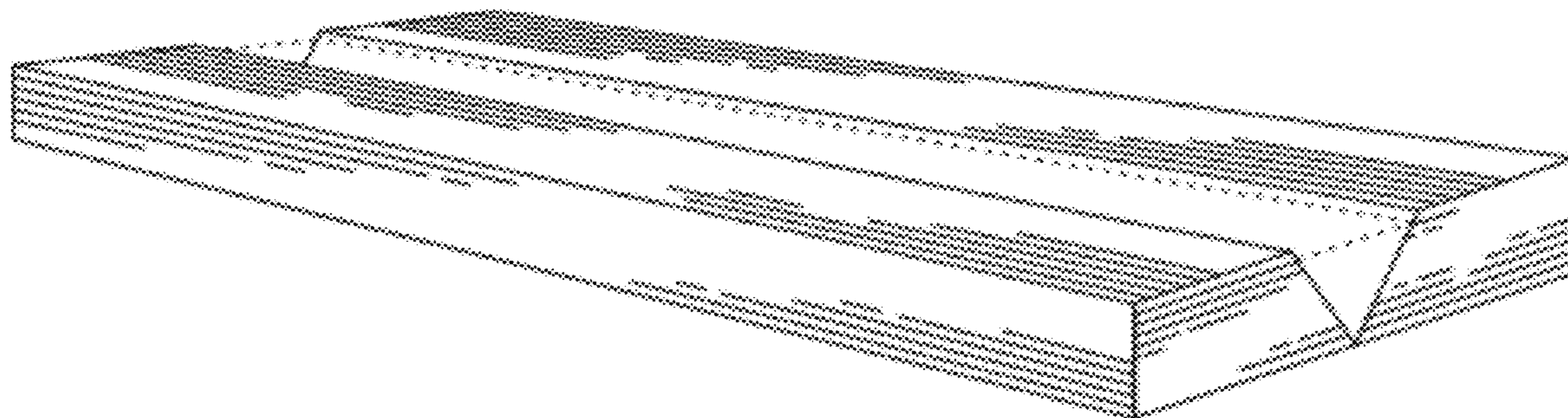

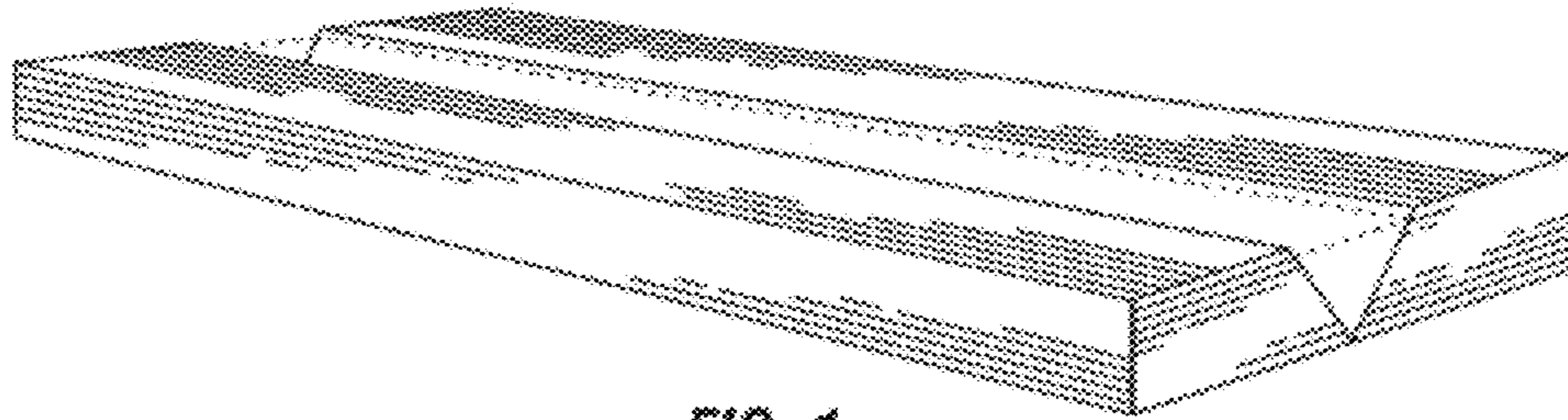
