(57) **CLAIM**

The ornamental design for a wrist-worn shopping bag grip, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a wrist-worn shopping bag grip.

FIG. 2 is a top view of the wrist-worn shopping bag grip of FIG. 1.

FIG. 3 is a bottom view of the wrist-worn shopping bag grip of FIG. 1.

FIG. 9 is another environmental view of the wrist-worn shopping bag grip of FIG. 1.

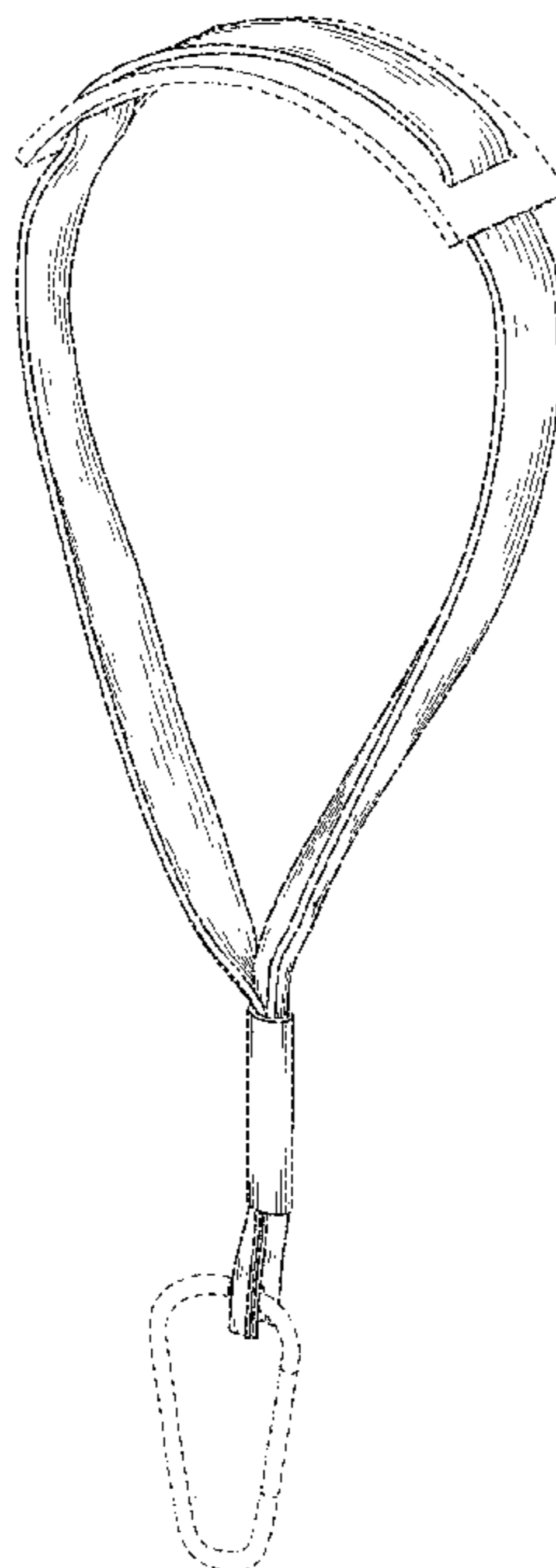

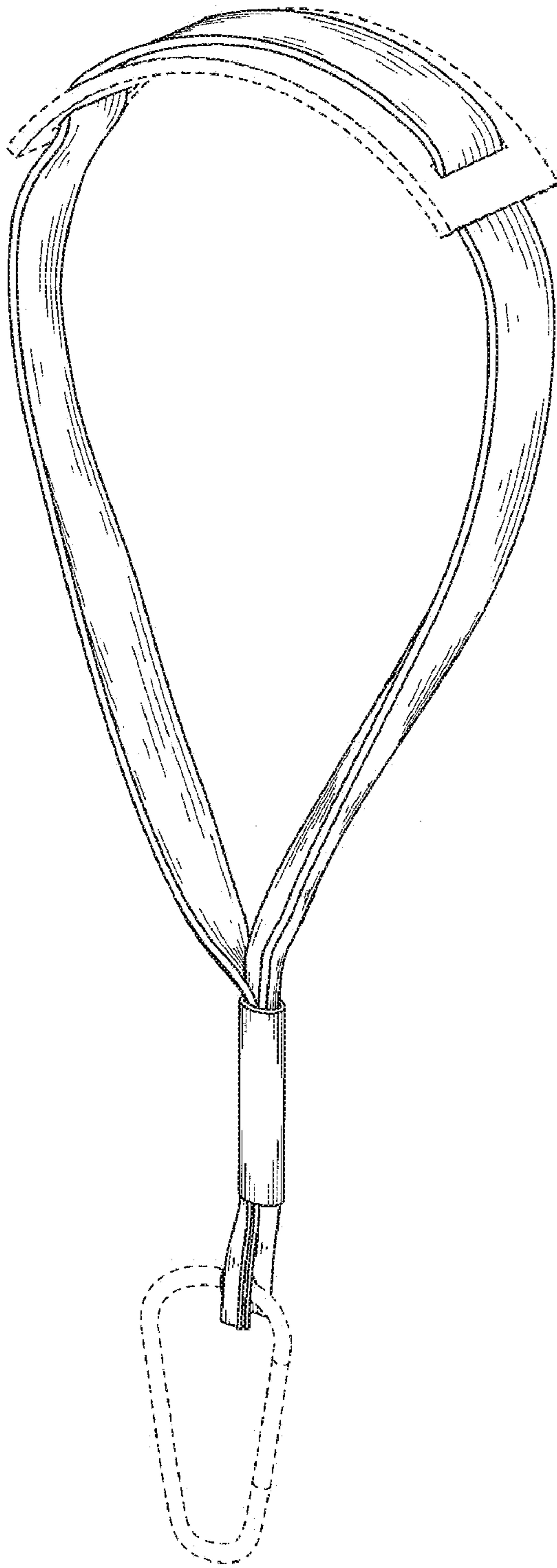

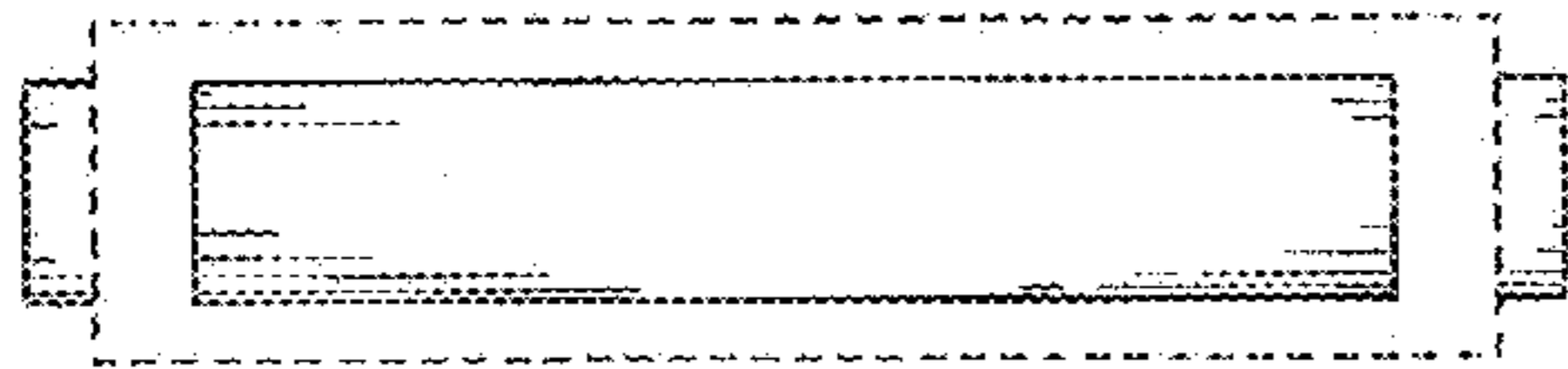

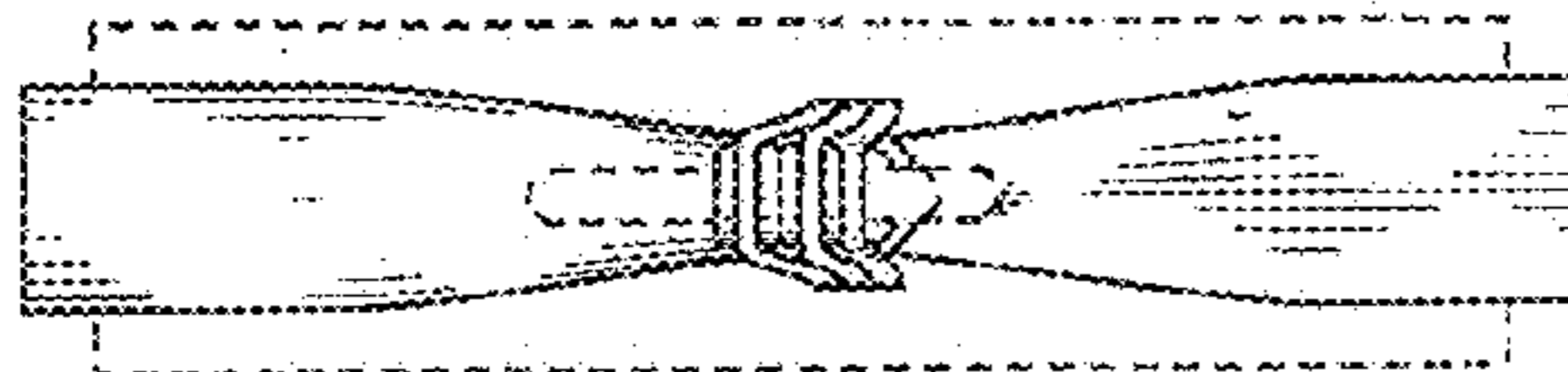

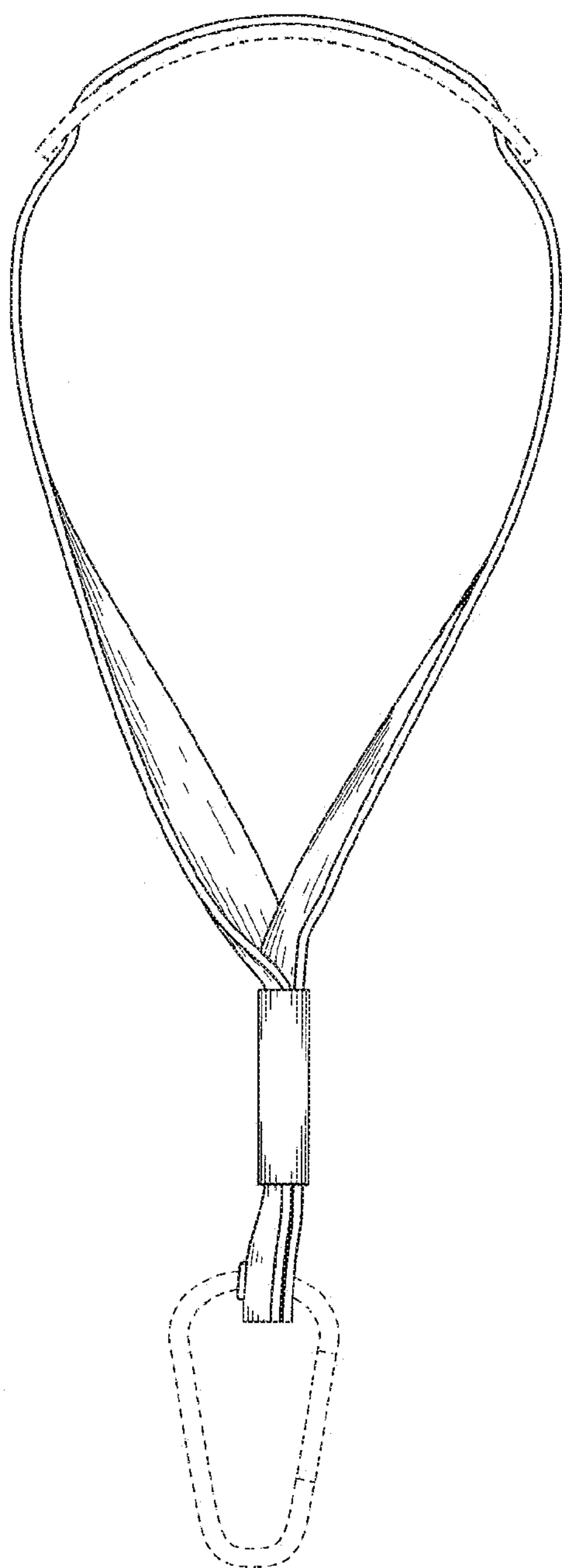

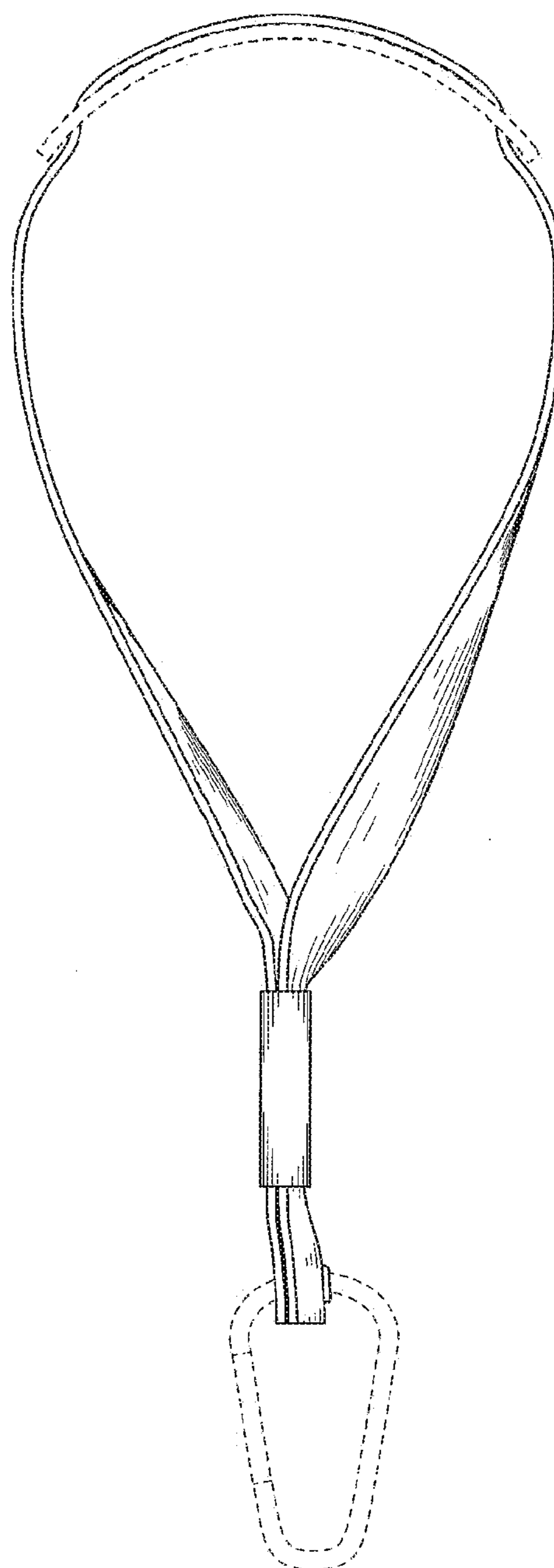

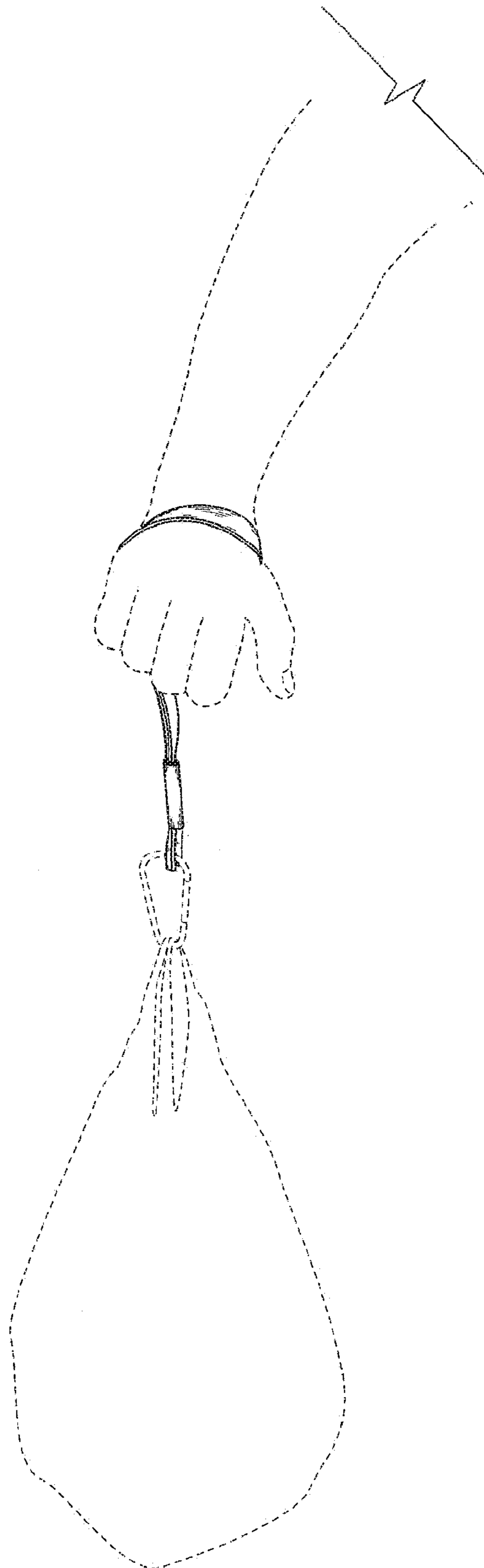

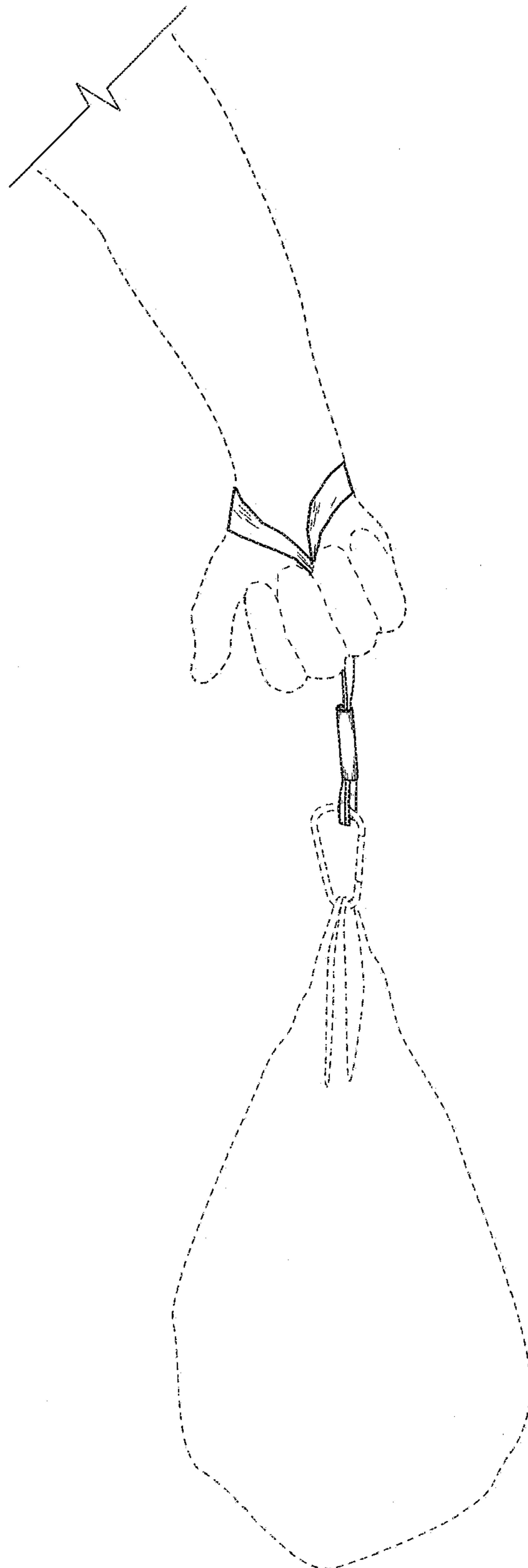
