(57) **CLAIM**
The ornamental design for a seat for motor vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a seat for motor vehicle showing my new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a left side elevation view thereof;
FIG. 5 is a right side elevation view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.
The broken lines are for illustration purposes only and form no part of the claimed design. The black portions of the vehicle seat indicate color contrast with the non-black portions of the vehicle seat. The particular color black is not claimed.

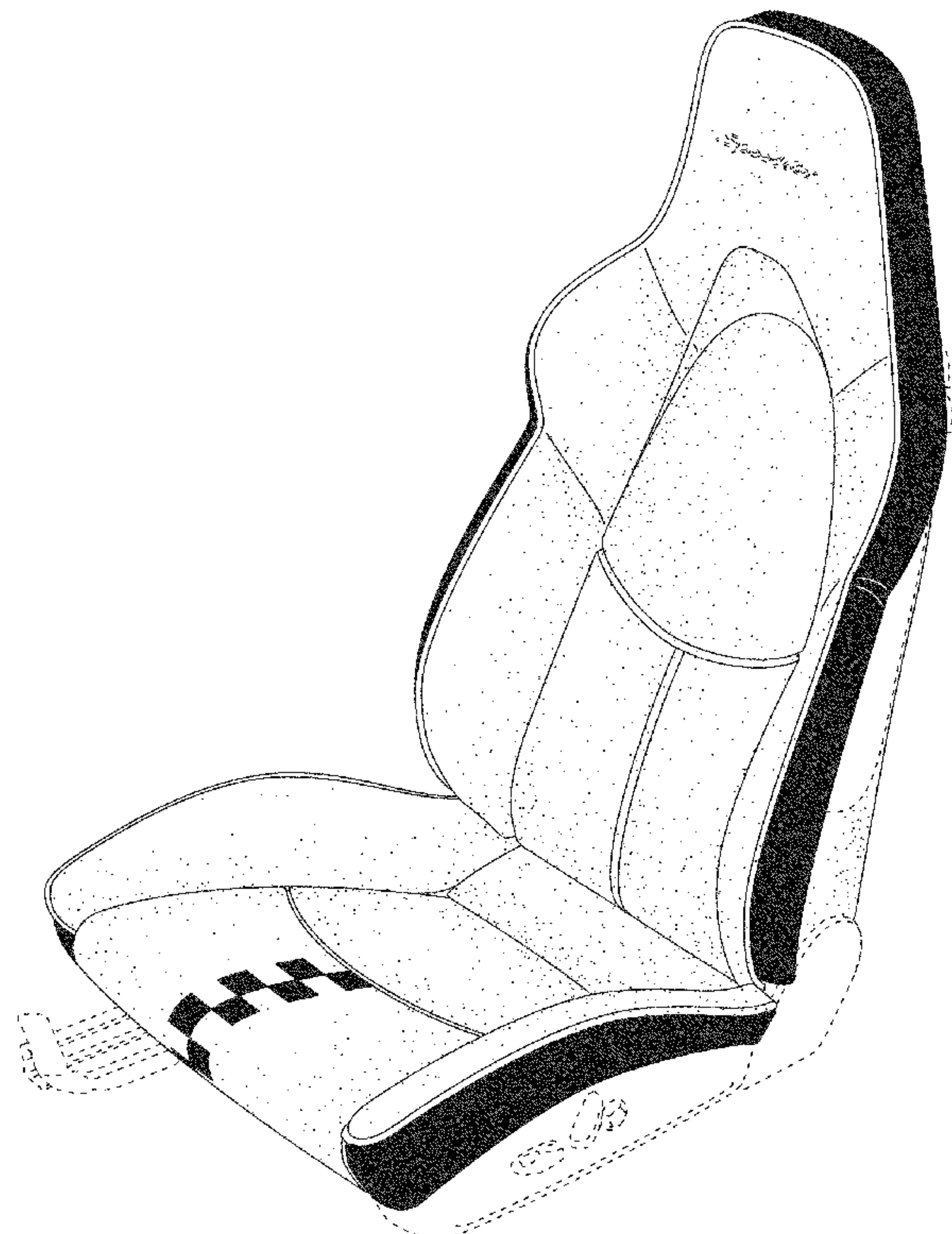

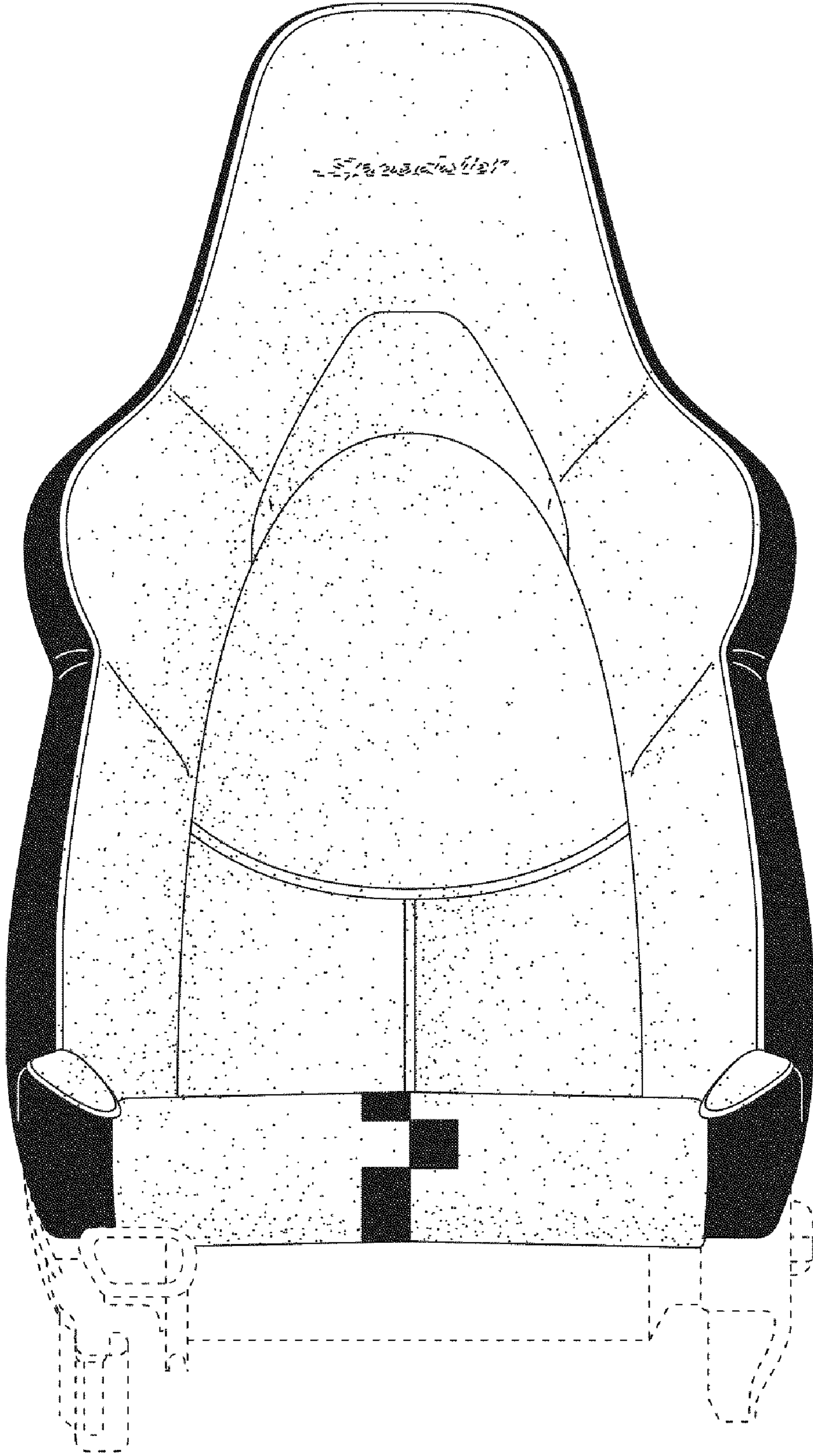

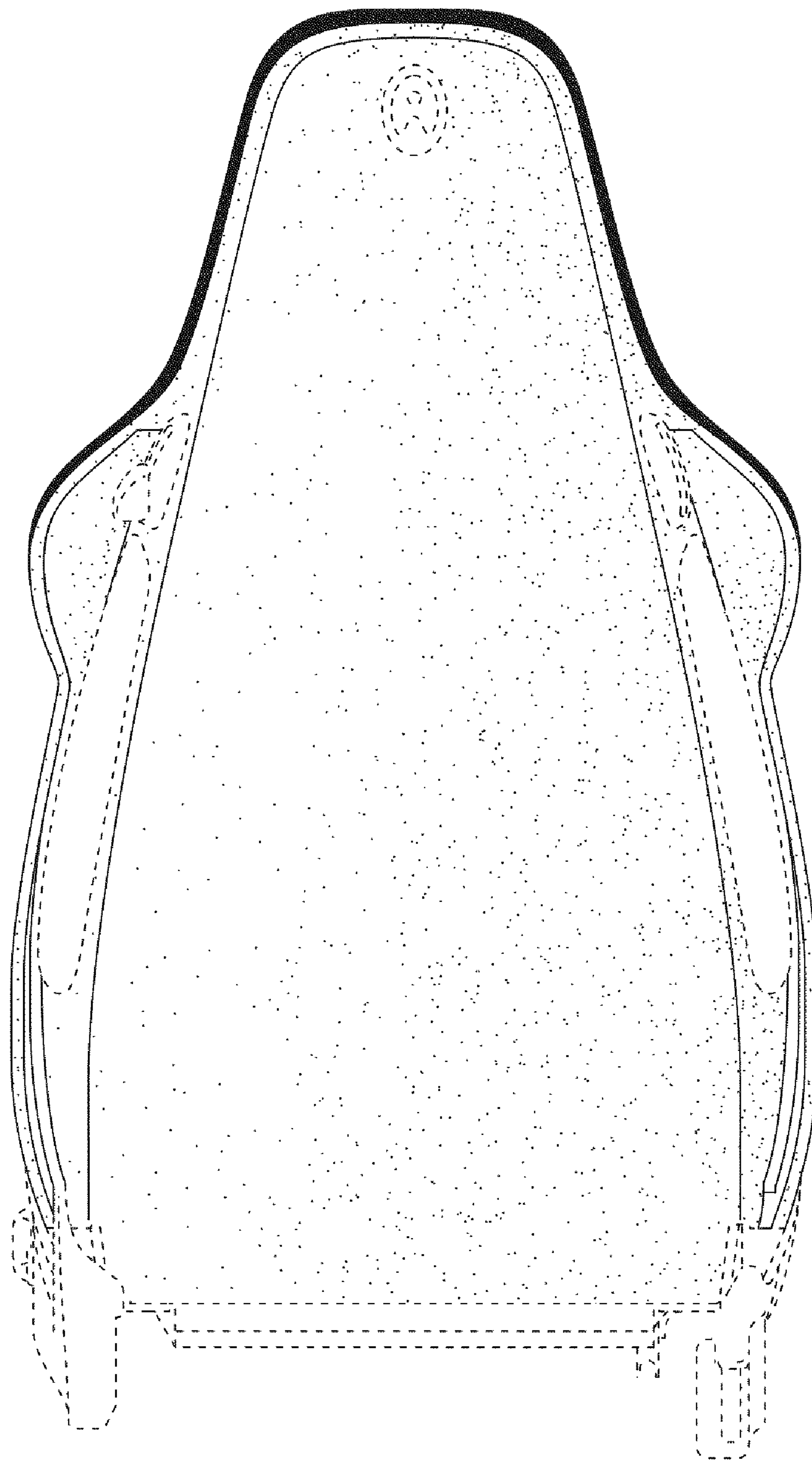

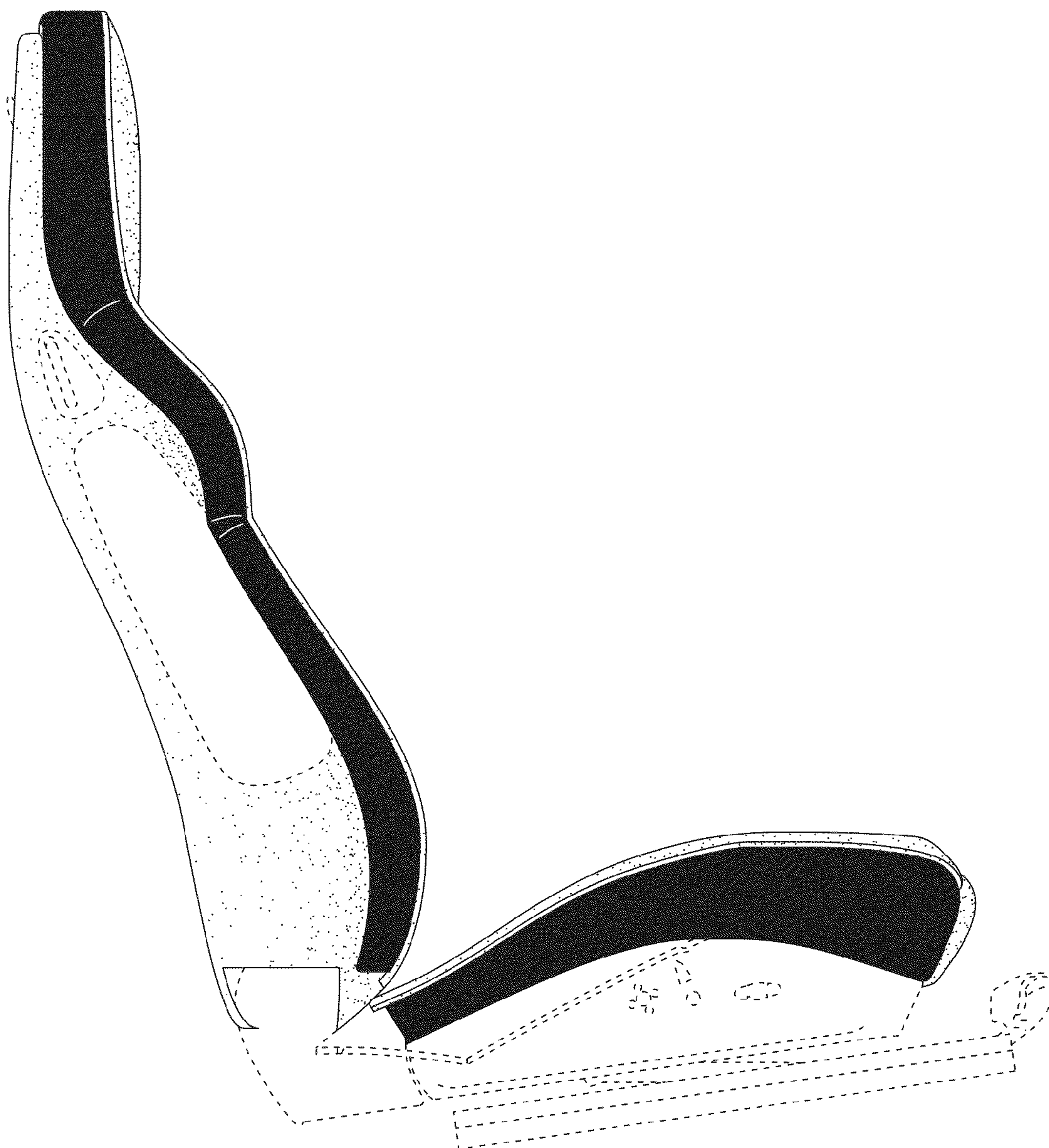

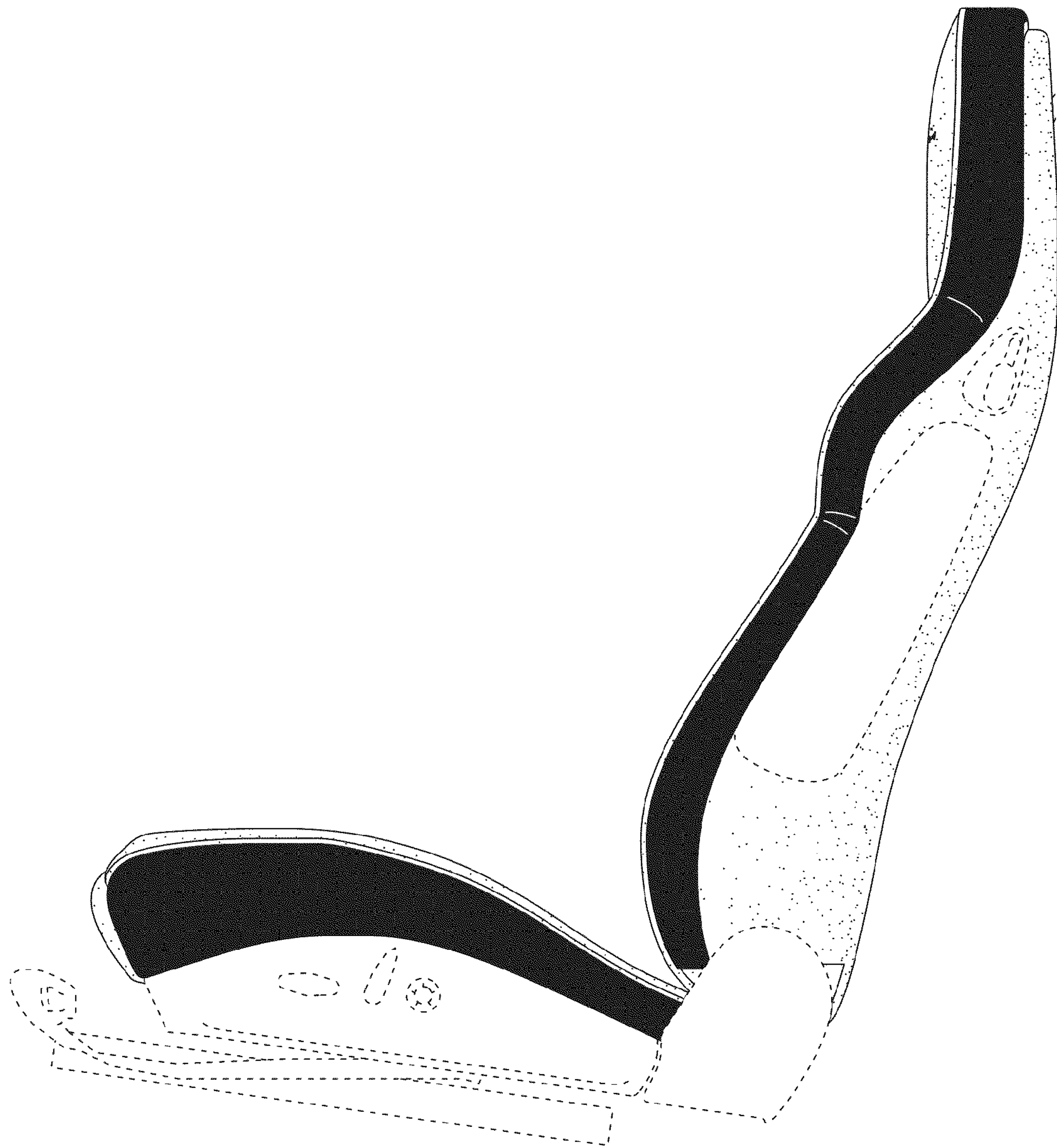

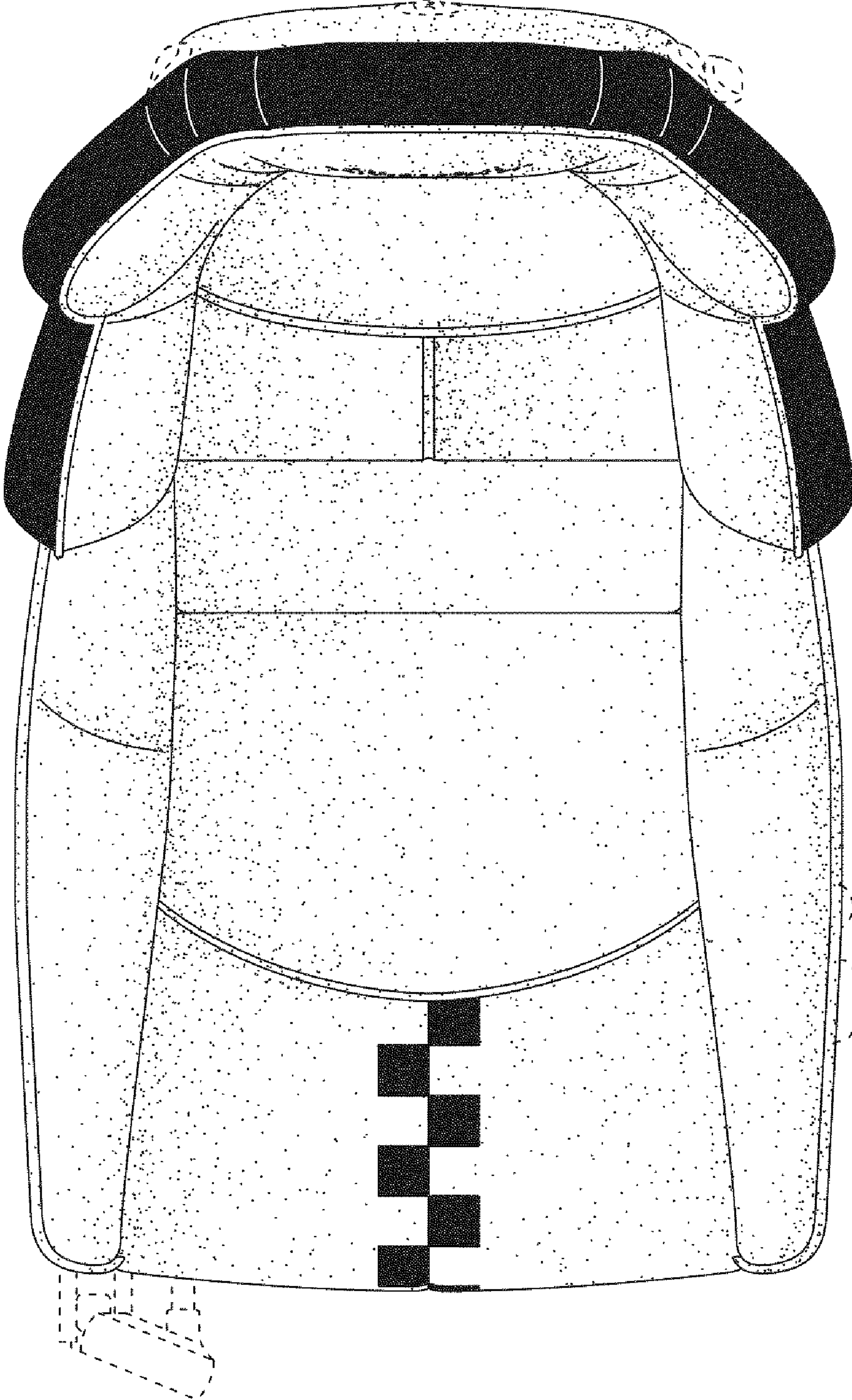

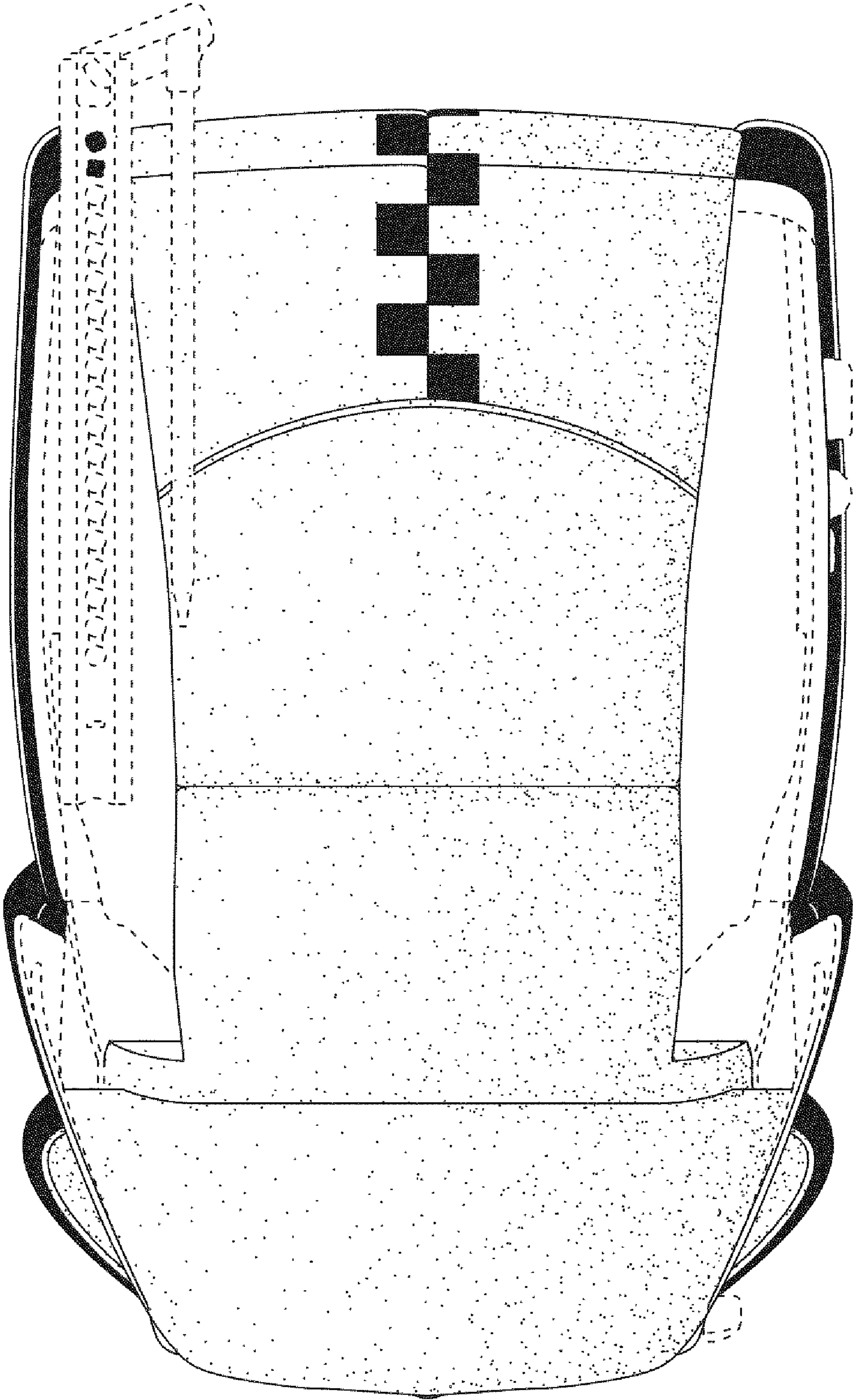
