The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a bottle showing my new design, the rear elevational view being a mirror image thereof;

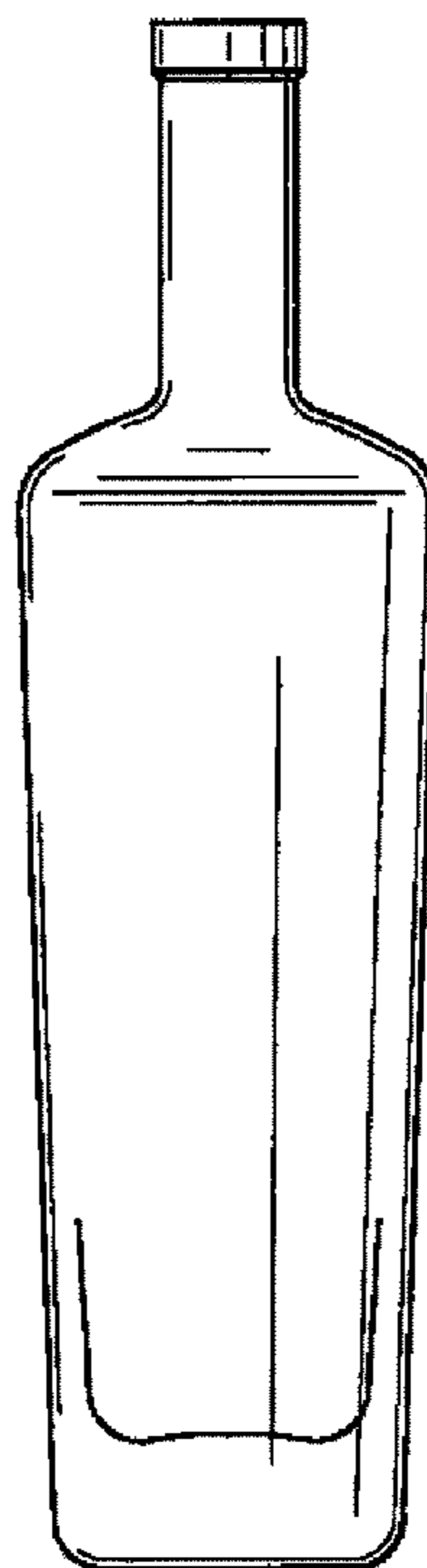
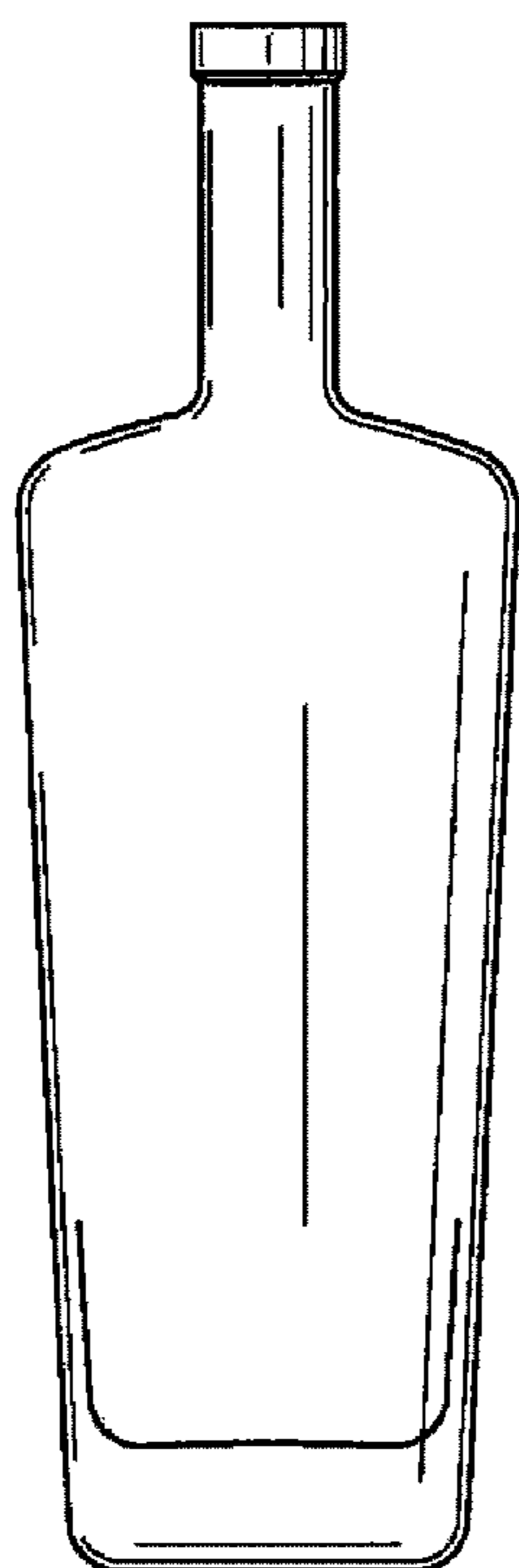
FIG. 2 is a right side elevational view thereof, the left side elevational view being a mirror image of the right side elevational view;

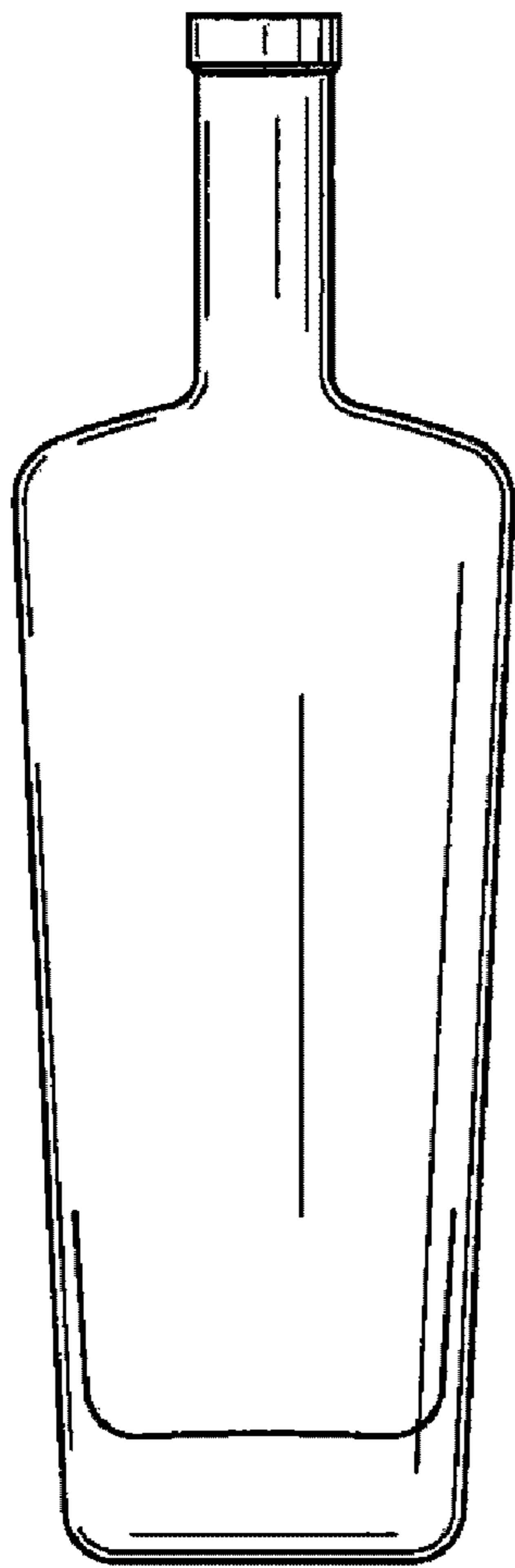

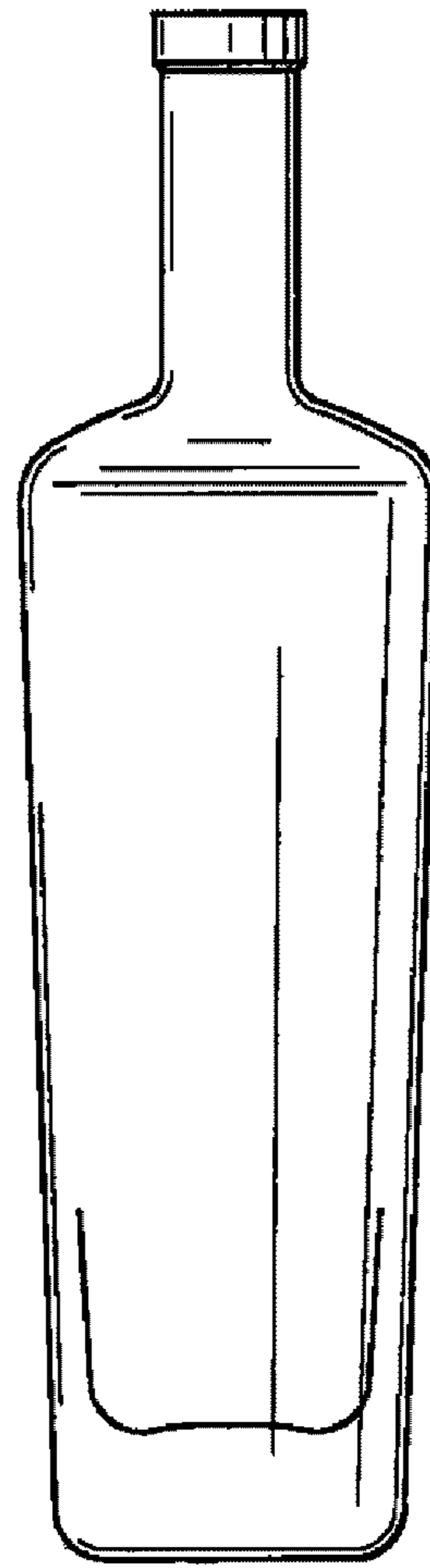

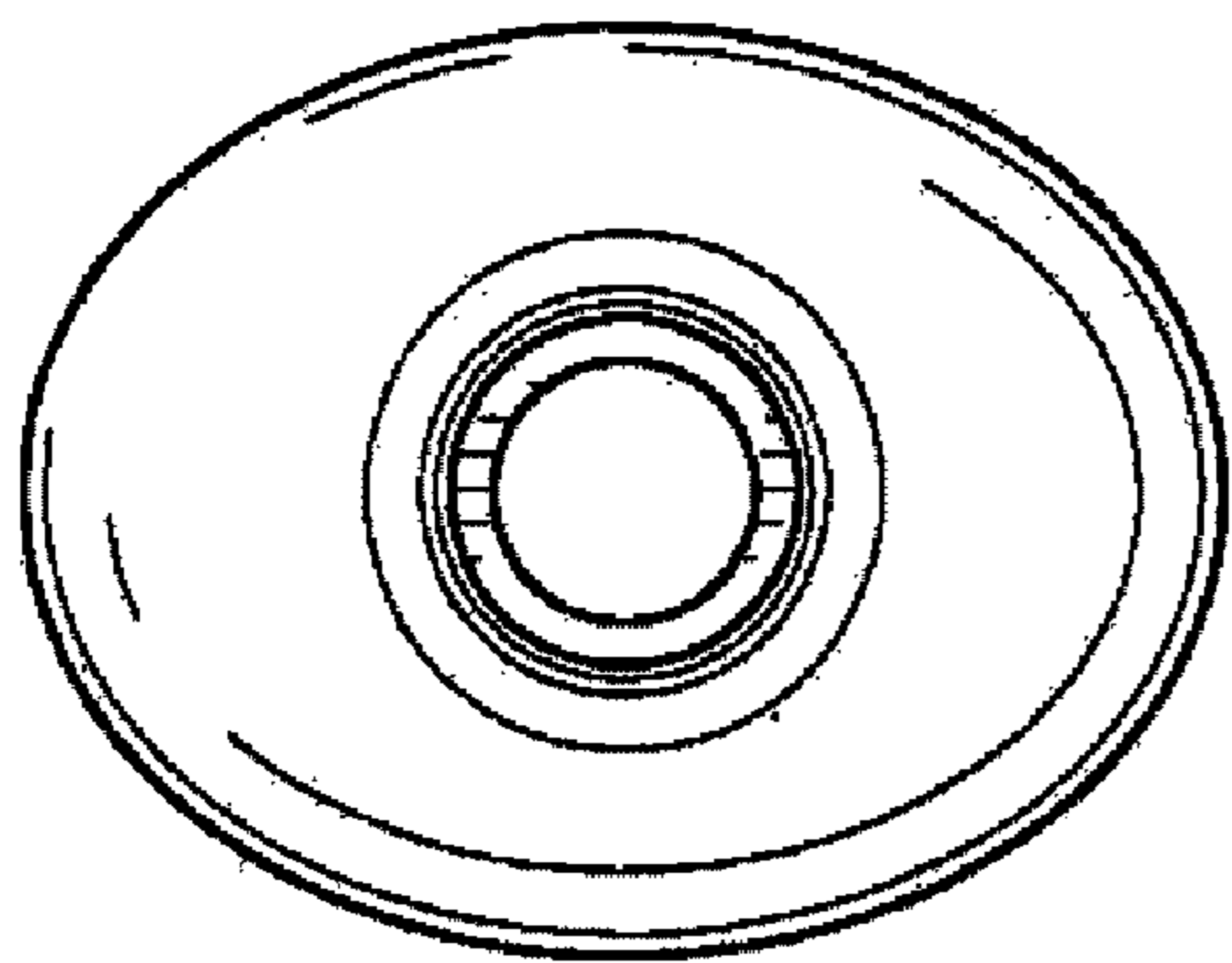

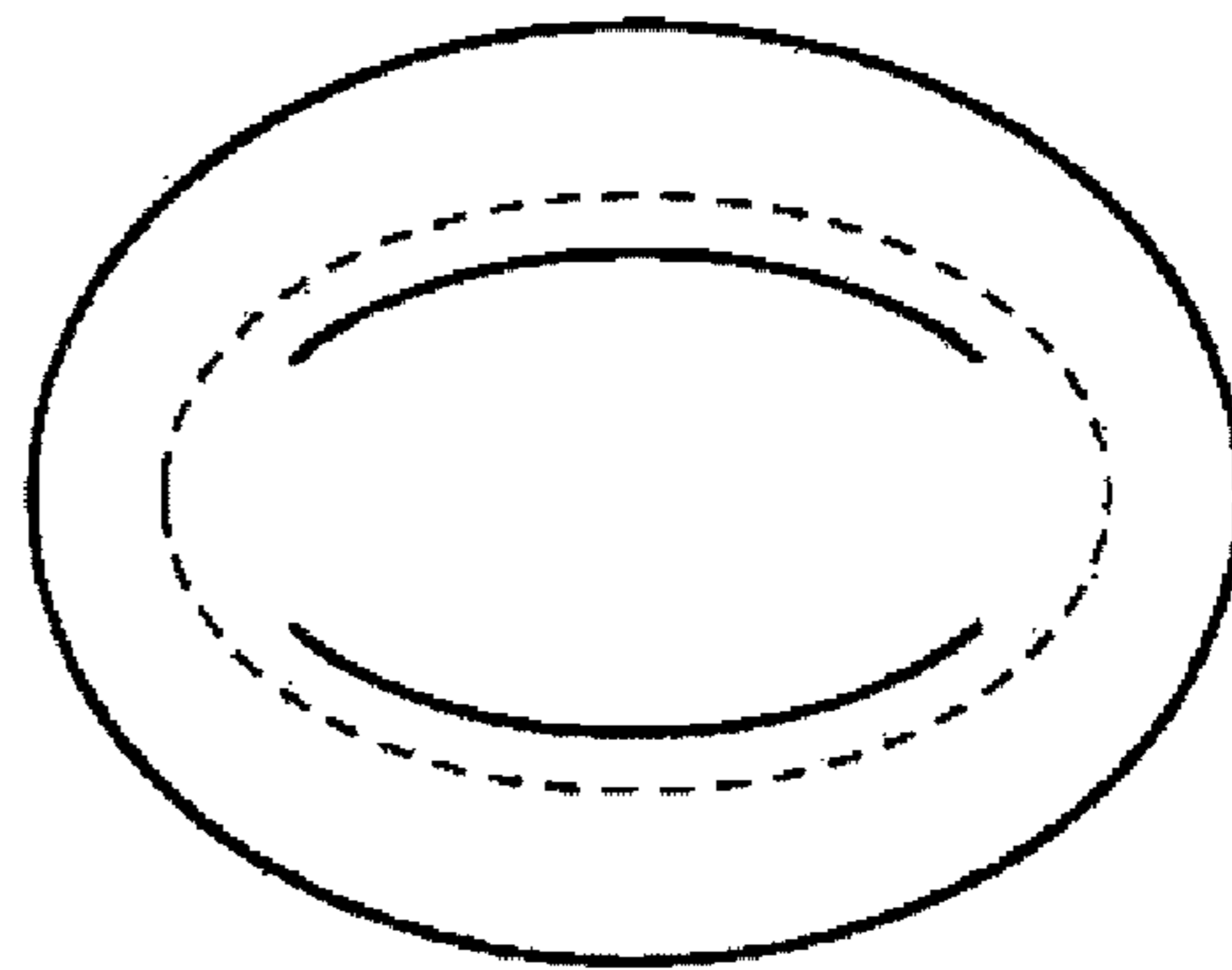
