The ornamental design for a container and lid, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the design of a container and lid;

FIG. 2 is an exploded front perspective view of the container and lid shown in FIG. 1;

FIG. 6 is a left side view of the container and lid shown in FIG. 1;

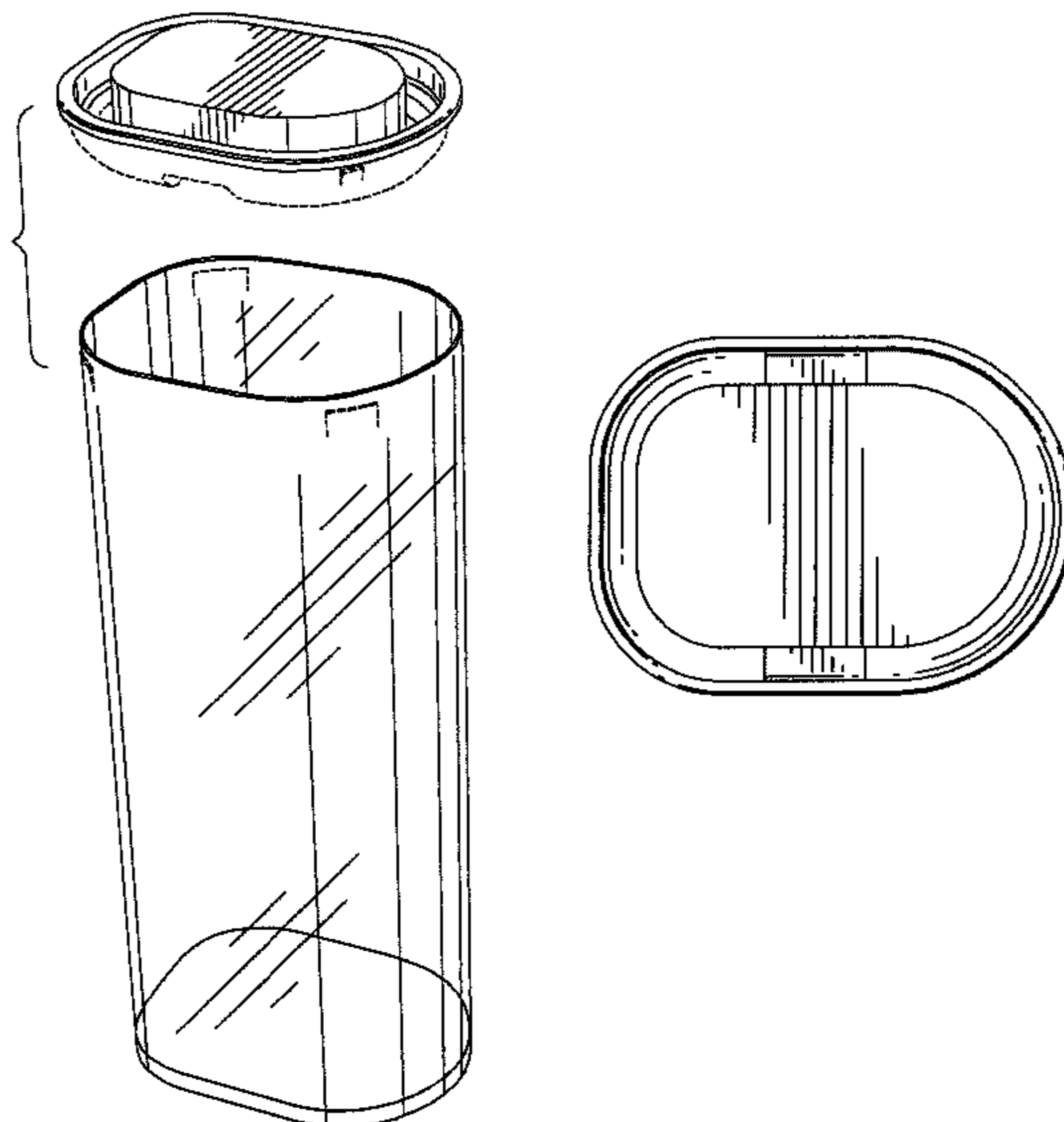
FIG. 7 is a back side view of the container and lid shown in FIG. 1;

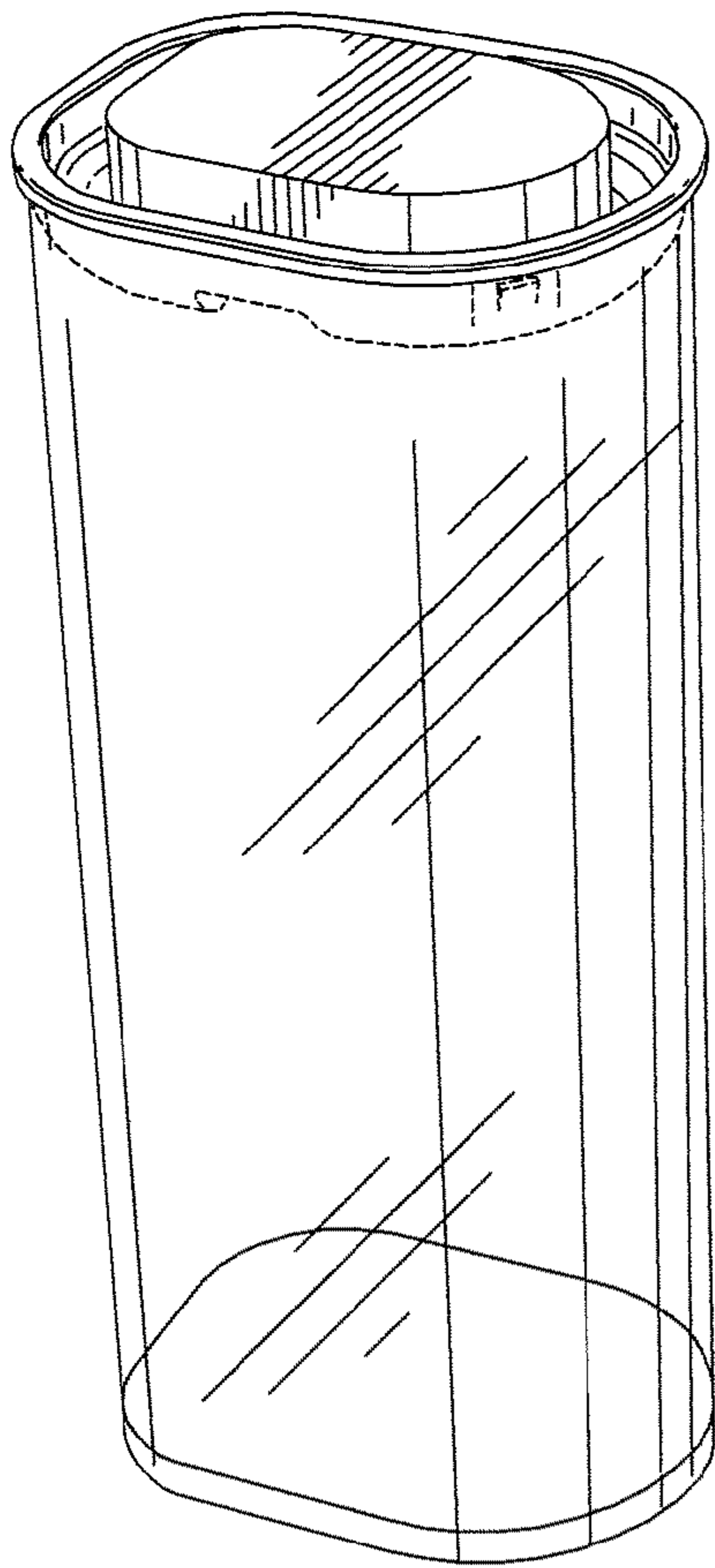

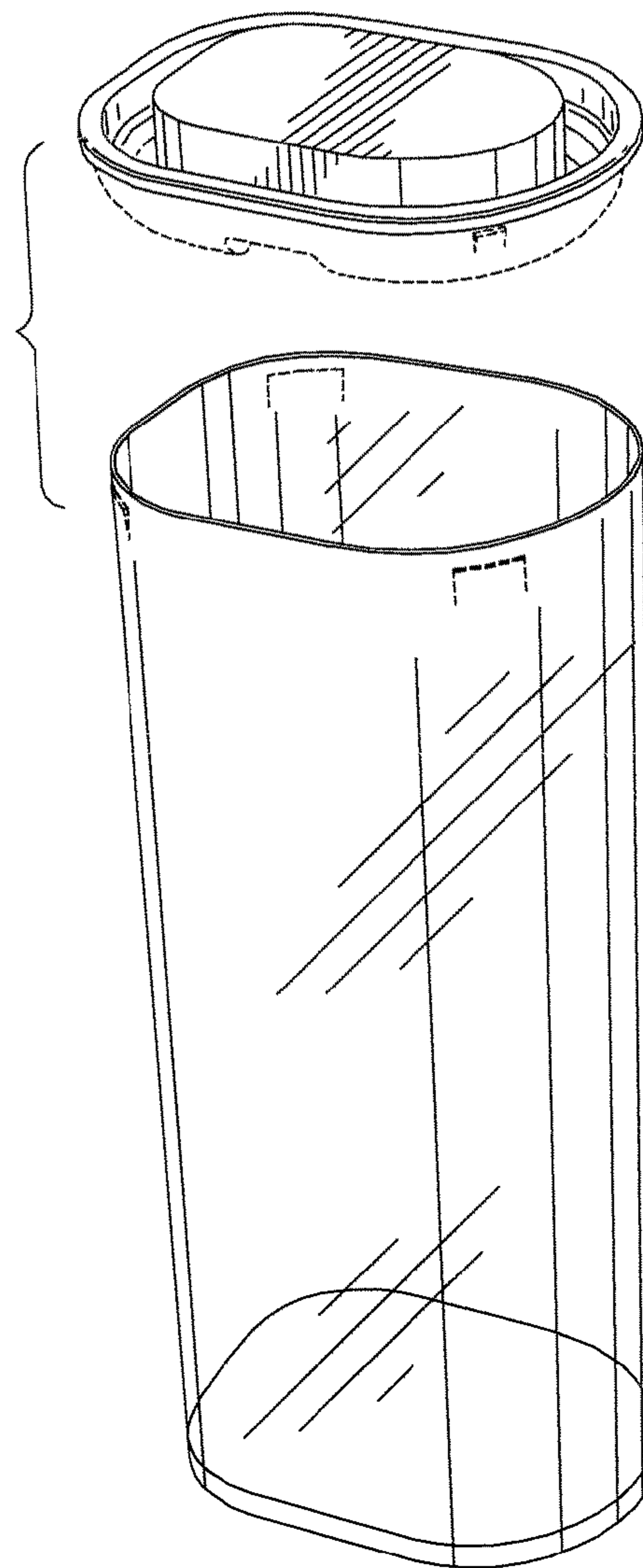

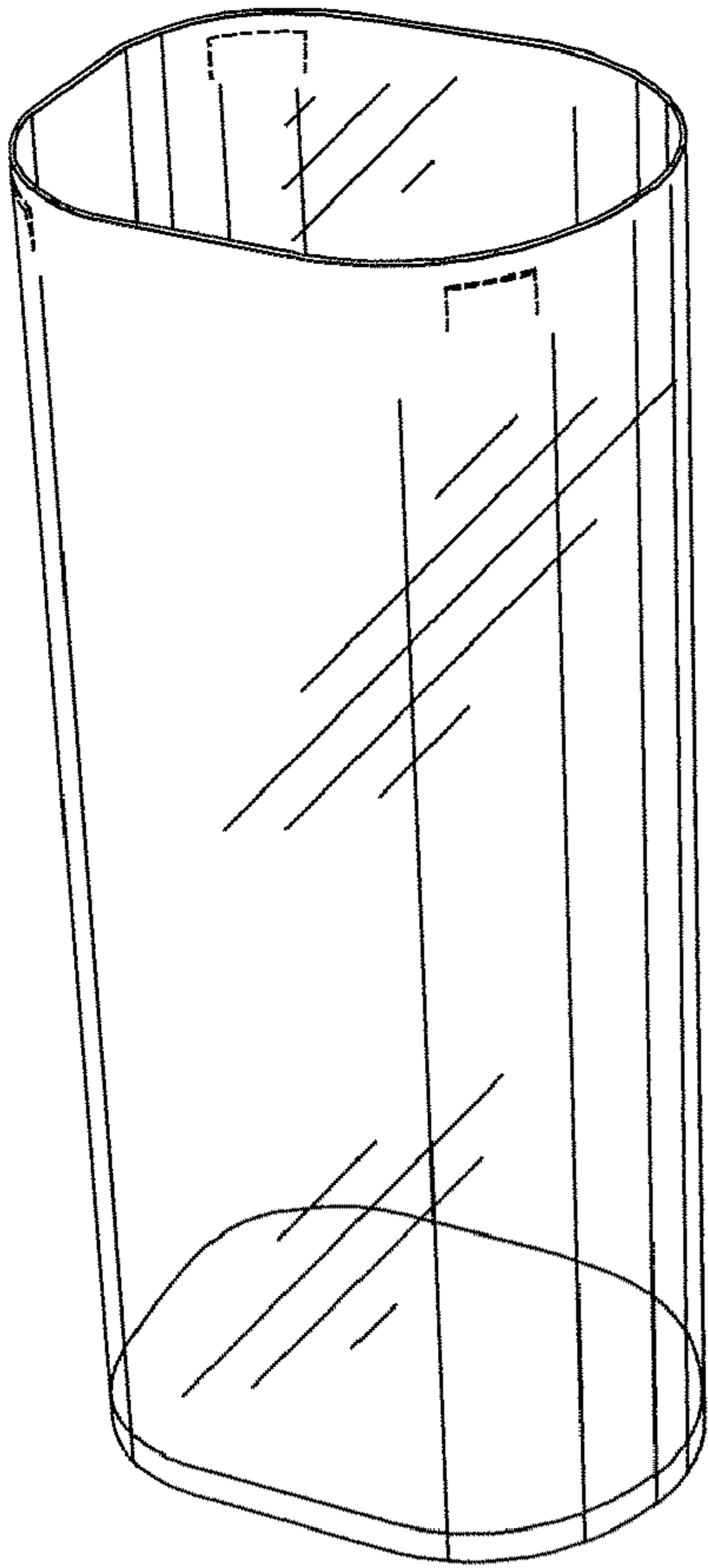

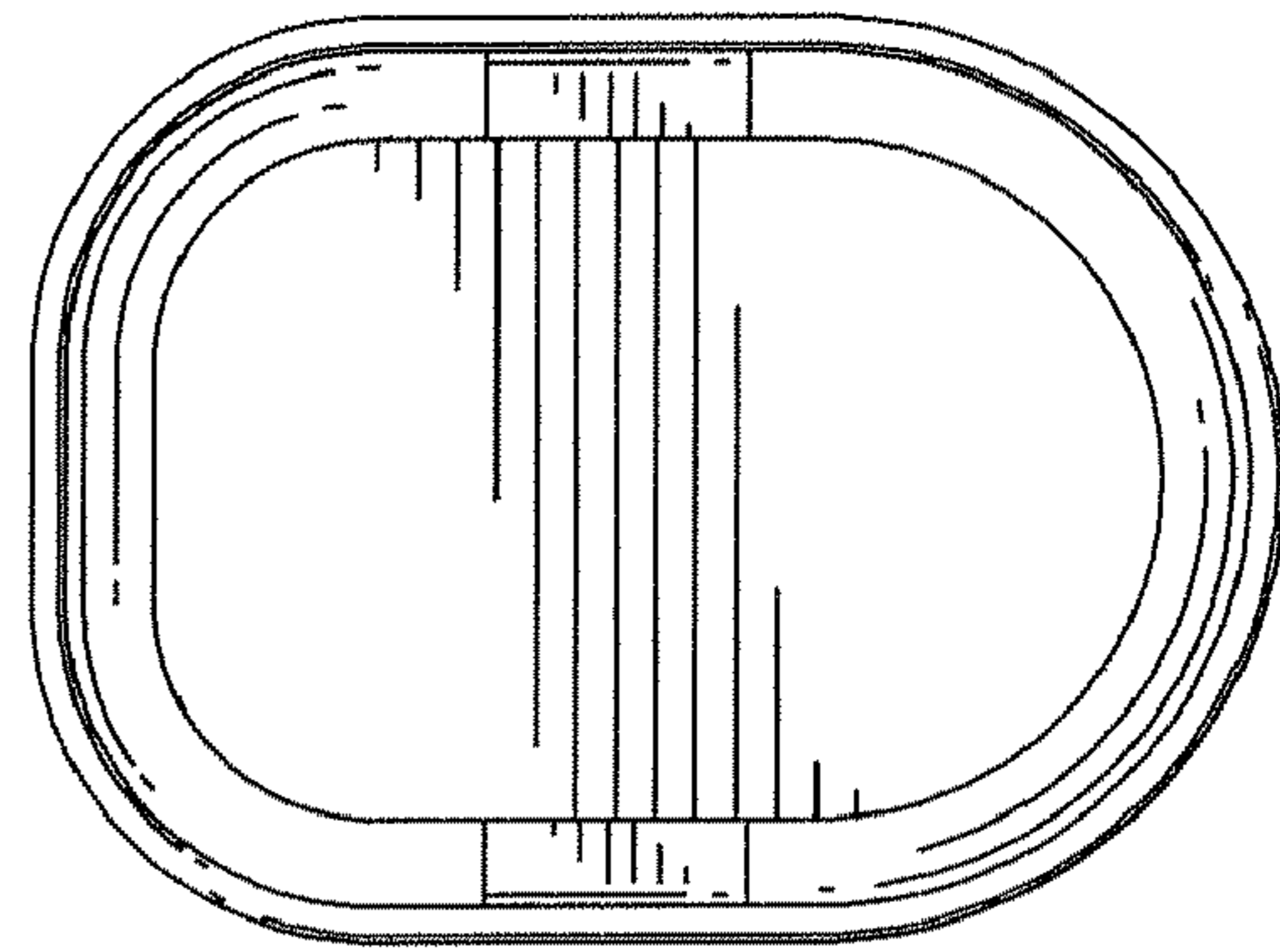

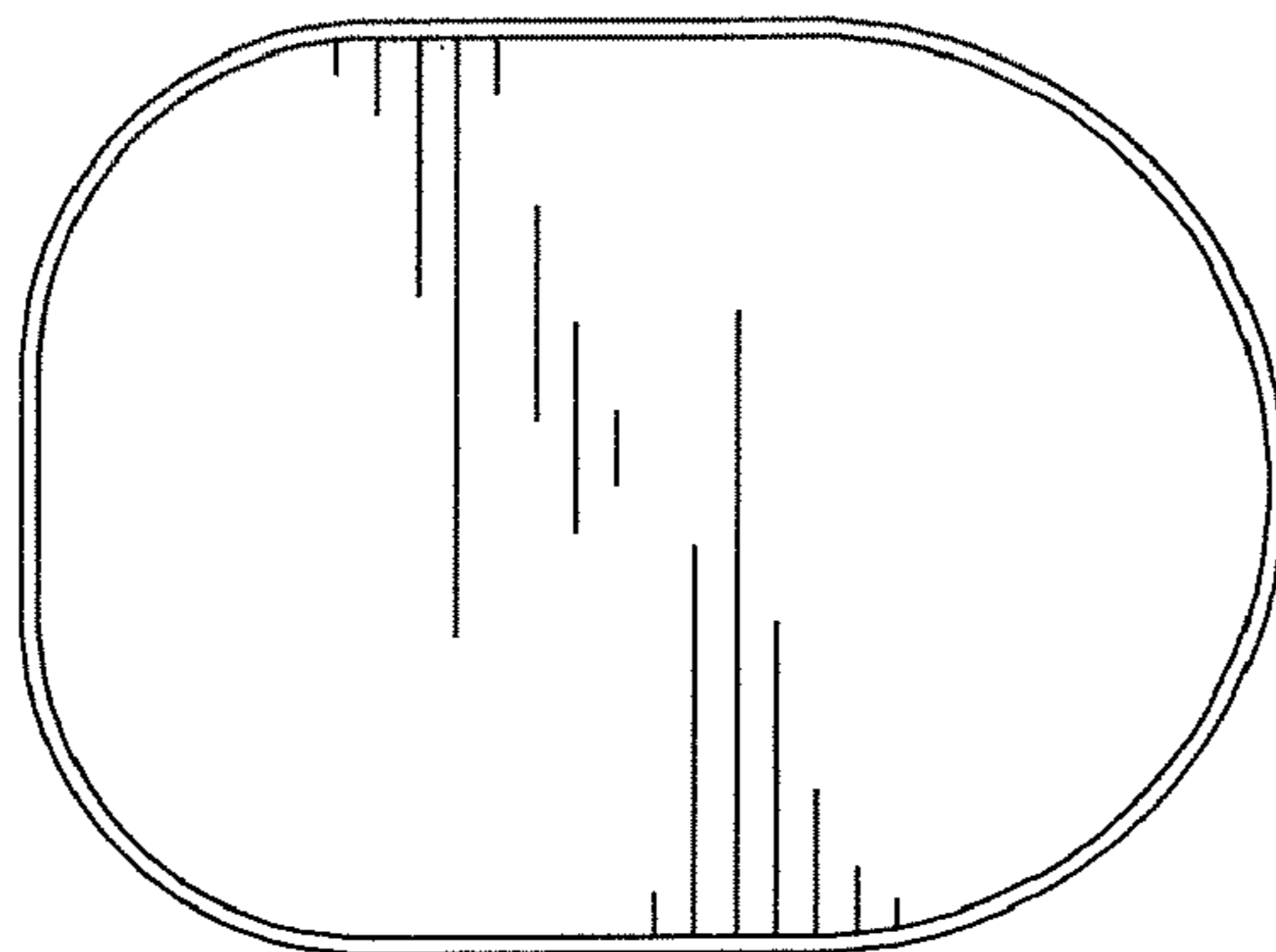

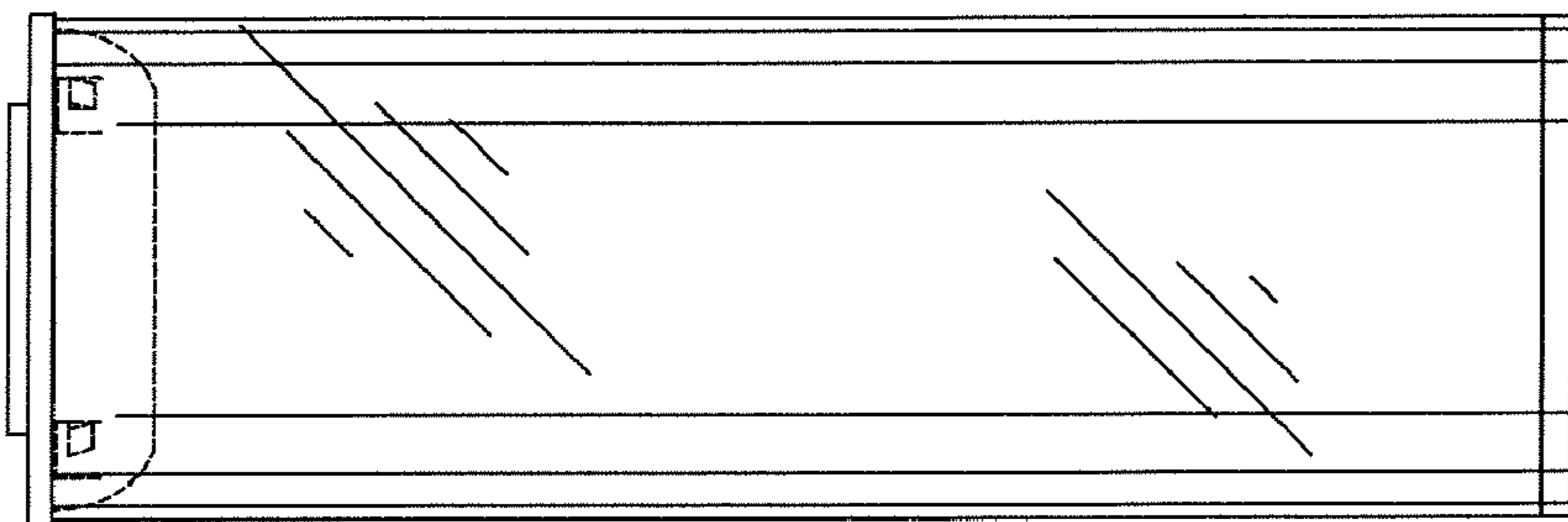

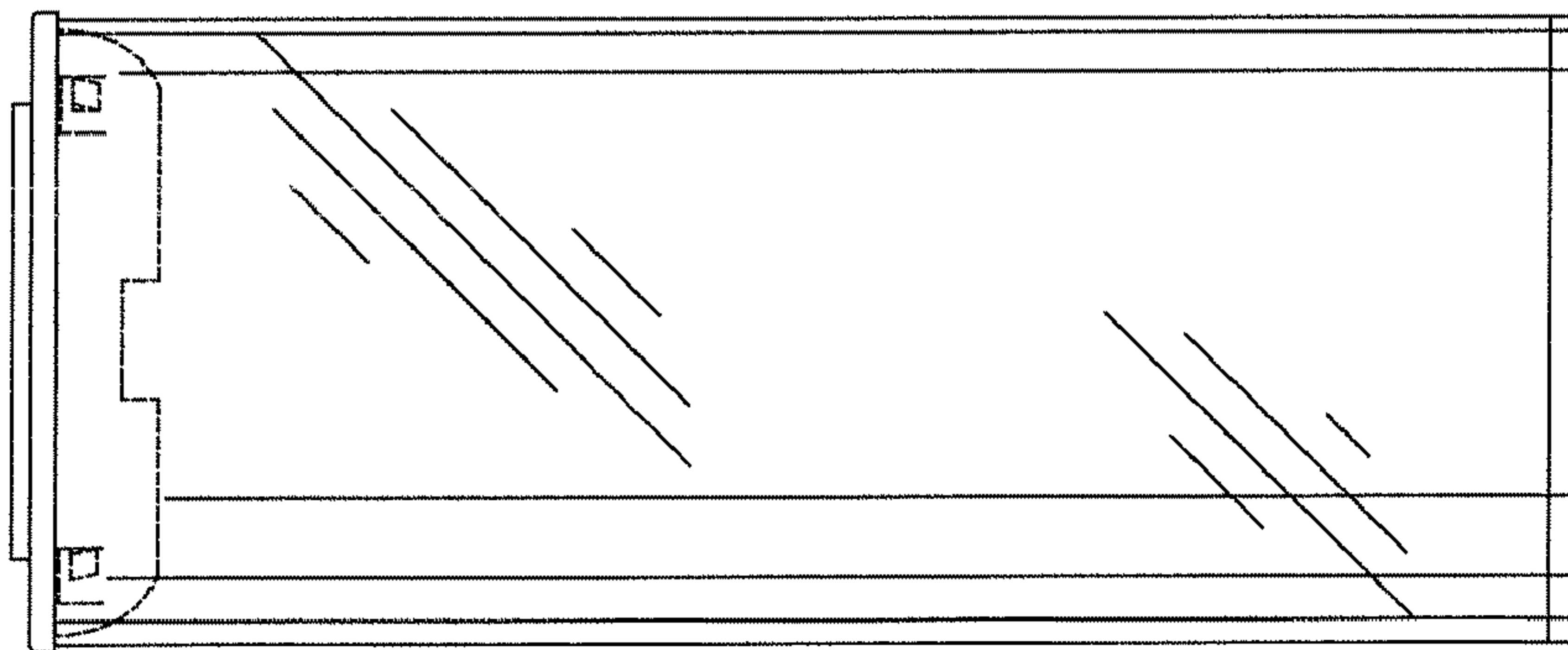

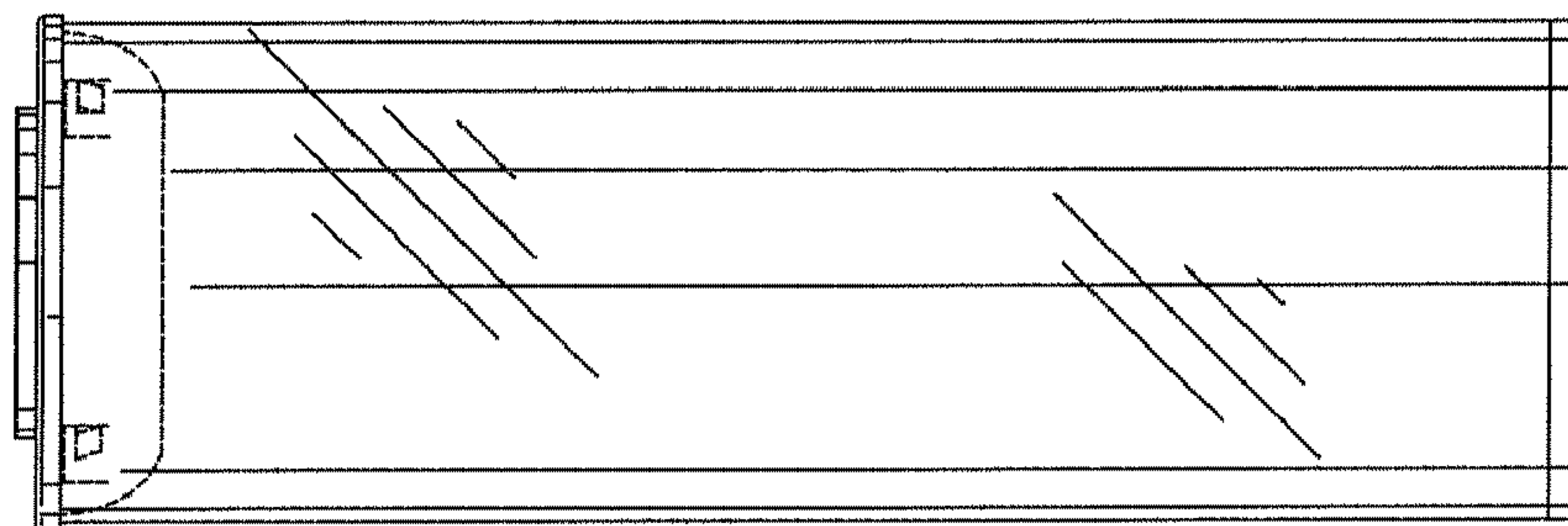

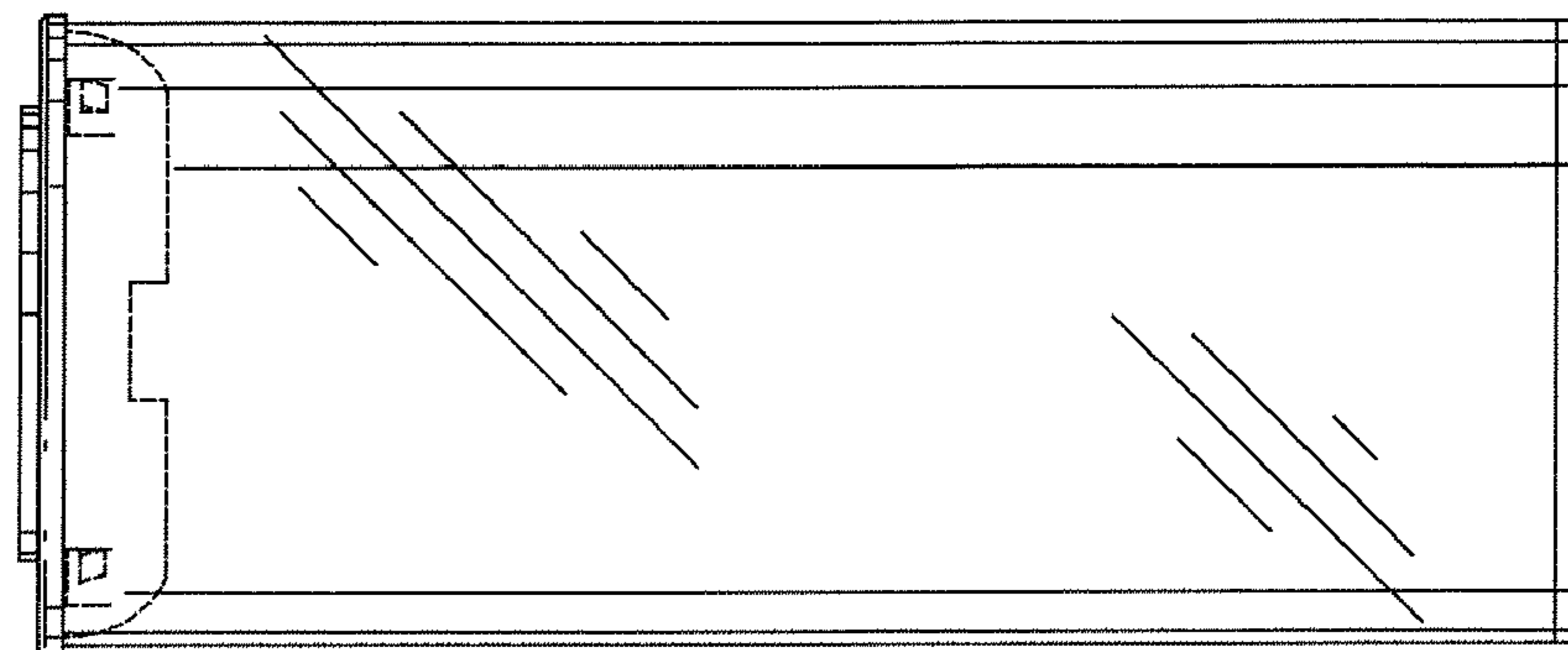
