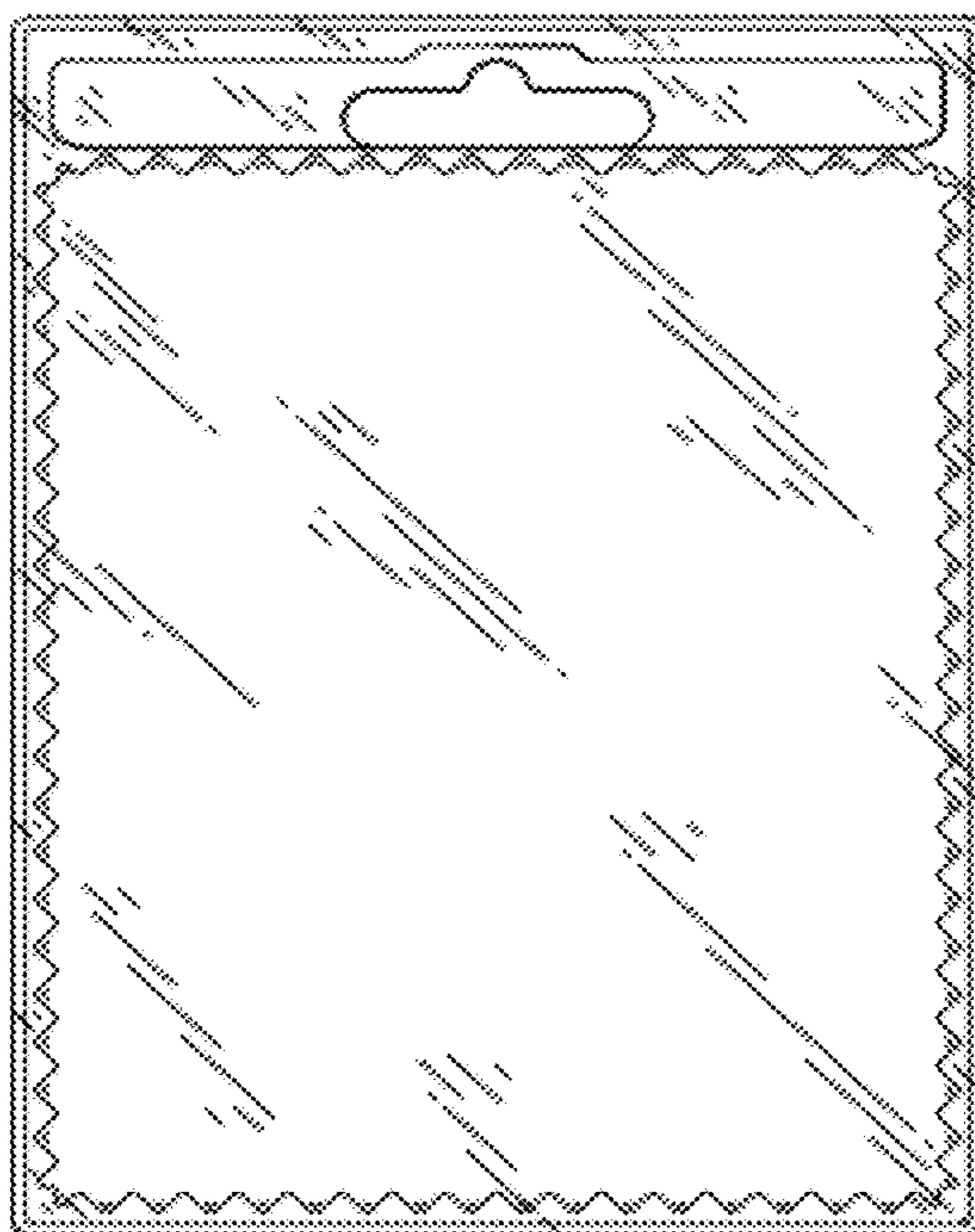
(57) **CLAIM**

The ornamental design for a clear plastic gift card package, as shown and described.

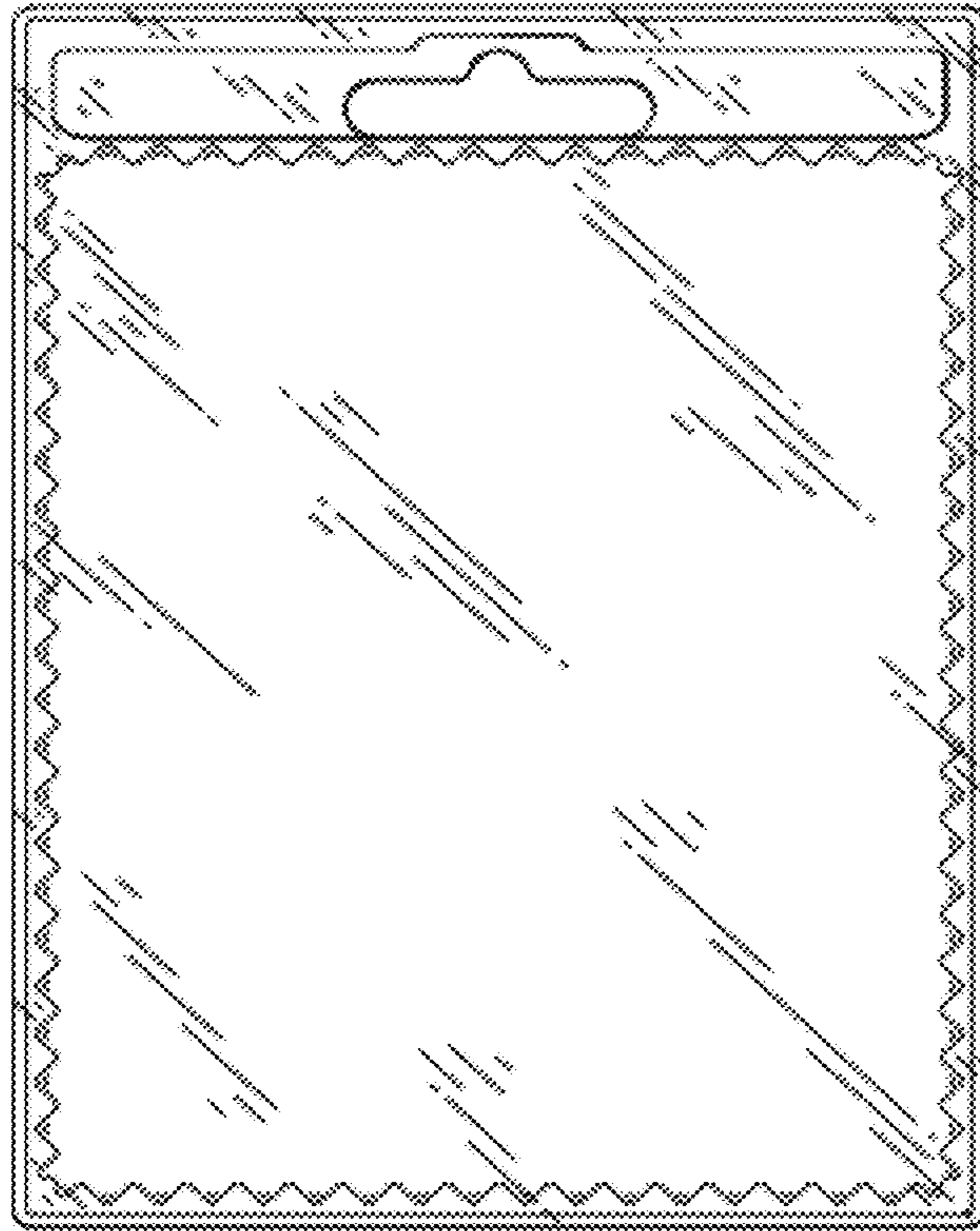
**DESCRIPTION**

FIG. 1 is a front view of the clear plastic gift card package showing our new design;  
 FIG. 2 is a rear view thereof;  
 FIG. 3 is a left side view thereof;  
 FIG. 4 is a right side view thereof;

 FIG. 6 is a bottom view thereof;  
 FIG. 7 is a front view of FIG. 1 with printed or card insert material shown in broken lines; and,  
 FIG. 8 is a rear view of FIG. 1 with printed or card insert material and a cutout shown in broken lines.  
 The broken line showing of printed or card insert material in FIGS. 7 and 8 and the cutout shown in FIG. 8 is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

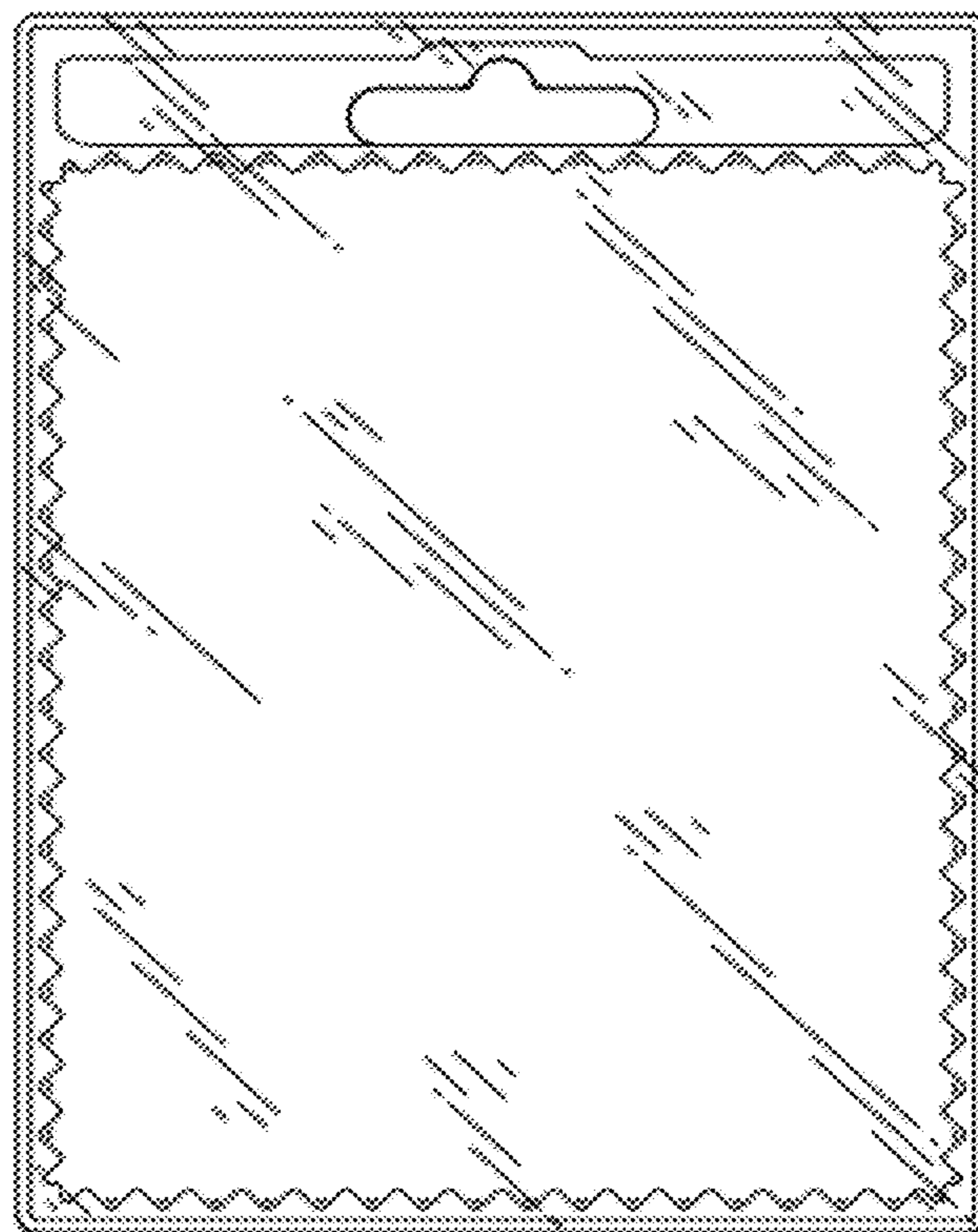

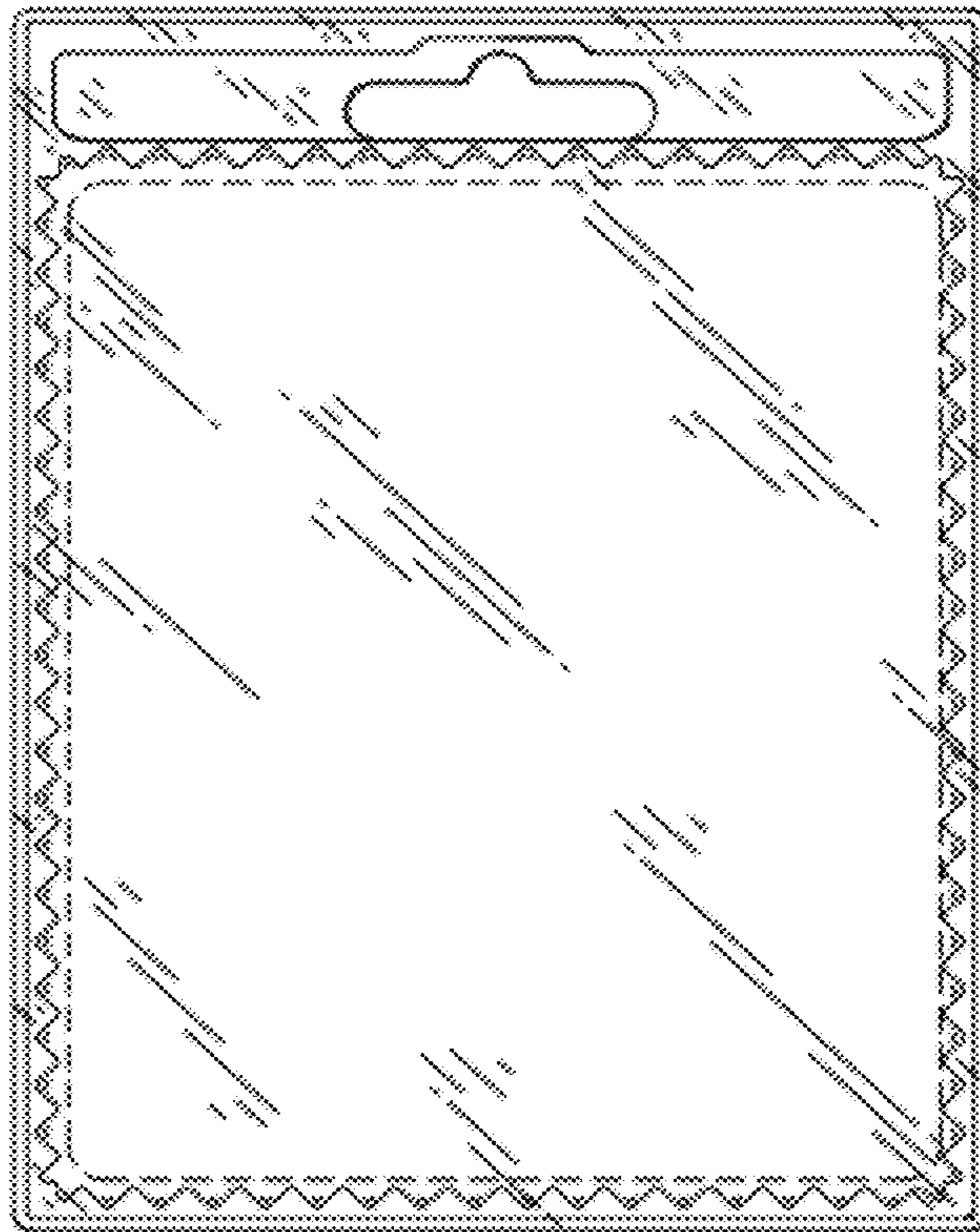
