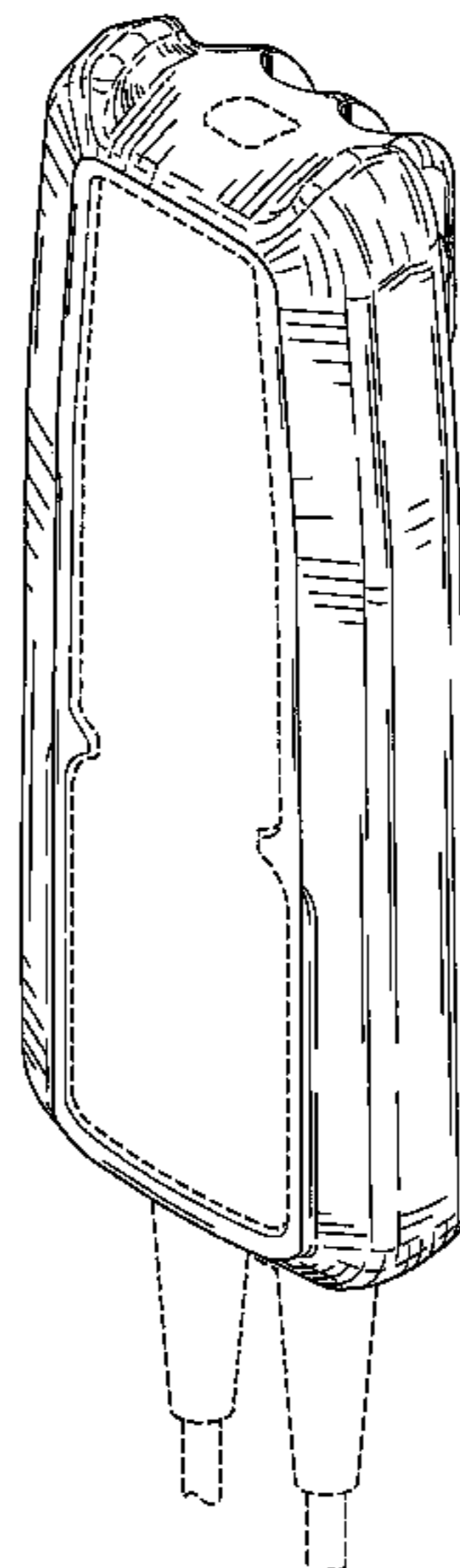
(57) **CLAIM**

The ornamental design for an electrical tester, as shown and described.

**DESCRIPTION**

FIG. 1 is an electrical tester in a perspective view; FIG. 2 is a left side view thereof; FIG. 3 is a front view thereof; FIG. 4 is a right side view thereof; FIG. 5 is a rear view thereof; FIG. 6 is a top side view thereof; and FIG. 7 is a bottom view thereof. FIG. 8 is a second embodiment of an electrical tester in a perspective view; FIG. 9 is a left side view thereof; FIG. 10 is a front view thereof; FIG. 11 is a right side view thereof; FIG. 12 is a rear view thereof; FIG. 13 a top side view thereof; and, FIG. 14 is a bottom view thereof. FIG. 15 is a third embodiment of an electrical tester in a perspective view; FIG. 16 is a left side view thereof; FIG. 17 is a front view thereof; FIG. 18 is a right side view thereof; FIG. 19 is a rear view thereof; FIG. 20 is a top side view thereof; and, FIG. 21 is a bottom view thereof. The broken lines shown in the drawings represent environmental structure and form no part of the claimed design. The stippled area shown in FIGS. 15-21 is an area having a color that is different than the non-stippled area of the design.

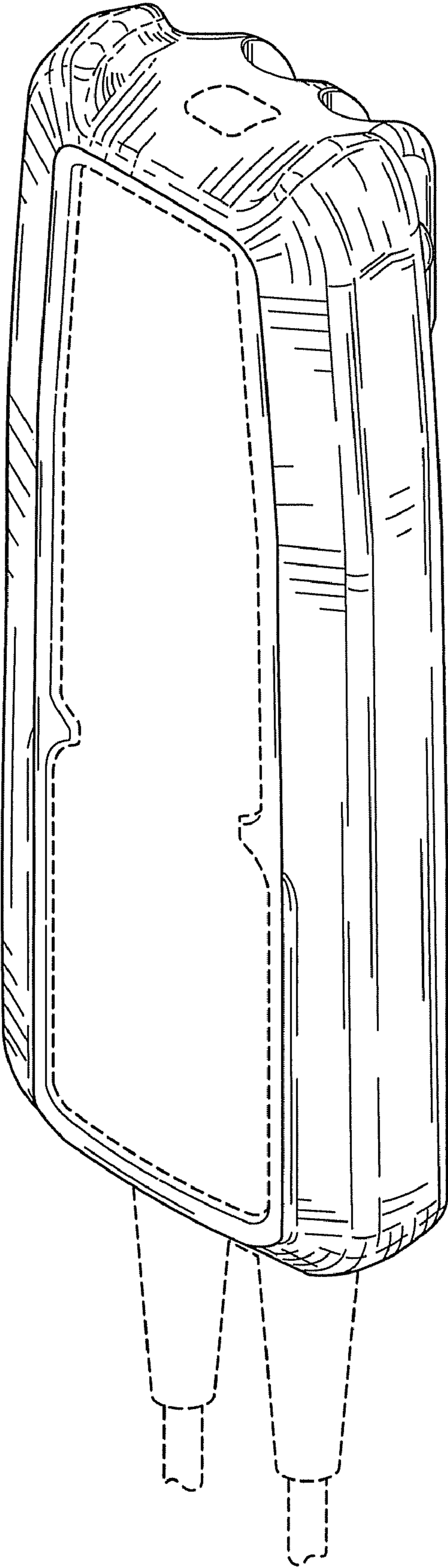

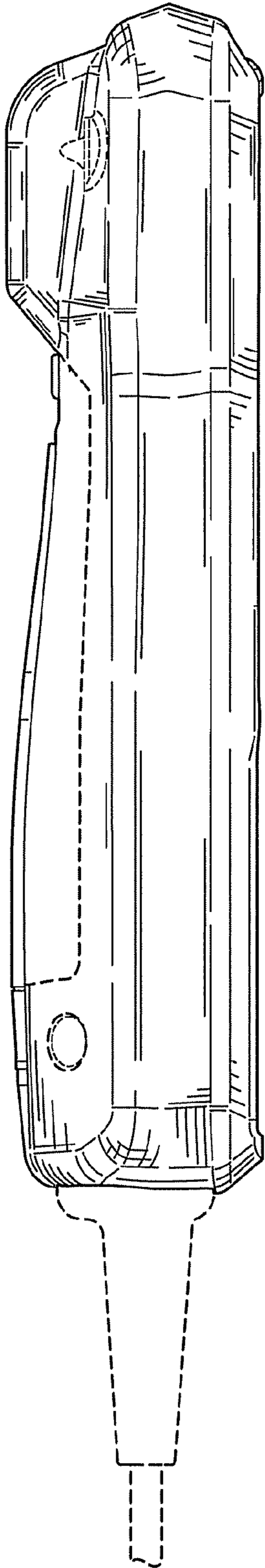

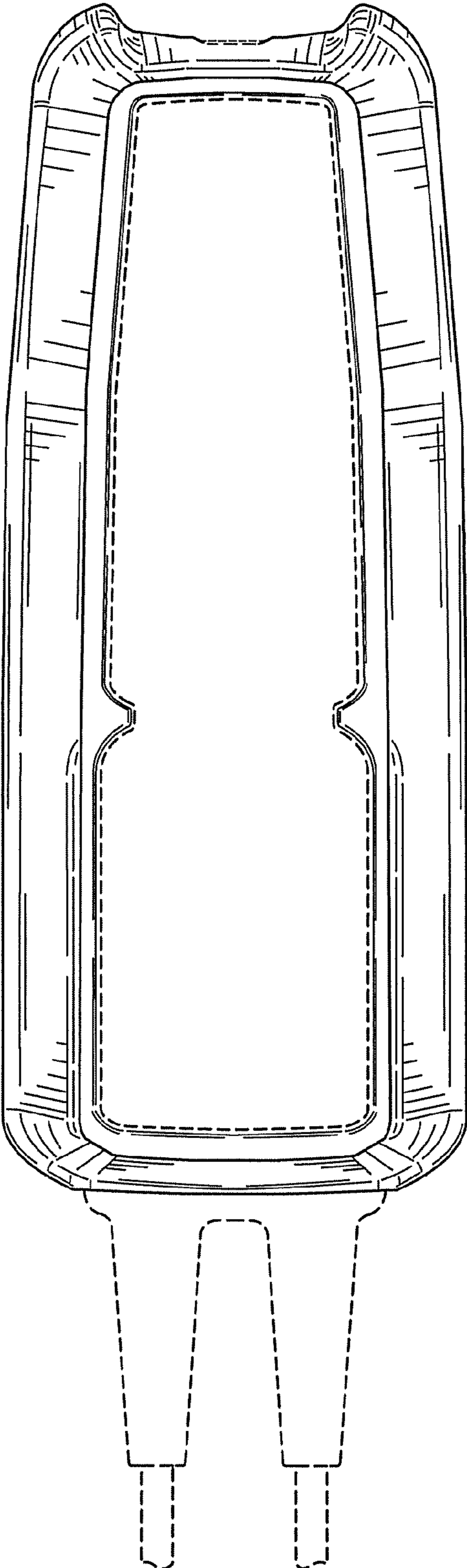

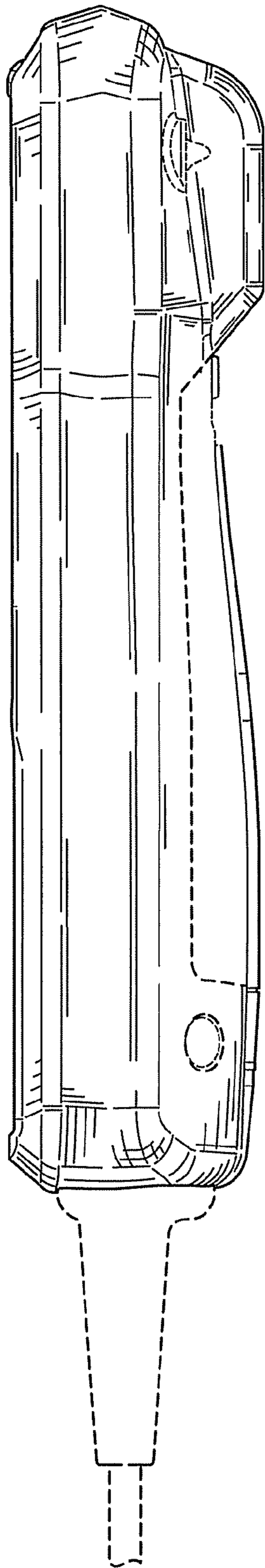

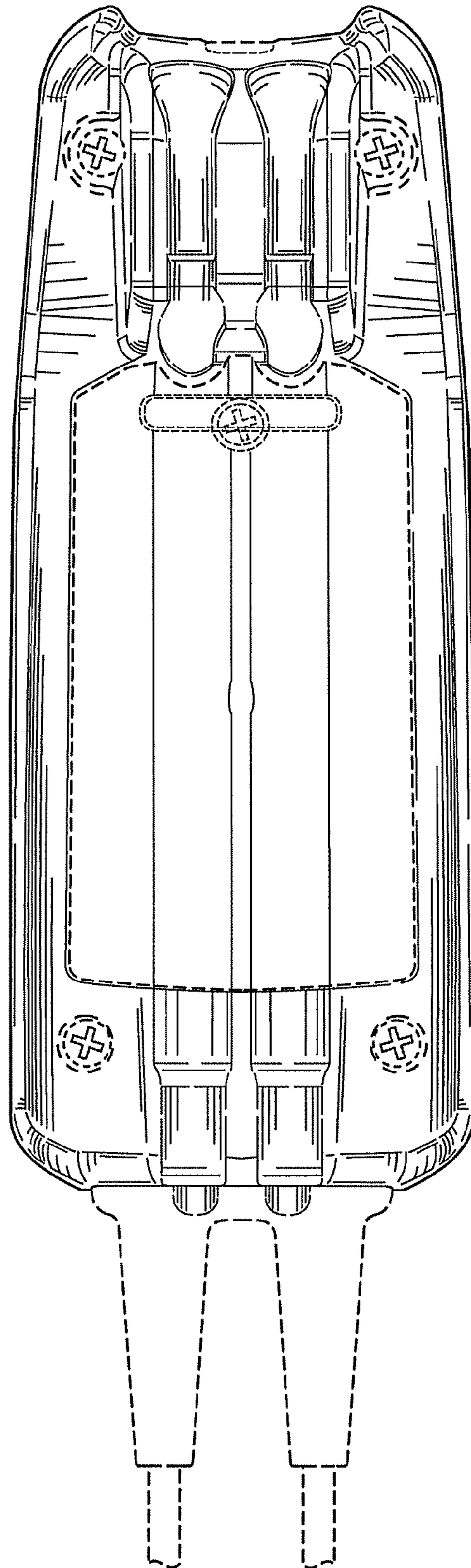

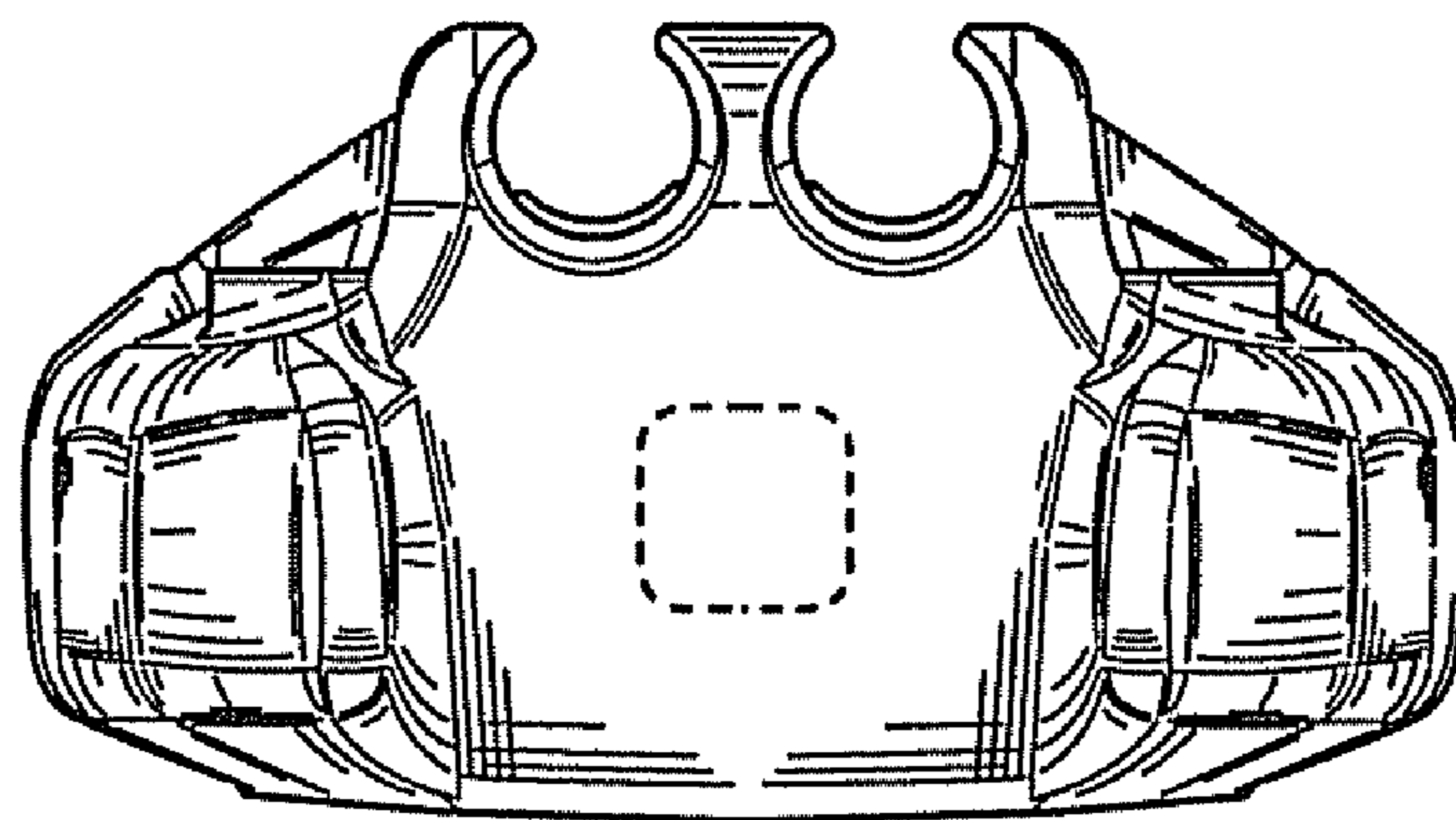

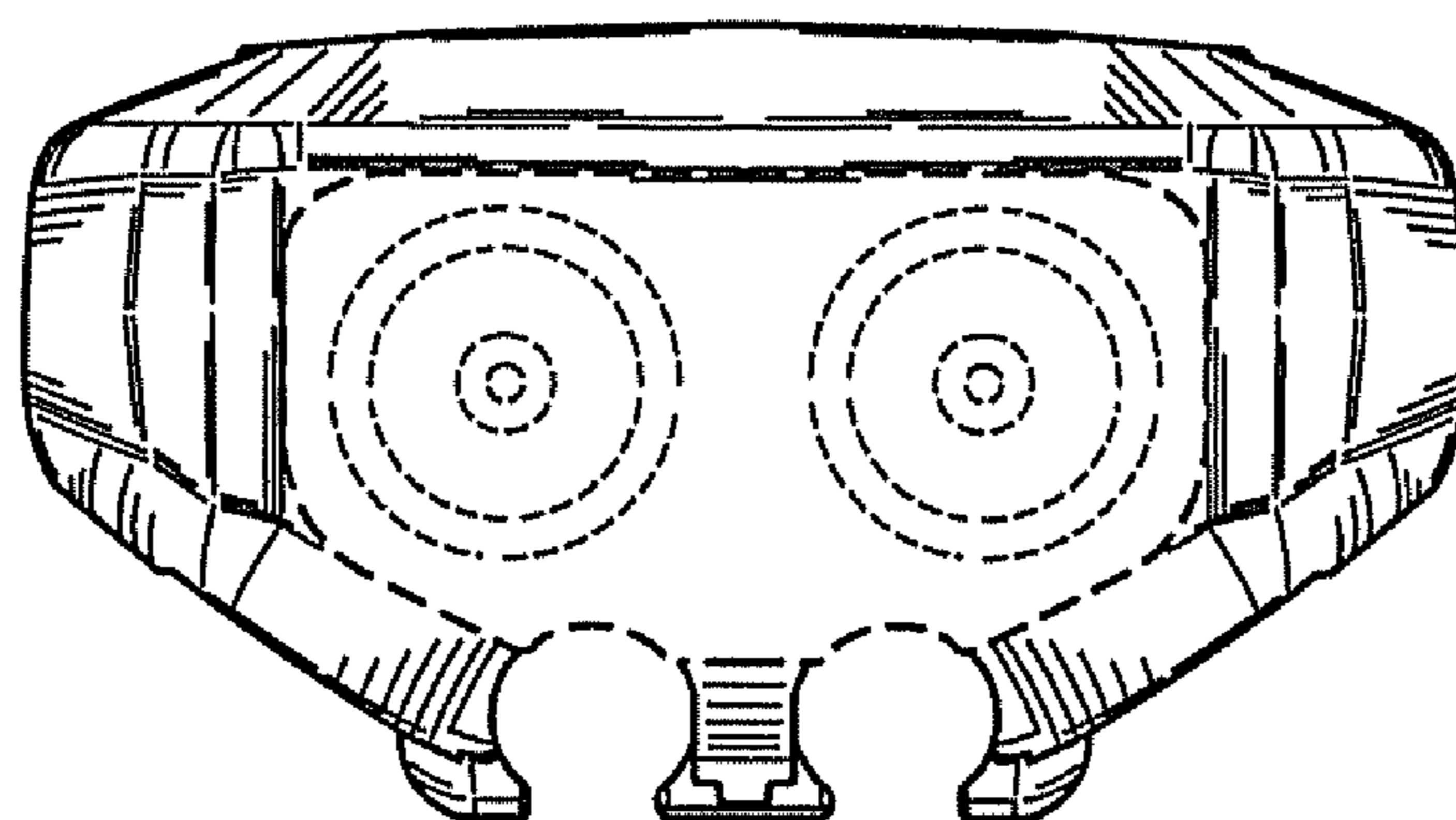

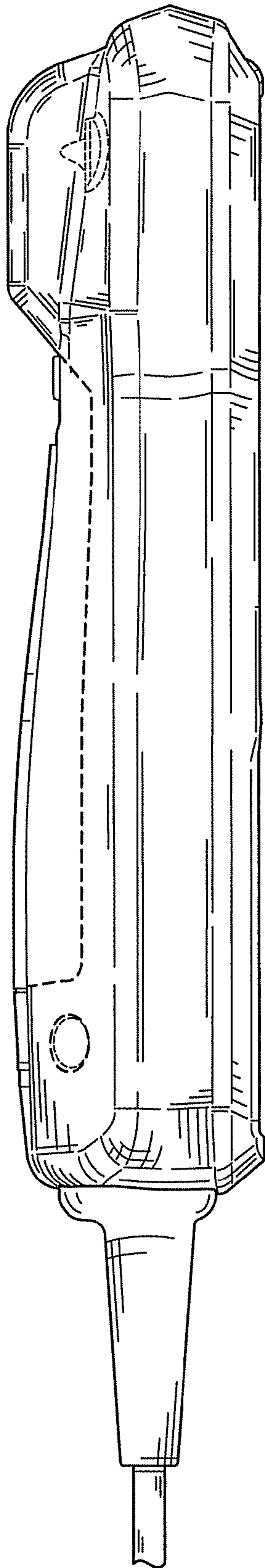

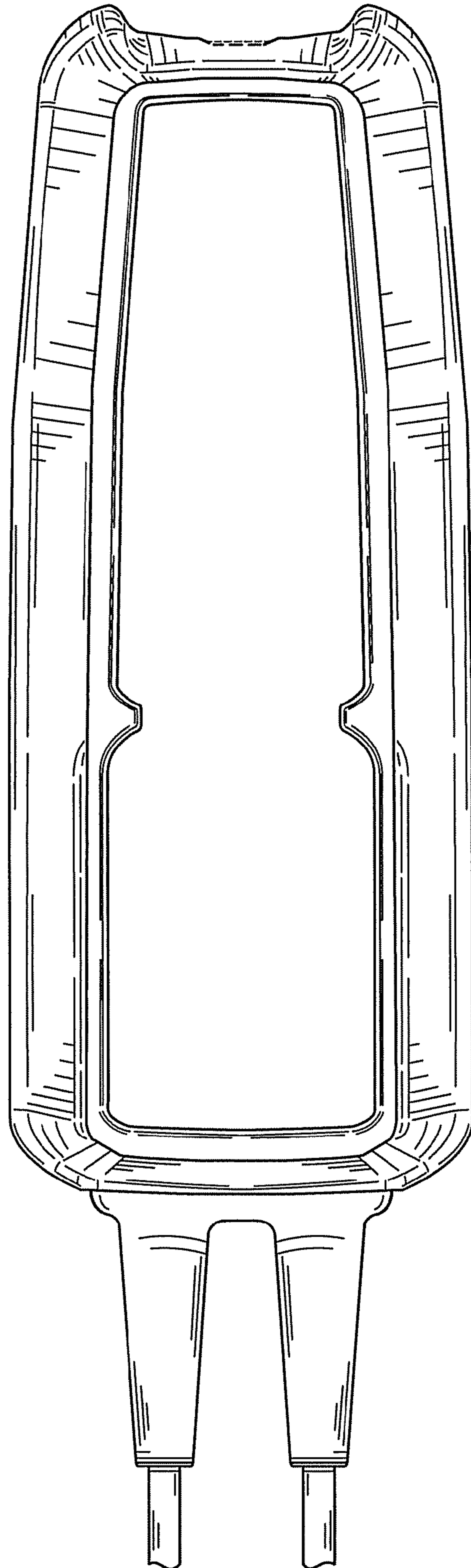

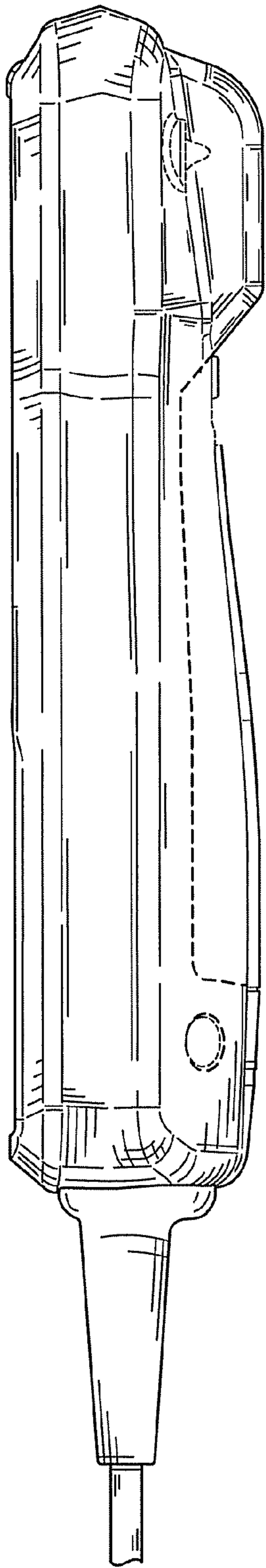

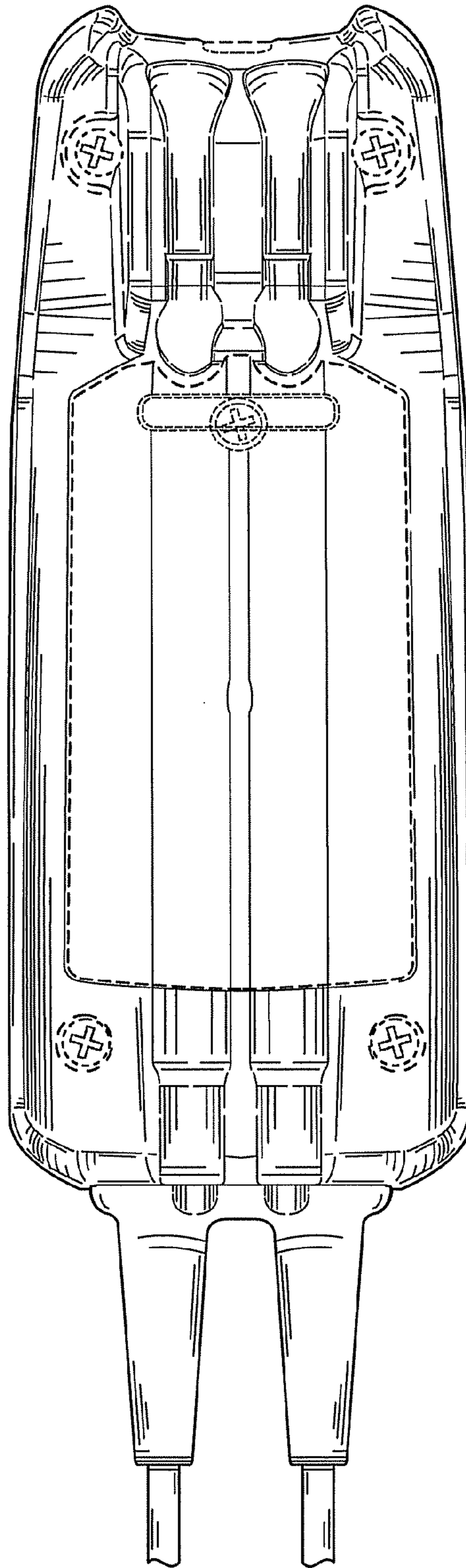

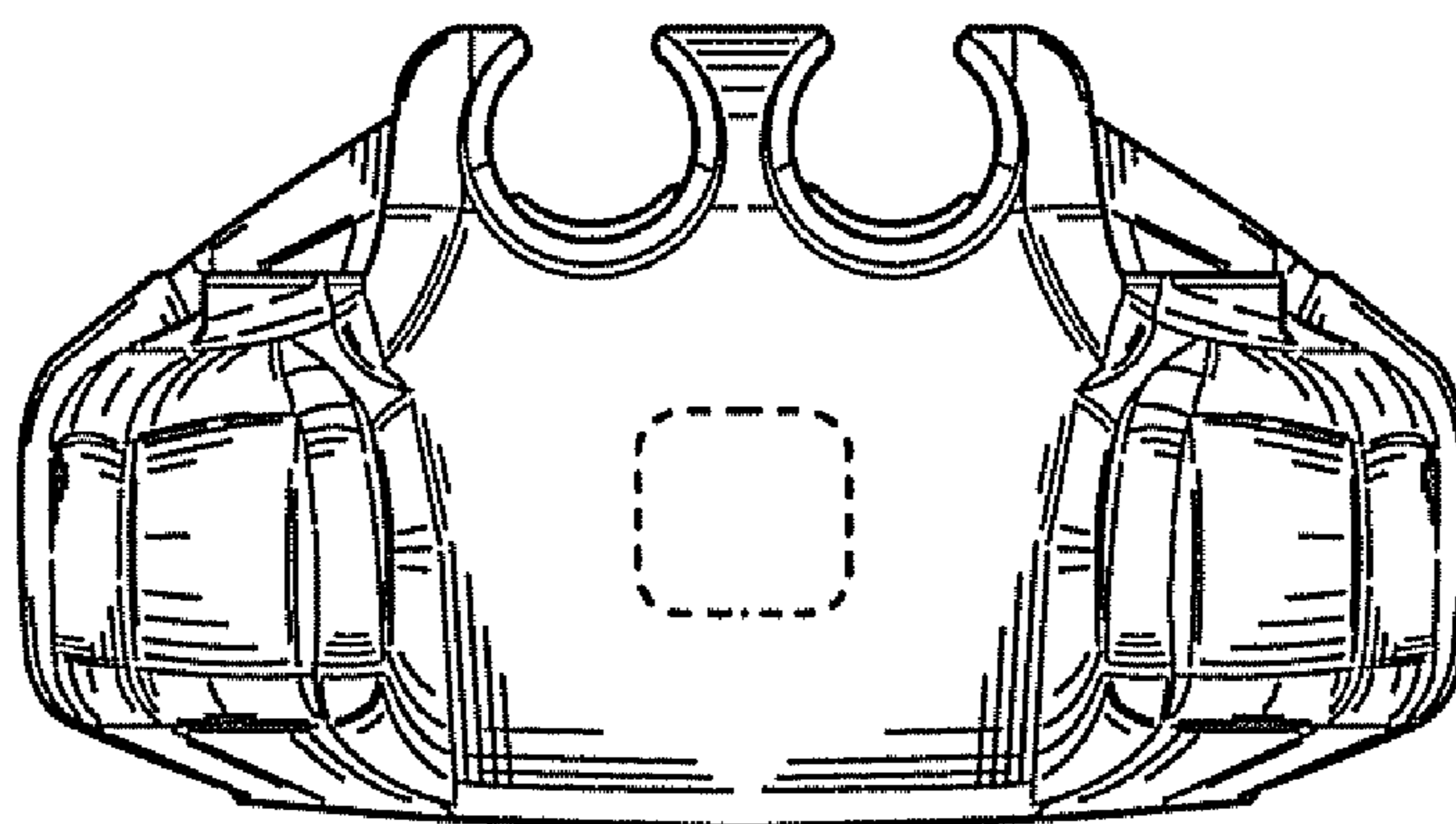

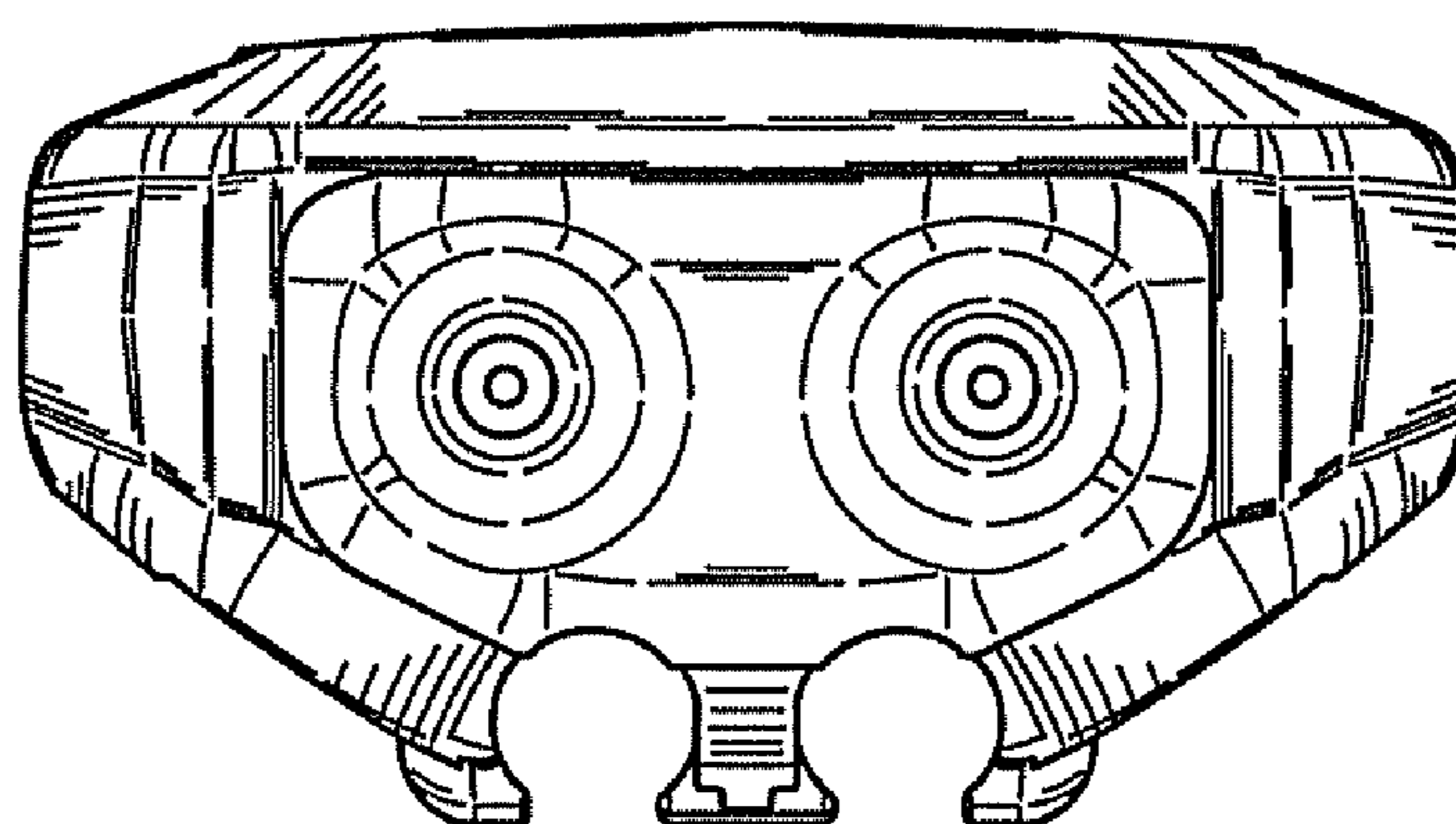

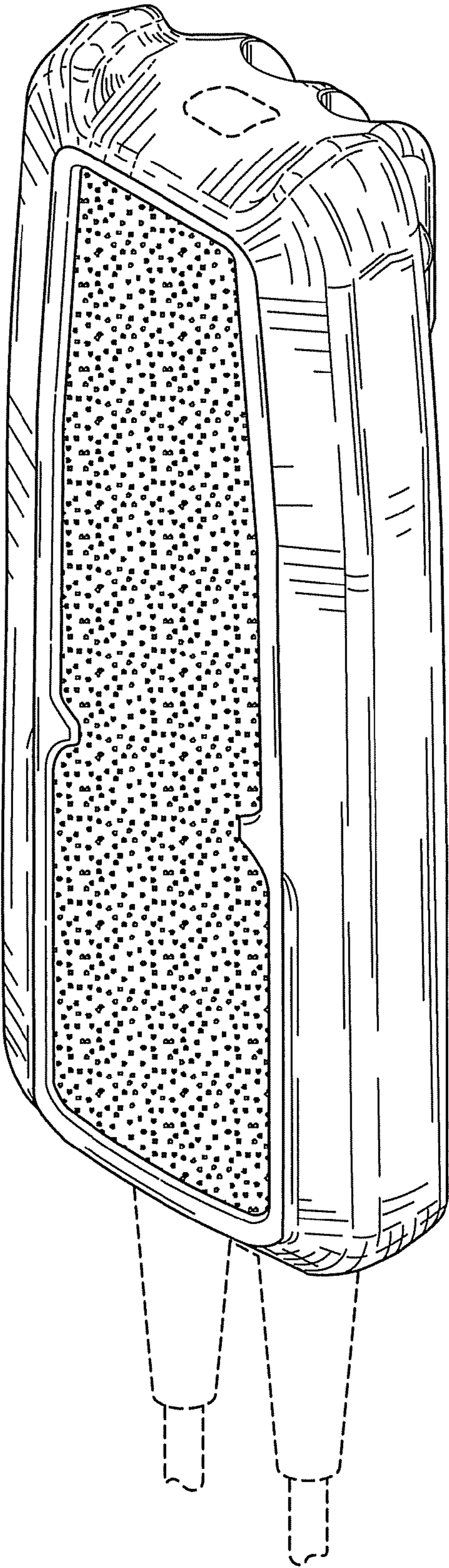

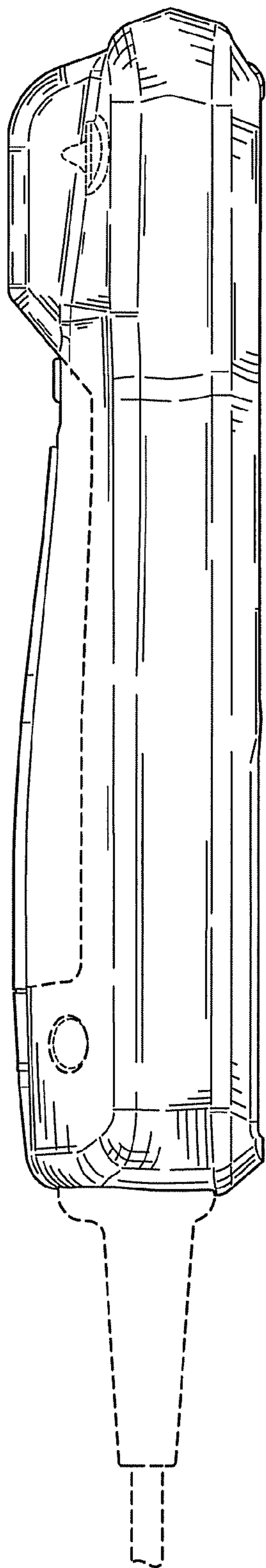

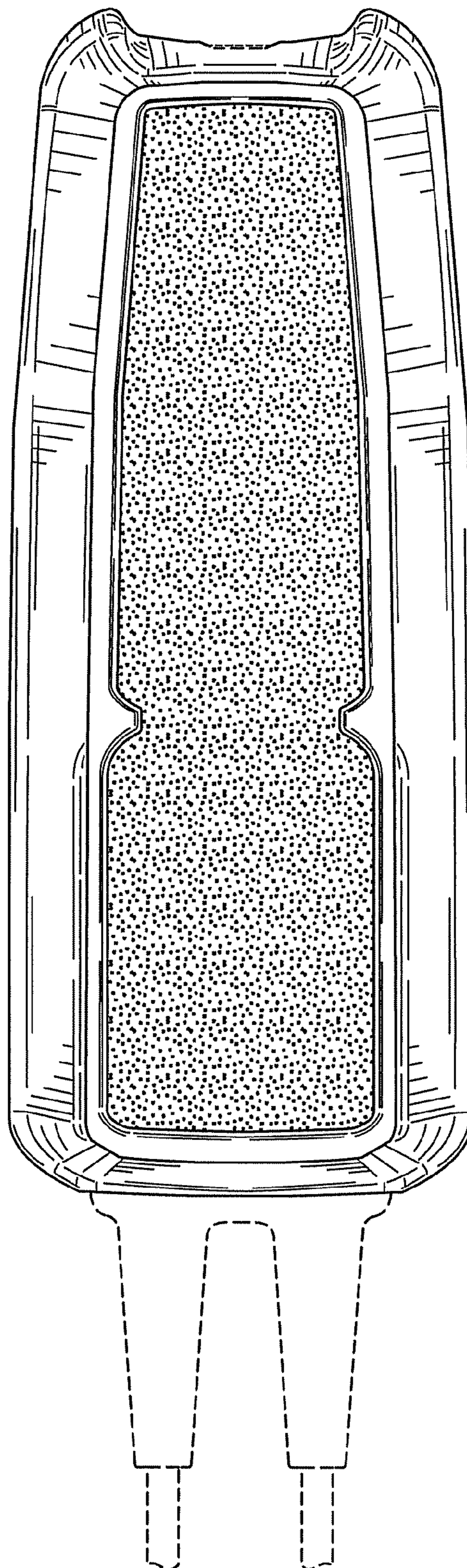

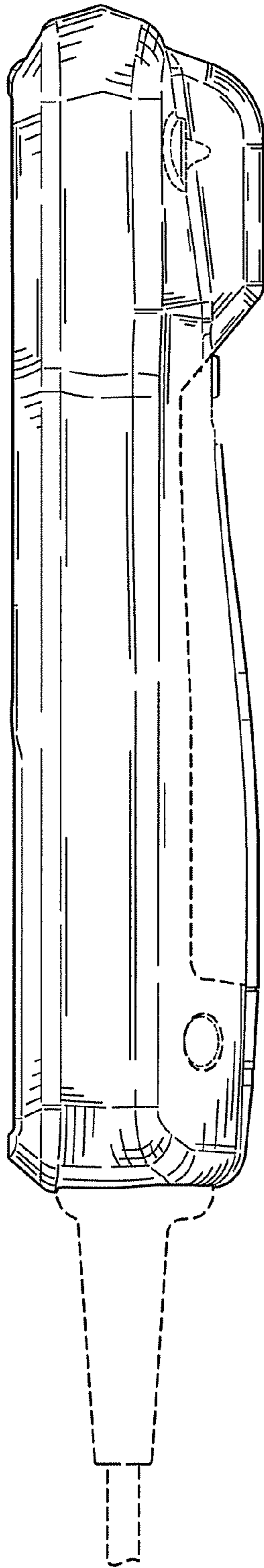

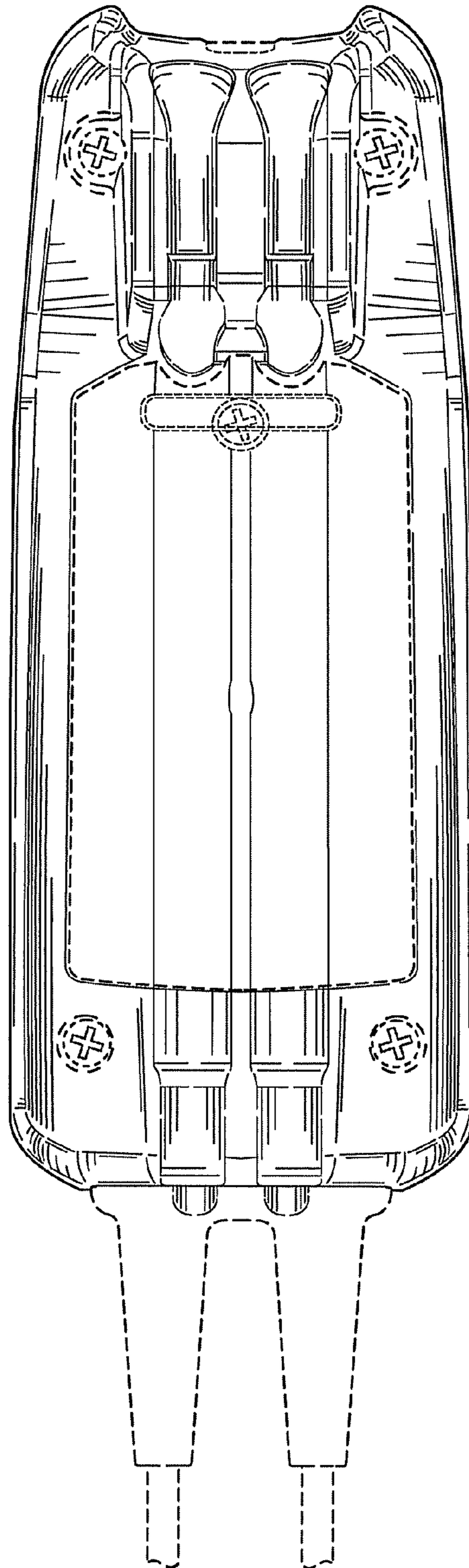

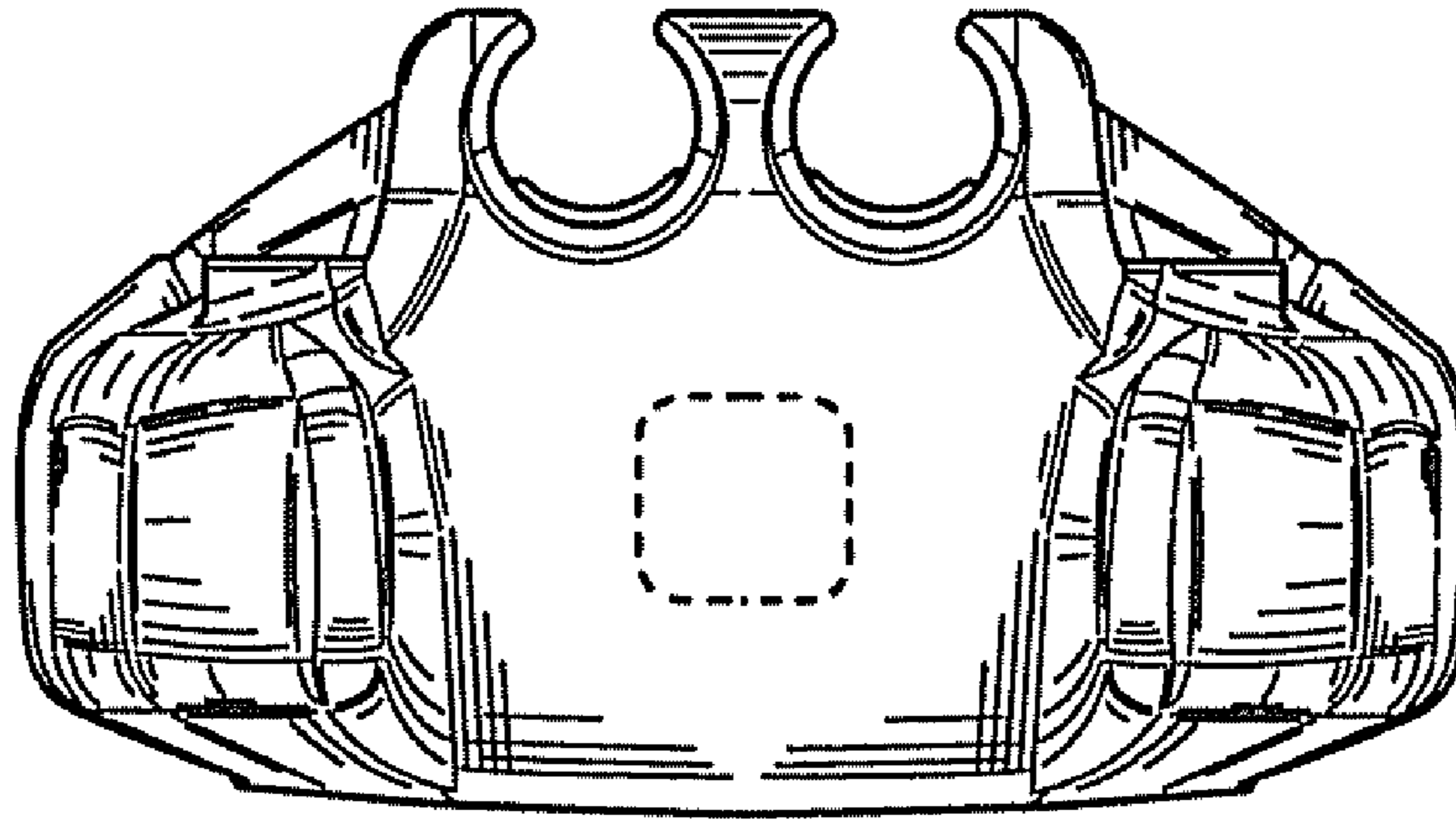

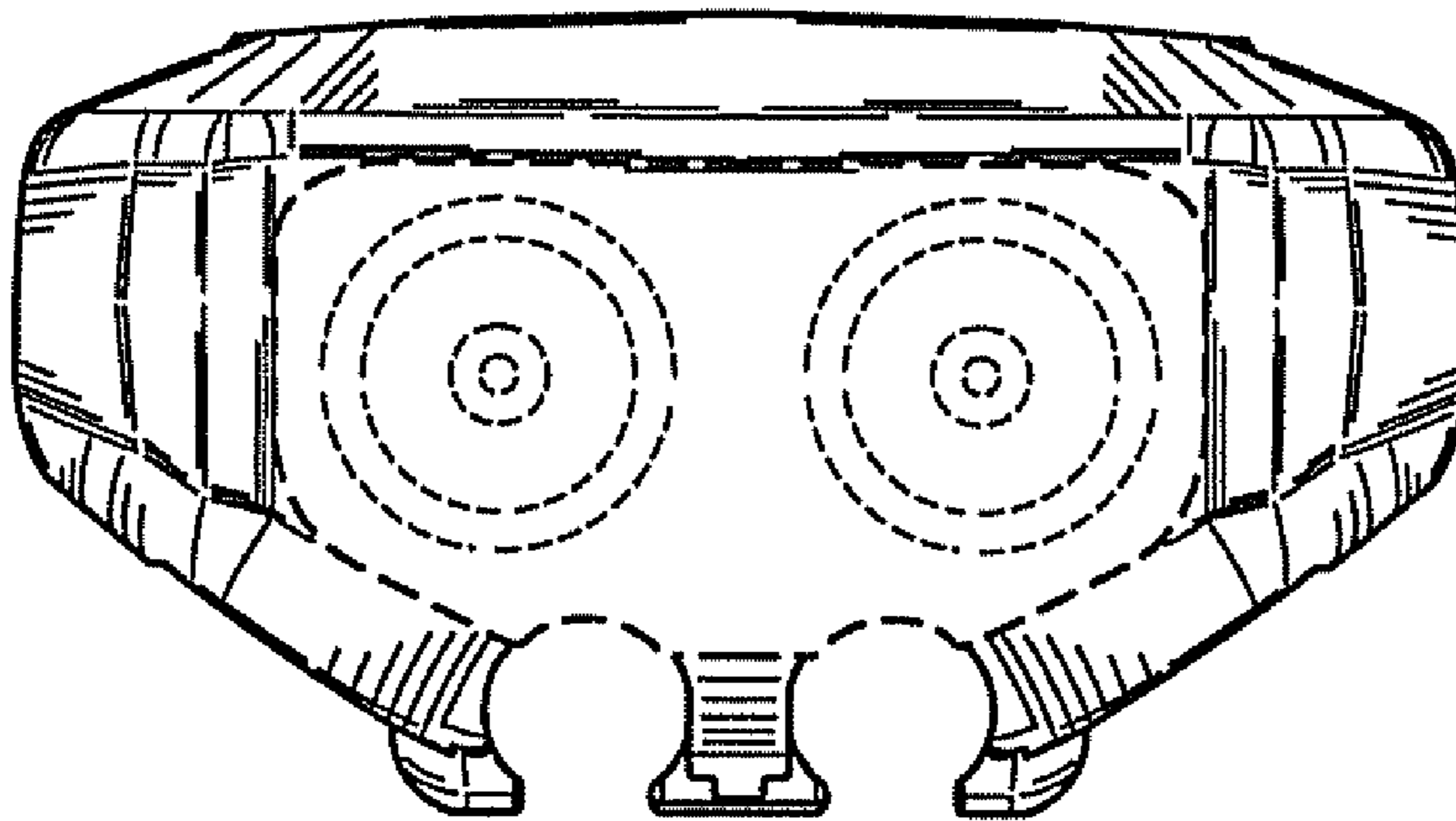
