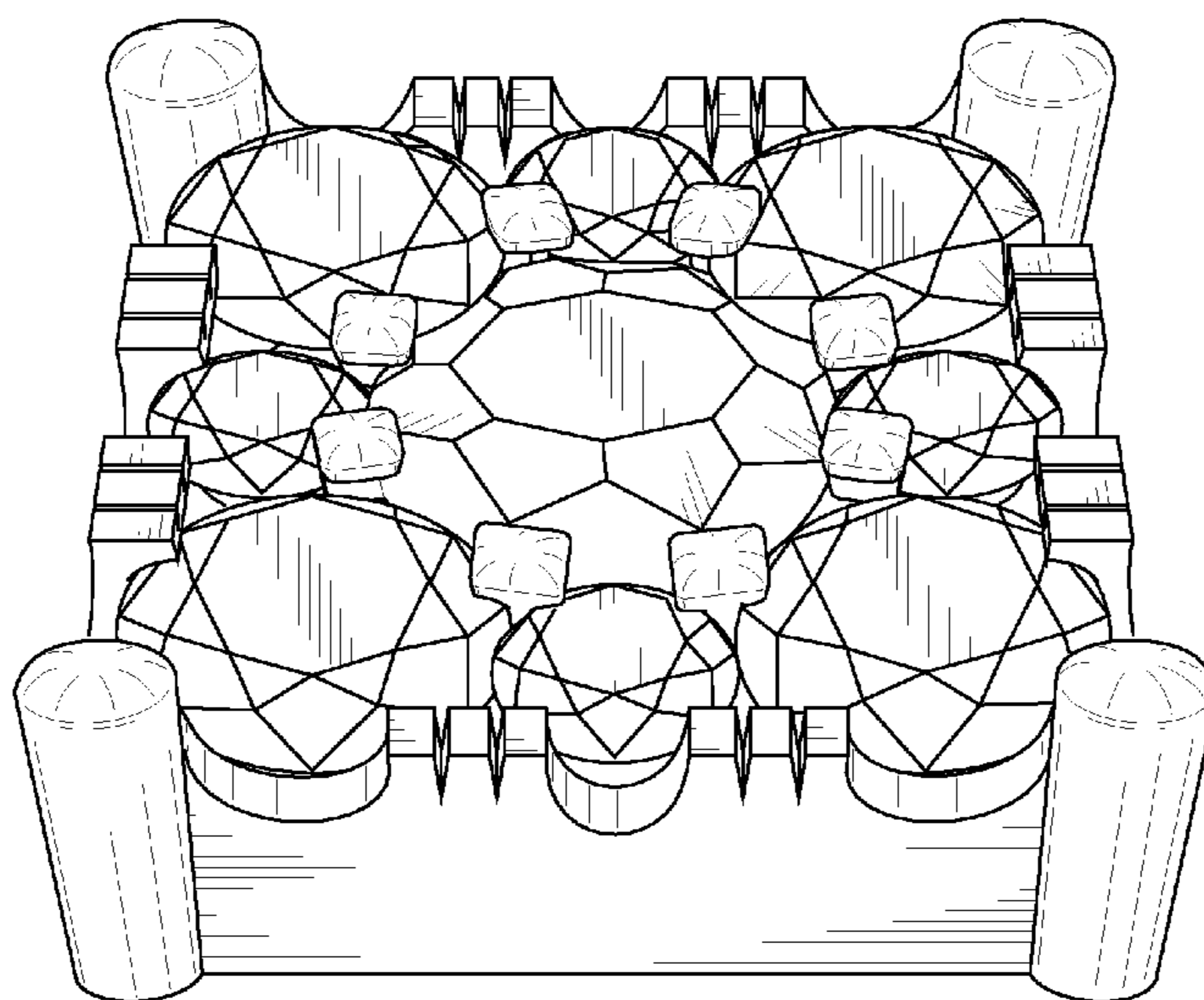
(57) **CLAIM**

The ornamental design for a gemstone jewelry, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of gemstone jewelry showing my new design;  
 FIG. 2 is a top plan view thereof;  
 FIG. 3 is a bottom plan view thereof;  
 FIG. 4 is a front elevation view thereof, the rear elevation view being a mirror image thereof; and,  
 FIG. 5 is a right side elevation view thereof, the left side elevation view being a mirror image thereof.  
 The broken lines shown in the drawings represent unclaimed portions of the gemstone jewelry and form no part of the claimed design.

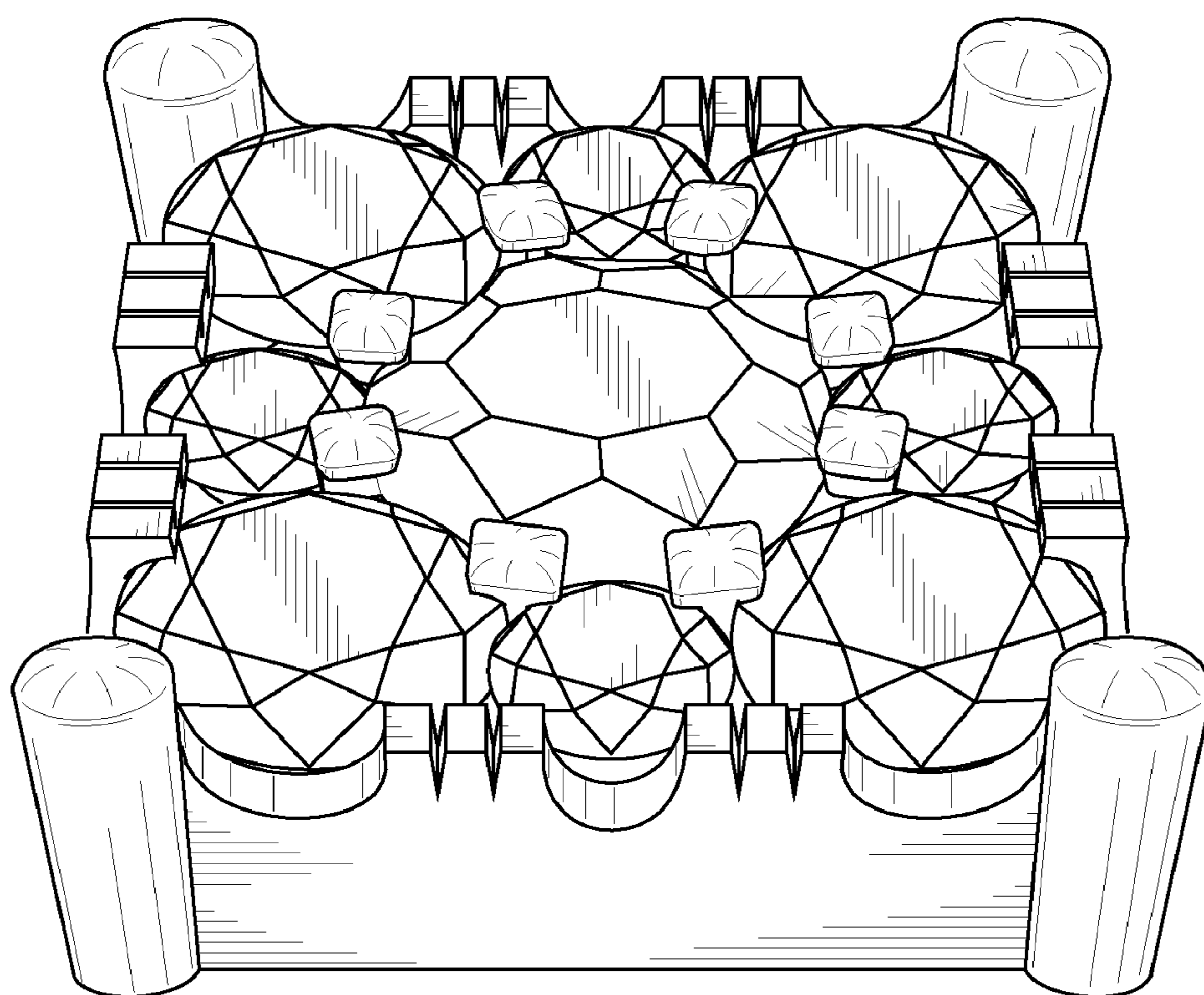

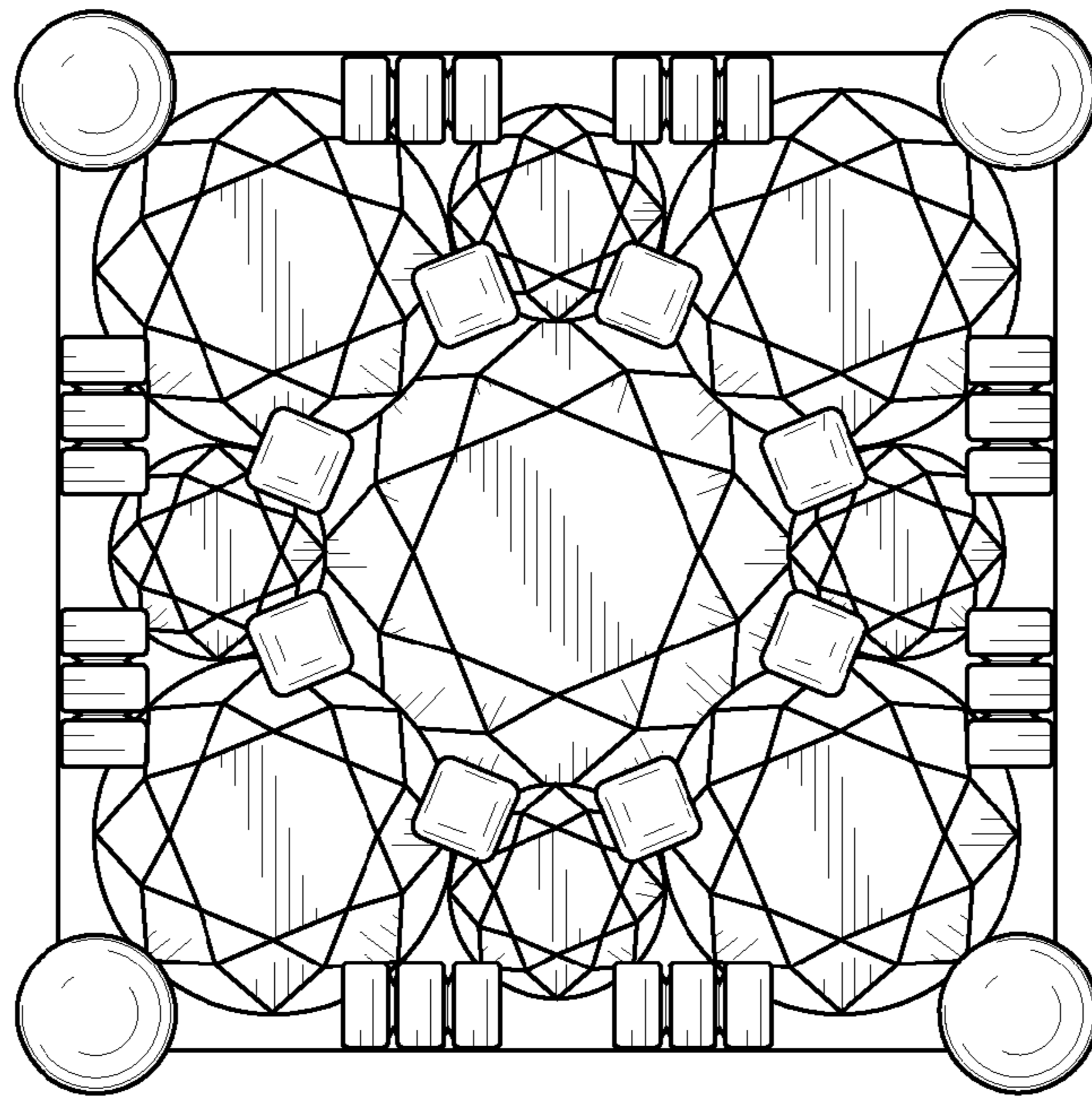

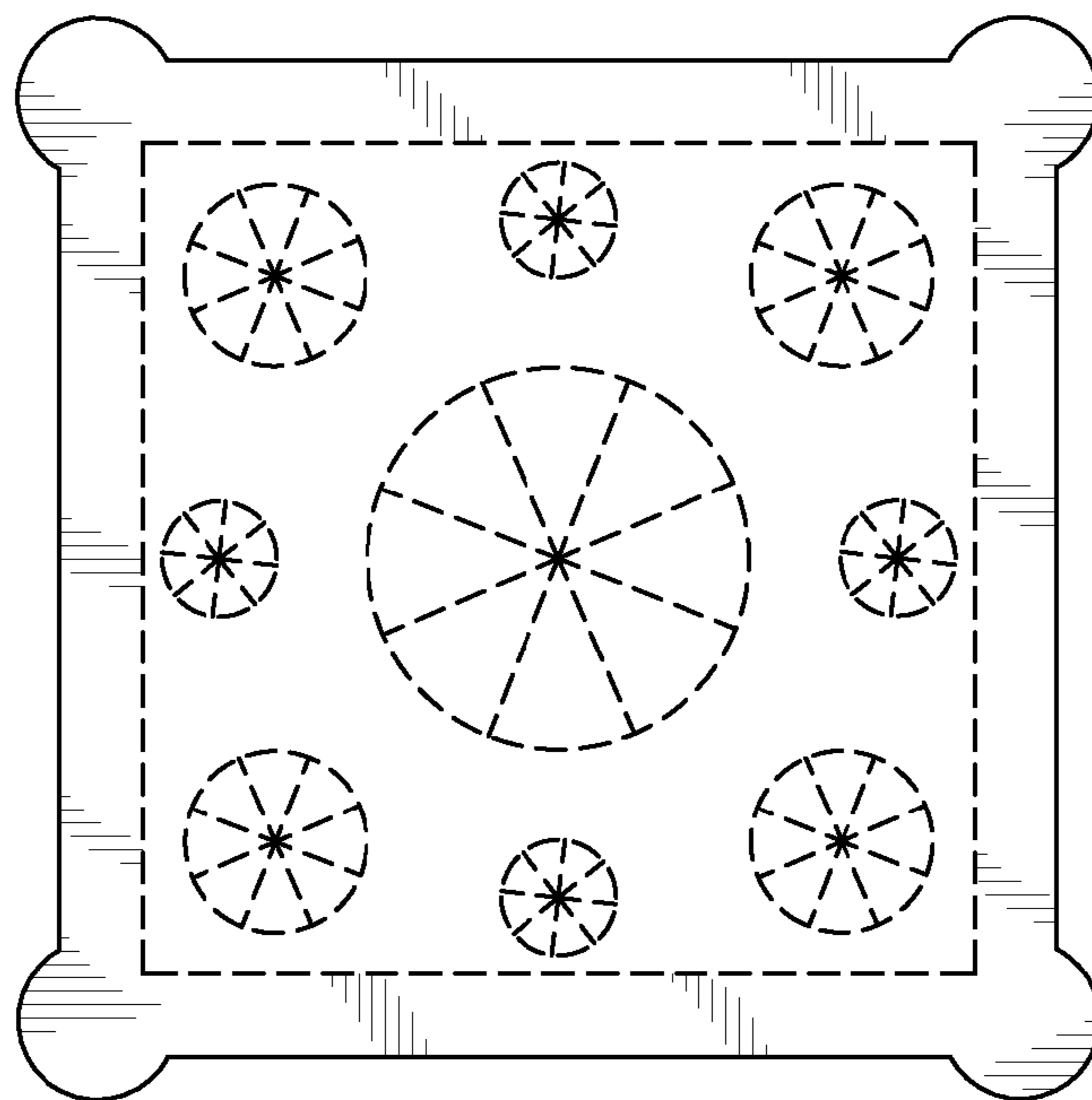

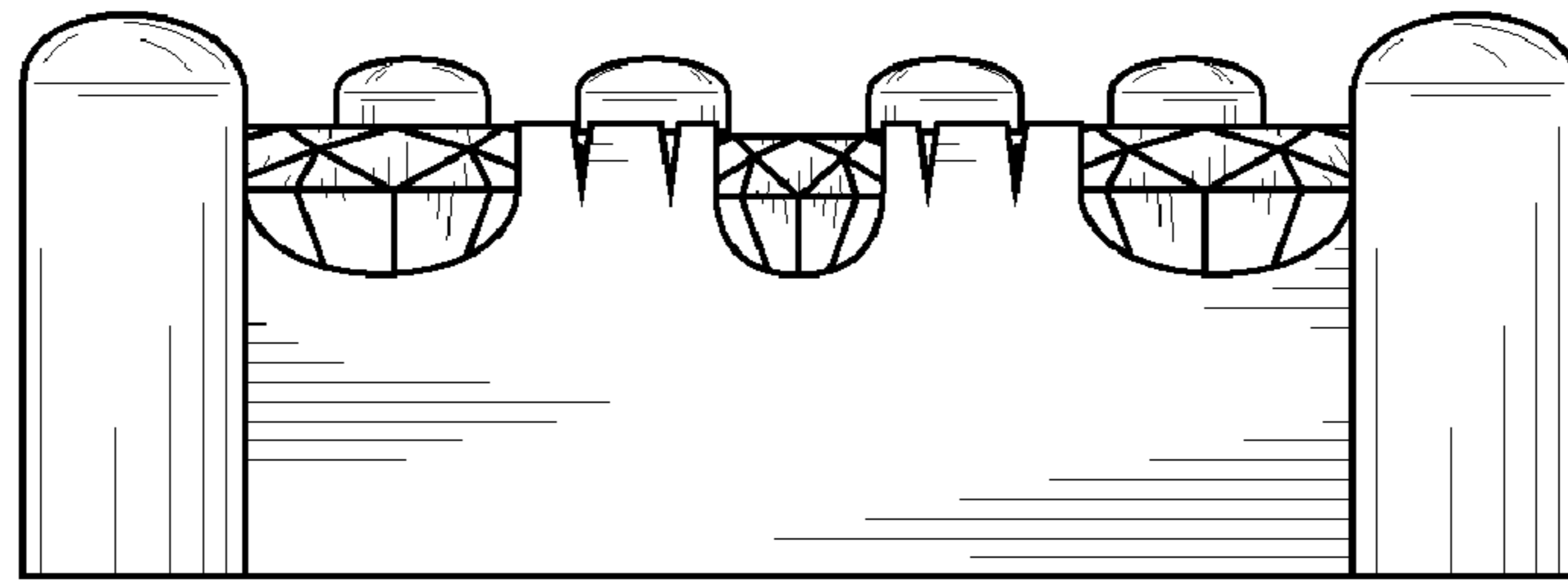

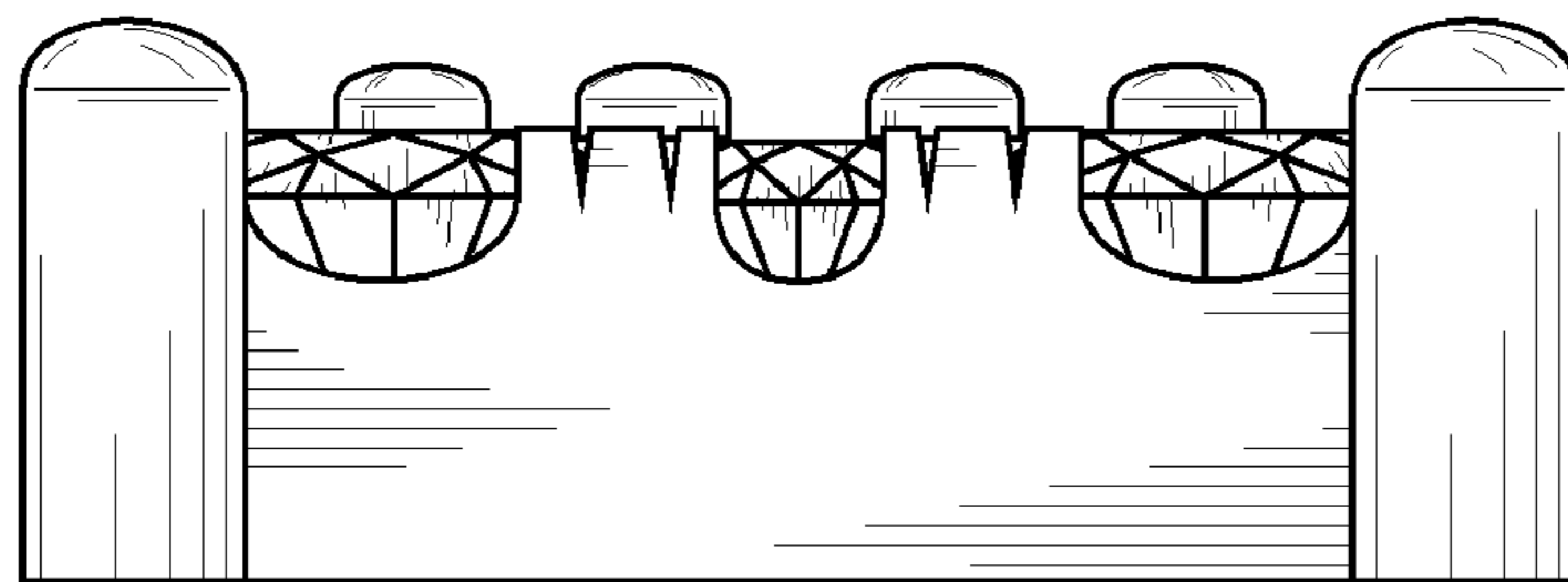
