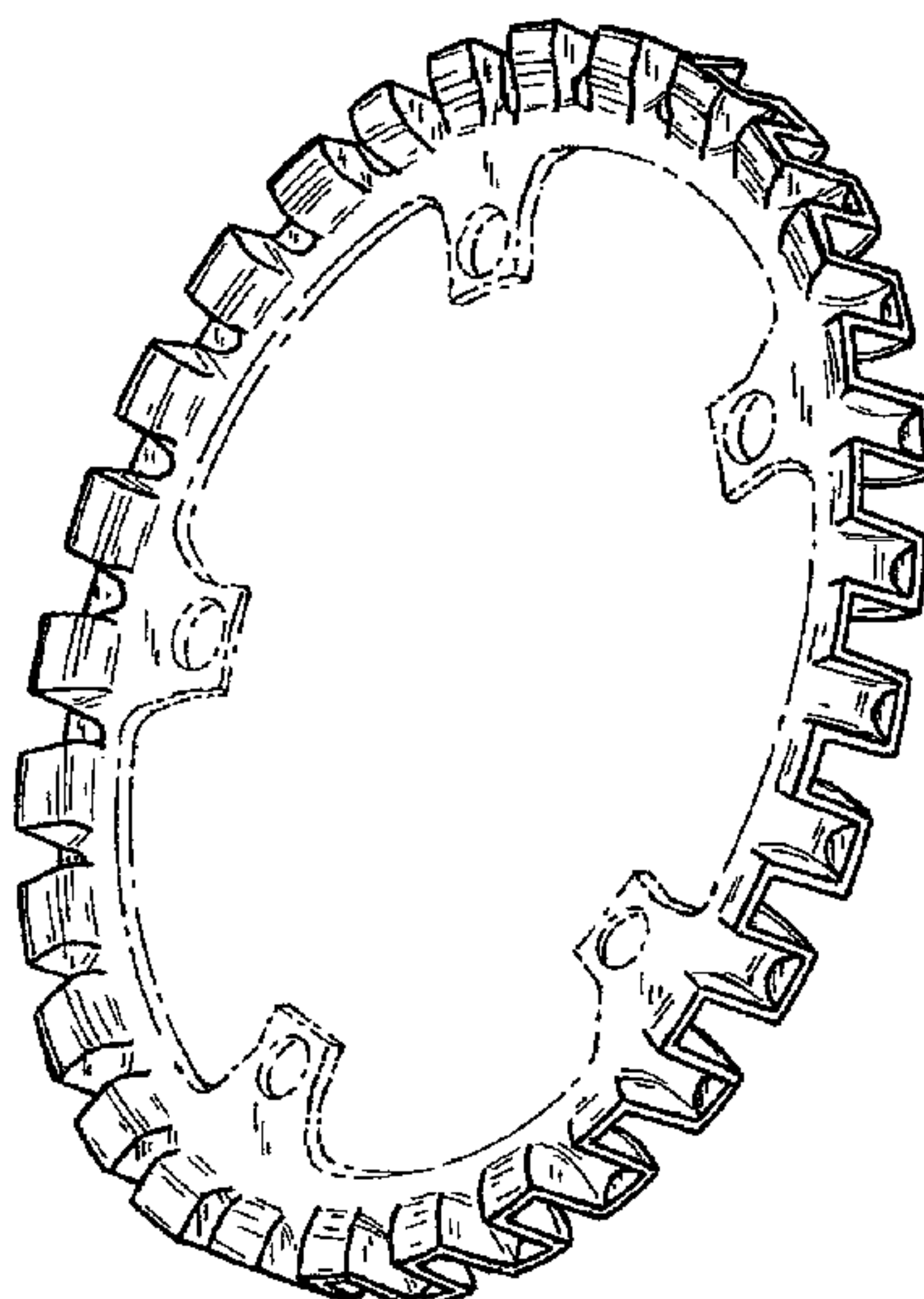
(57) **CLAIM**

The ornamental design for a bicycle cog, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a bicycle cog according to the present invention;  
FIG. 2 is a right side elevation view of the bicycle cog shown in FIG. 1;  
FIG. 3 is a front elevation view of the bicycle cog shown in FIG. 1;  
FIG. 4 is a top plan view of the bicycle cog shown in FIG. 1; and,  
FIG. 5 is a left side elevation view of the bicycle cog shown in FIG. 1.  
The broken lines represent environmental structure and form no part of the claimed design.

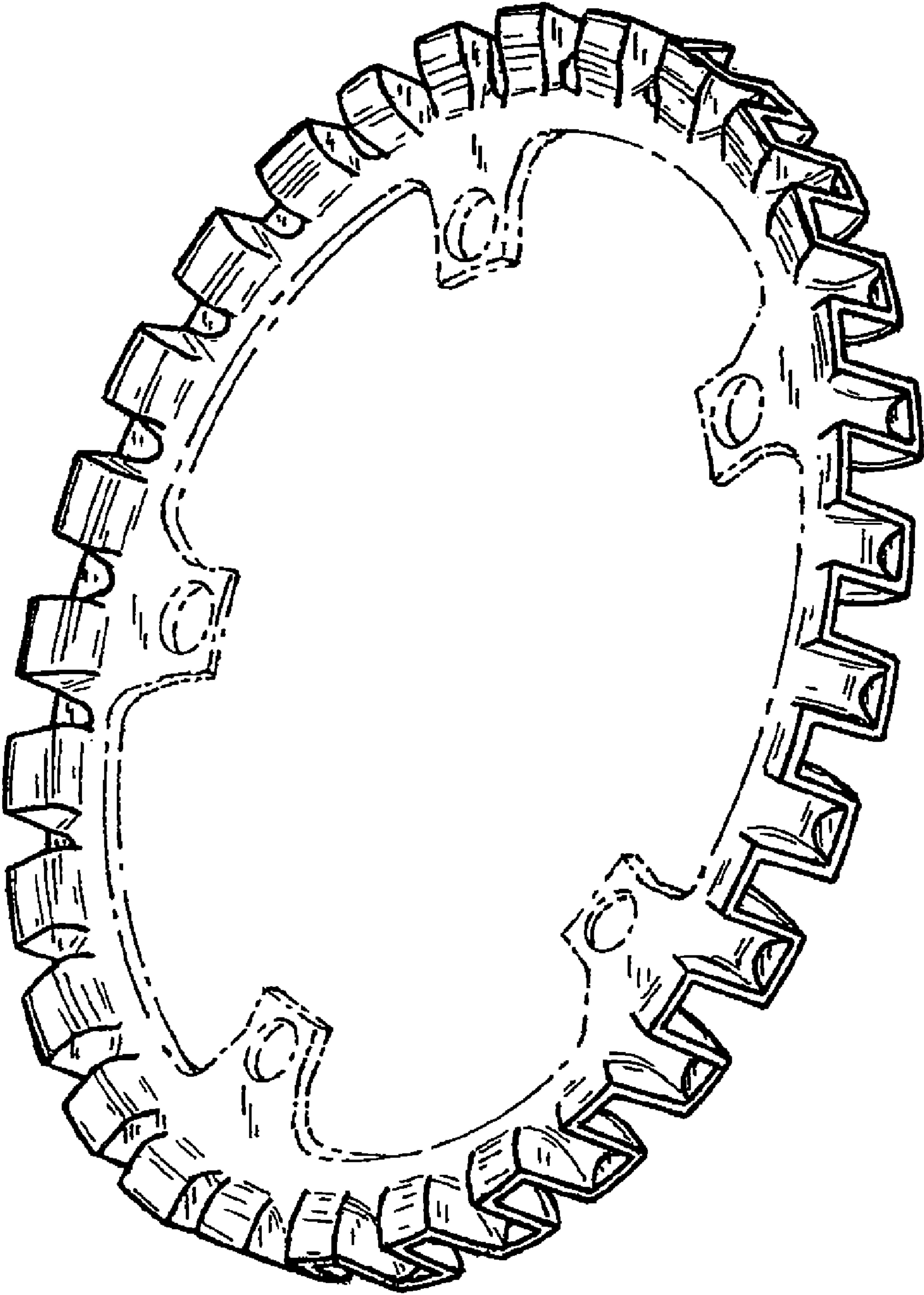

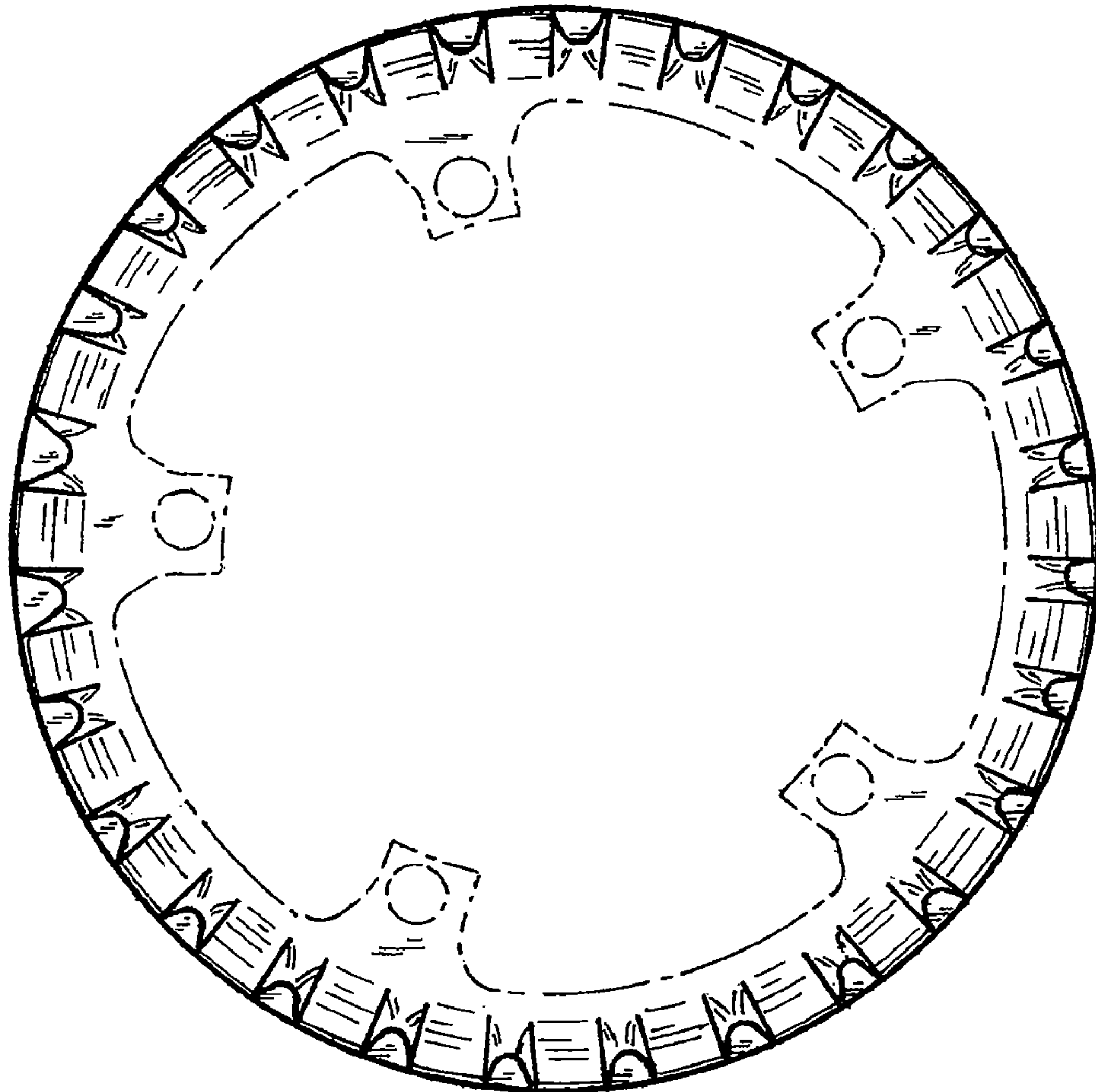

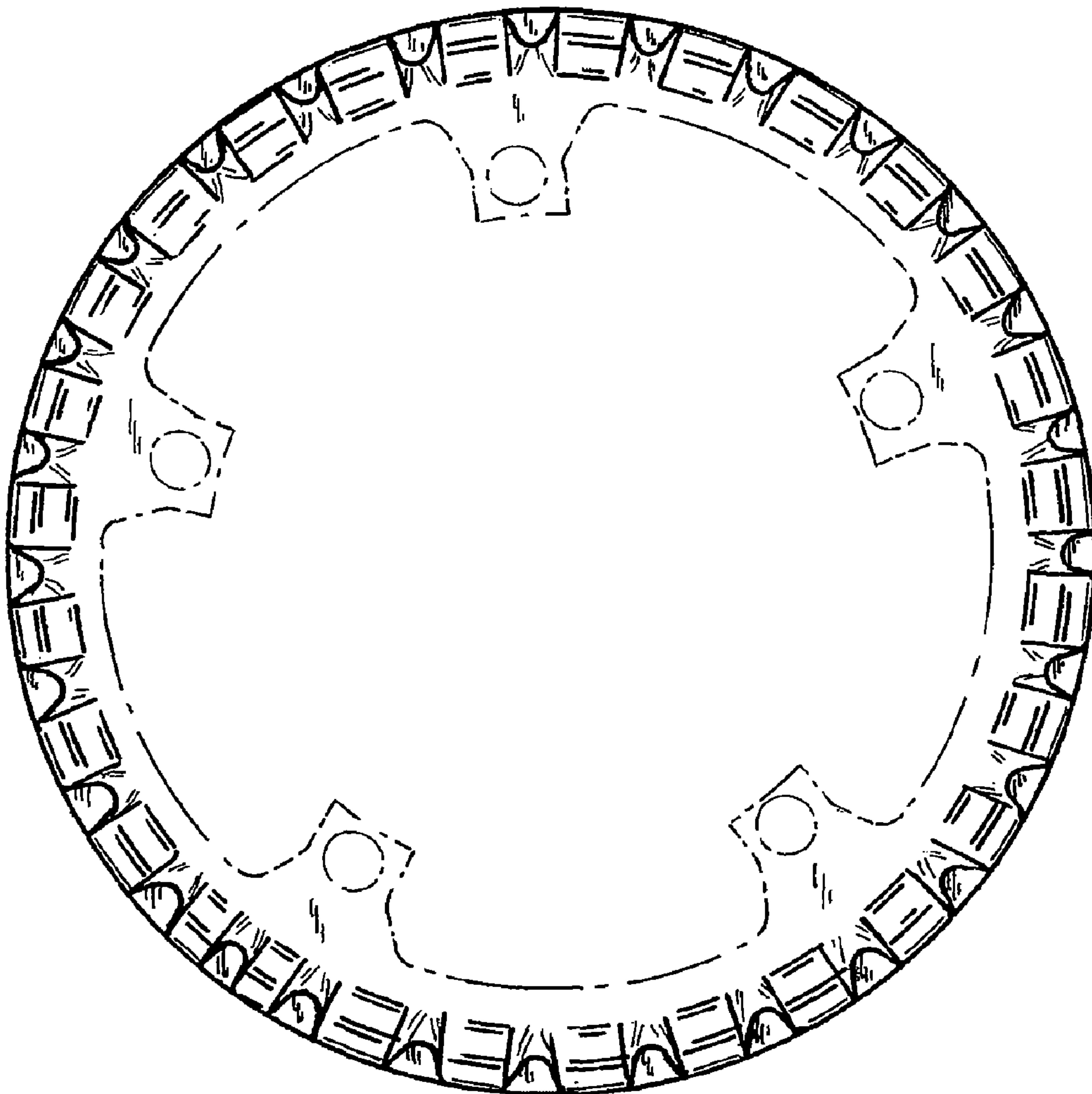
