(57) **CLAIM**

The ornamental design for a greeting card, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a greeting card showing our new design, the opposite side being a mirror image;
FIG. 2 is a top front perspective view thereof, both right and left sides being partially folded in the middle to approximately a 90 degree angle;
FIG. 3 is a front elevation view shown in the folded condition;
FIG. 4 is a front and side perspective view thereof, shown partially folded to approximately a 170 degree angle; and,
FIG. 5 is a perspective view thereof, shown in a partially open condition with the top folded over approximately 45 degrees.

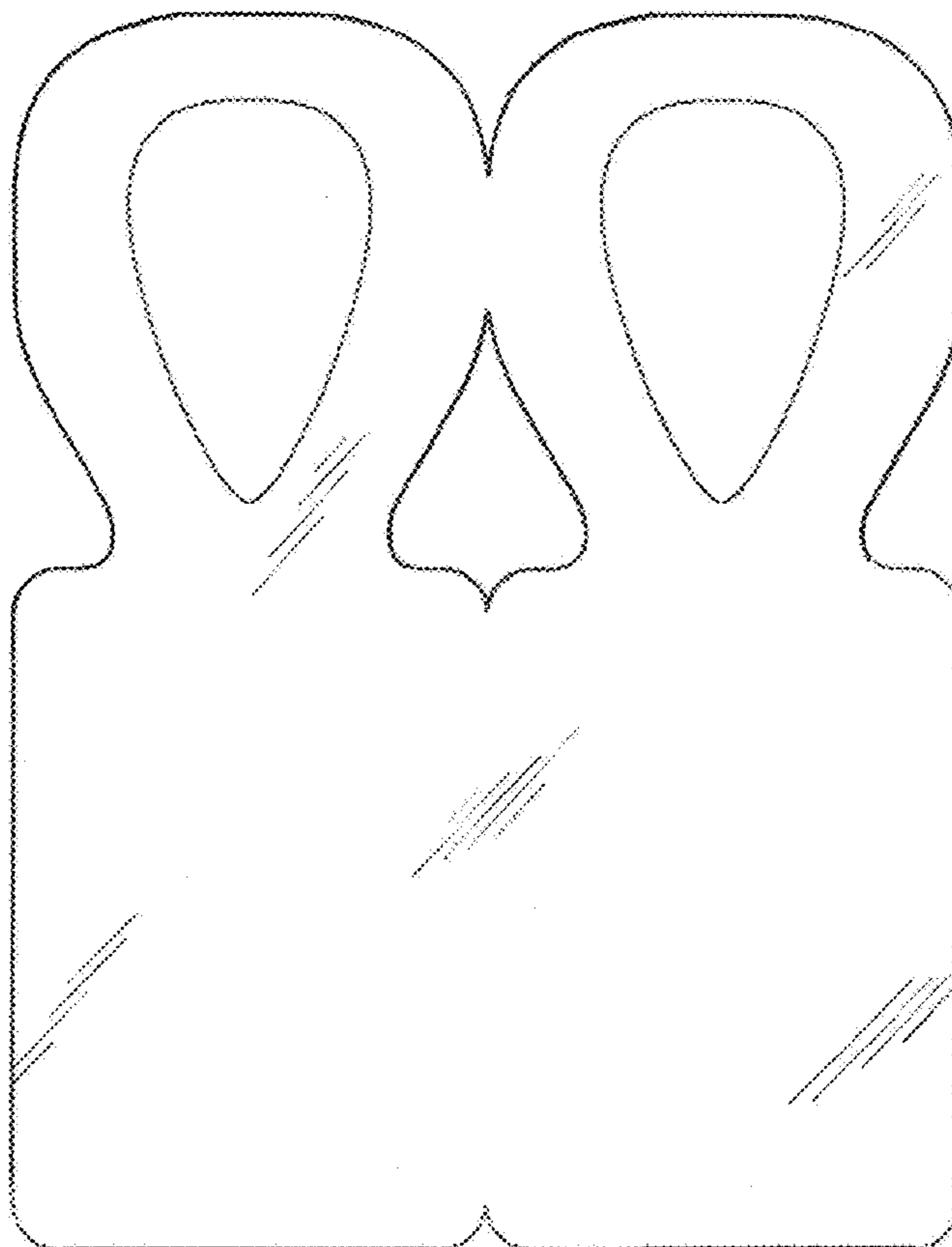

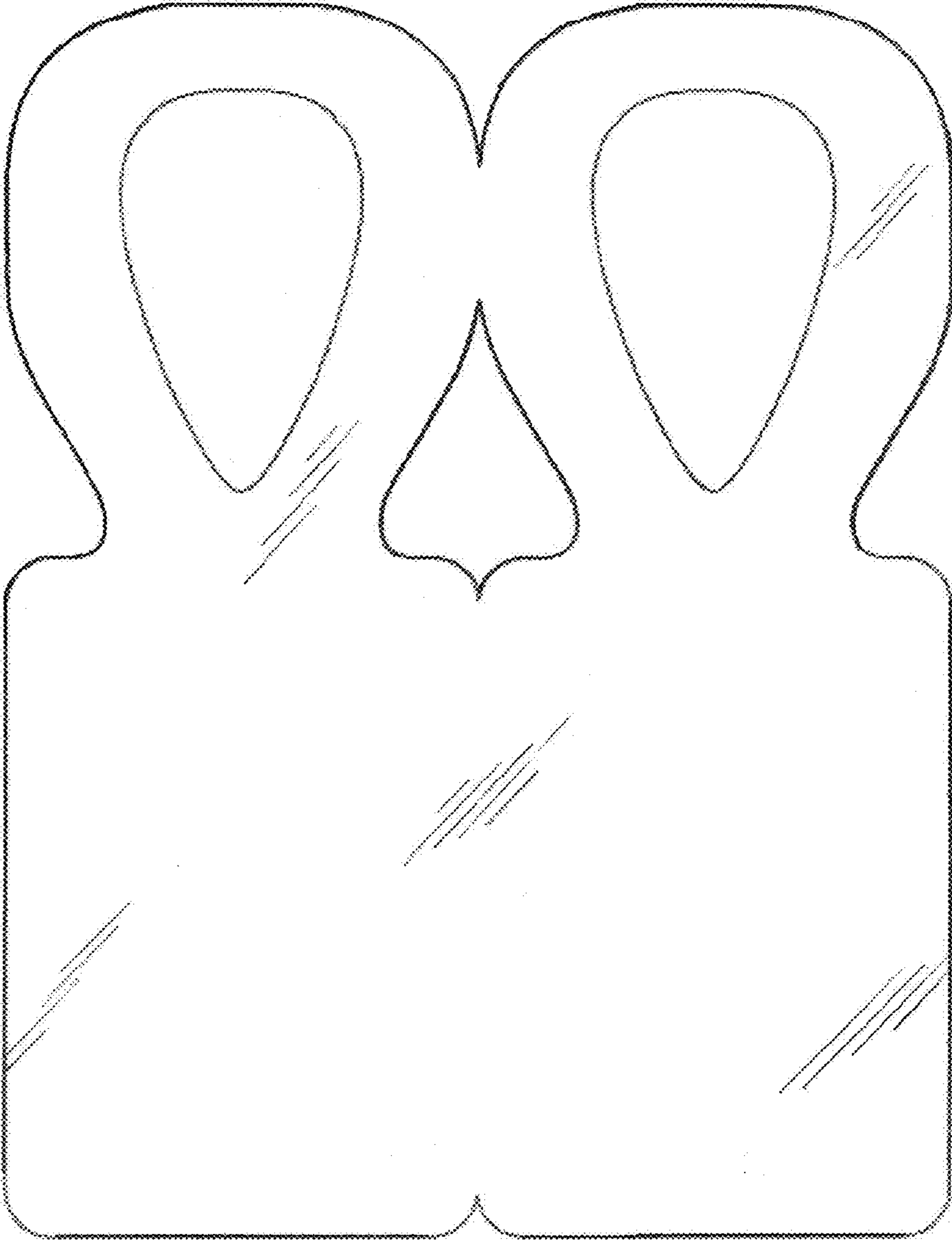

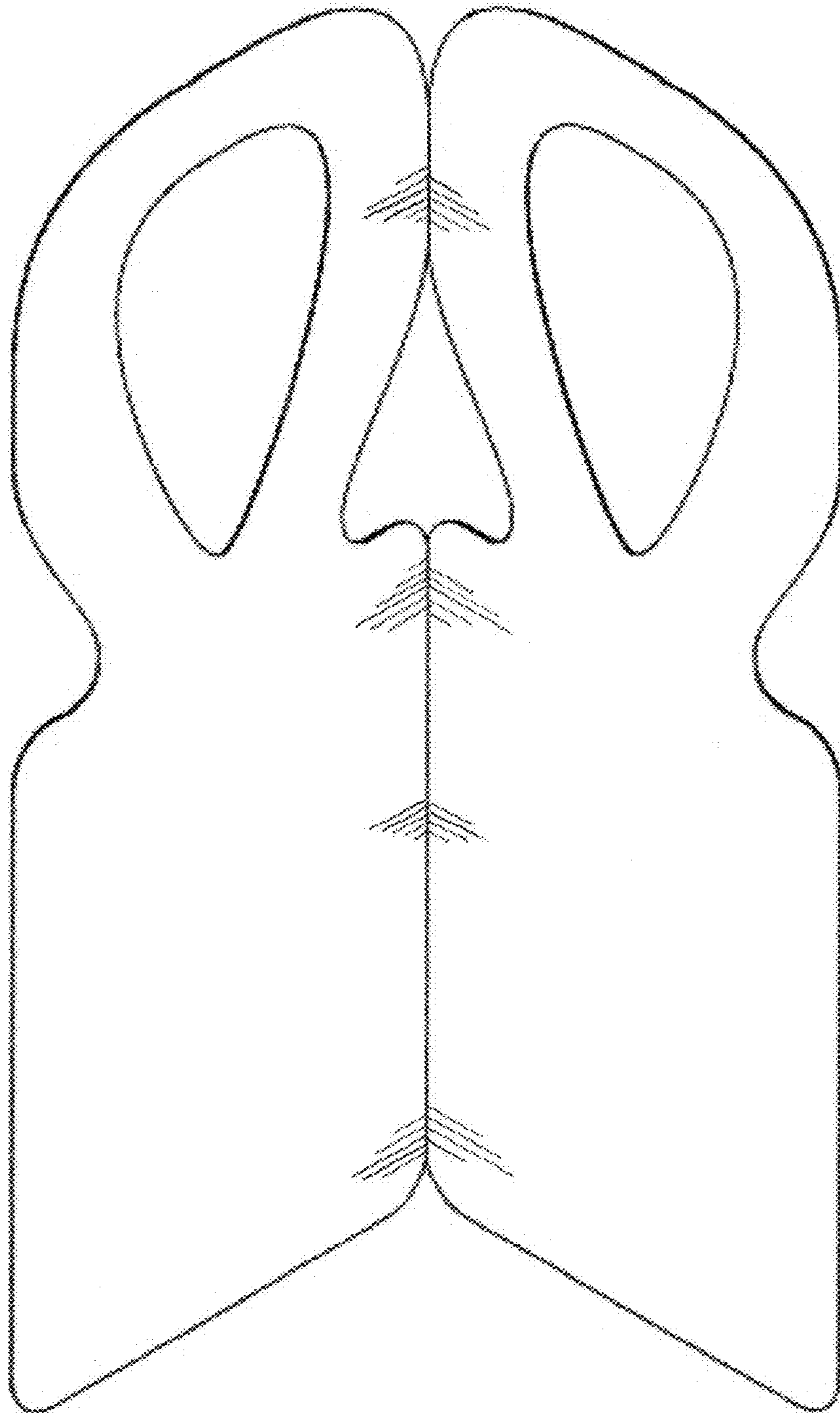

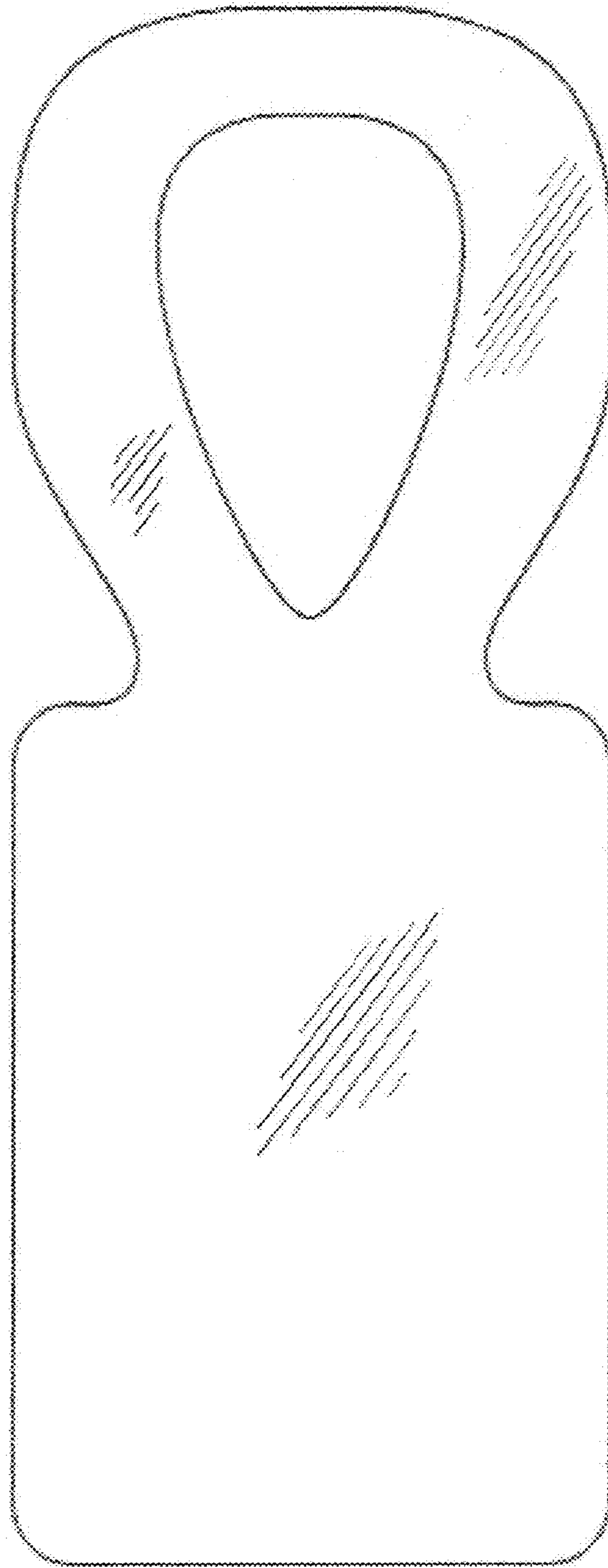

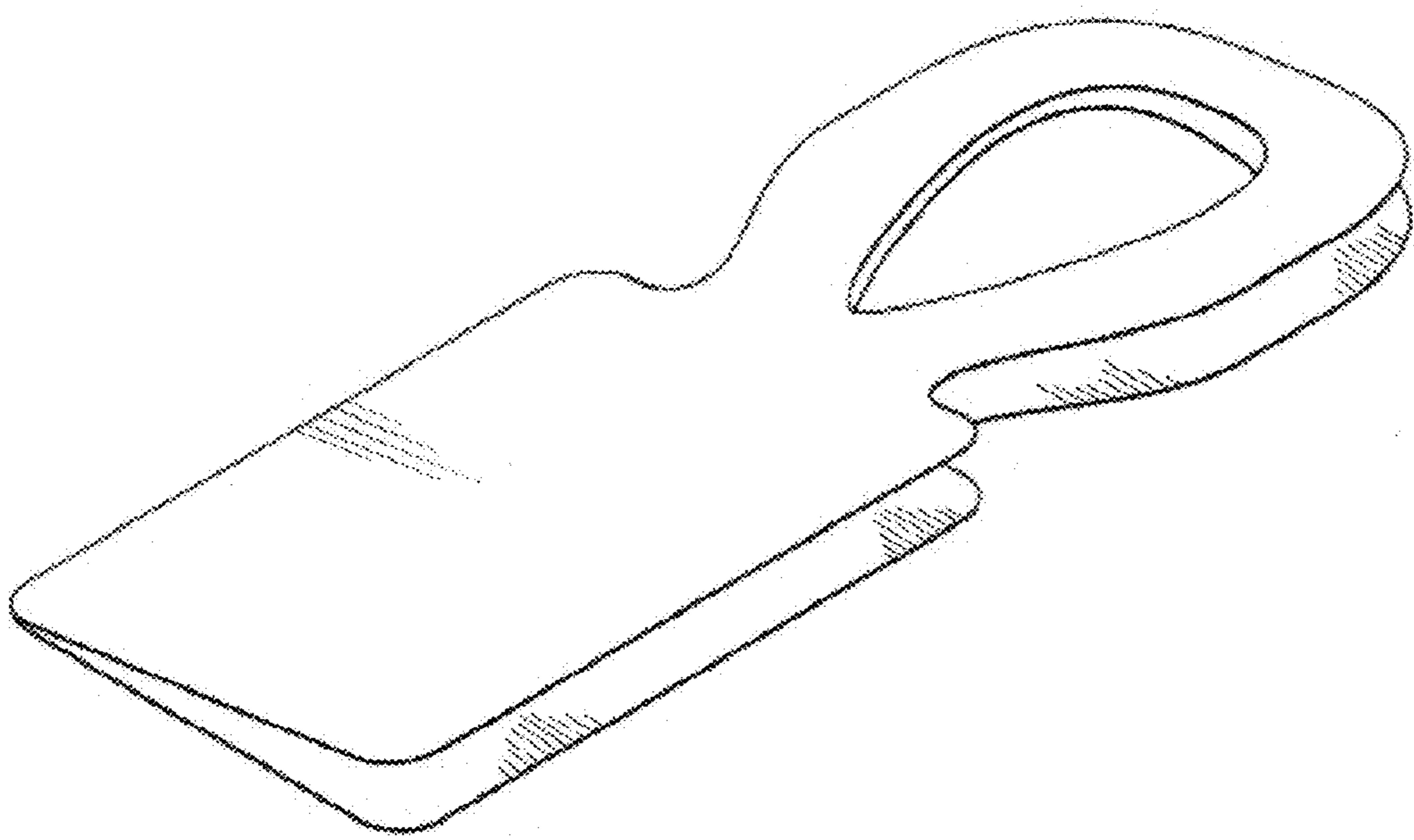
