(57) **CLAIM**

The ornamental design for a handheld shower spray, as shown and described.

**DESCRIPTION**

FIG. 1 is a left side elevational view of a handheld shower spray according to a first embodiment of the present invention.

FIG. 2 is a right side elevational view of the handheld shower spray of FIG. 1.

FIG. 3 is a front elevational view of the handheld shower spray of FIG. 1.

FIG. 4 is a rear elevational view of the handheld shower spray of FIG. 1.

FIG. 5 is a top plan view of the handheld shower spray of FIG. 1.

FIG. 6 is a bottom plan view of the handheld shower spray of FIG. 1.

FIG. 7 is a three quarter view of the handheld shower spray of FIG. 1.

FIG. 8 is a left side elevational view of a handheld shower spray according to a second embodiment of the present invention.

FIG. 9 is a right side elevational view of the handheld shower spray of FIG. 8.

FIG. 10 is a front elevational view of the handheld shower spray of FIG. 8.

FIG. 11 is a rear elevational view of the handheld shower spray of FIG. 8.

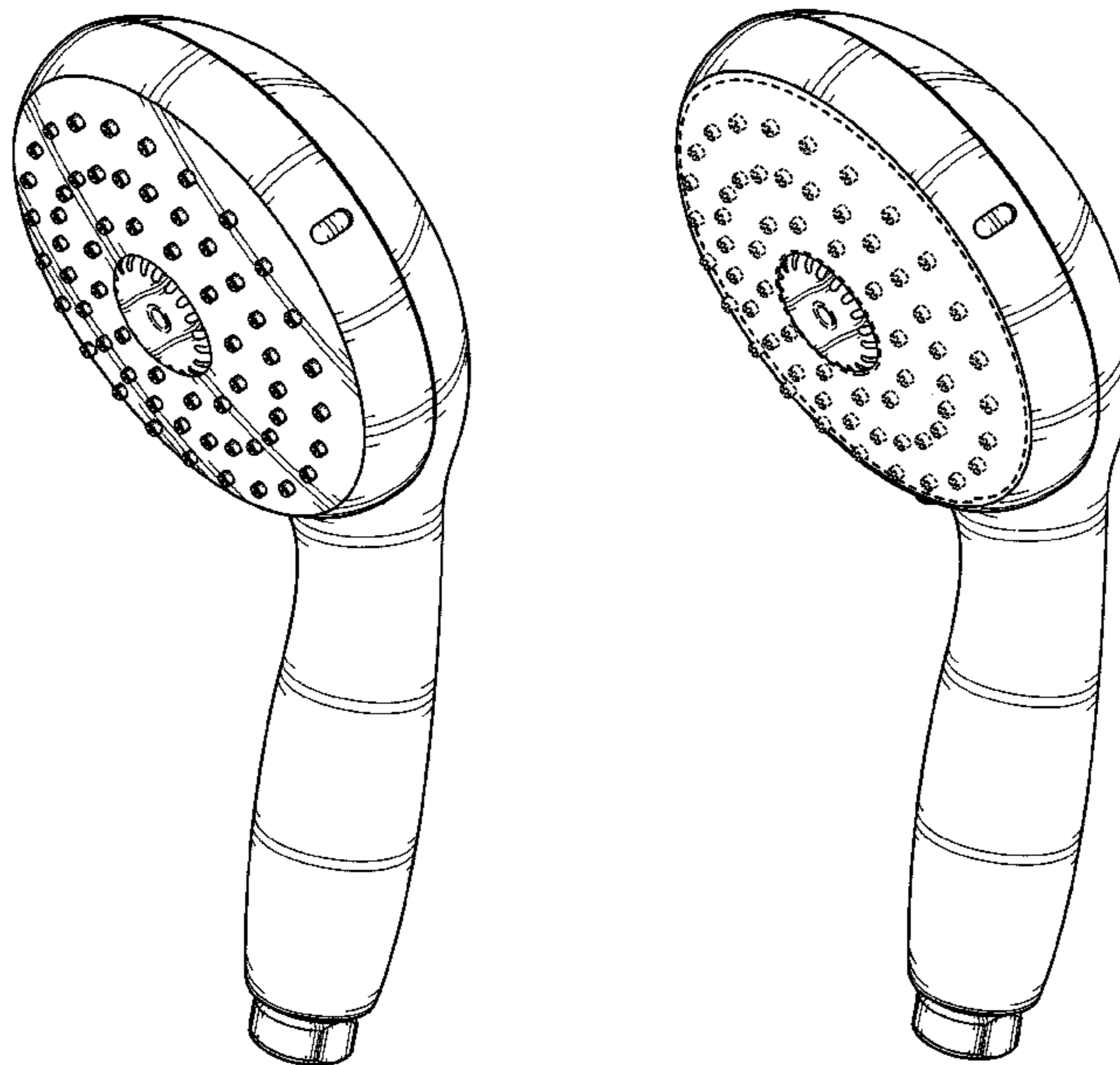
FIG. 12 is a top plan view of the handheld shower spray of FIG. 8.

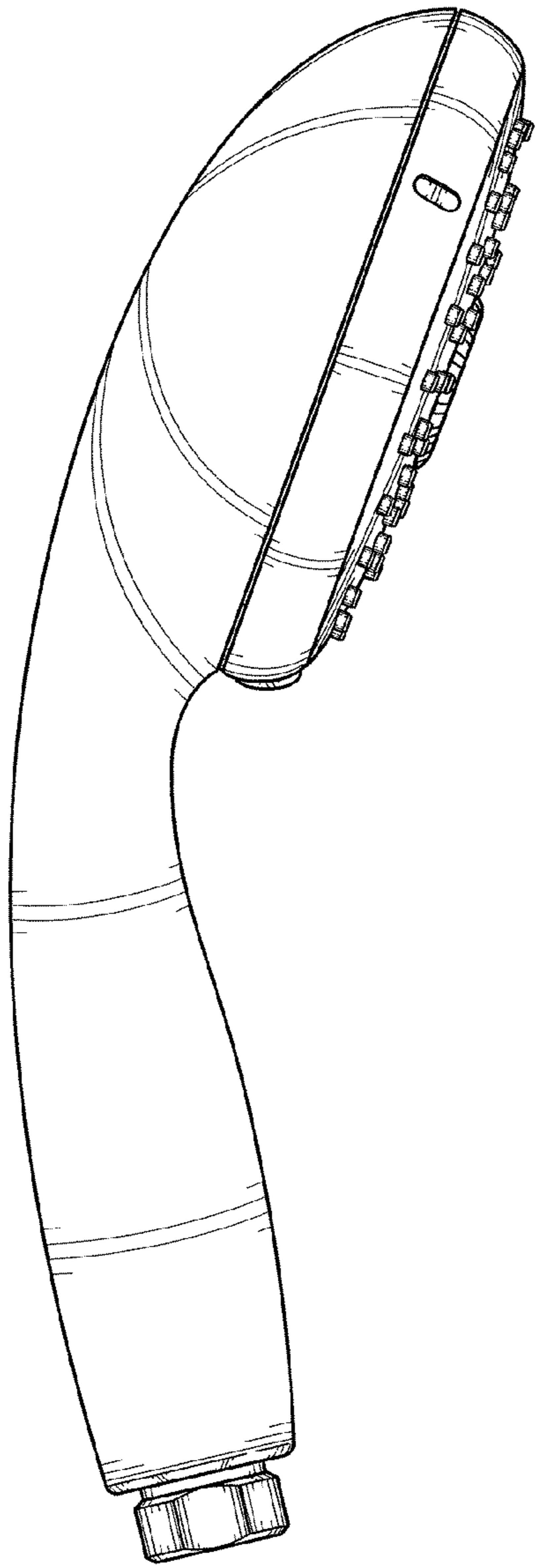

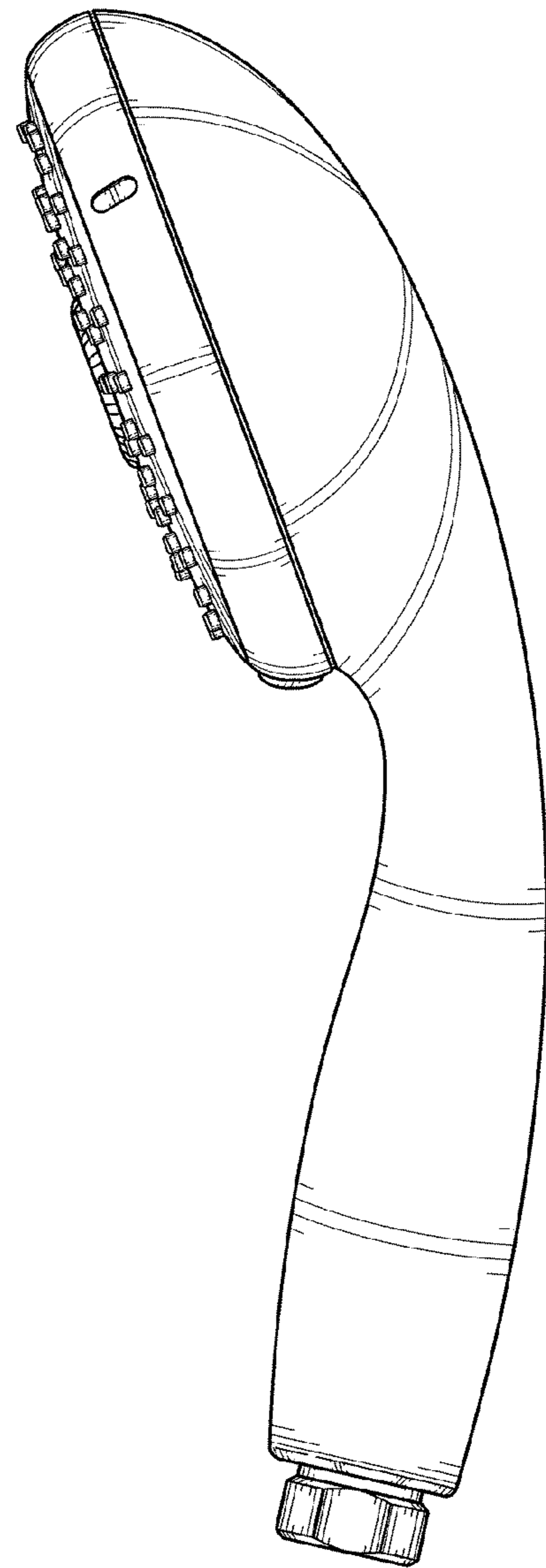

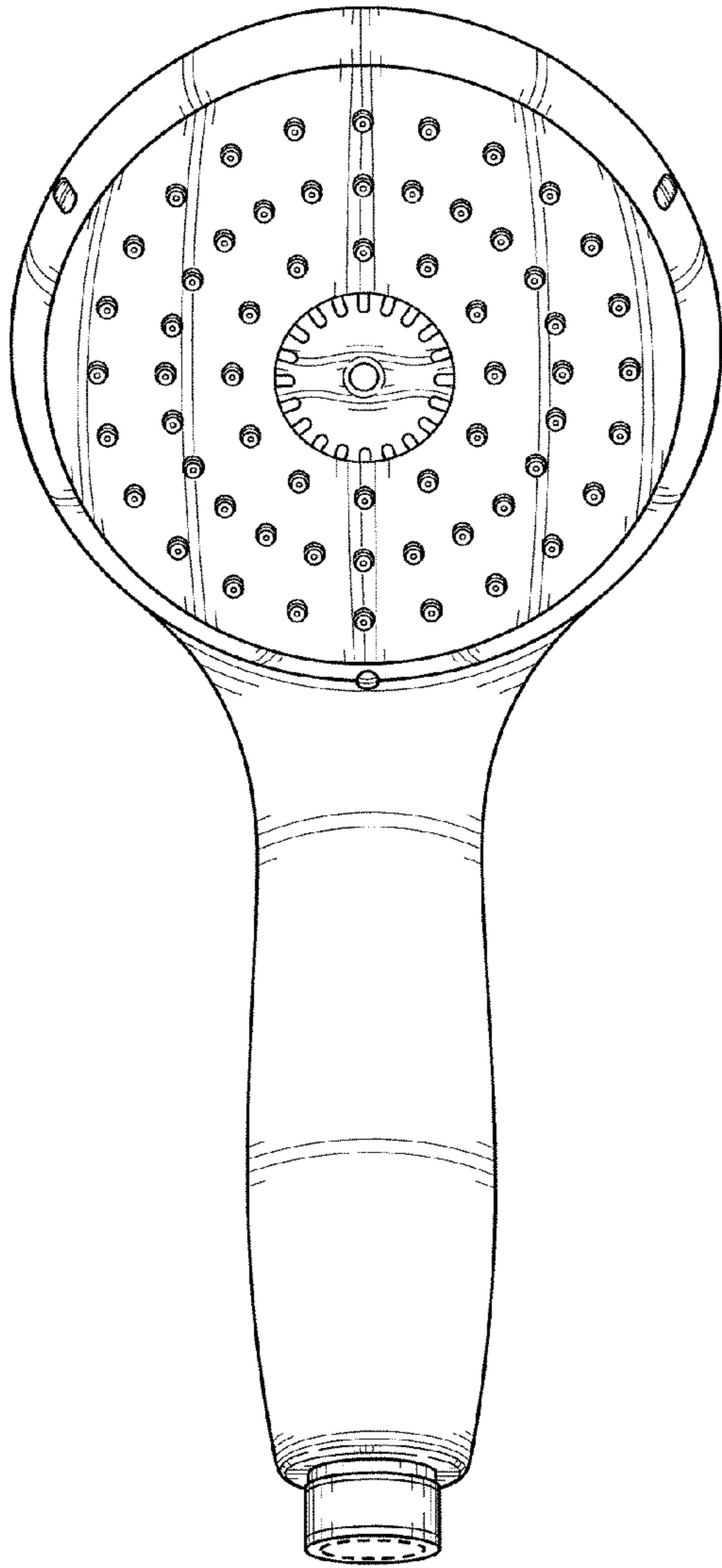

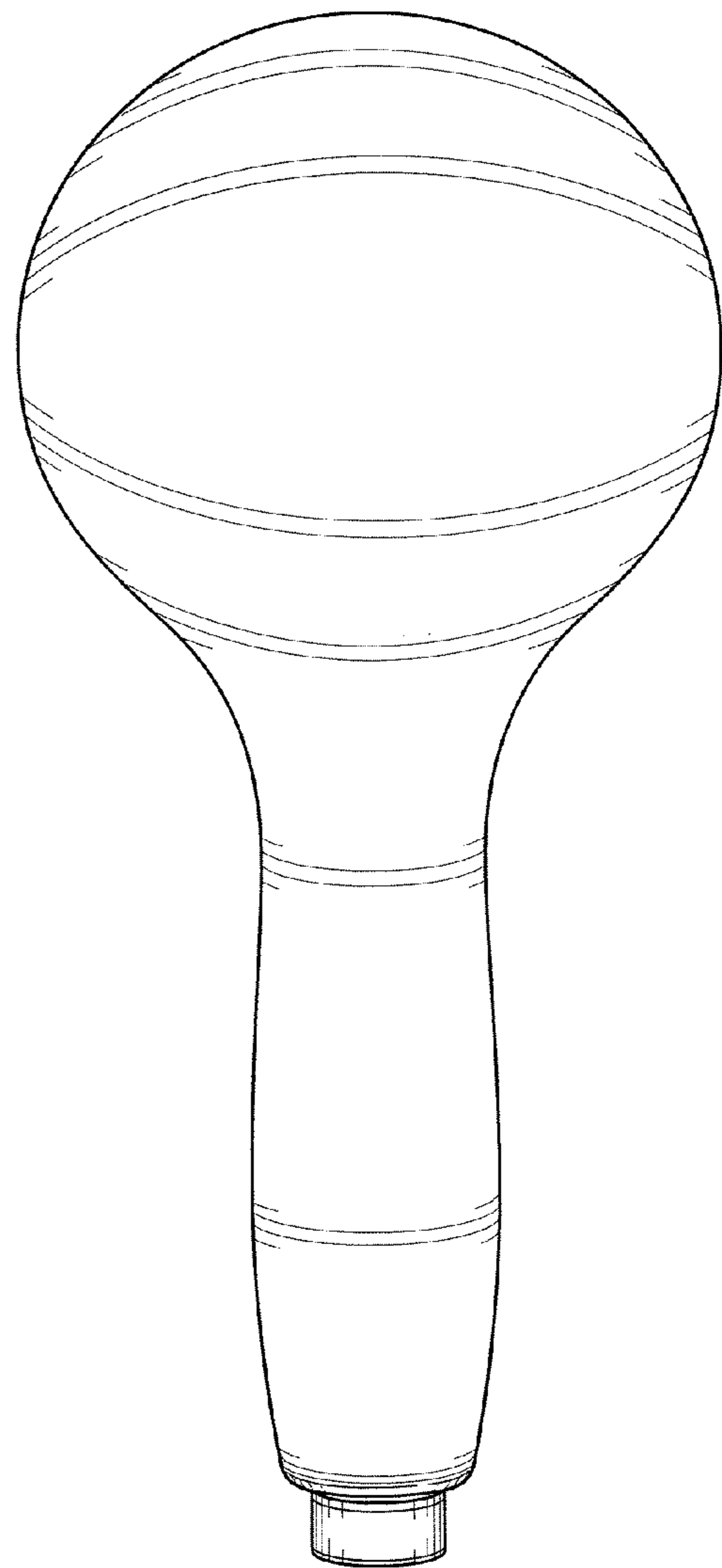

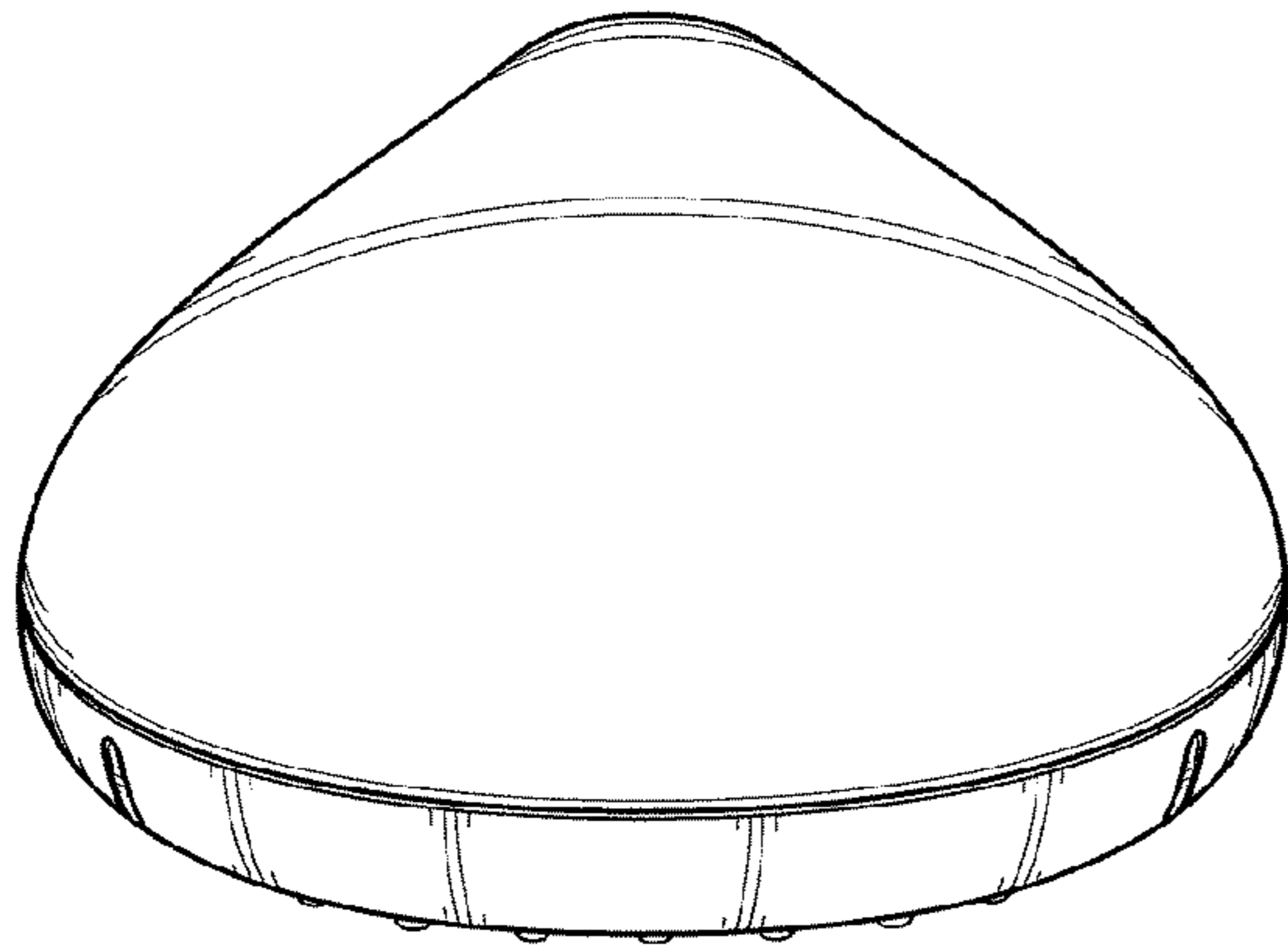

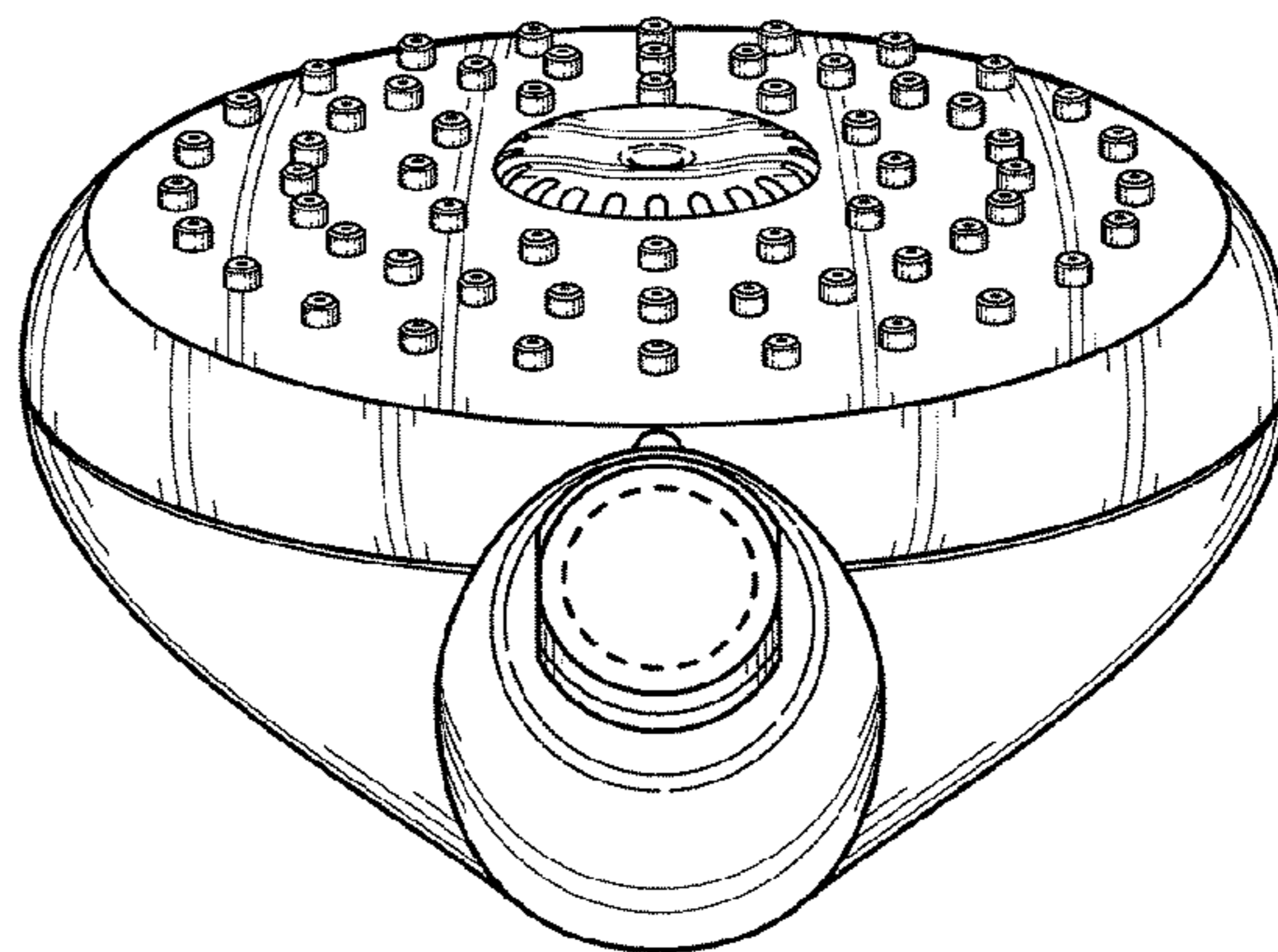

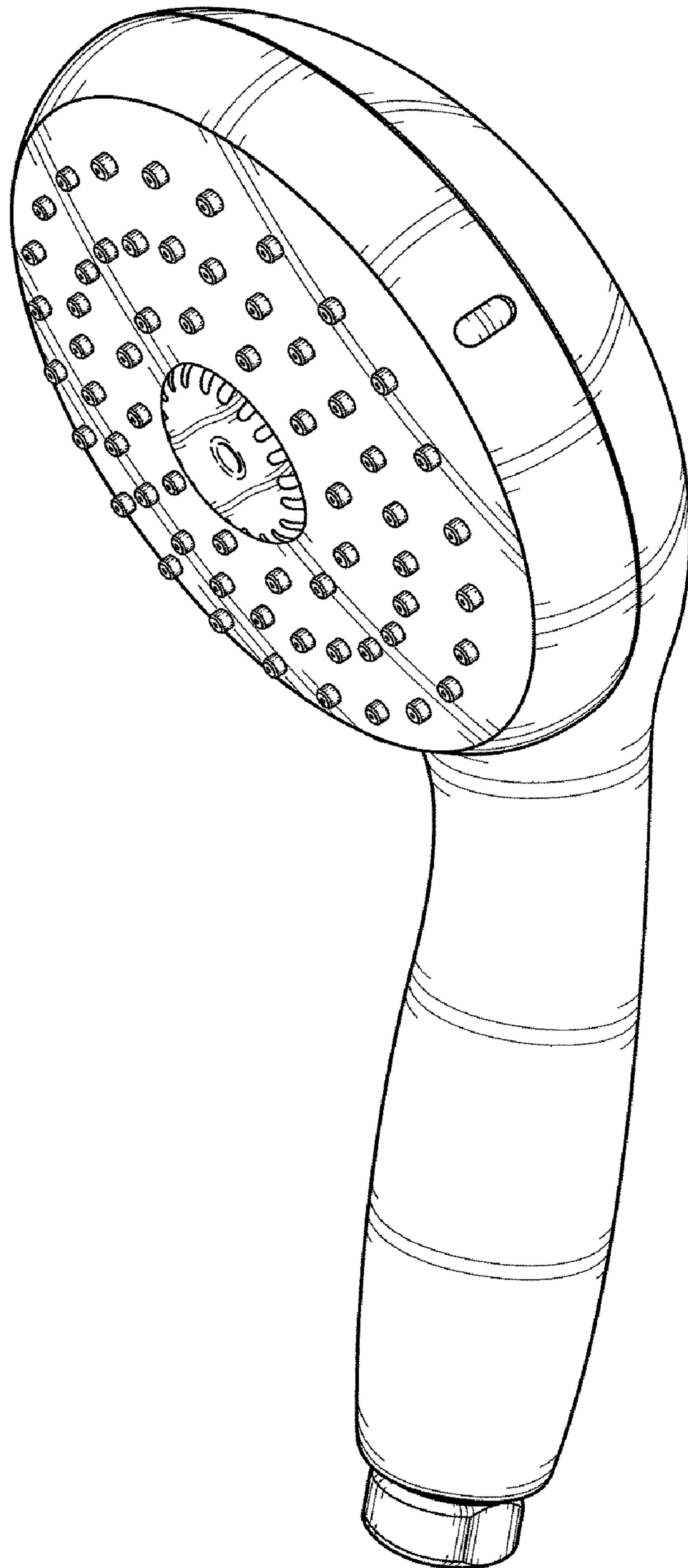

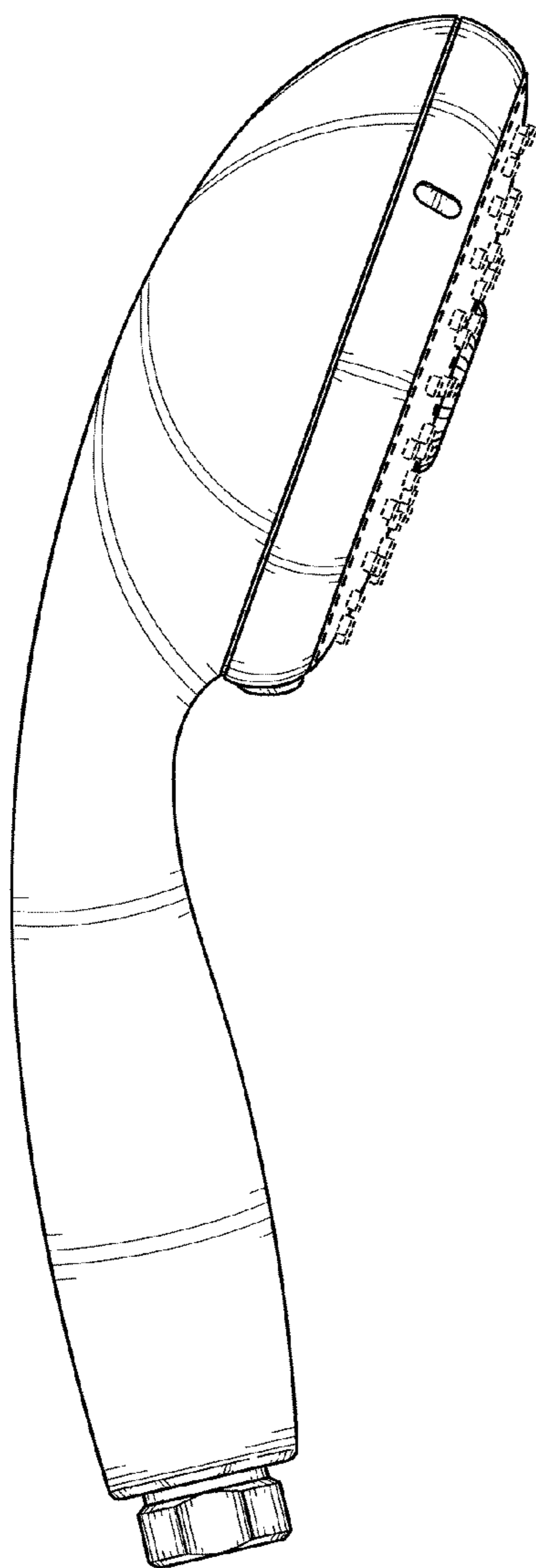

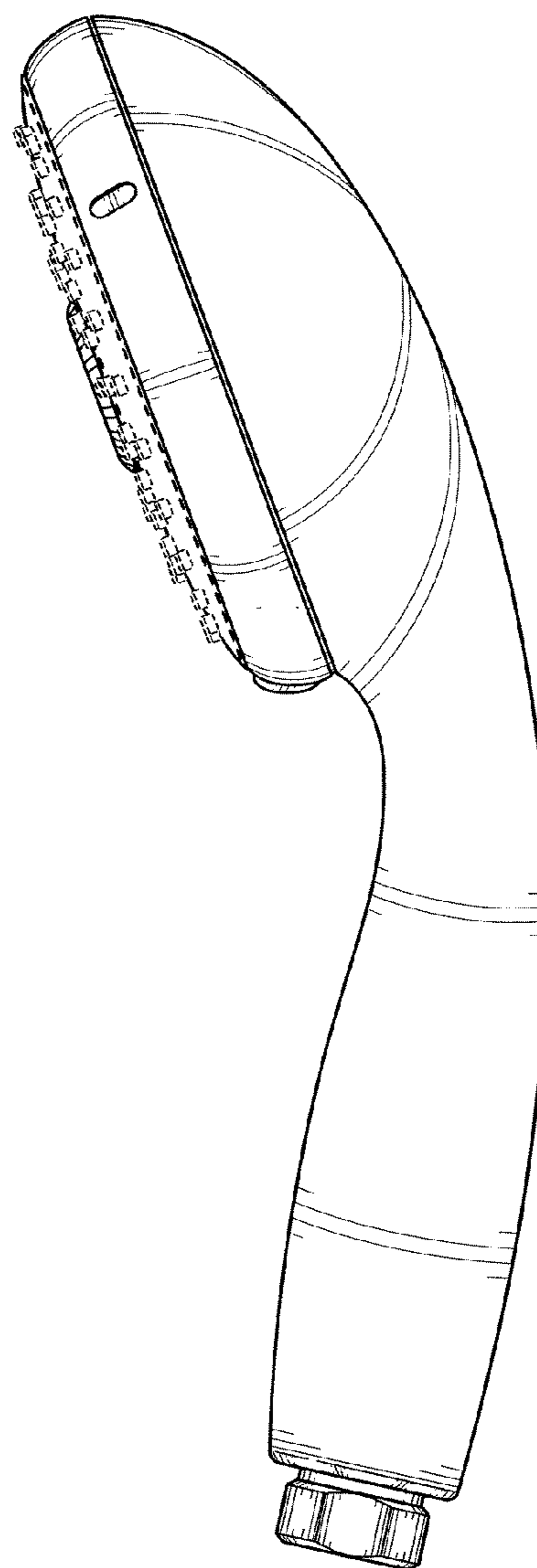

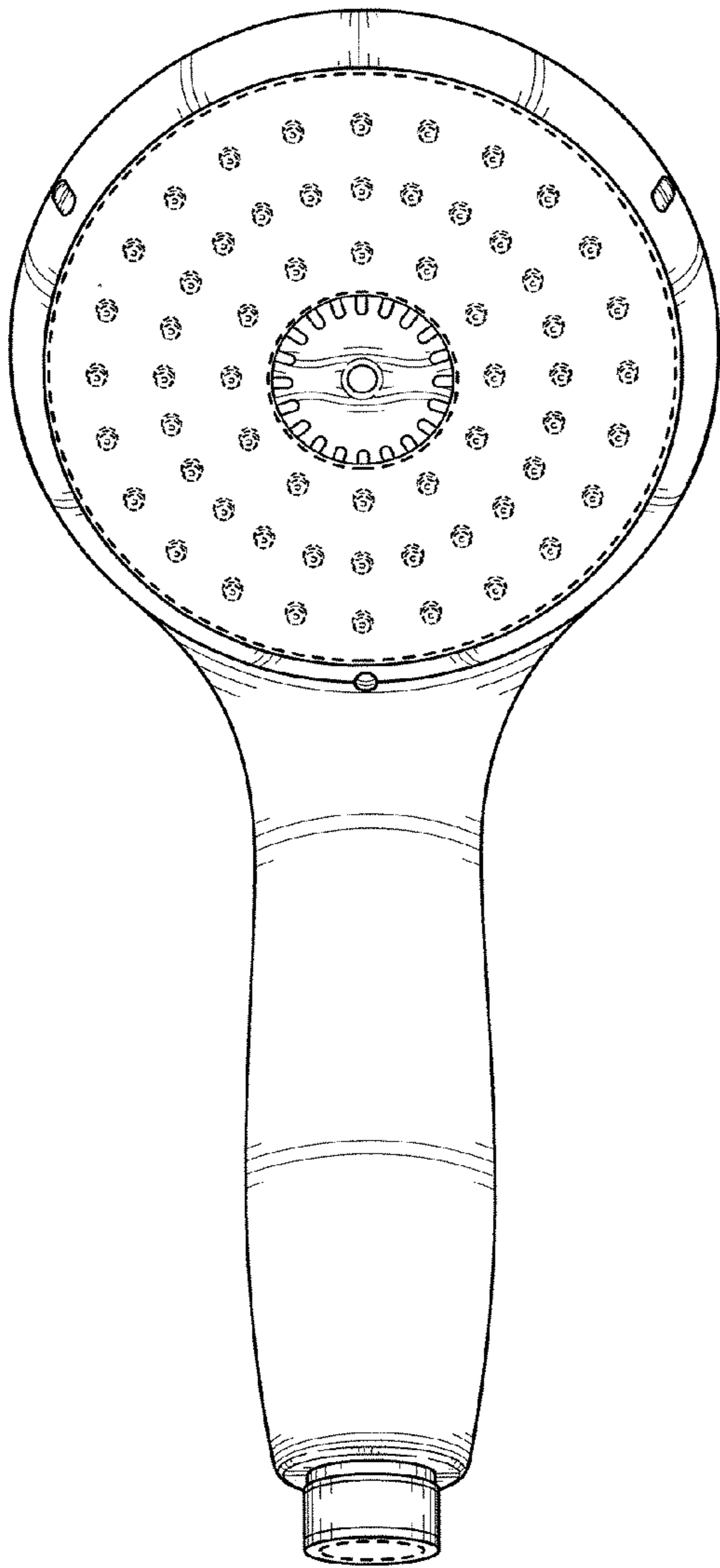

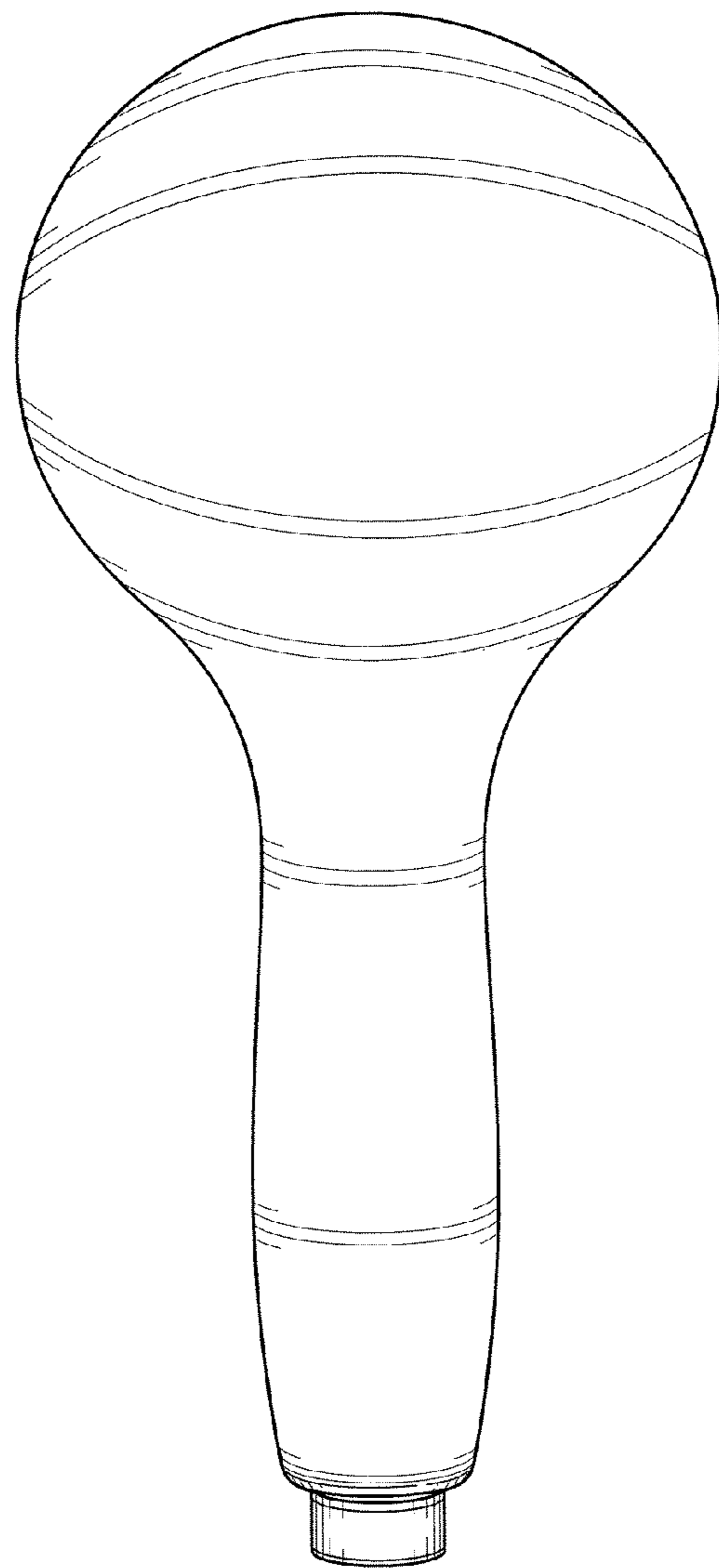

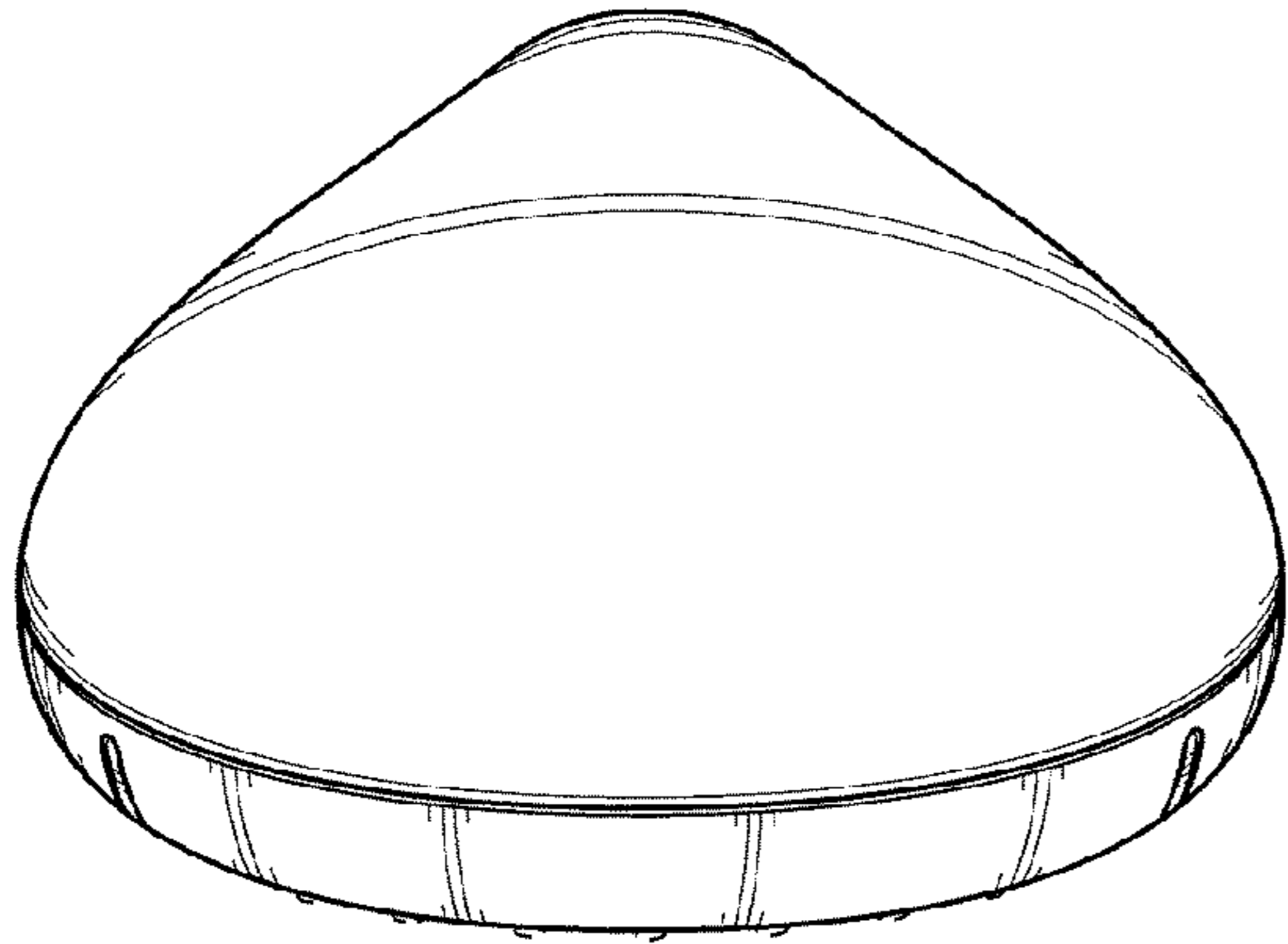

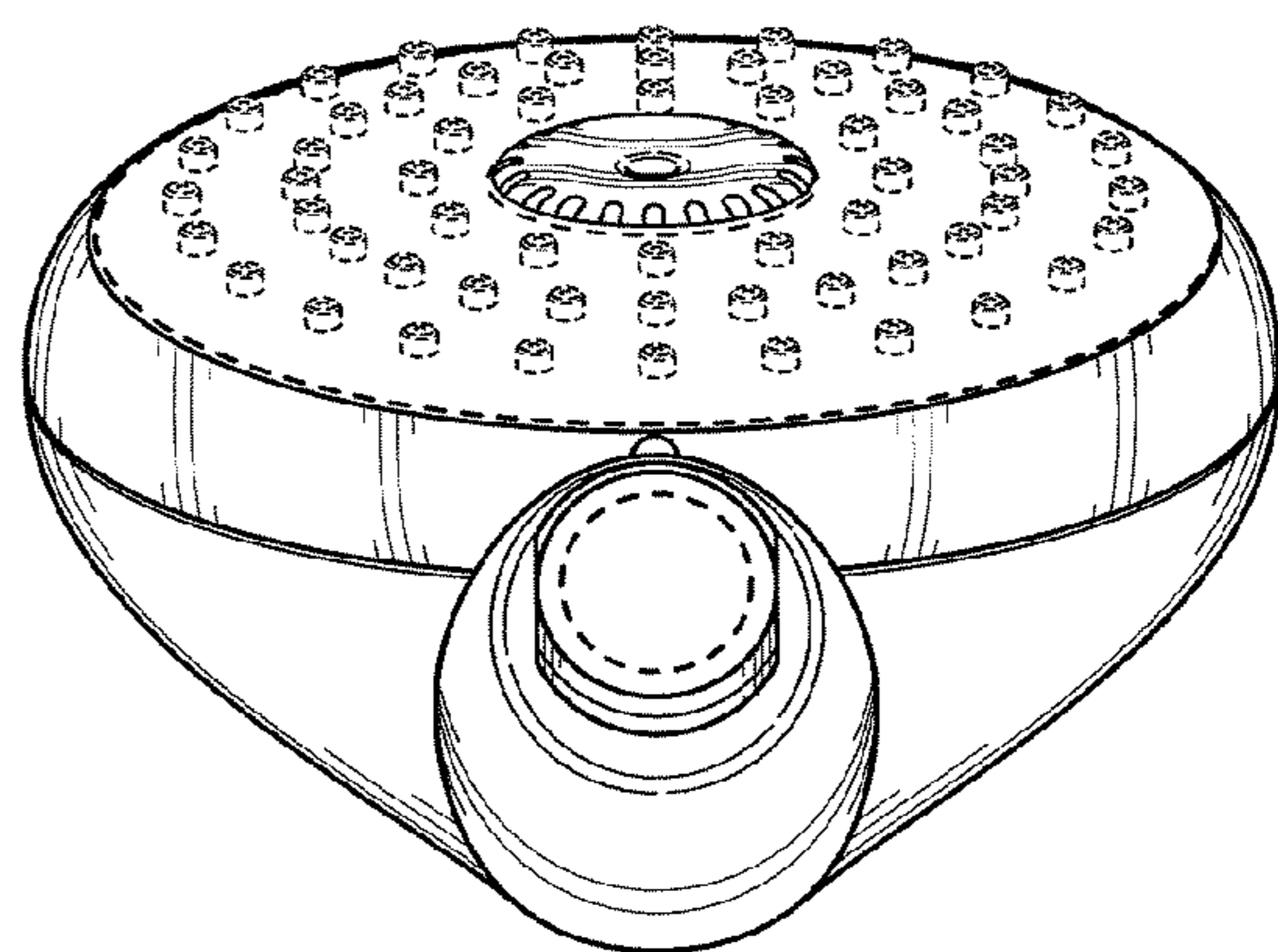

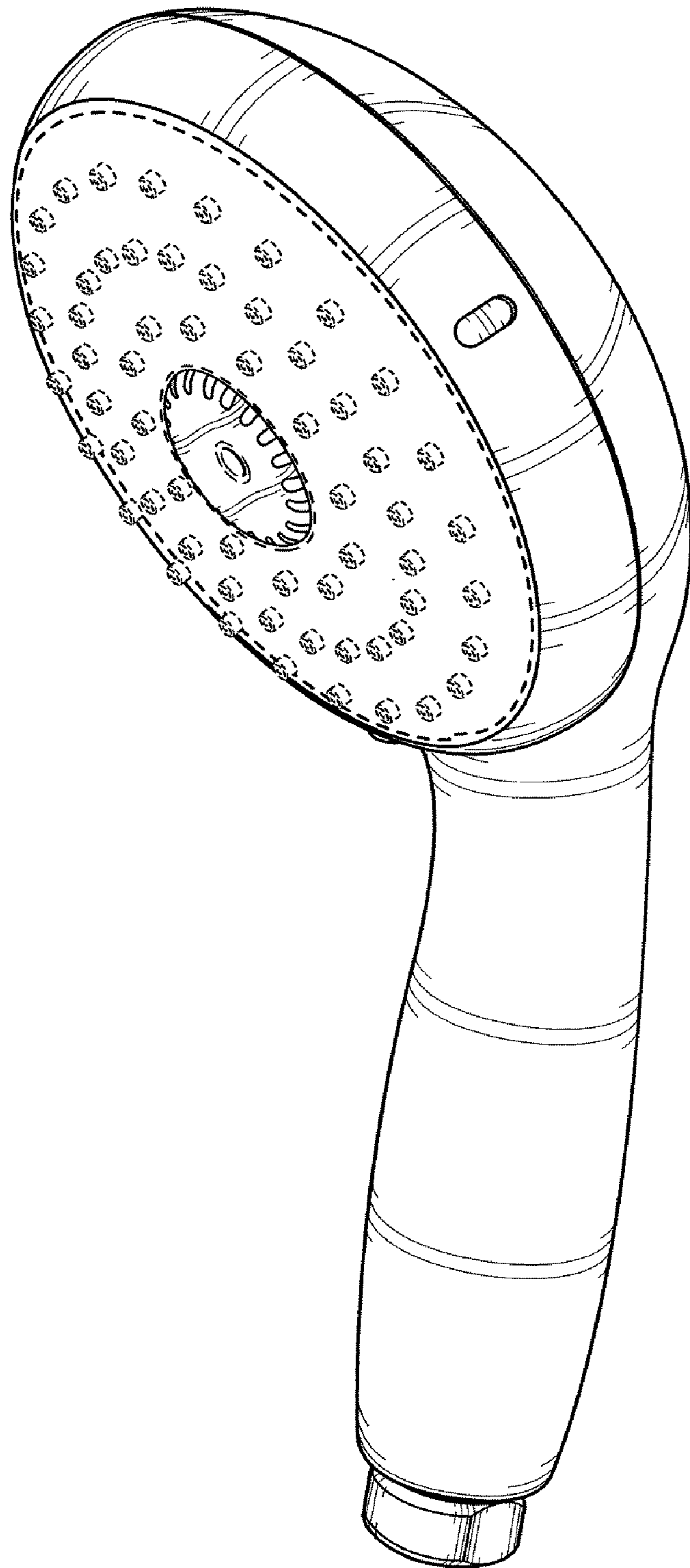
