(57) **CLAIM**

The ornamental design for a nail appliqué, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of a nail appliqué showing my new design, the phantom lines showing the finger being for illustrative purposes only and forming no part of the claimed design;

FIG. 2 is a top plan view of the nail appliqué shown in FIG. 1; FIG. 3 is a front elevation view of the nail appliqué shown in FIG. 1;

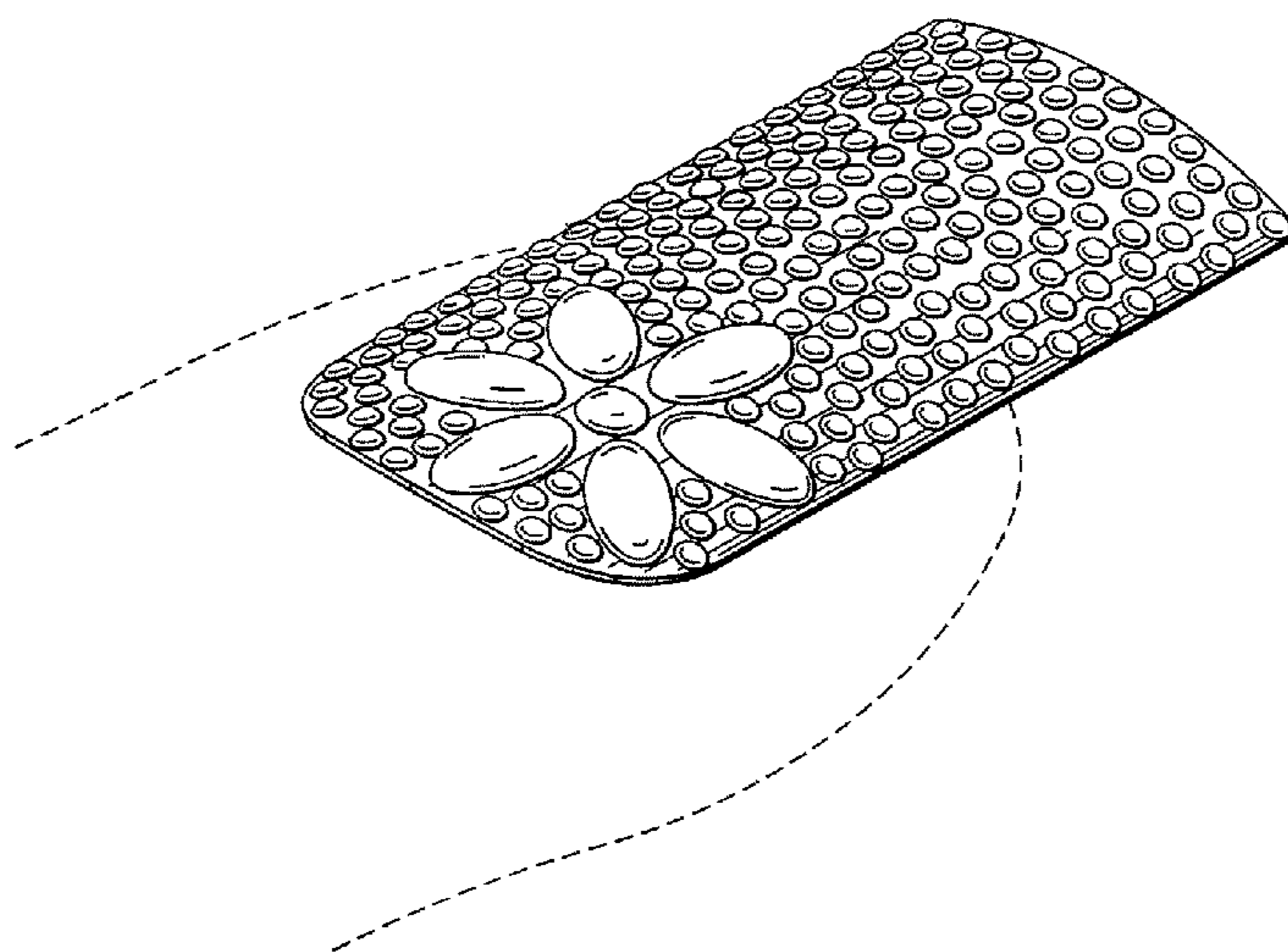
FIG. 4 is a right side elevation view of the nail appliqué shown in FIG. 1;

FIG. 5 is a left side elevation view of the nail appliqué shown in FIG. 1; and,

FIG. 6 is a rear elevation view of the nail appliqué shown in FIG. 1.

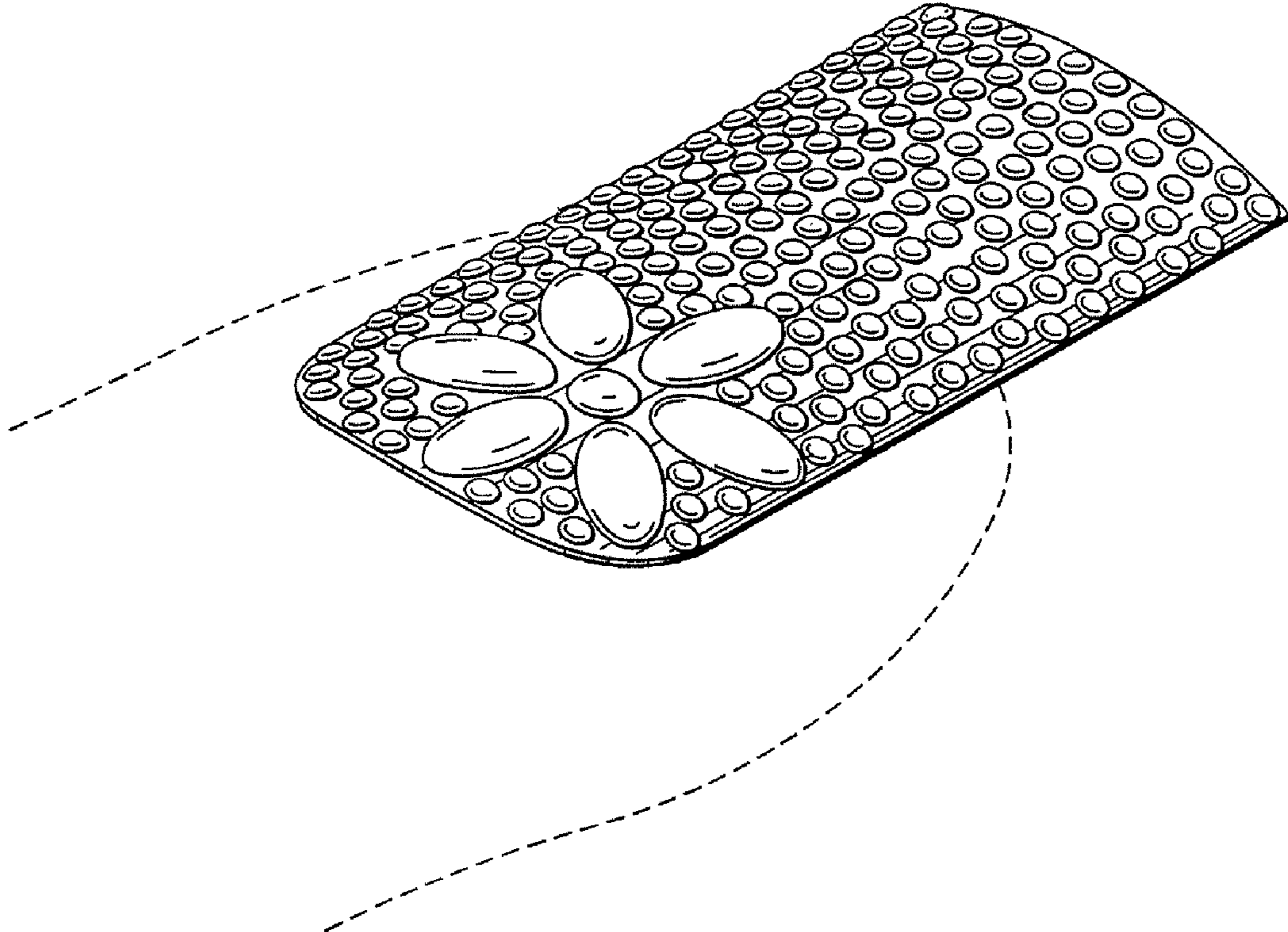

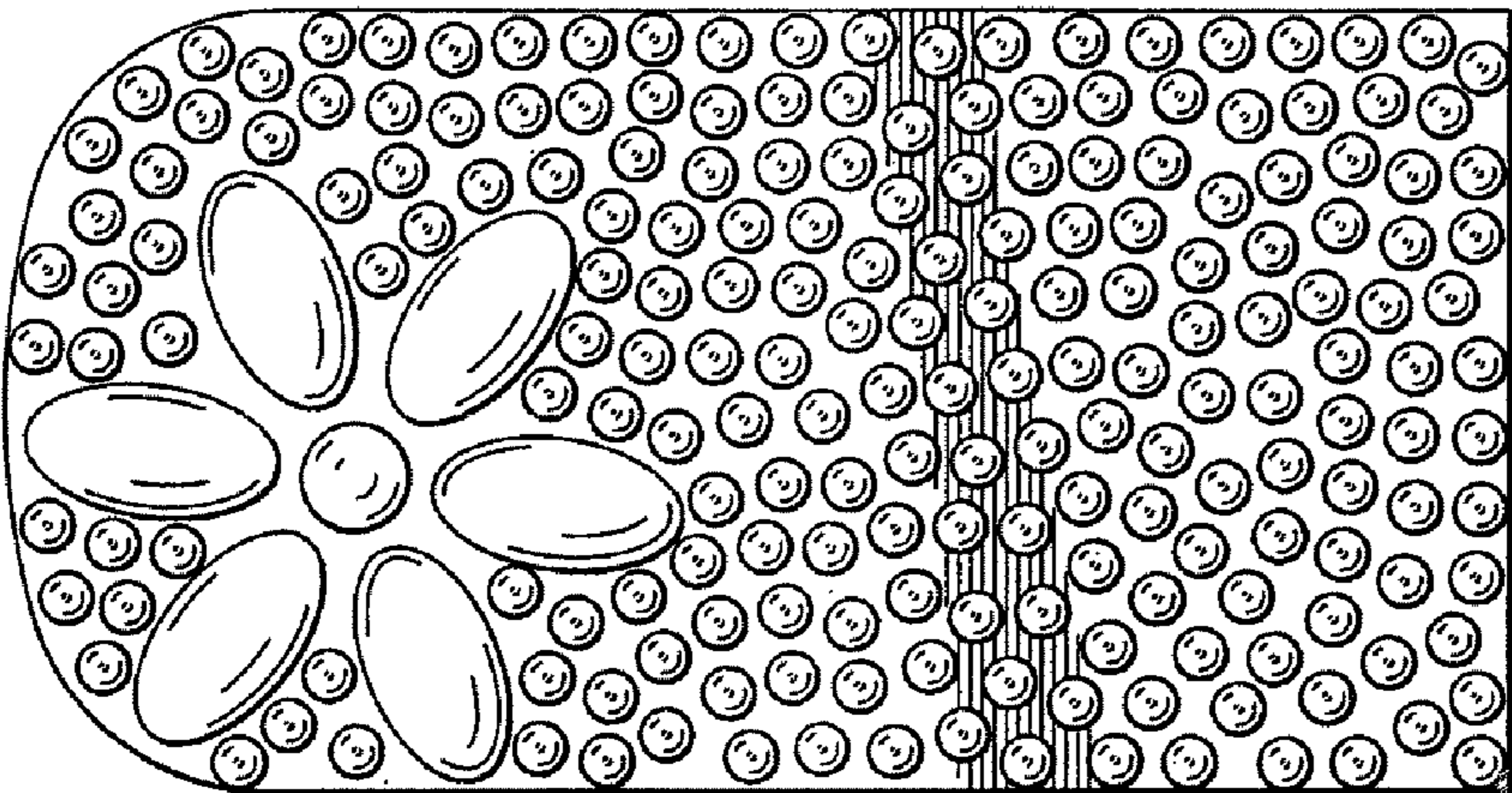
