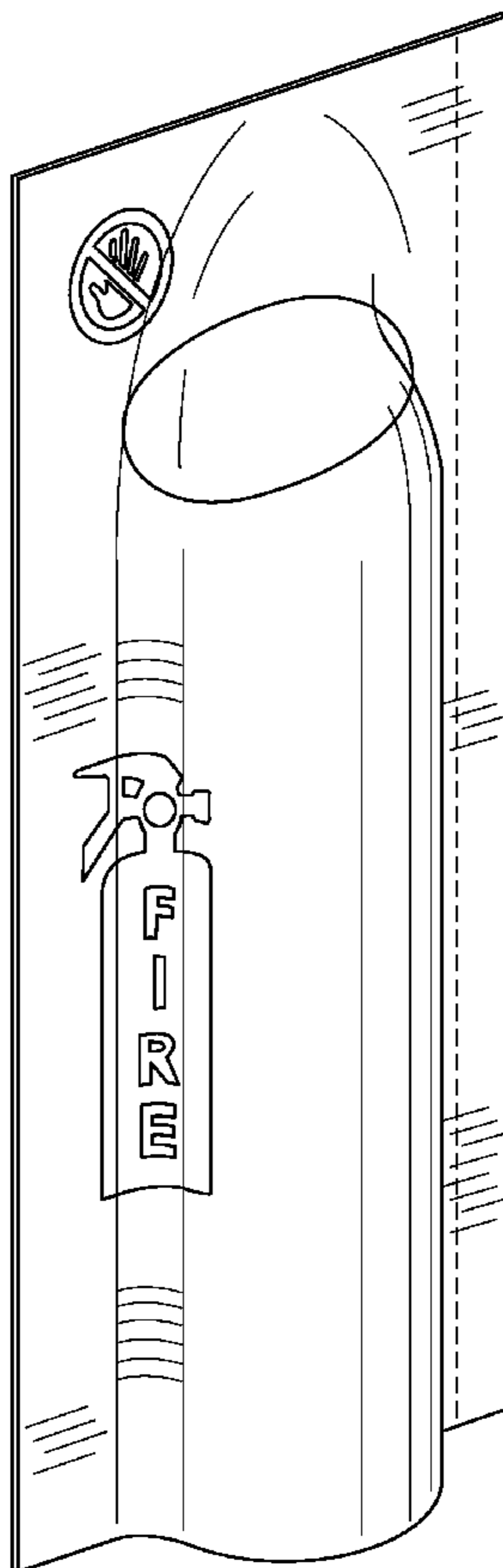

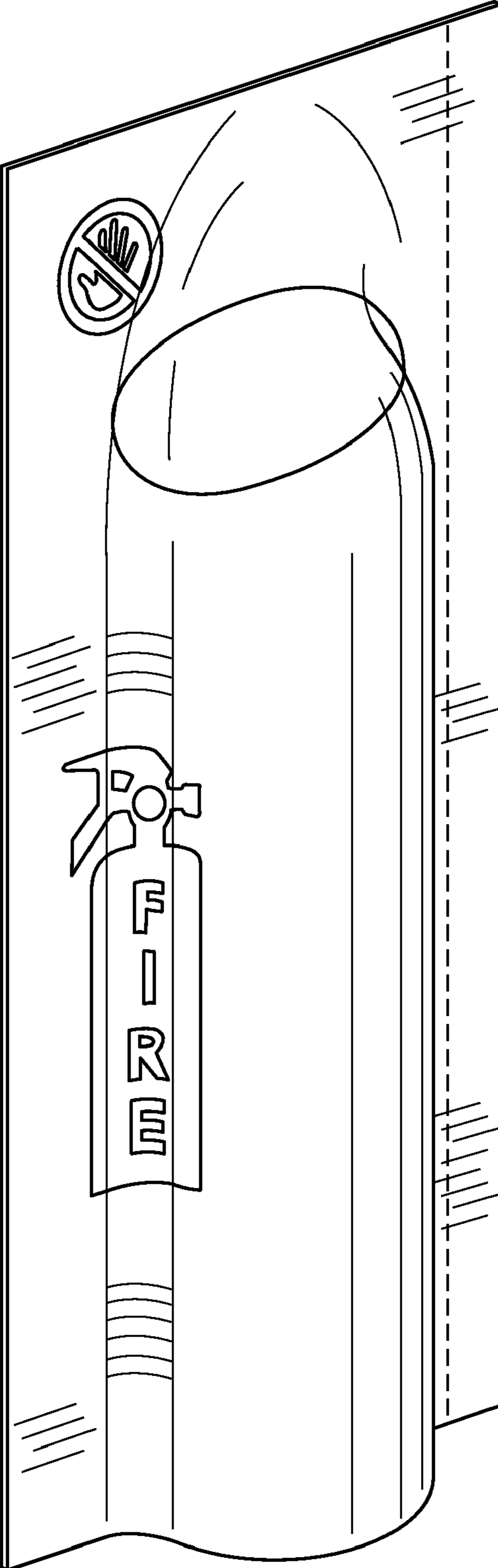
The ornamental design for a protective cover, as shown and described.

**DESCRIPTION**

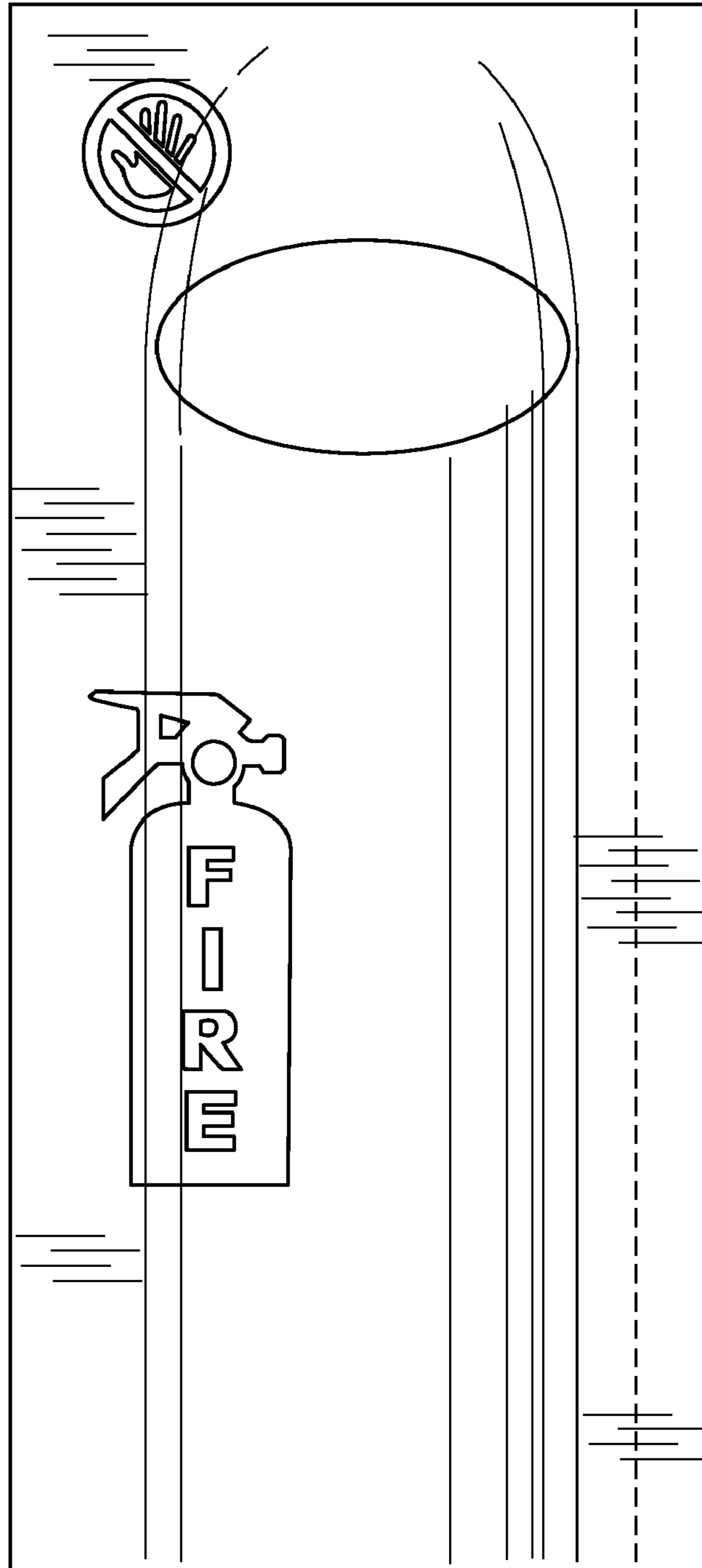
FIG. 1 is a front perspective view of the protective cover.

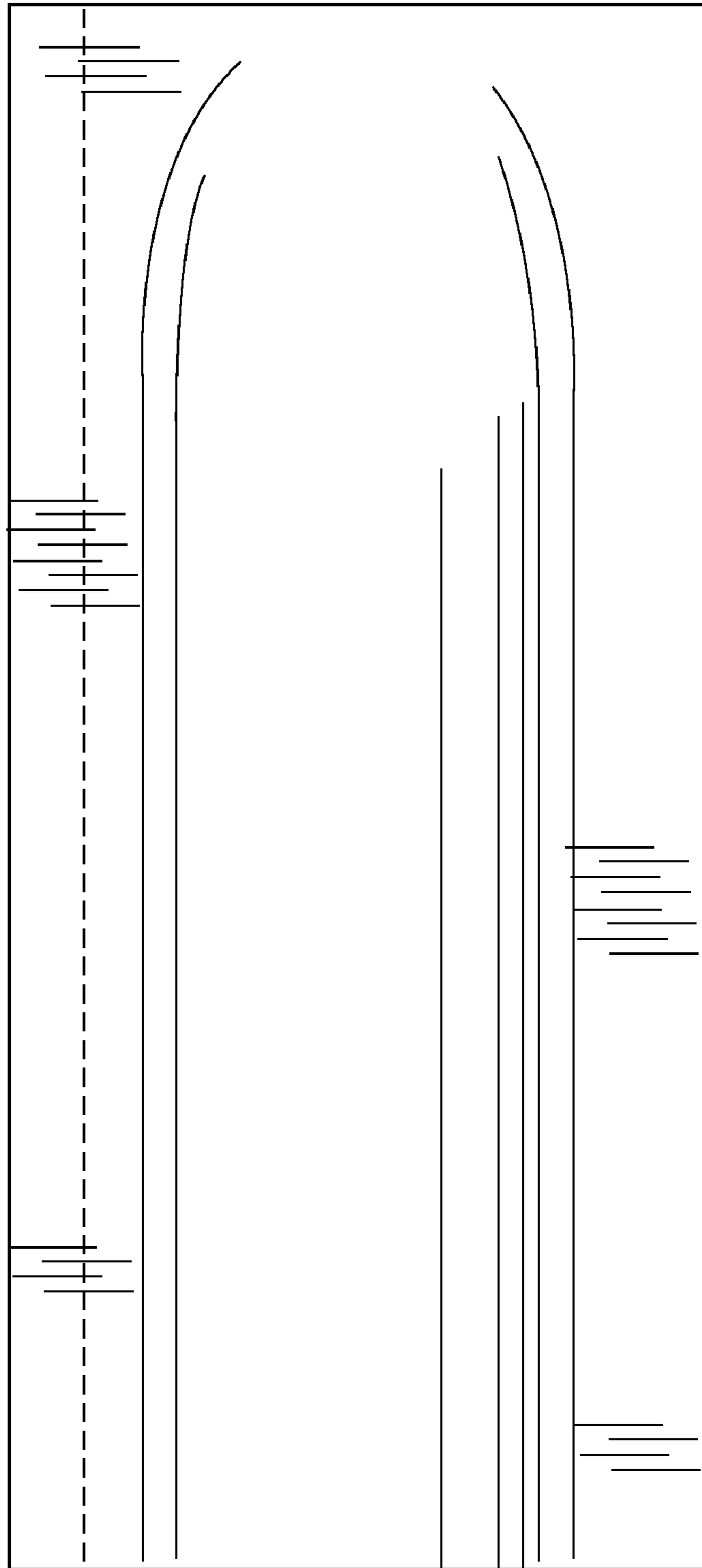




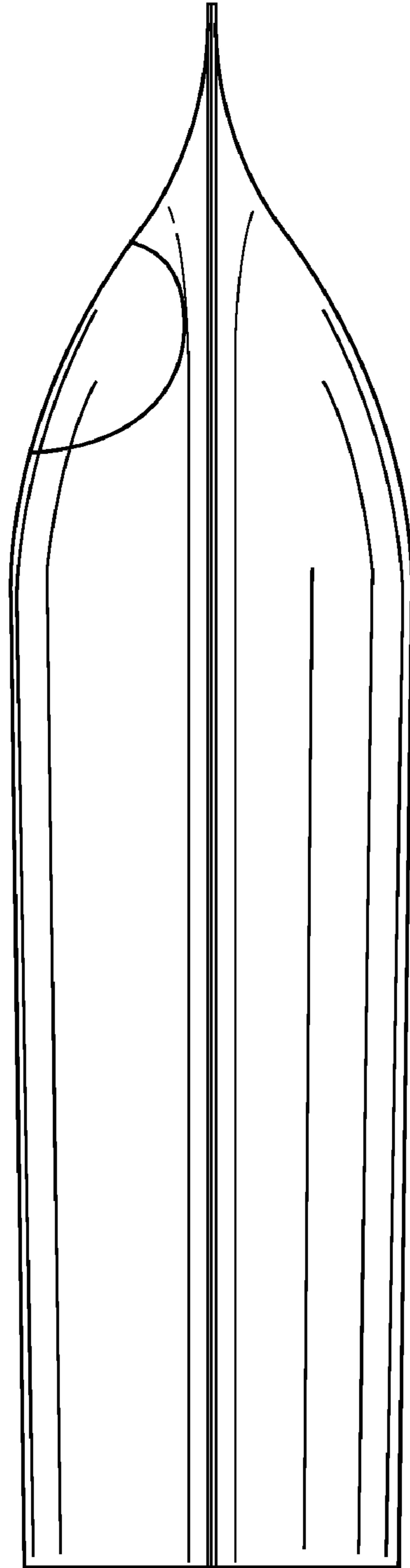

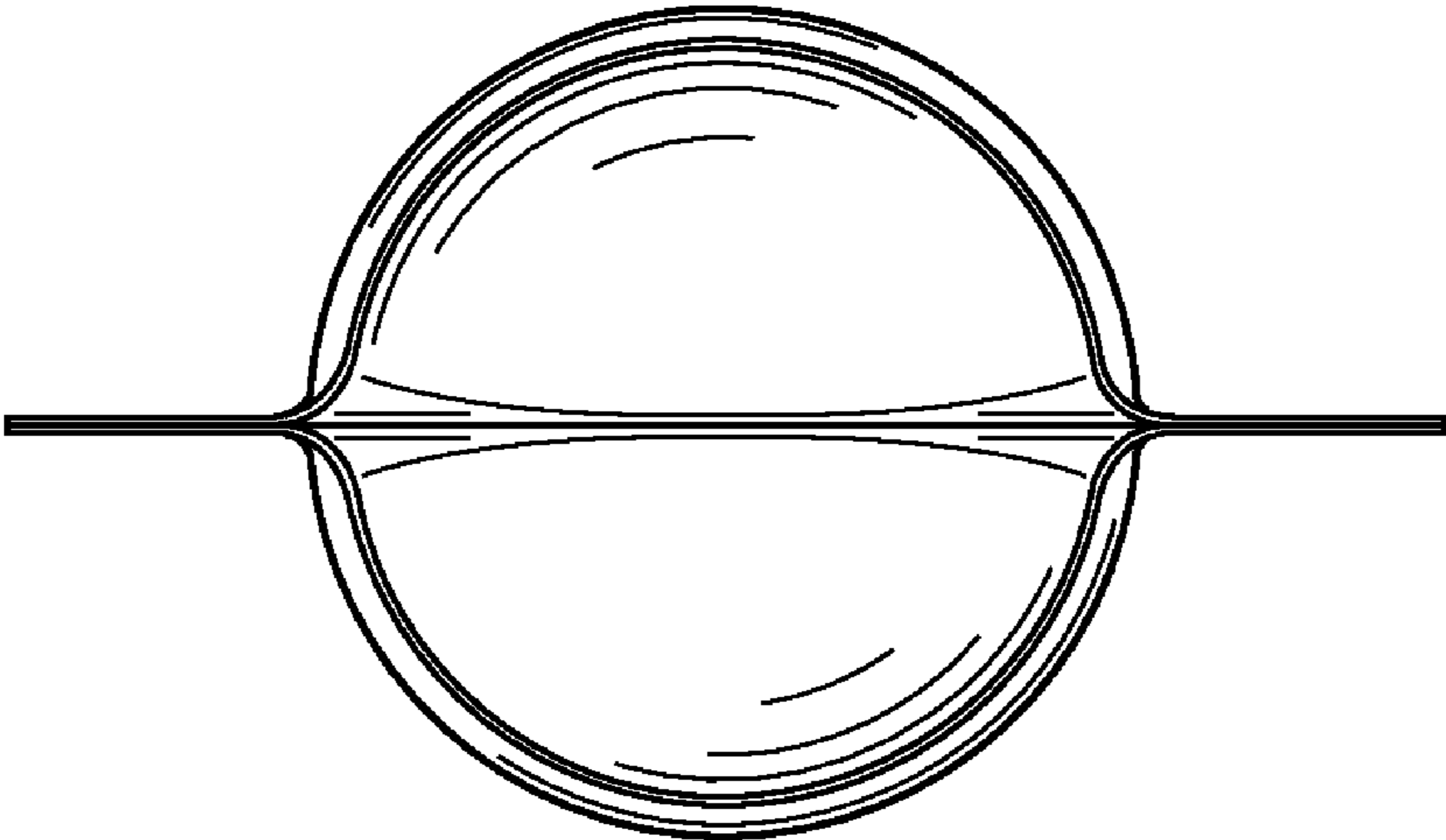

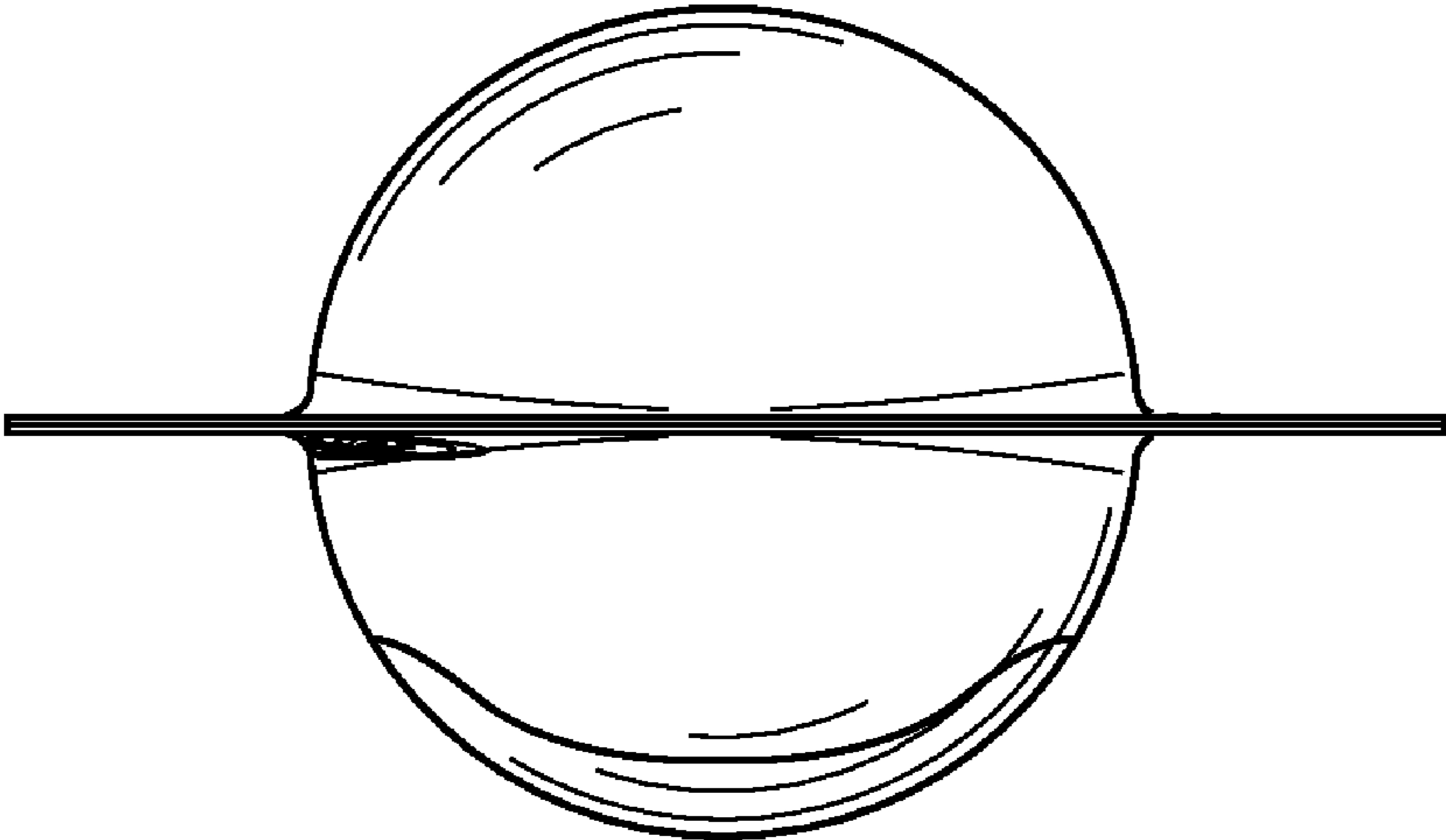
