(57) **CLAIM**

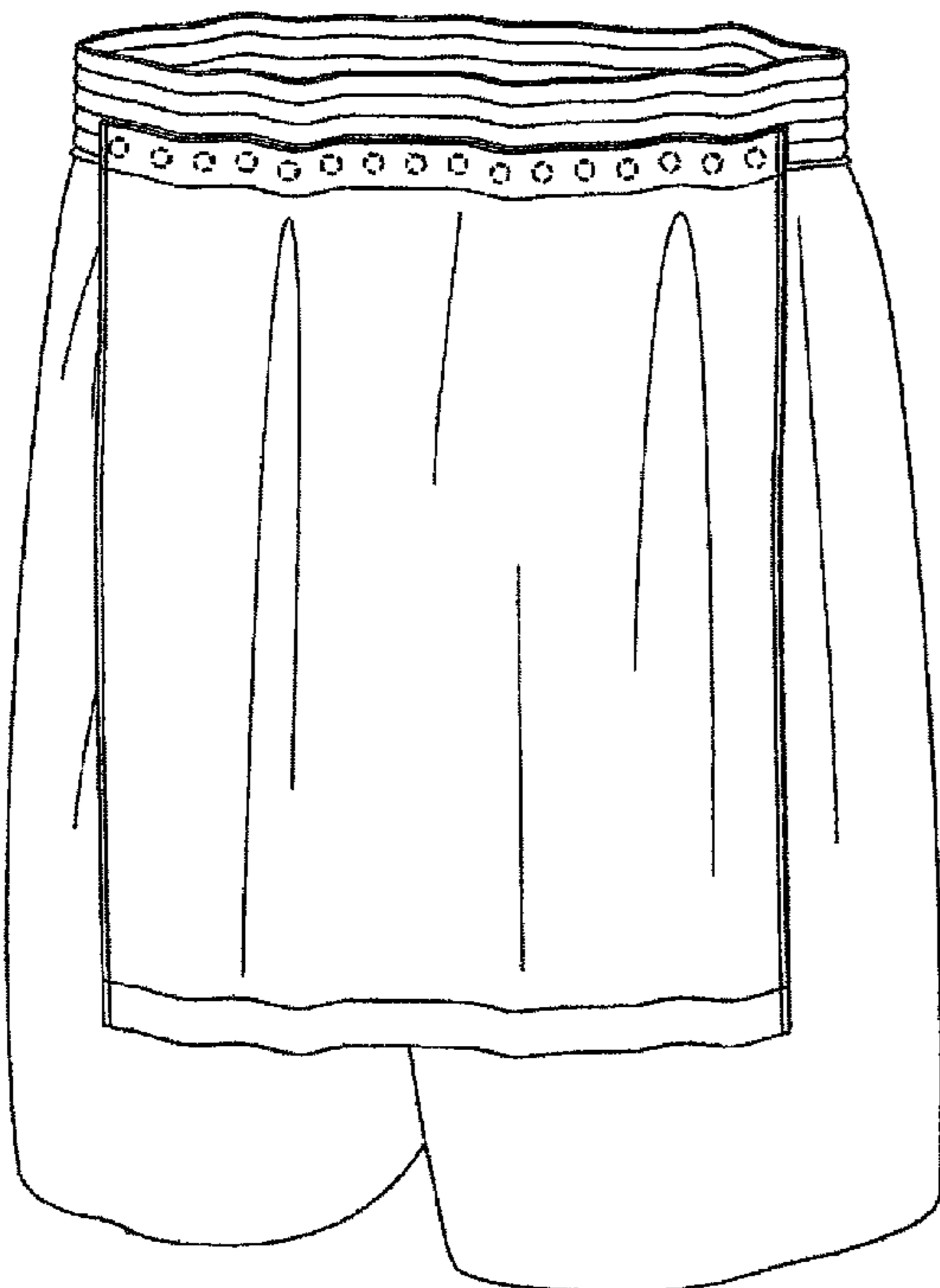
The ornamental design for shorts, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of shorts with a towel attached; FIG. 2 is a perspective view of the shorts with the towel partially attached; FIG. 3 is a perspective view of the shorts without the towel; FIG. 4 is a front view of the shorts illustrated in FIG. 1; FIG. 5 is a rear view of the shorts illustrated in FIG. 1; FIG. 6 is a left side view of the shorts illustrated in FIG. 1; FIG. 7 is a right side view of the shorts illustrated in FIG. 1; FIG. 8 is a top view of the shorts illustrated in FIG. 1; FIG. 9 is a bottom view of the shorts illustrated in FIG. 1; and, FIG. 10 is a perspective view of the shorts without the towel and with the waist band unfolded.

The broken lines, positioned at the waistband of the shorts and along the top of the towel, represent the attaching structure for the towel and shorts. The broken line representations are for illustrative purposes only and form no part of the claimed design.

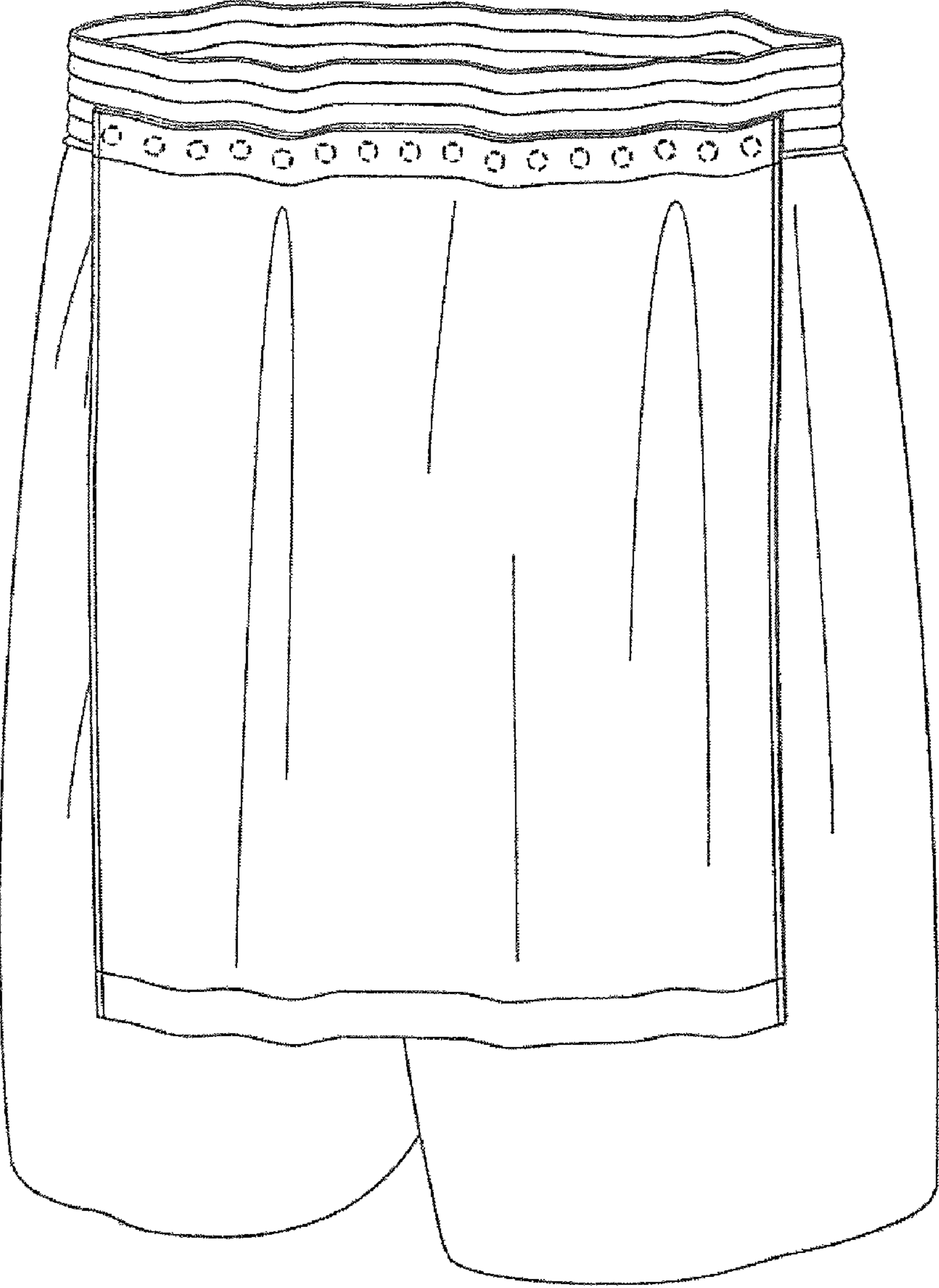

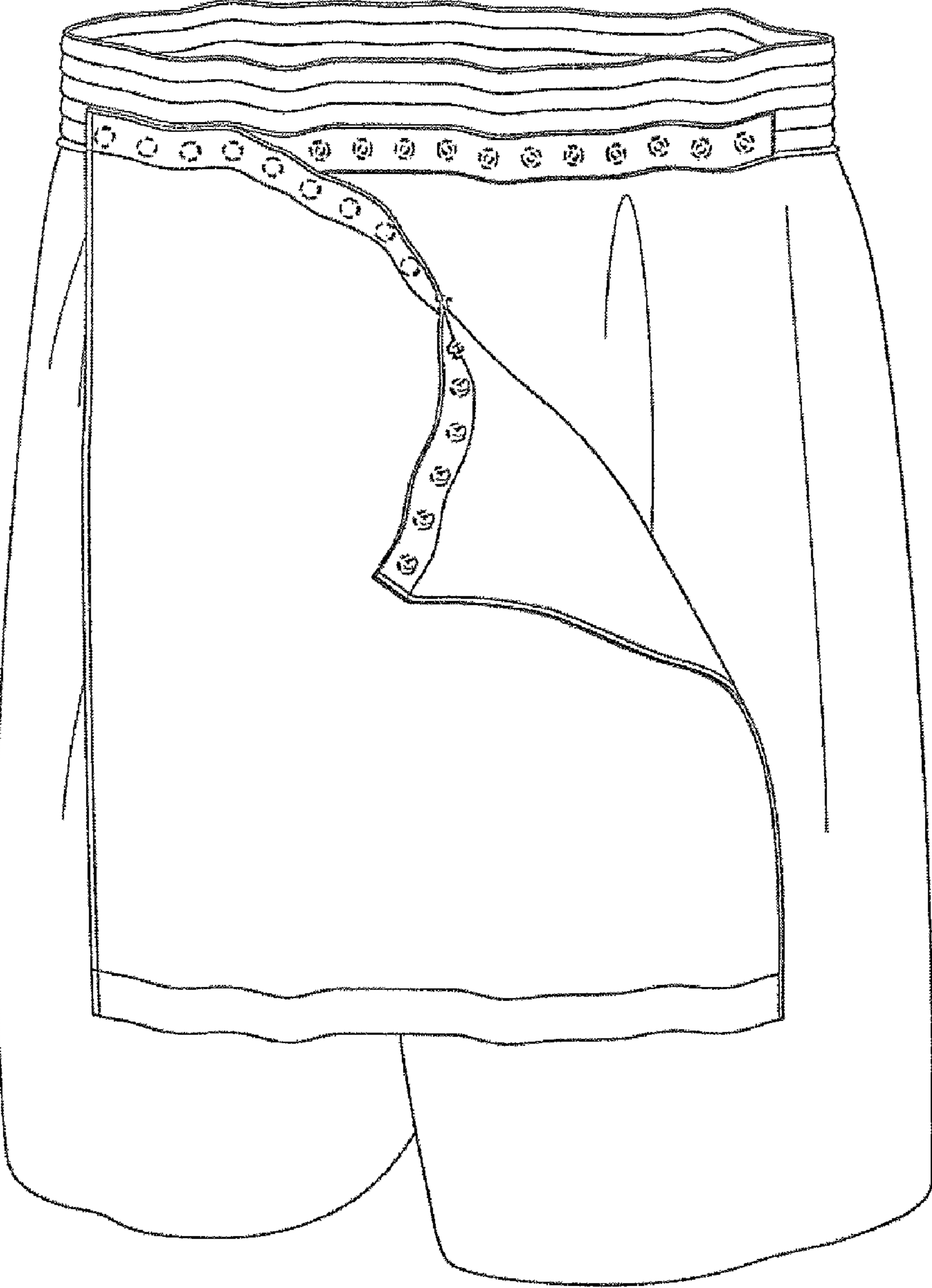

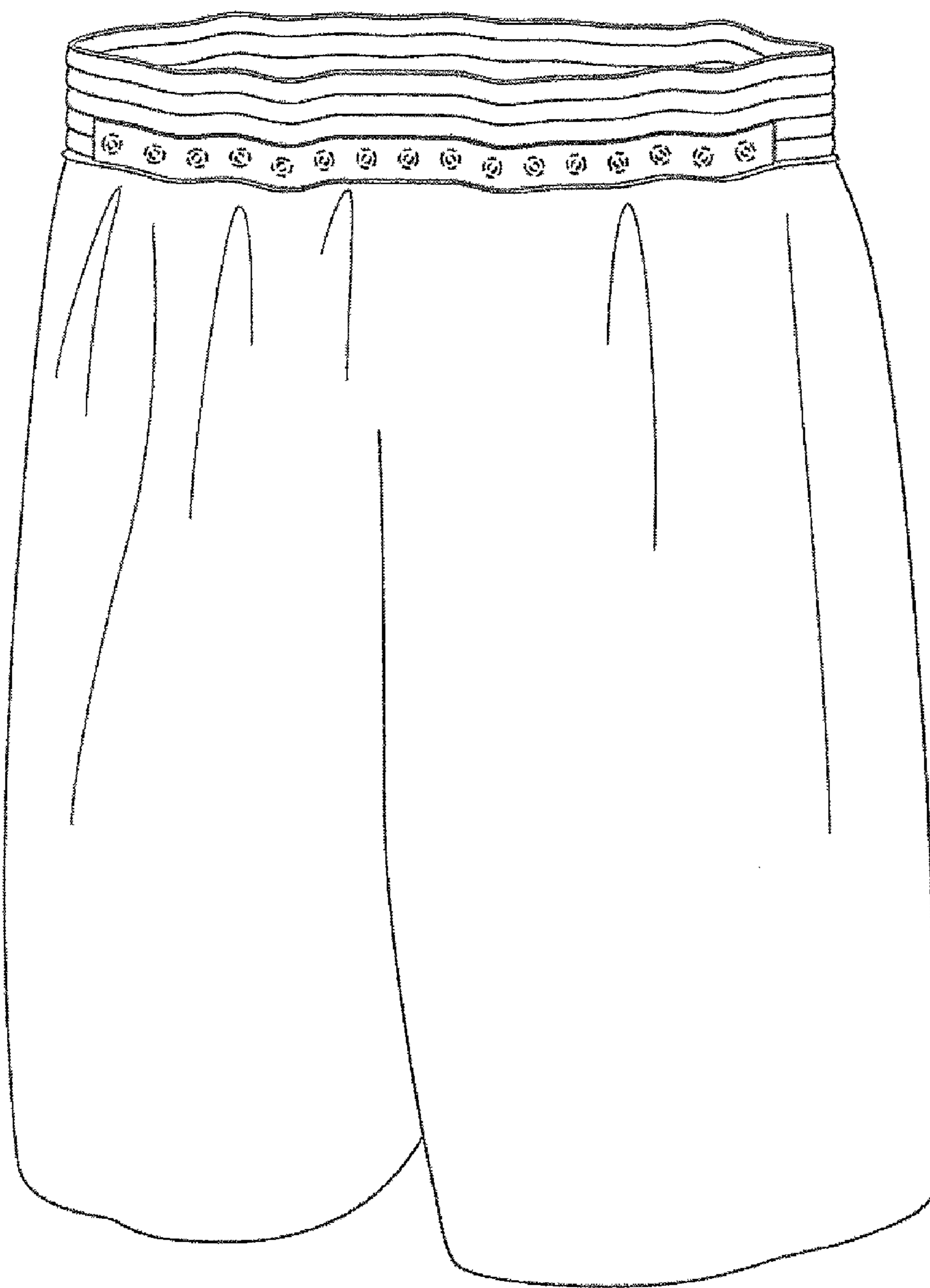

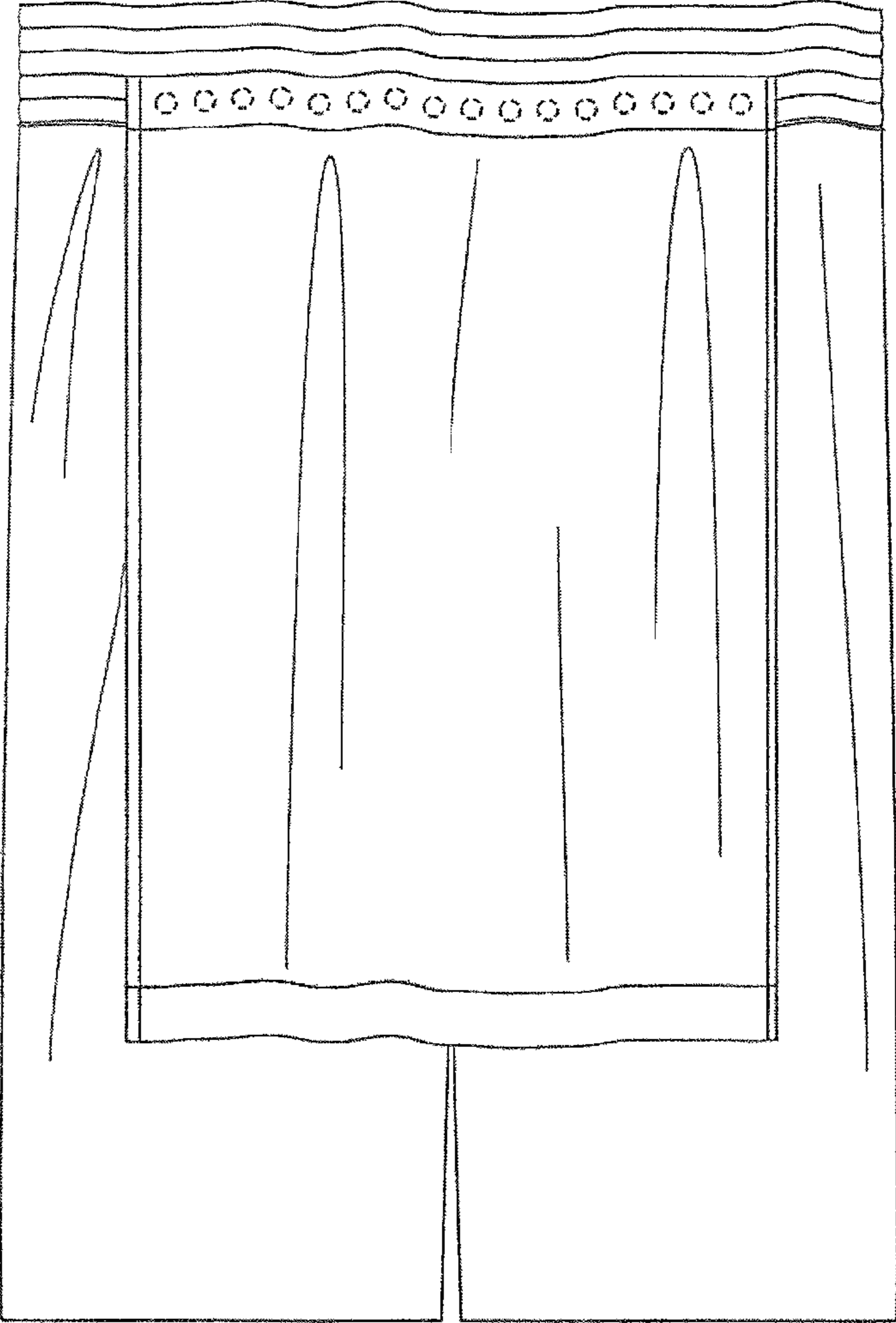

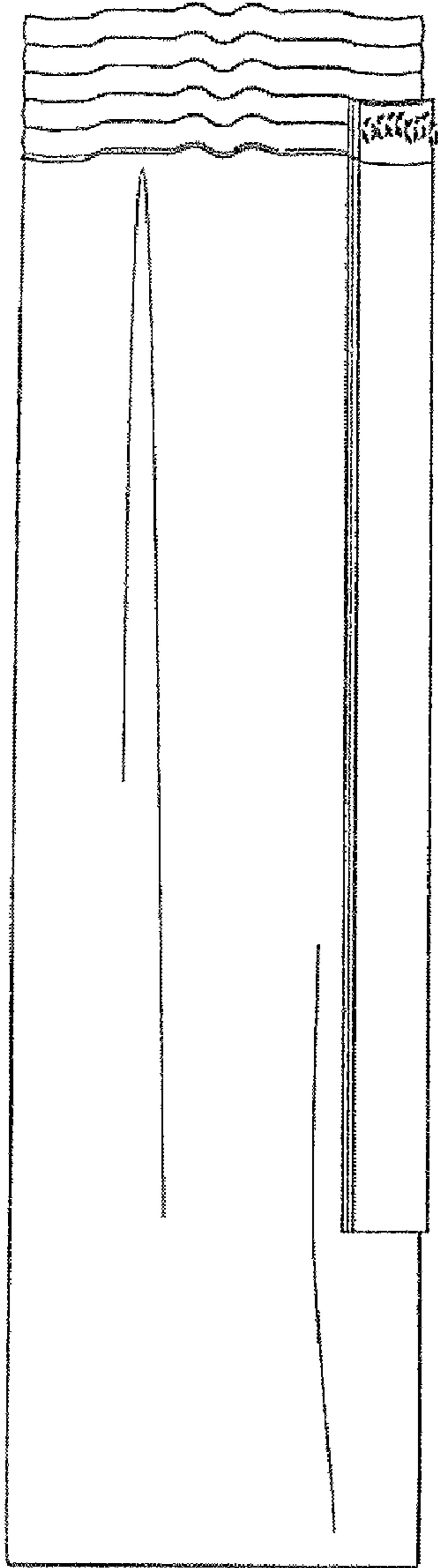

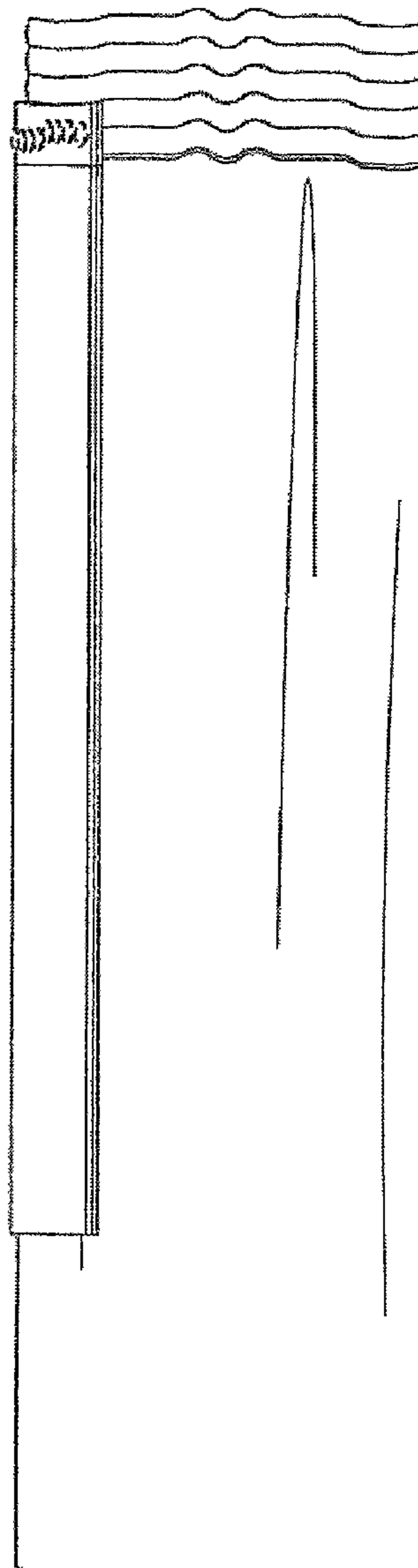

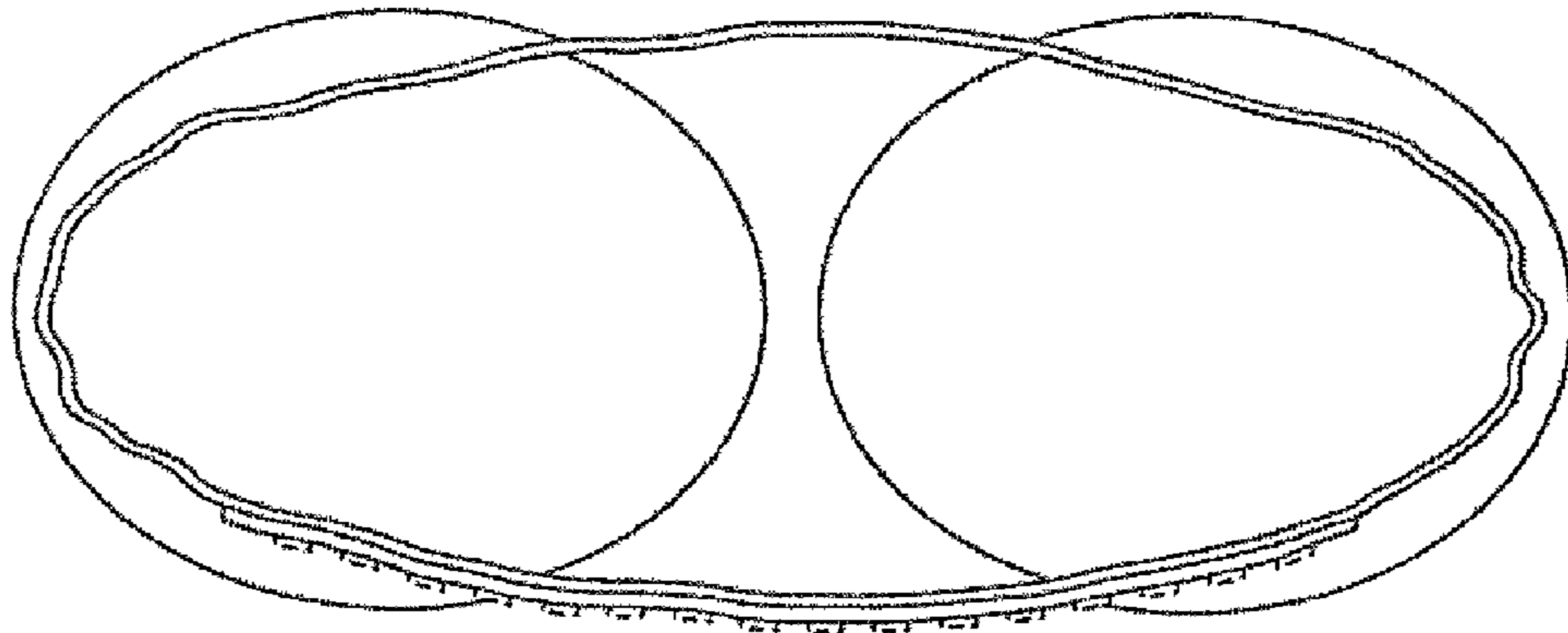

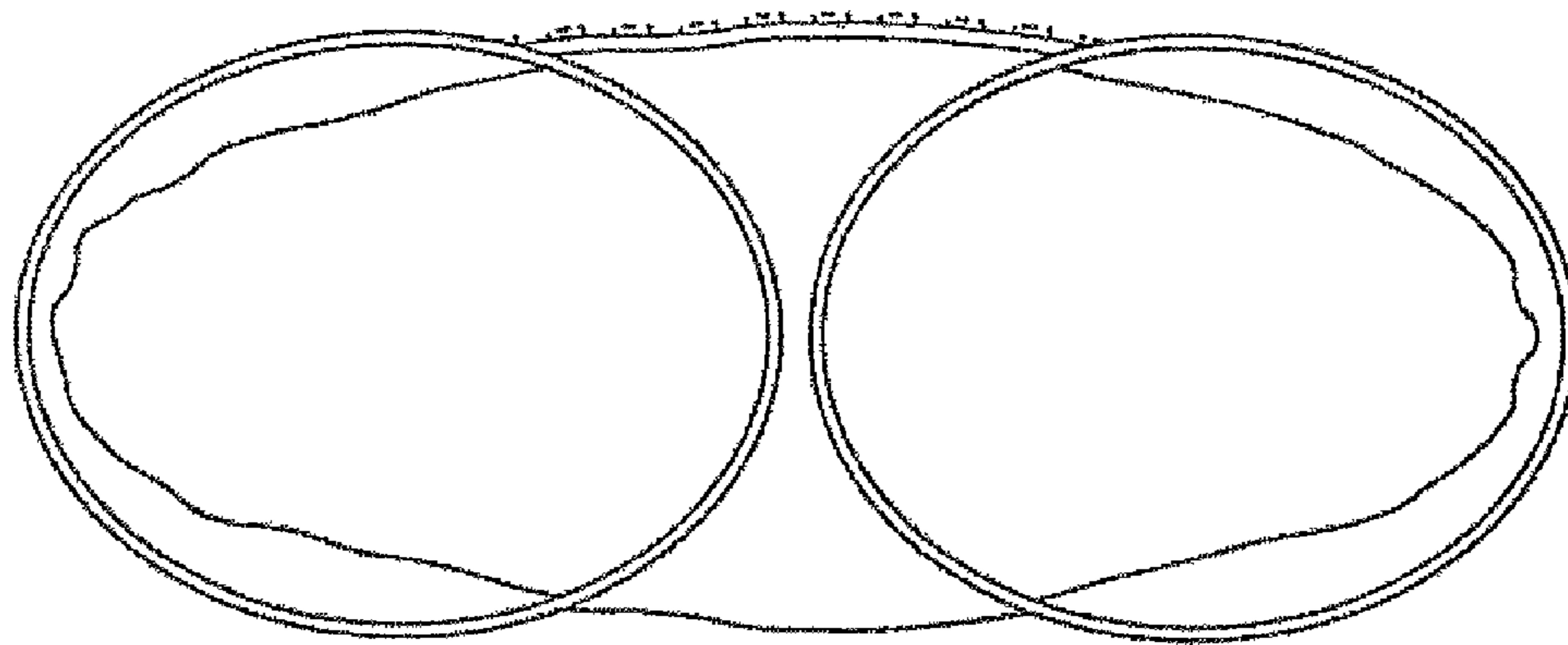

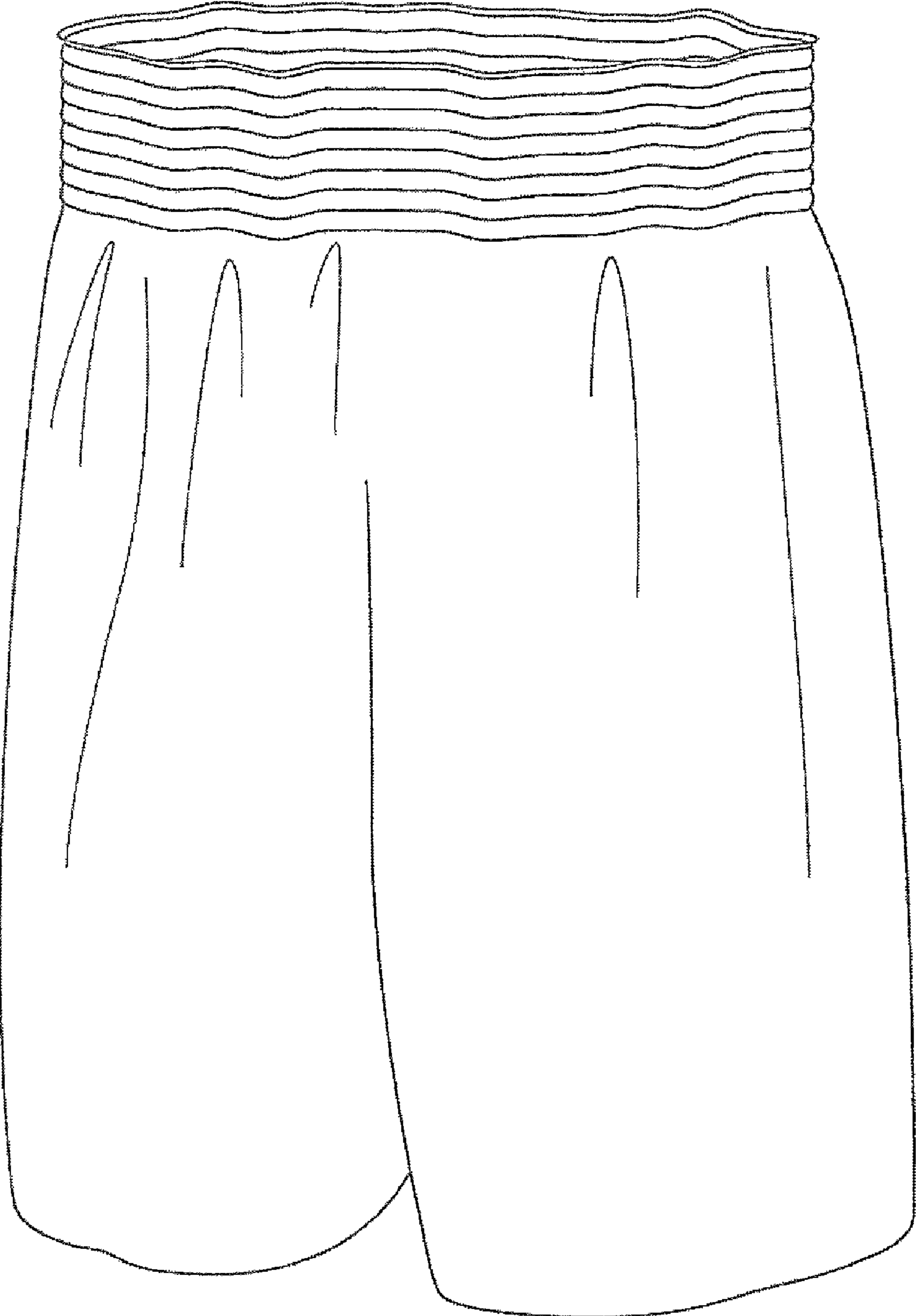
