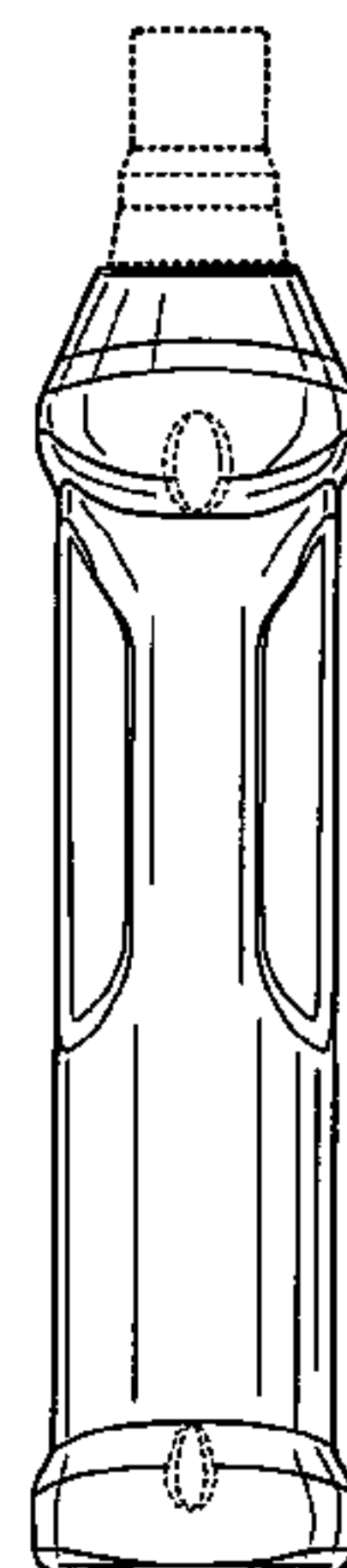
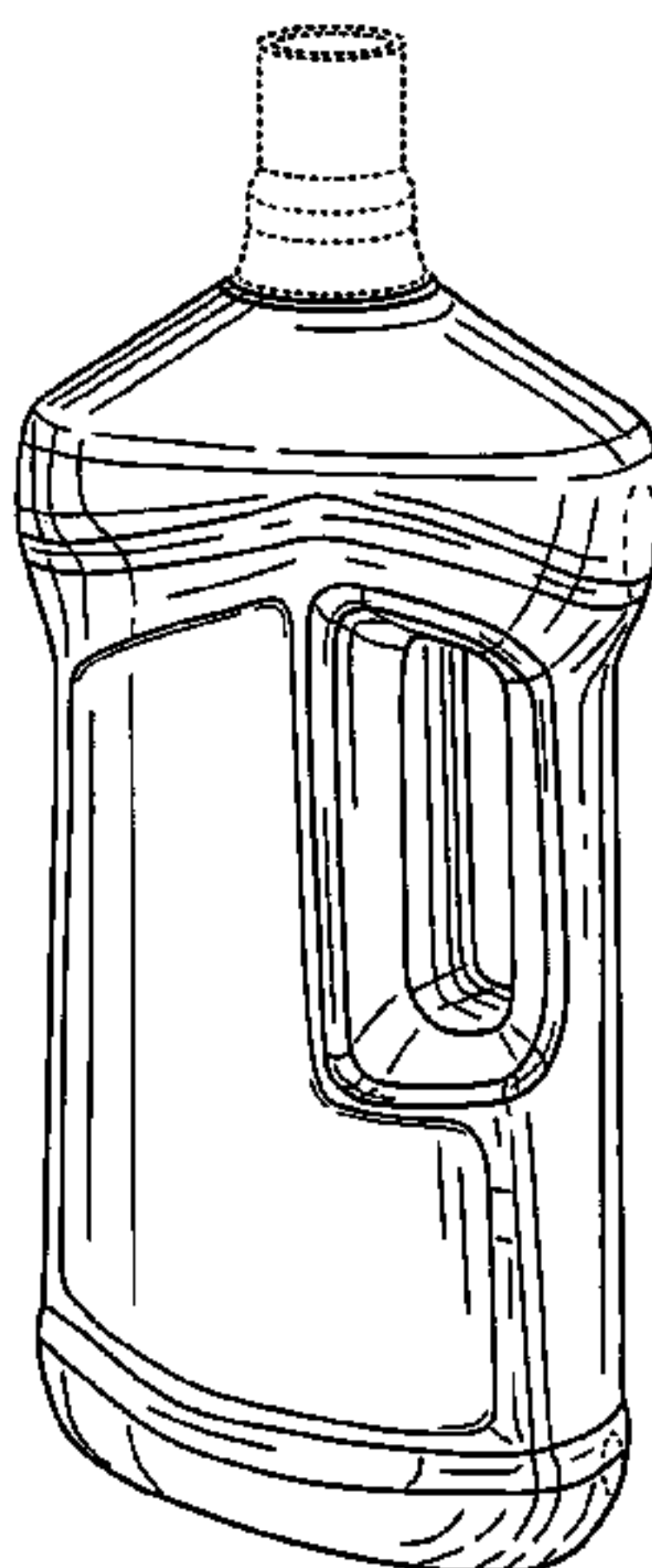
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the front, top, and right side of a bottle embodying our new design;
FIG. 2 is a front elevational view thereof;

FIG. 4 is a right side elevational view thereof;
FIG. 5 is a left side elevational view thereof;

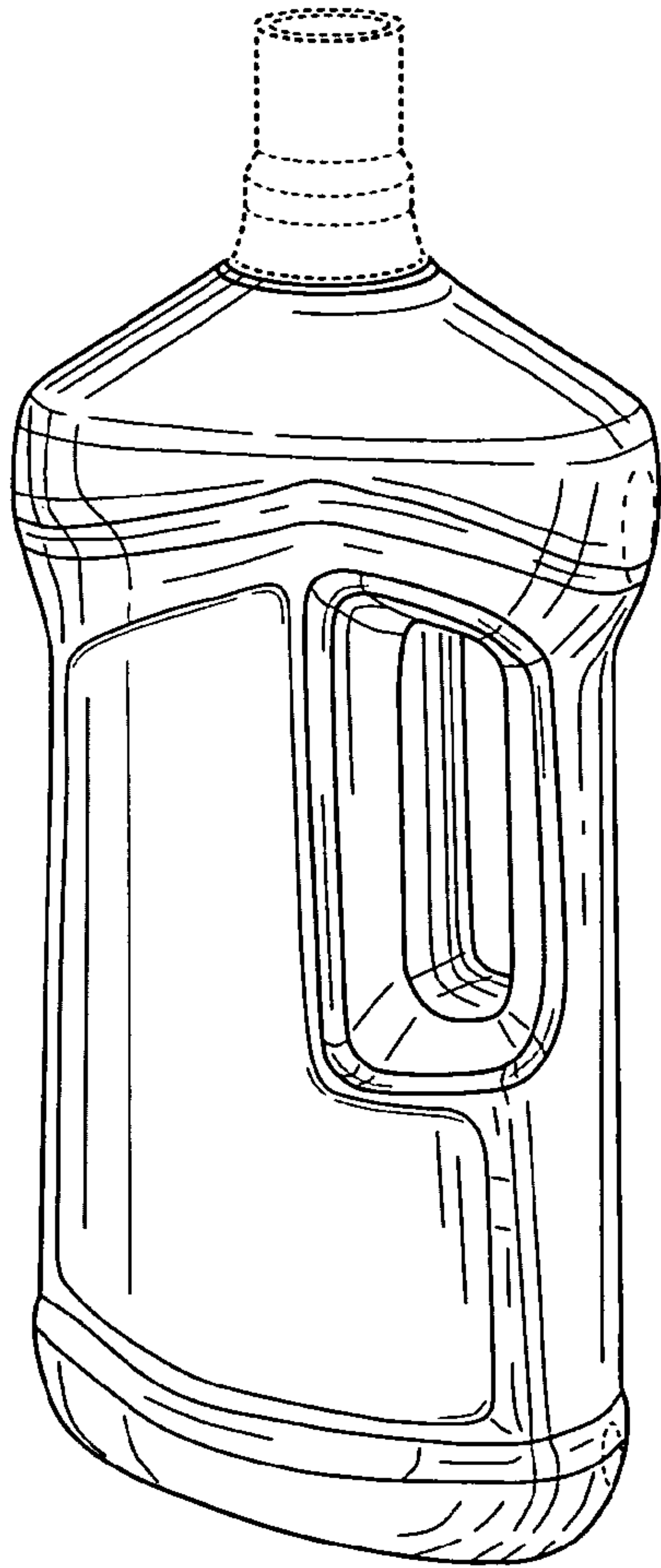

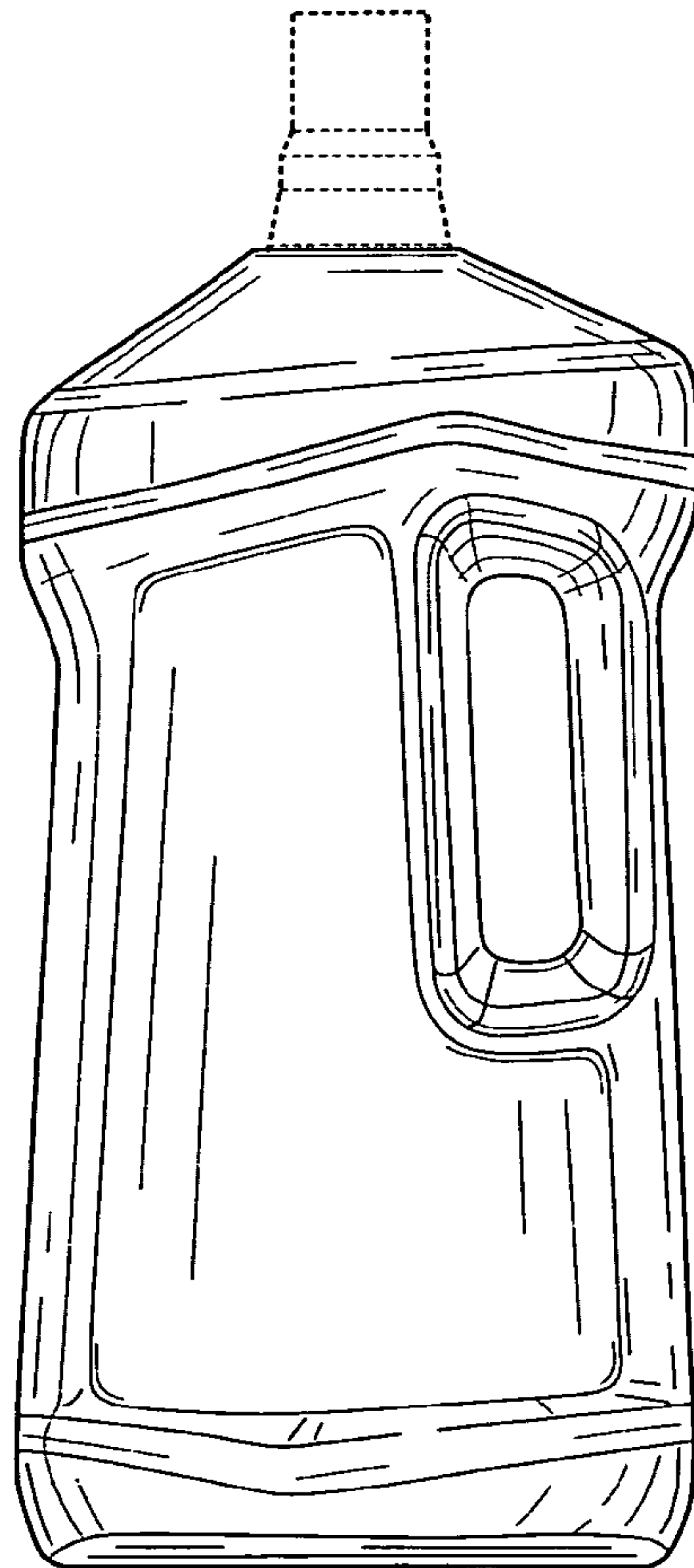

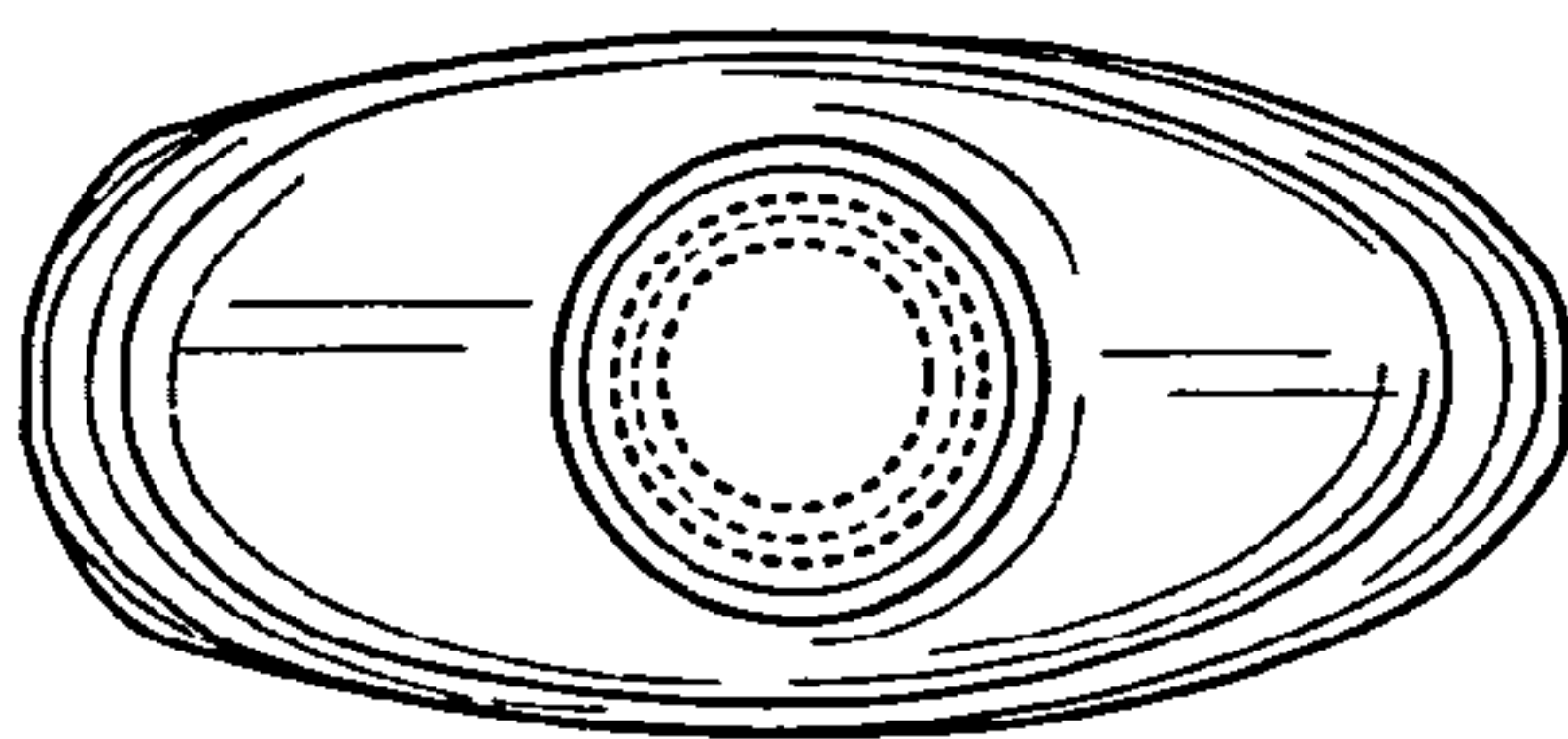

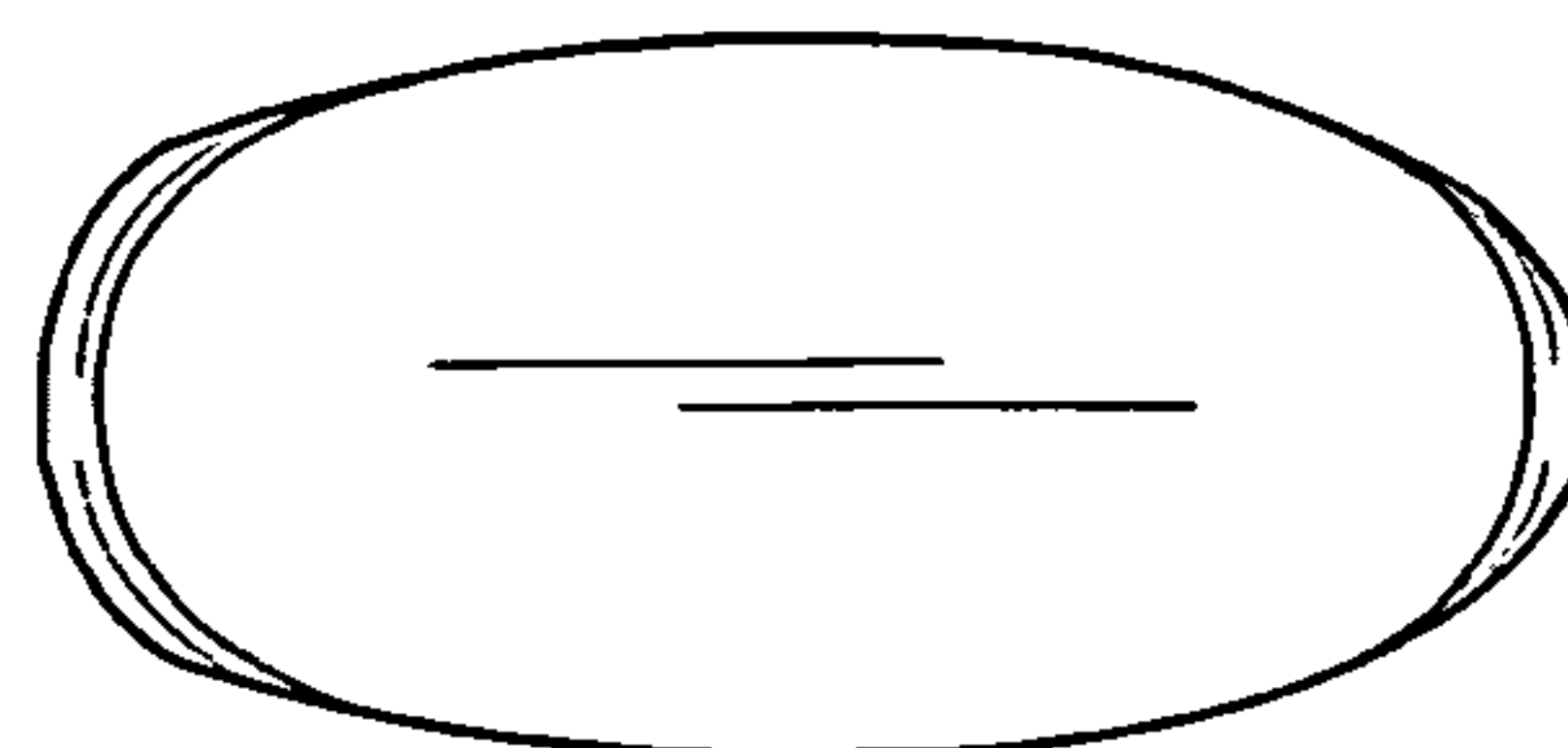

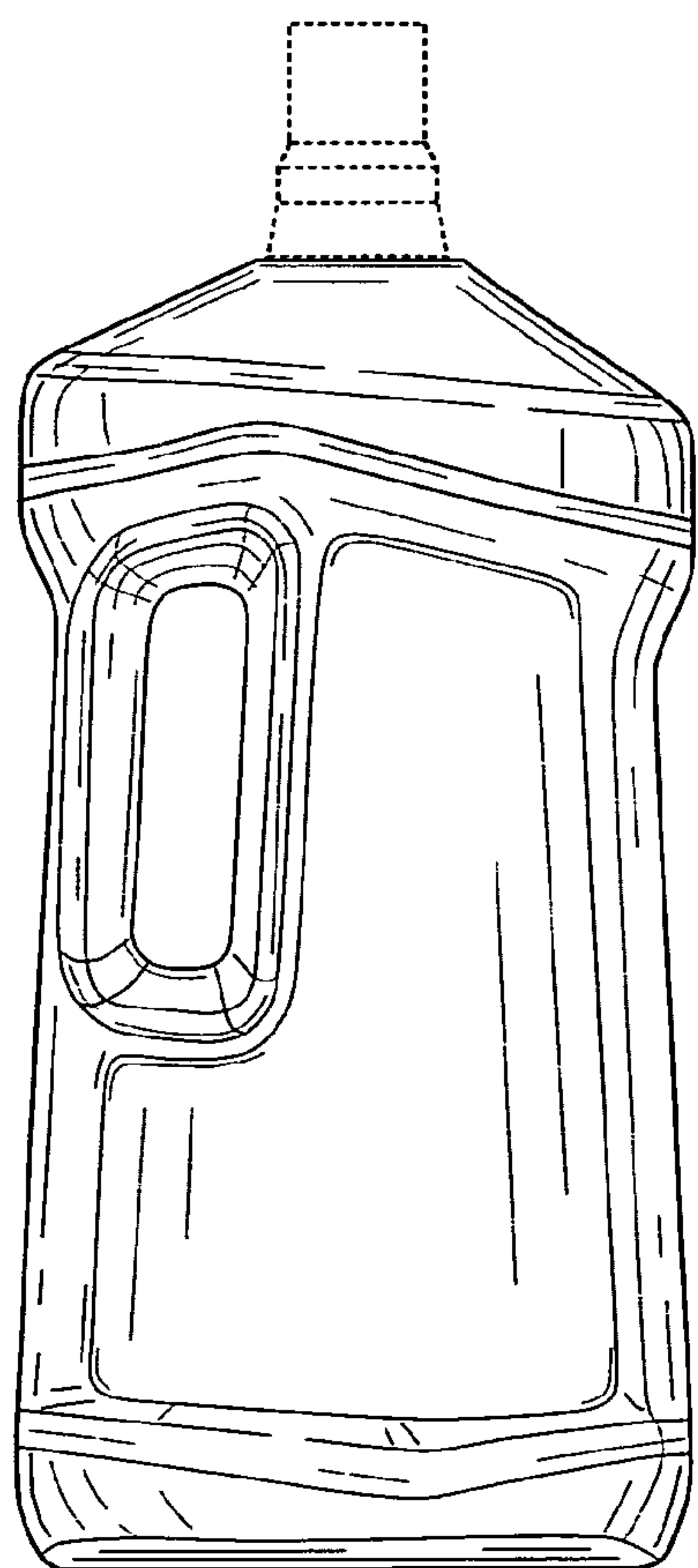

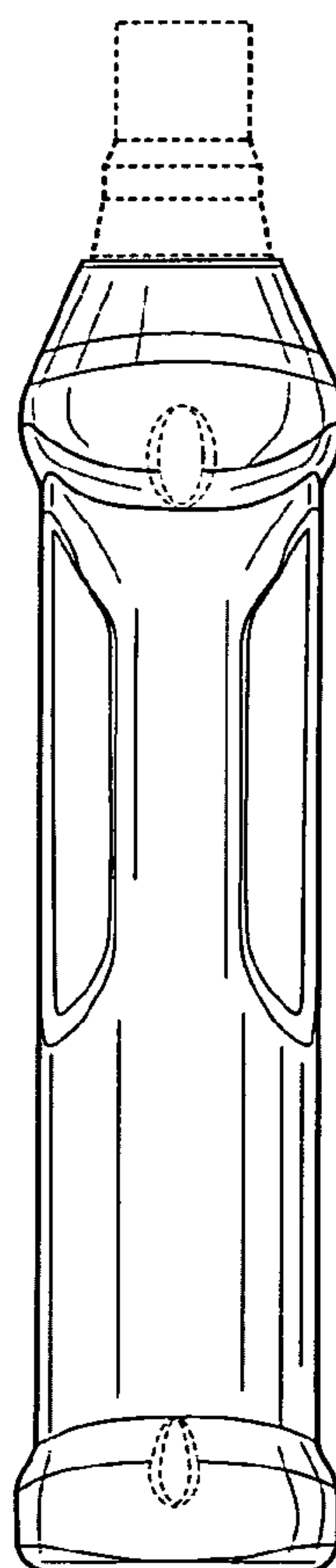

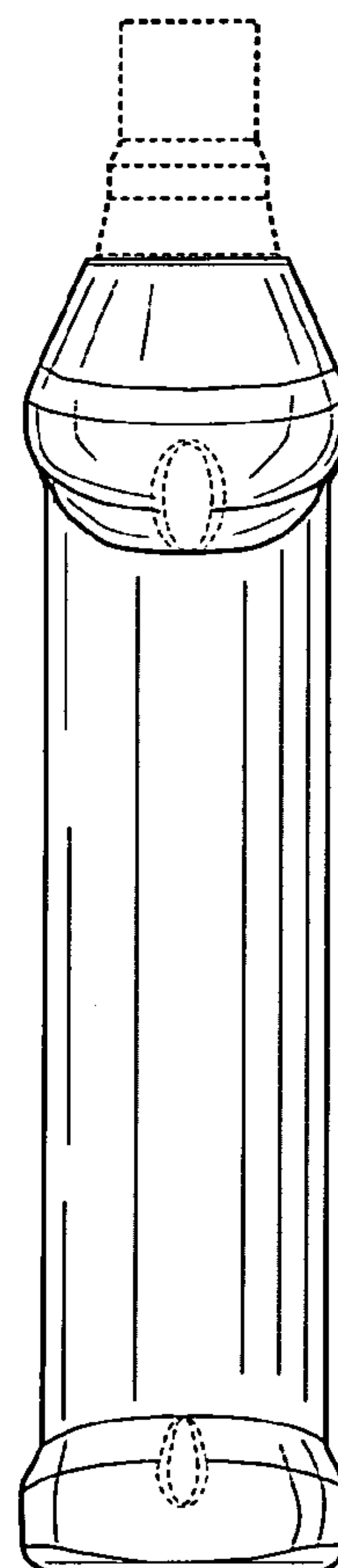
