FIG. 4 is a left view of FIG. 1;

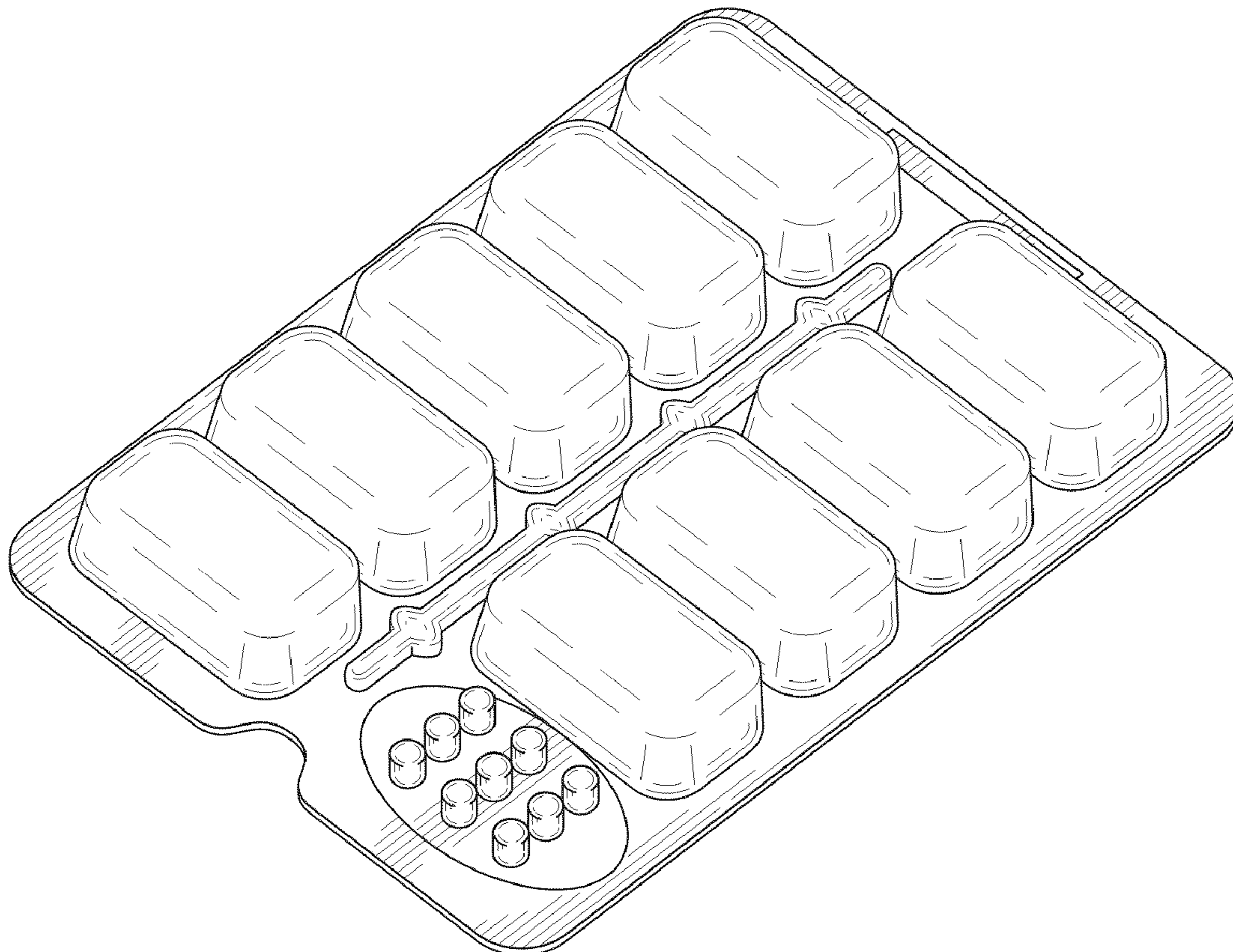
FIG. 5 is a right view of FIG. 1;

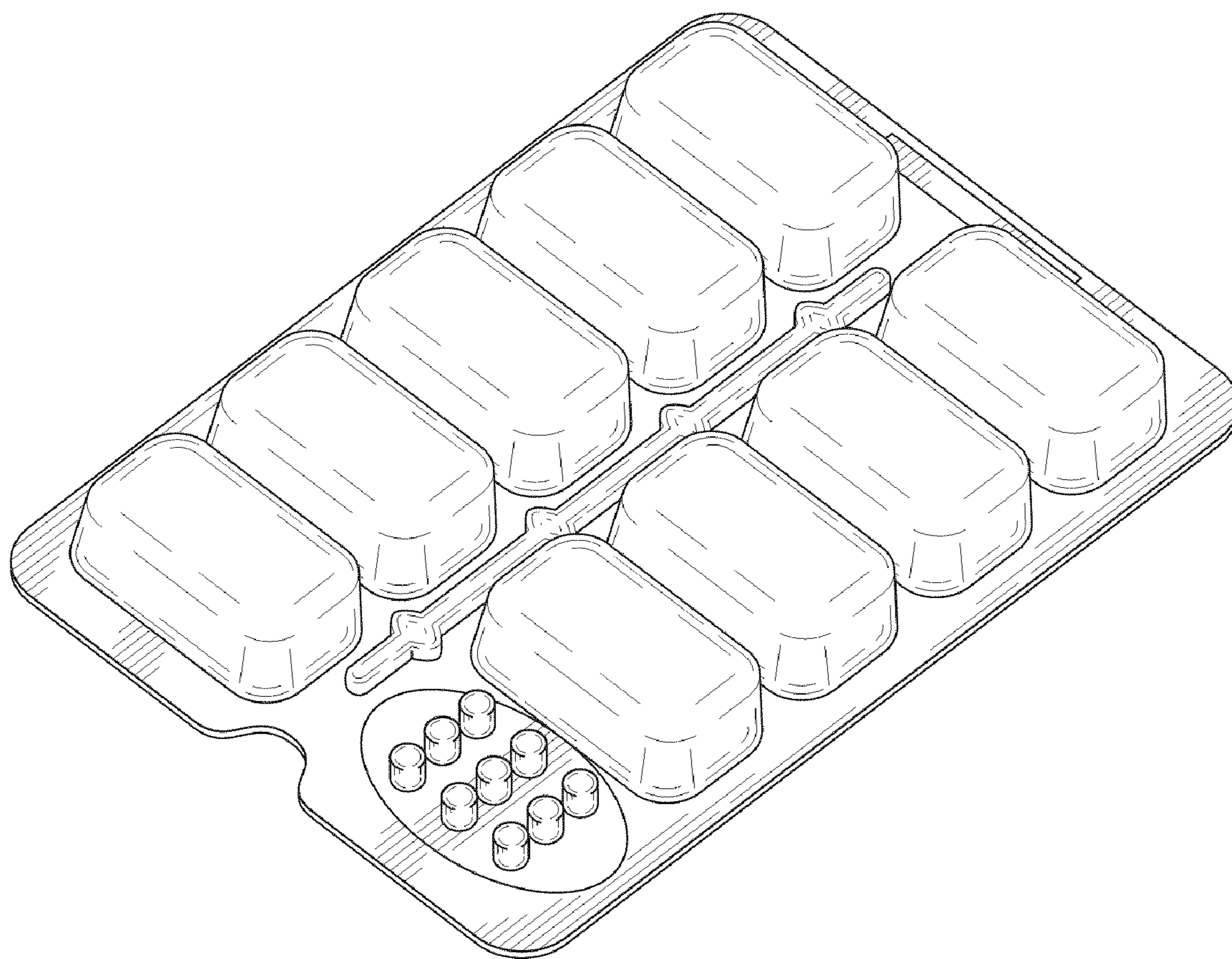
FIG. 6 is a rear view of FIG. 1; and,

FIG. 7 is a front view of FIG. 1.

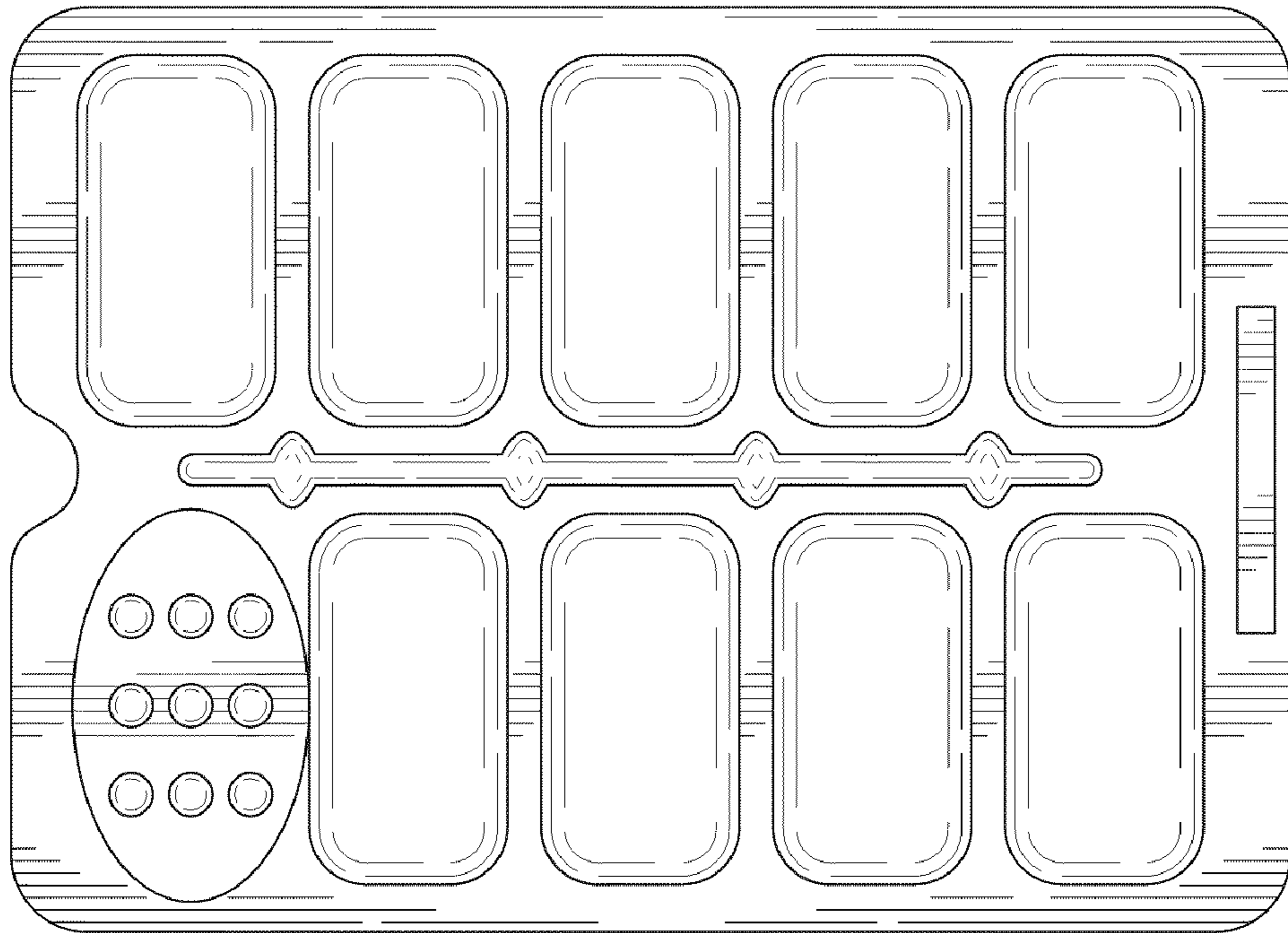
The broken line portion of FIG. 3 is included to show claimed perforations on the bottom surface of the blister card.

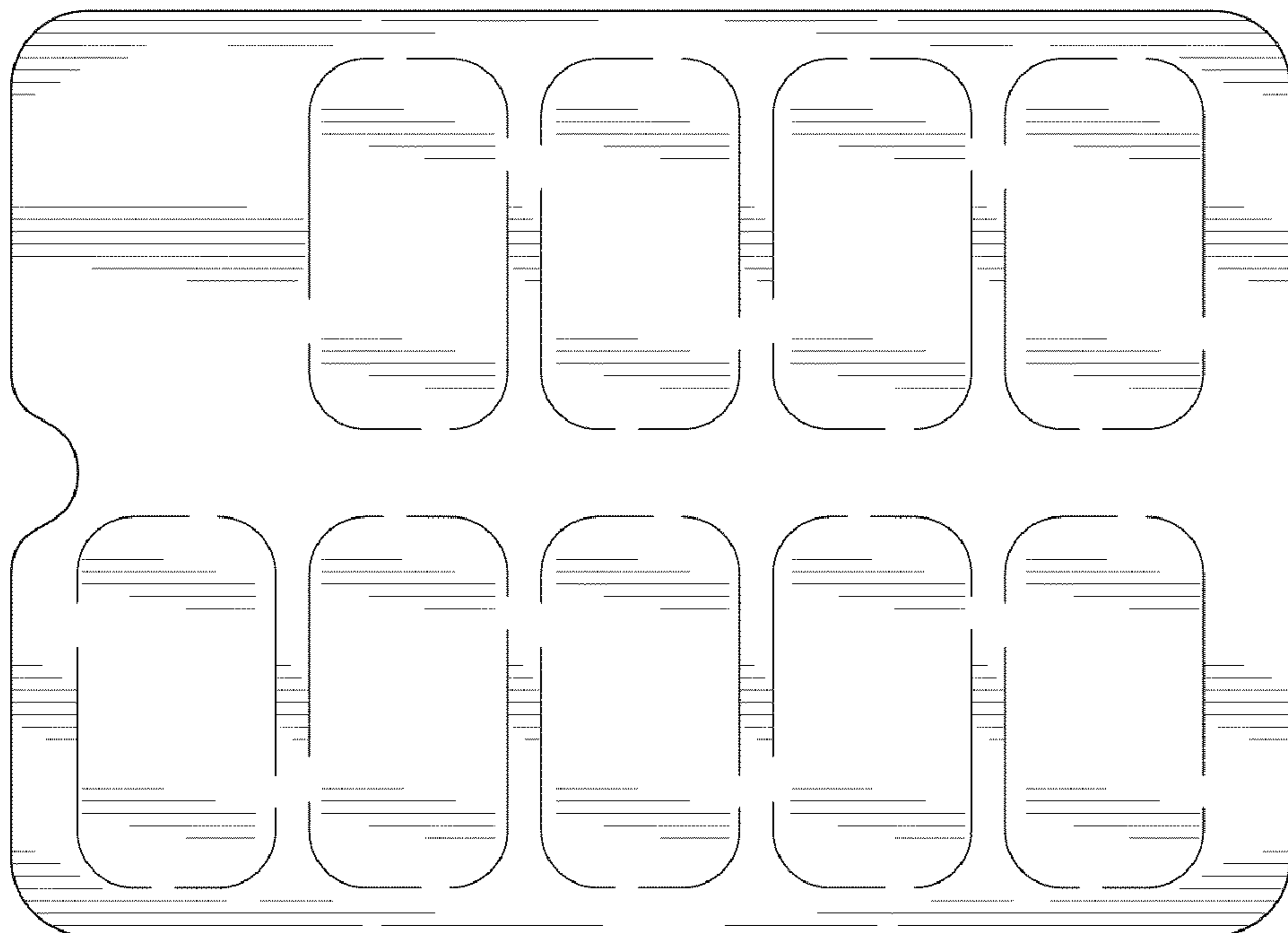




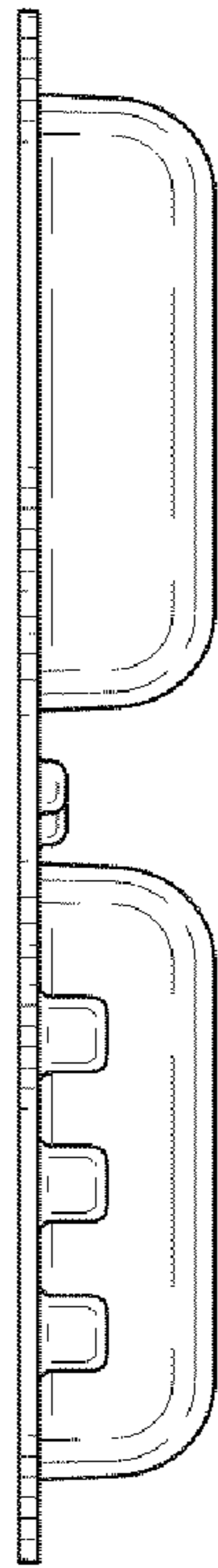

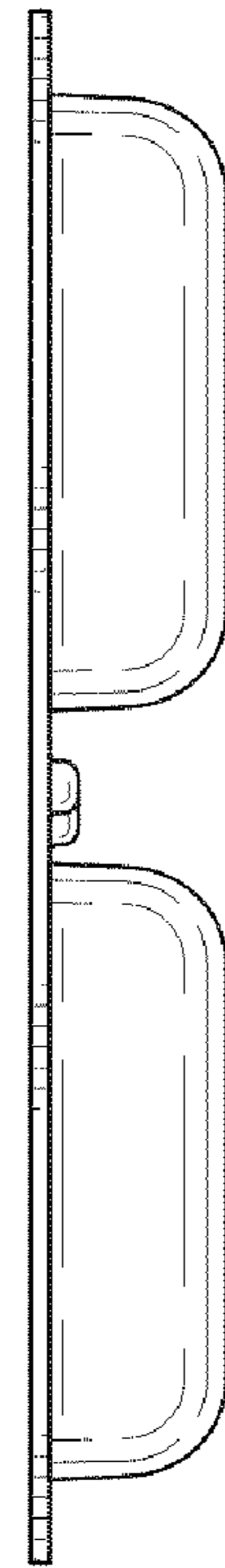

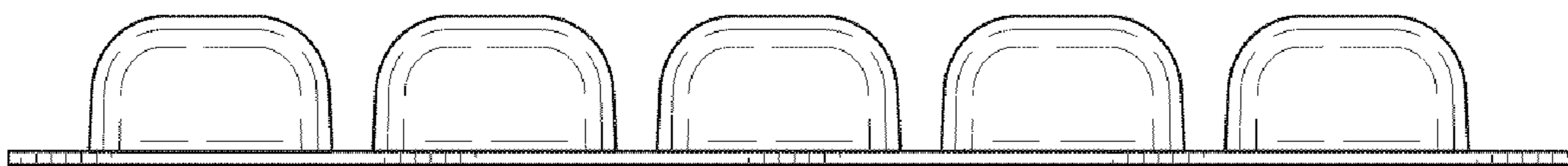

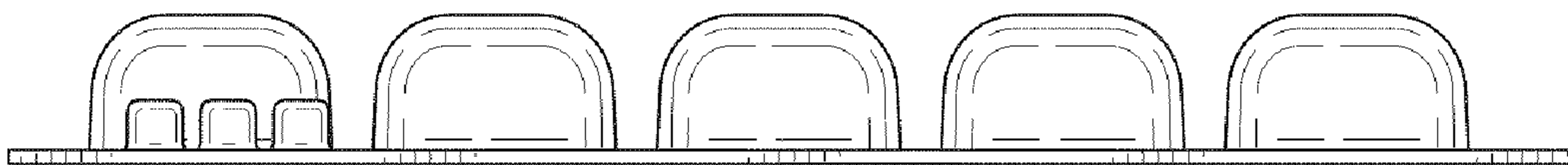
