The ornamental design for a display screen with user interface, as shown and described.

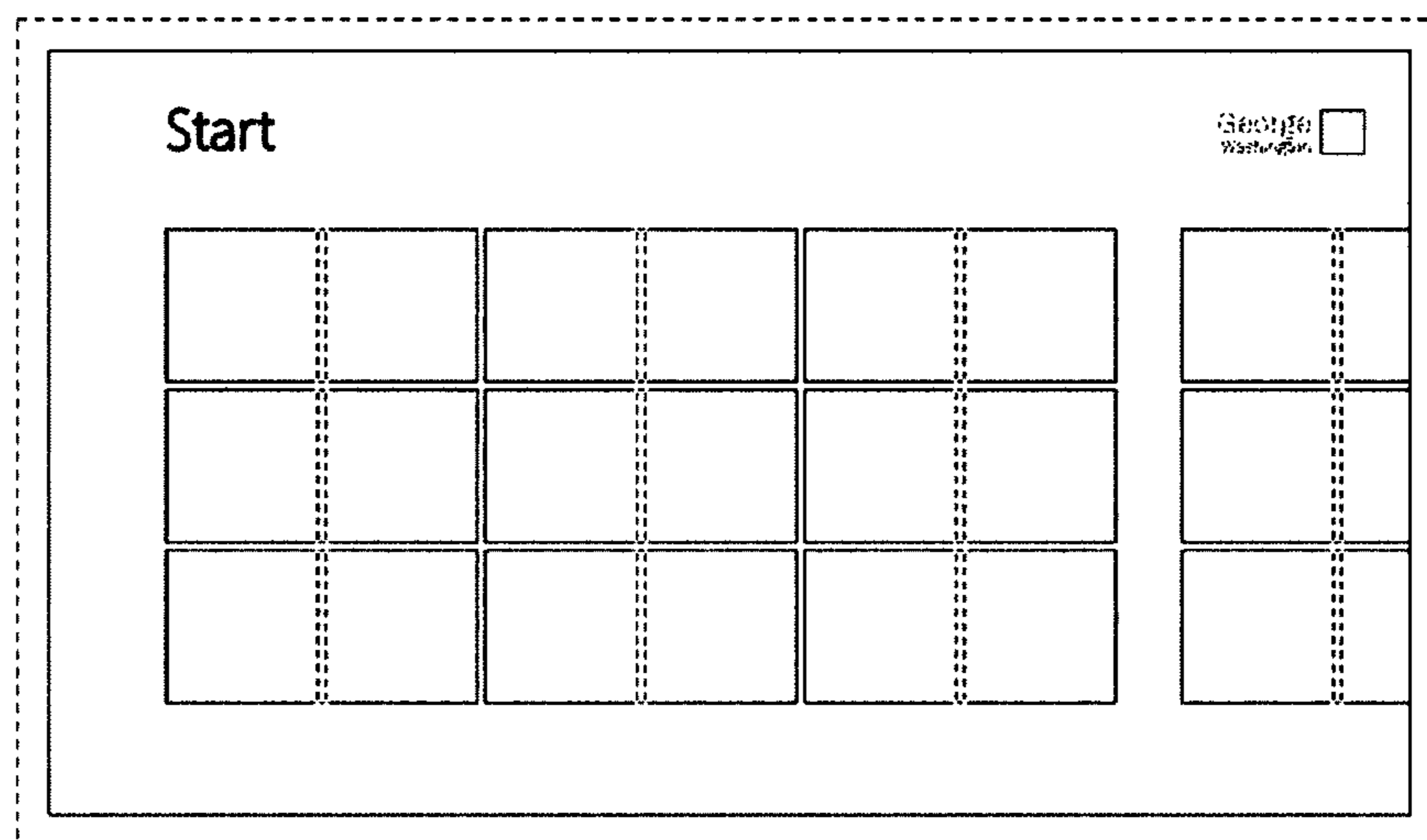
DESCRIPTION

The twenty-four small horizontal dashes located between collinear horizontal segments represent disclaimed line segments that form no part of the claimed design.
