FIG. 6 is an enlarged bottom-view illustration of the cloud-shaped display placard.

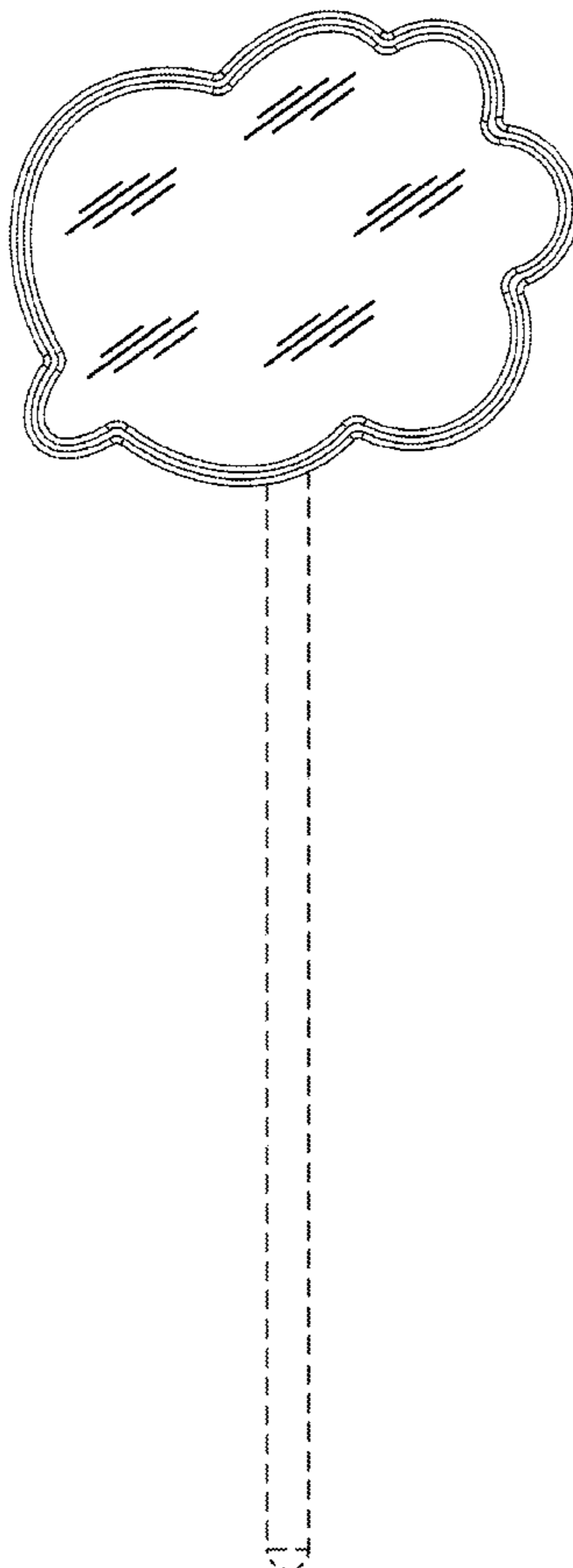

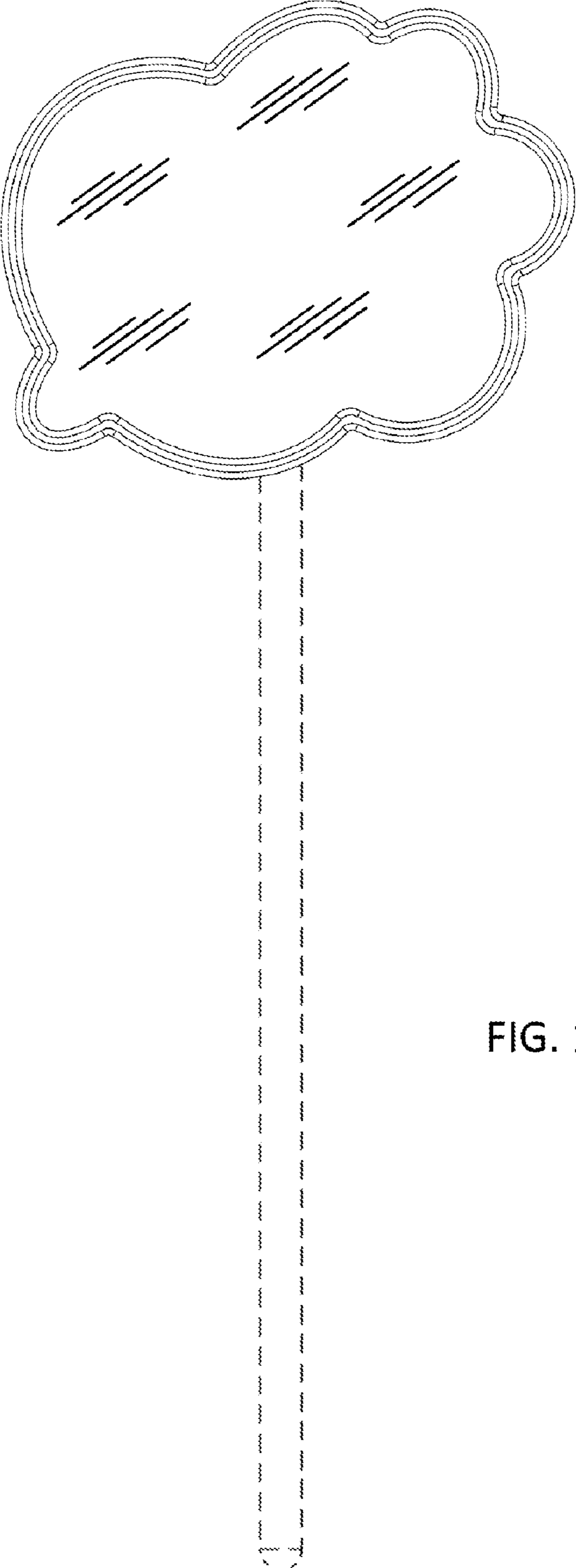

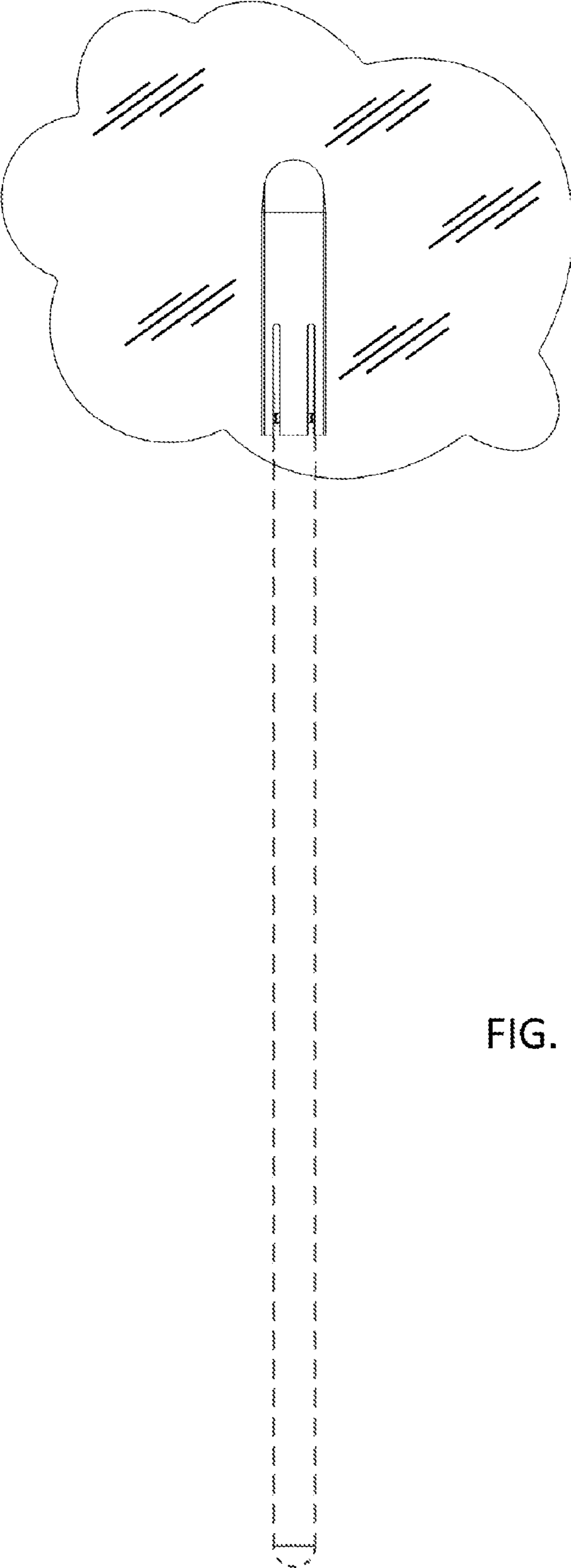

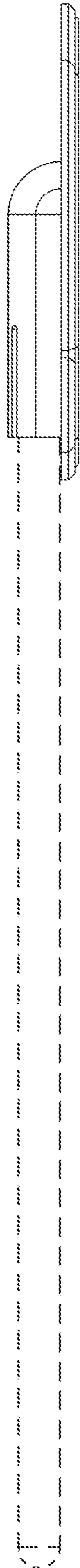

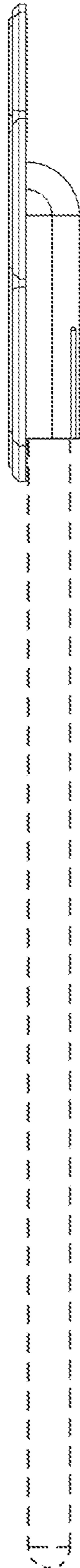

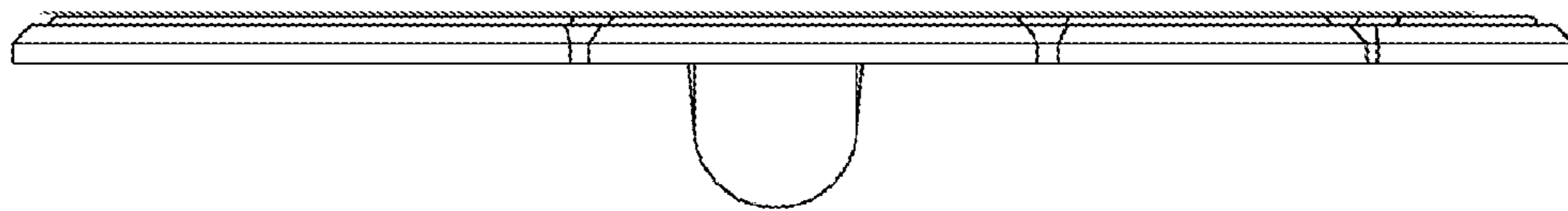

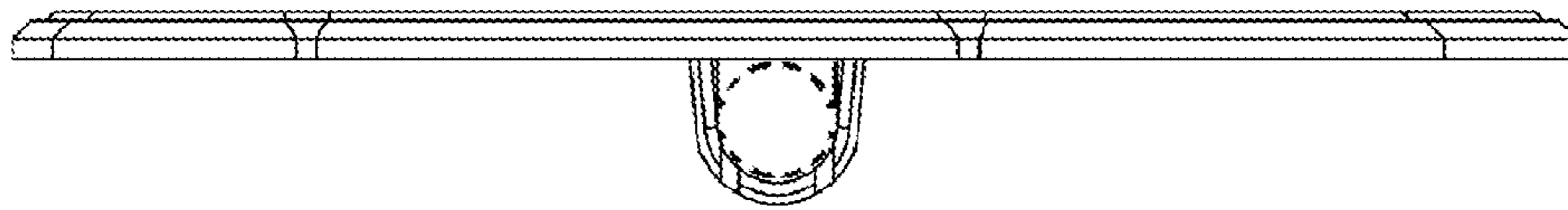
