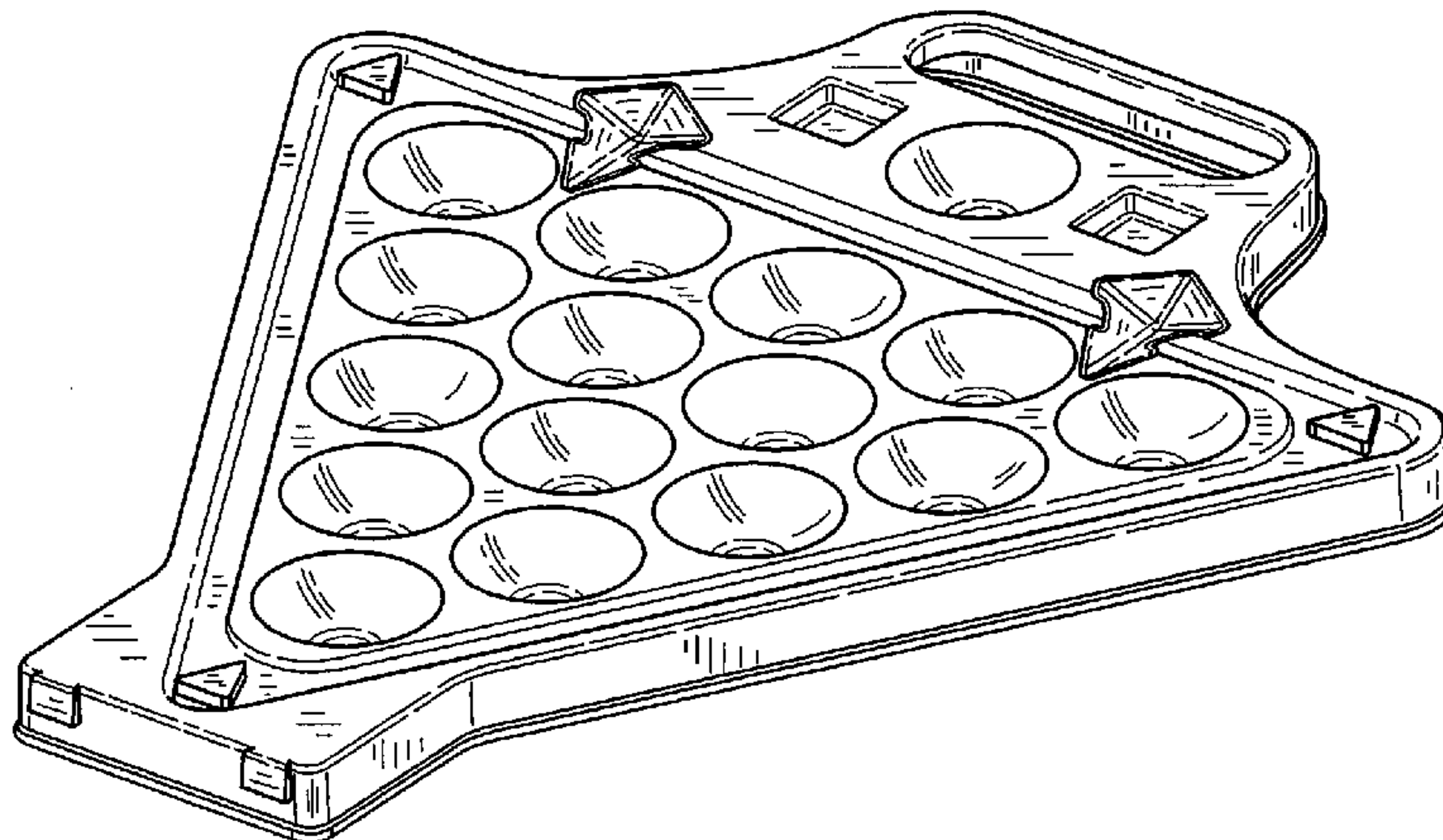
(57) **CLAIM**

The ornamental design for a billiards tray, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of our design for a billiards tray;

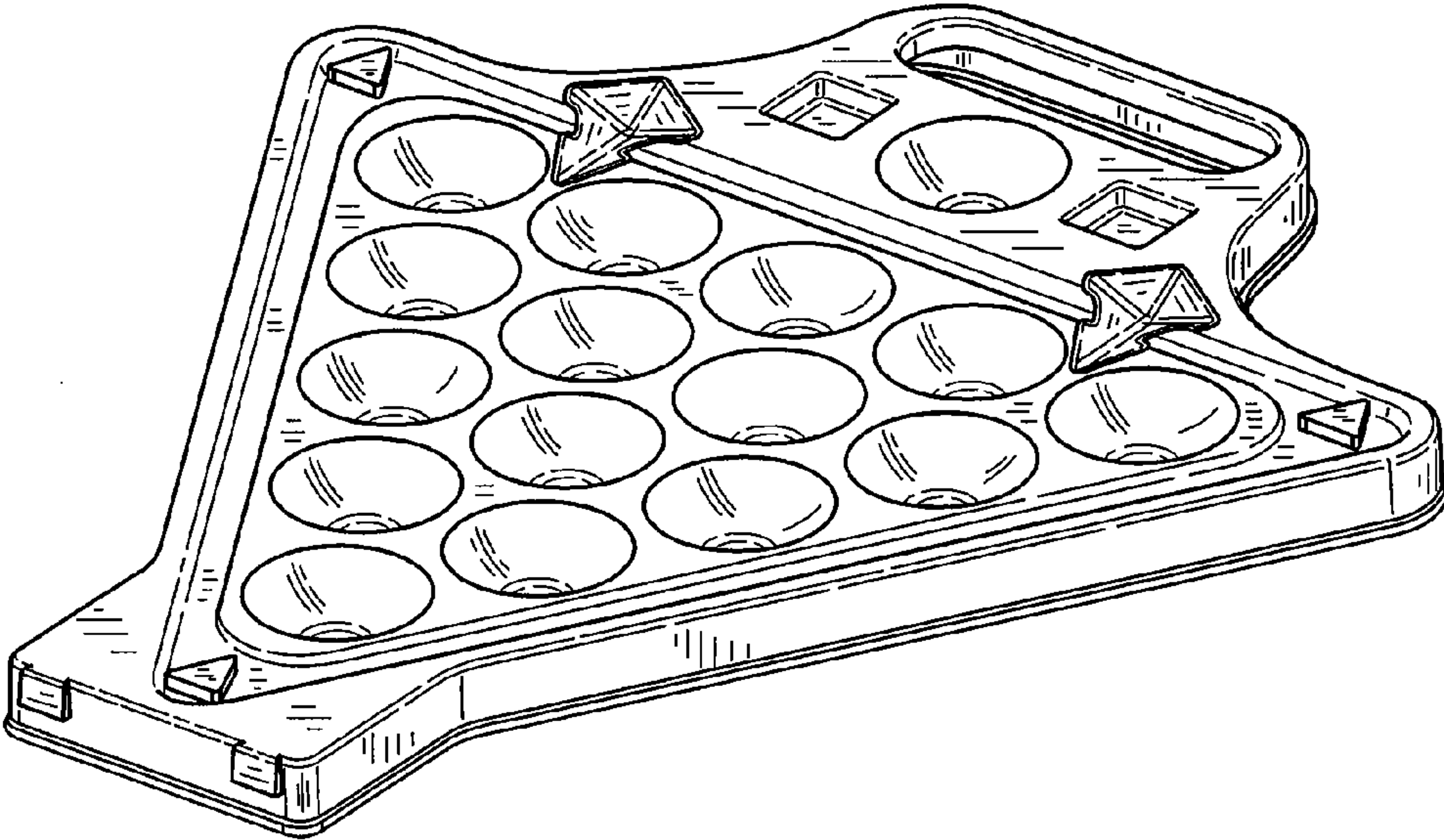

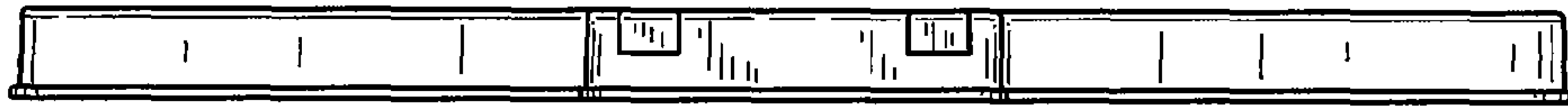

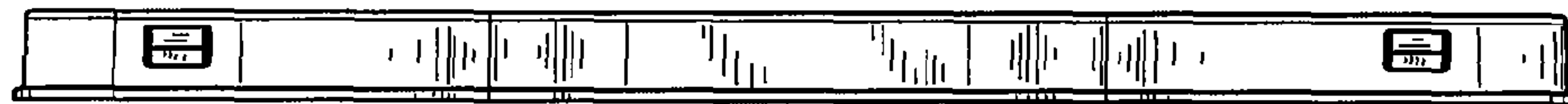

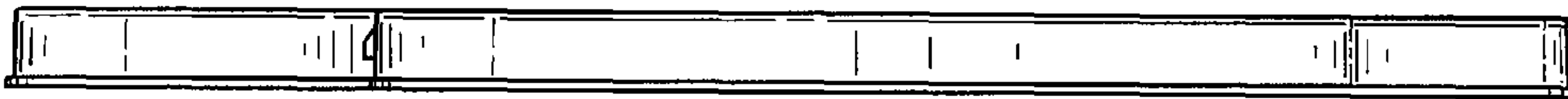

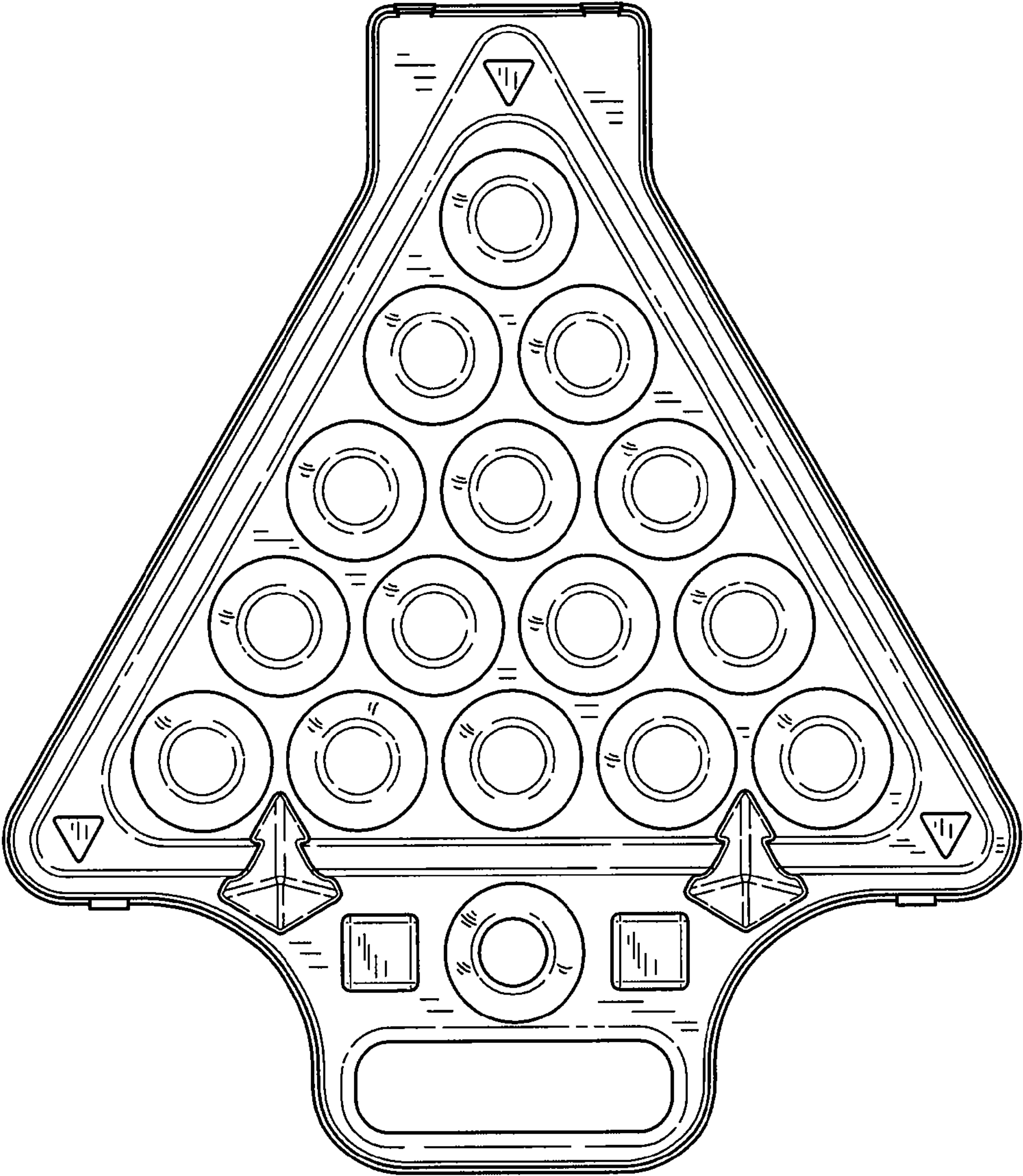

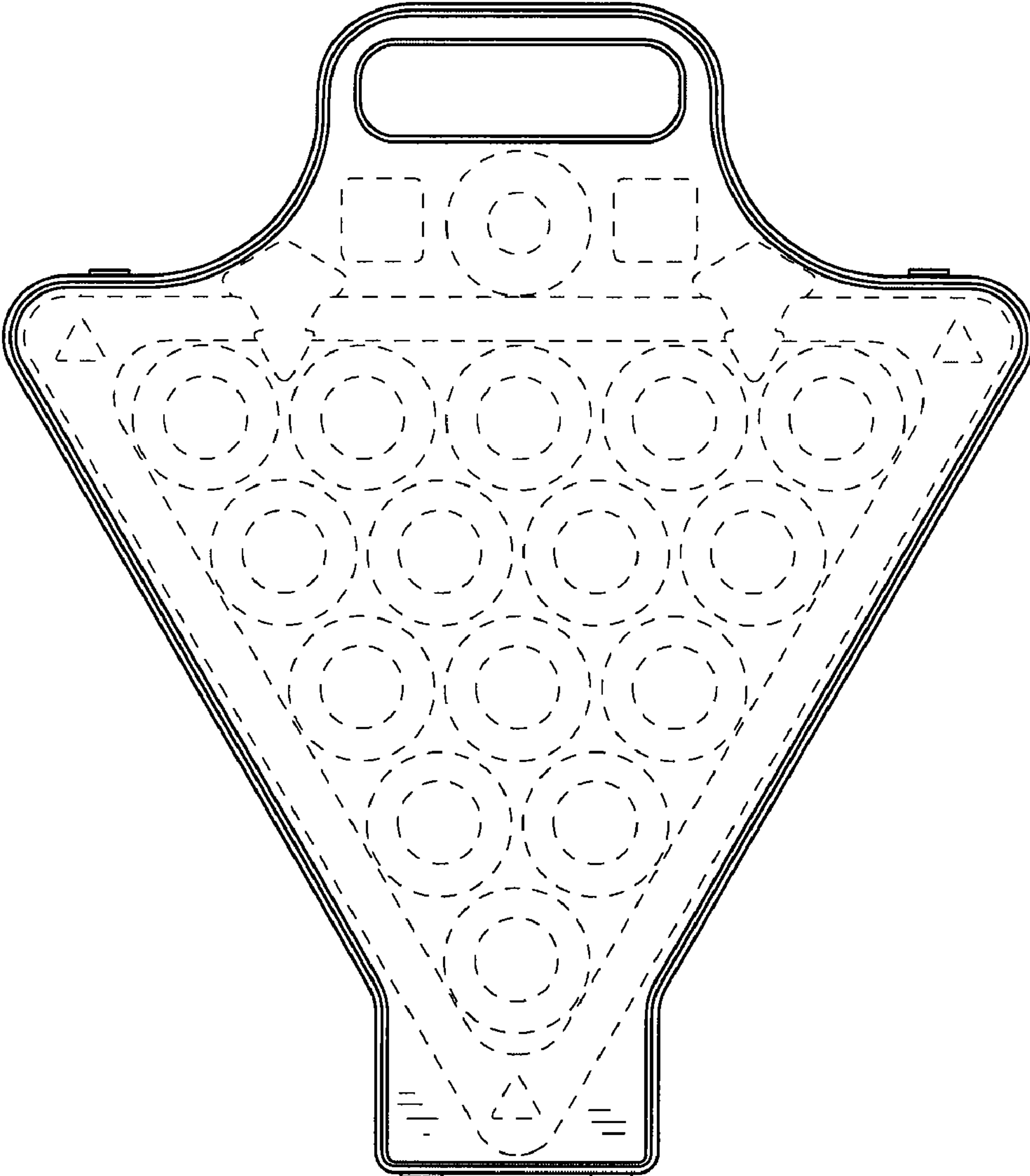

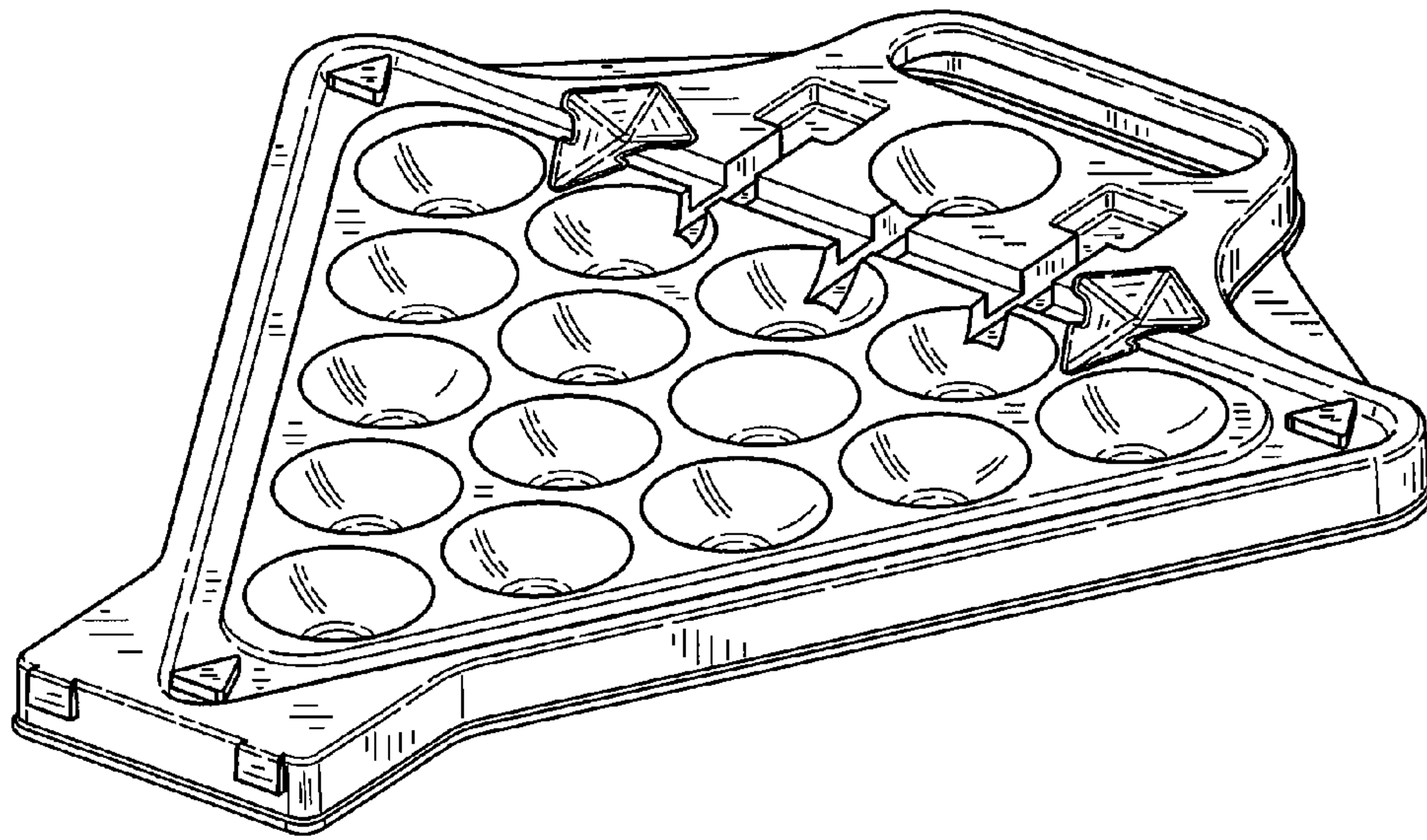

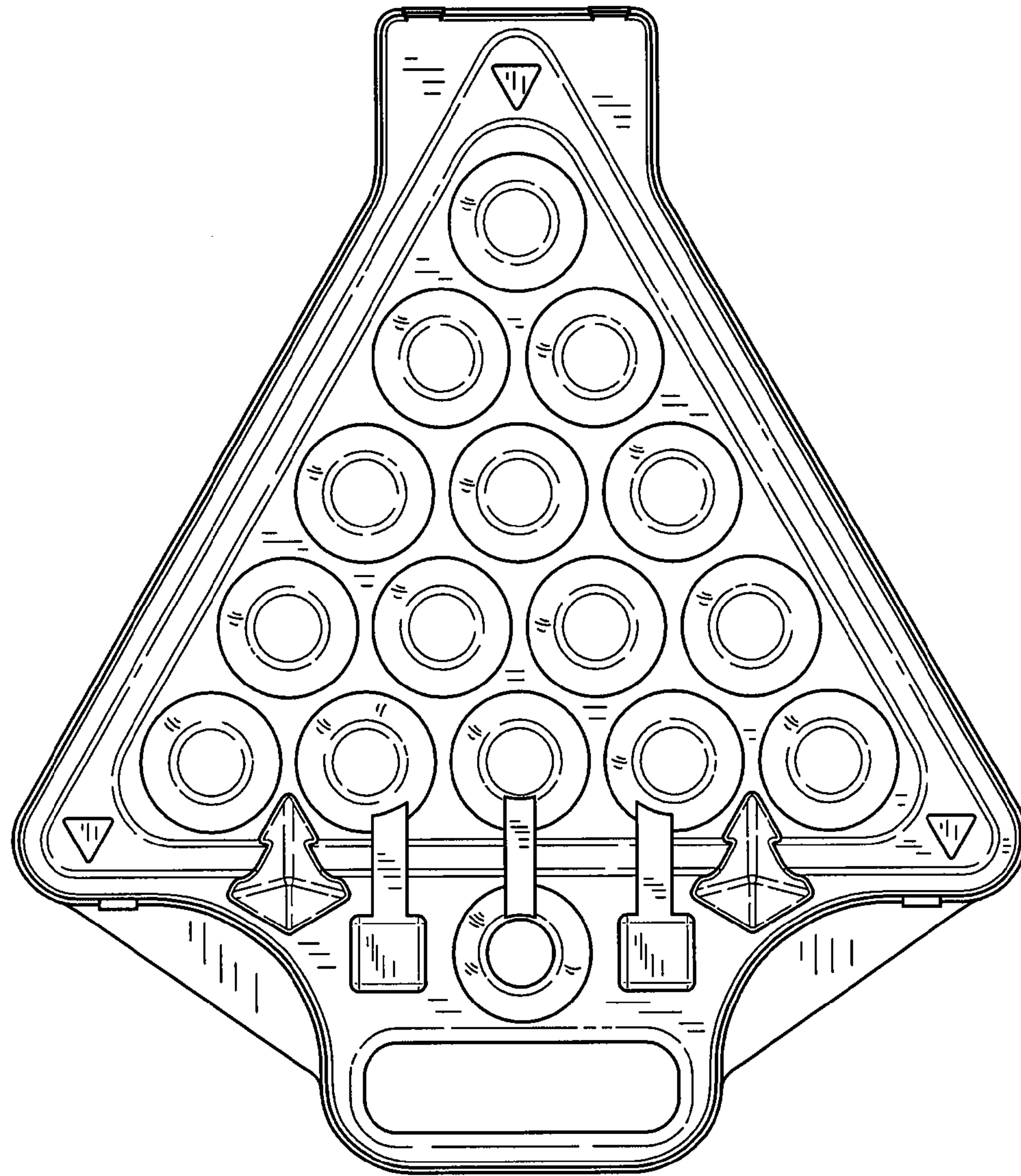

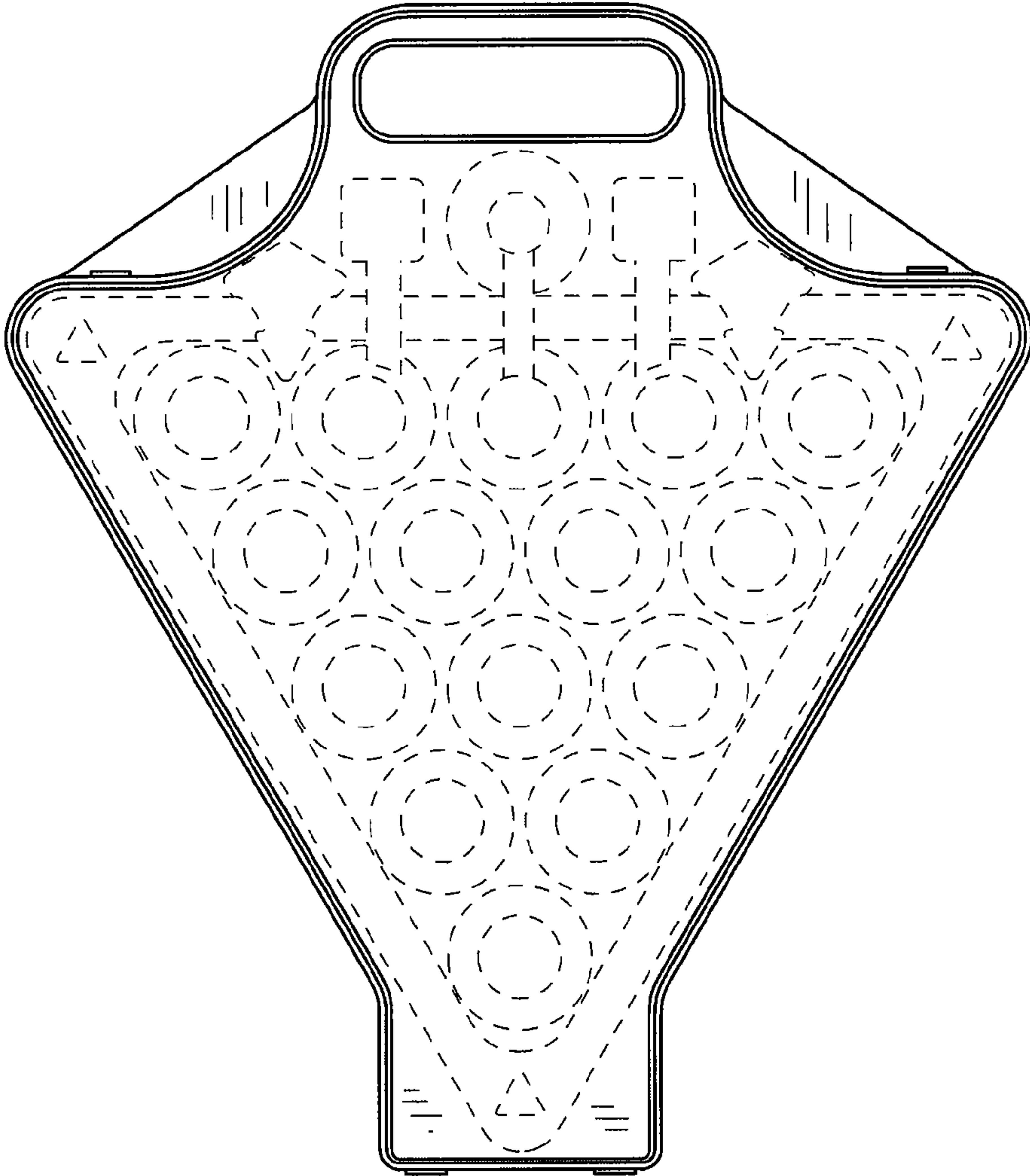
