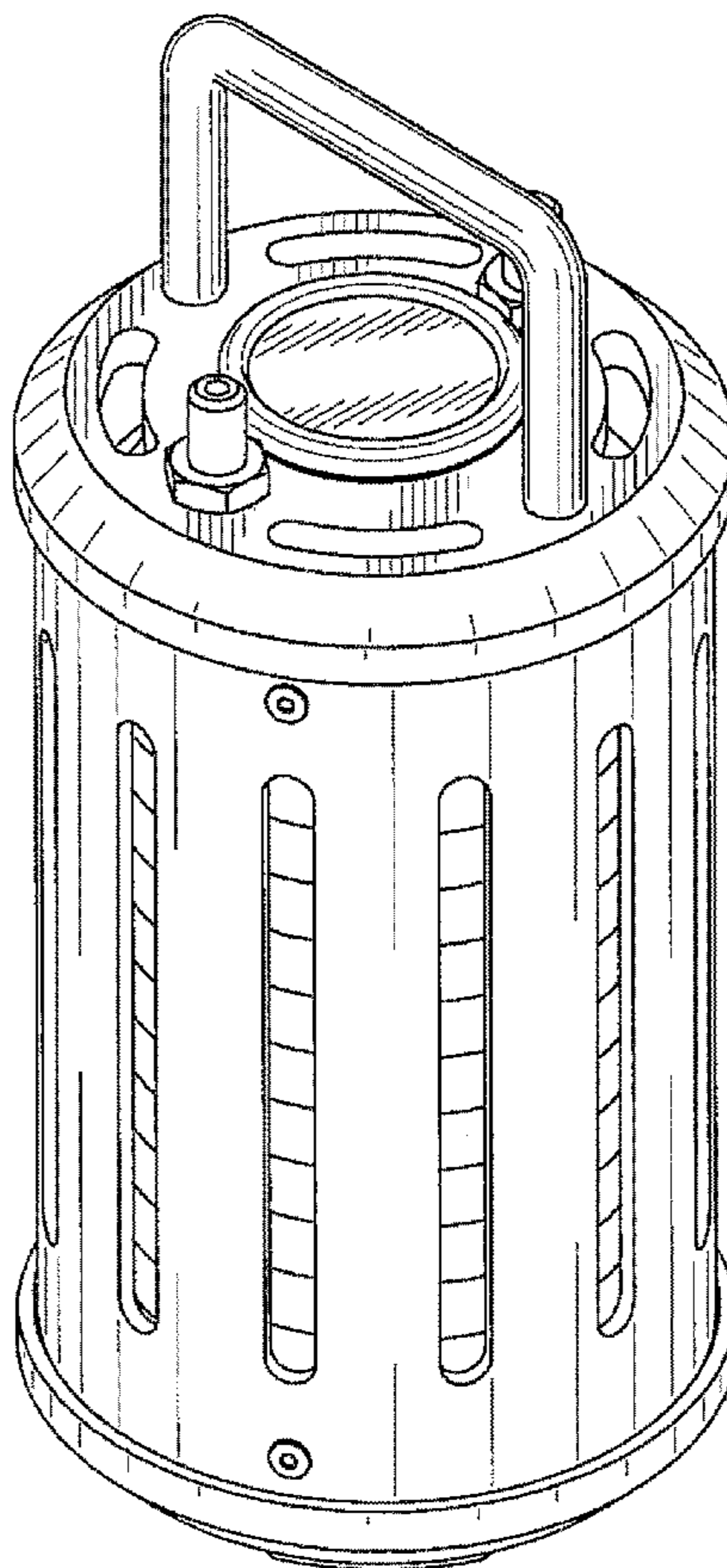
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the portable submersible
condenser/heat exchanger, showing the new design;
FIG. 2 is a side elevation view of the portable submersible
condenser/heat exchanger;
FIG. 3 is a top elevation view of the portable submersible
condenser/heat exchanger;
FIG. 4 is a bottom elevation view of the portable submersible
condenser/heat exchanger; and,

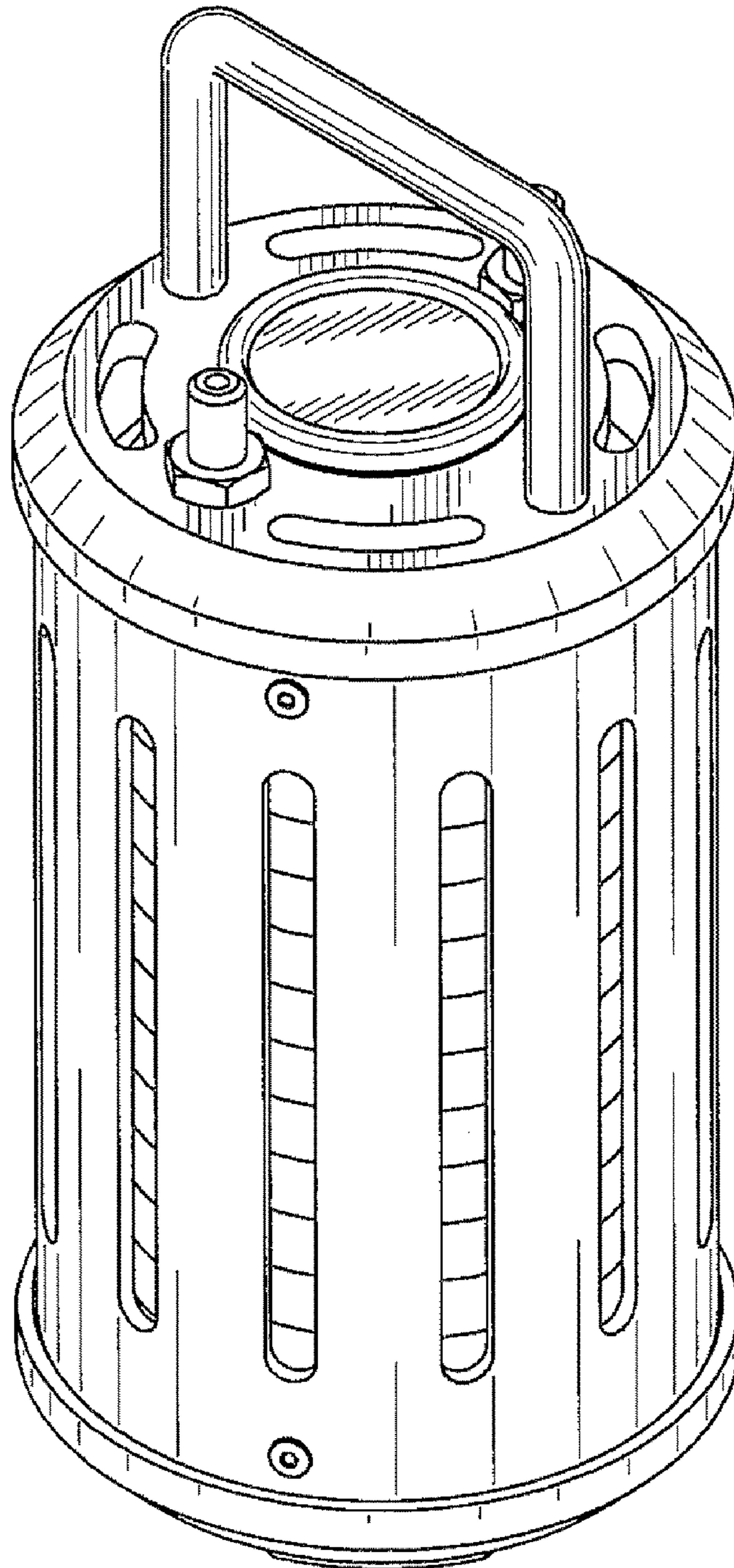

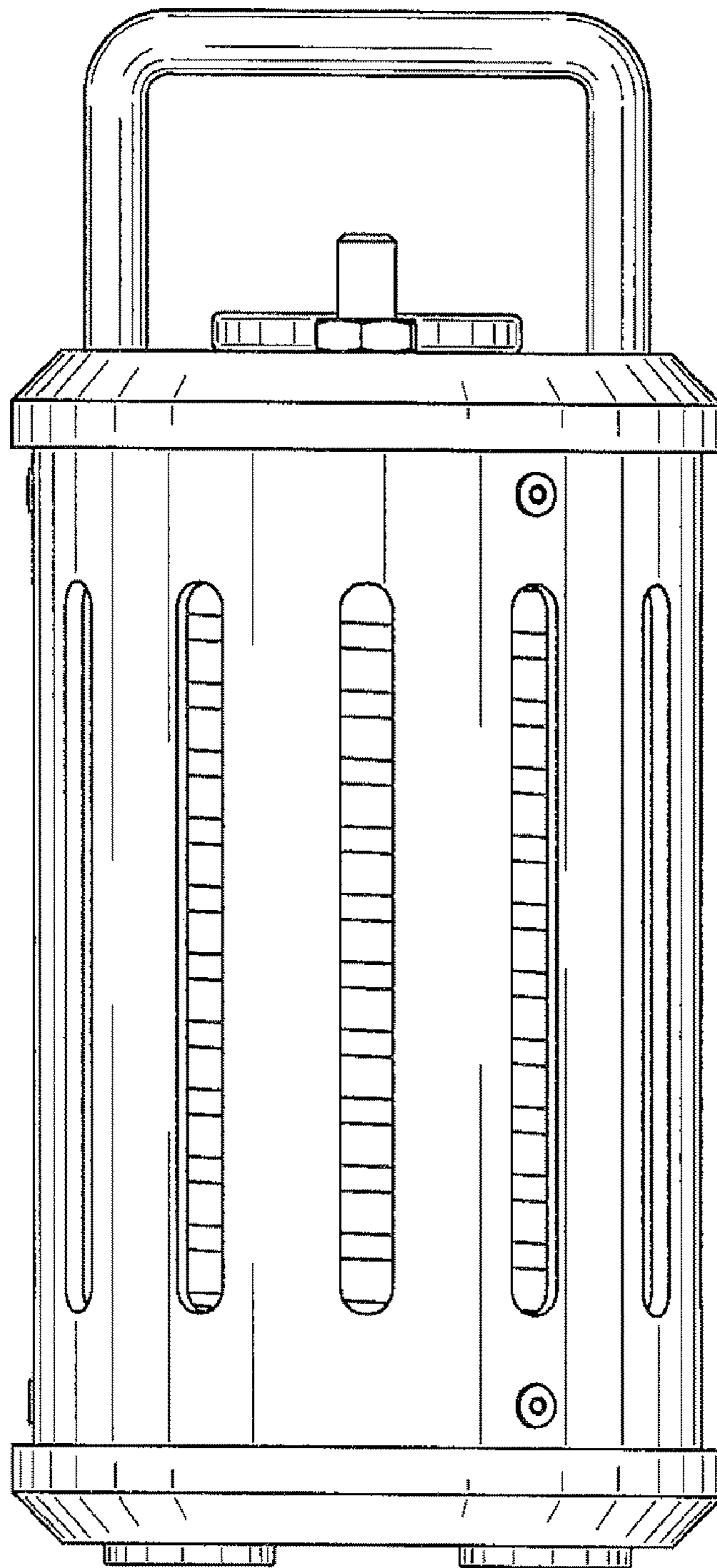

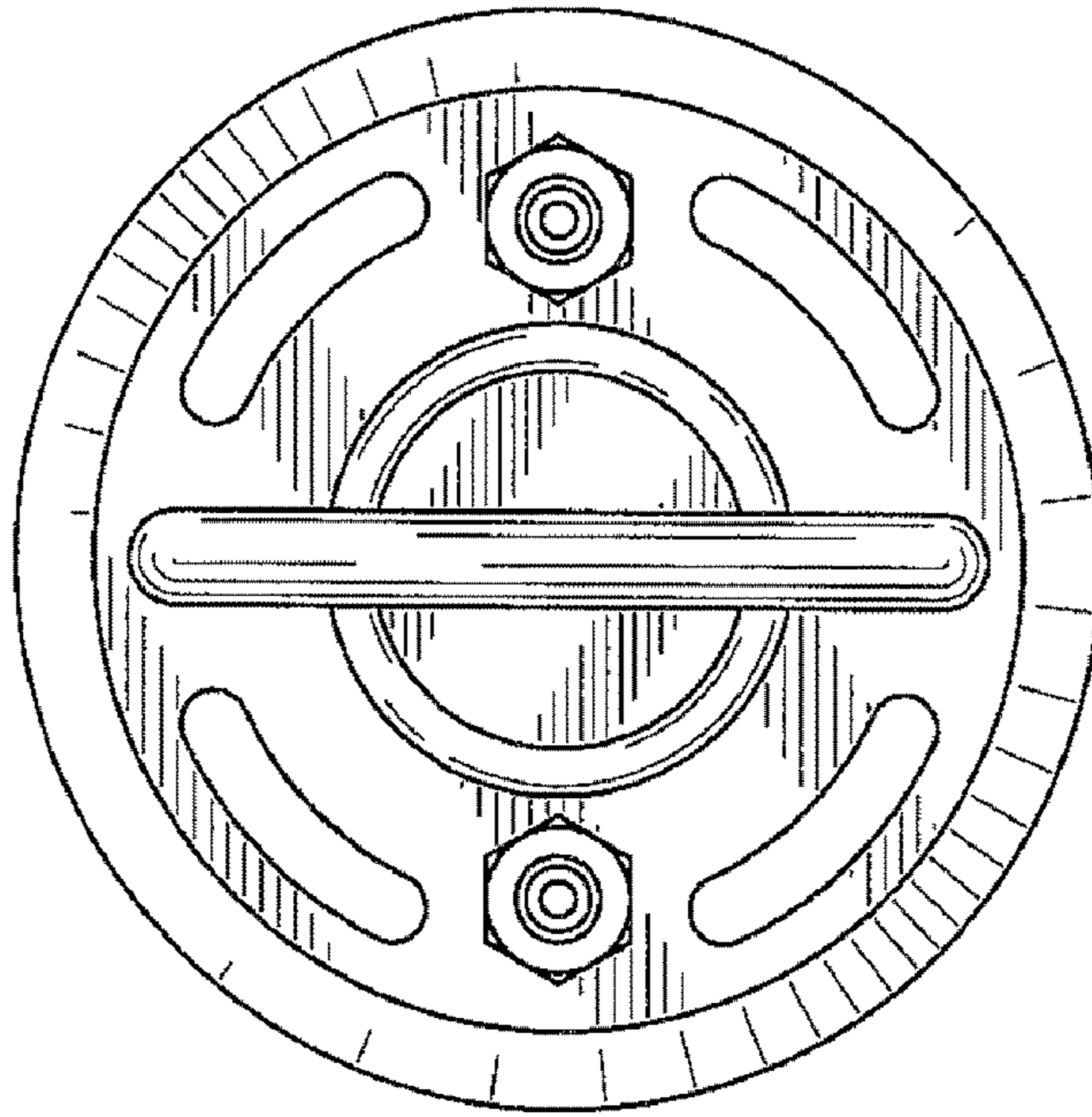

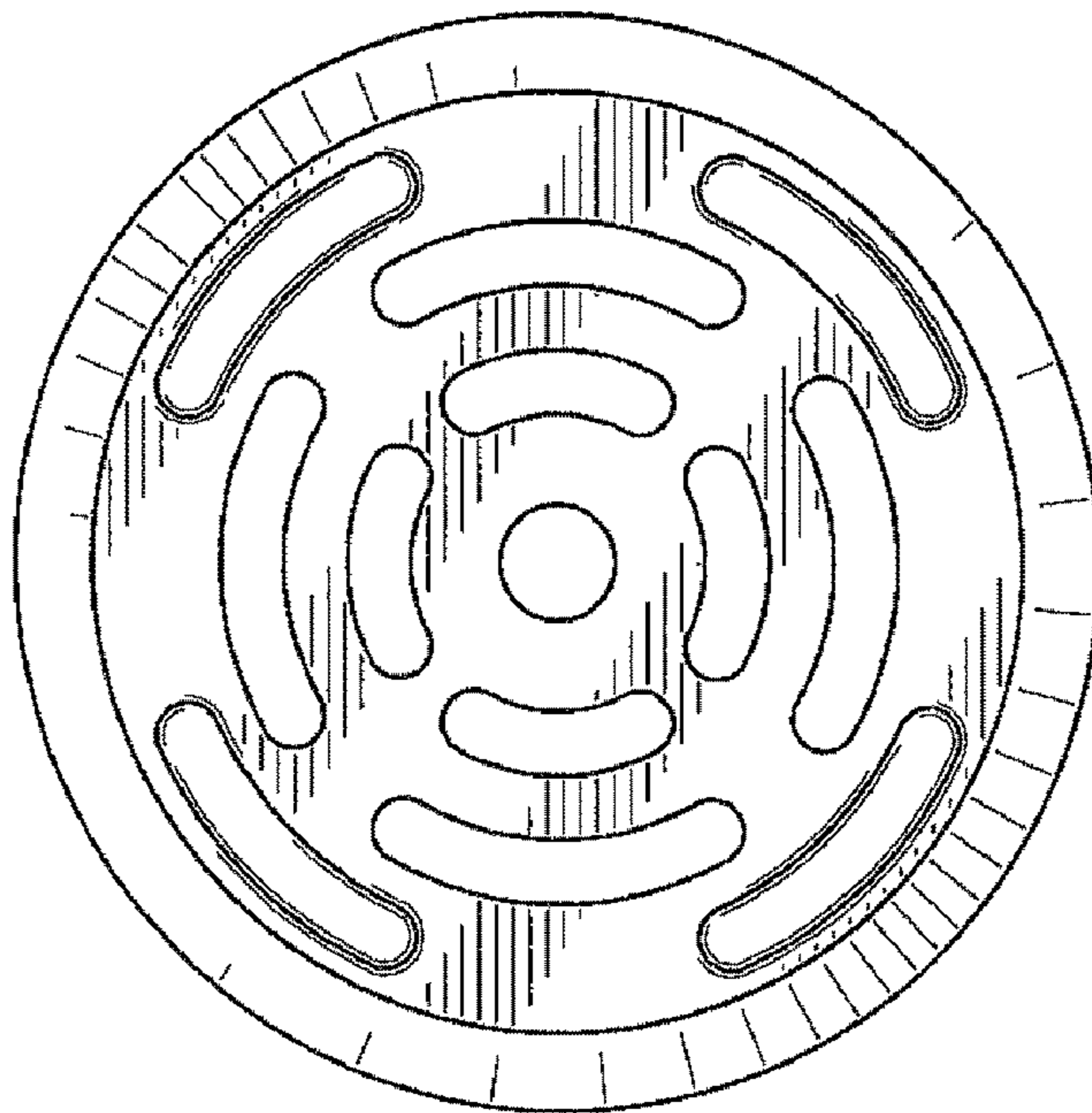

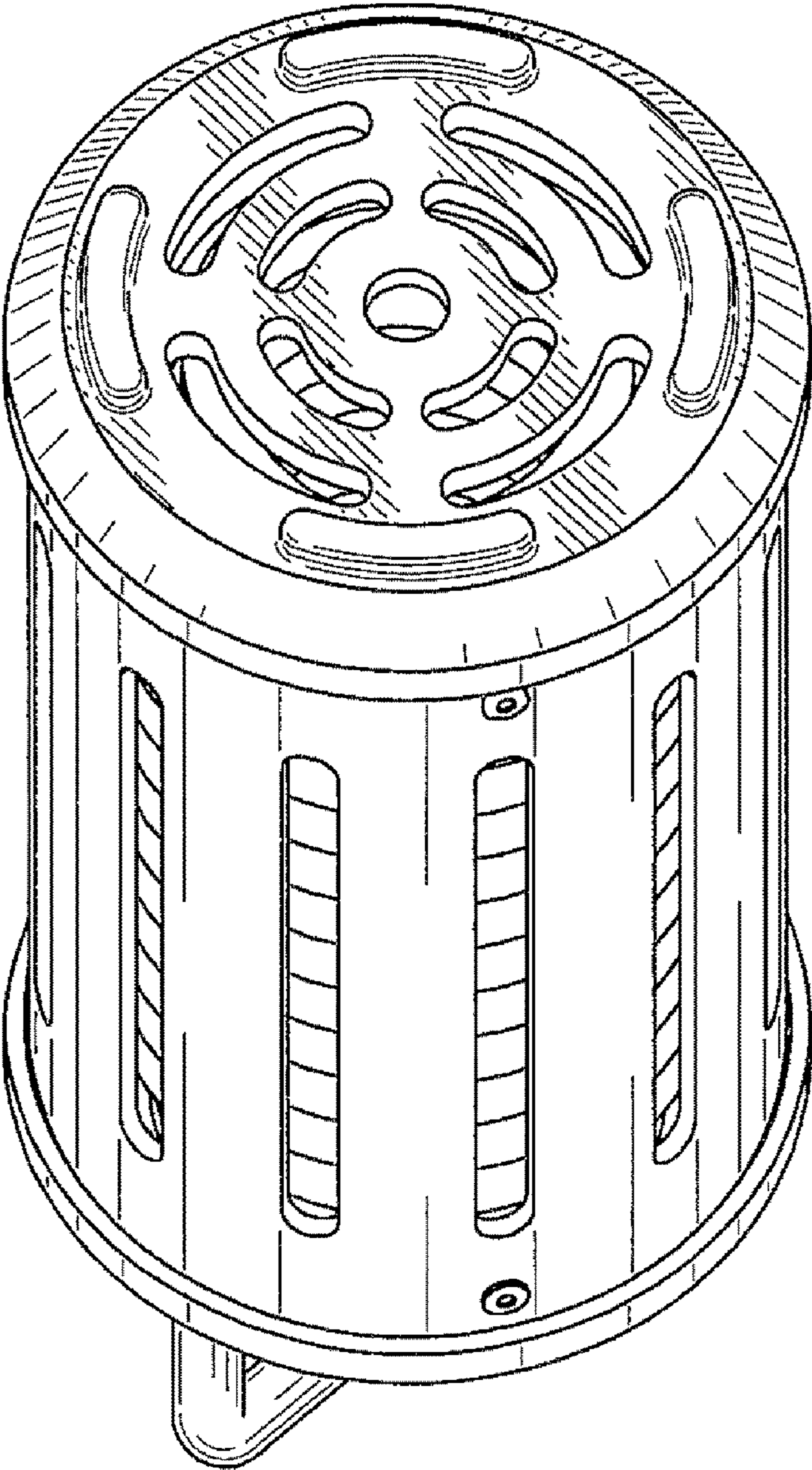
