**DESCRIPTION**

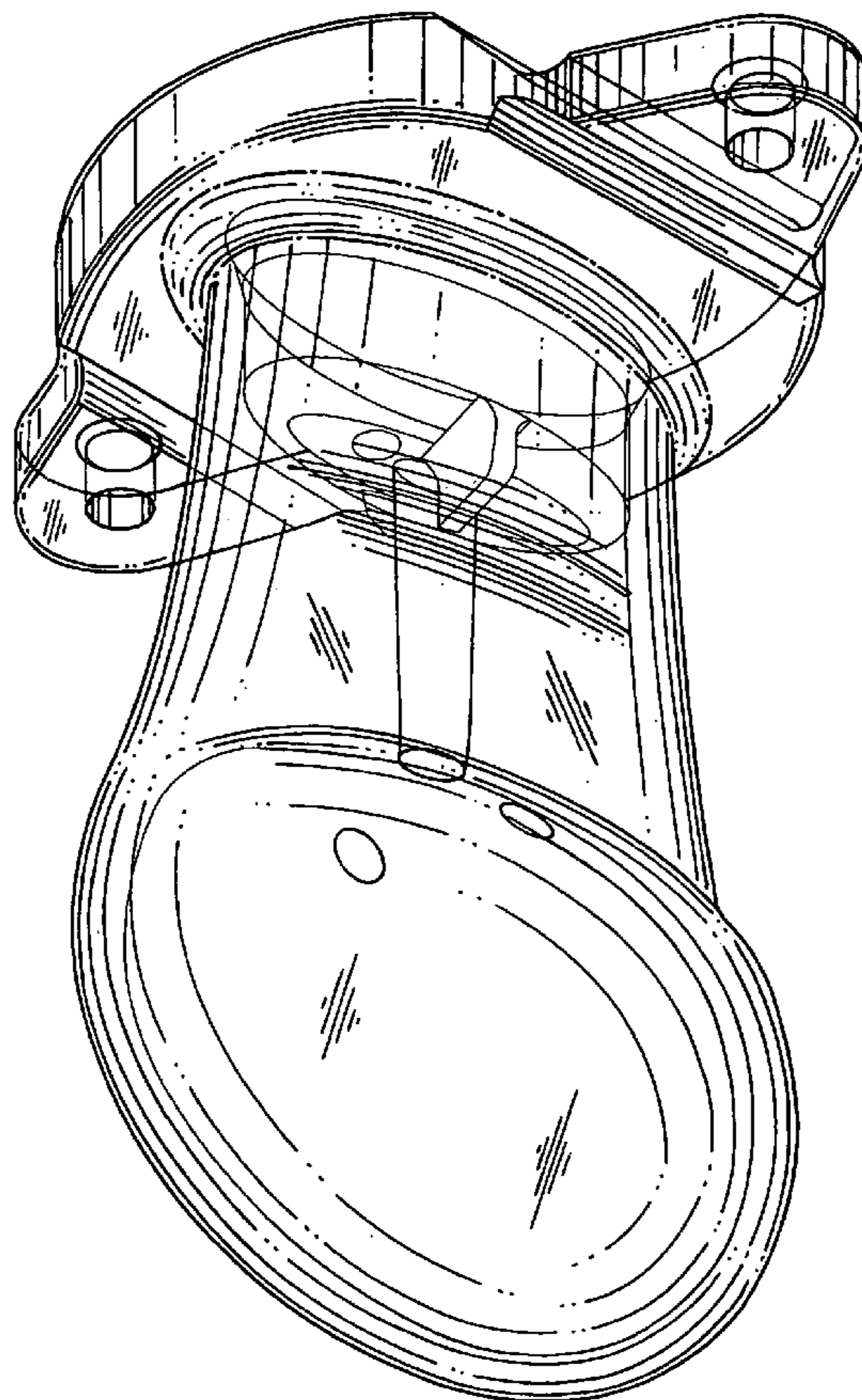
FIG. 1 is a front and left side perspective view from below, of the pacifier constructed according to my new design;  
FIG. 2 is a front elevational view thereof, the rear elevational view being a mirror image thereof;

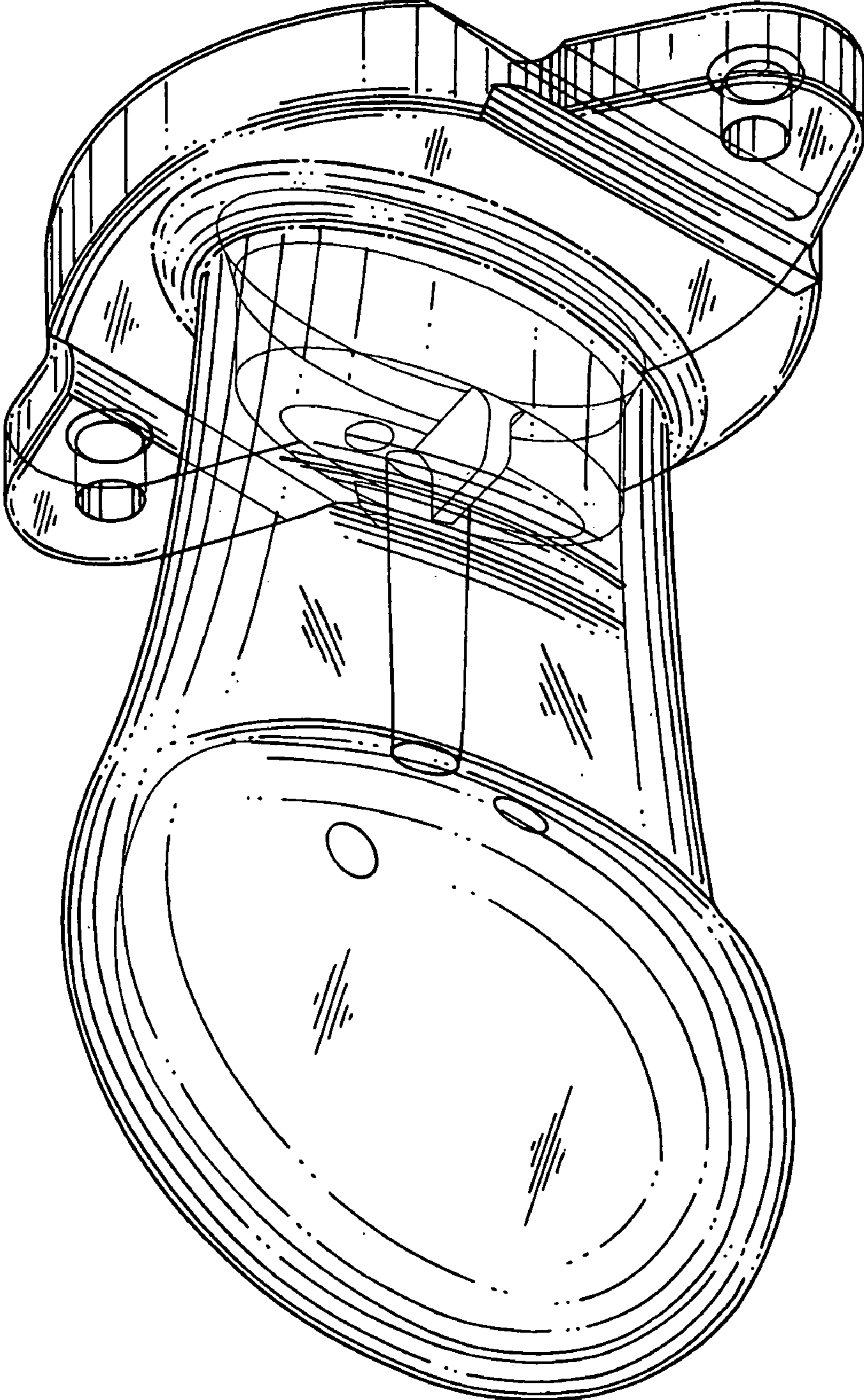

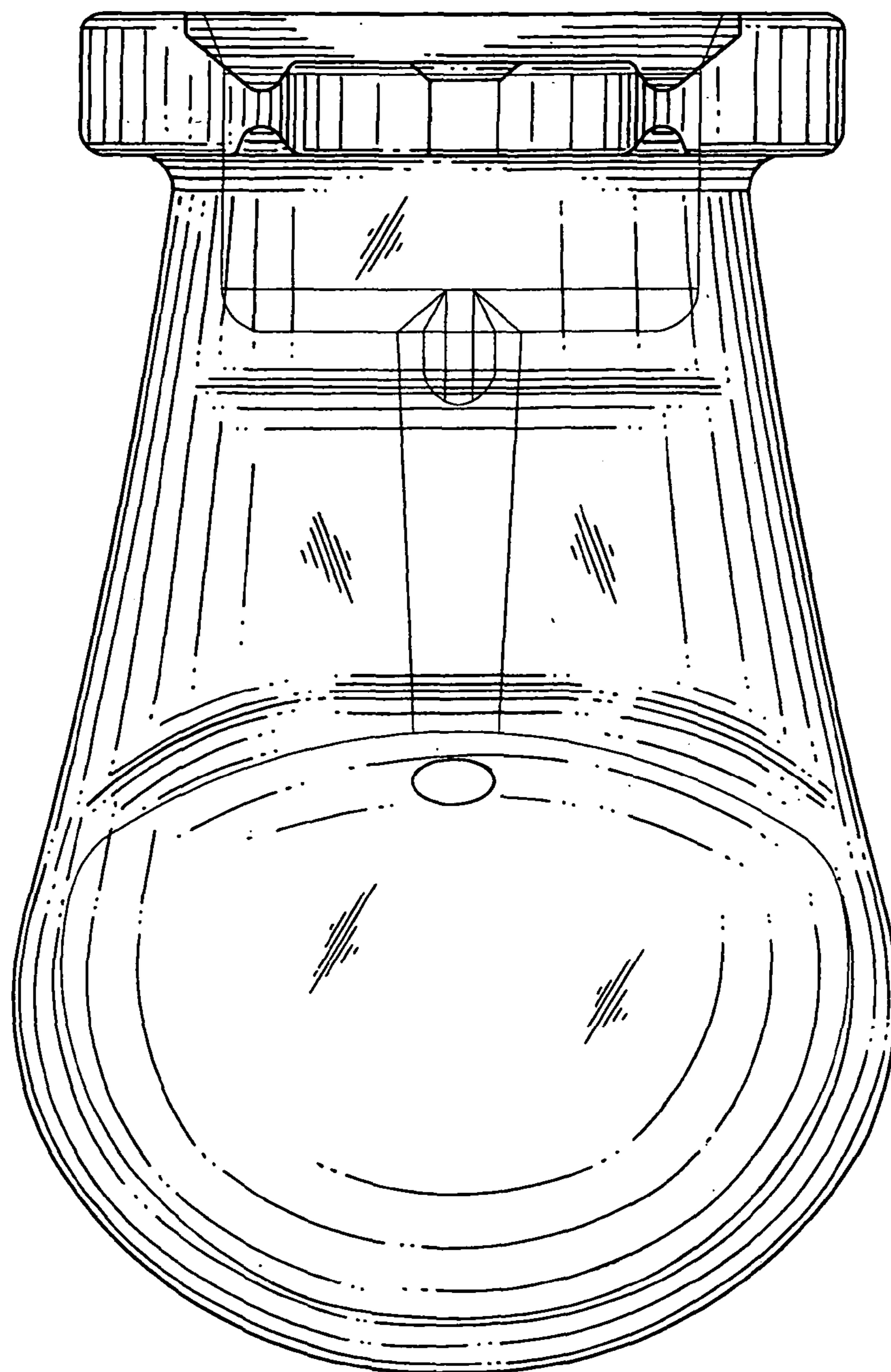

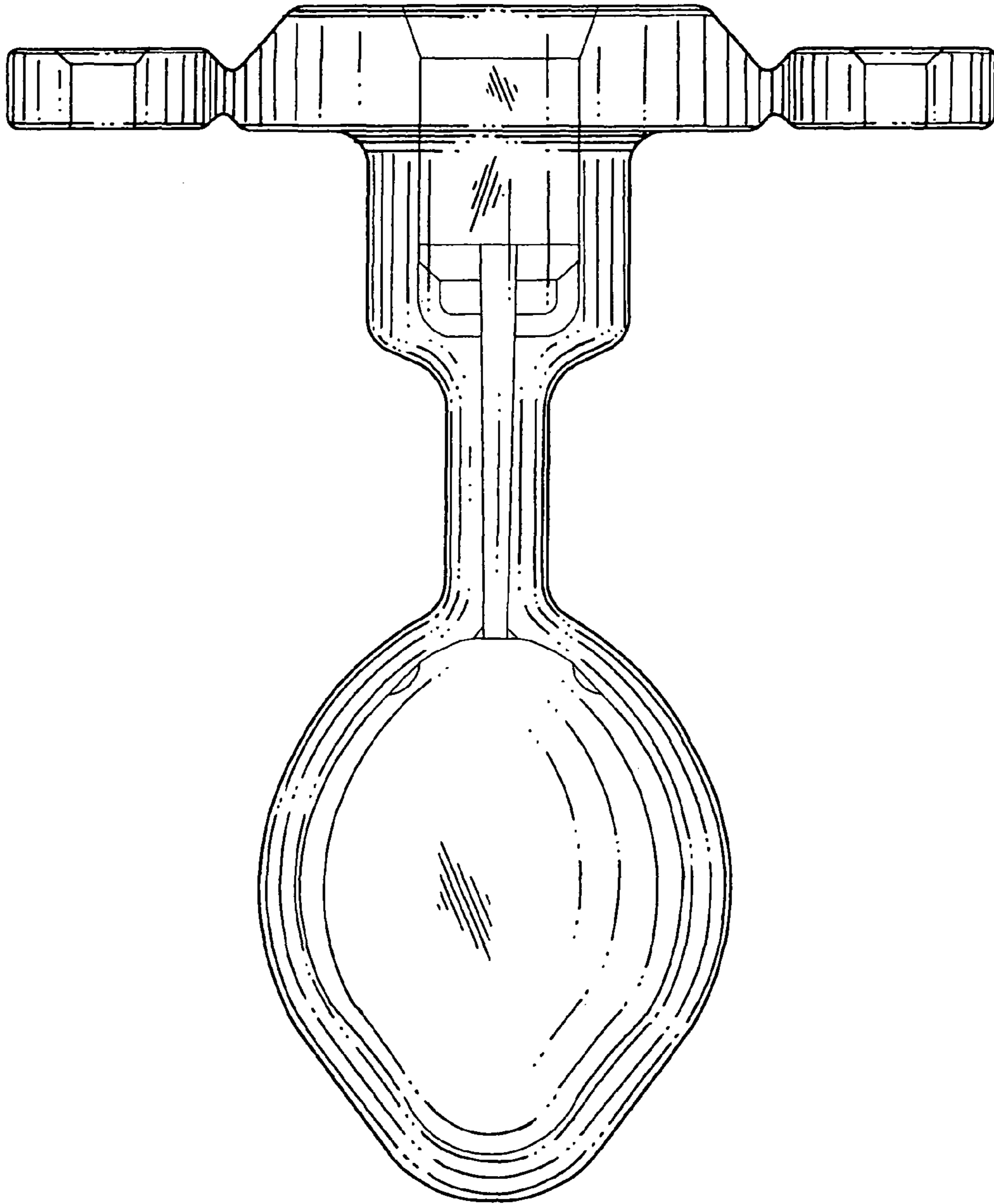

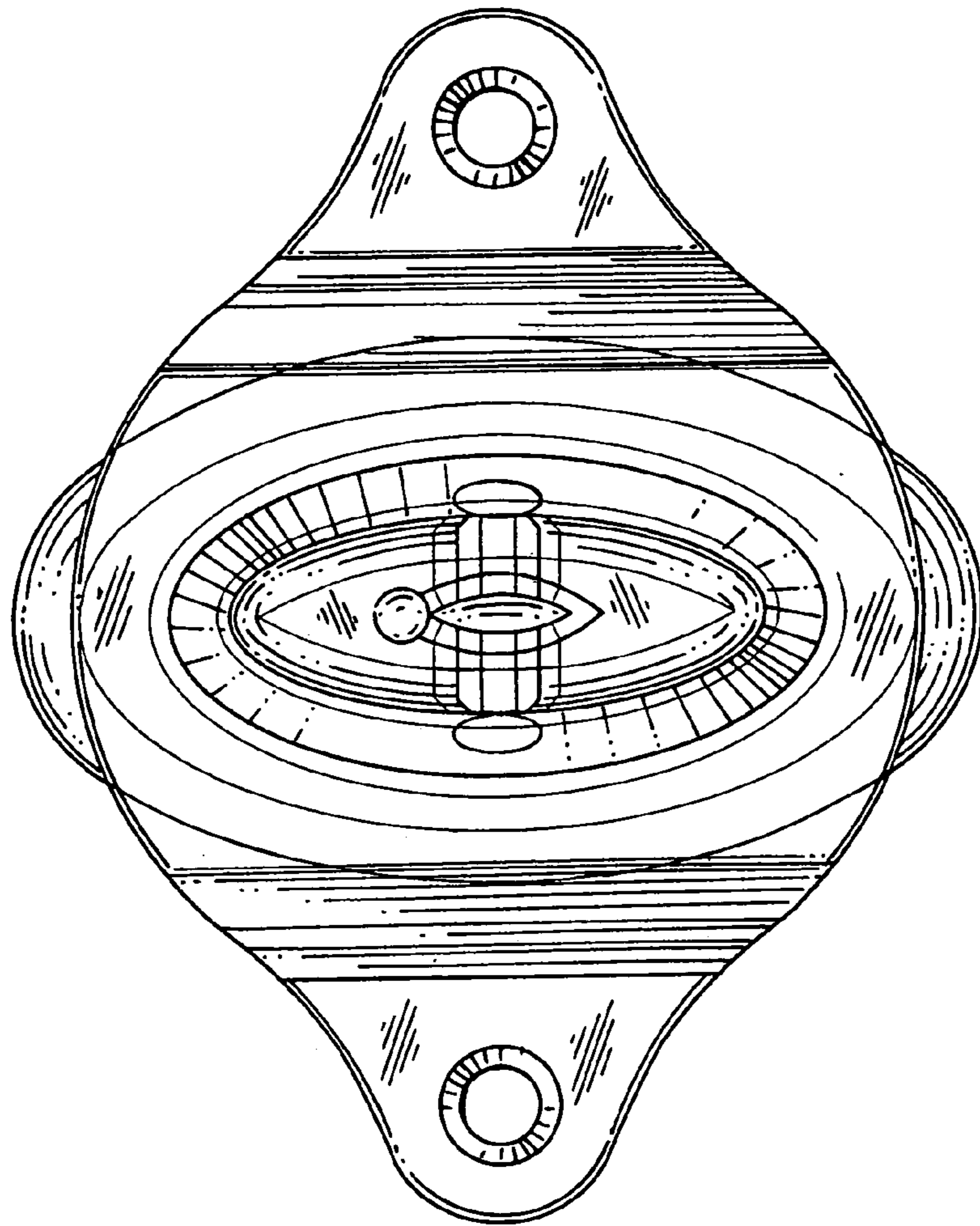

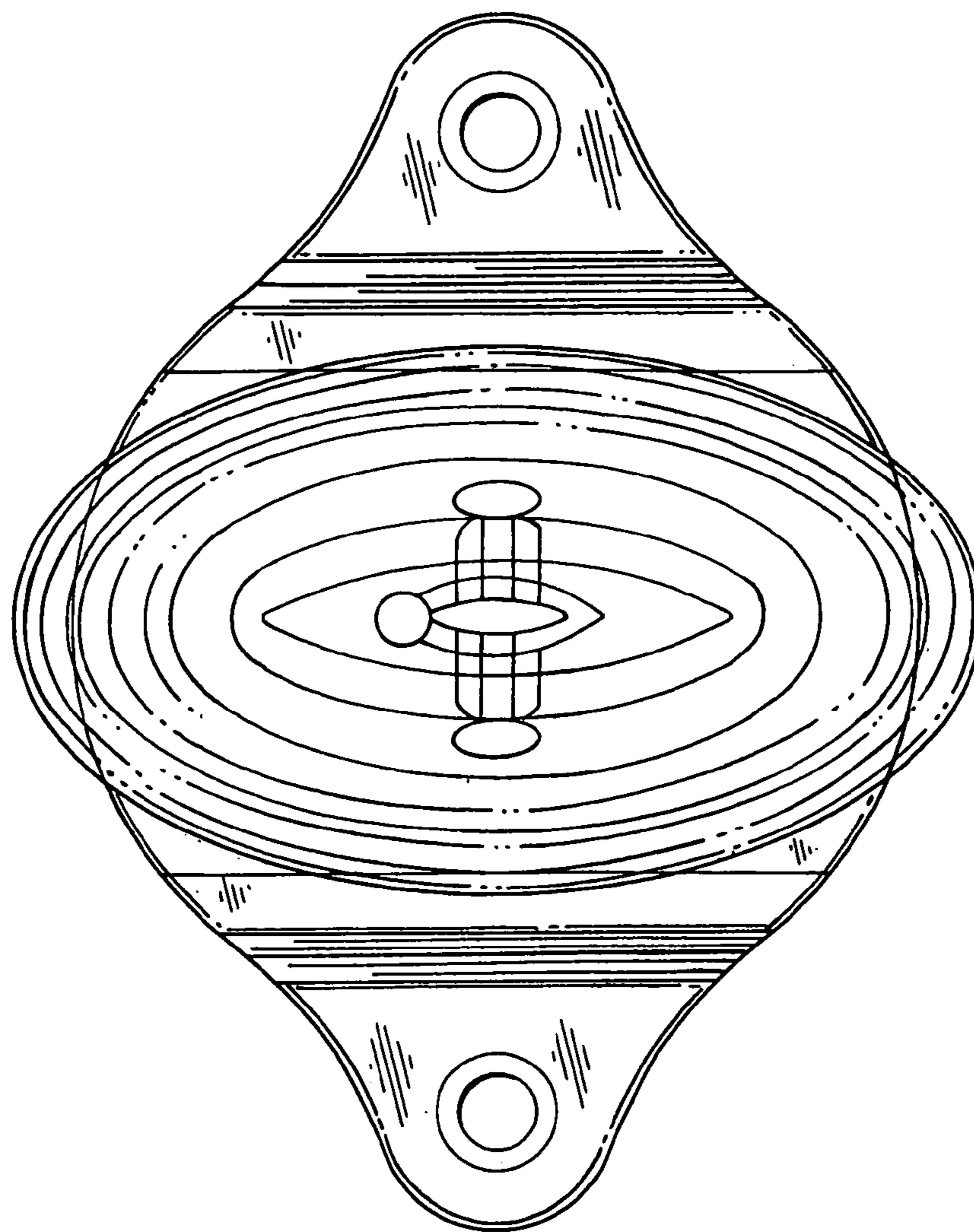
