(57) **CLAIM**

The ornamental design for a cosmetic compact, as shown and described.

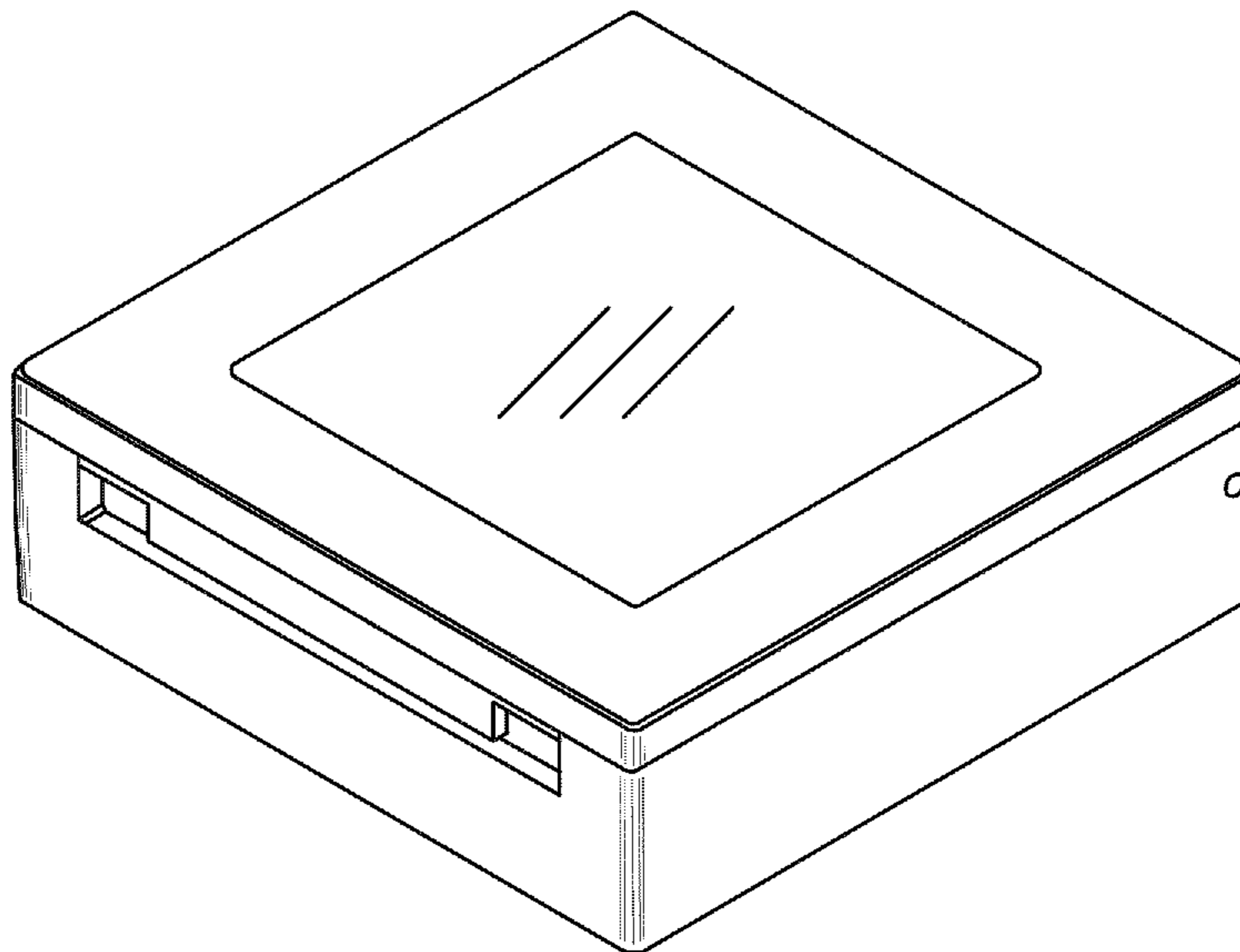
DESCRIPTION

FIG. 1 is a perspective view of a cosmetic compact;
FIG. 2 is a front elevation view of the cosmetic compact of FIG. 1;
FIG. 3 is a back elevation view of the cosmetic compact of FIG. 1;
FIG. 4 is a left-side elevation view of the cosmetic compact of FIG. 1;
FIG. 5 is a right-side elevation view of the cosmetic compact of FIG. 1;
FIG. 6 is a top plan view of the cosmetic compact of FIG. 1; and,
FIG. 7 is a bottom plan view of the cosmetic compact of FIG. 1.

The broken lines shown in the drawings illustrate portions of the hinge and form no part of the claimed design.

The internal features of the cosmetic compact that would be visible through the transparent window in the top are not shown and do not form part of the claimed design.

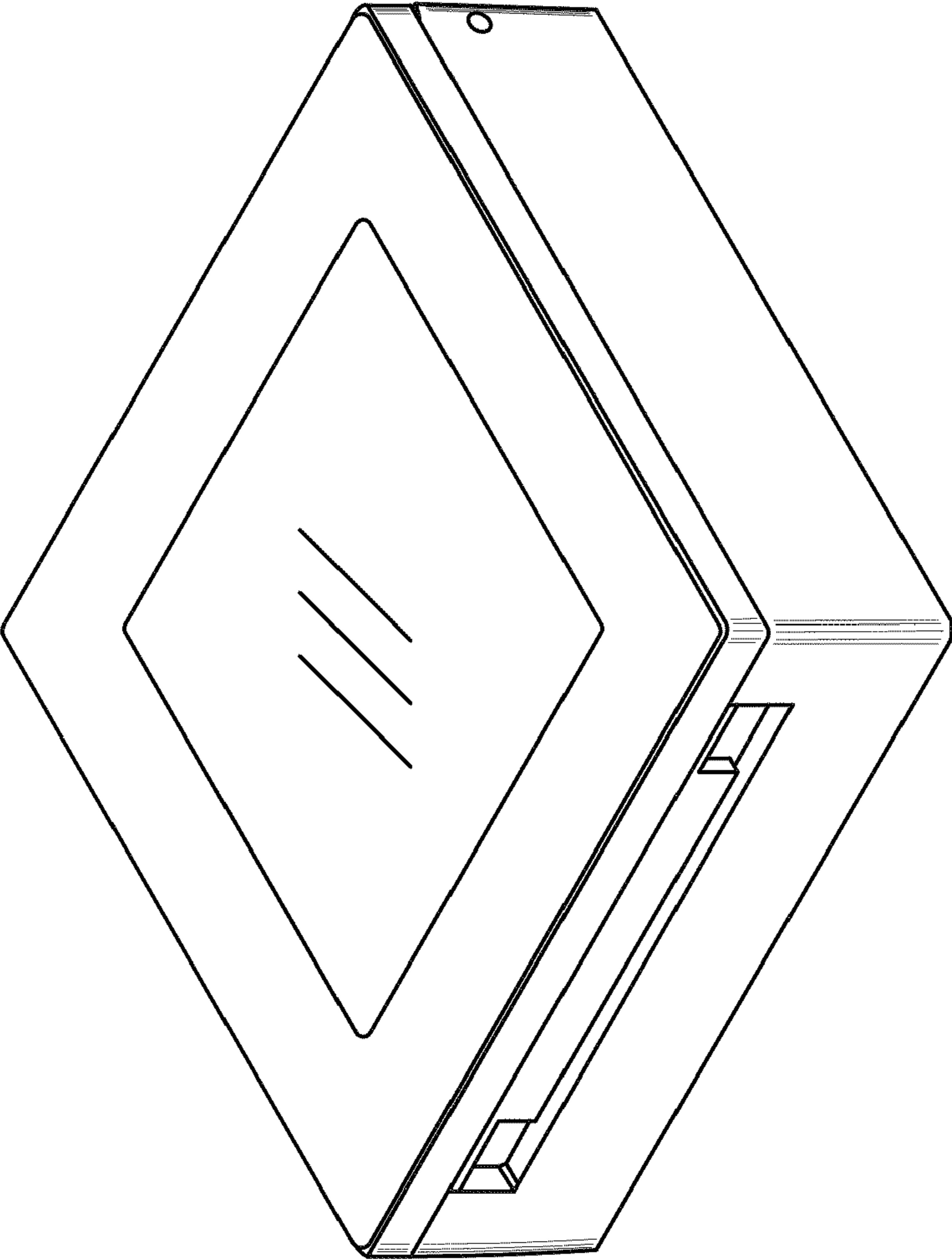

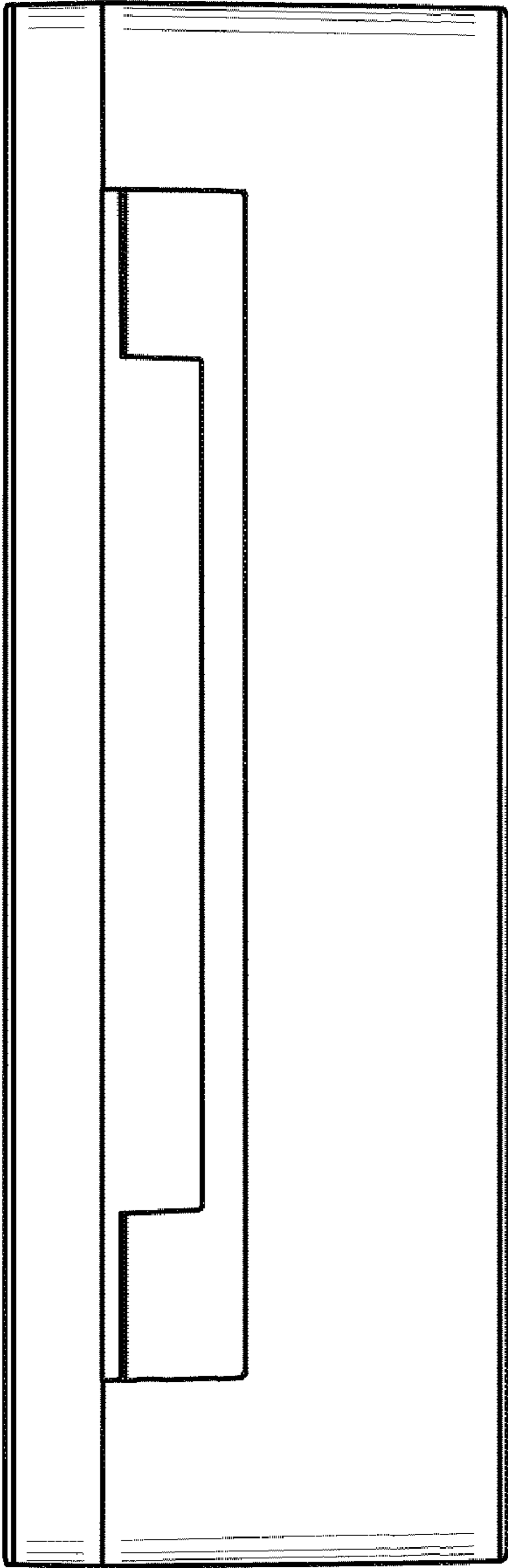

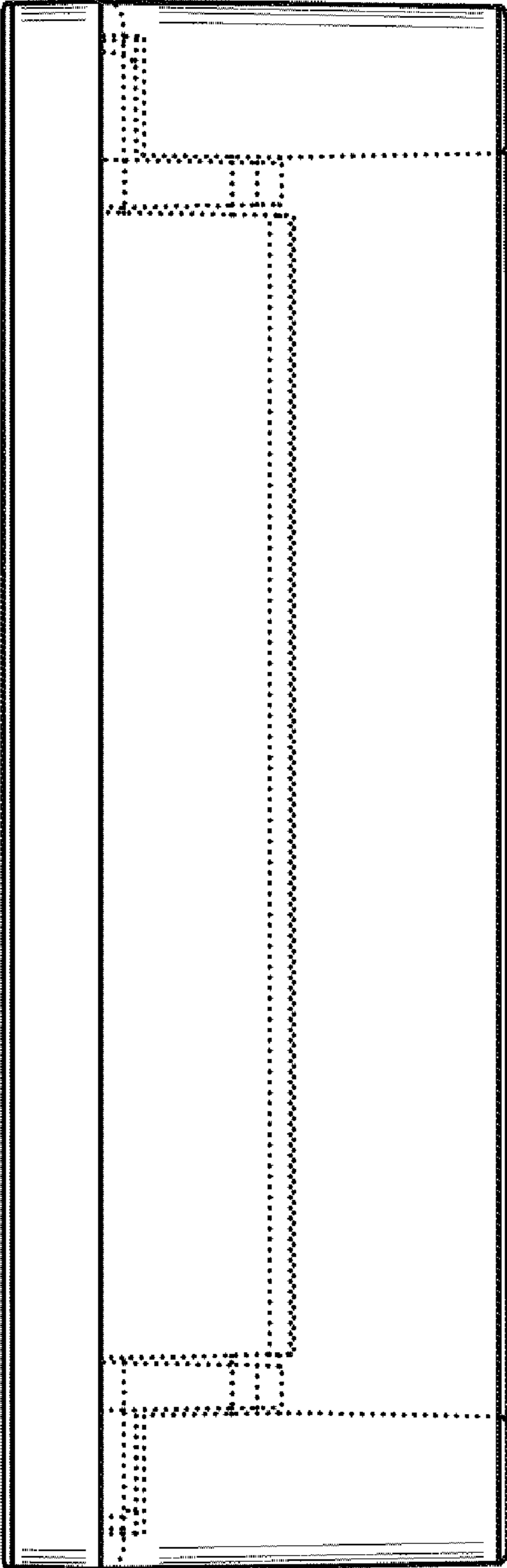

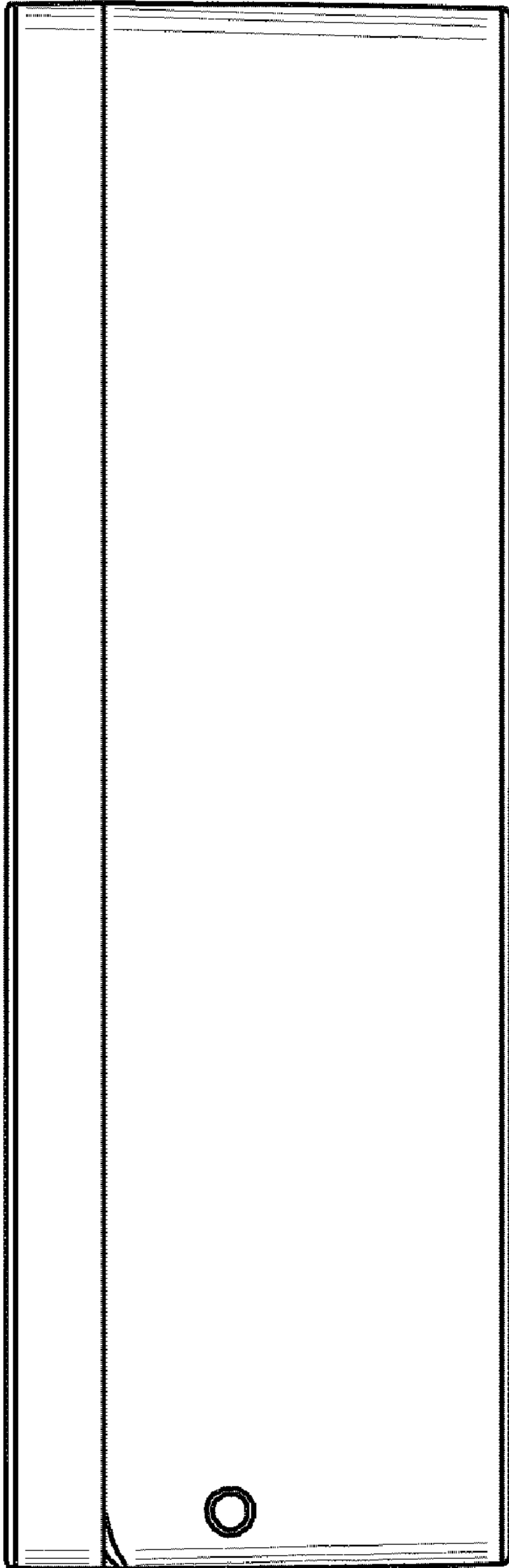

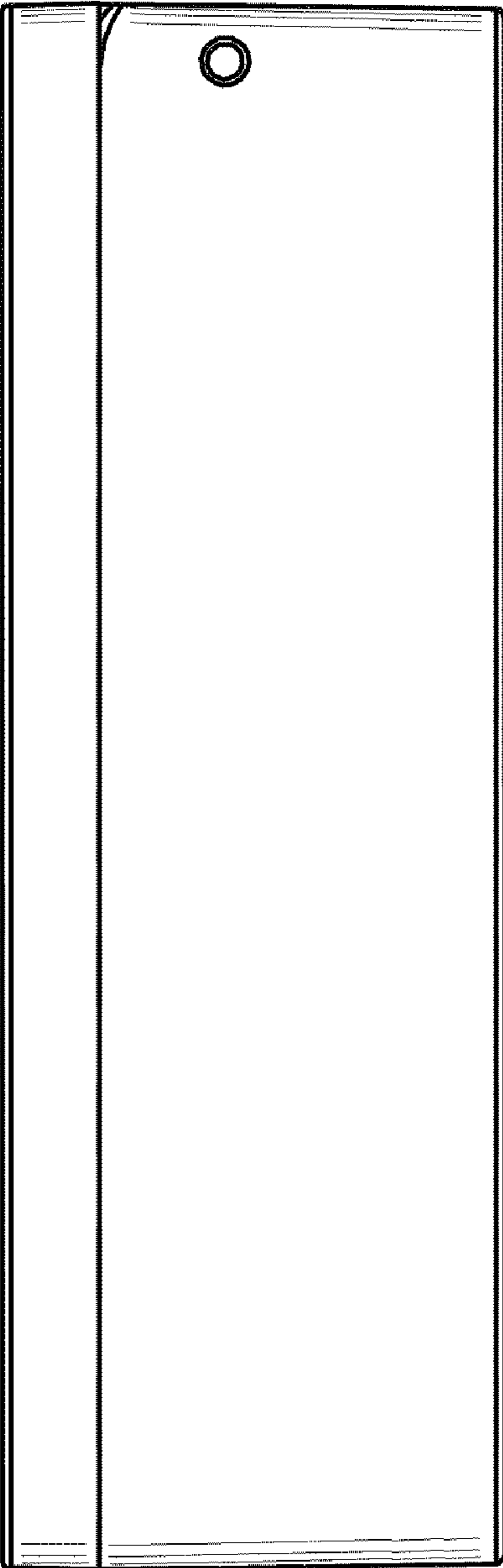

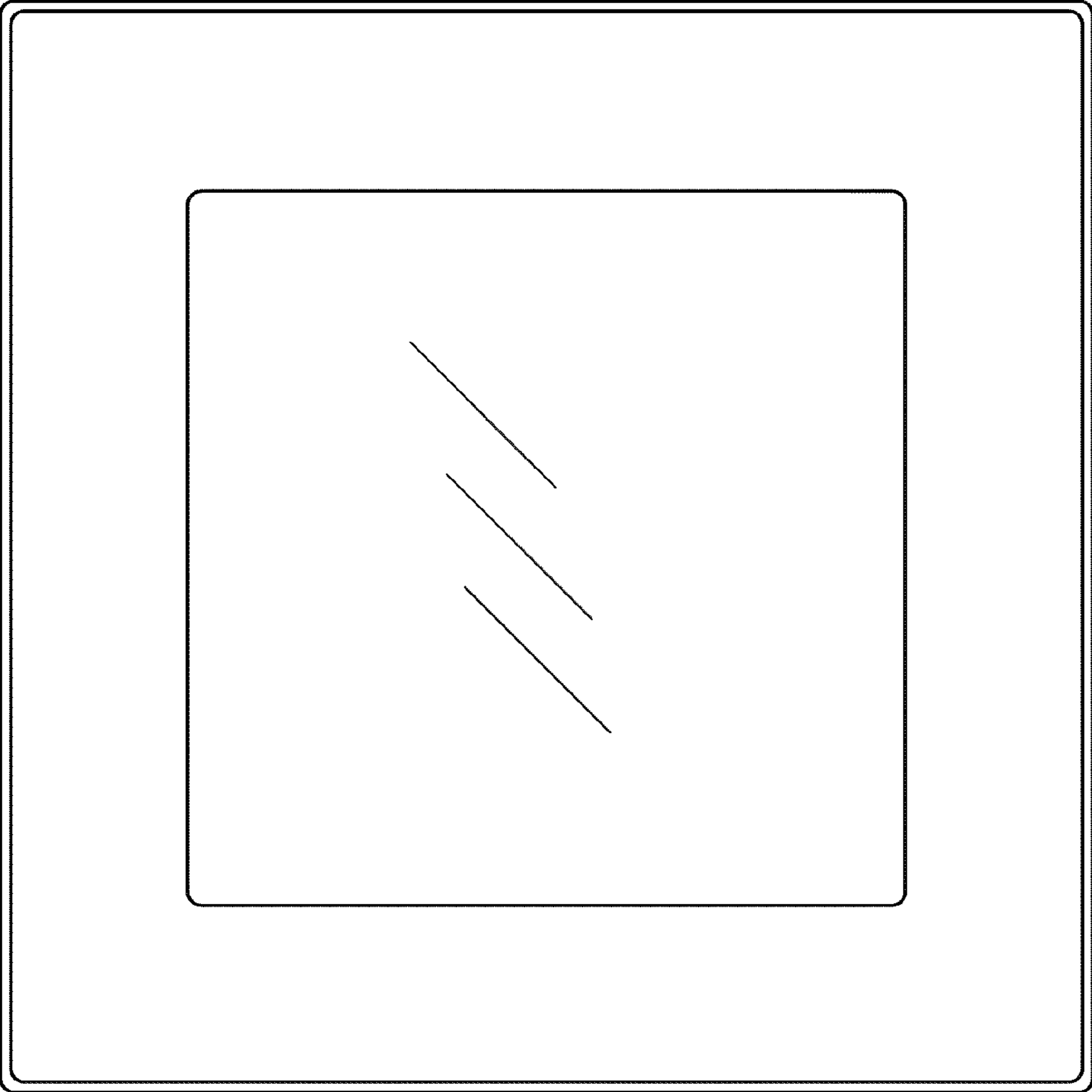

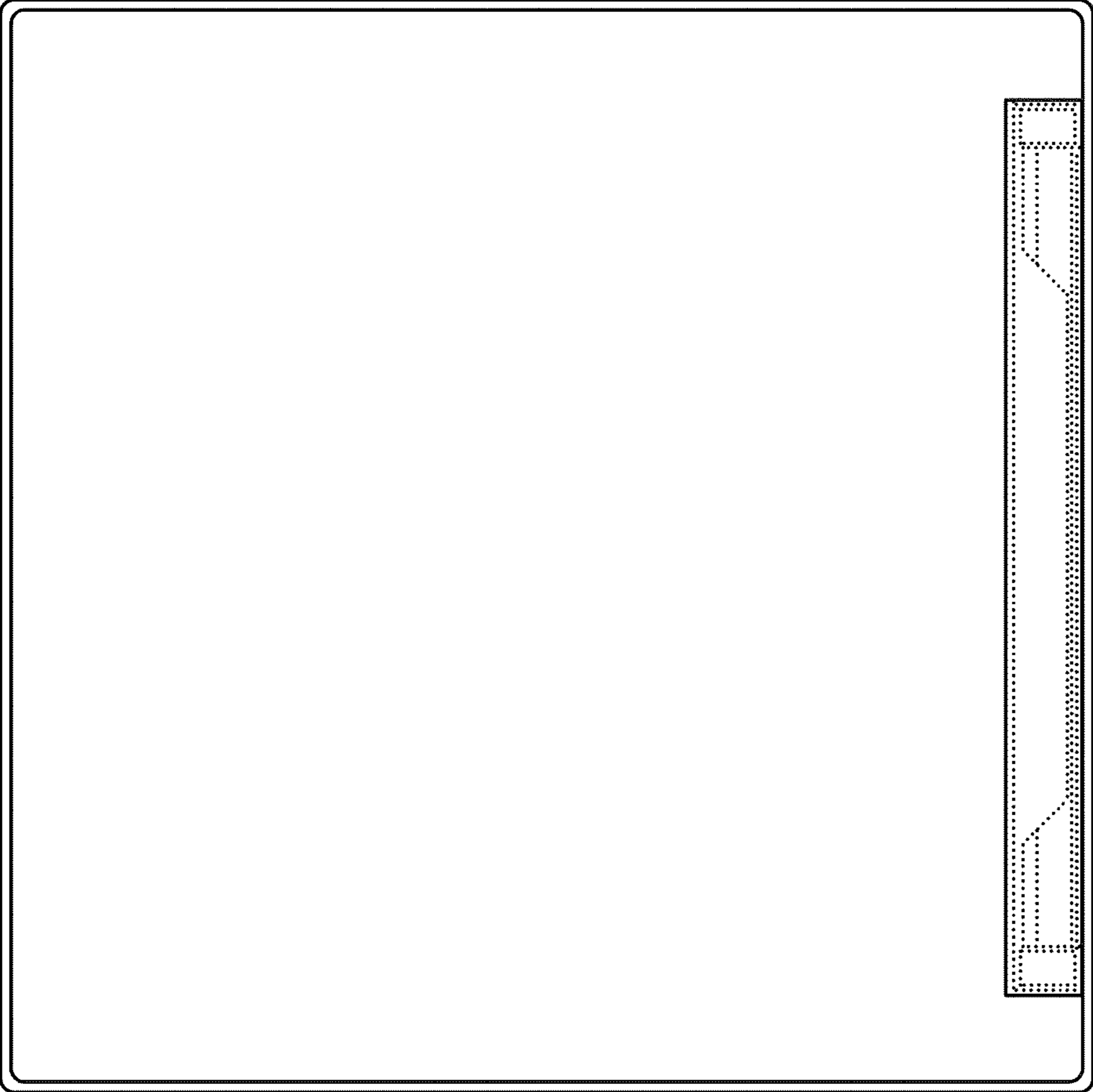
