The ornamental design for a square bottom taco shell, as shown and described.

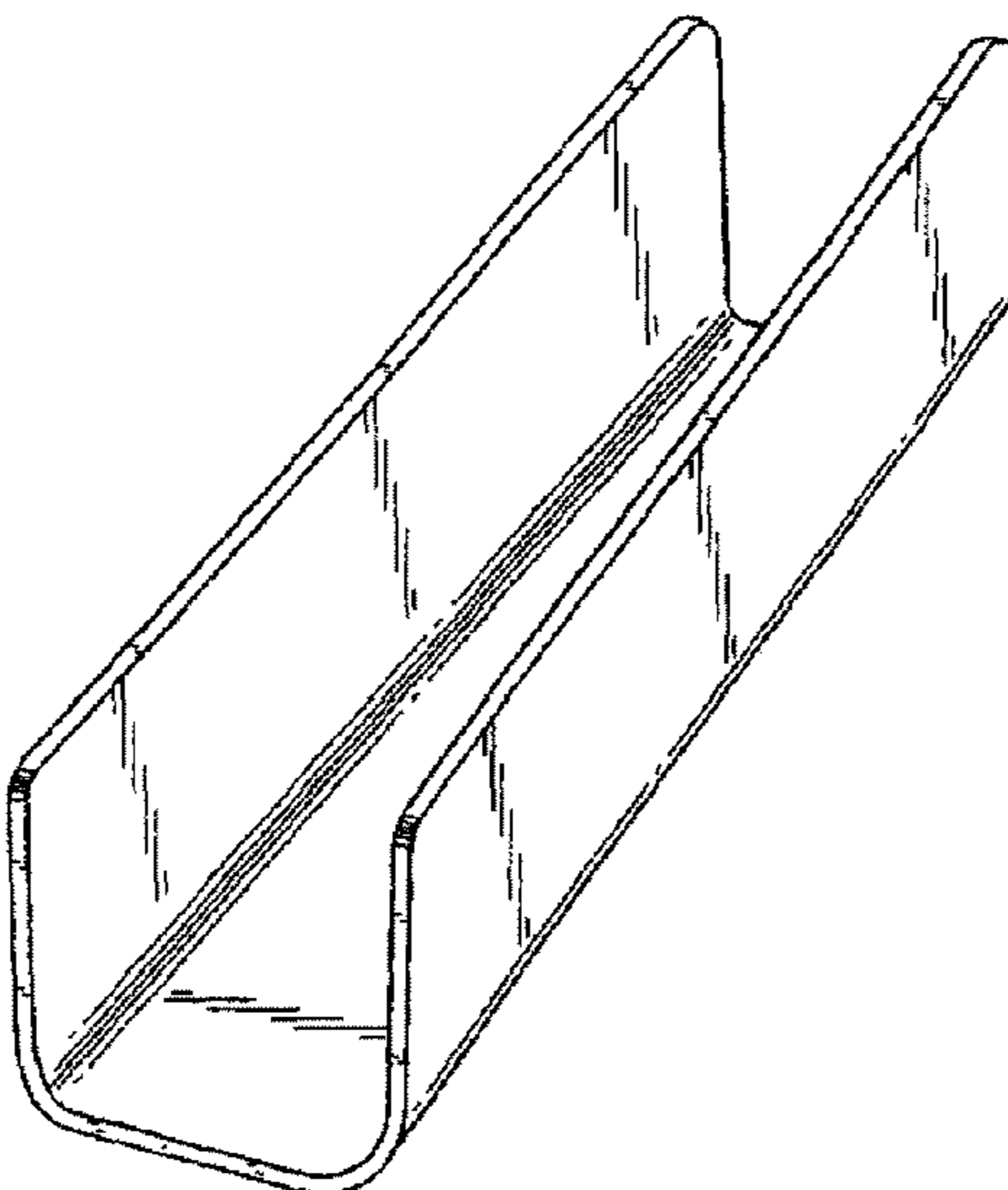
DESCRIPTION

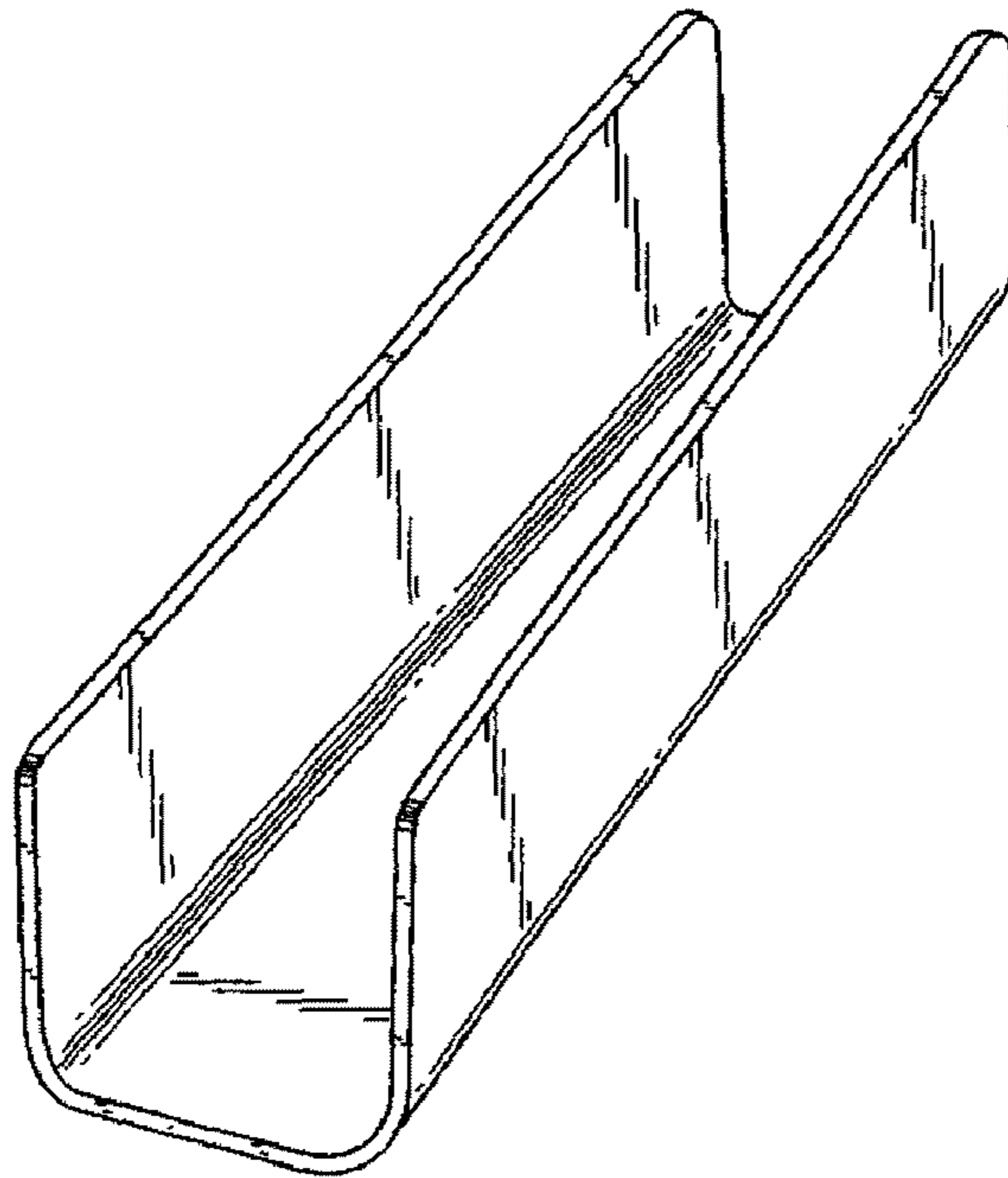

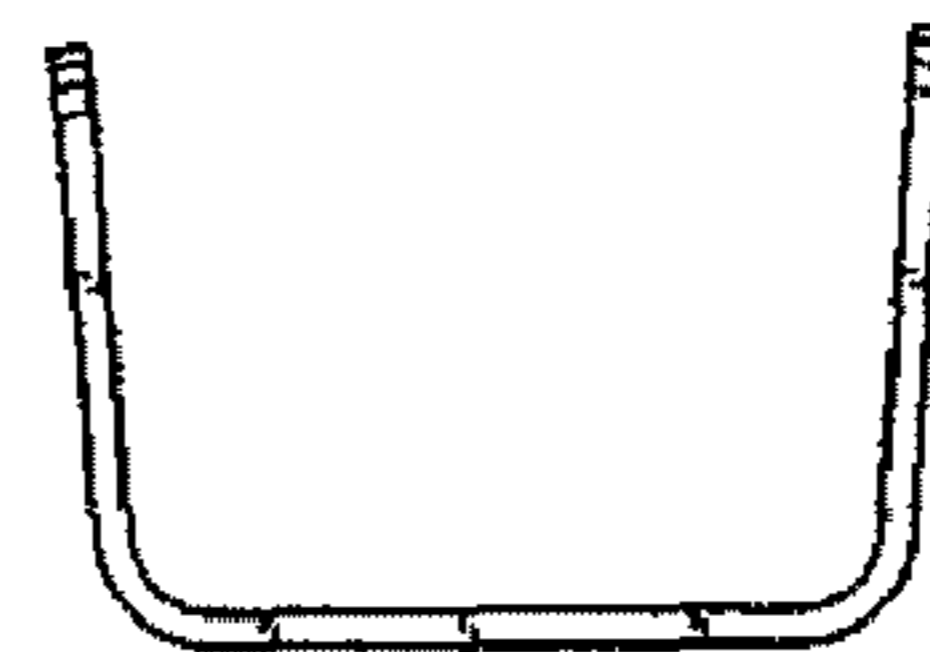

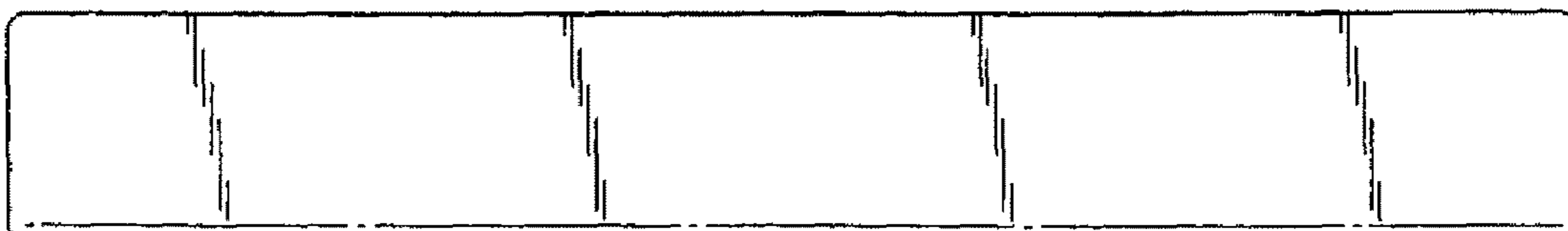
