FIG. 1 is a perspective view of a dog treat showing the new design.

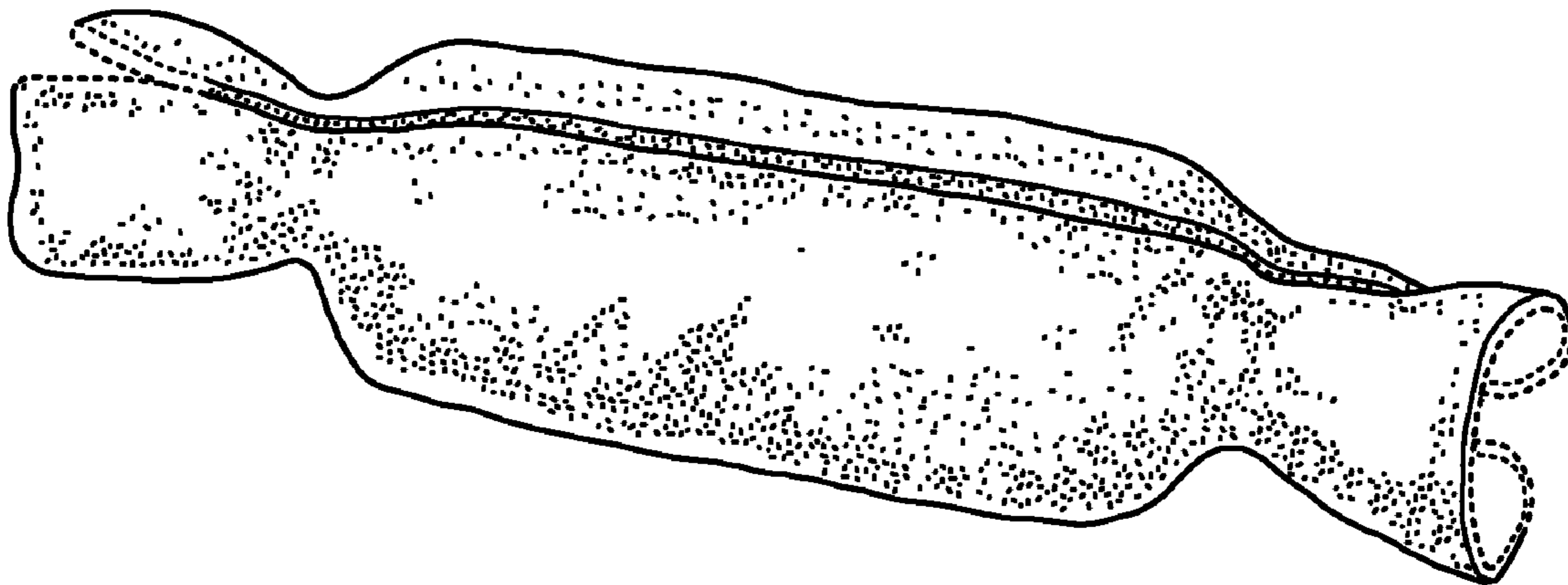
FIG. 2 is a right side view thereof.

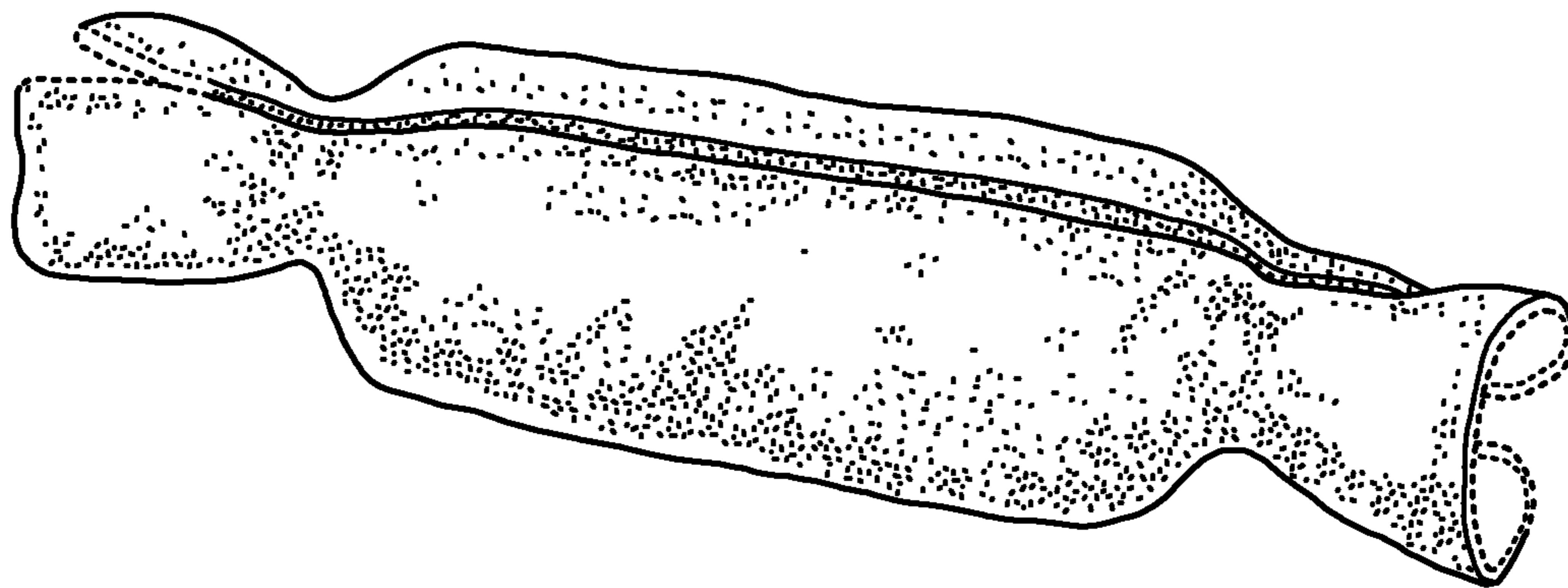

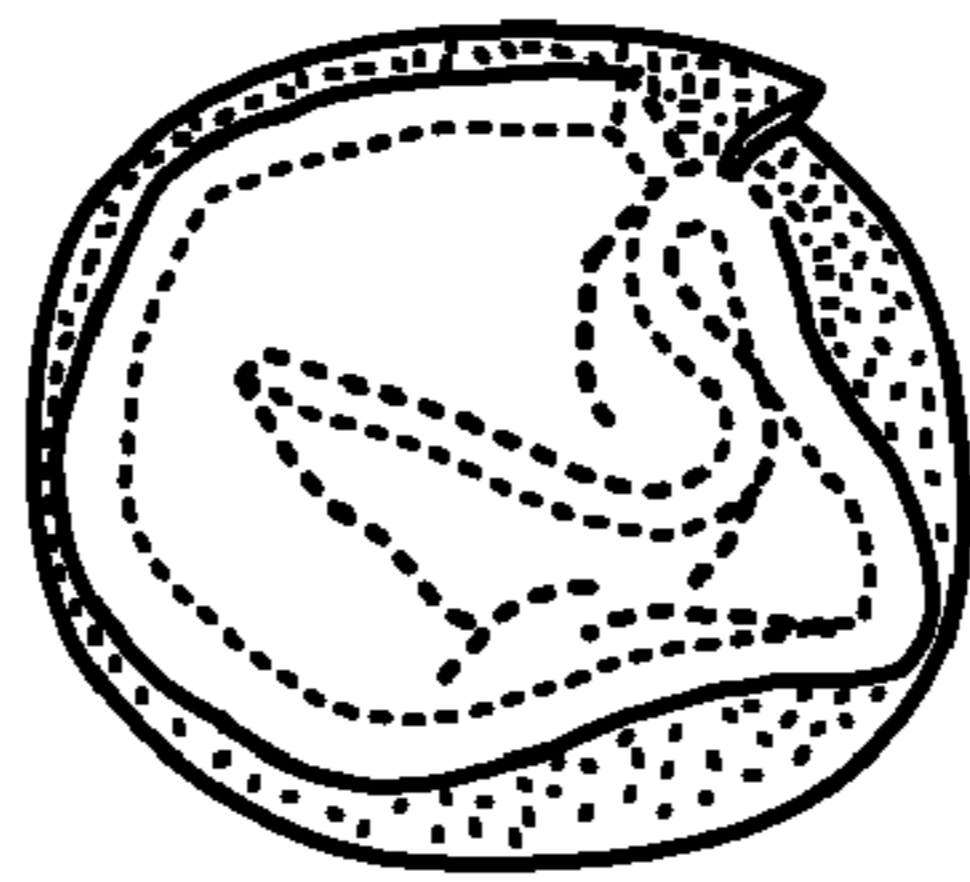

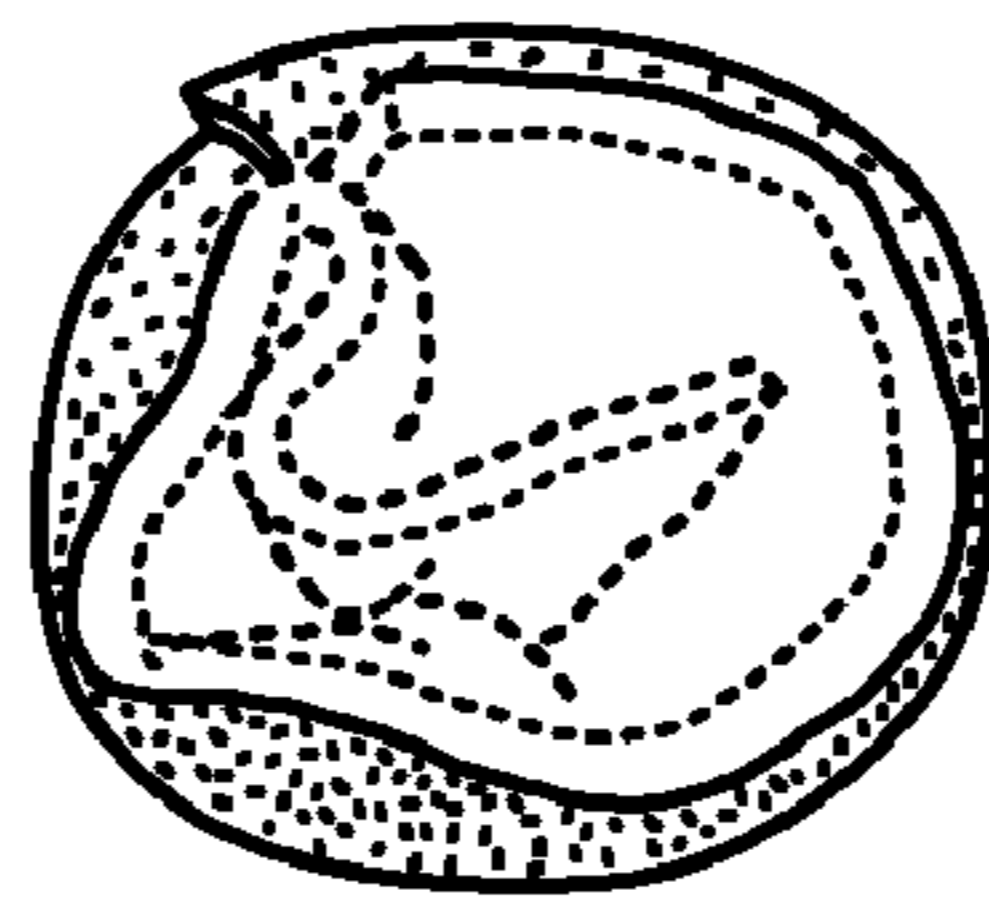
