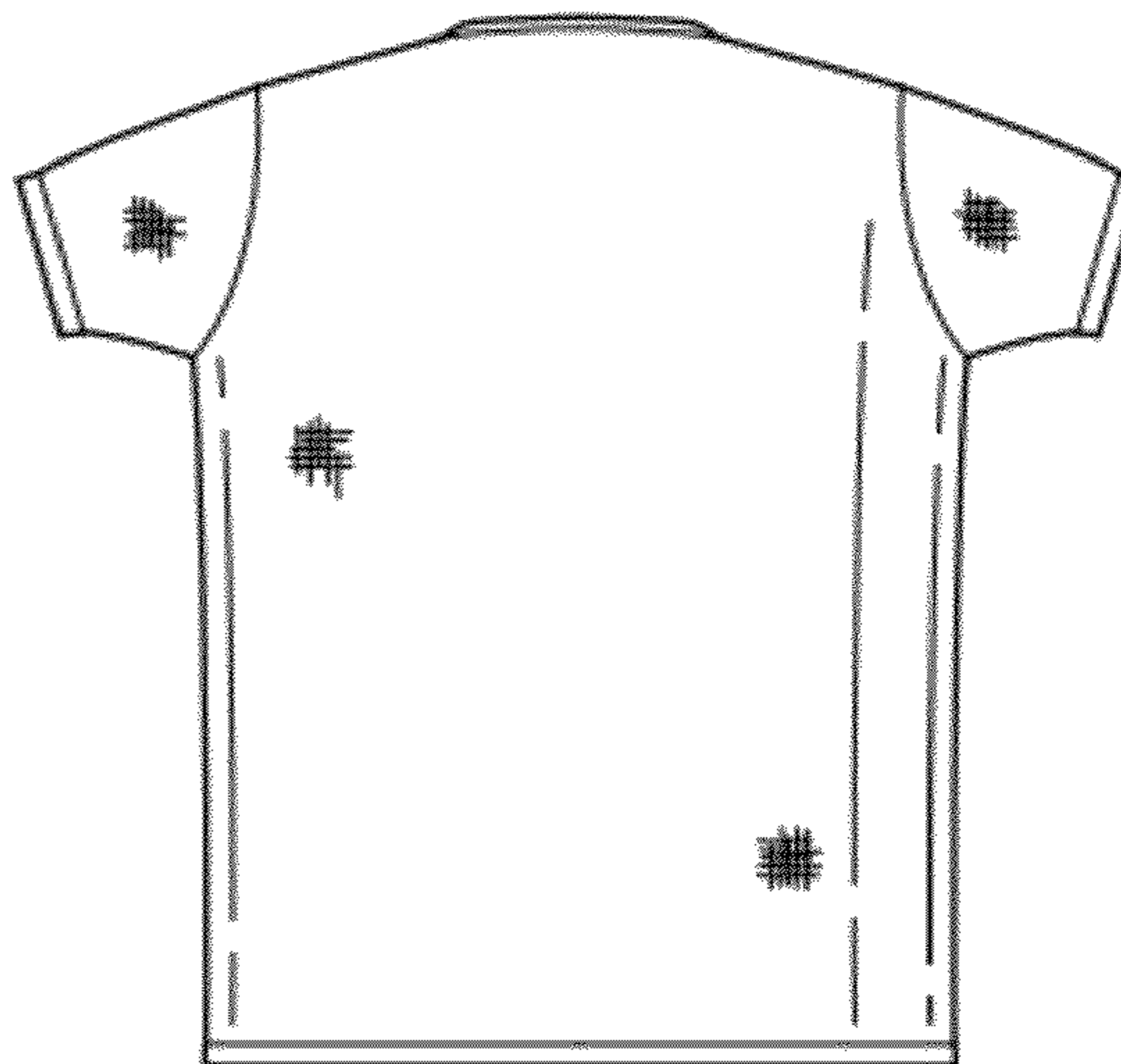
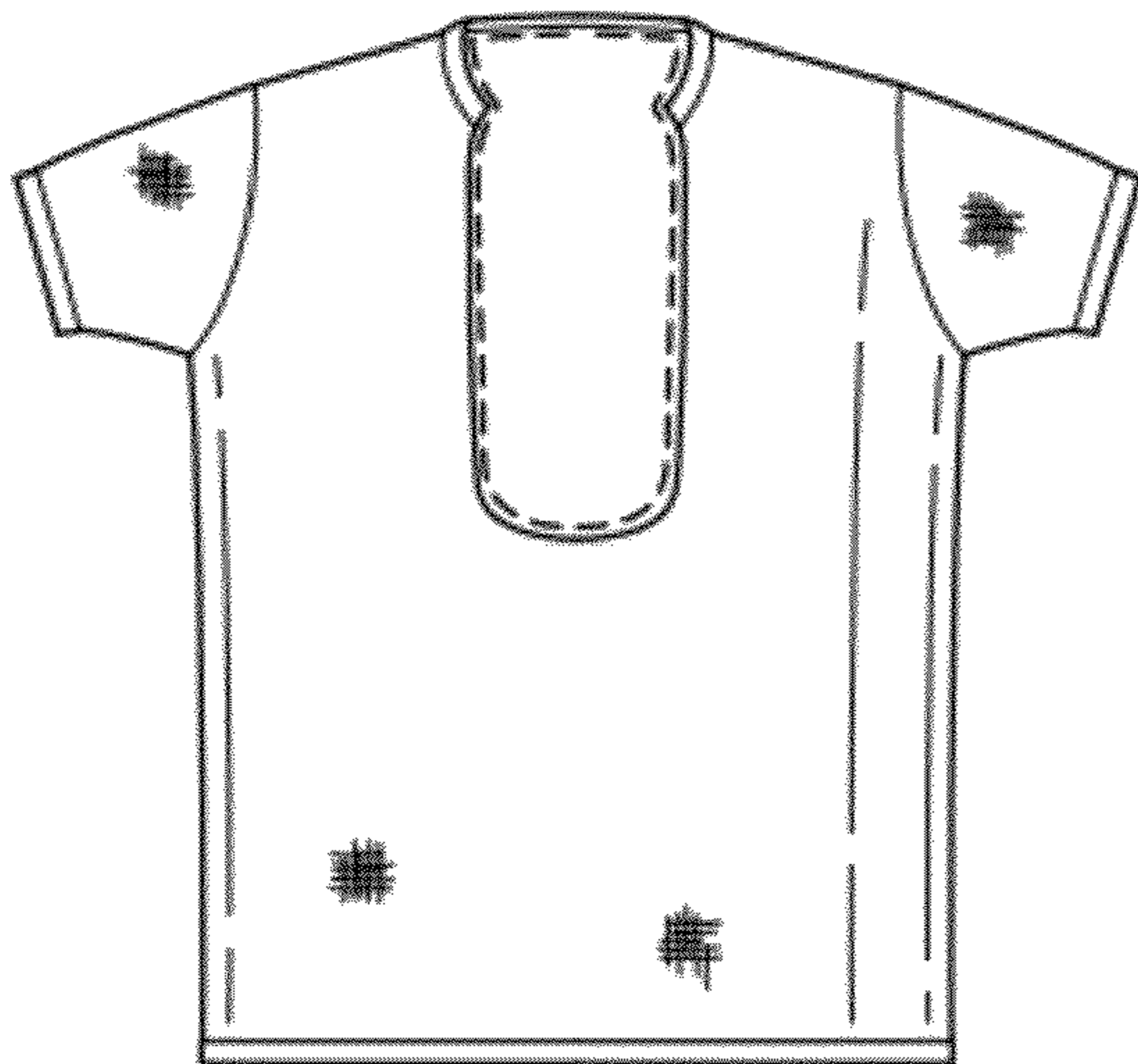
(57) **CLAIM**

I claim the ornamental design for a garment with low cut neck, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a garment with low cut neck showing my new design;

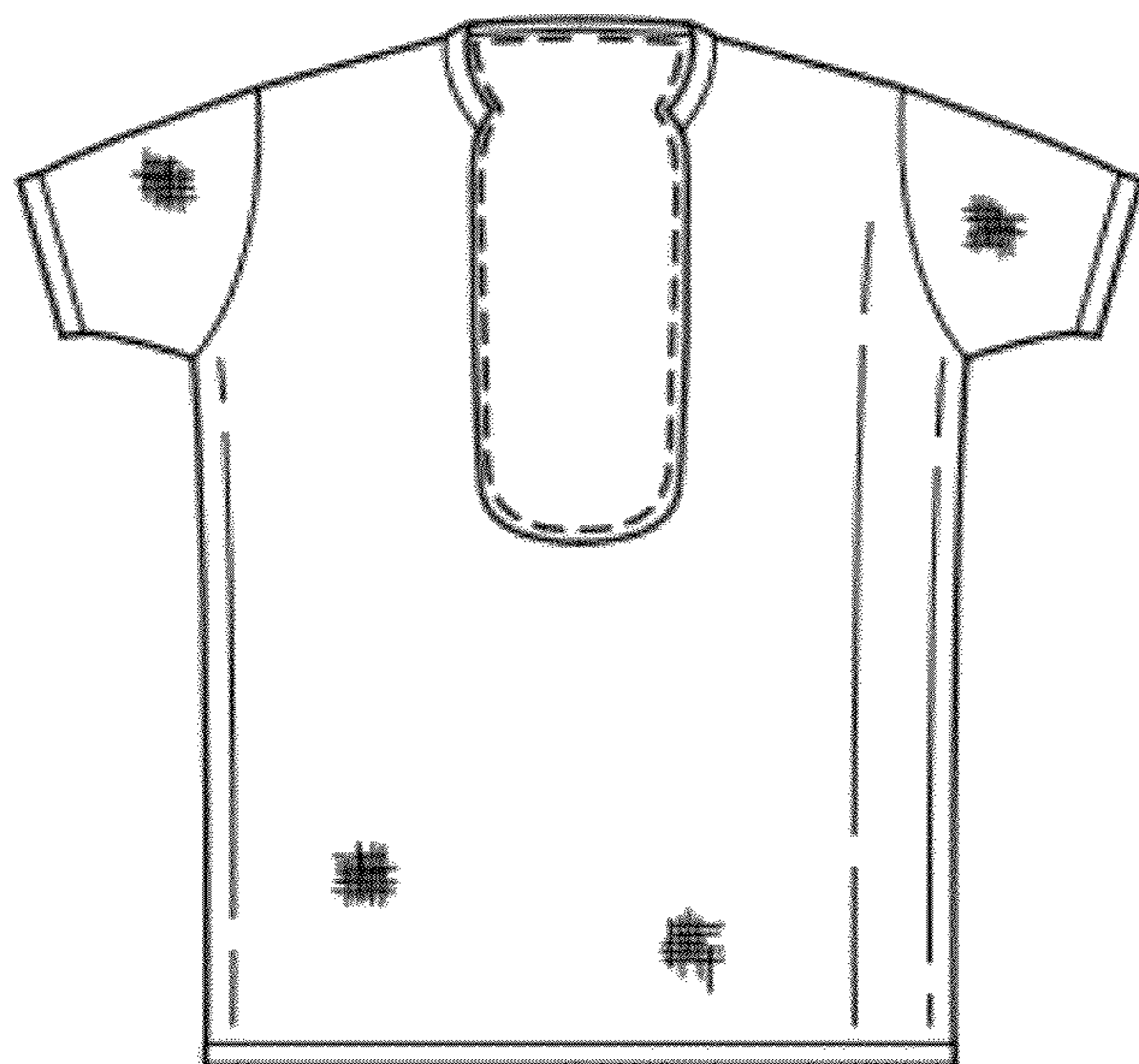

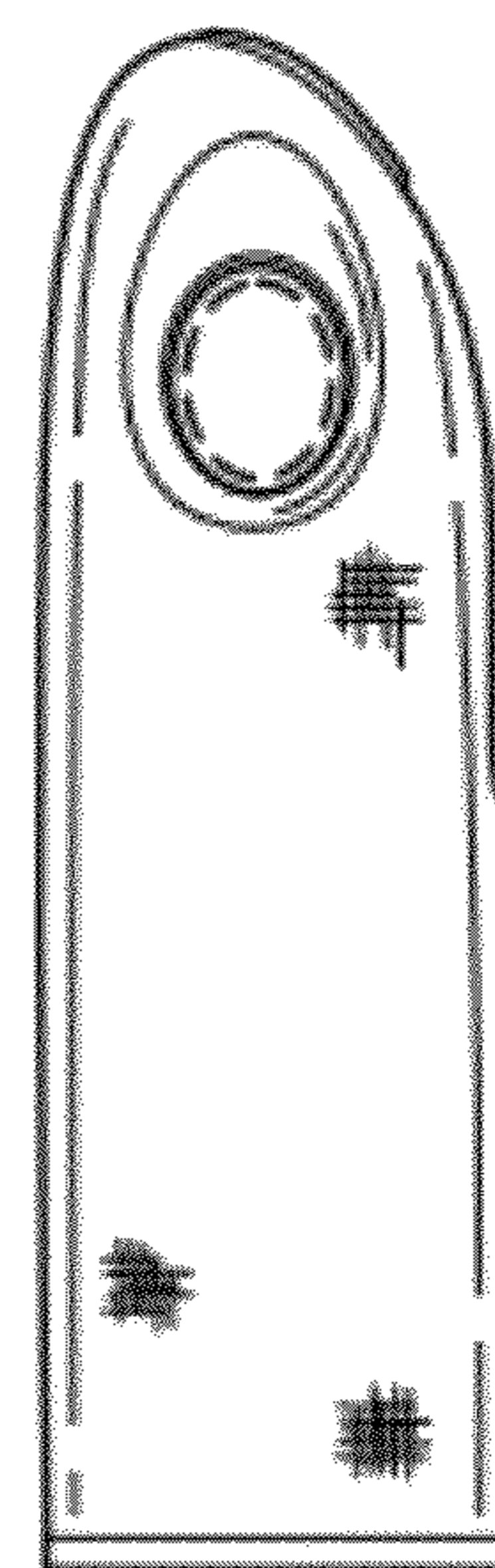

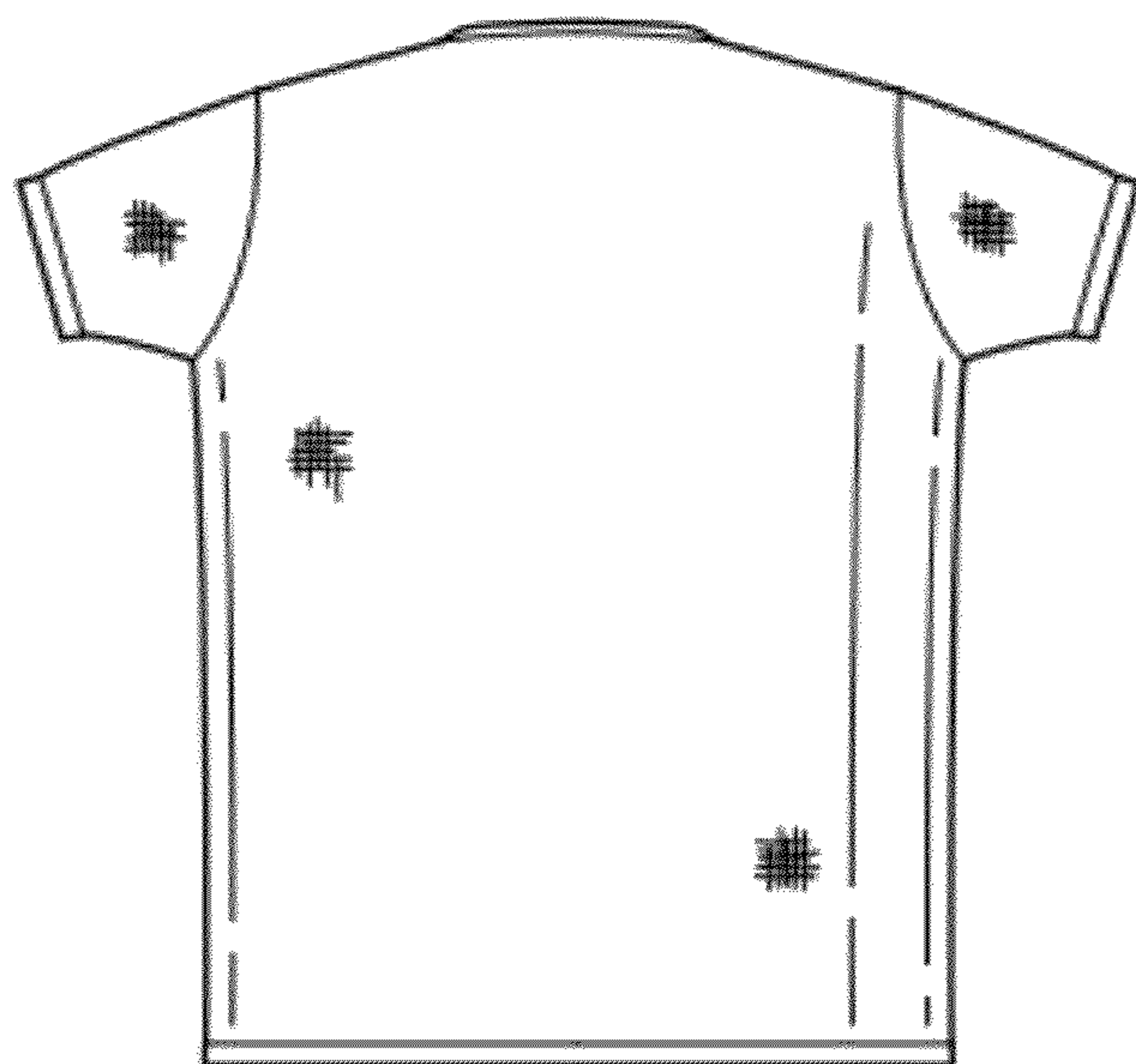
