DESCRIPTION

FIG. 1 is a top view of a bench showing my new design;

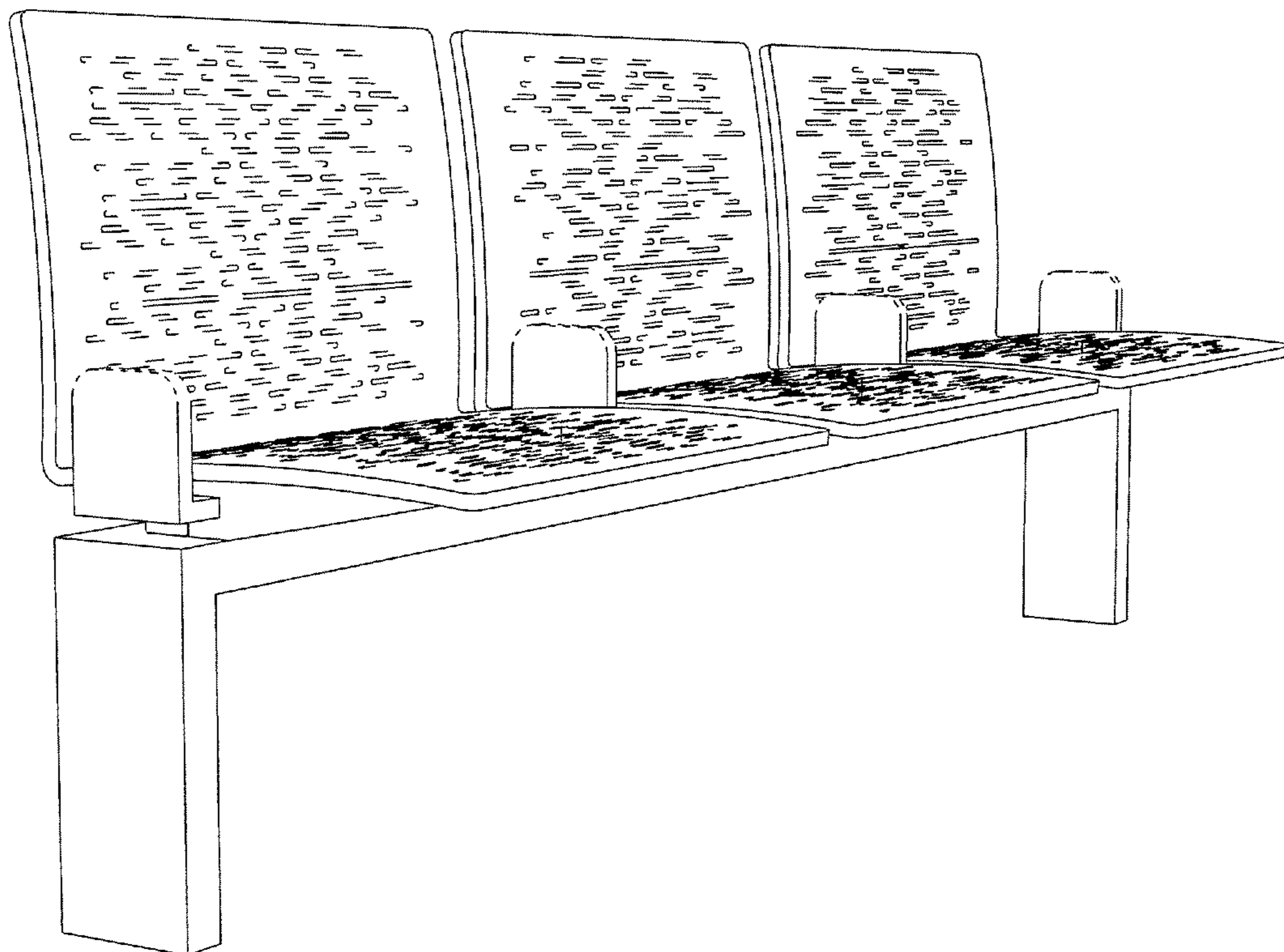

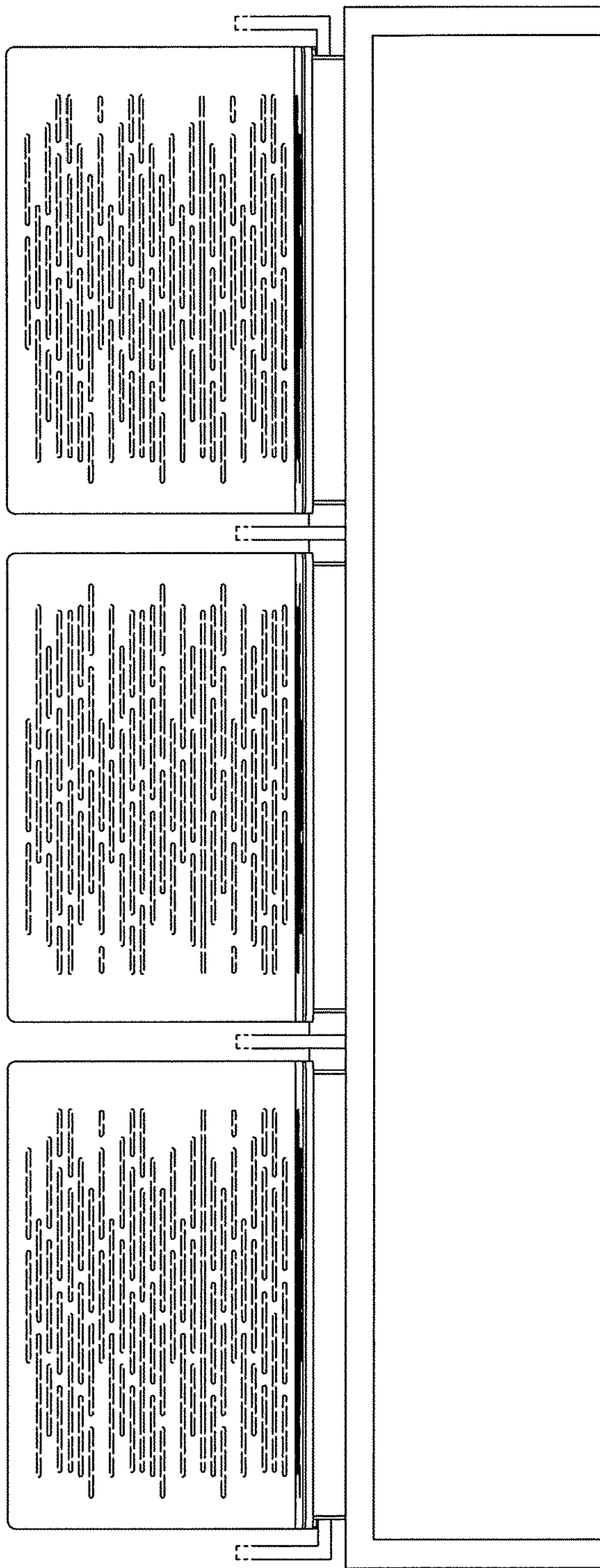

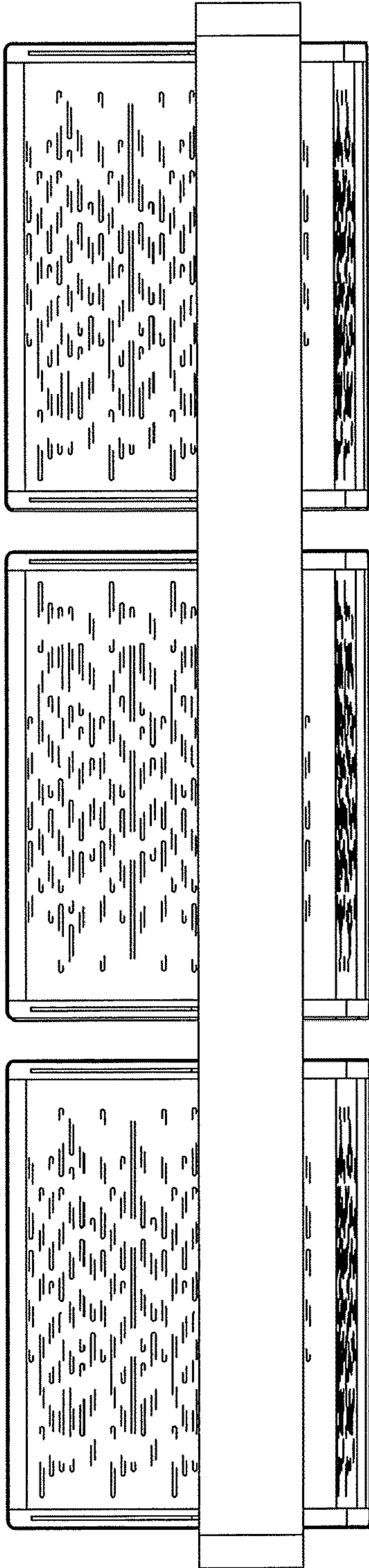

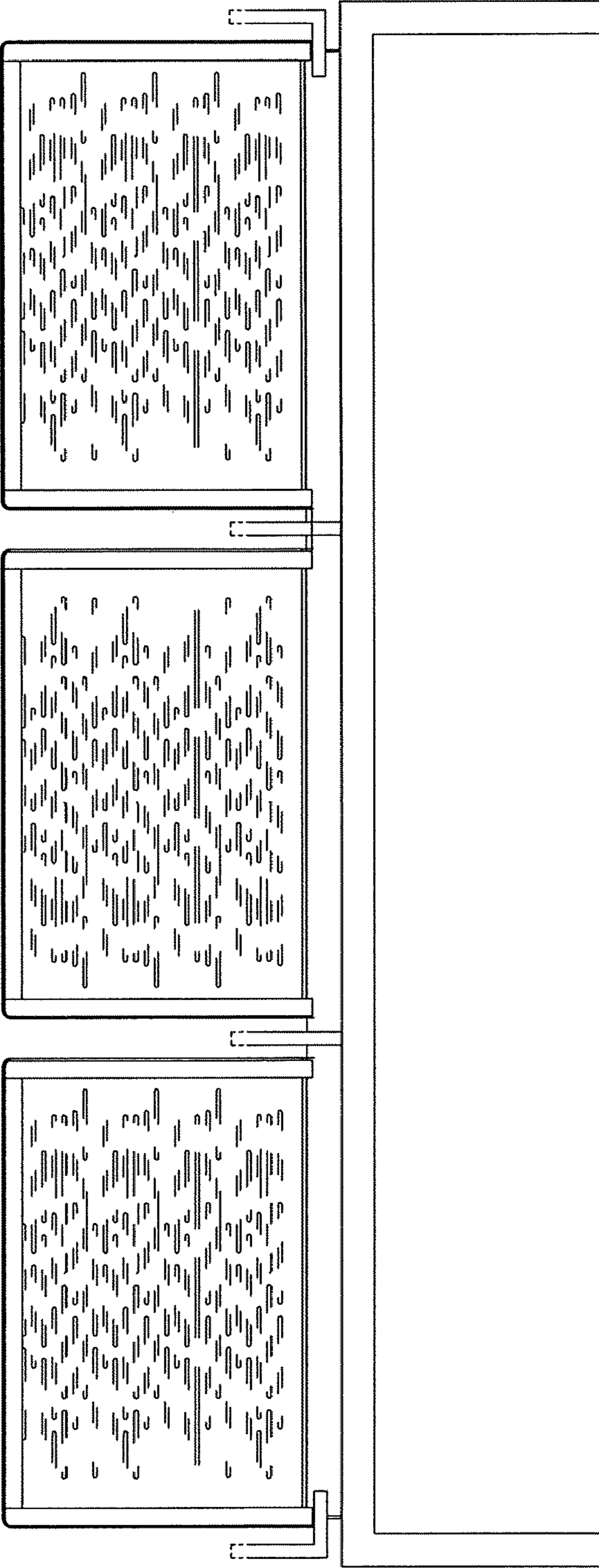

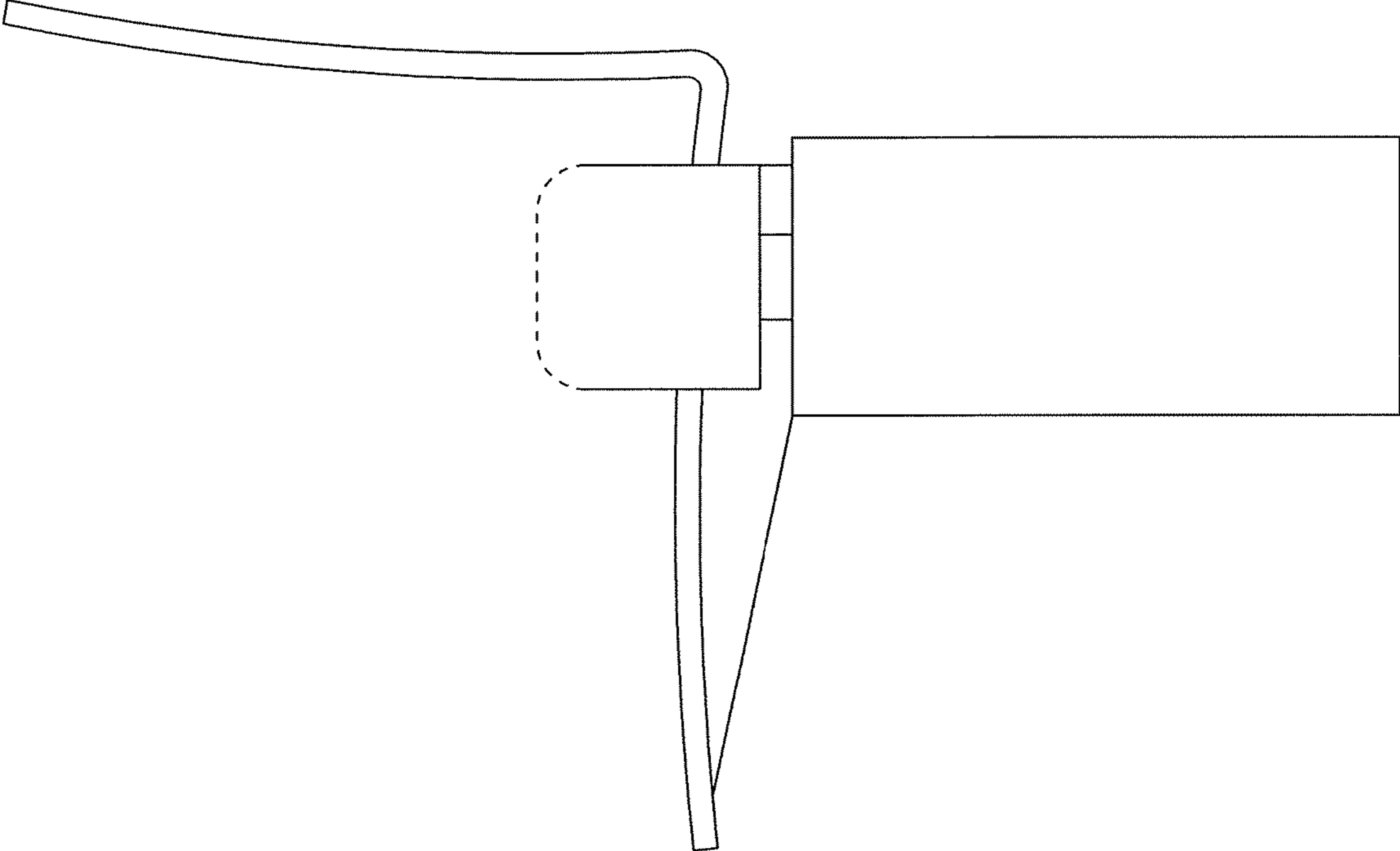

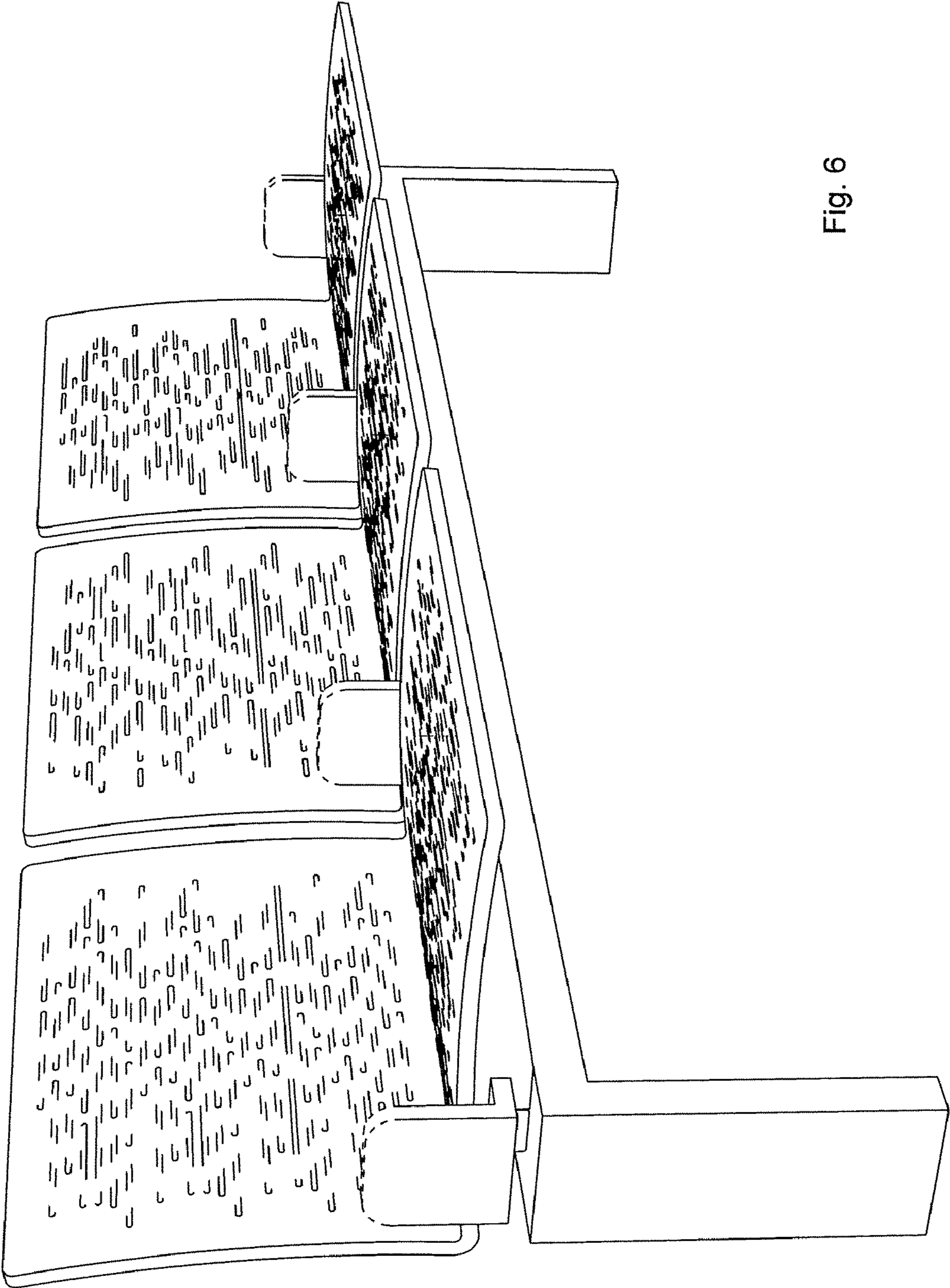

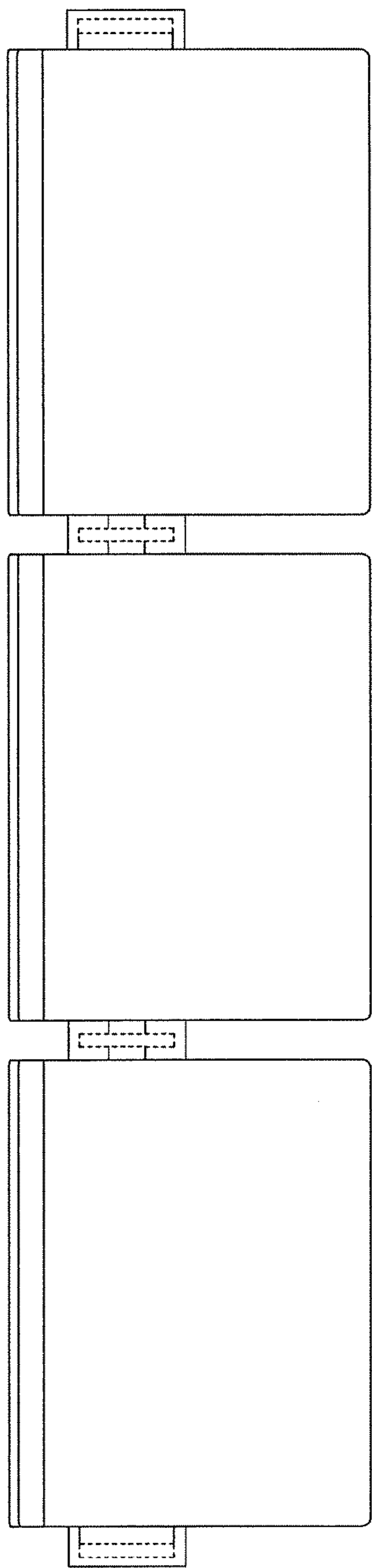

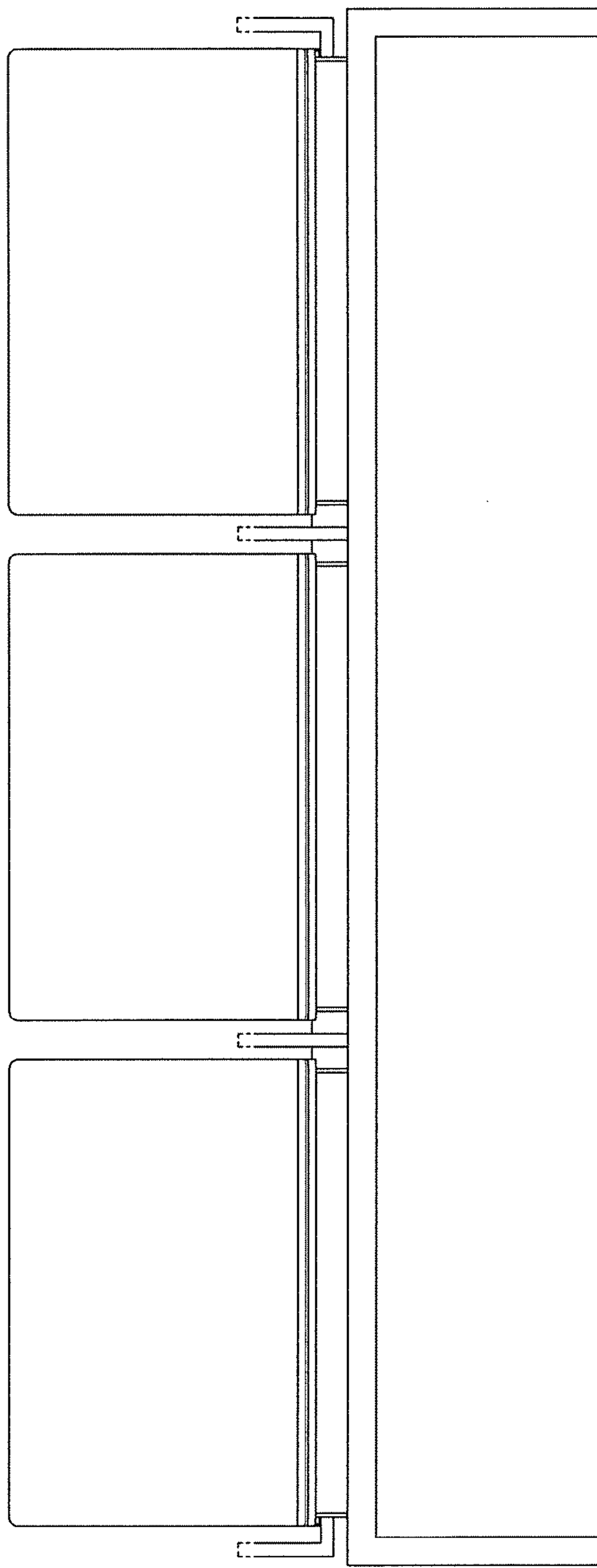

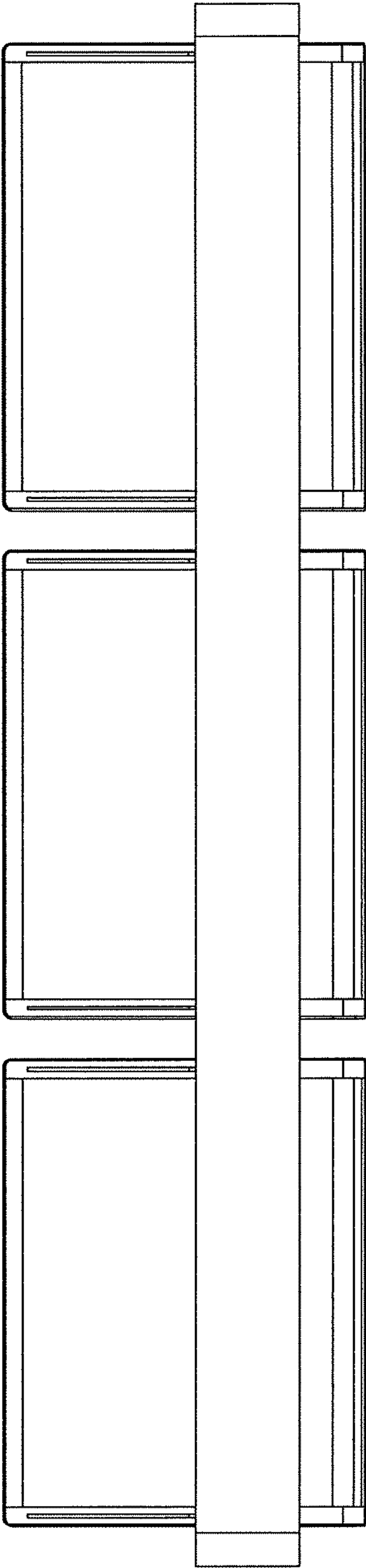

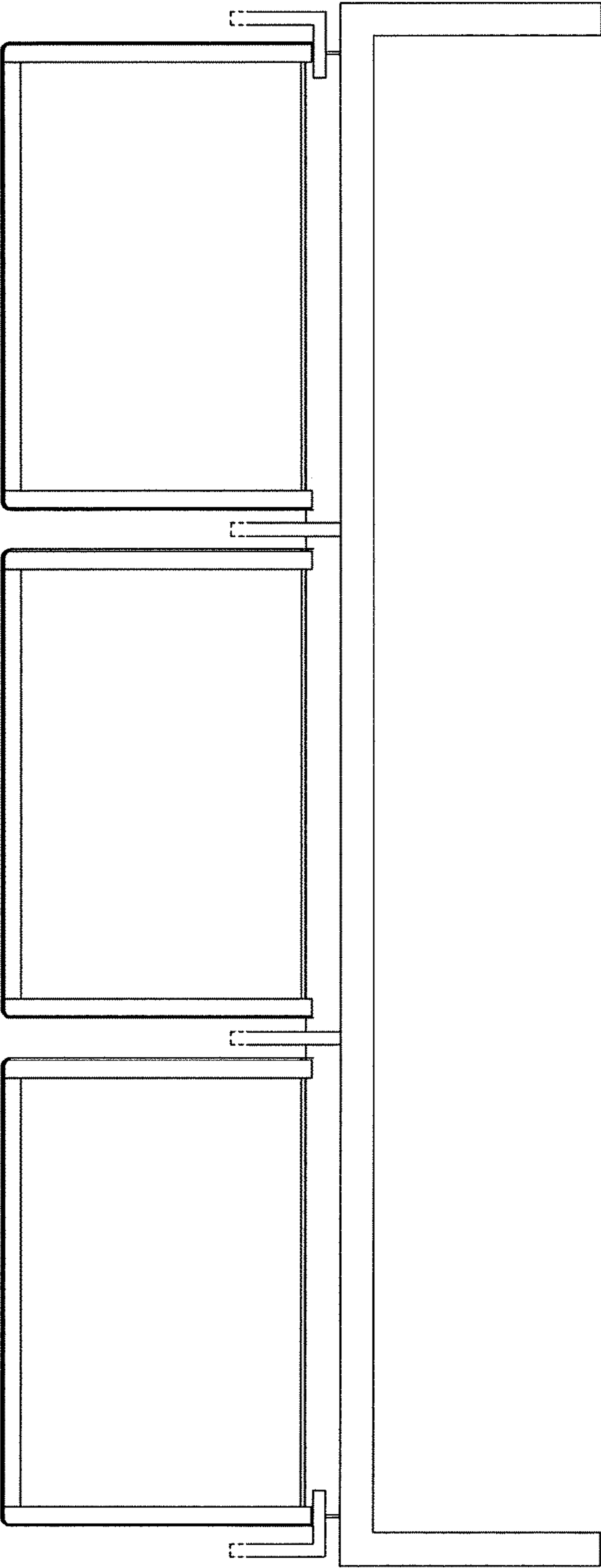

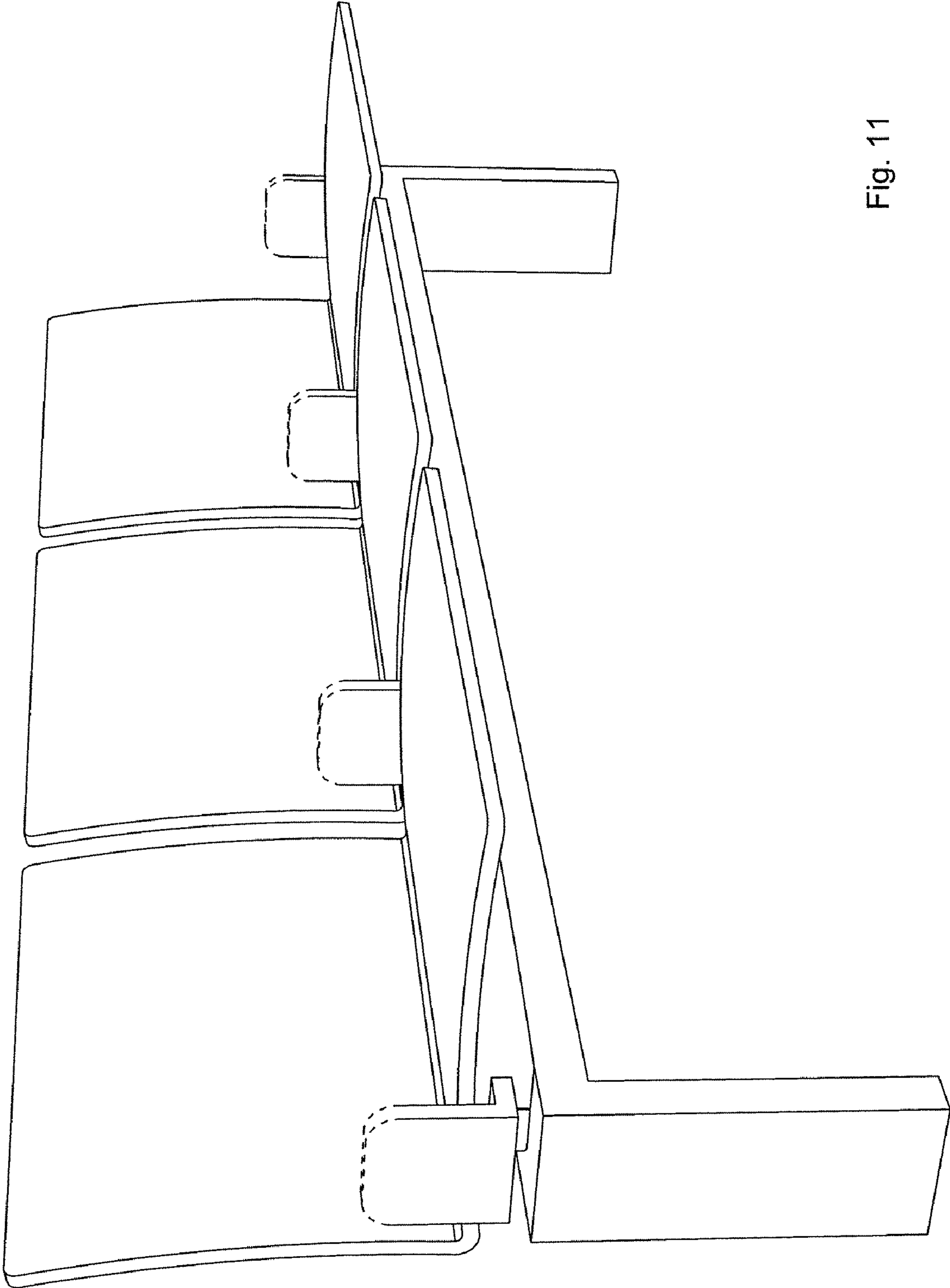
