(57) **CLAIM**

I claim the ornamental design for a dispenser, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view from above of a dispenser showing my new design;

FIG. 5 is a left side view of the claimed design of FIG. 1;

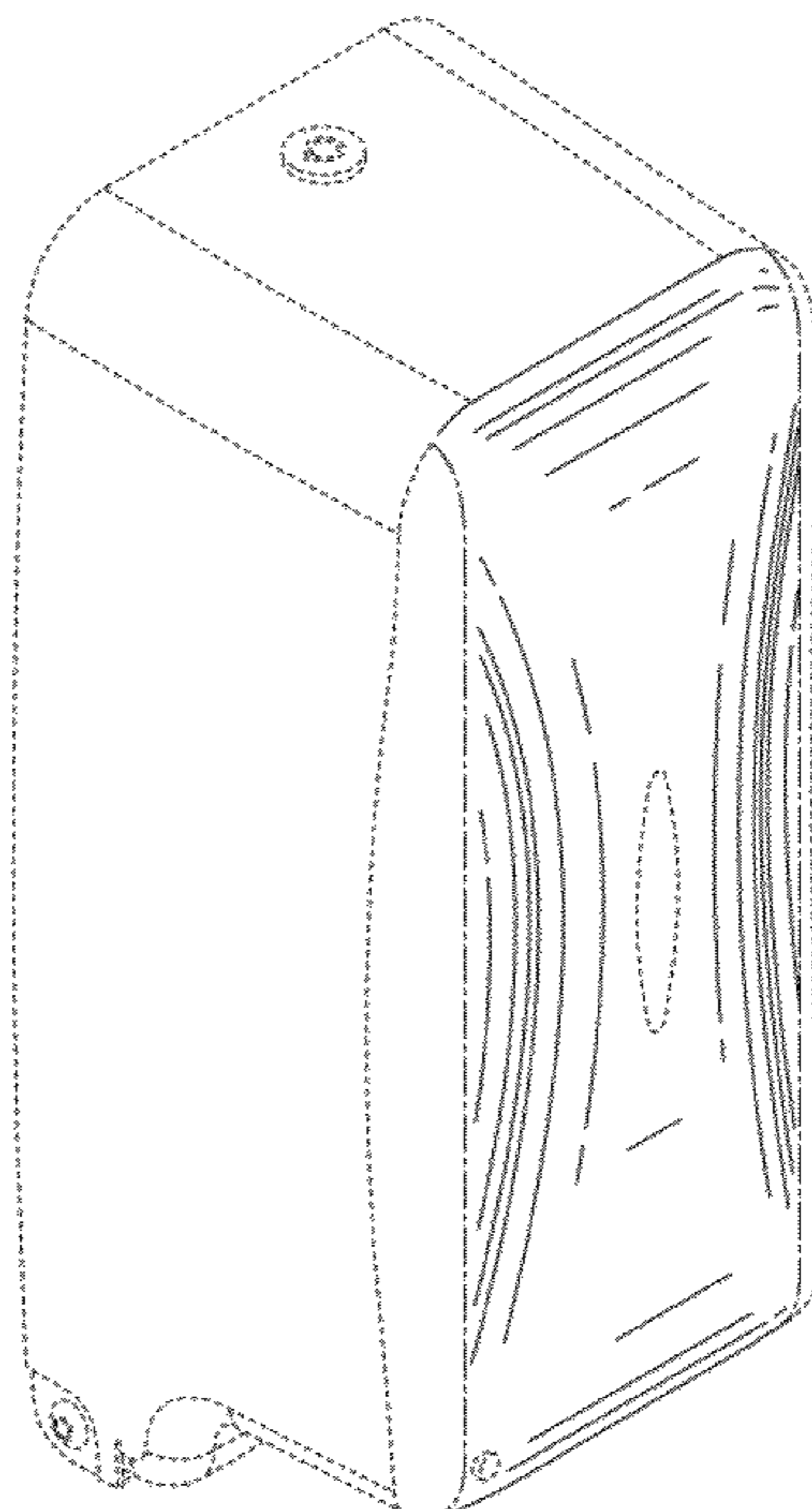
FIG. 6 is a right side view of the claimed design of FIG. 1;

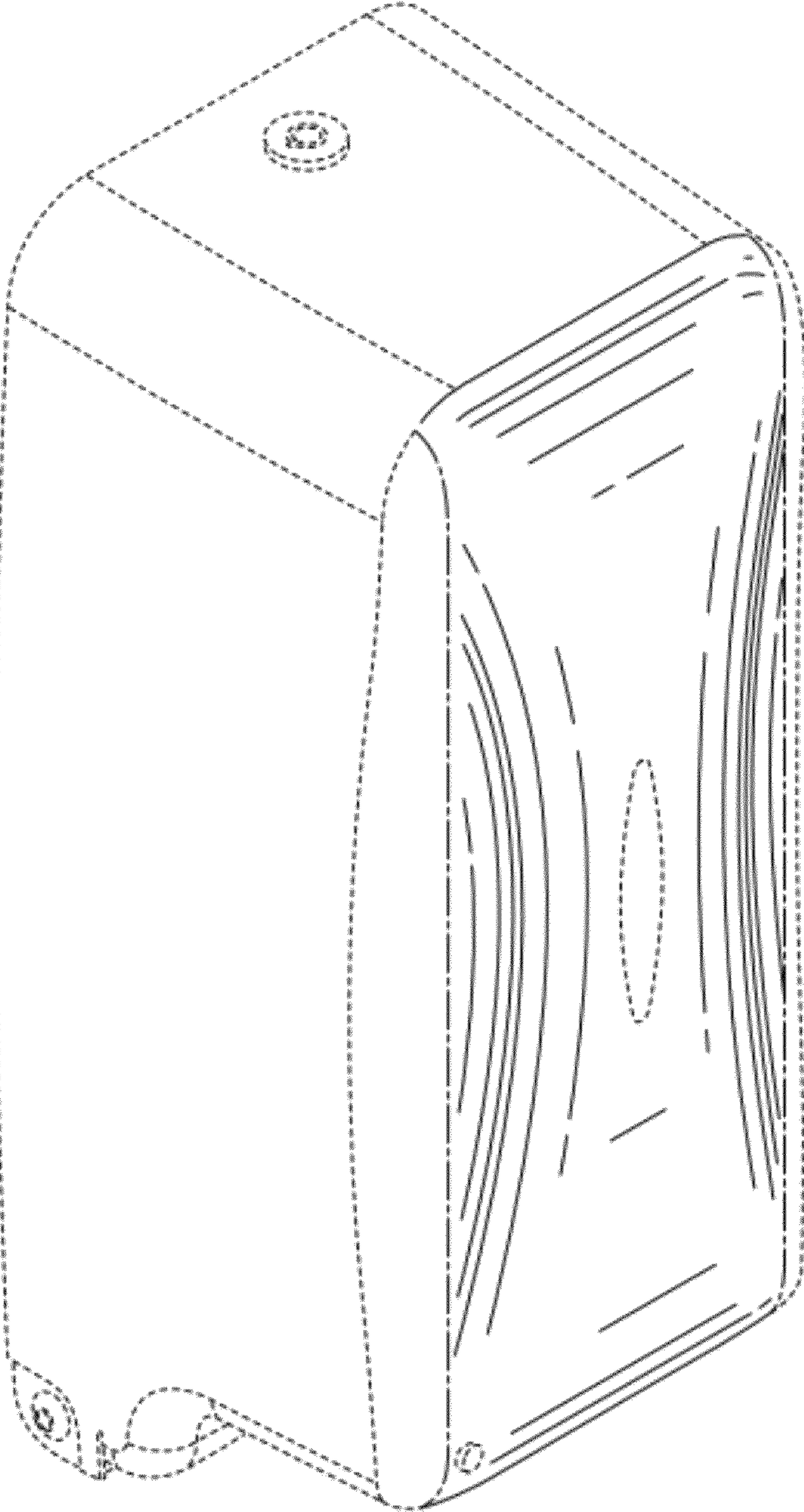

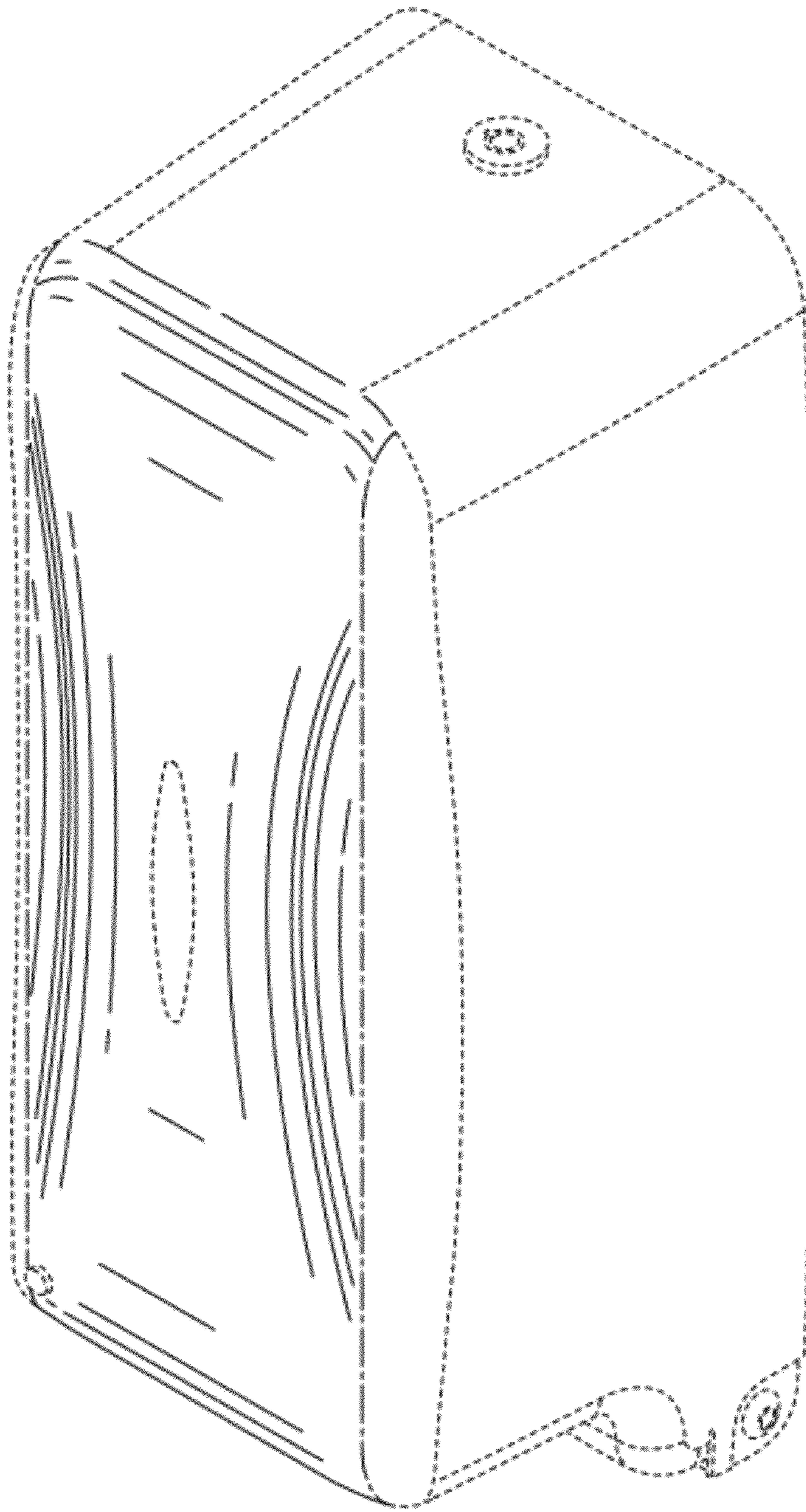

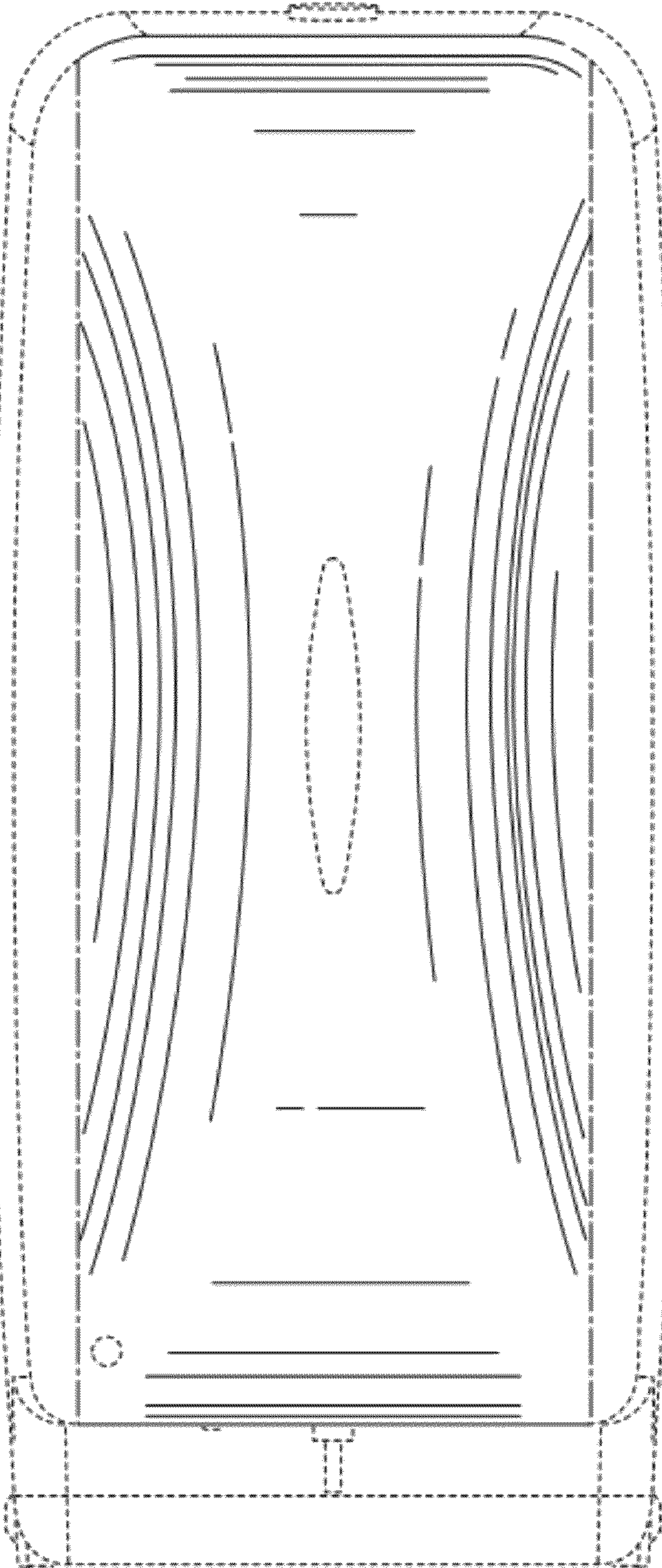

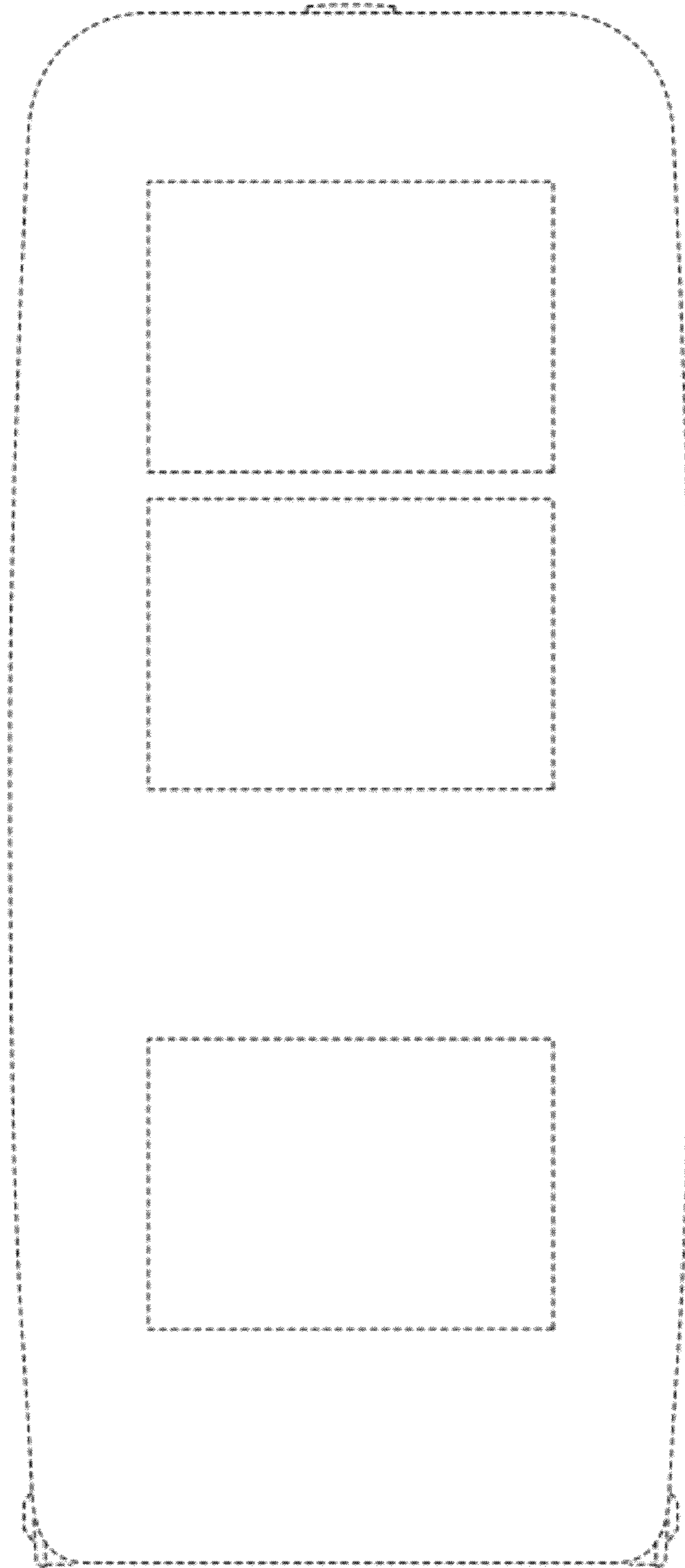

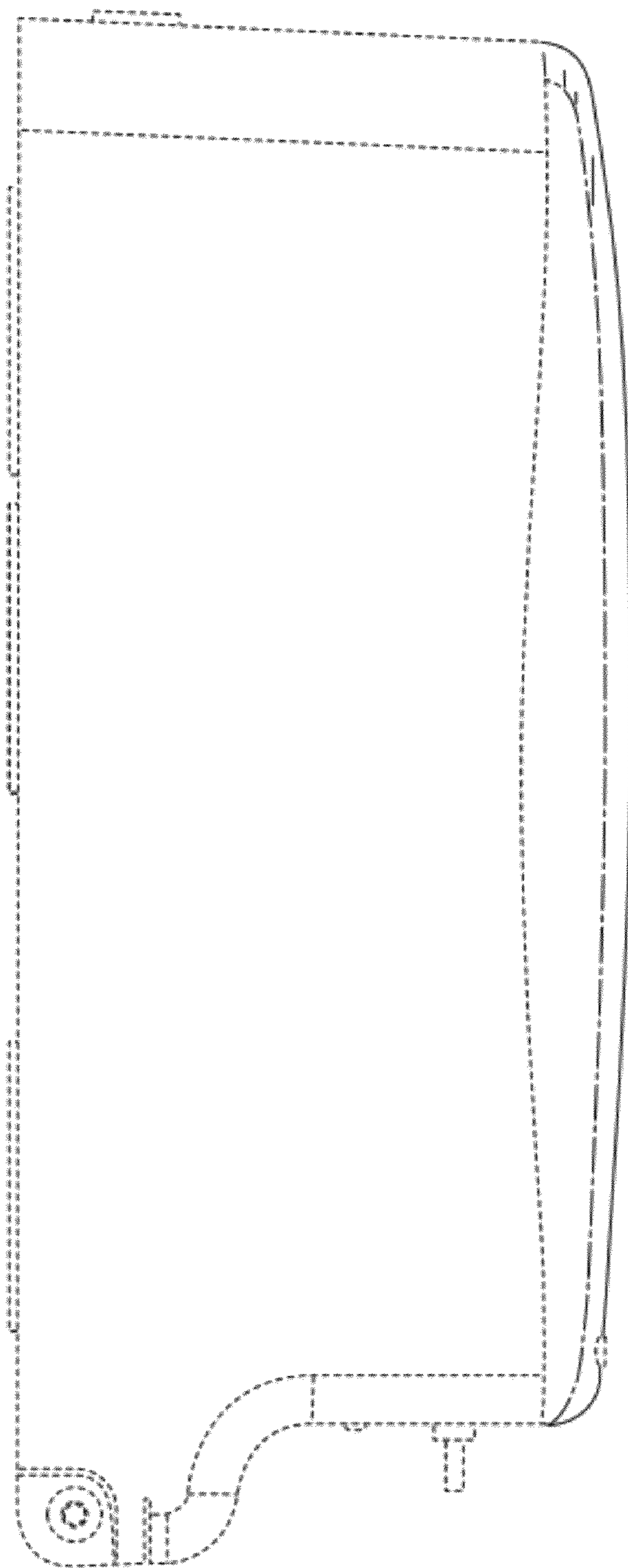

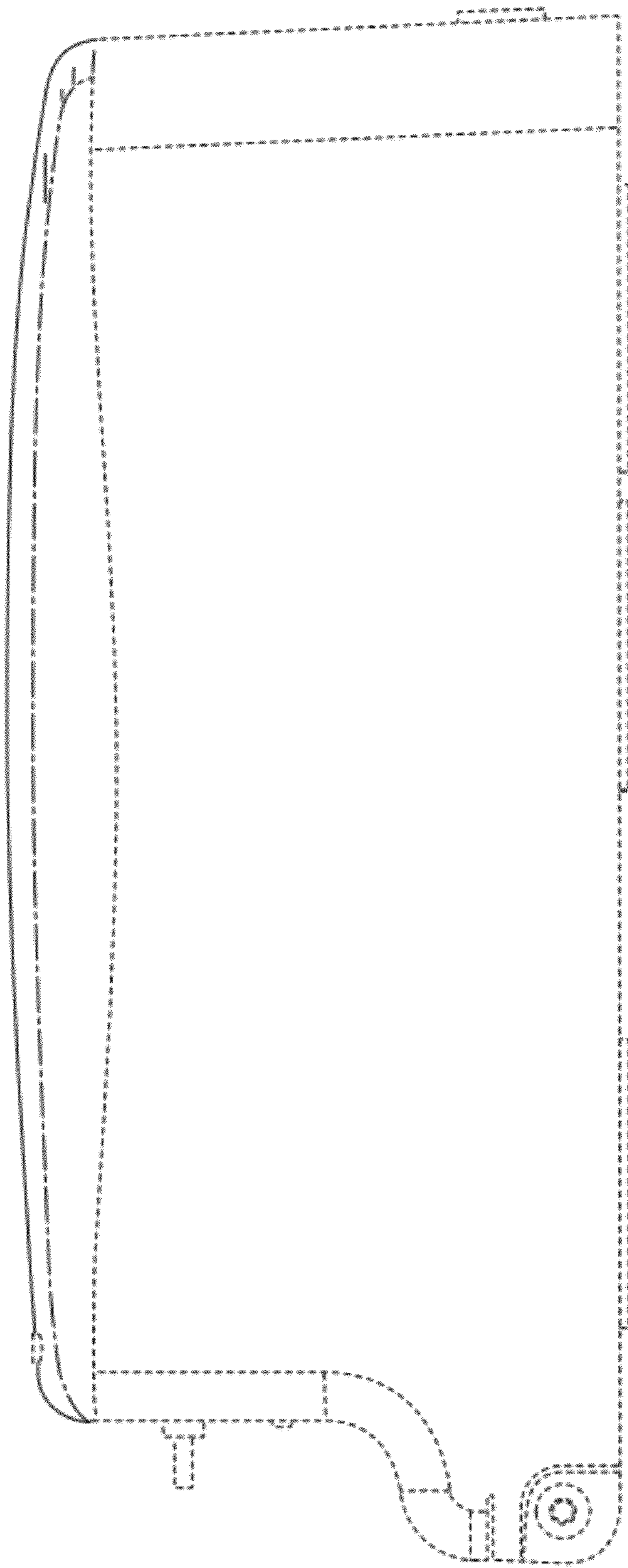
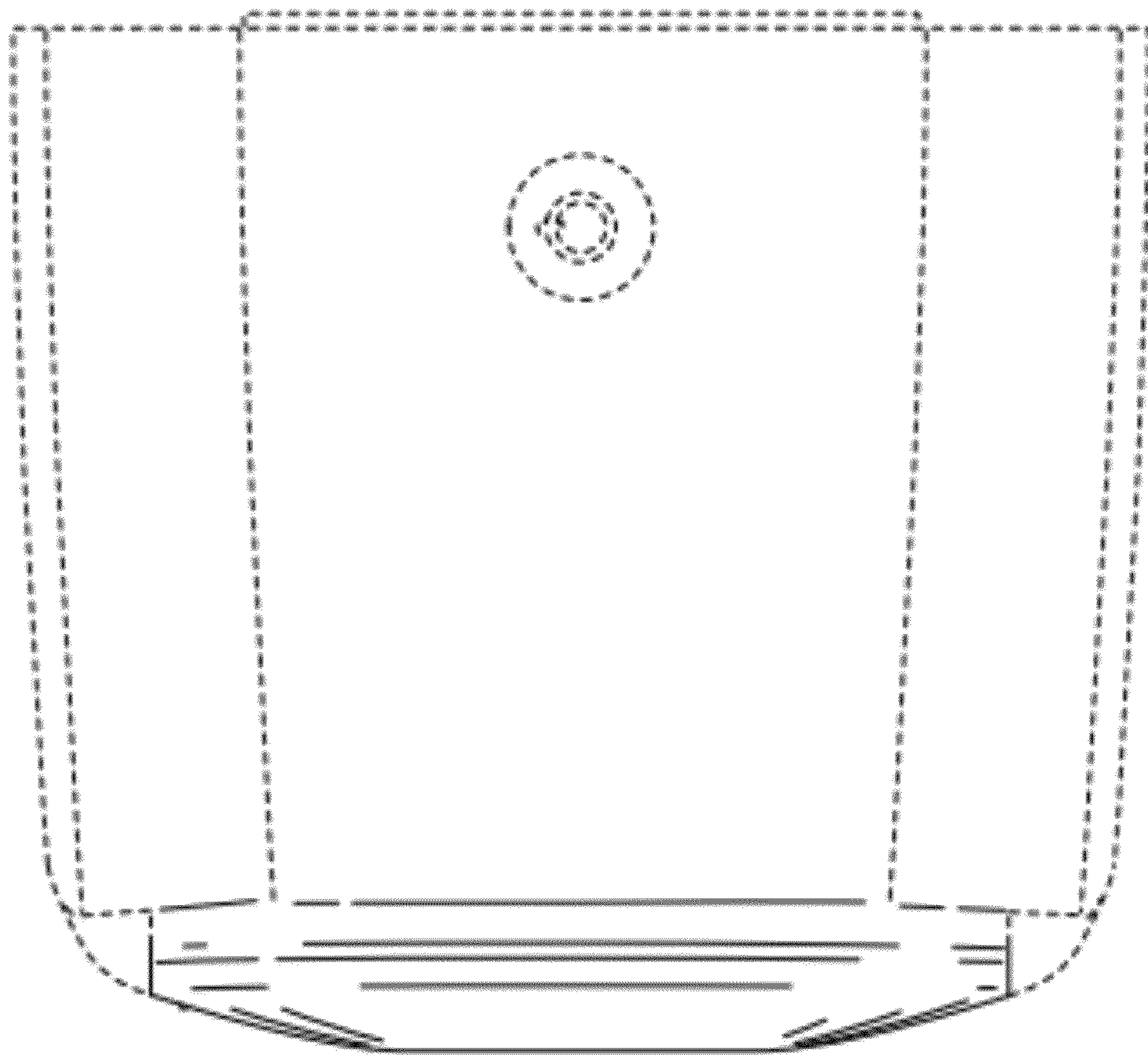
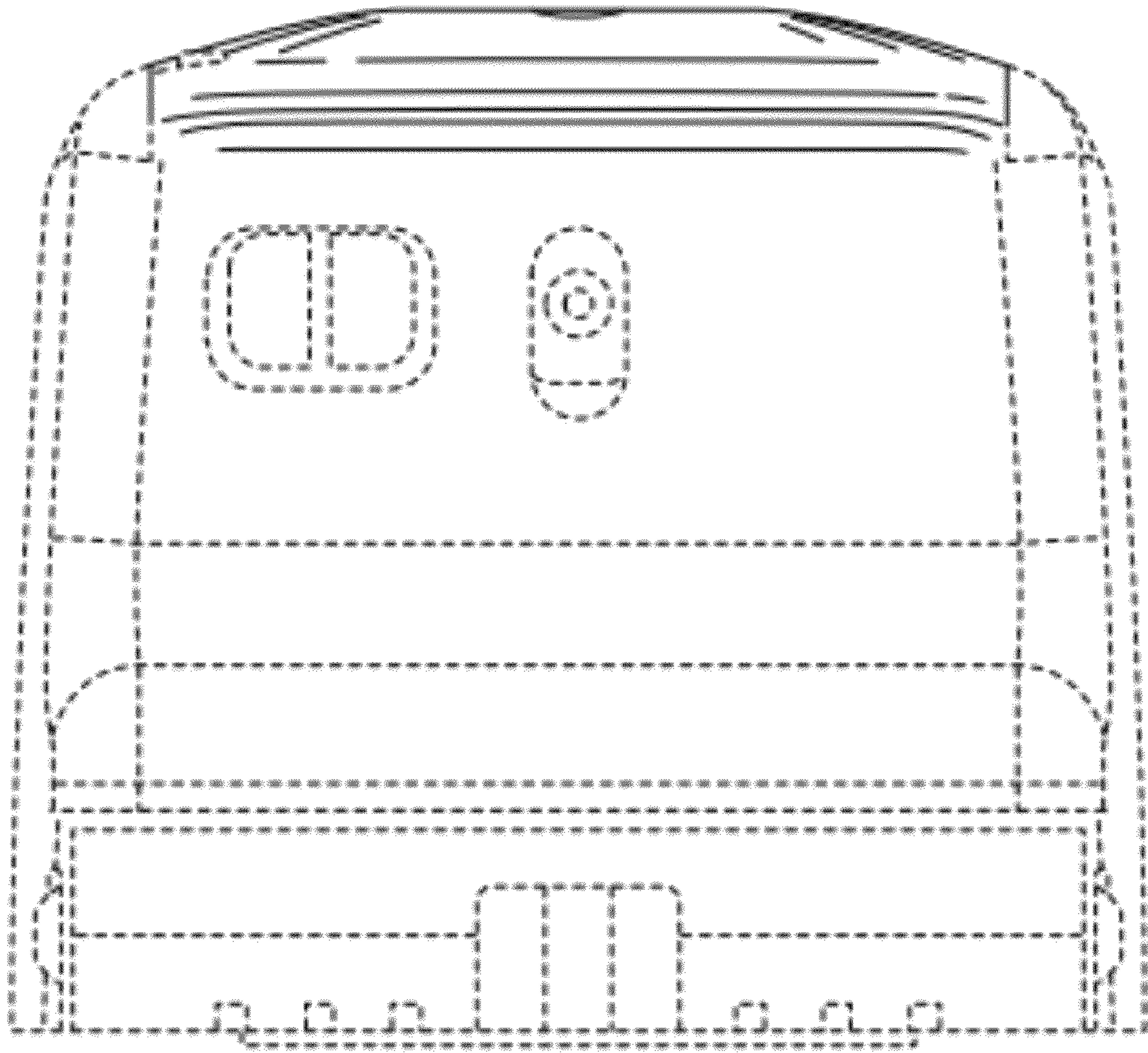
