FIG. 4 is a right side view of the claimed design;

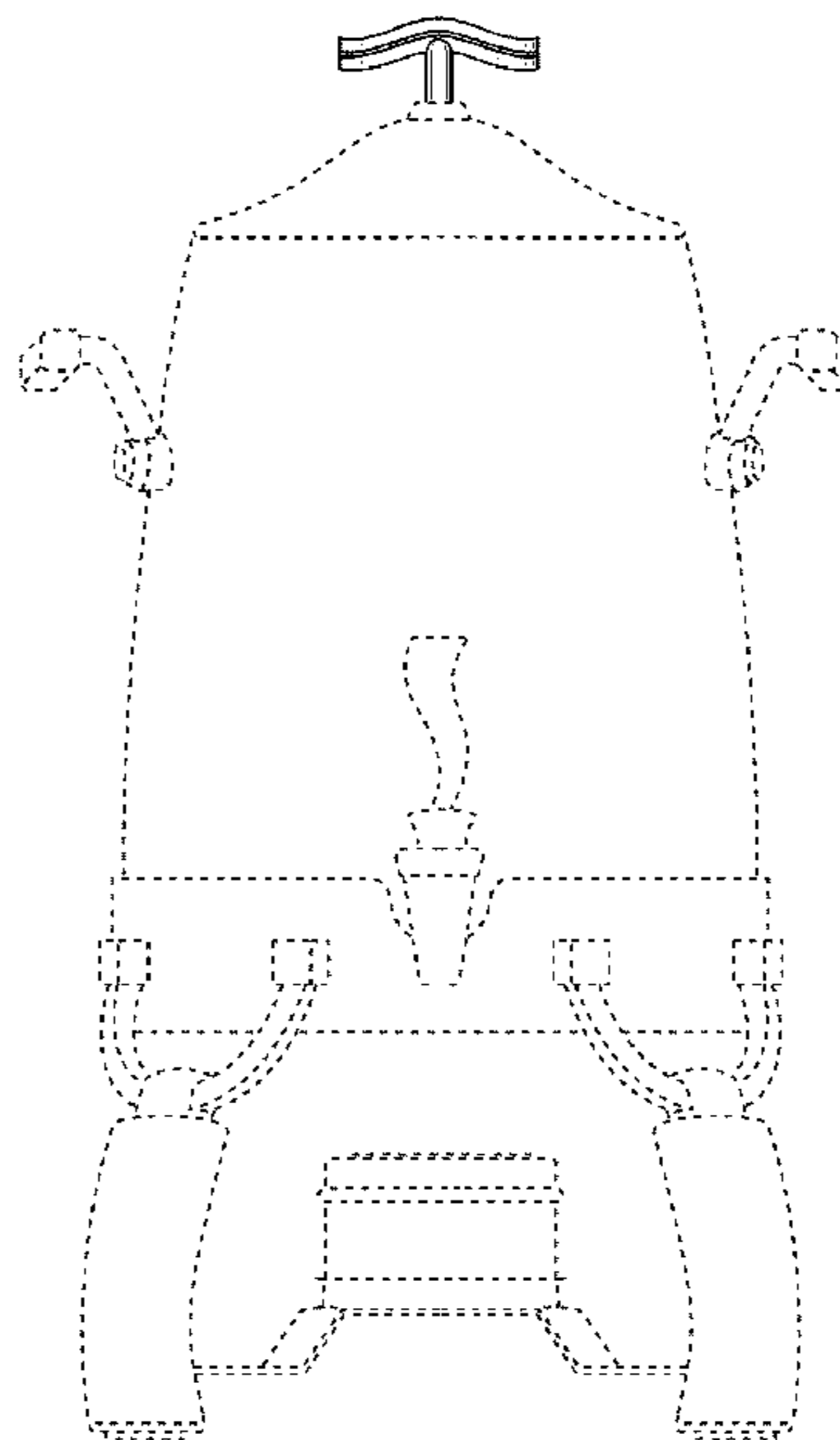
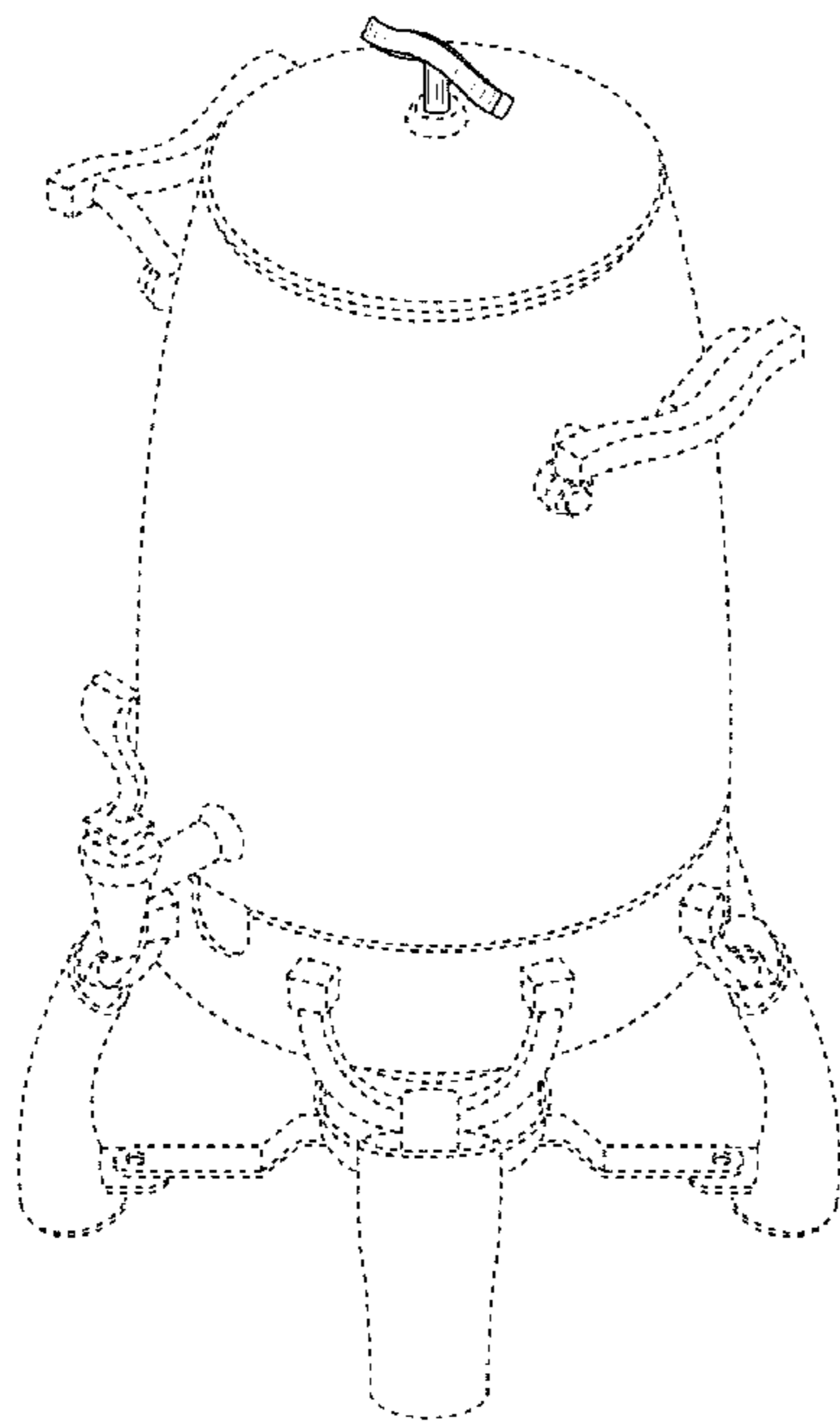
FIG. 5 is a left side view of the claimed design;

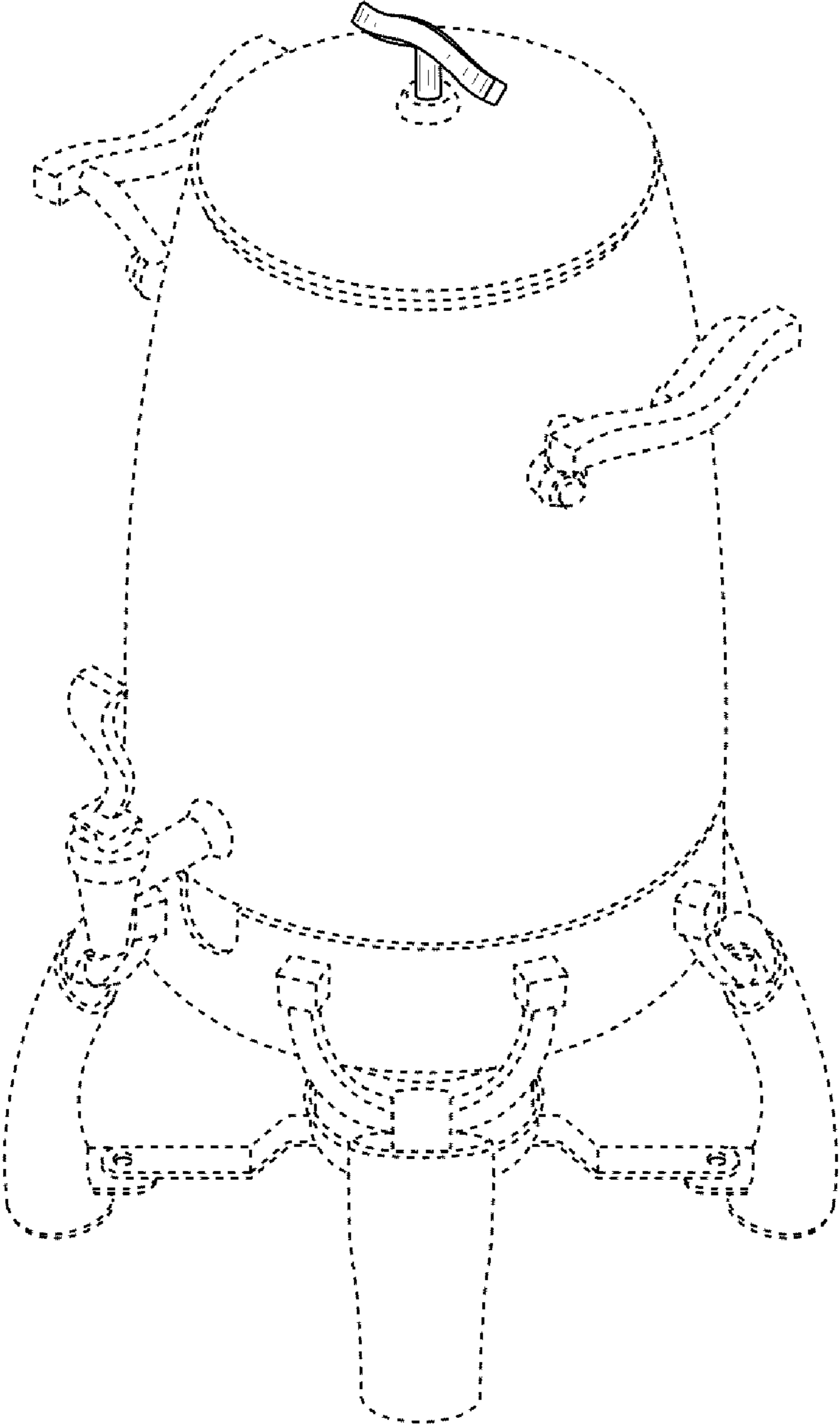

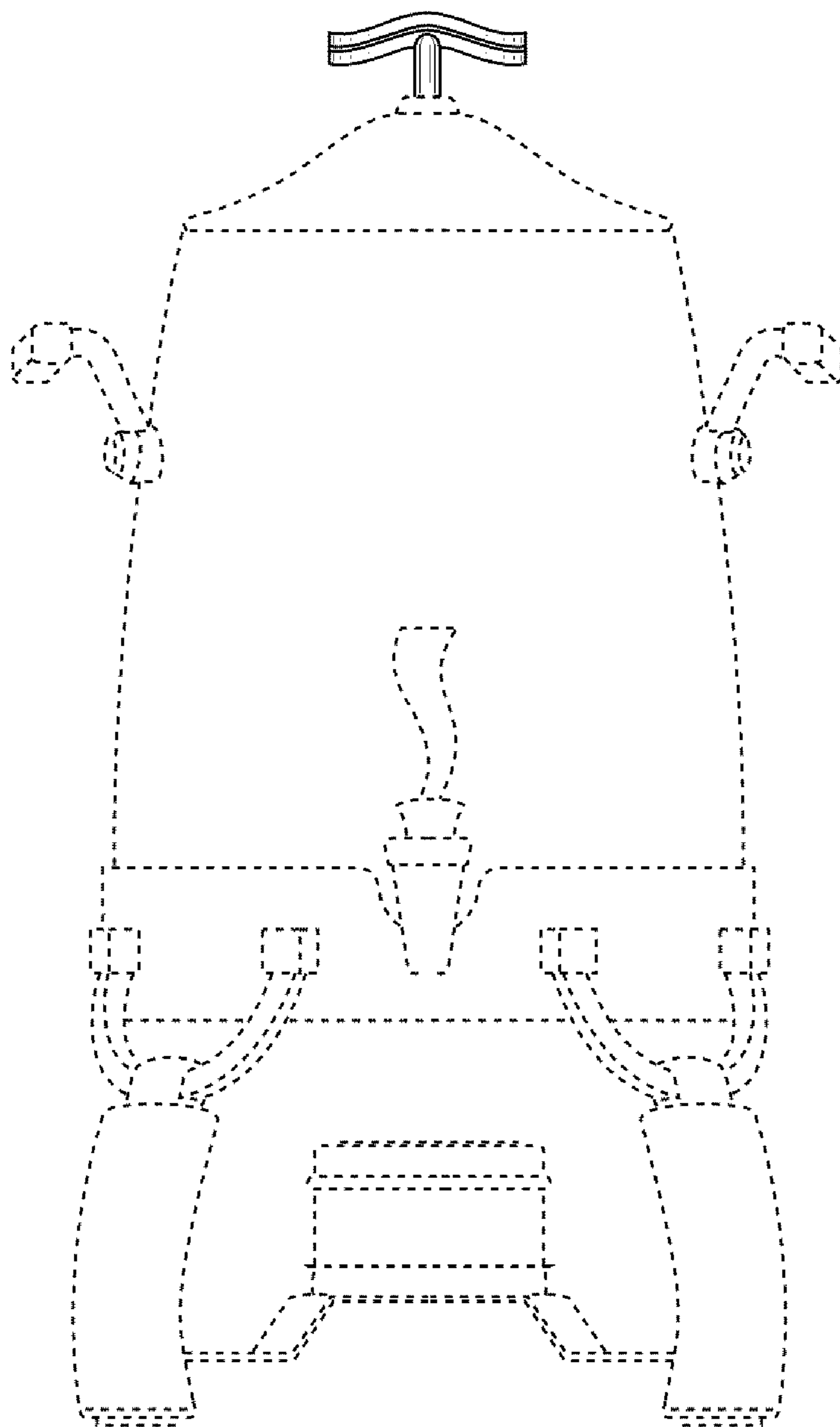

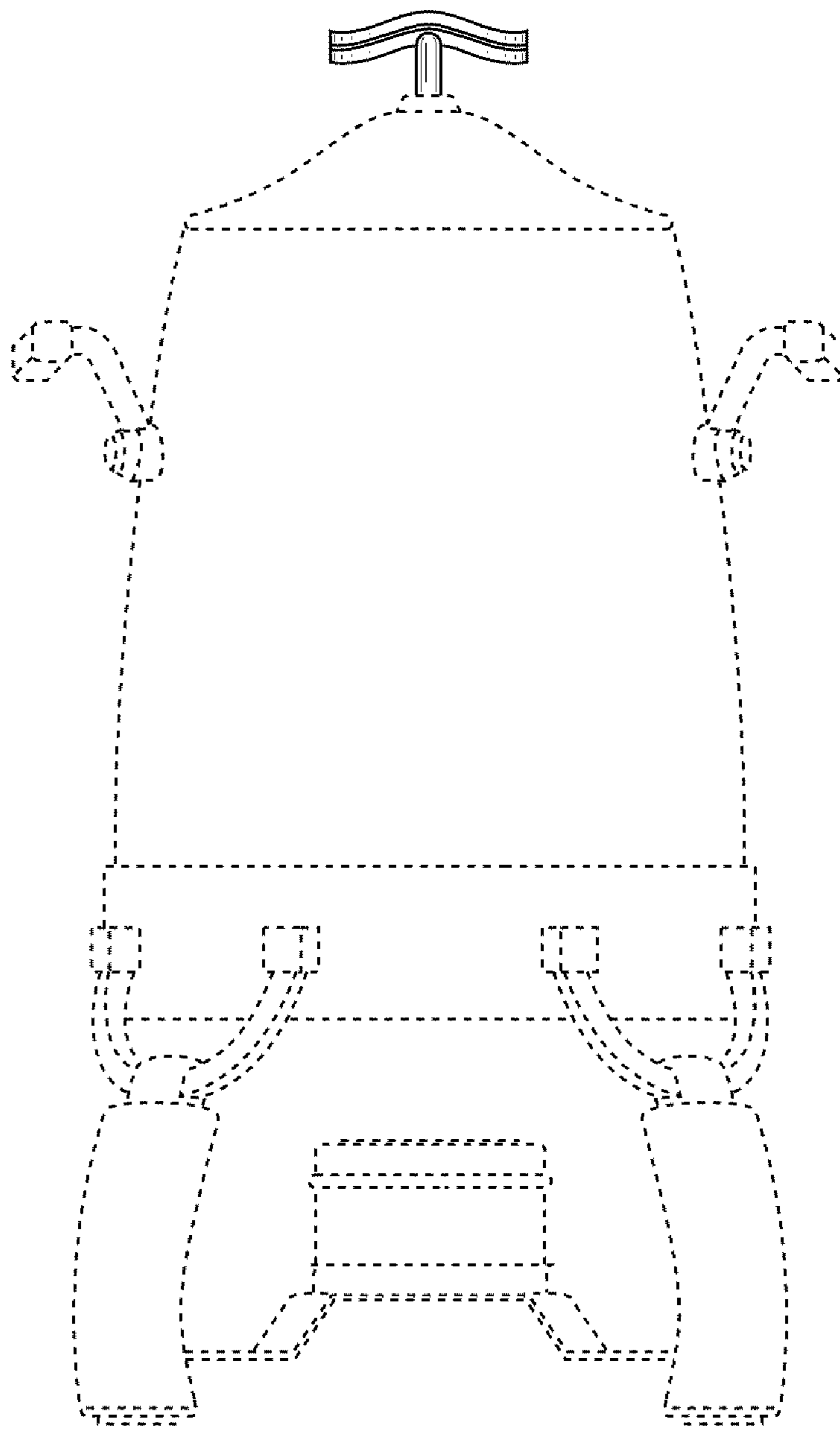

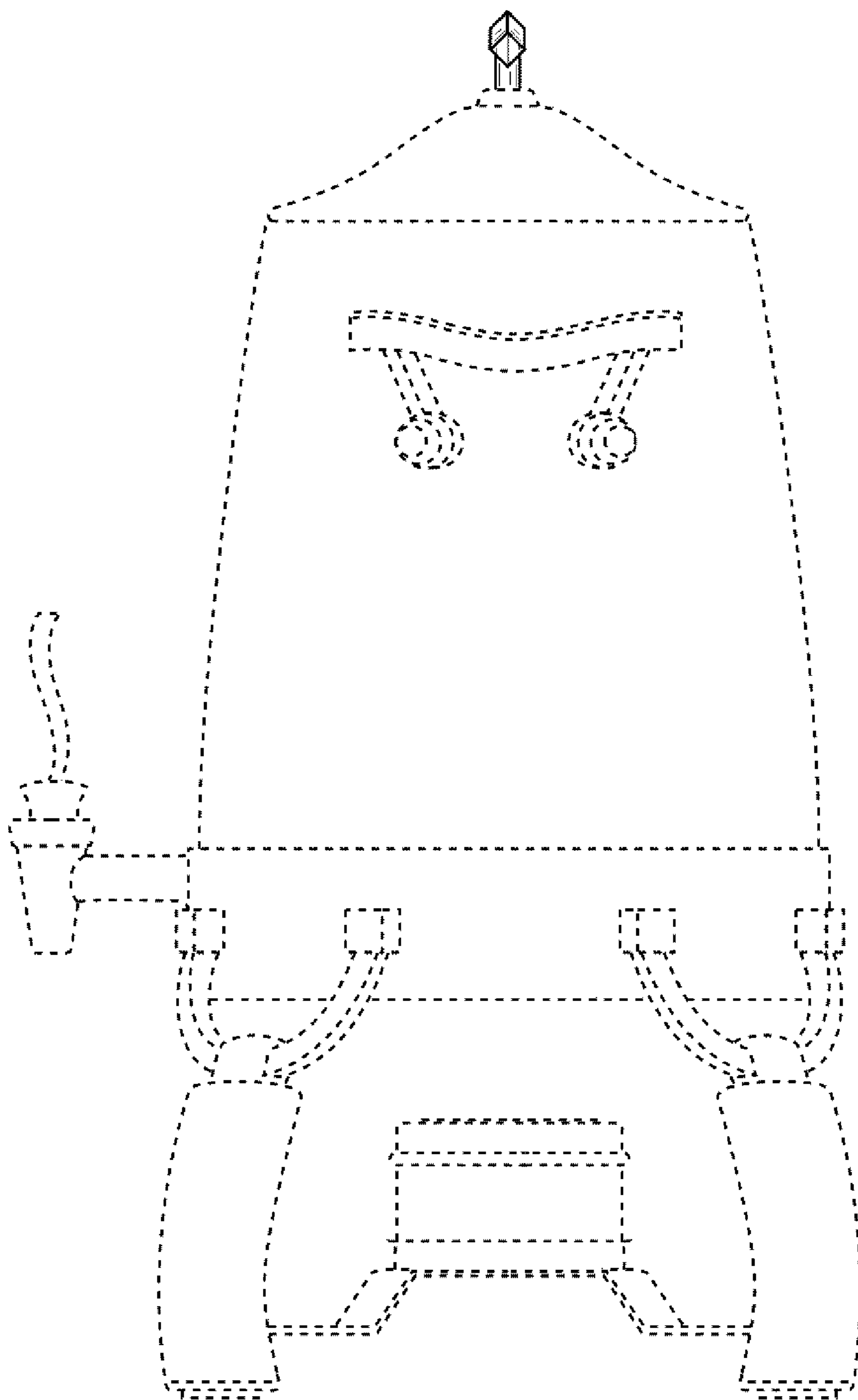

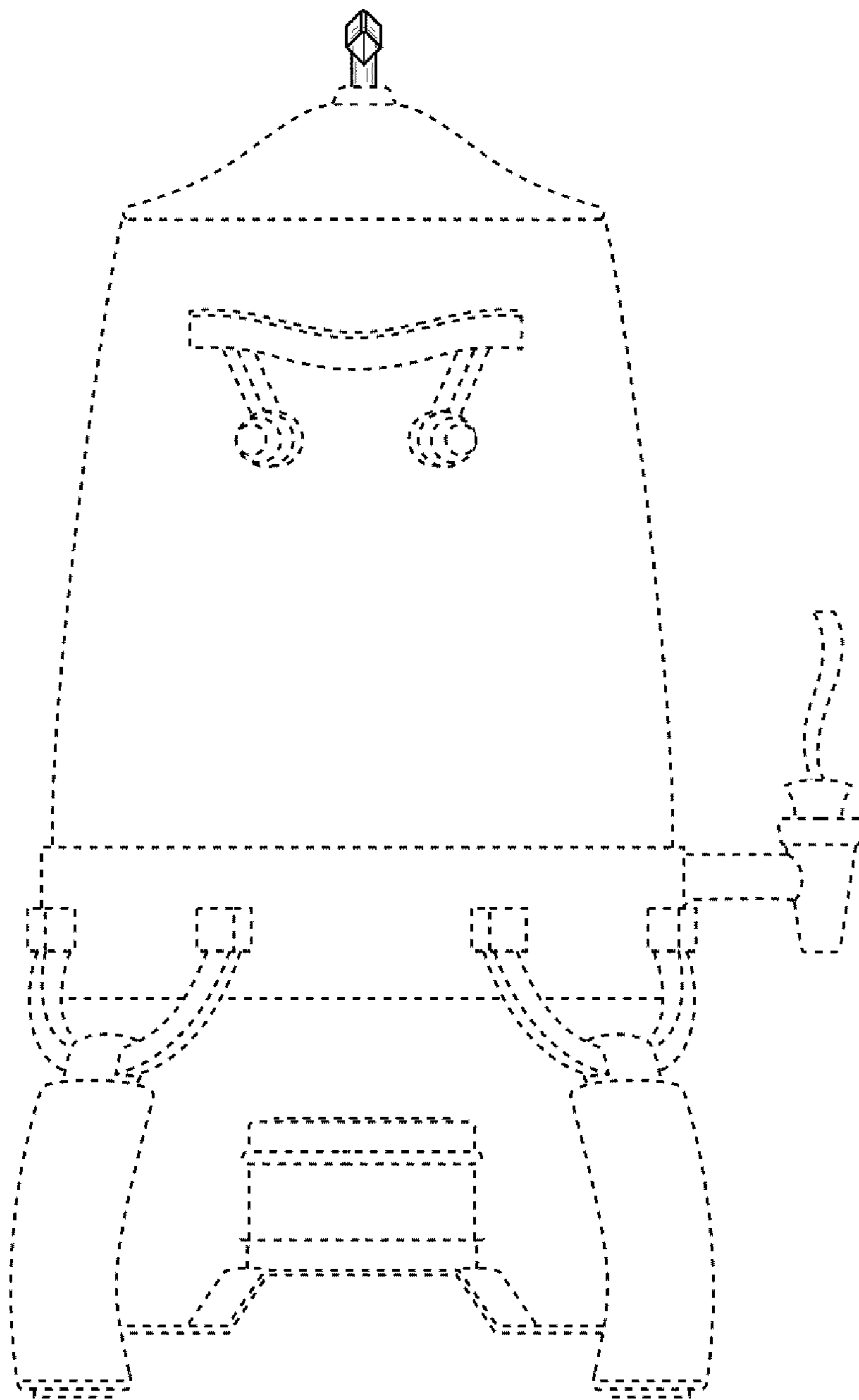

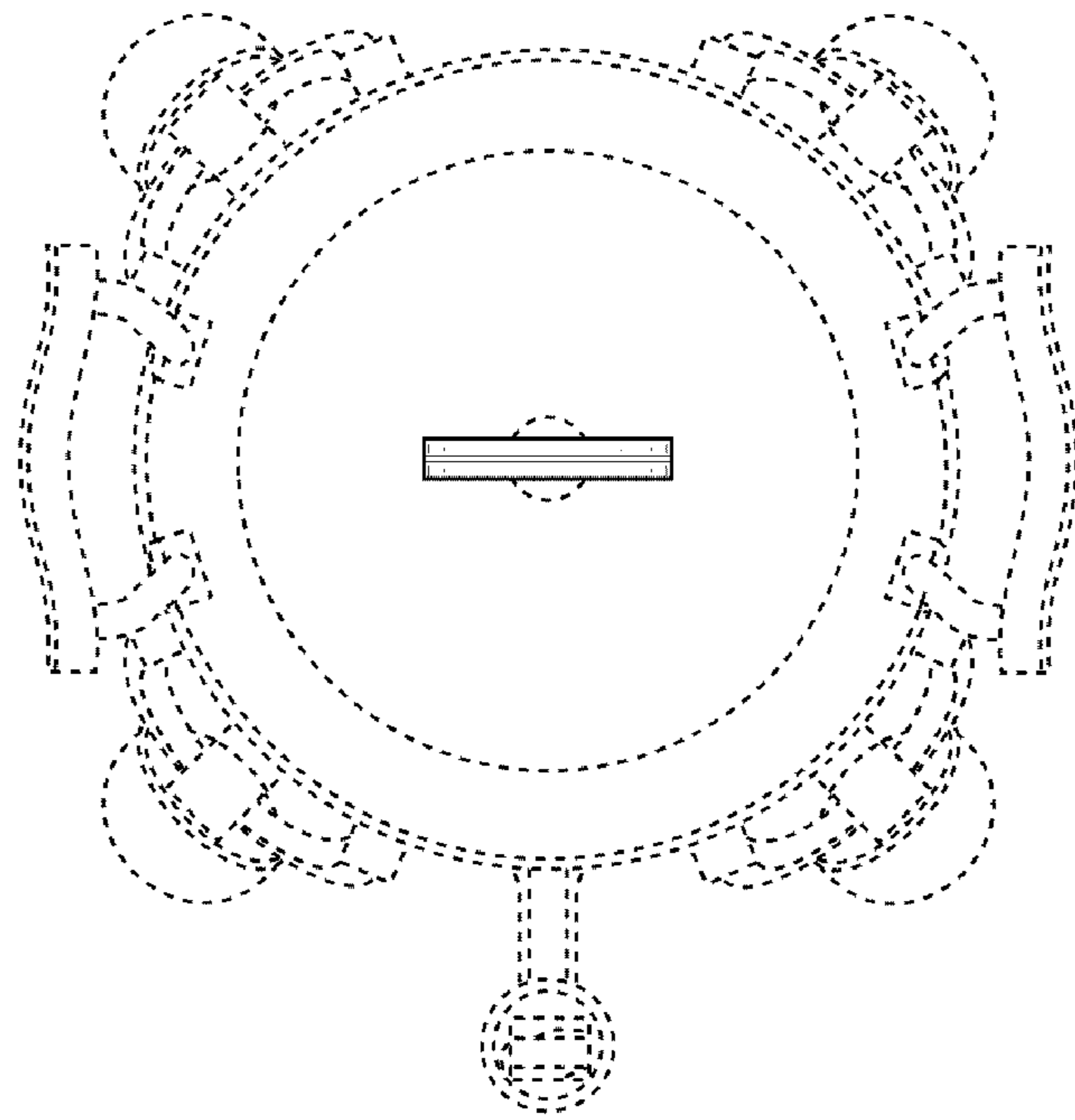

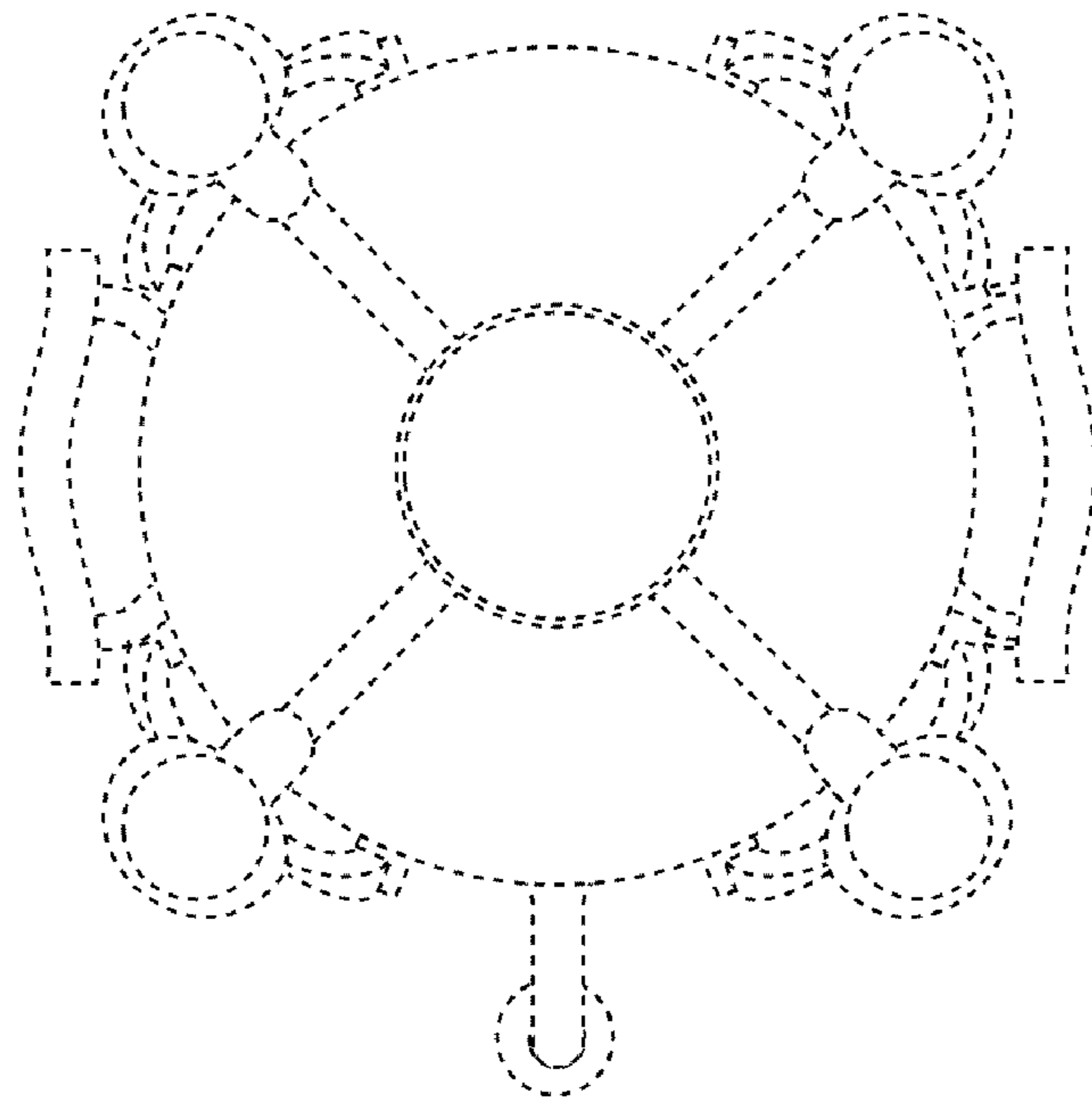
