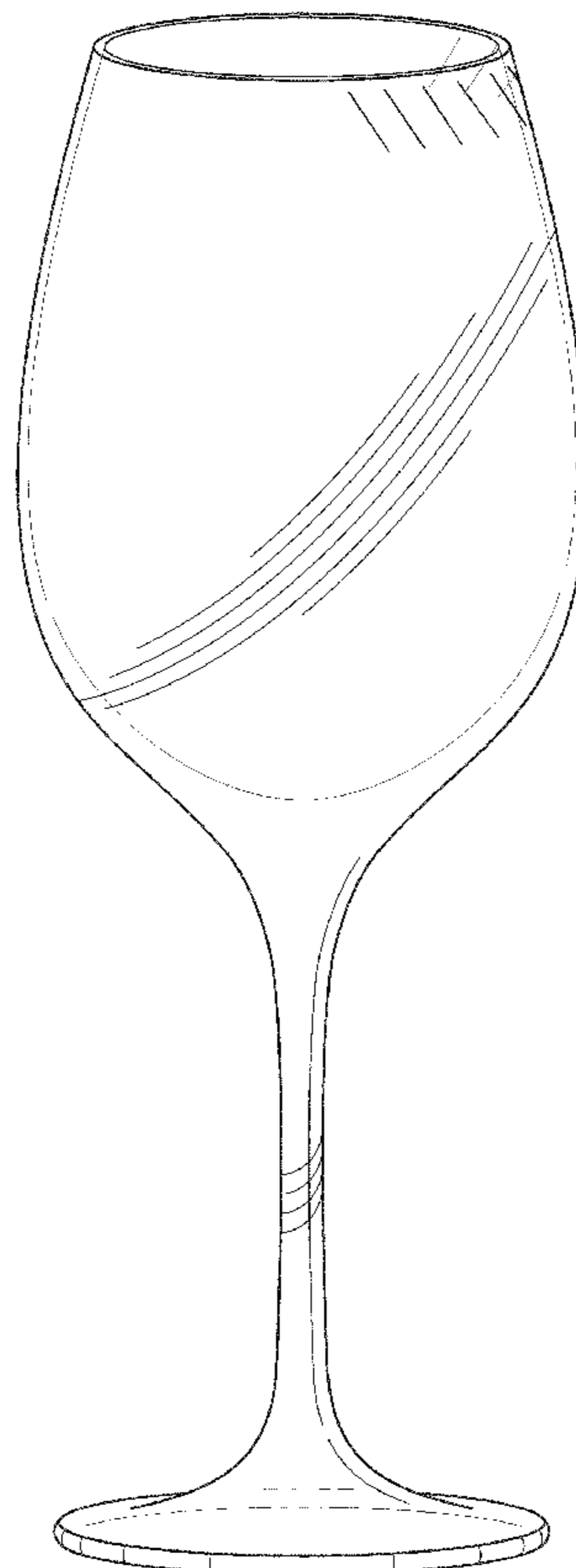
(57) **CLAIM**

The ornamental design for a wine glass with textures at the rim, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view from above of a wine glass with textures at the rim, incorporating the design;

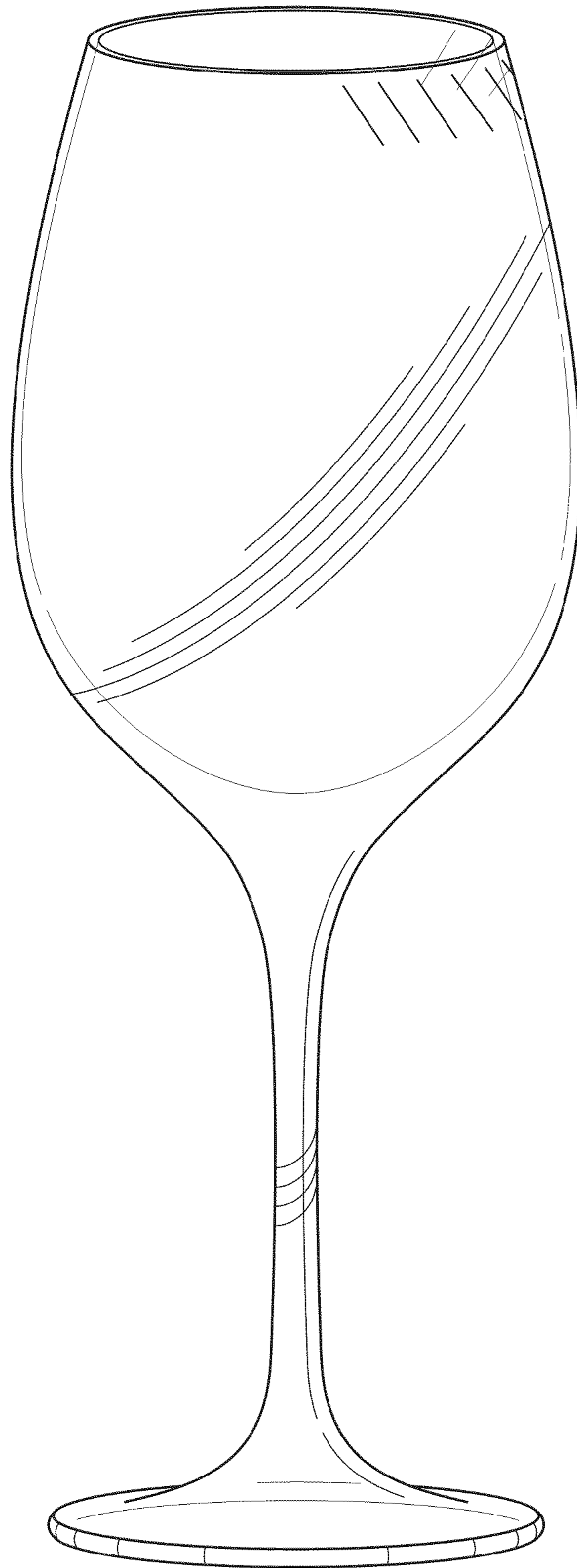

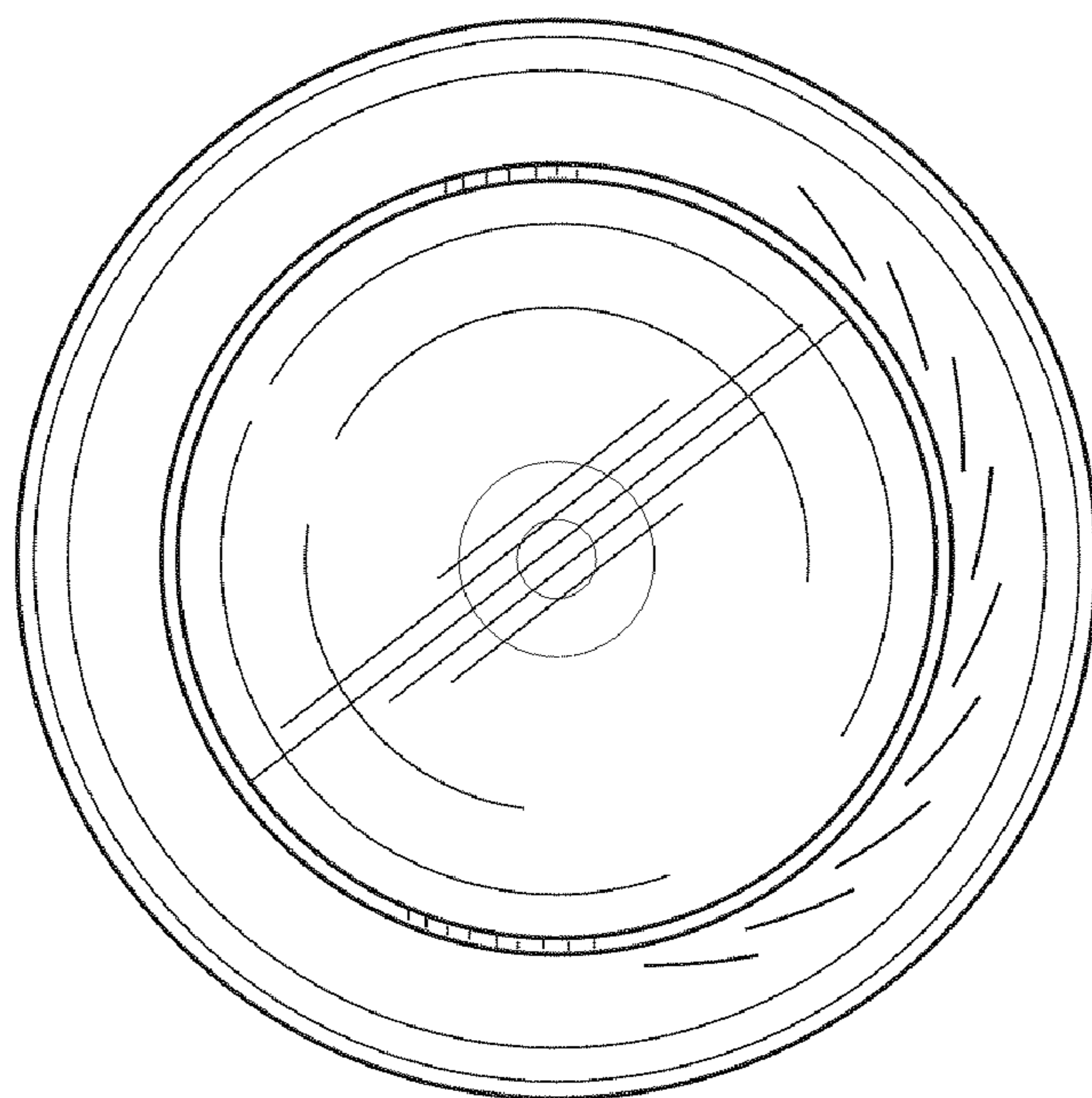

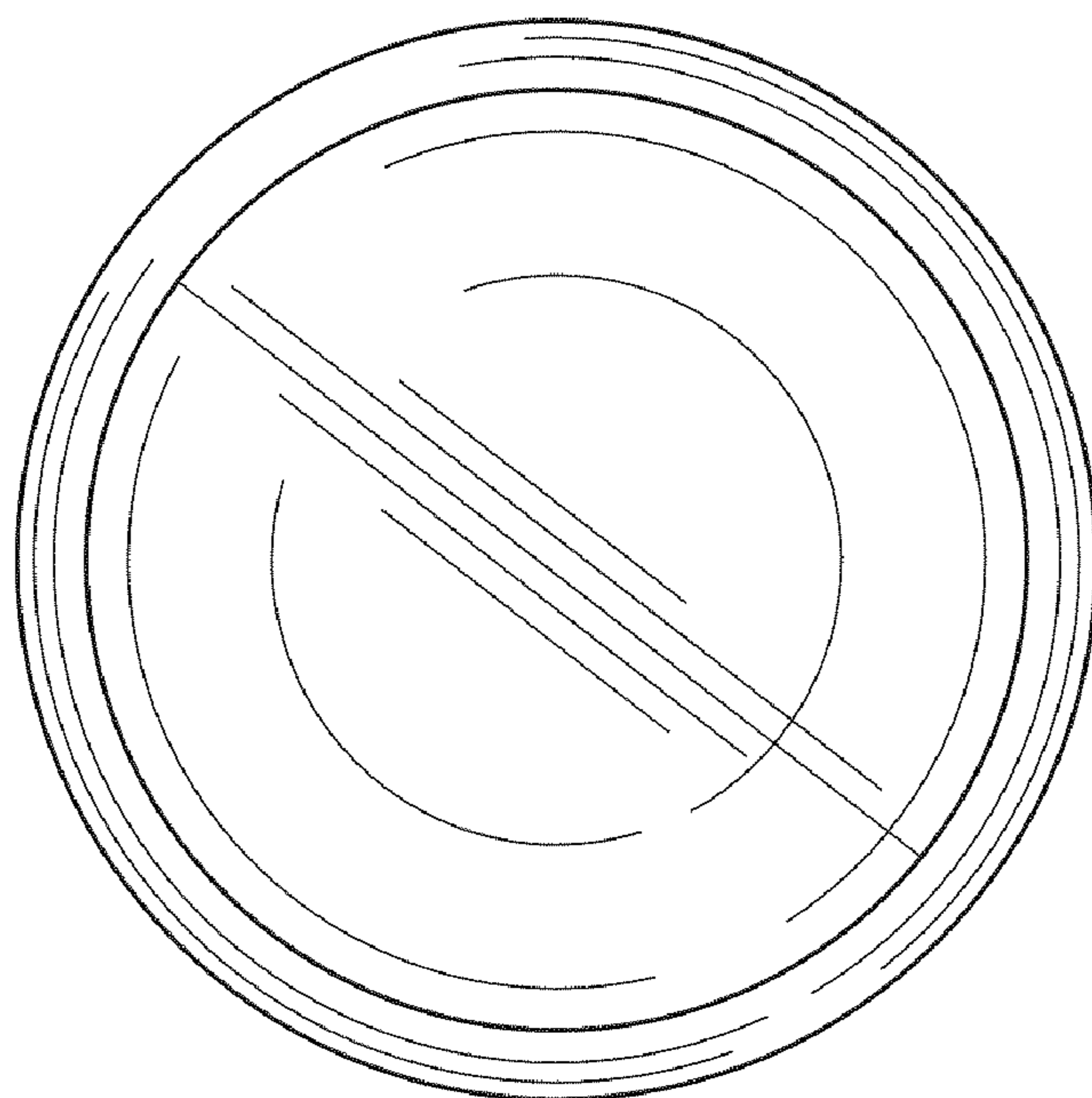

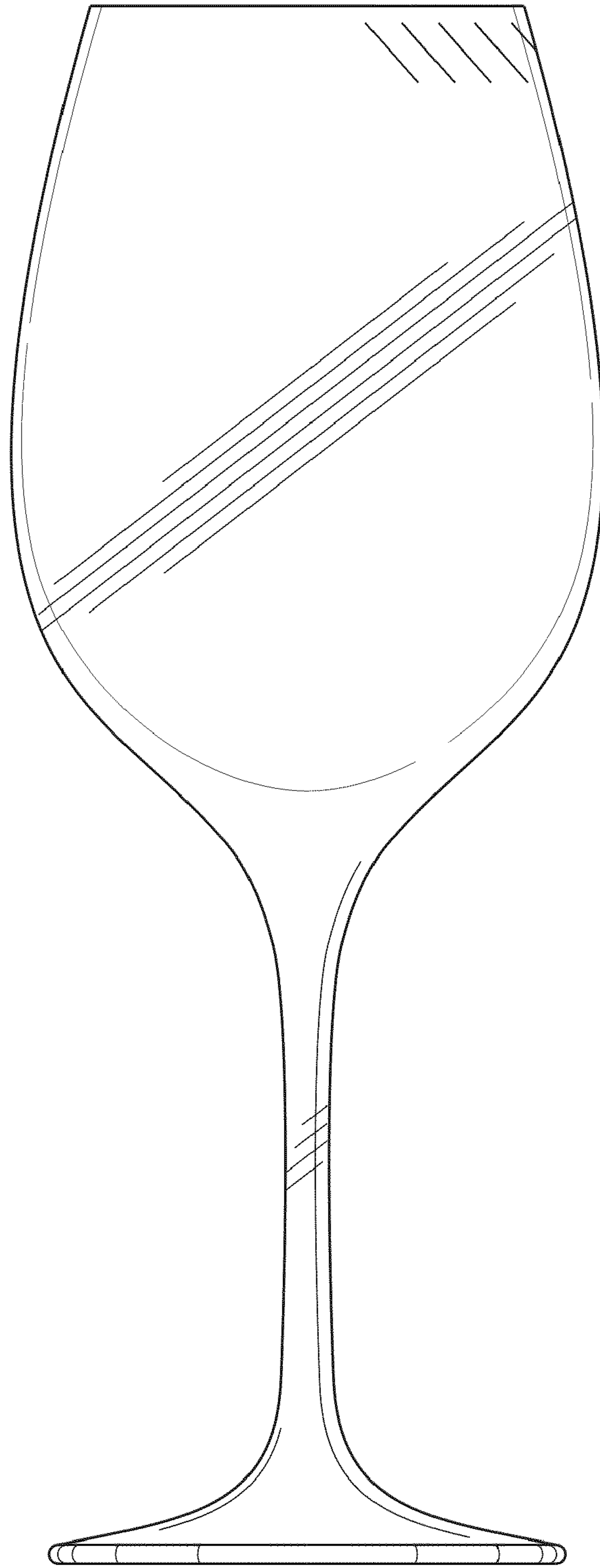
