FIG. 4 is a top view of a beverage pouch according to the present invention;

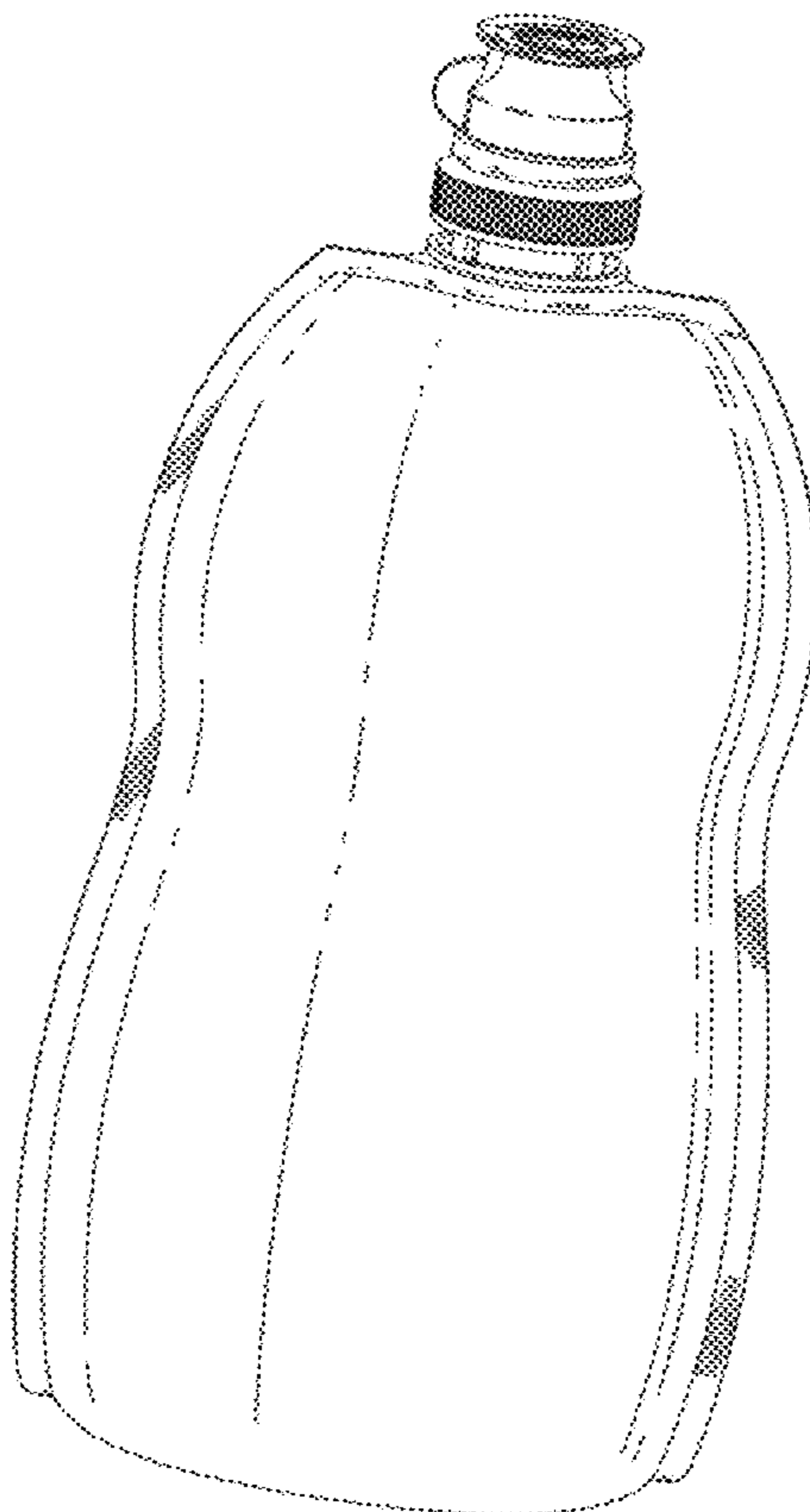
FIG. 5 is a bottom view of a beverage pouch according to the present invention;

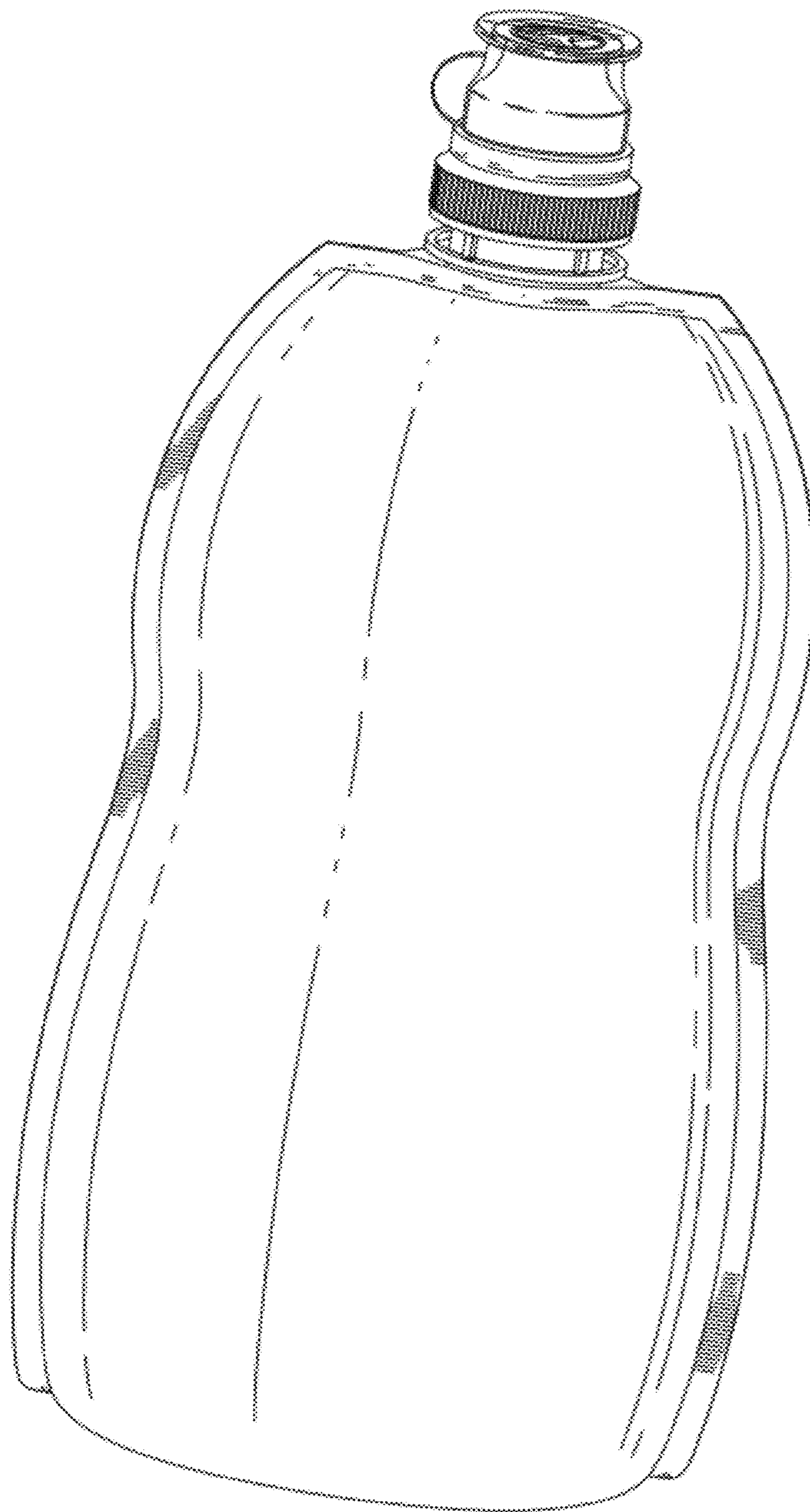

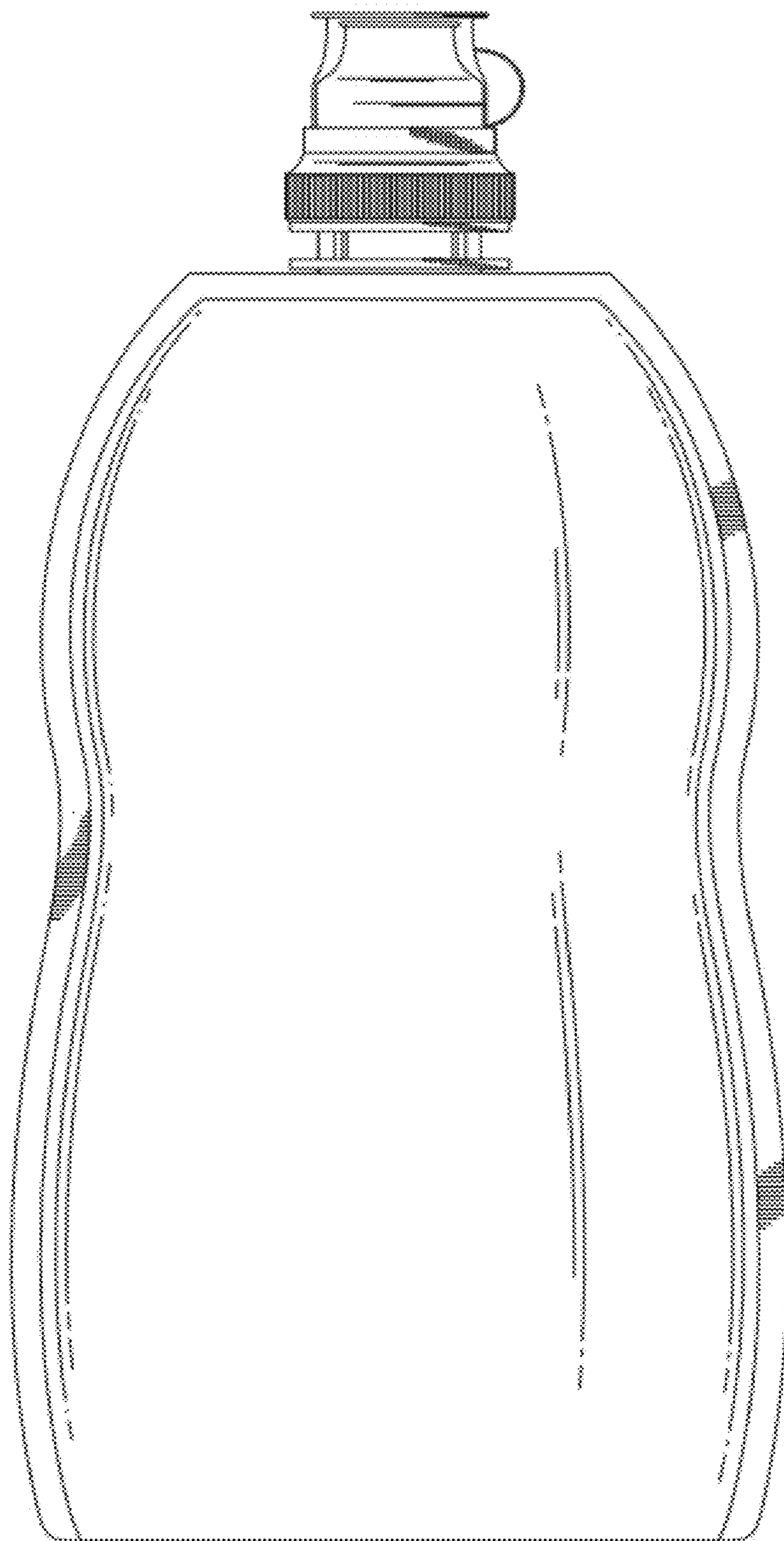

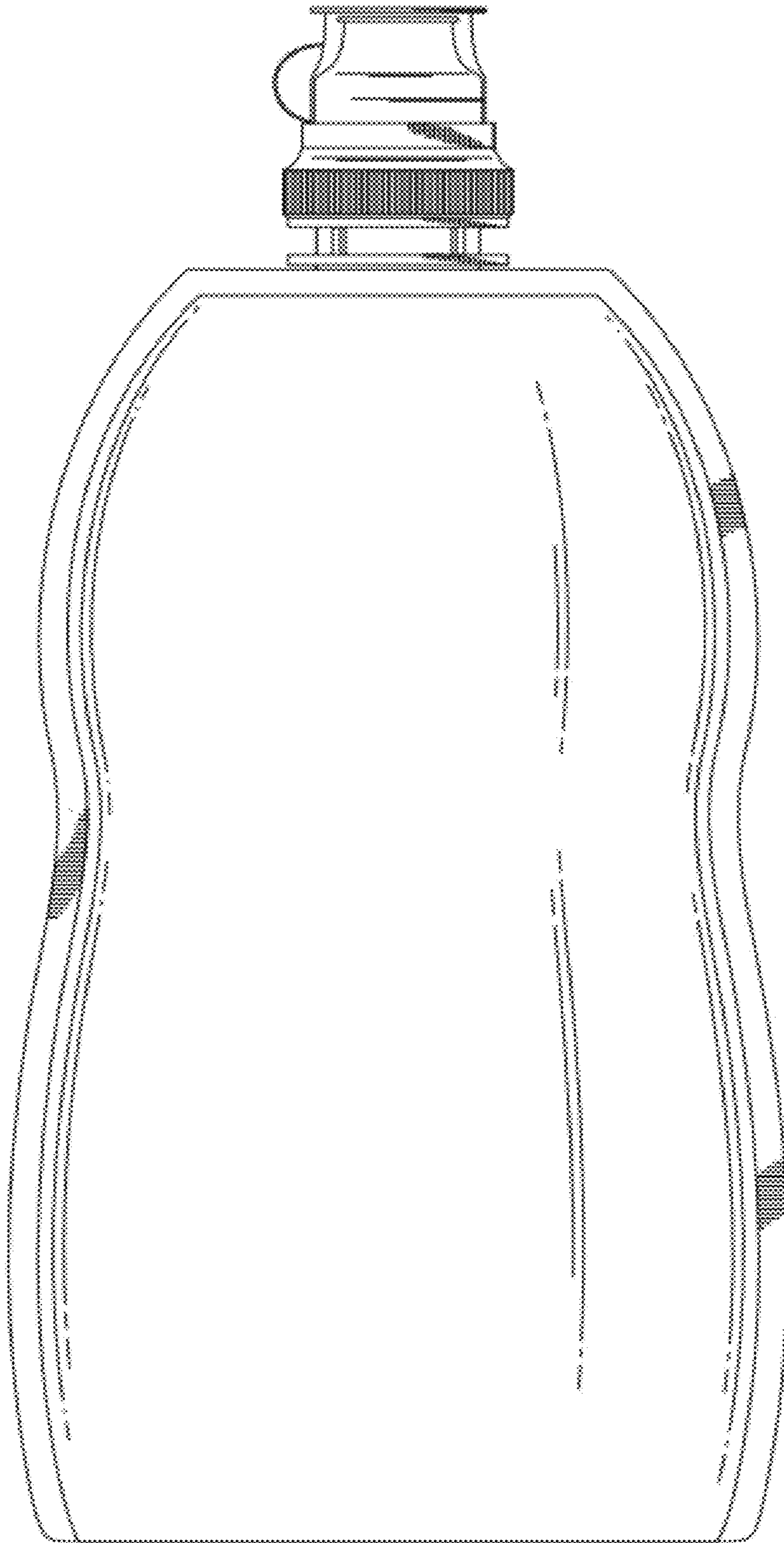

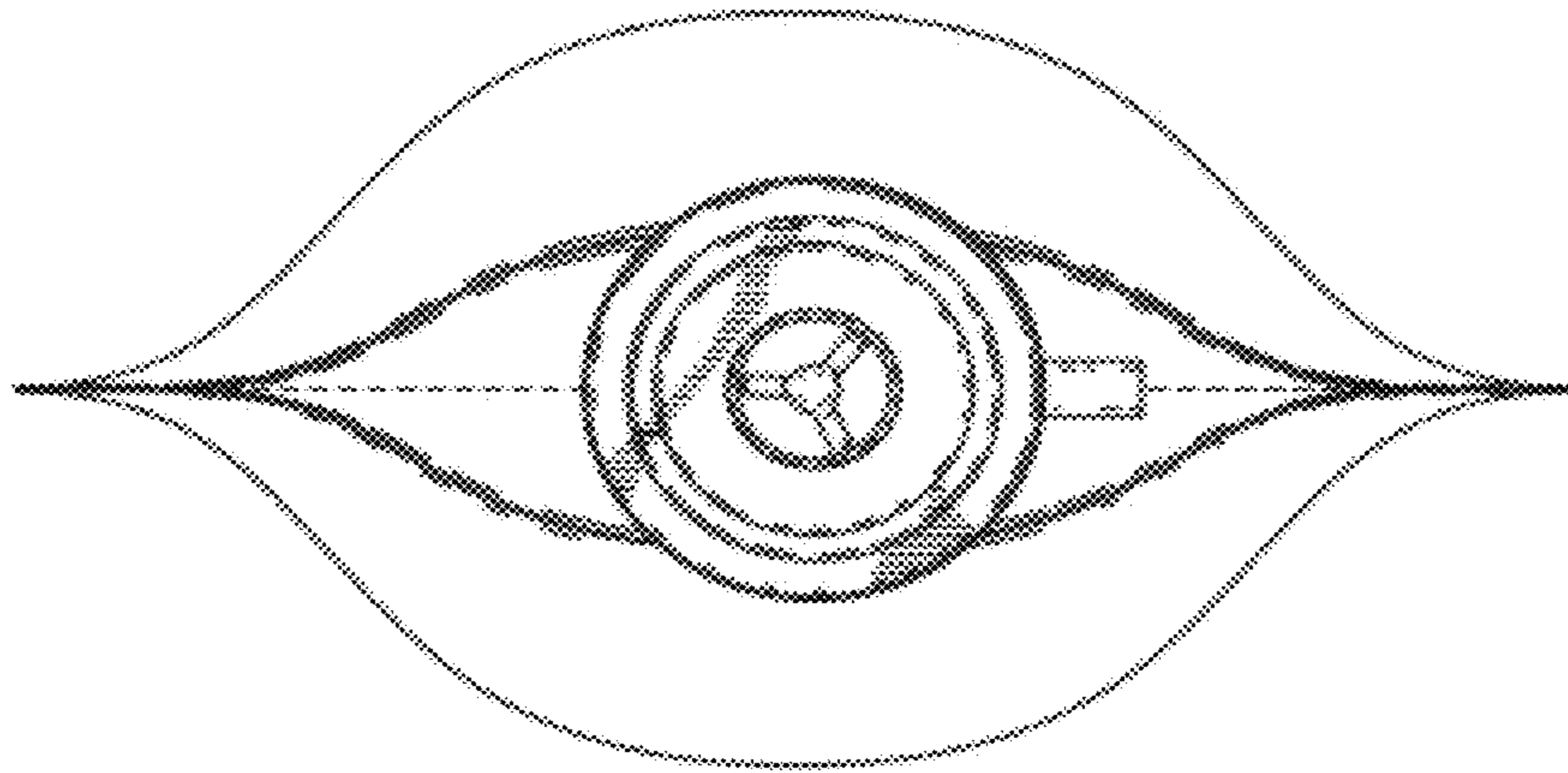

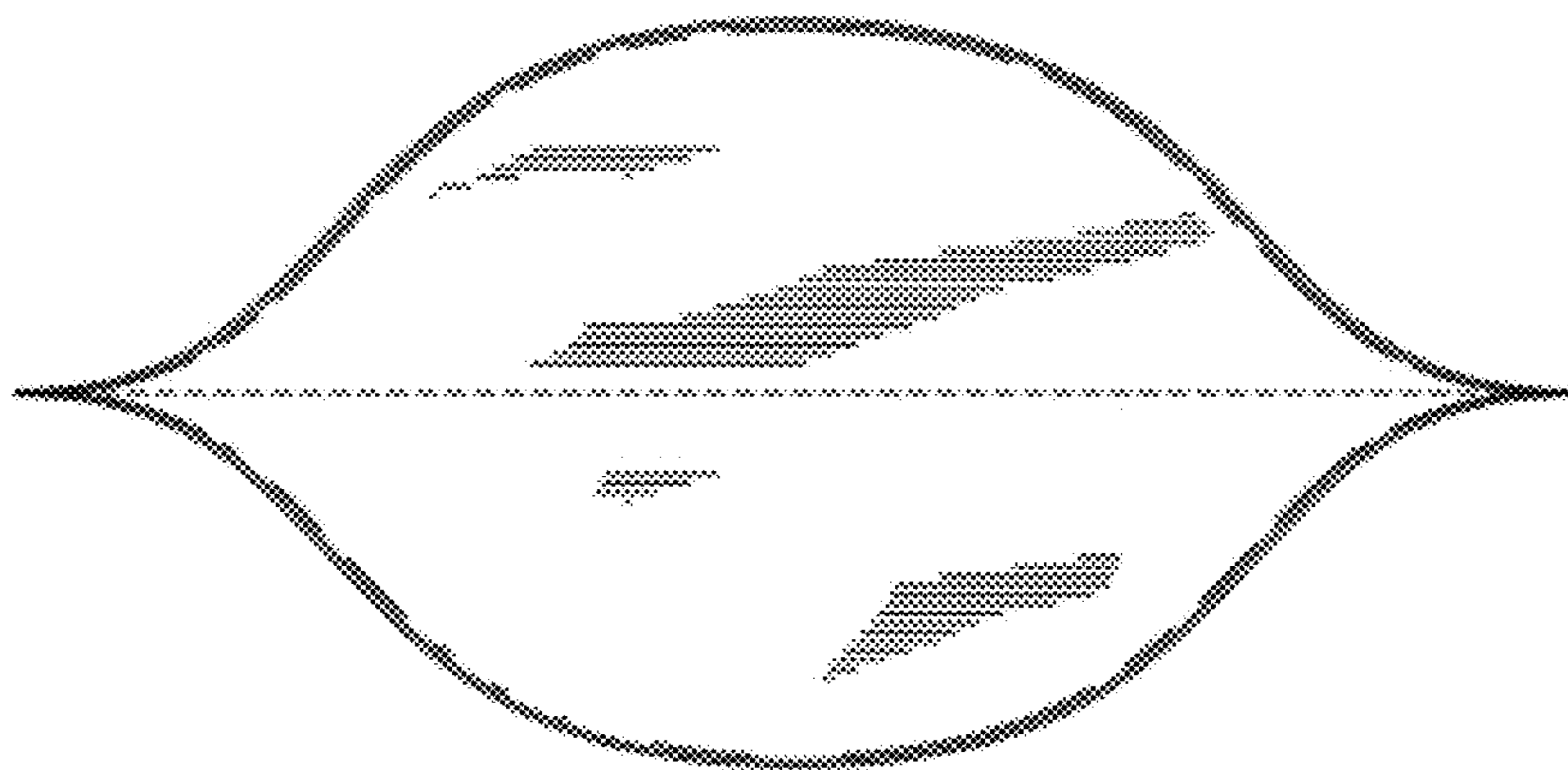

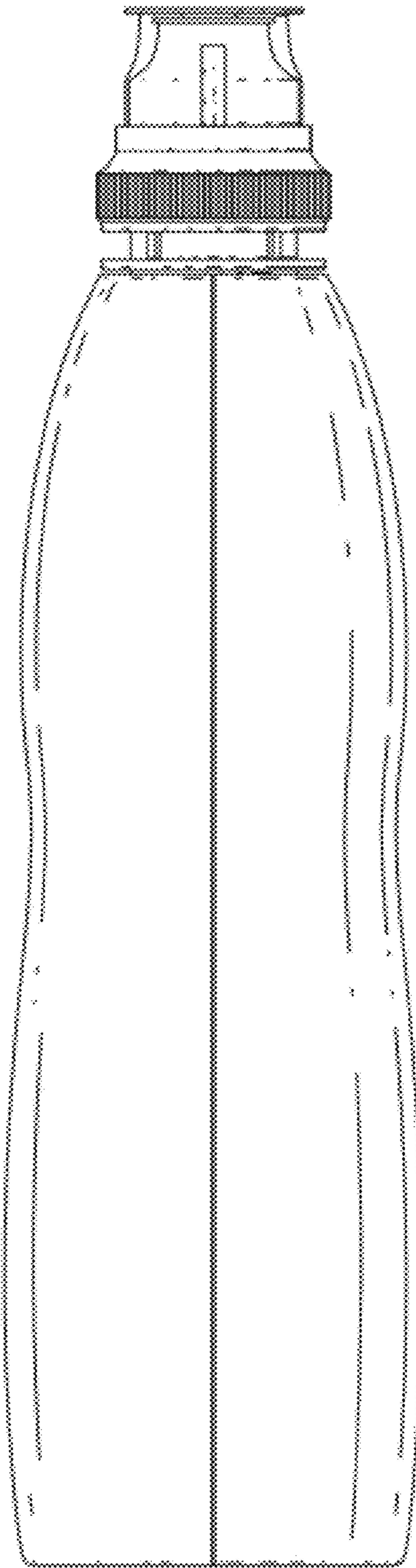

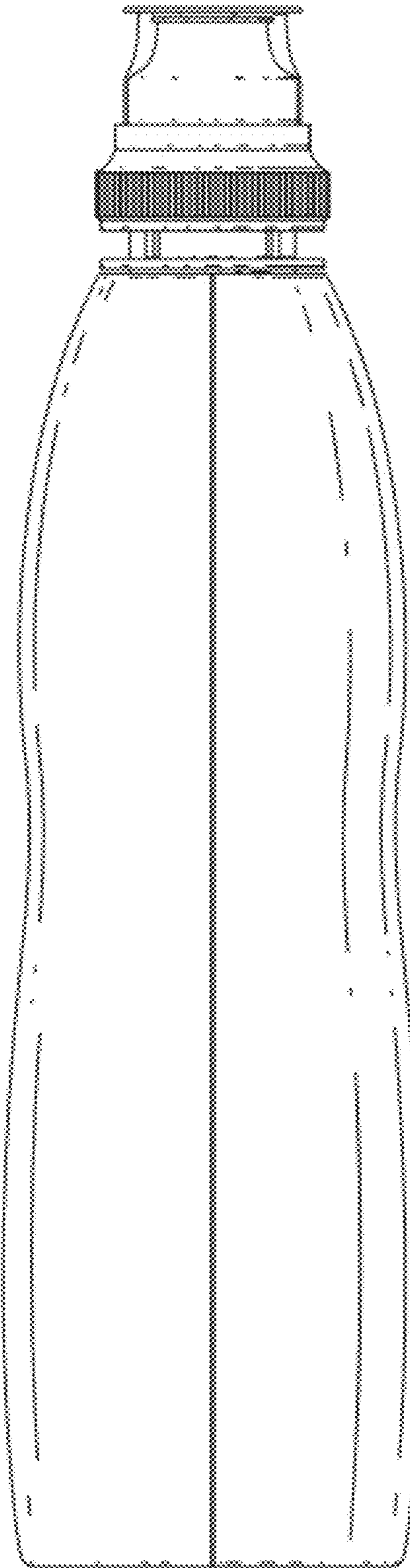
