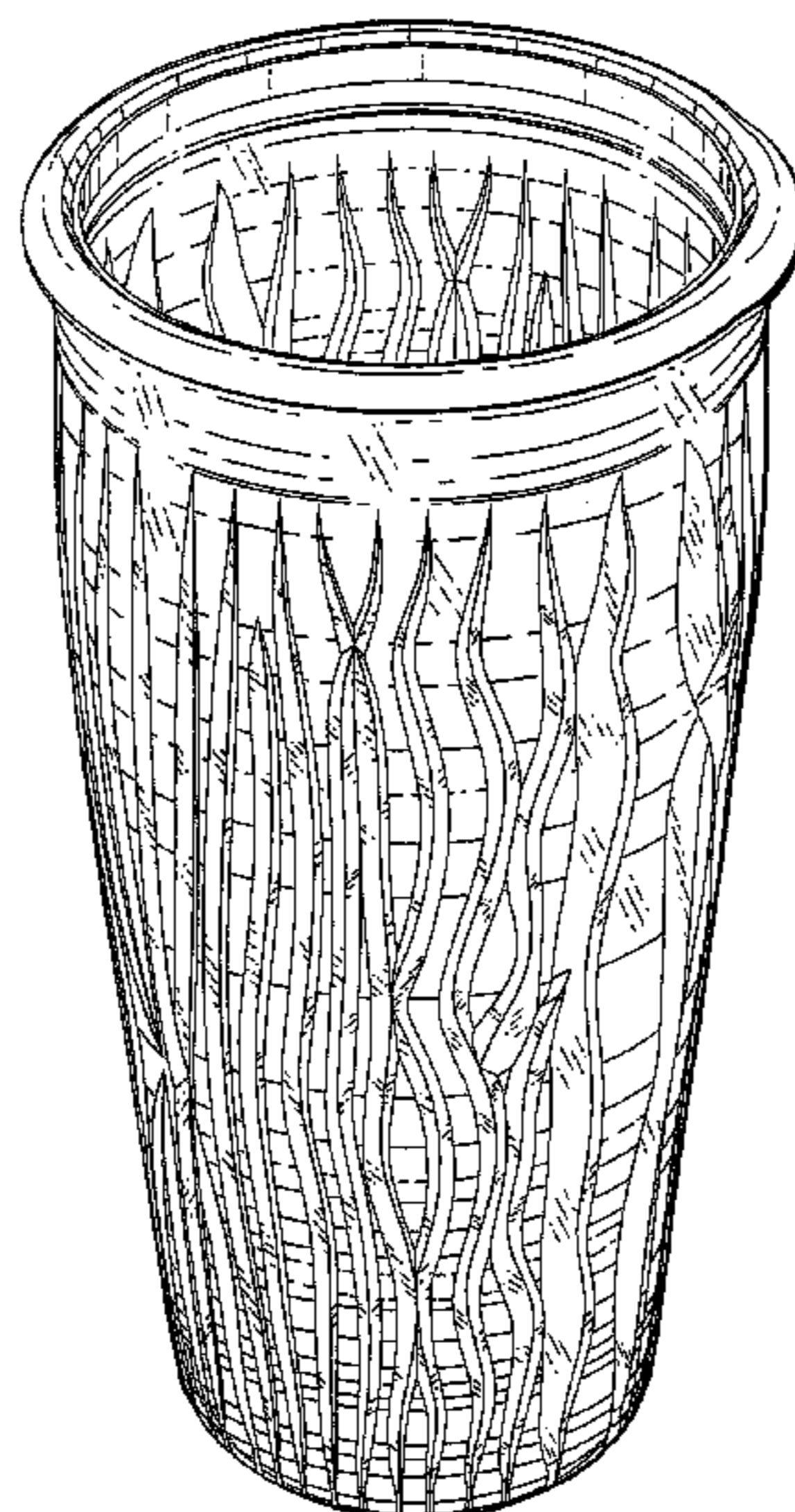
(57) **CLAIM**

The ornamental design for a fluted vase, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a fluted vase incorporating my new design;
FIG. 2 is a right side elevation view thereof, the left side elevation view being identical thereto;
FIG. 3 is a front elevation view thereof, the rear elevation view being identical thereto;
FIG. 4 is a top plan view thereof;
FIG. 5 is a bottom plan view thereof; and,
FIG. 6 is cross-section view thereof, taken along line 6-6 of FIG. 3, shown at an enlarged scale.

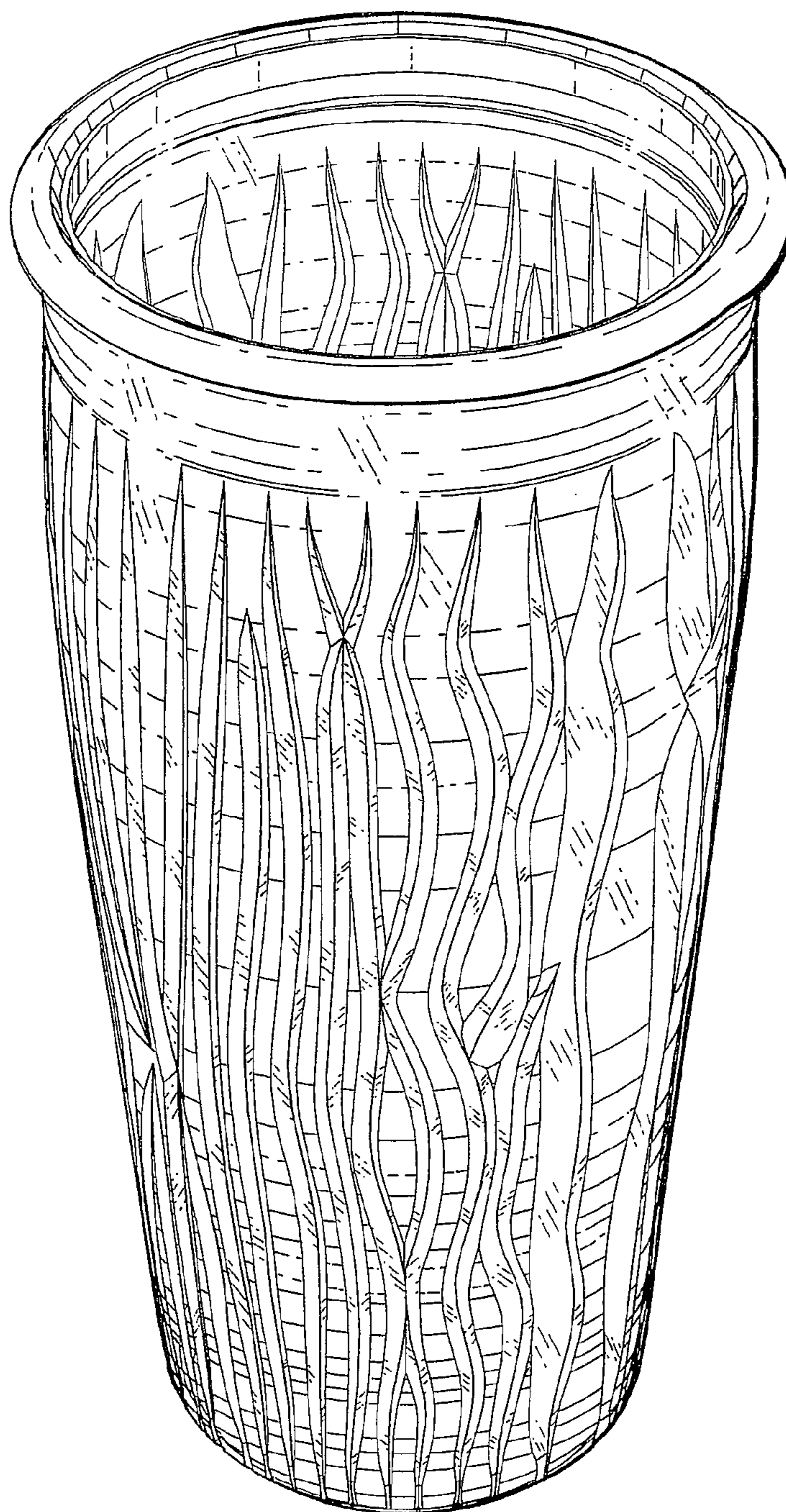

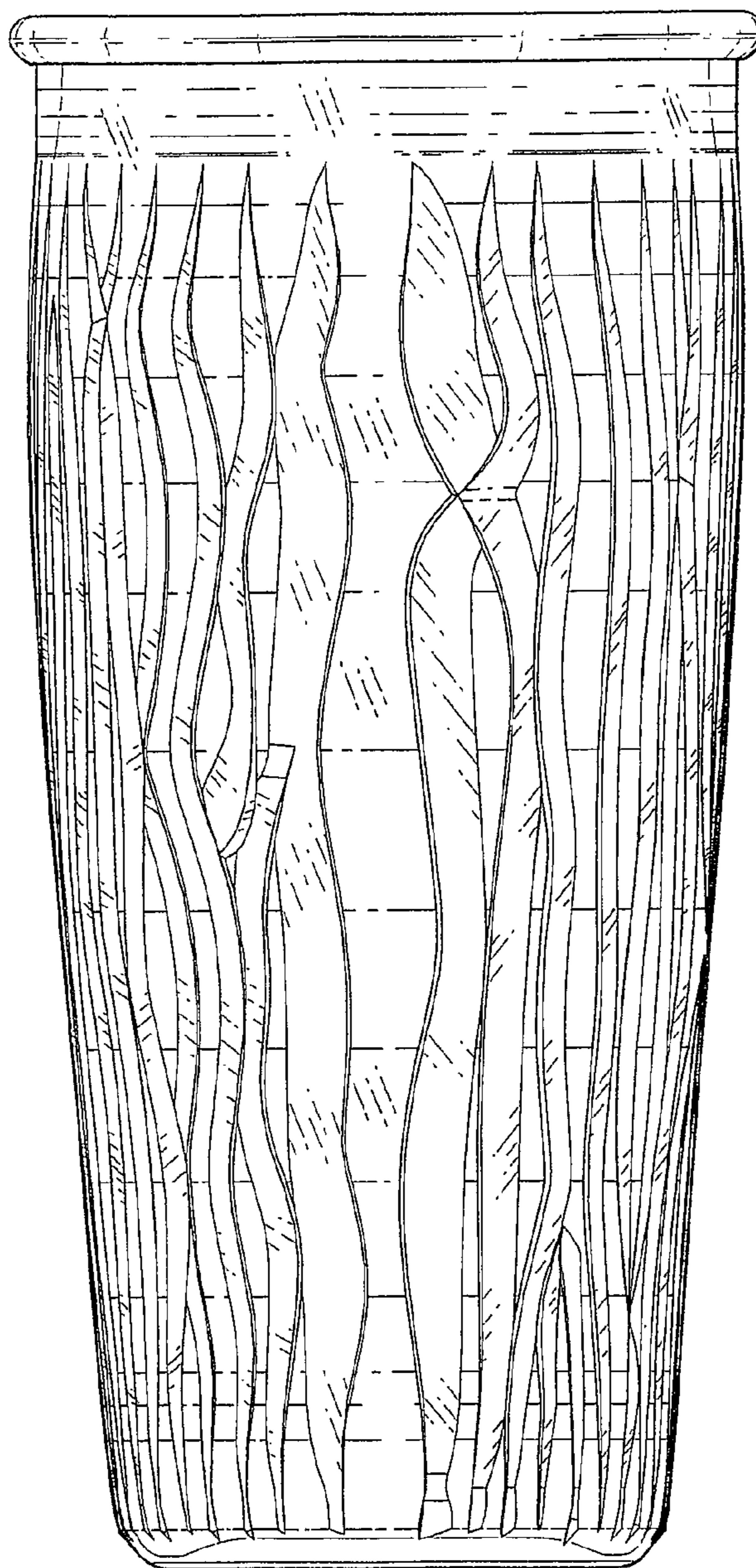

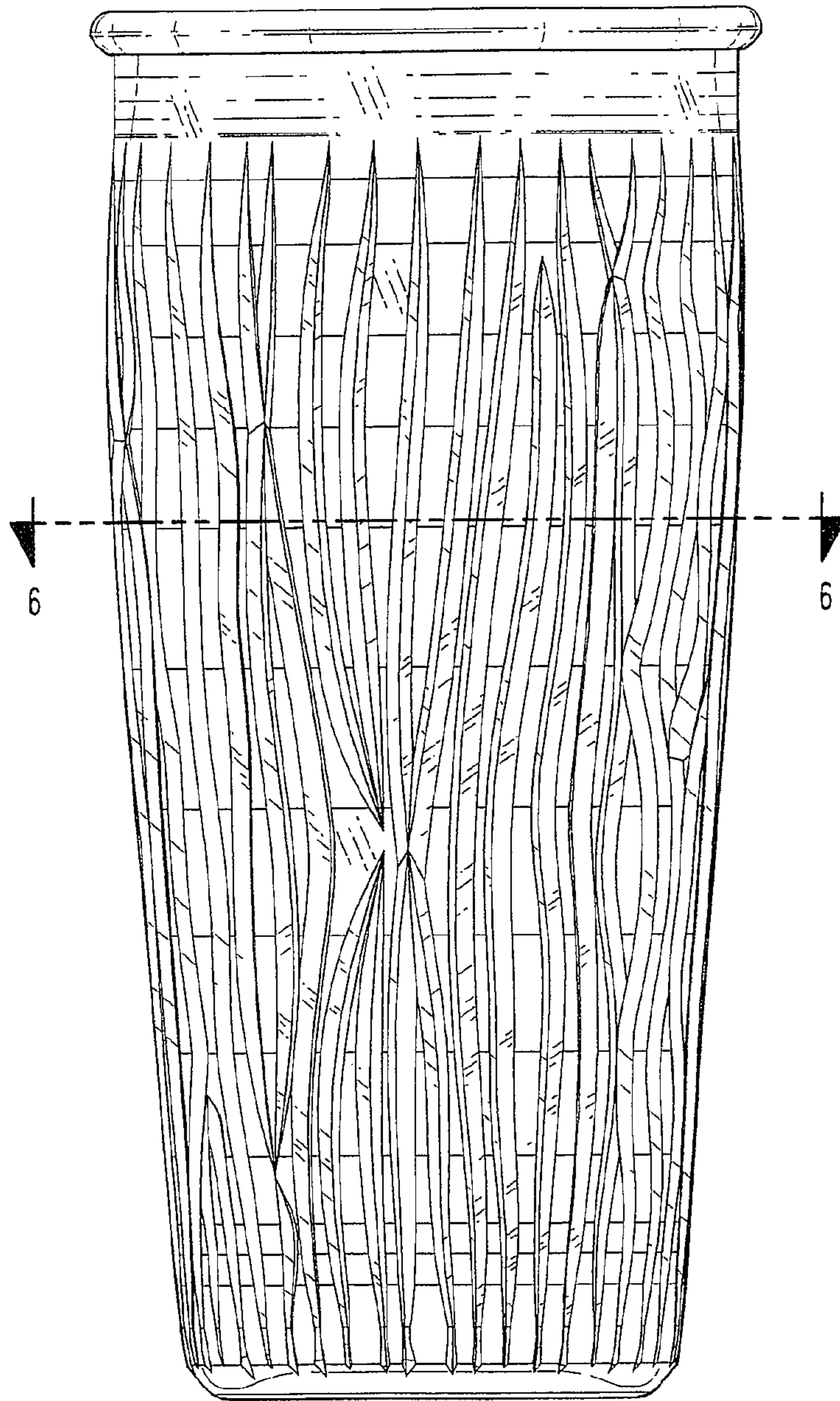

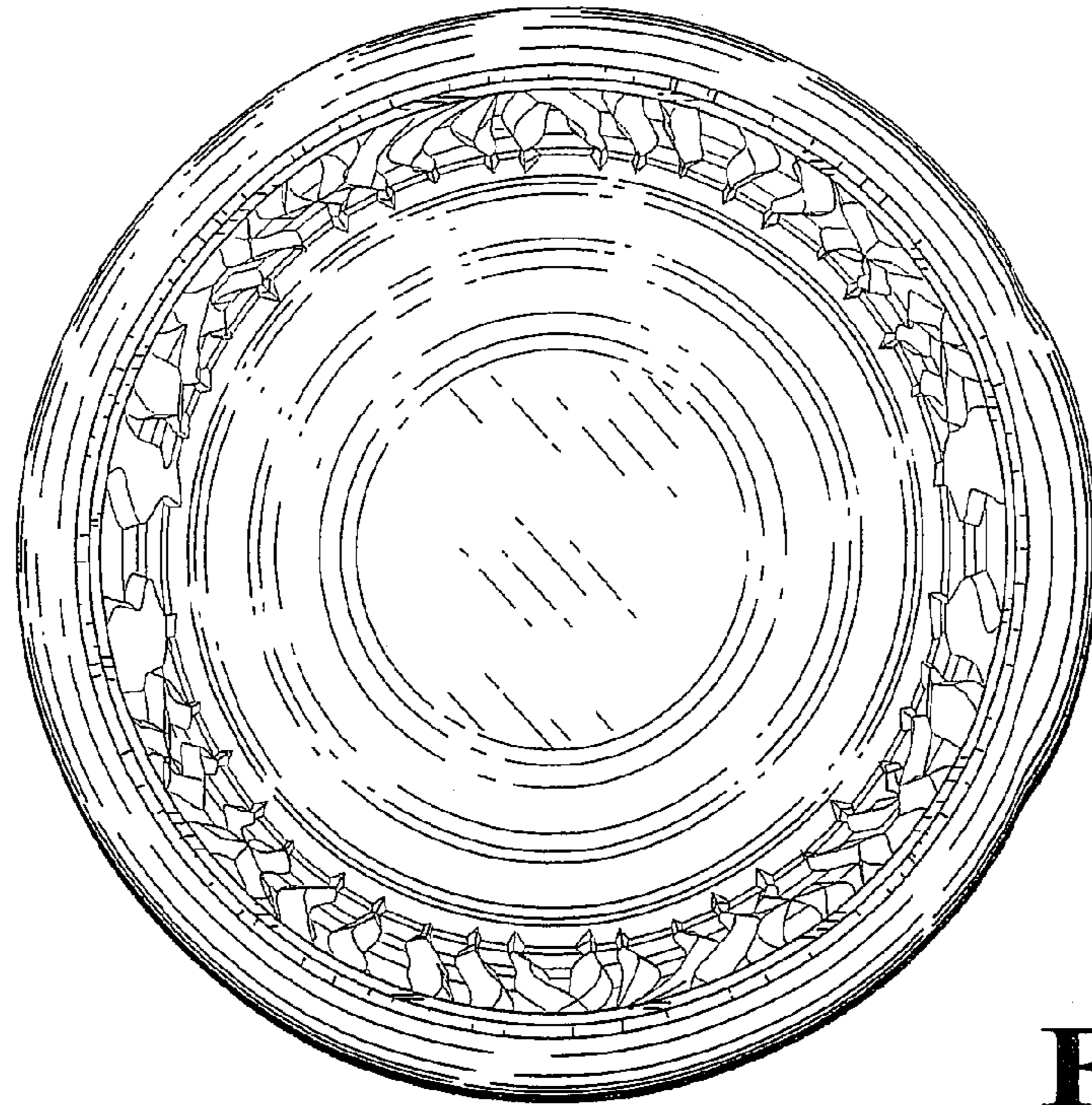

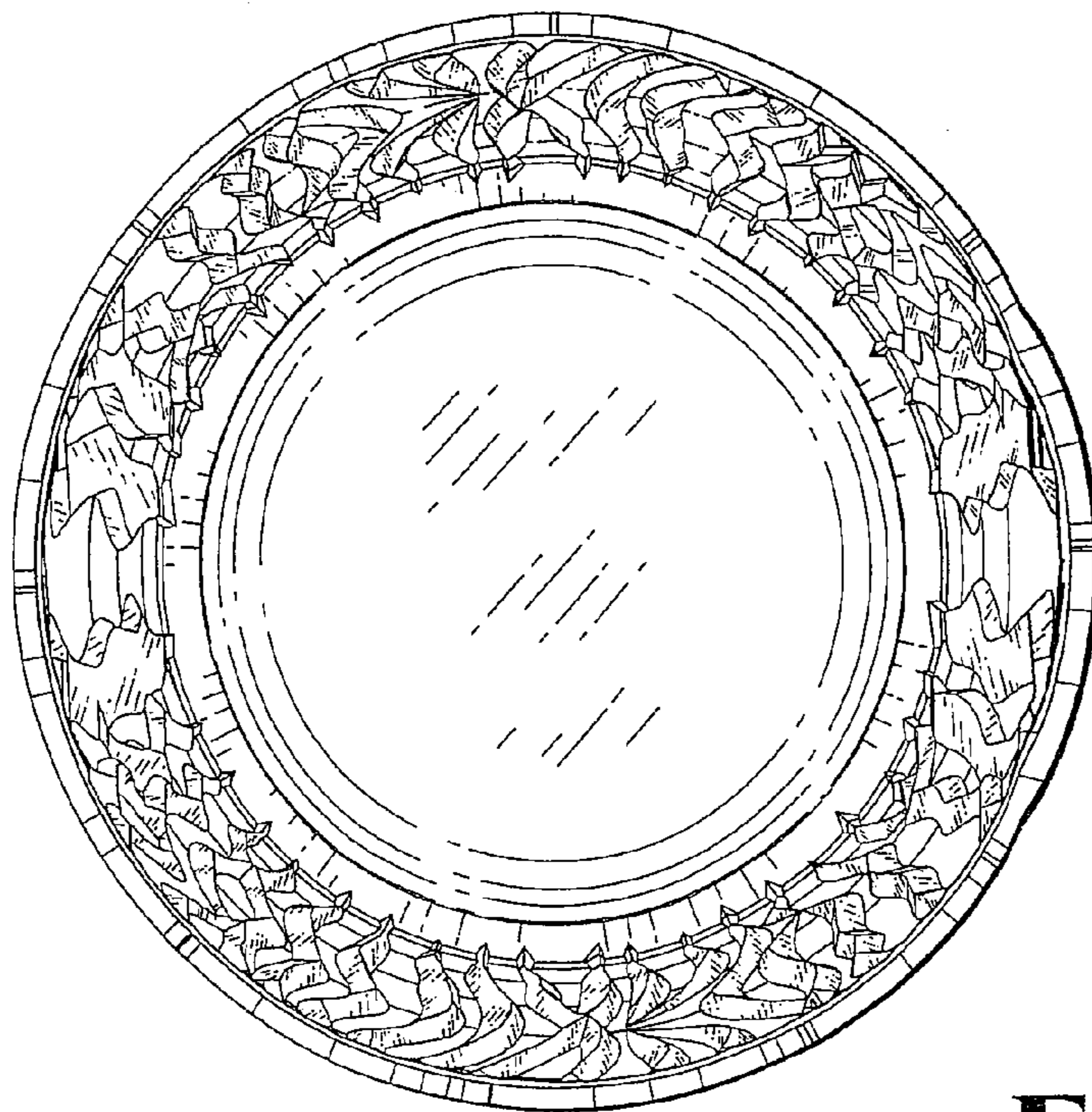

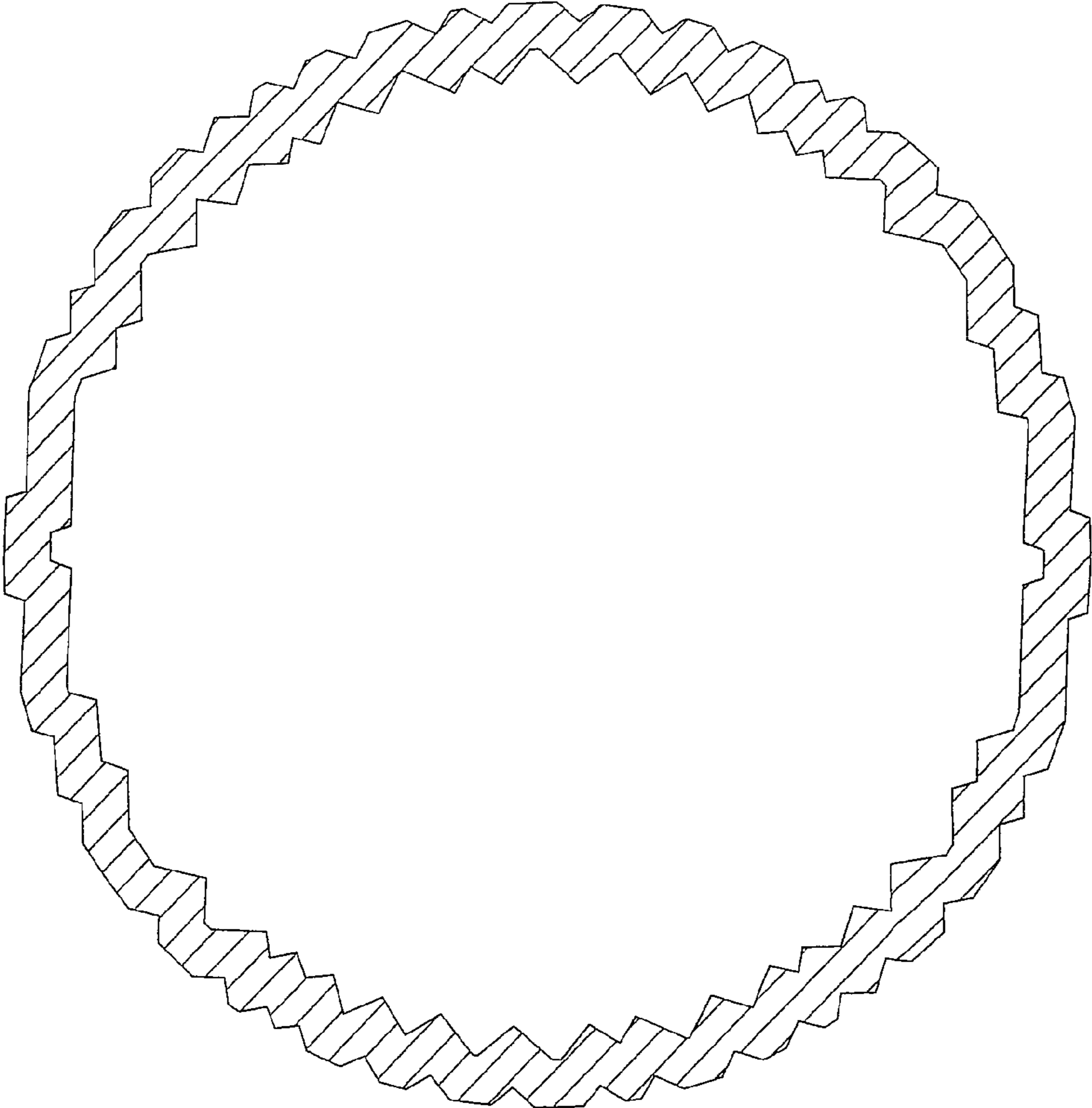
