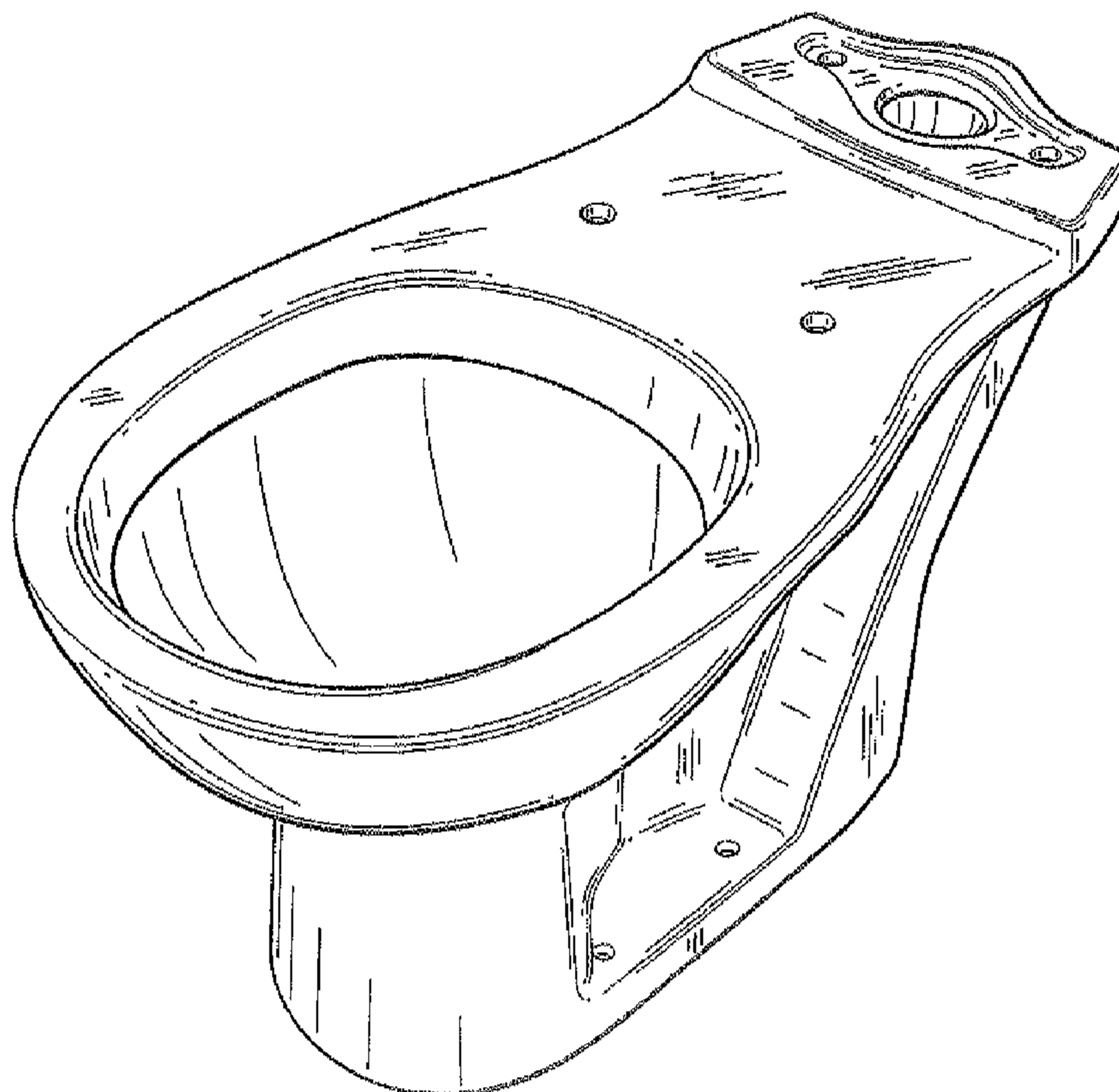
(57) **CLAIM**

We claim the ornamental design for a toilet, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from above, front and to one side of a first embodiment of a toilet, showing our new design; FIG. 2 is a perspective view from above, rear and to one side of the toilet, as shown in FIG. 1; FIG. 3 is a top plan view of the toilet, as shown in FIG. 1; FIG. 4 is a right view of the toilet, as shown in FIG. 1; FIG. 5 is a left side view of the toilet, as shown in FIG. 1; FIG. 6 is a front side view of the toilet, as shown in FIG. 1; and FIG. 7 is a rear side view of the toilet, as shown in FIG. 1; FIG. 8 is a perspective view from above, front and to one side of a second embodiment of a toilet, showing our new design; FIG. 9 is a perspective view from above, rear and to one side of the toilet, as shown in FIG. 8; FIG. 10 is a top plan view of the toilet, as shown in FIG. 8; FIG. 11 is a right view of the toilet, as shown in FIG. 8; FIG. 12 is a left side view of the toilet, as shown in FIG. 8; FIG. 13 is a front side view of the toilet, as shown in FIG. 8; and, FIG. 14 is a rear side view of the toilet, as shown in FIG. 8.

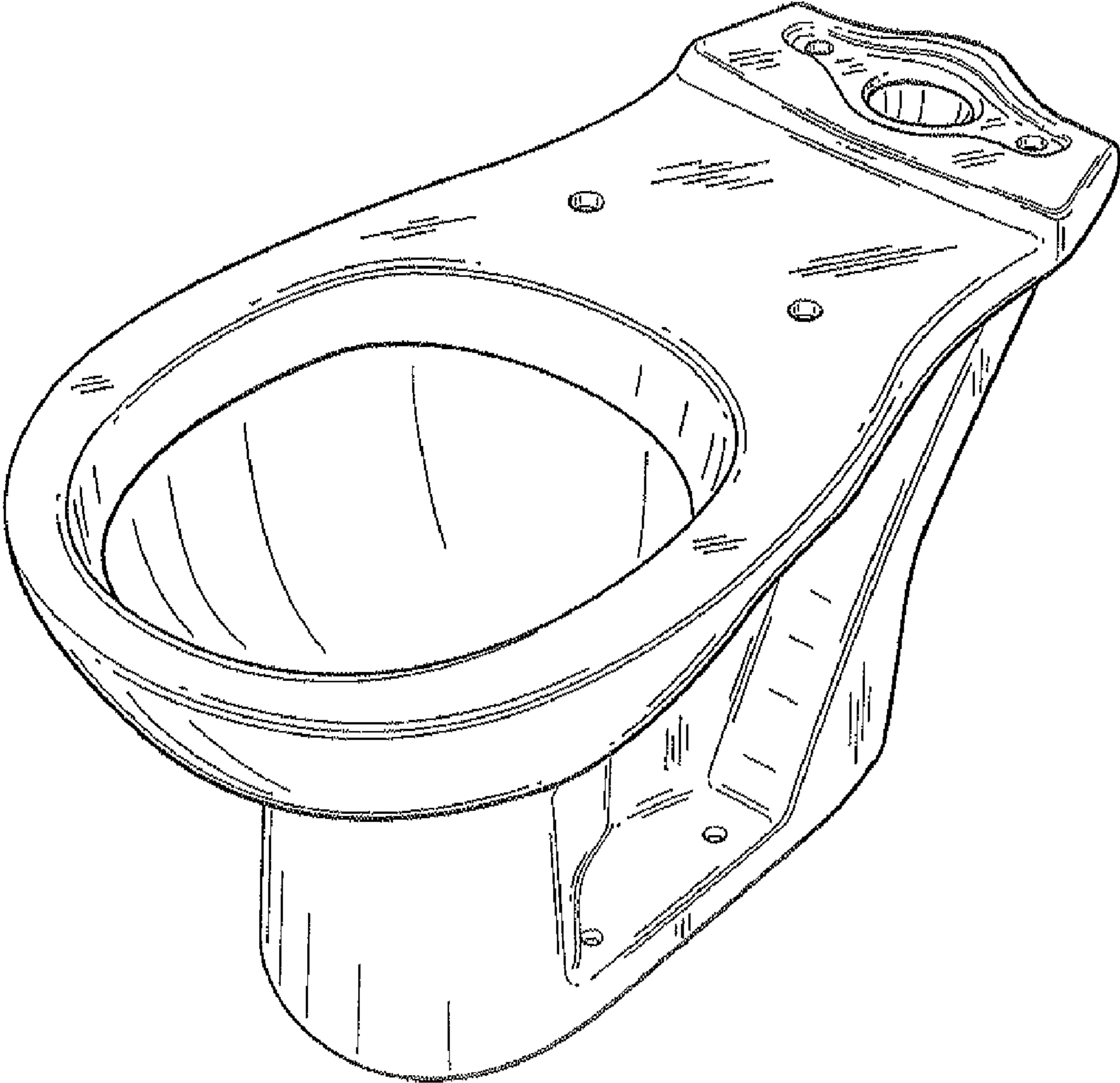

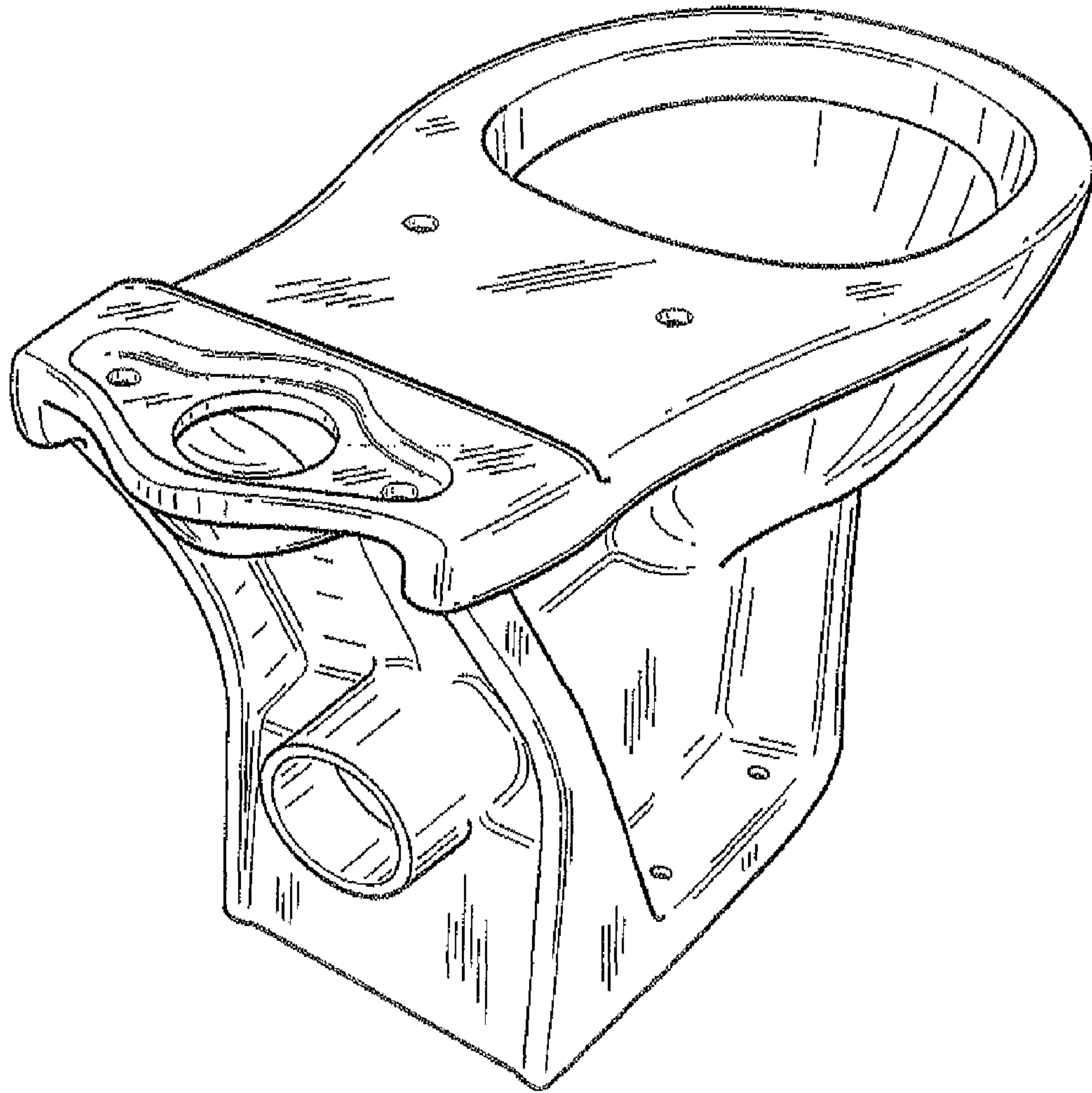

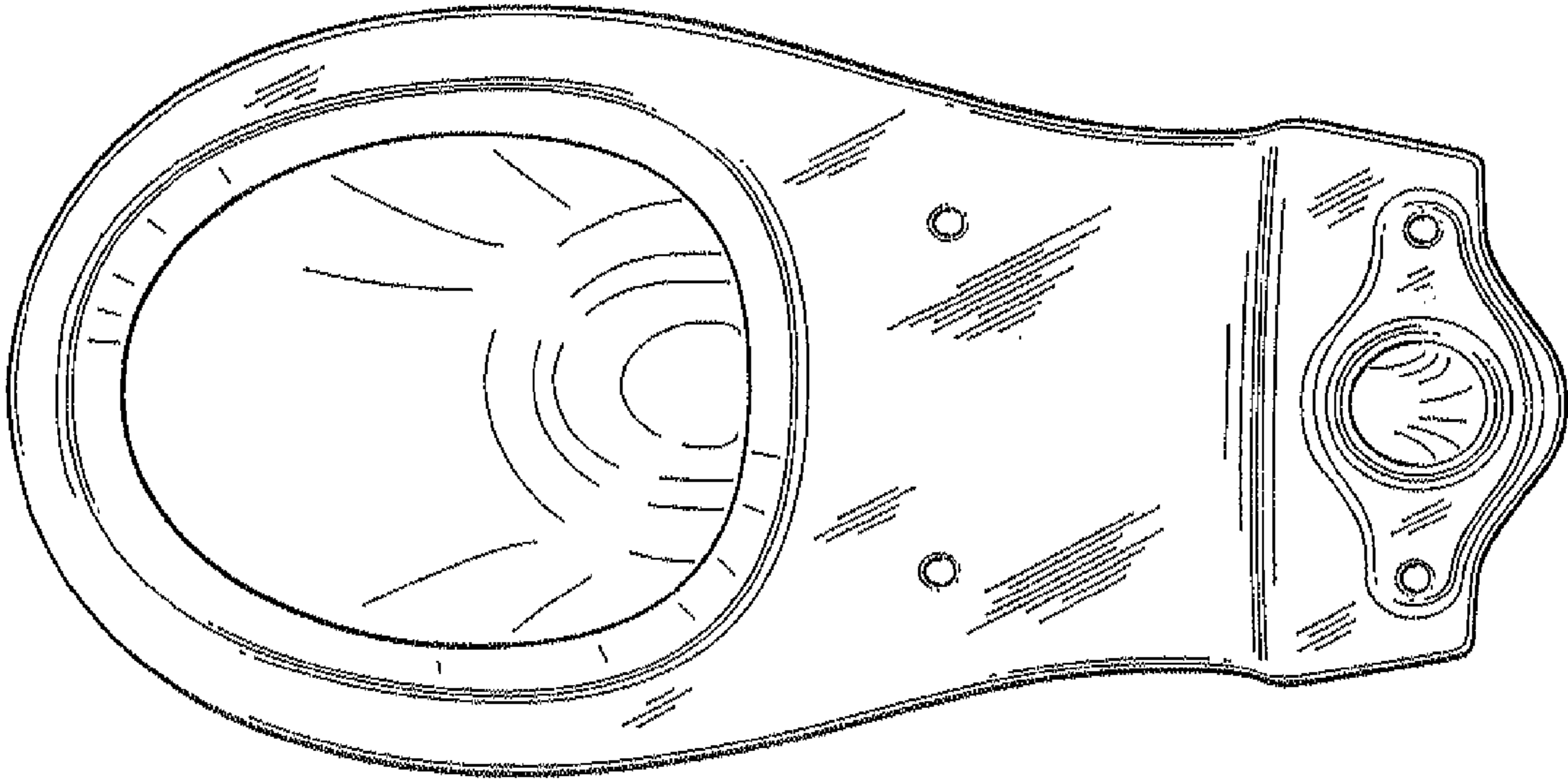

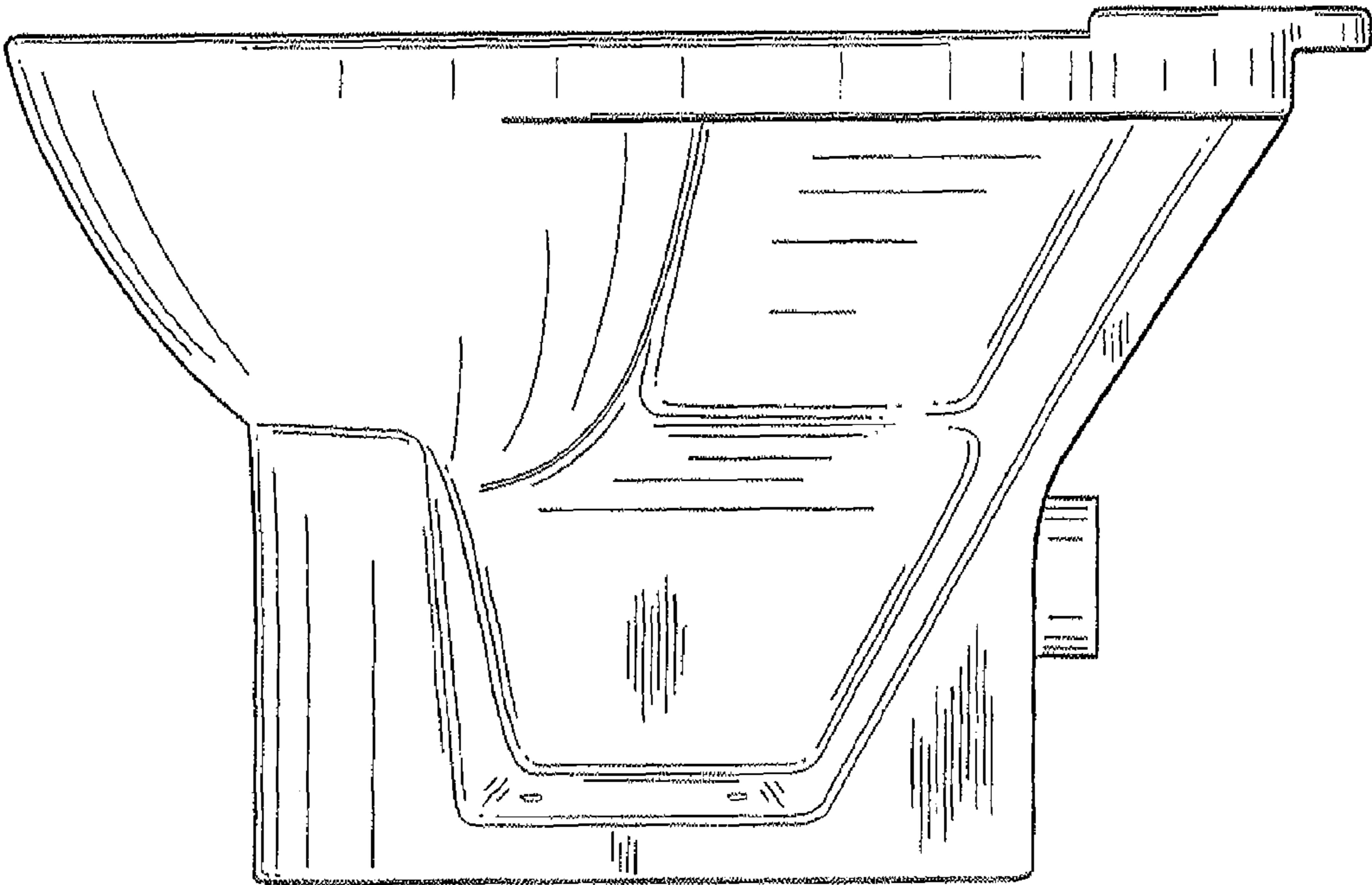

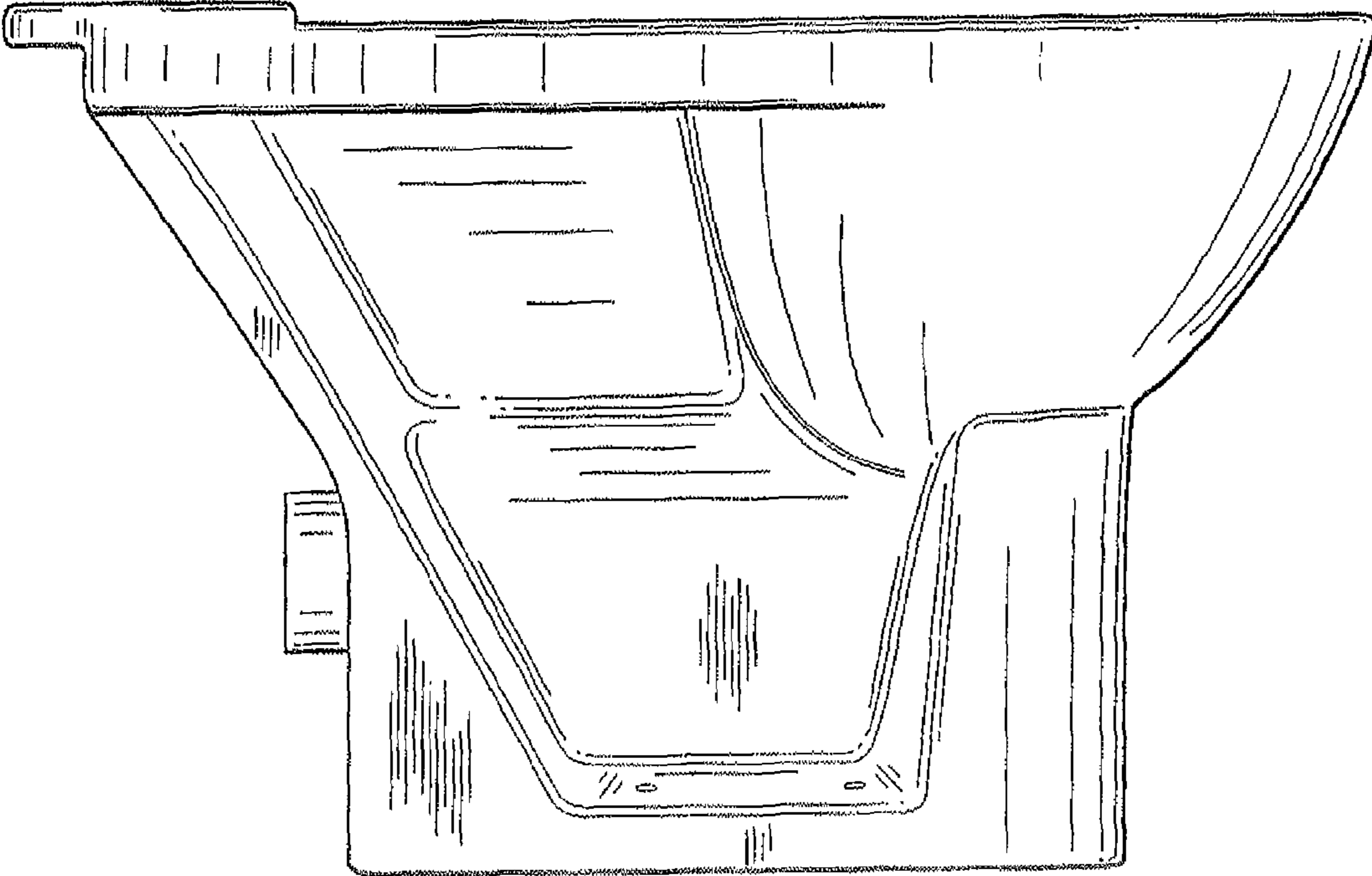

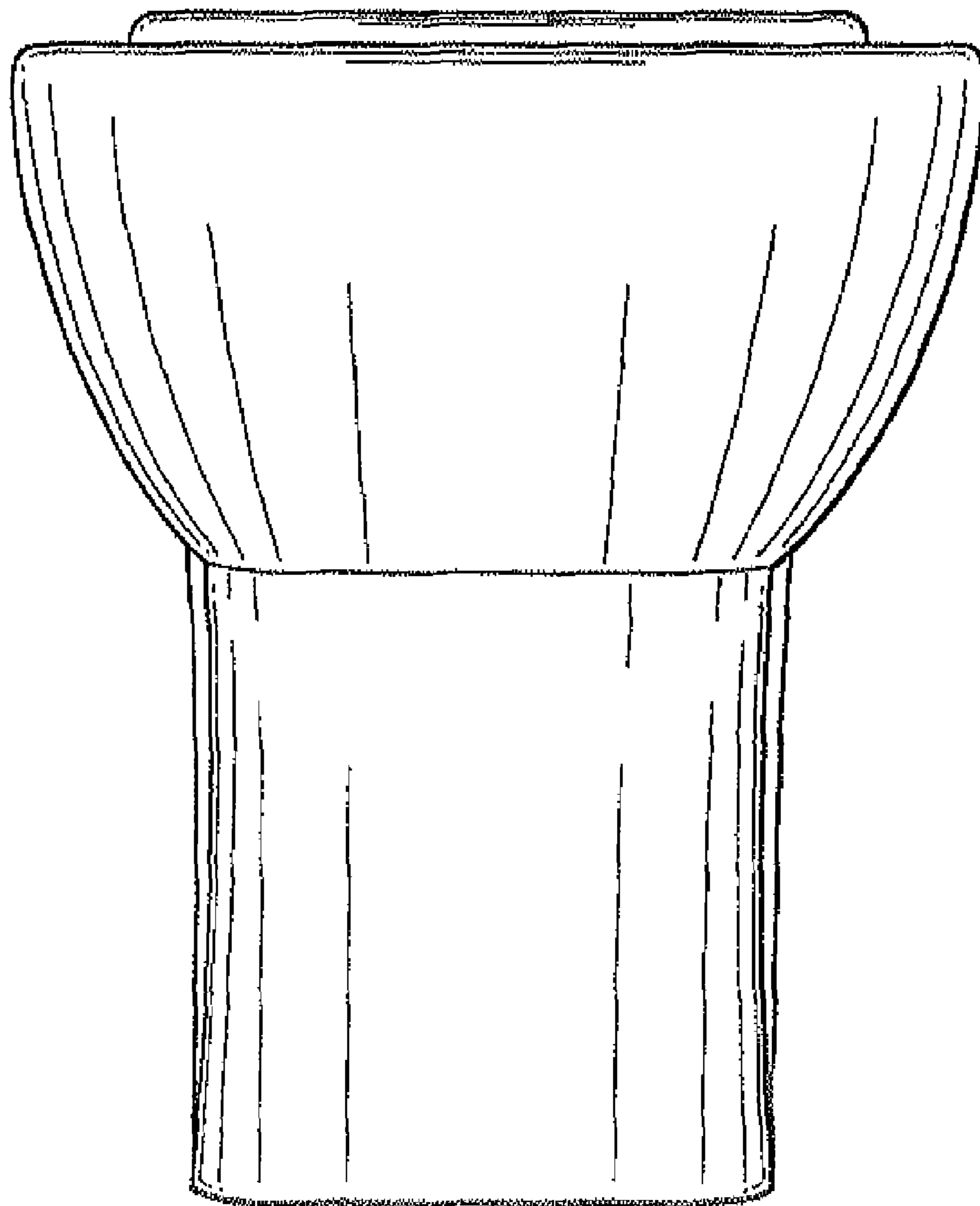

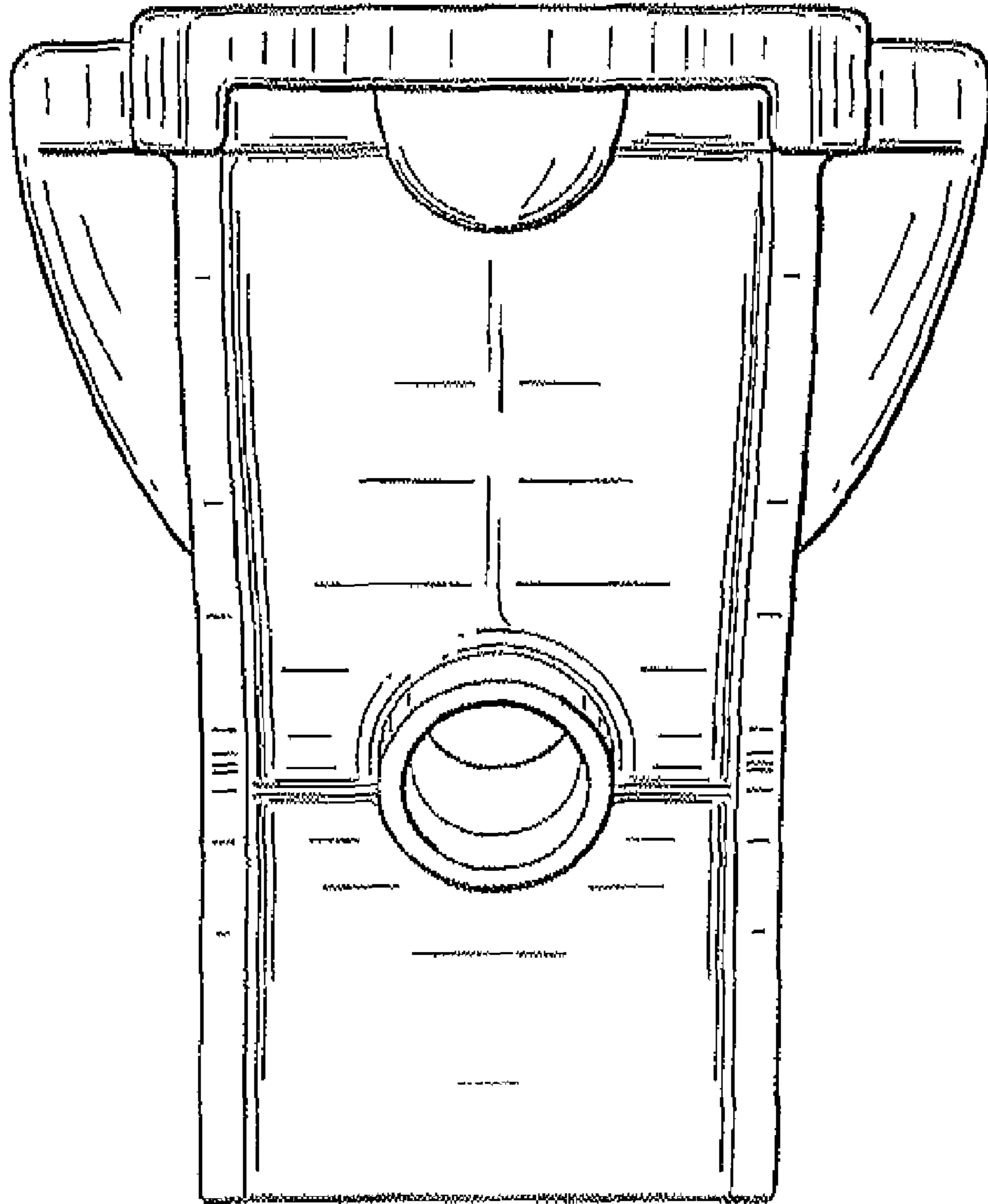

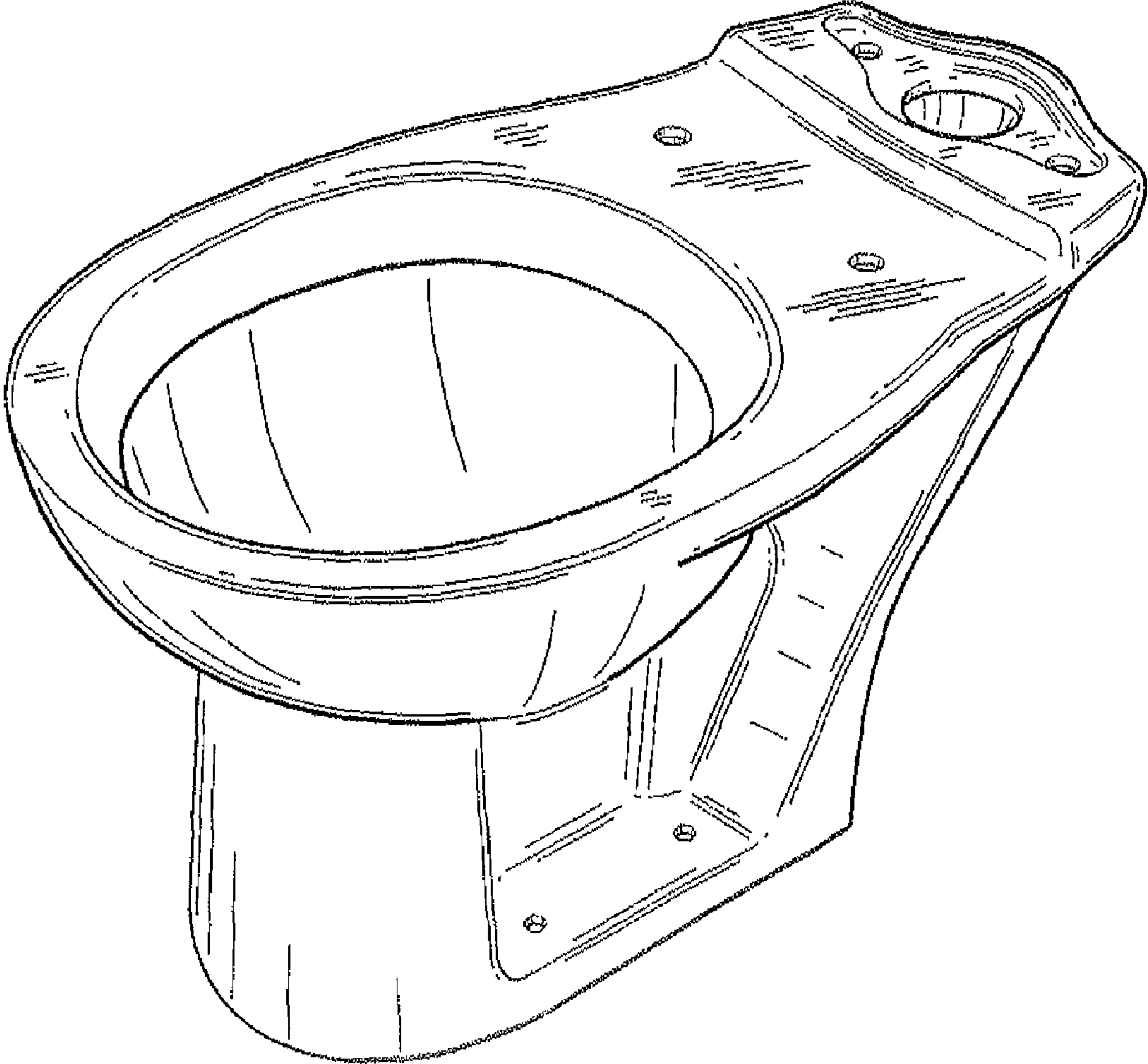

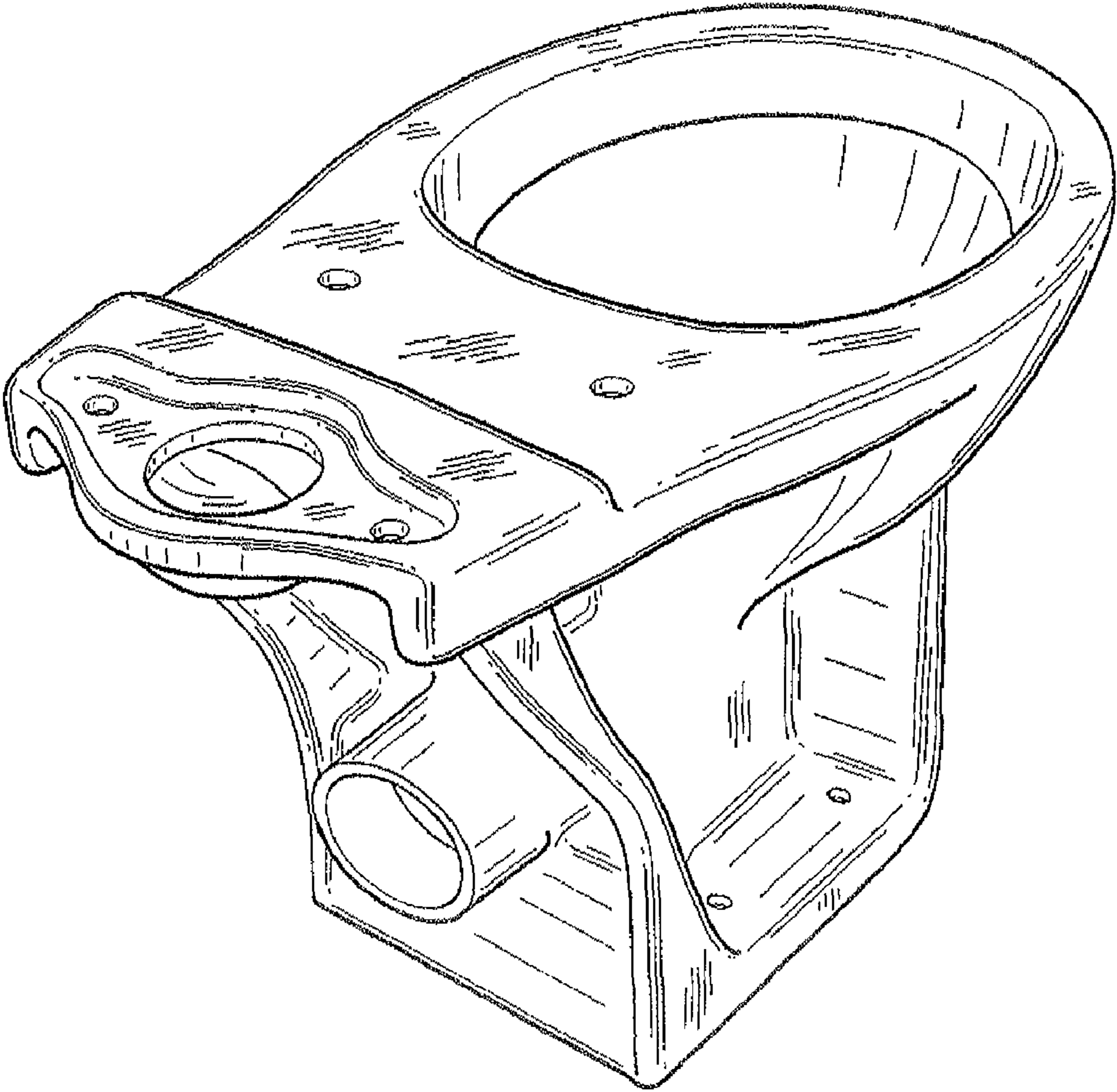

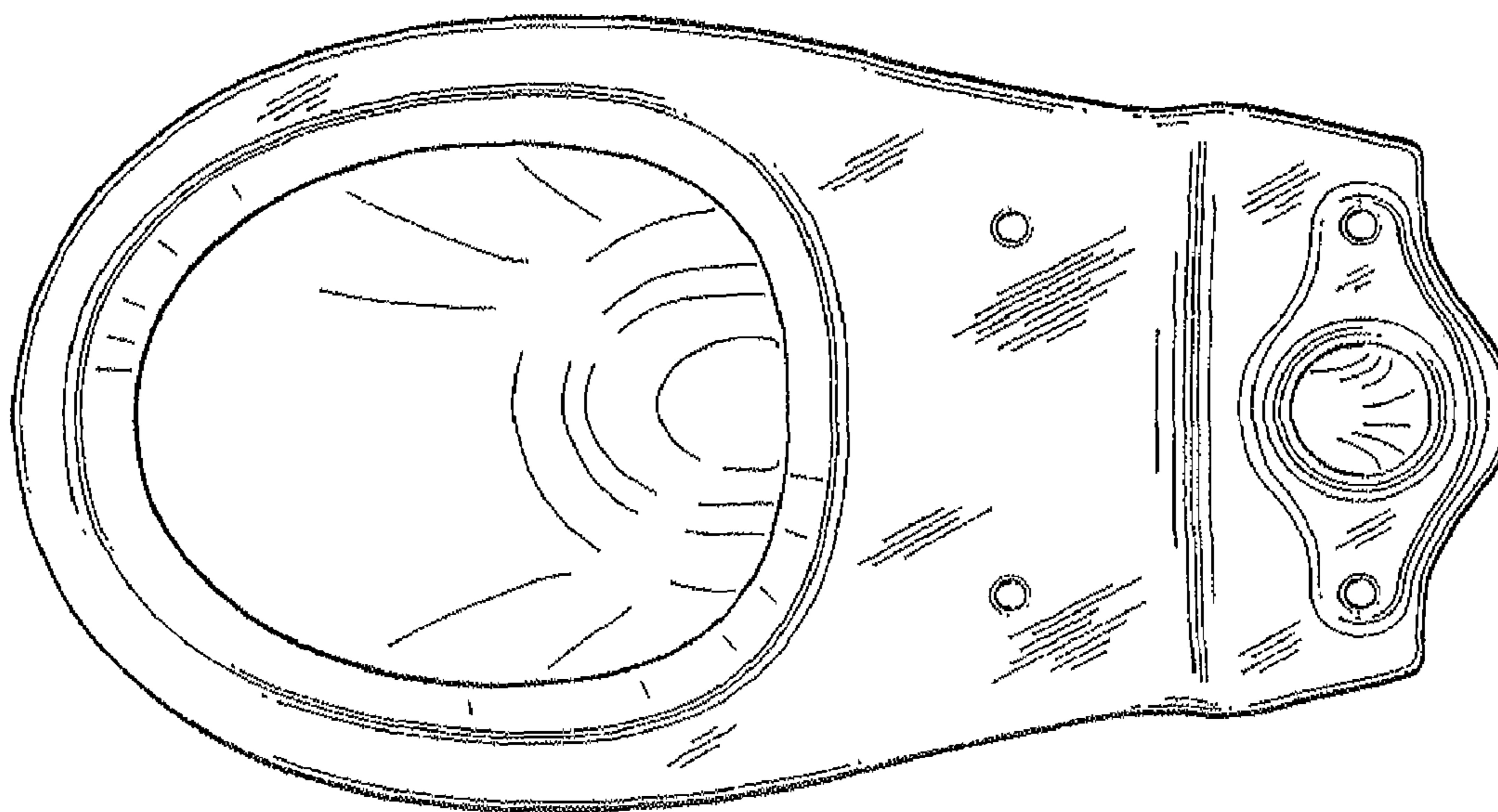

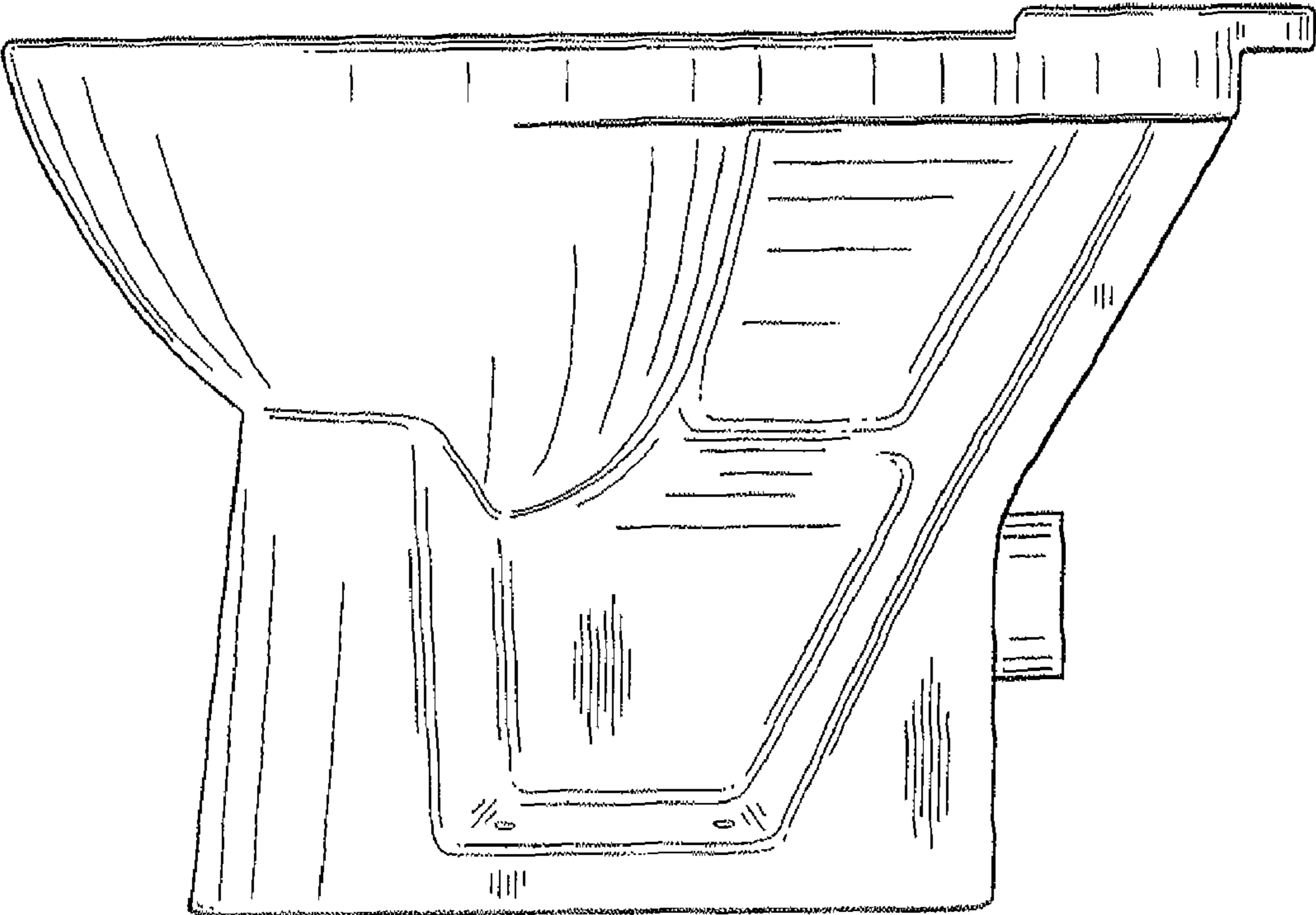

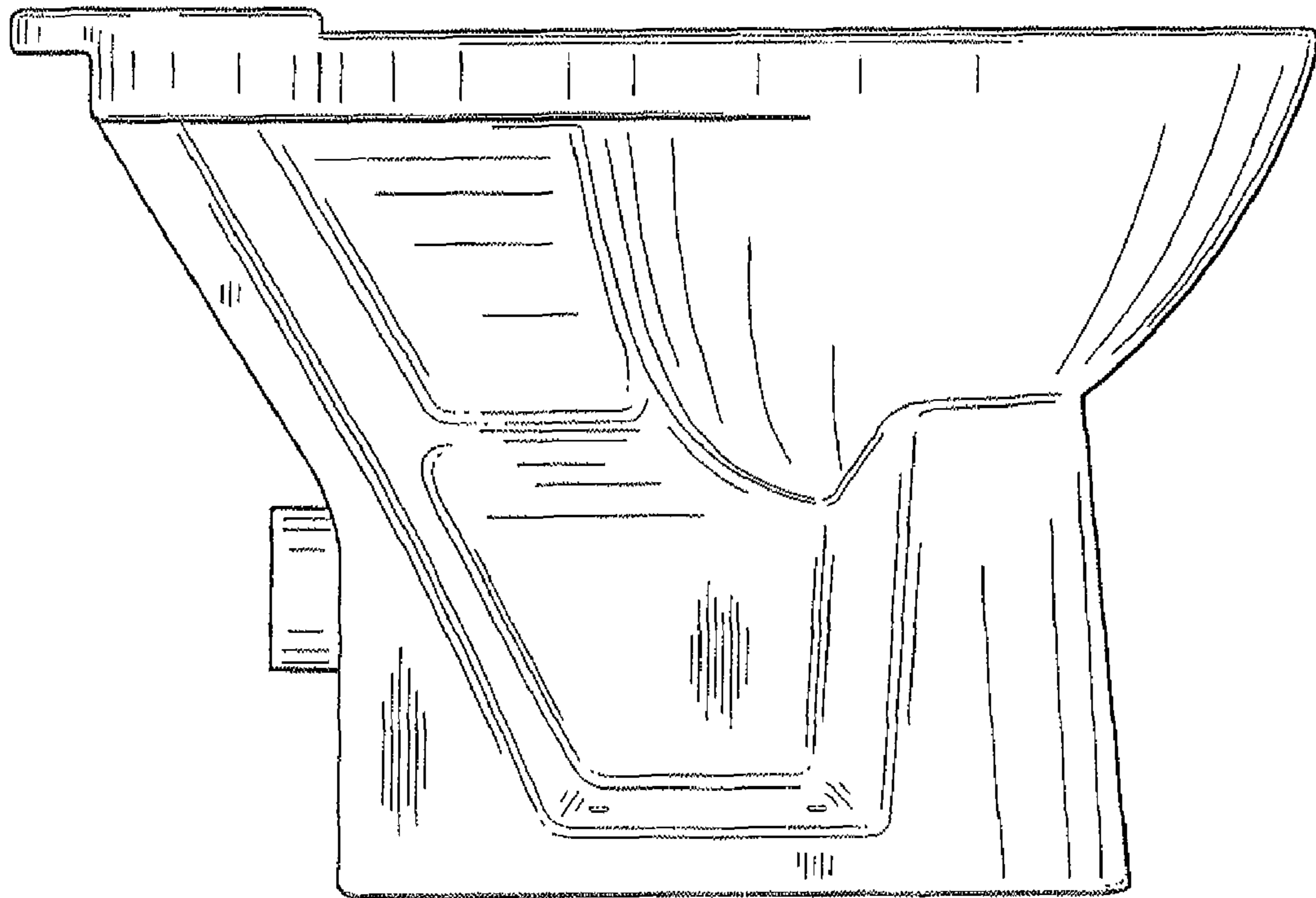

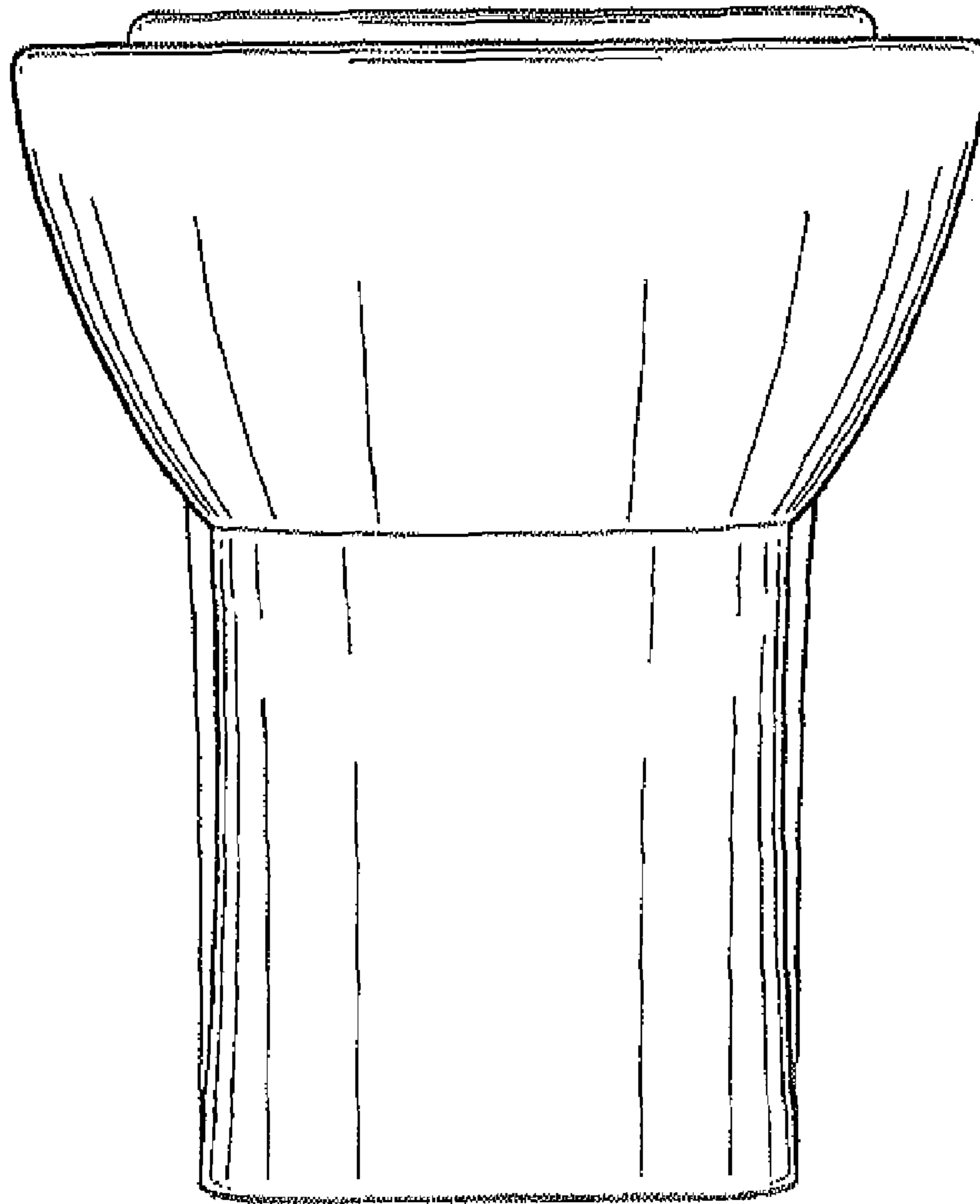

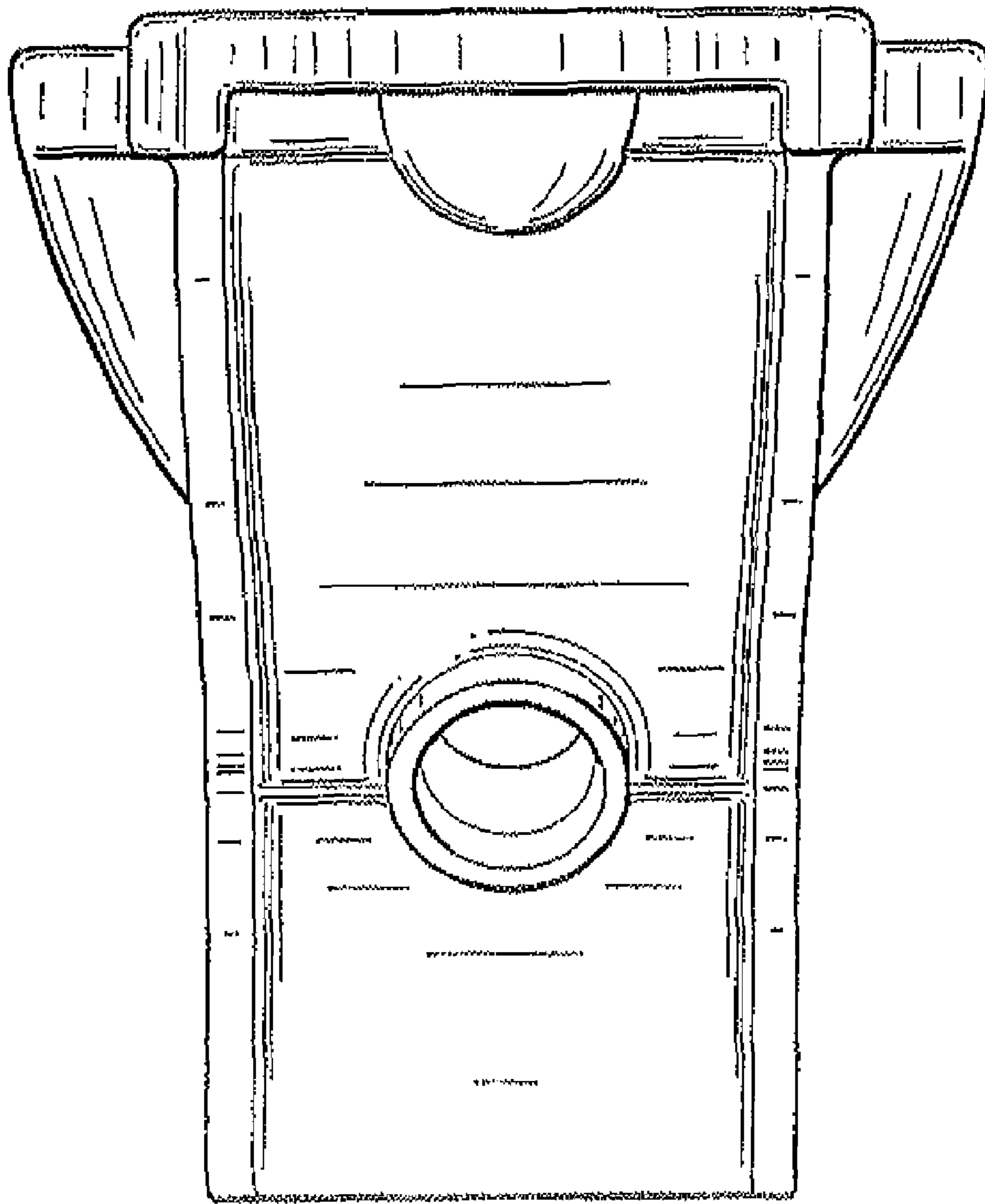
