(57) **CLAIM**

We claim the ornamental design for a removable top for a portable vaporizer, as shown and described.

**DESCRIPTION**

FIG. 1 is an upper right front perspective view of a removable top for a portable vaporizer shown on a disclaimed portable vaporizer;

FIG. 2 is a lower right rear perspective view of the removable top of FIG. 1;

FIG. 3 is a top plan view of the removable top of FIG. 1;

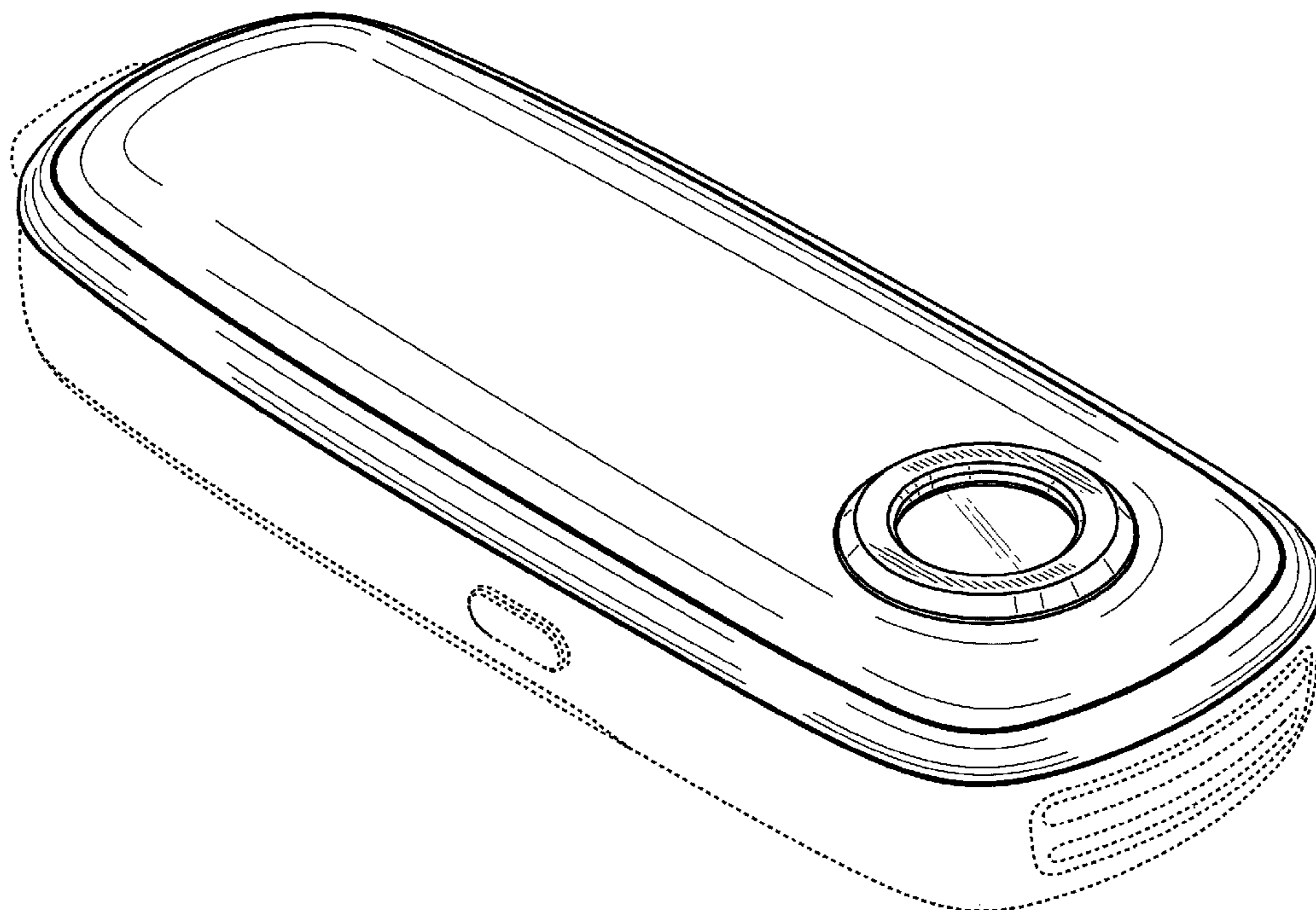
FIG. 4 is a left side elevational view of the removable top of FIG. 1, the right side elevational view is a mirror image thereof;

FIG. 5 is a rear elevational view of the removable top of FIG. 1;

FIG. 6 is a front elevational view of the removable top of FIG. 1; and,

FIG. 7 is a bottom plan view of the removable top of FIG. 1. The broken line showing of portable vaporizer in FIG. 1 is for the purpose of illustrating environmental structure and forms no part of the claimed design.

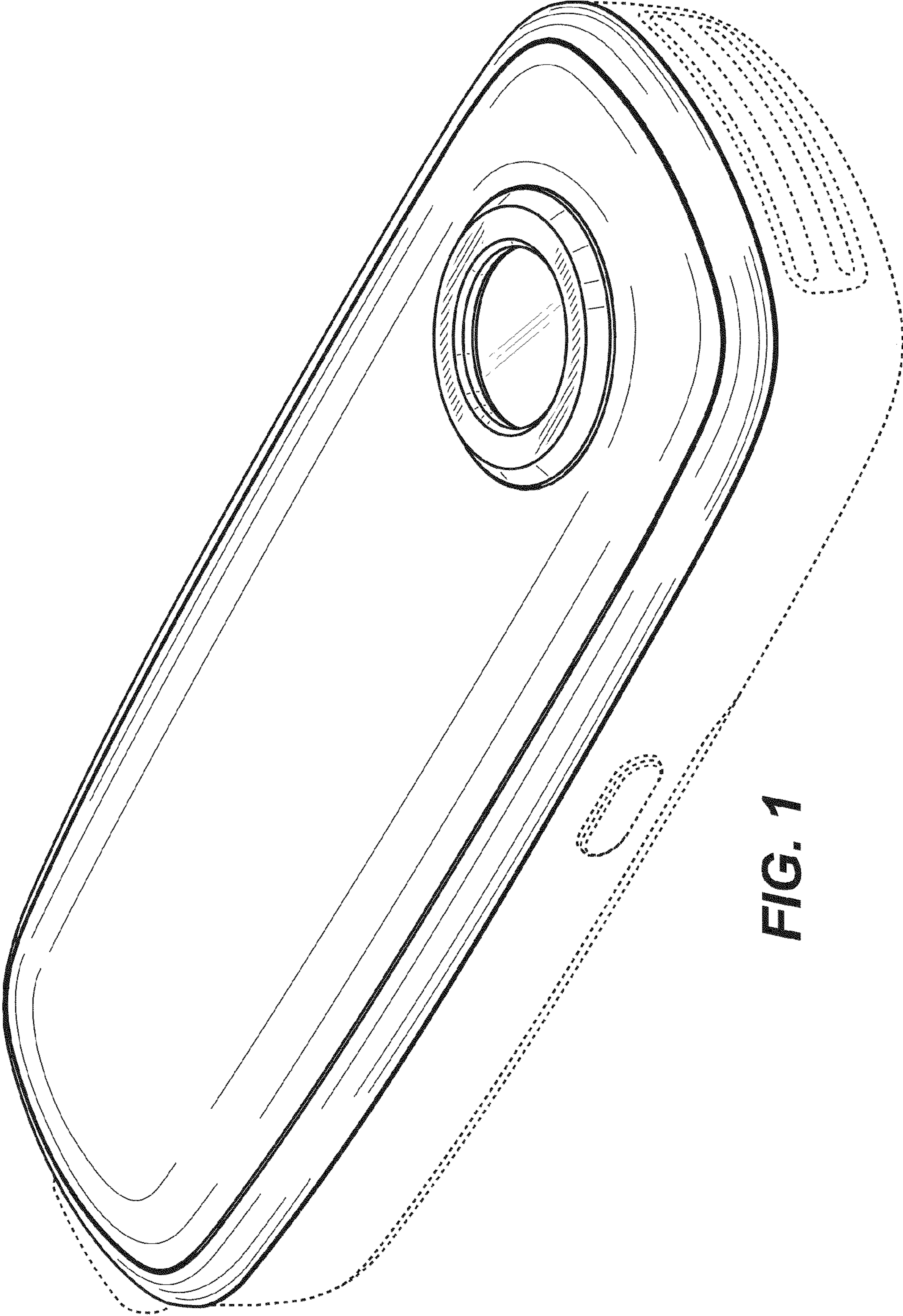

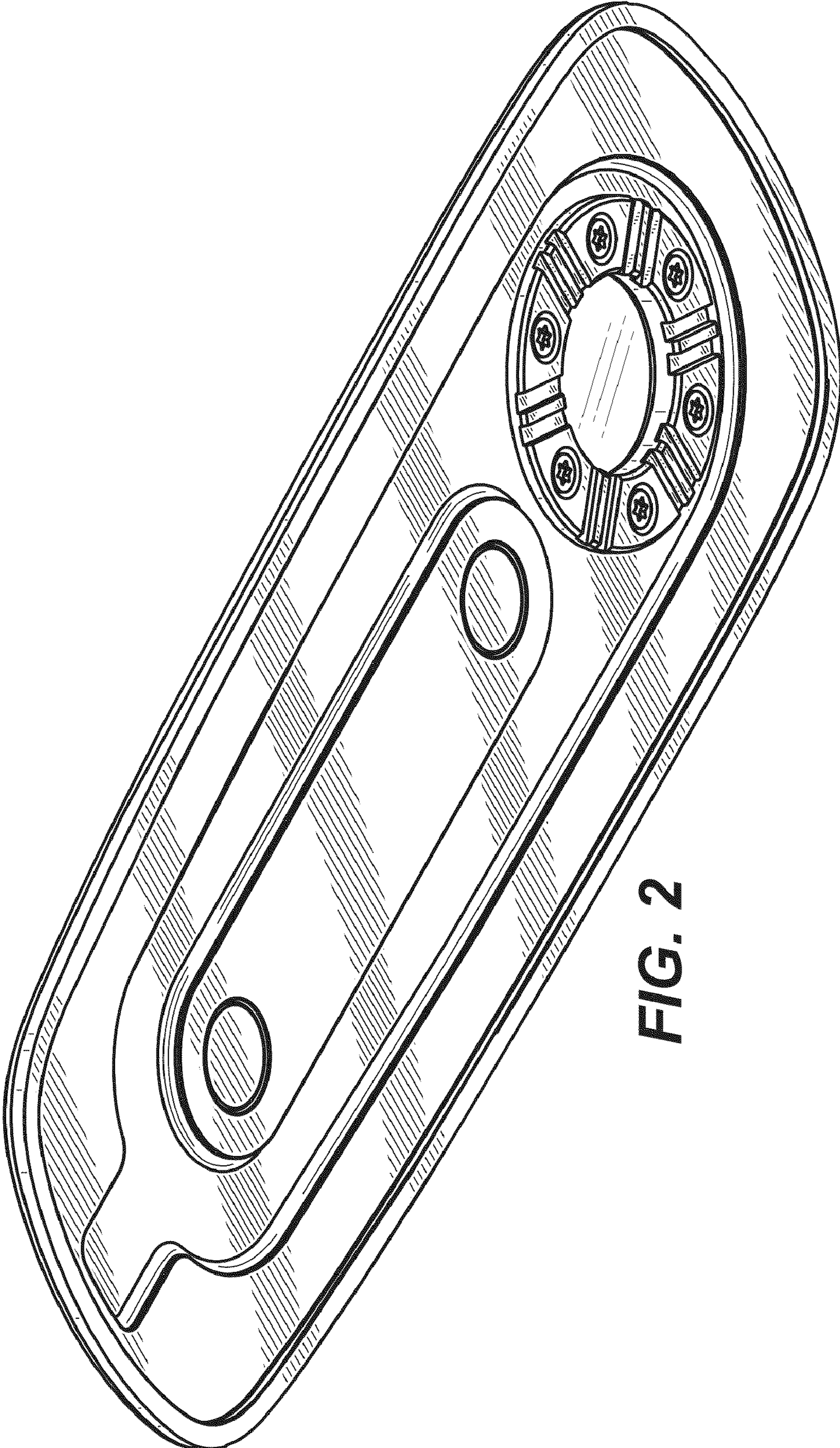
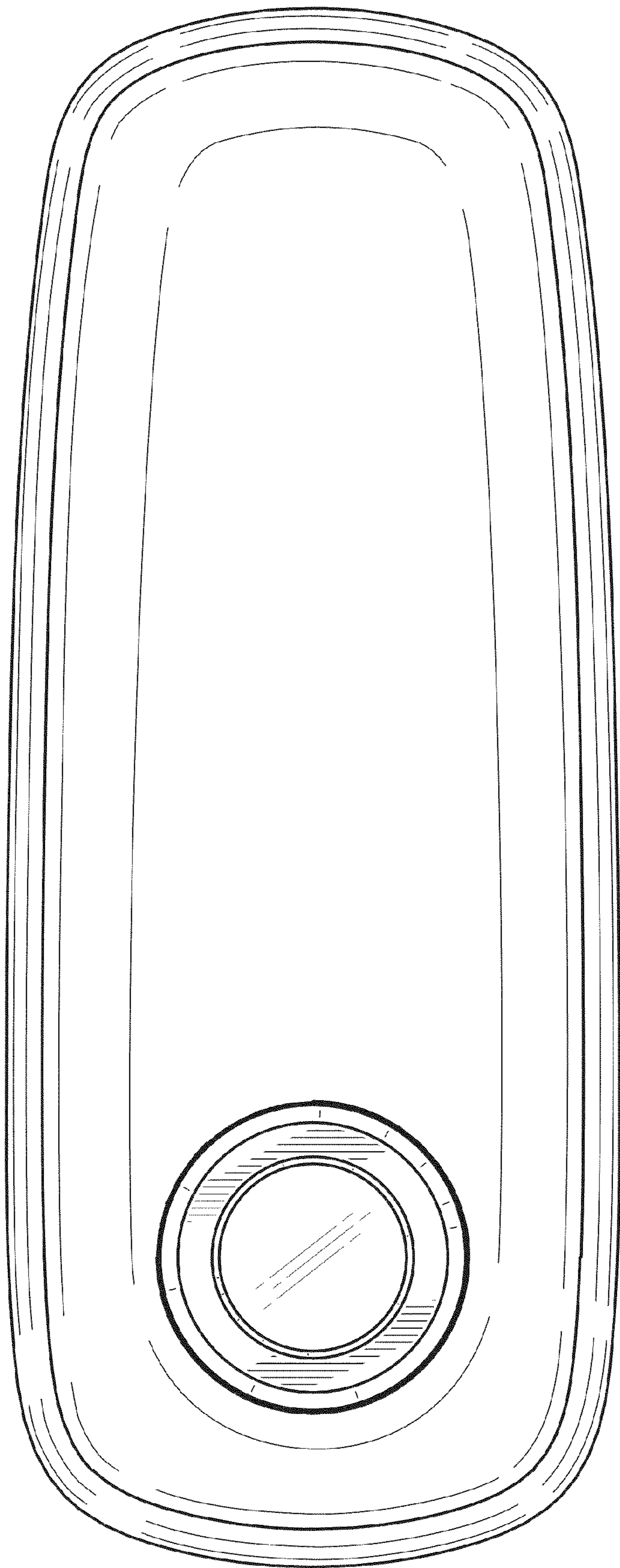
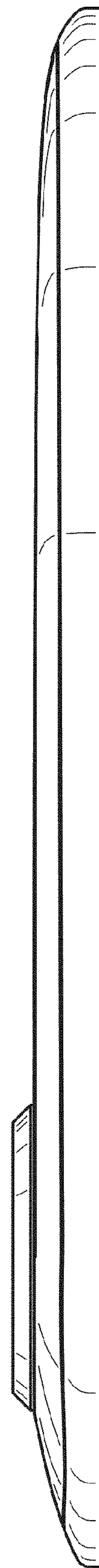


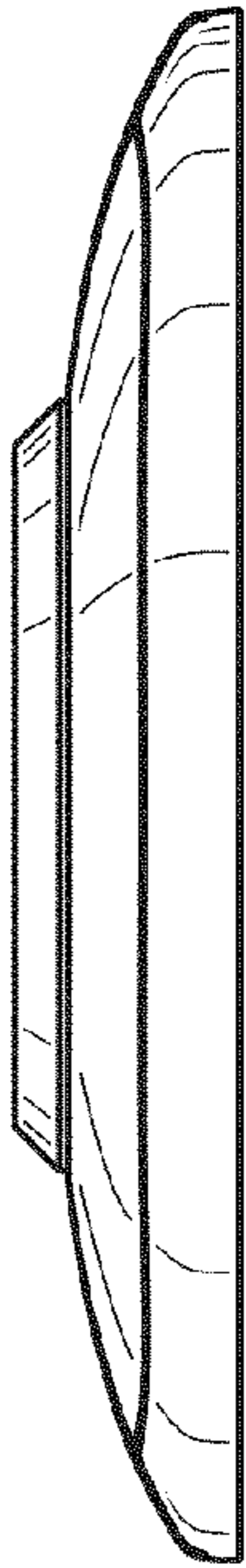

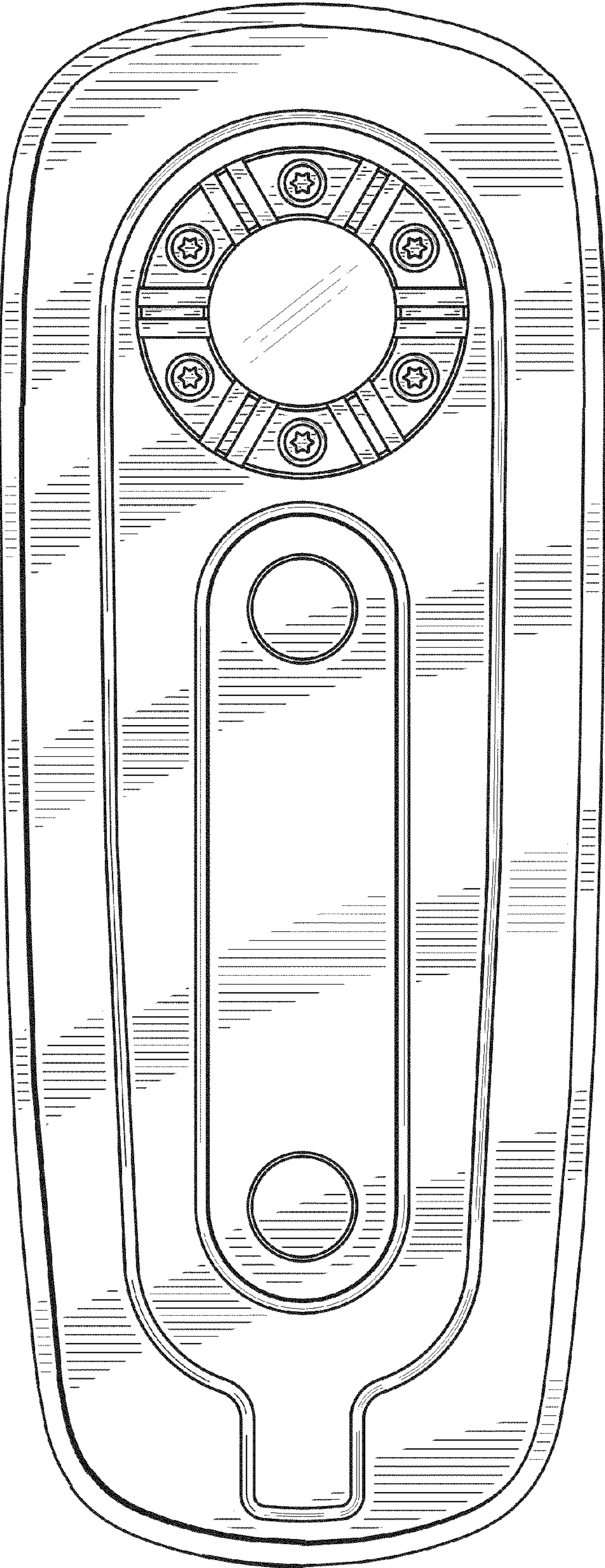
