FIG. 2 is a top view thereof;

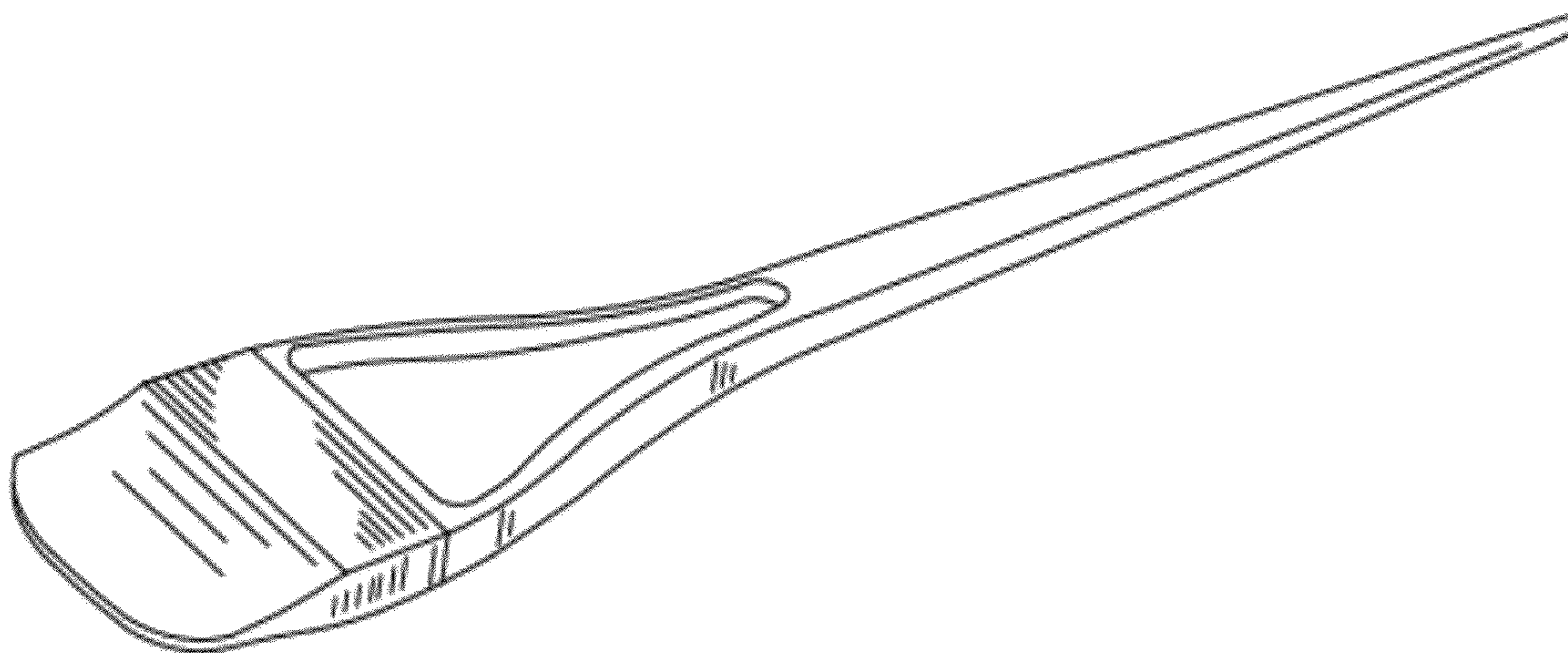
FIG. 3 is a cross-sectional view thereof;

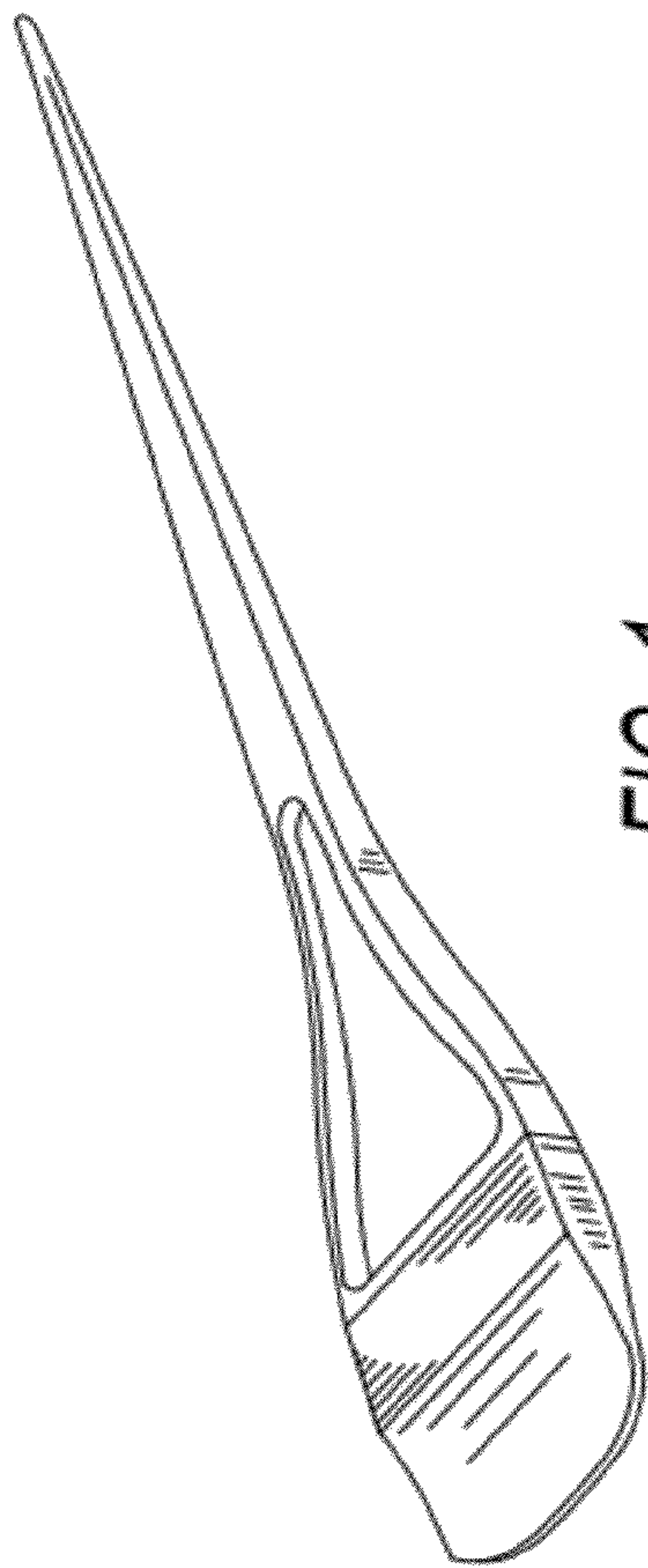

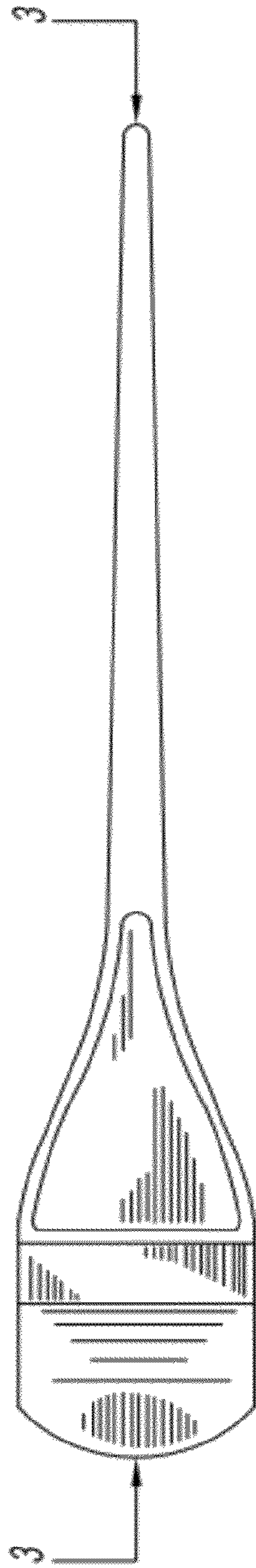

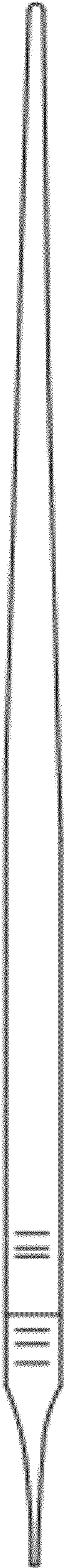
