(57) **CLAIM**

The ornamental design for a soleplate for an electric iron, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an embodiment of a soleplate for an electric iron.

FIG. 2 is a left side elevational view of the soleplate for an electric iron of FIG. 1.

FIG. 3 is a right side elevational view of the soleplate for an electric iron of FIG. 1.

FIG. 4 is a front elevational view of the soleplate for an electric iron of FIG. 1.

FIG. 5 is a back elevational view of the soleplate for an electric iron of FIG. 1.

FIG. 6 is a top plan view of the soleplate for an electric iron of FIG. 1; and,

FIG. 7 is bottom plan view of the soleplate for an electric iron of FIG. 1.

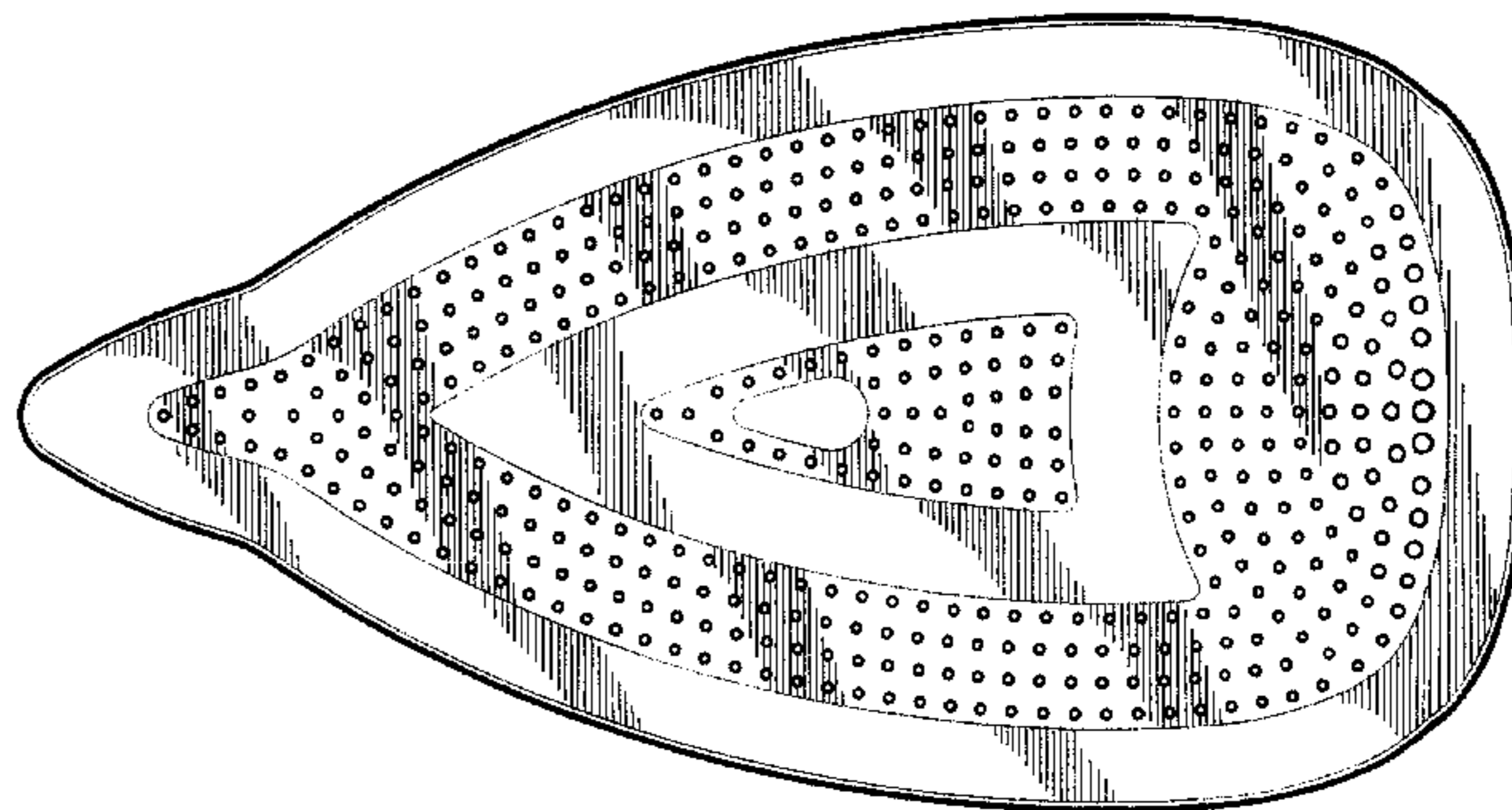
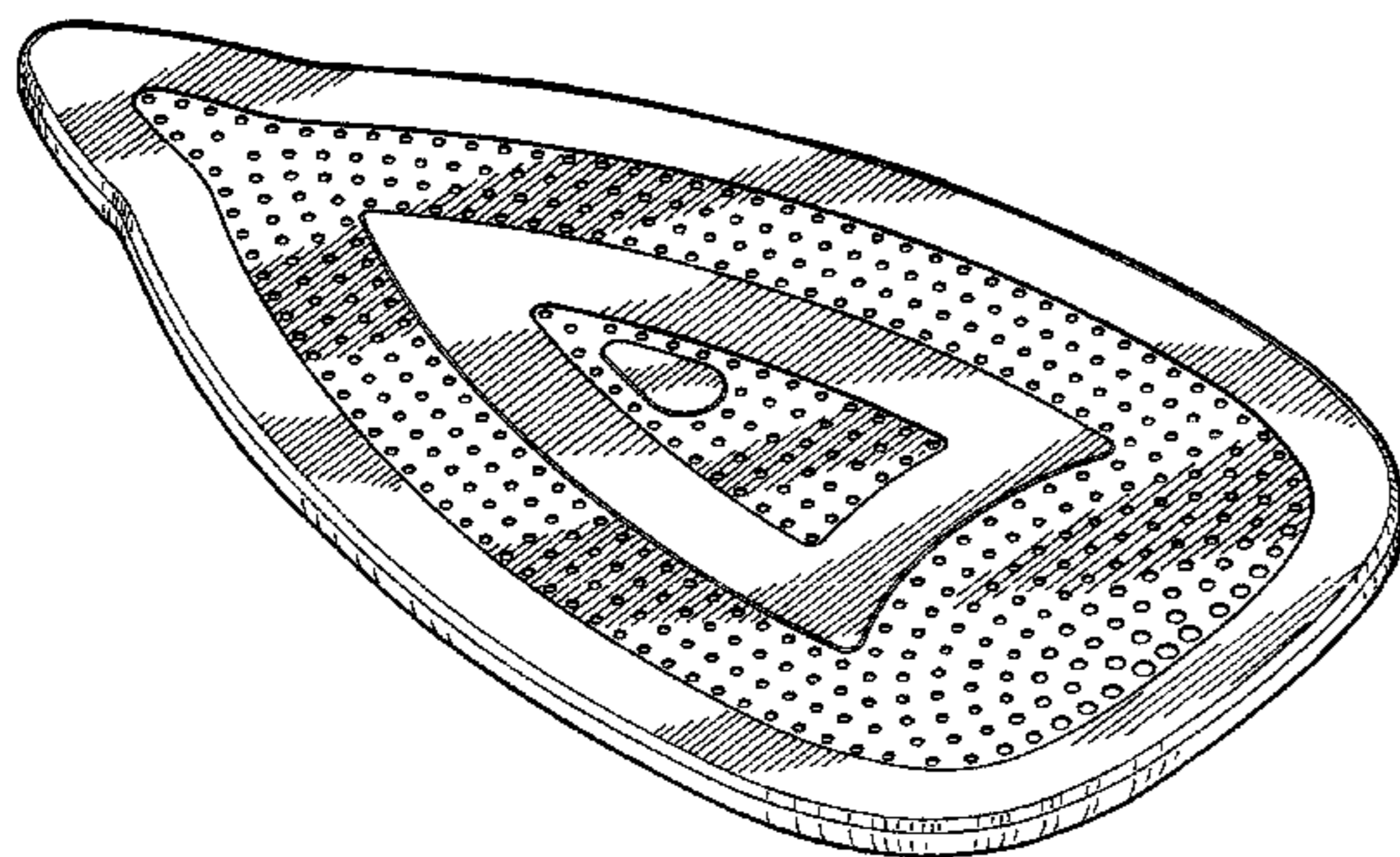
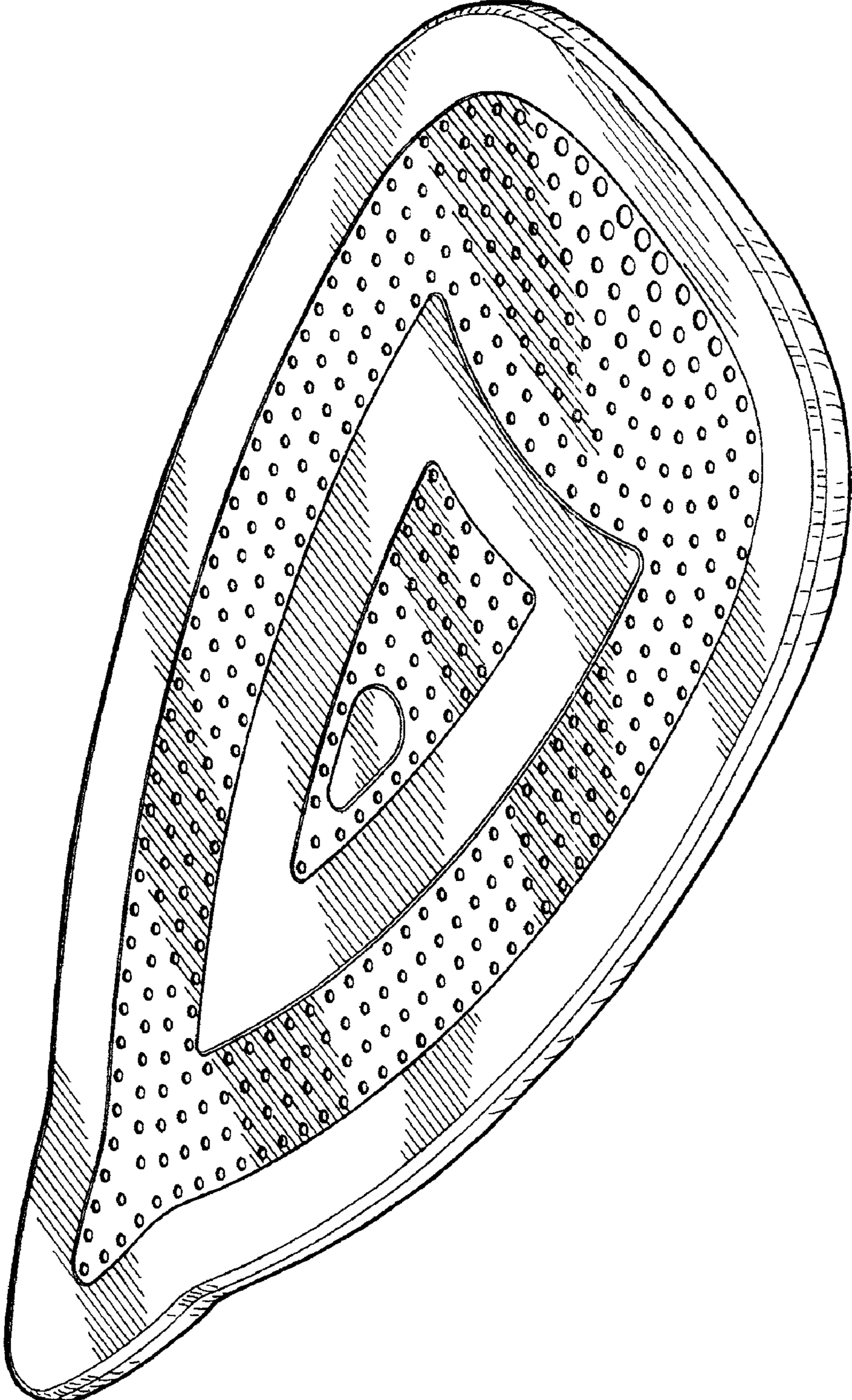

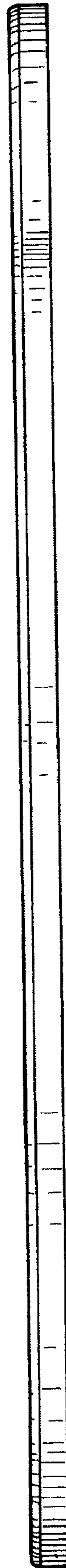

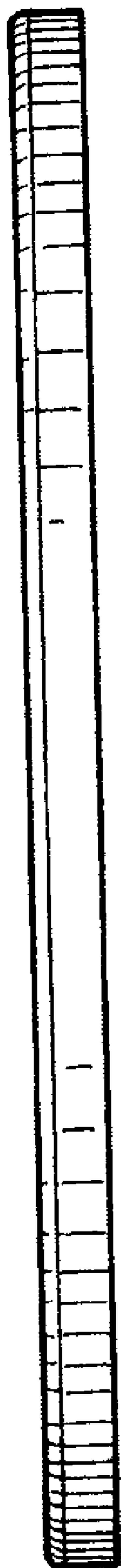

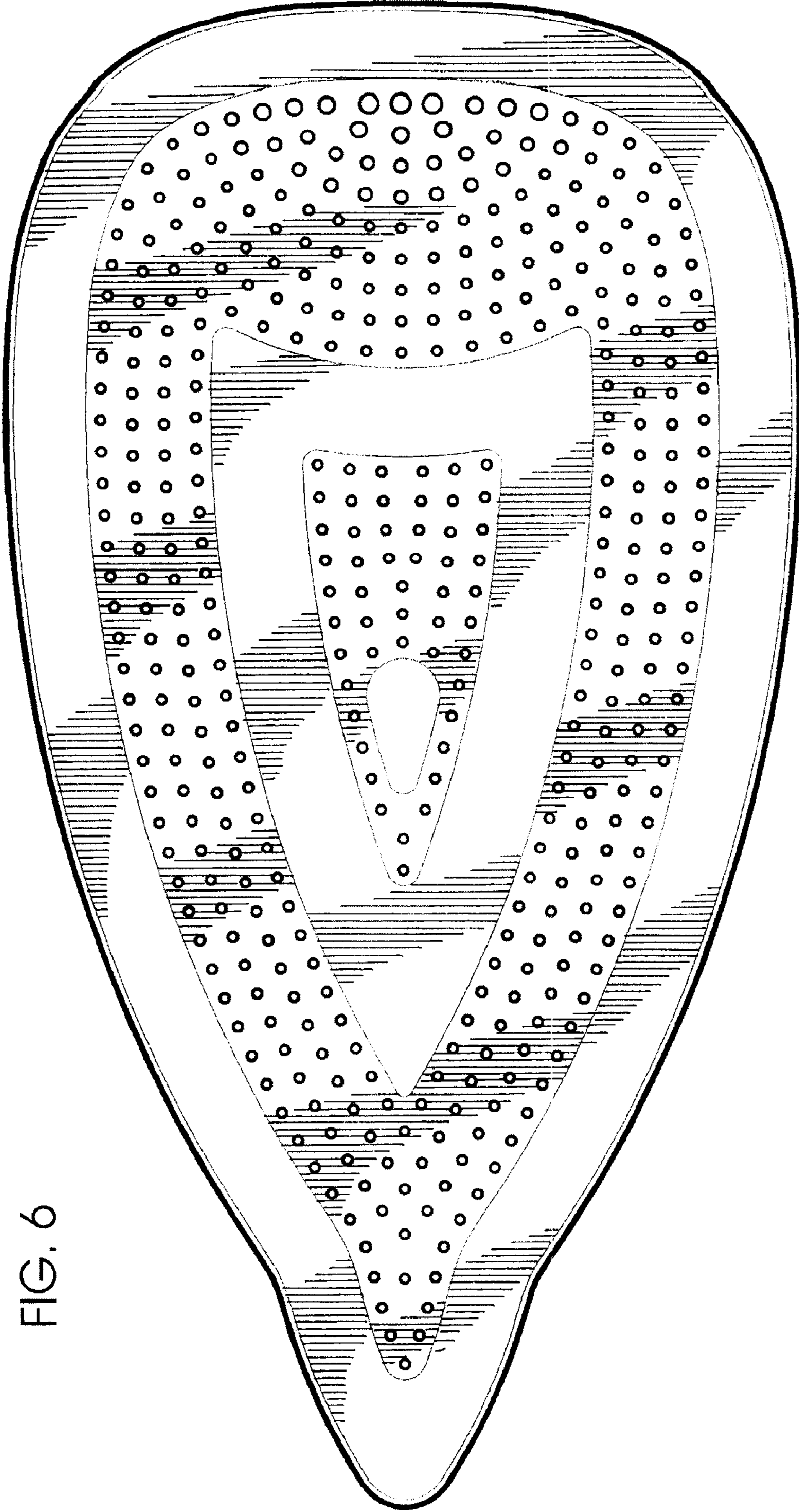

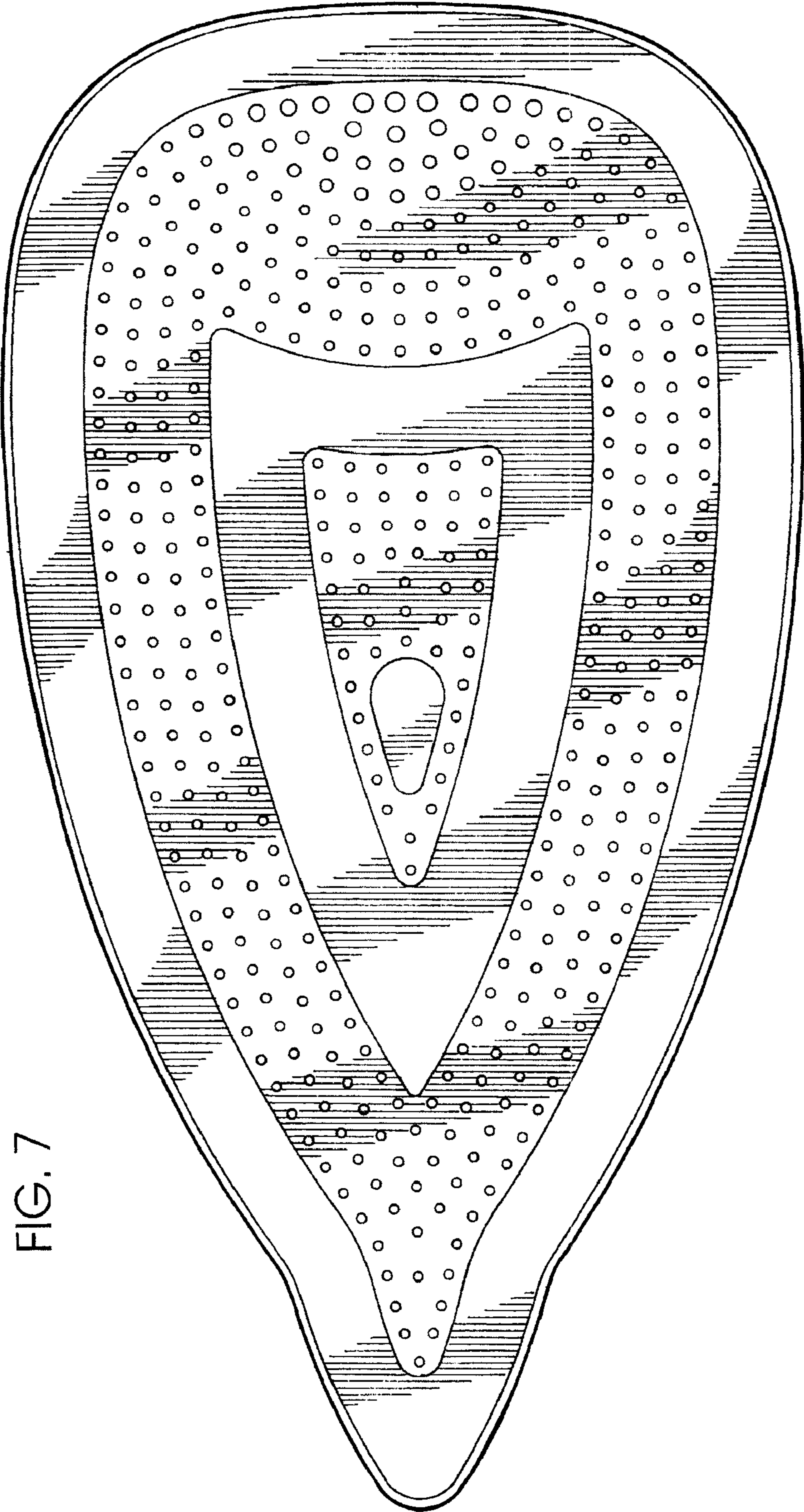
