DESCRIPTION

FIG. 1 is a top perspective view of a handle for towel dispenser showing our new design;

FIG. 2 is a front elevation view of the handle for towel dispenser of FIG. 1;

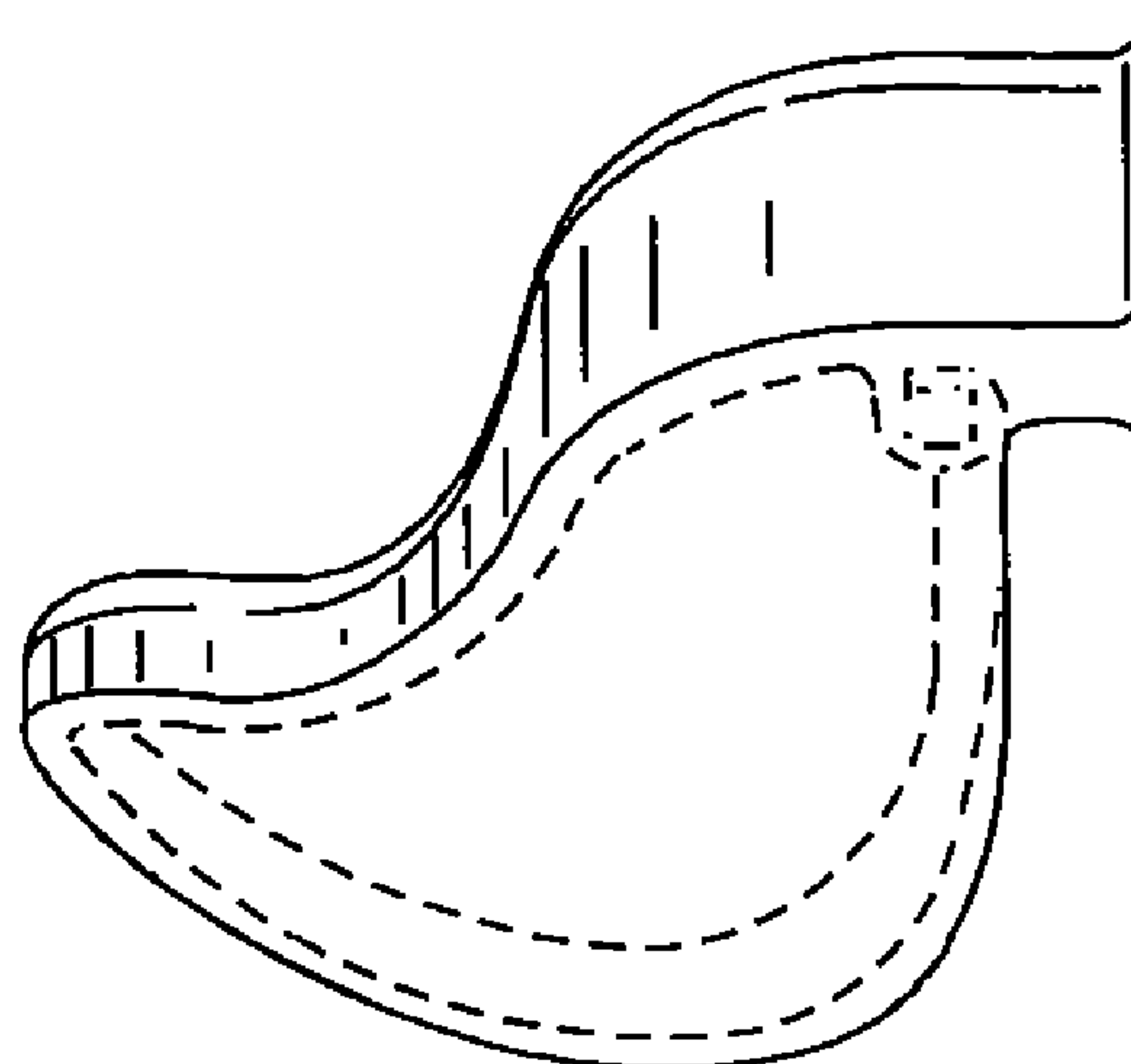
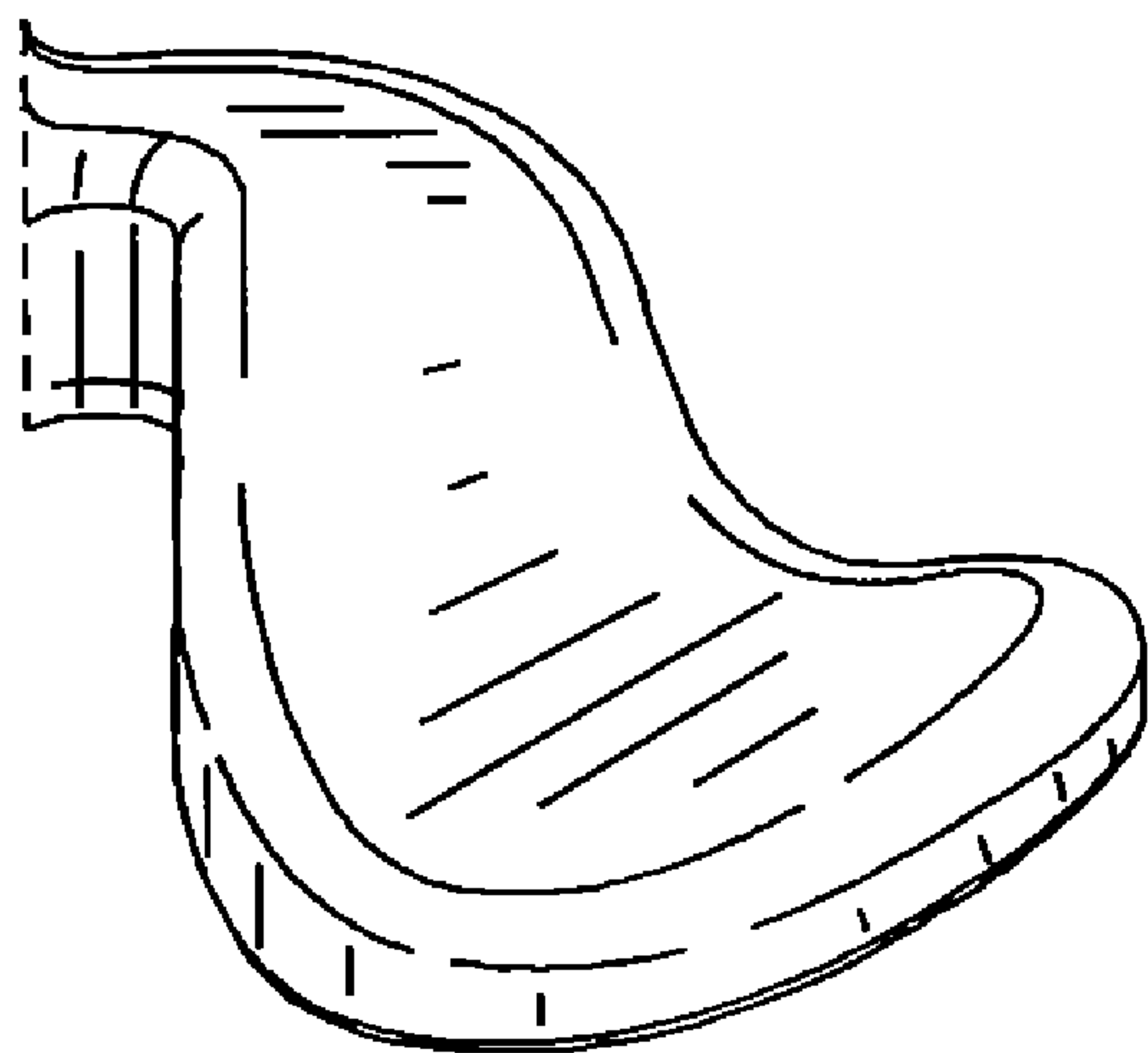
FIG. 3 is a rear elevation view of the handle for towel dispenser of FIG. 1;

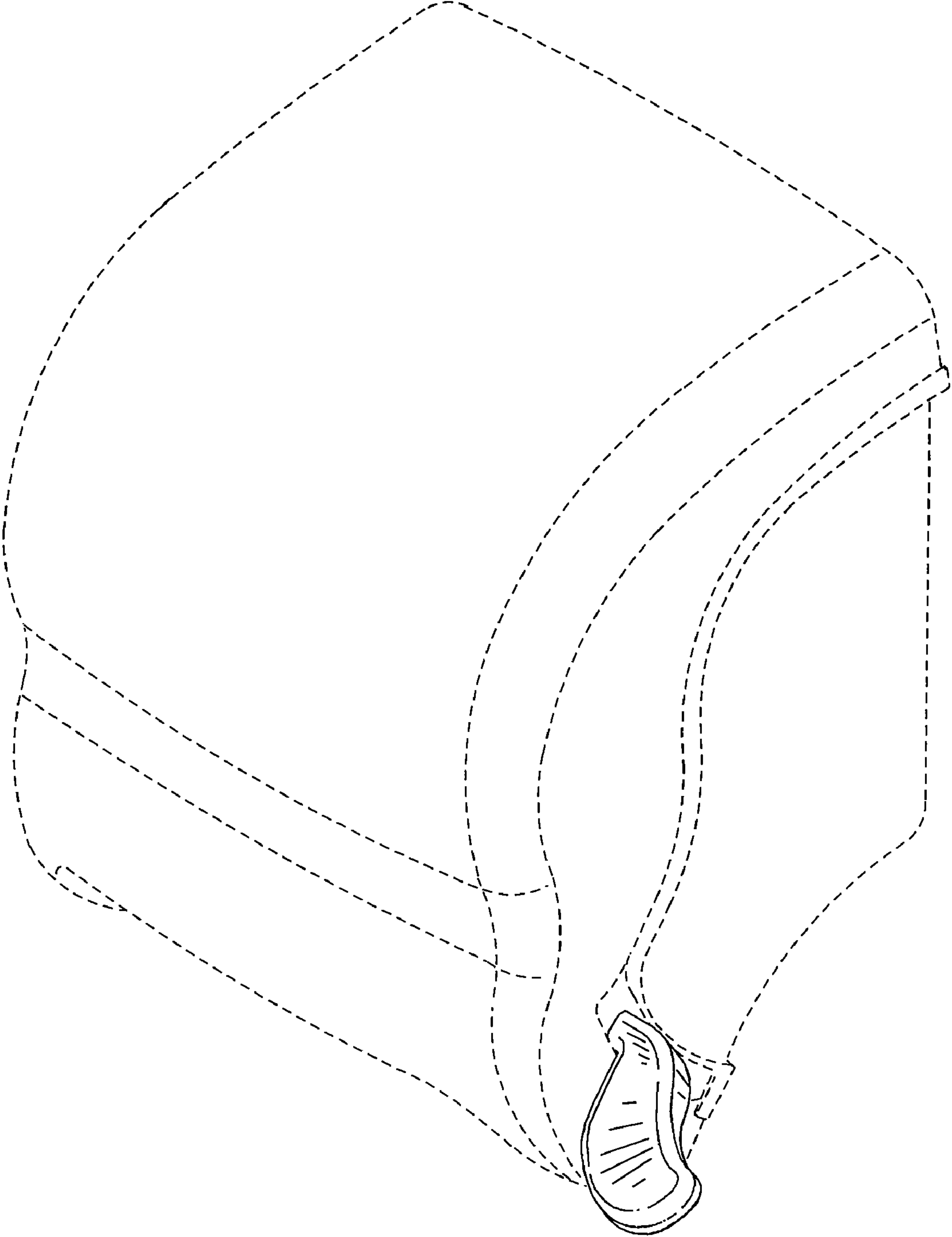

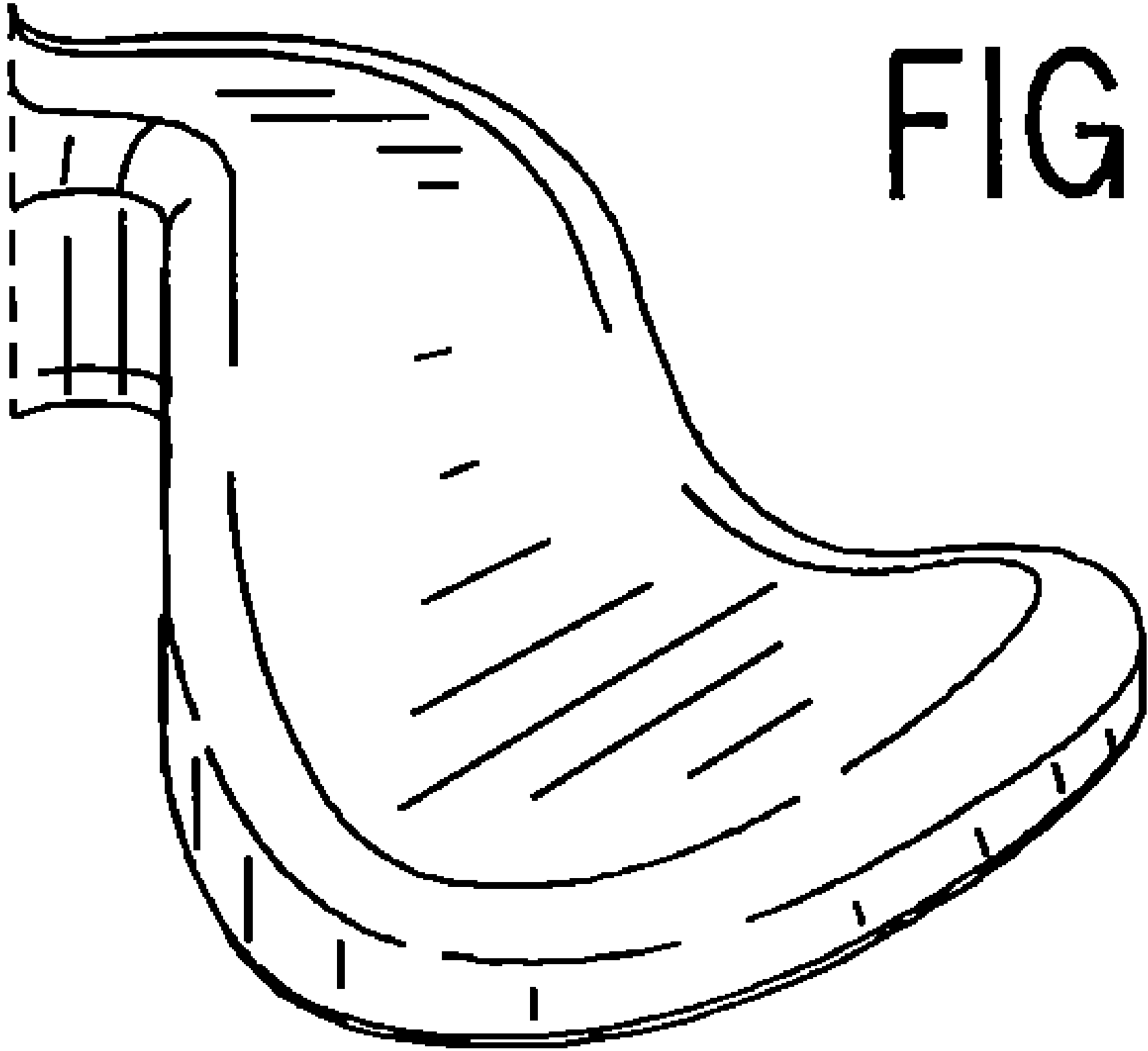

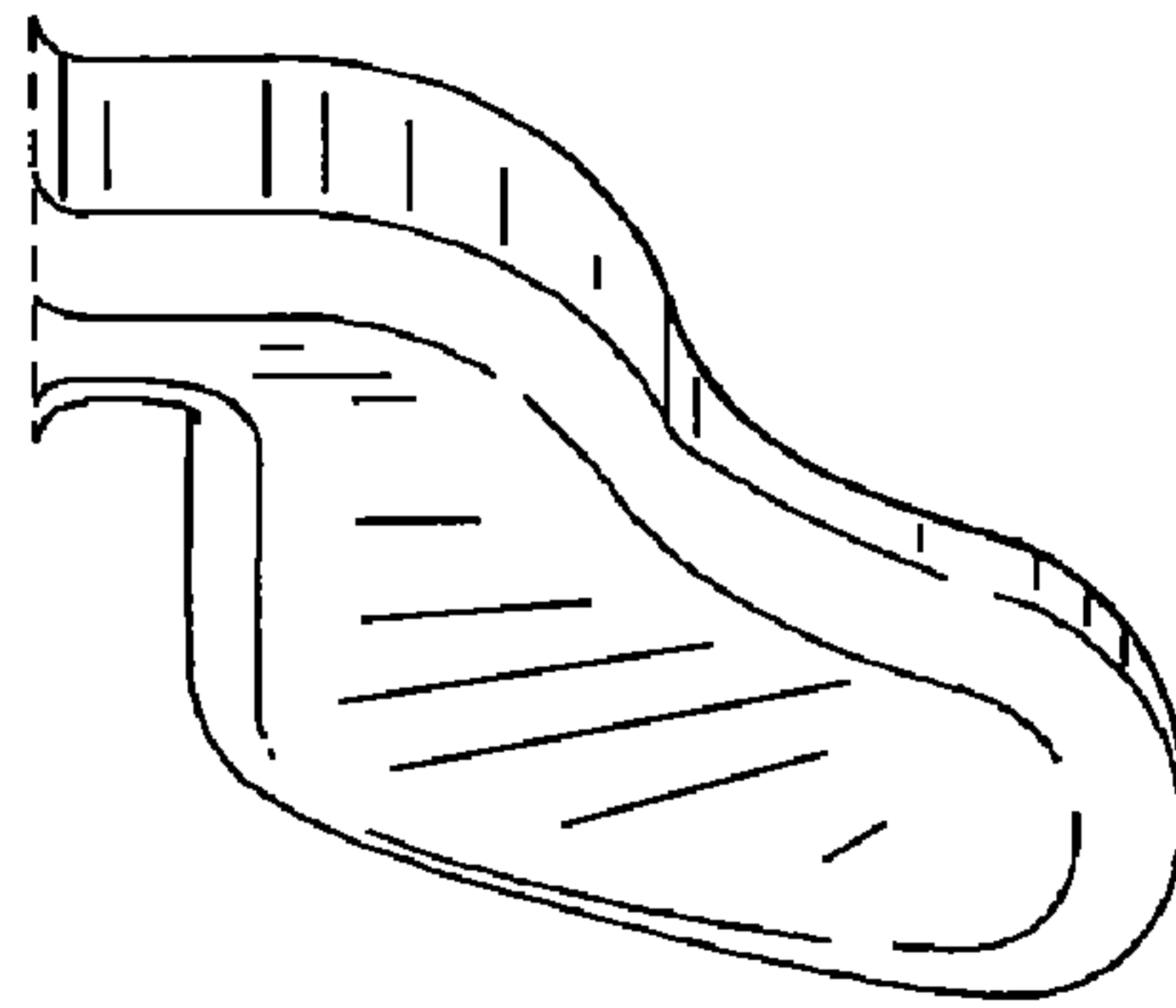
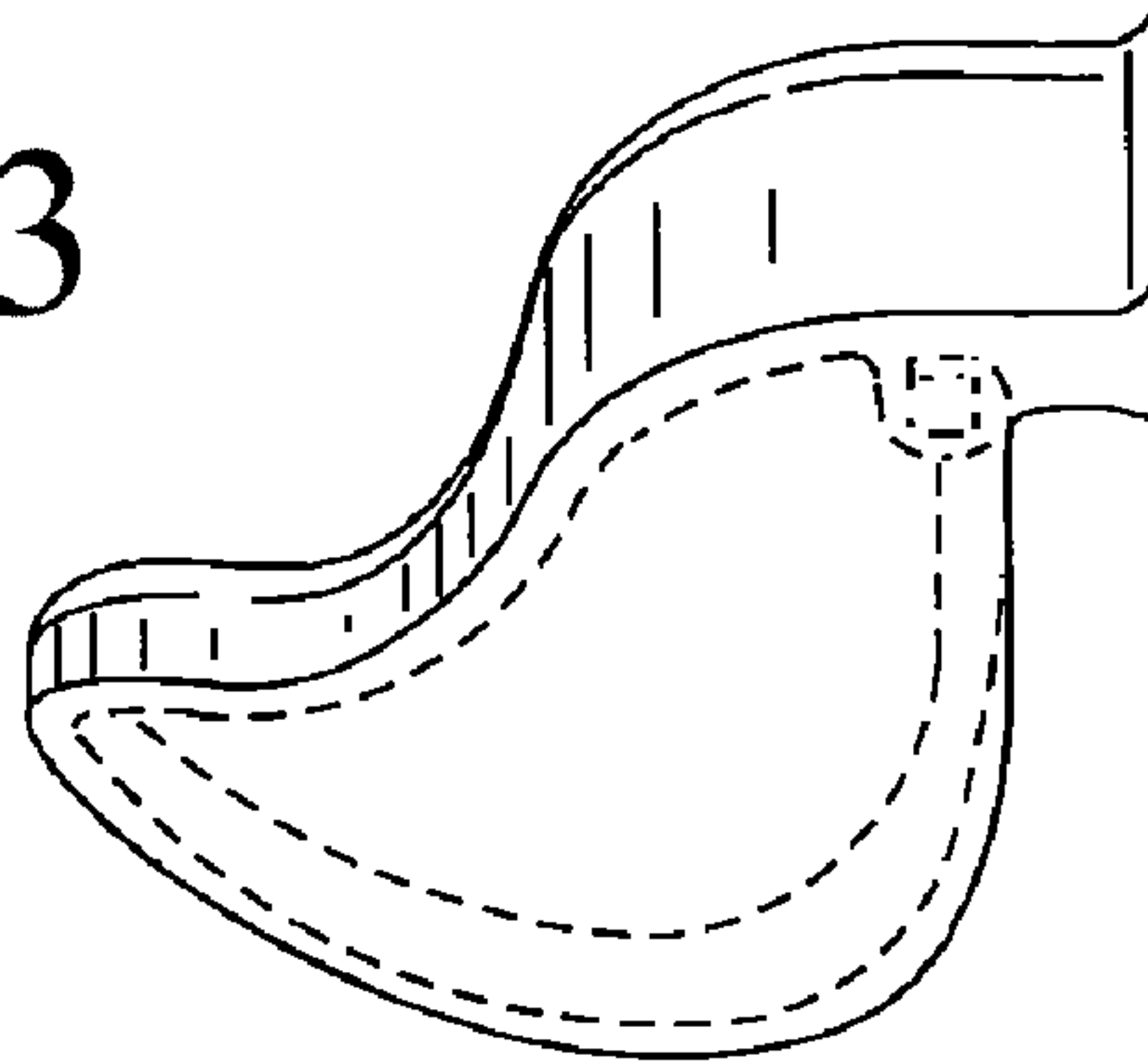
