**DESCRIPTION**

FIG. 1 is a front perspective view of a modular grid, showing our new design.

FIG. 5 is a rear elevation view of the modular grid of FIG. 1.

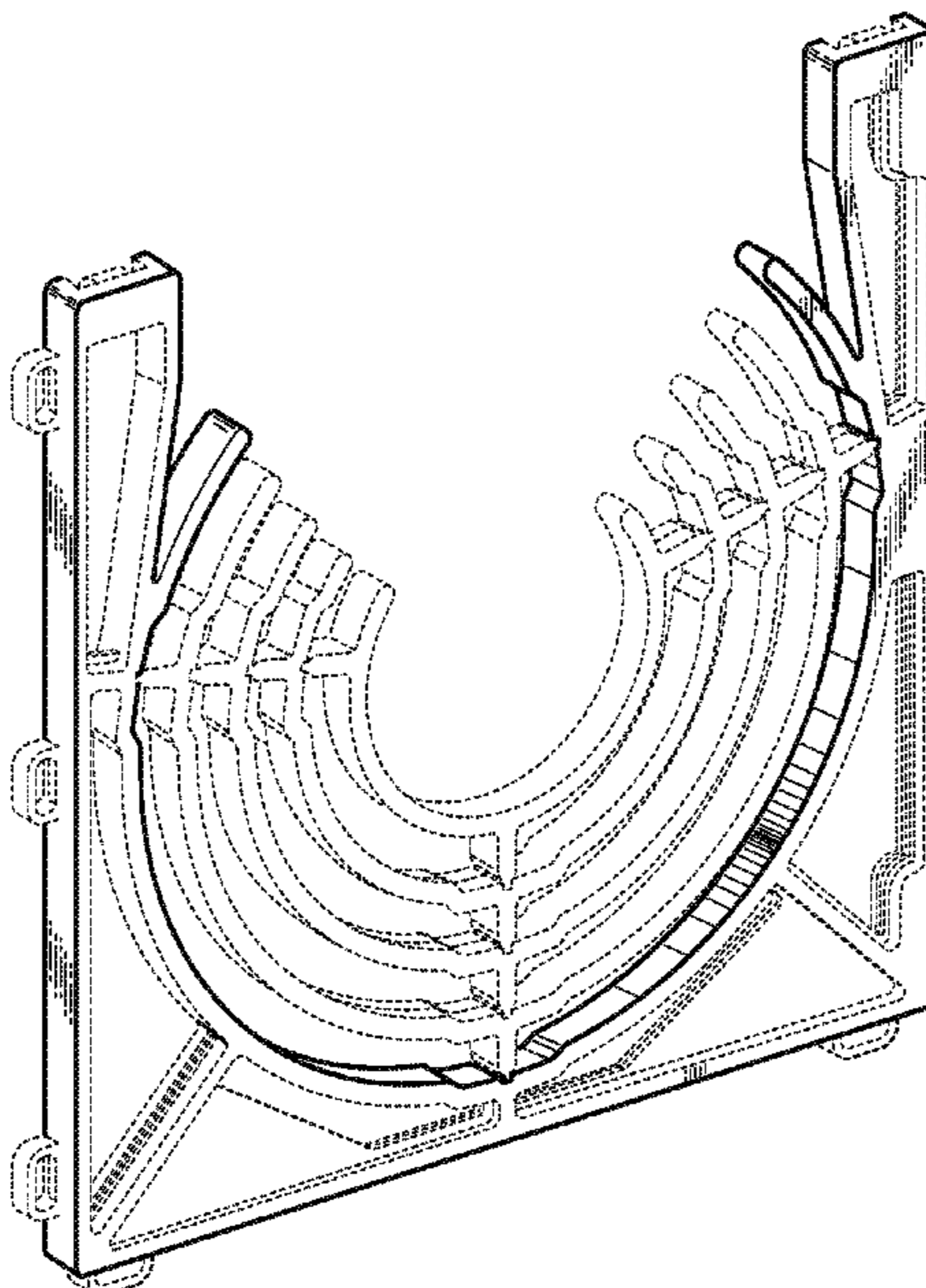
FIG. 6 is a top plan view of the modular grid of FIG. 1.

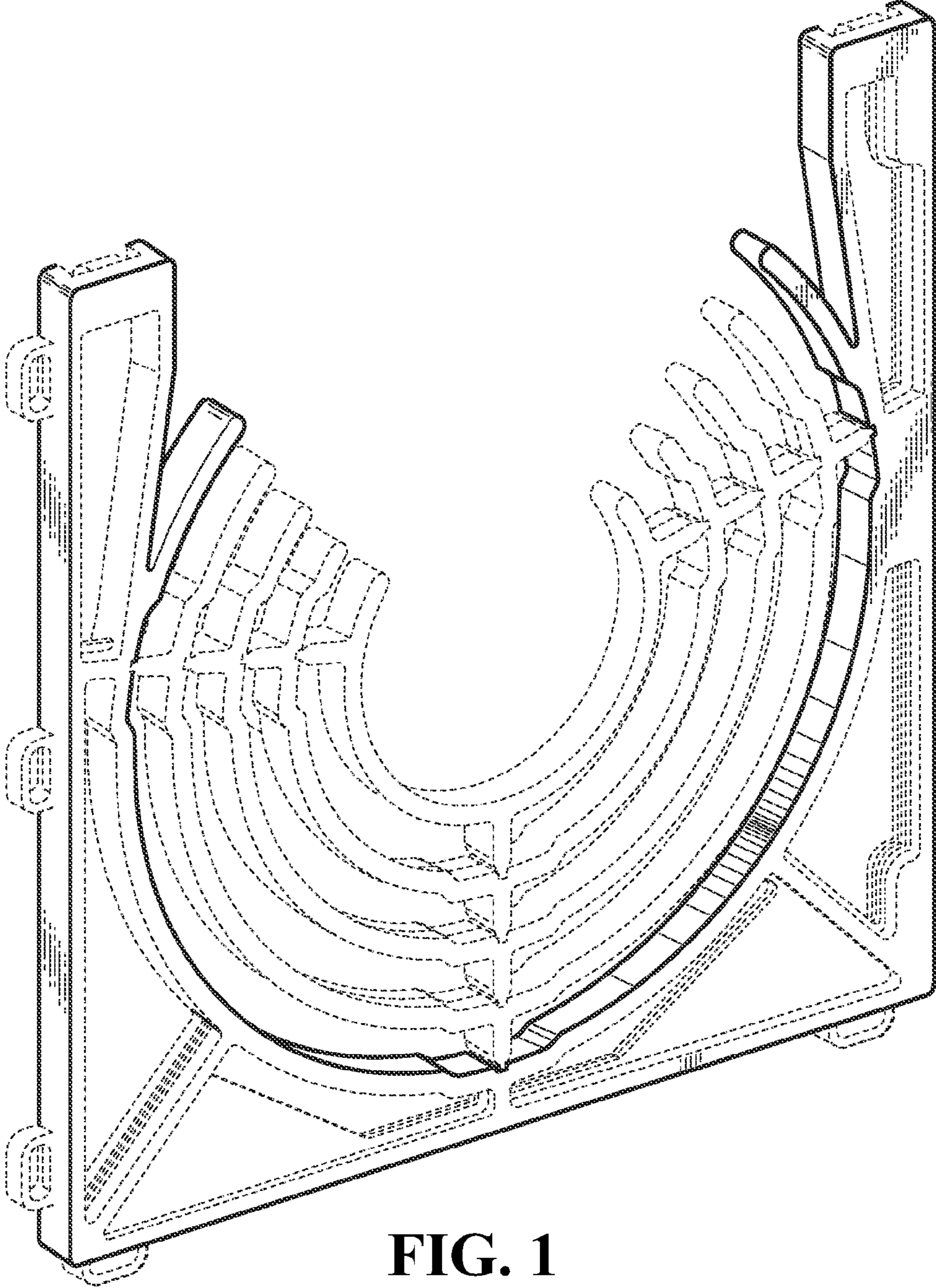
FIG. 7 is a bottom plan view of the modular grid of FIG. 1; and,

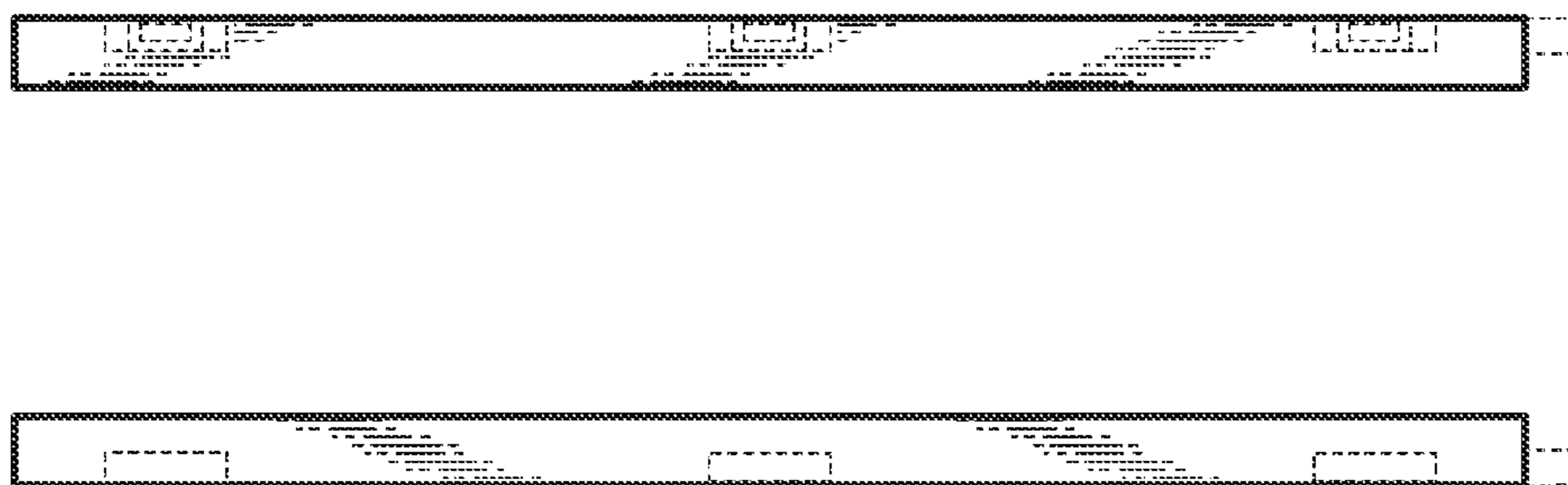


FIG. 2 FIG. 3



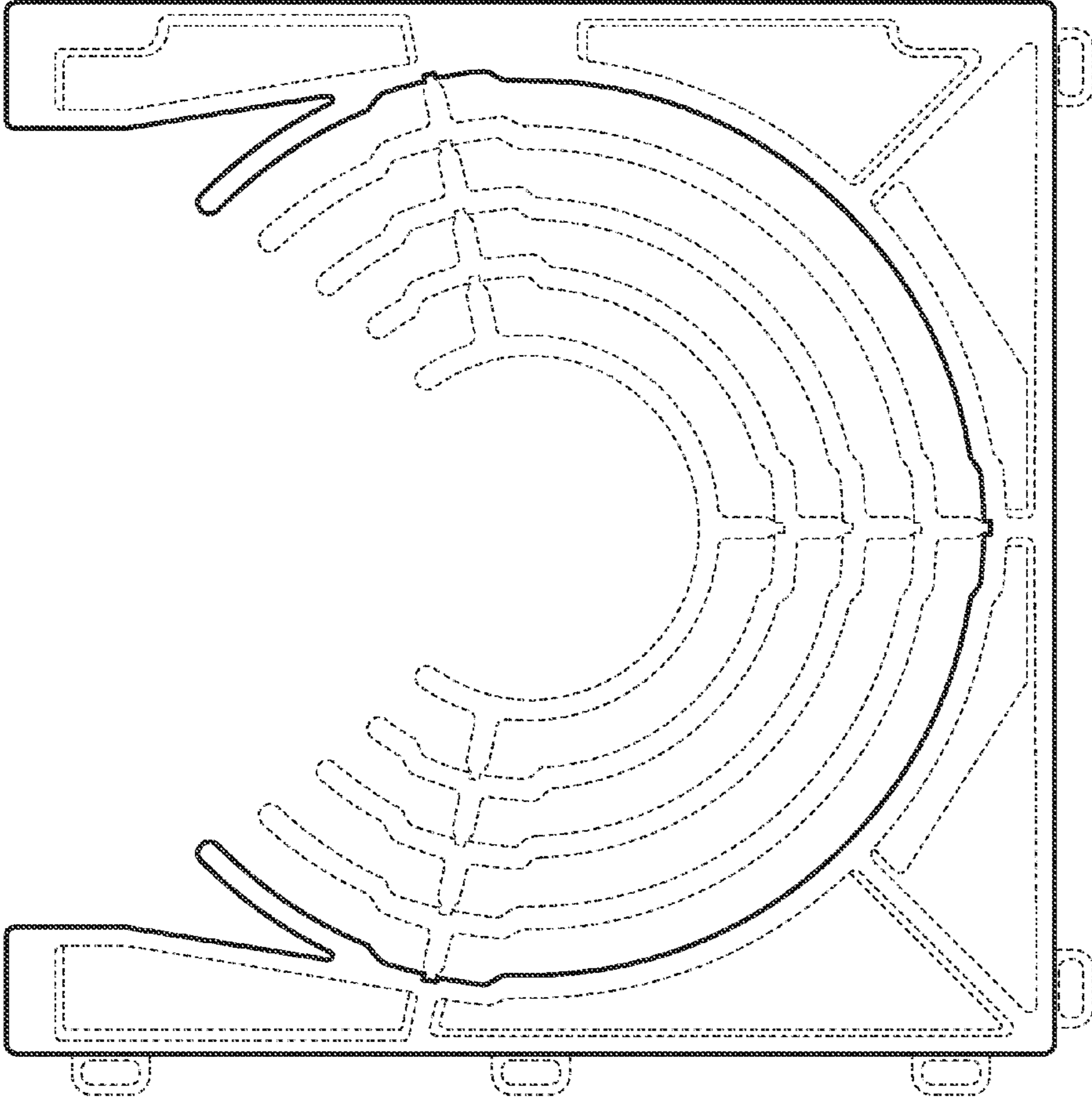

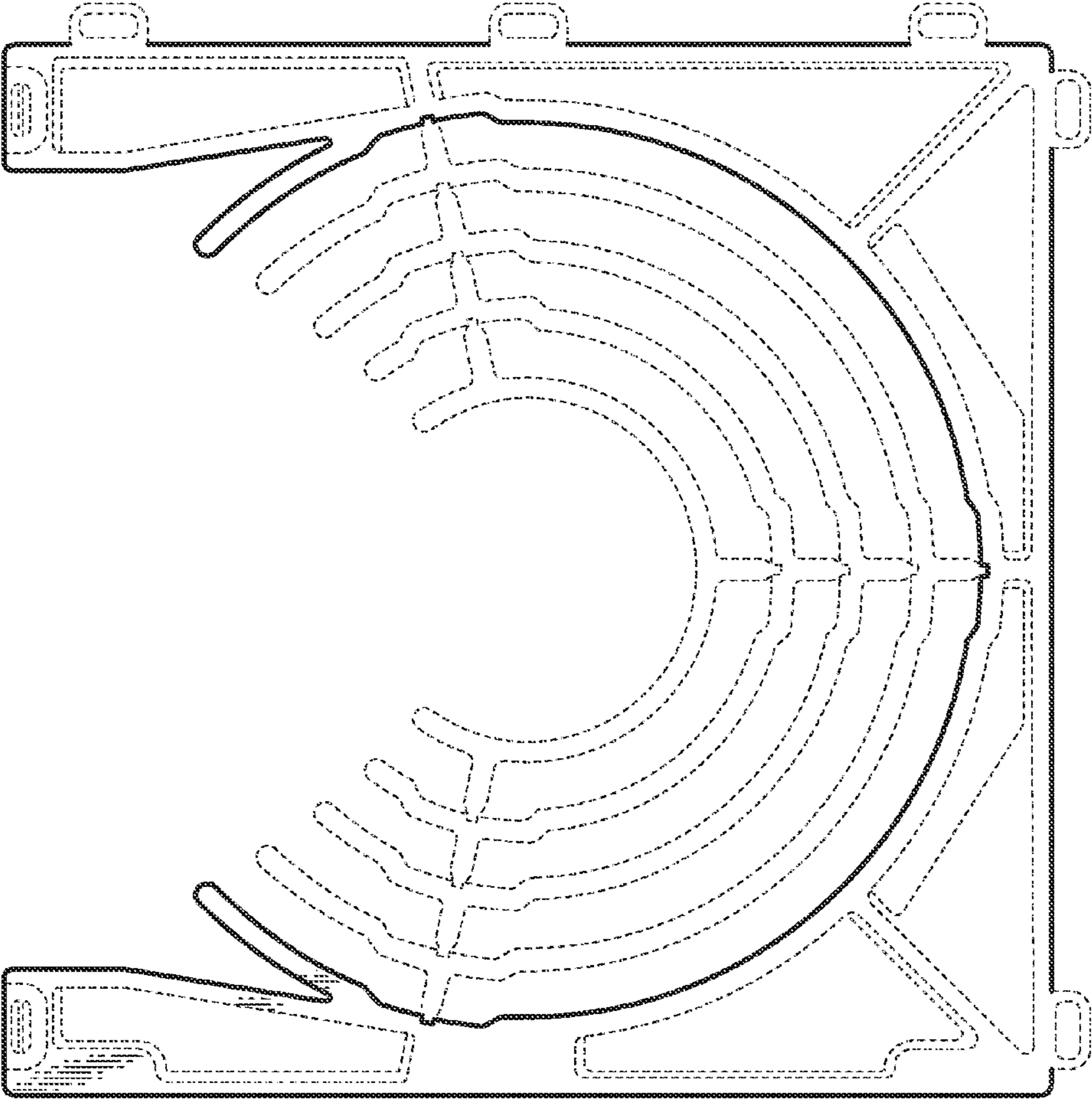

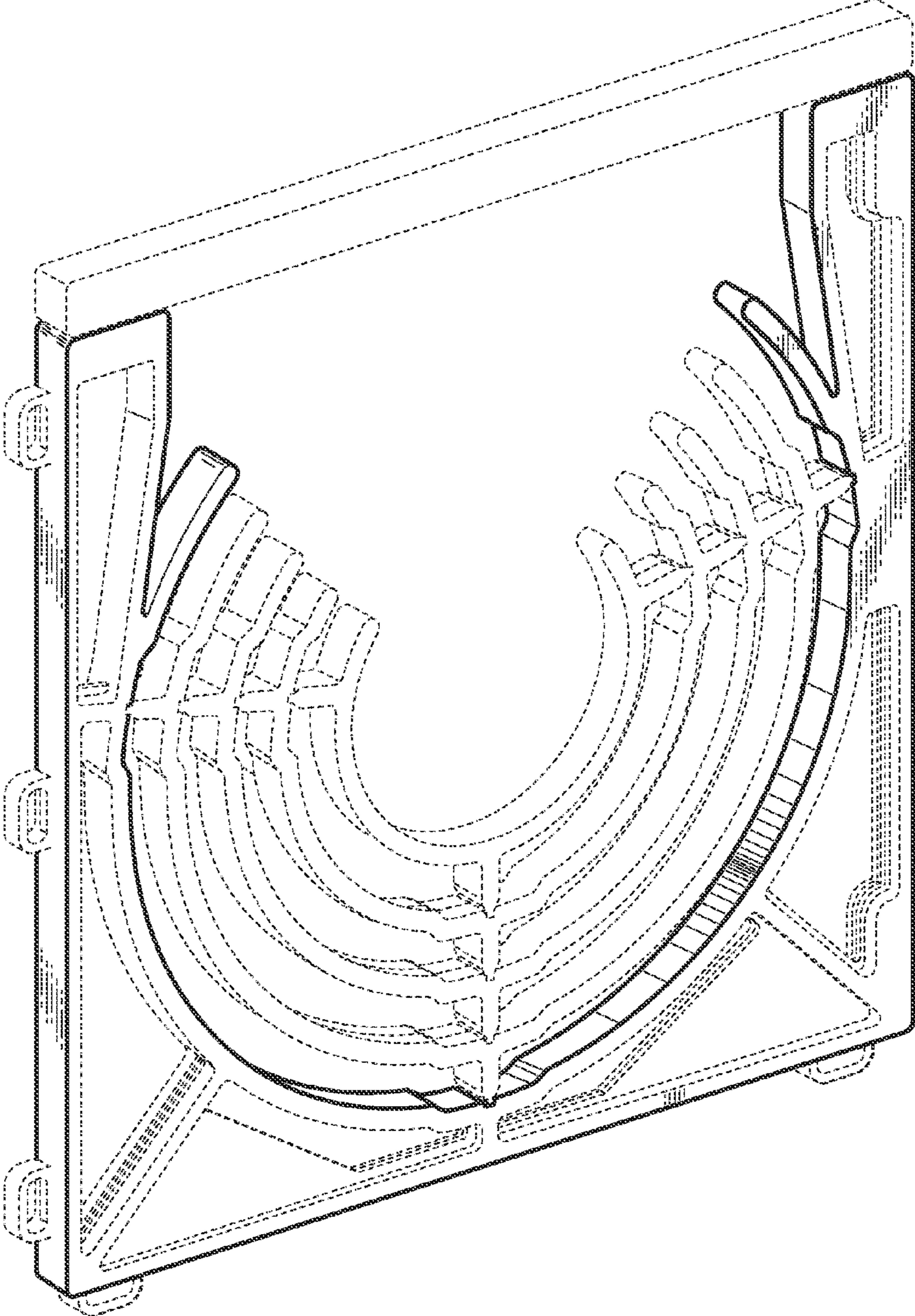
