The ornamental design for a flow wrap for a container with surface ornamentation, as shown and described.

FIG. 11 is a top plan view thereof;

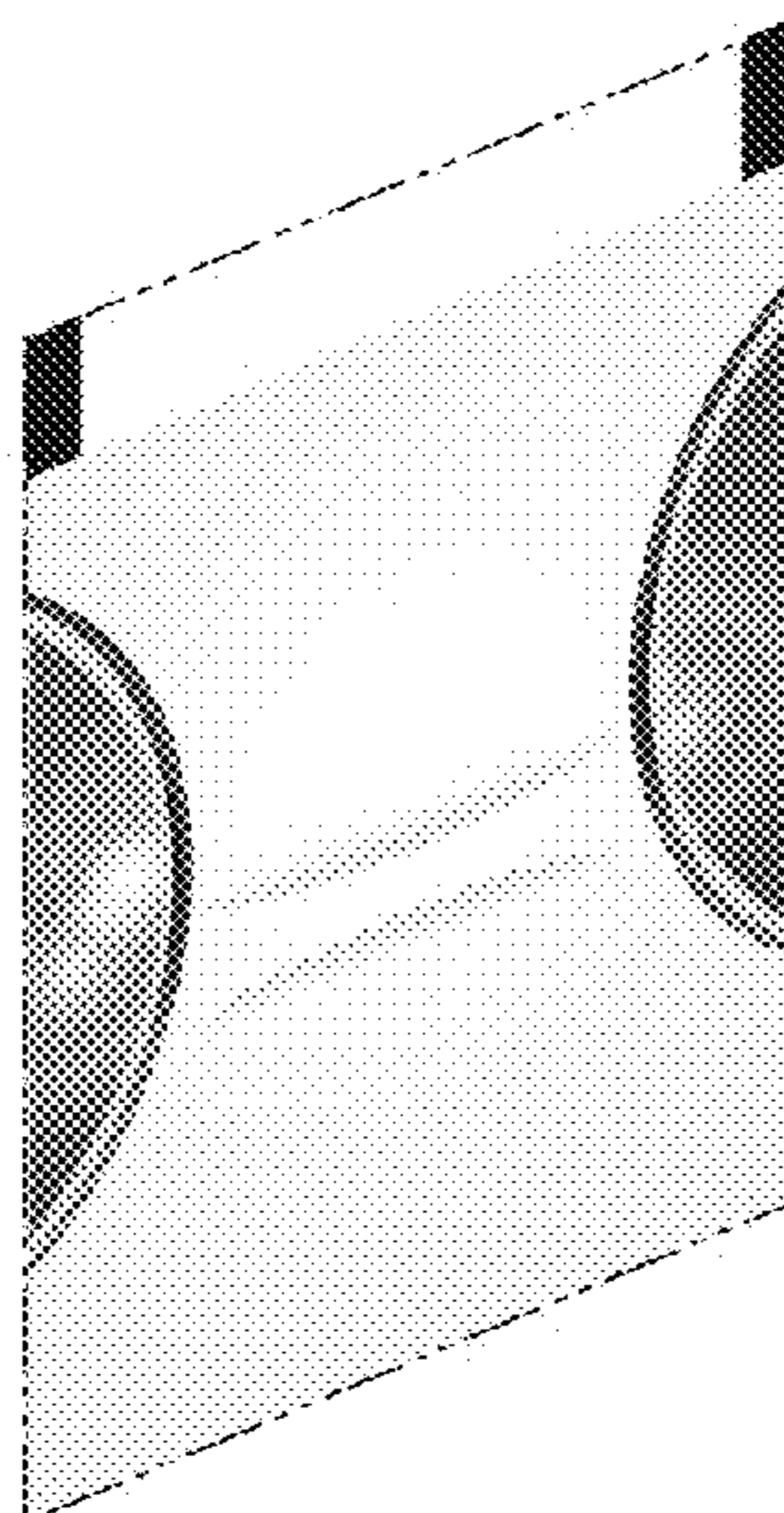
FIG. 12 is a bottom plan view thereof;

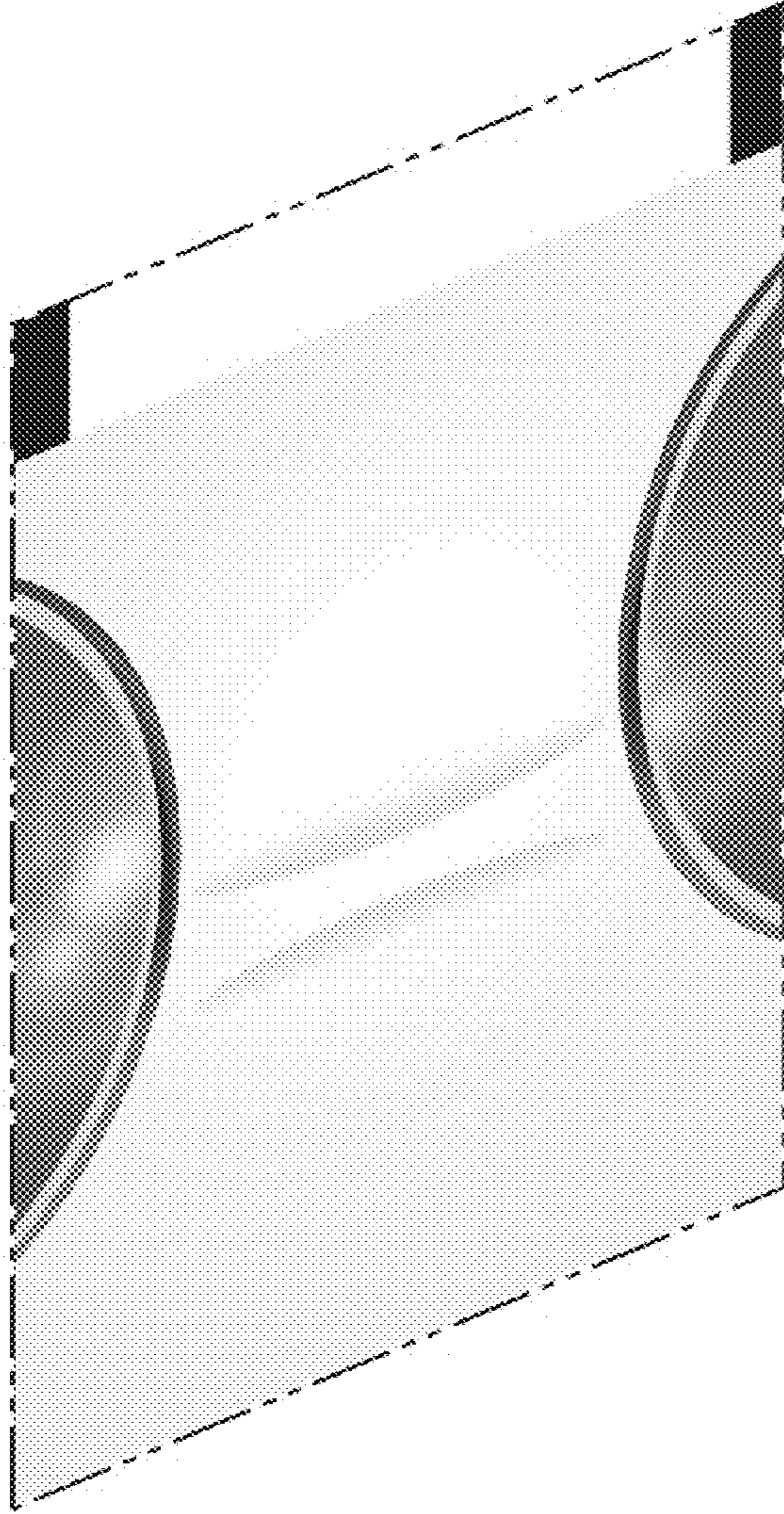

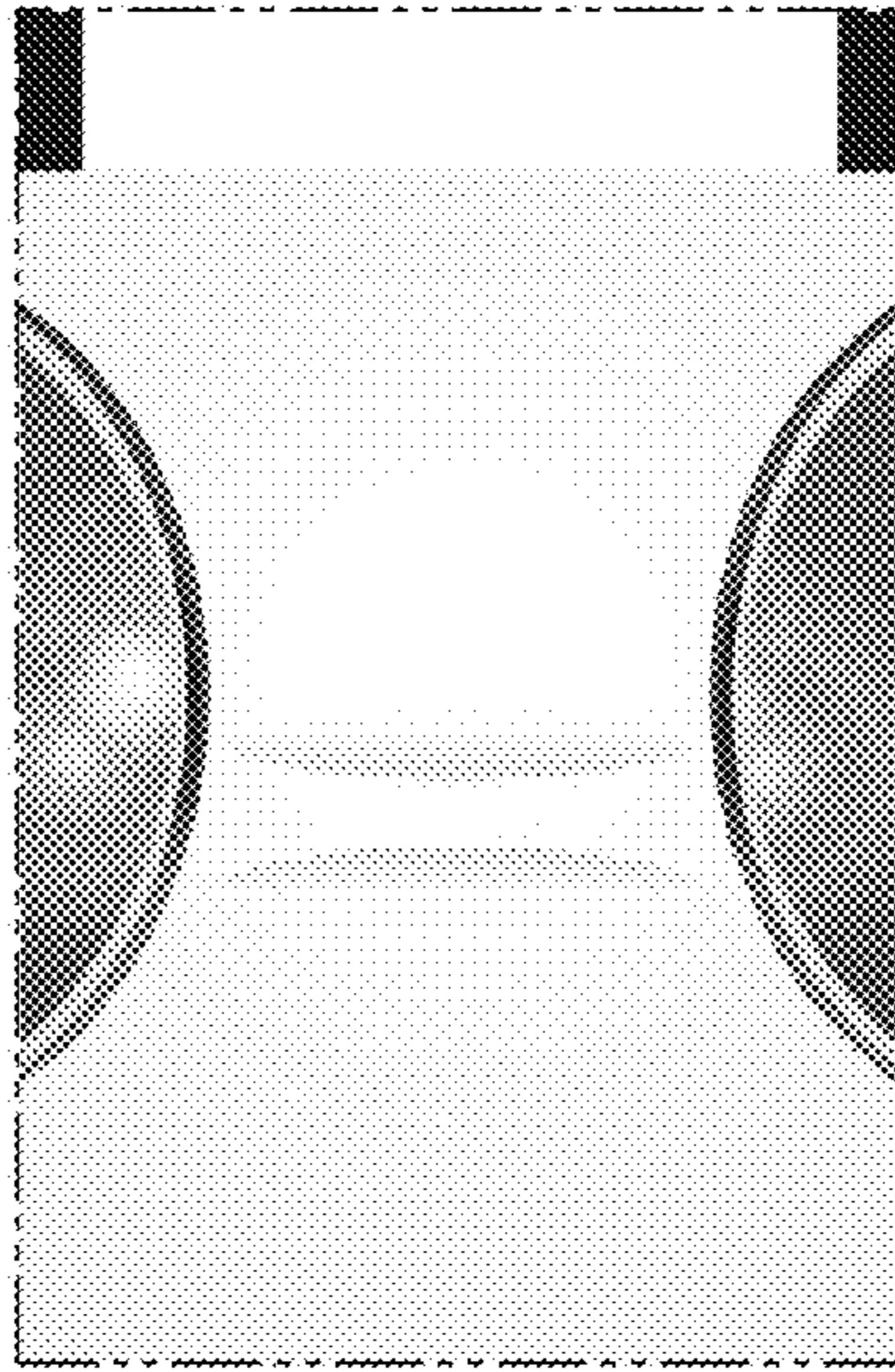

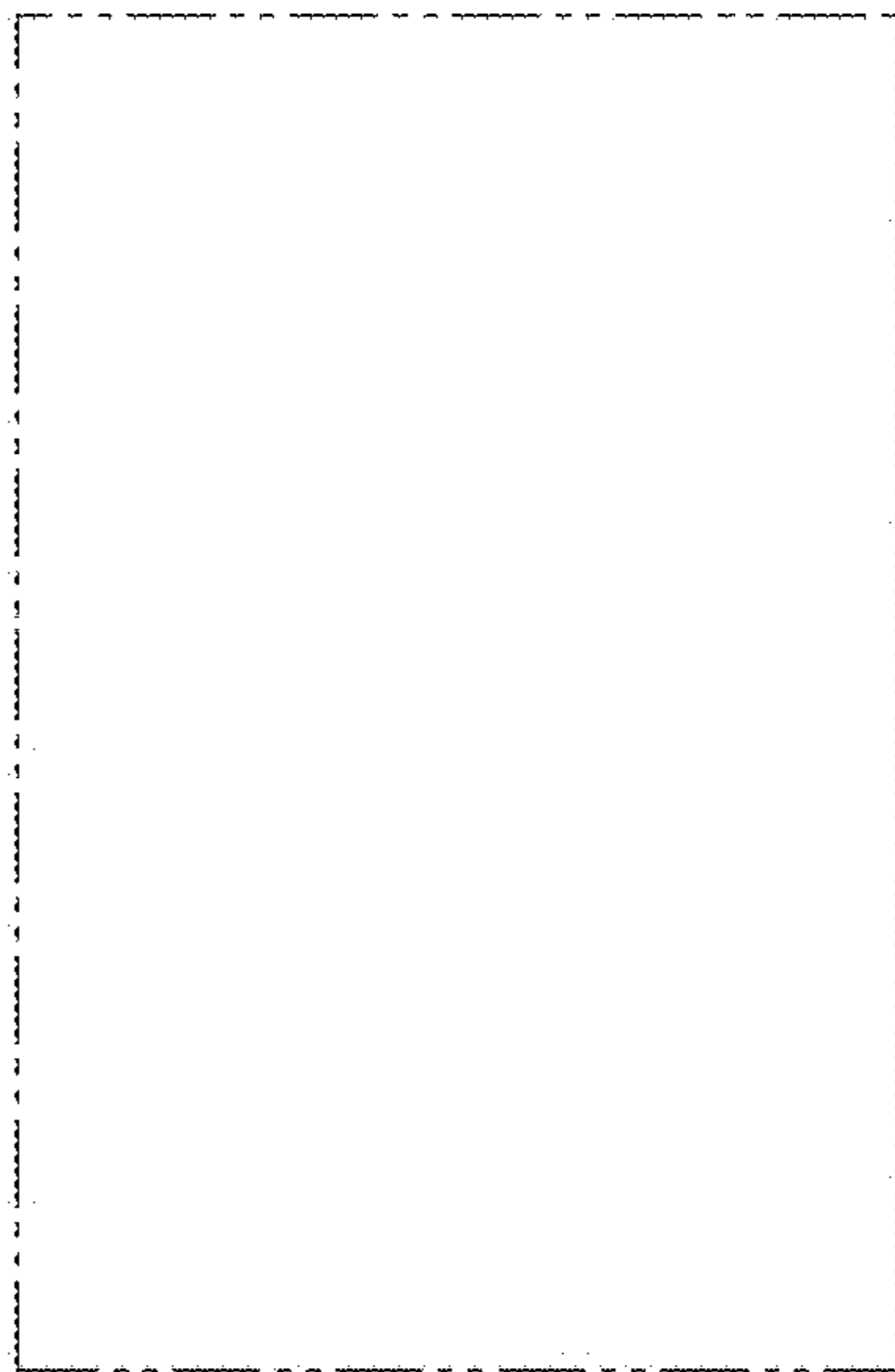

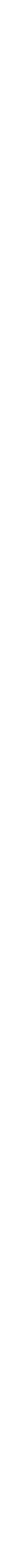

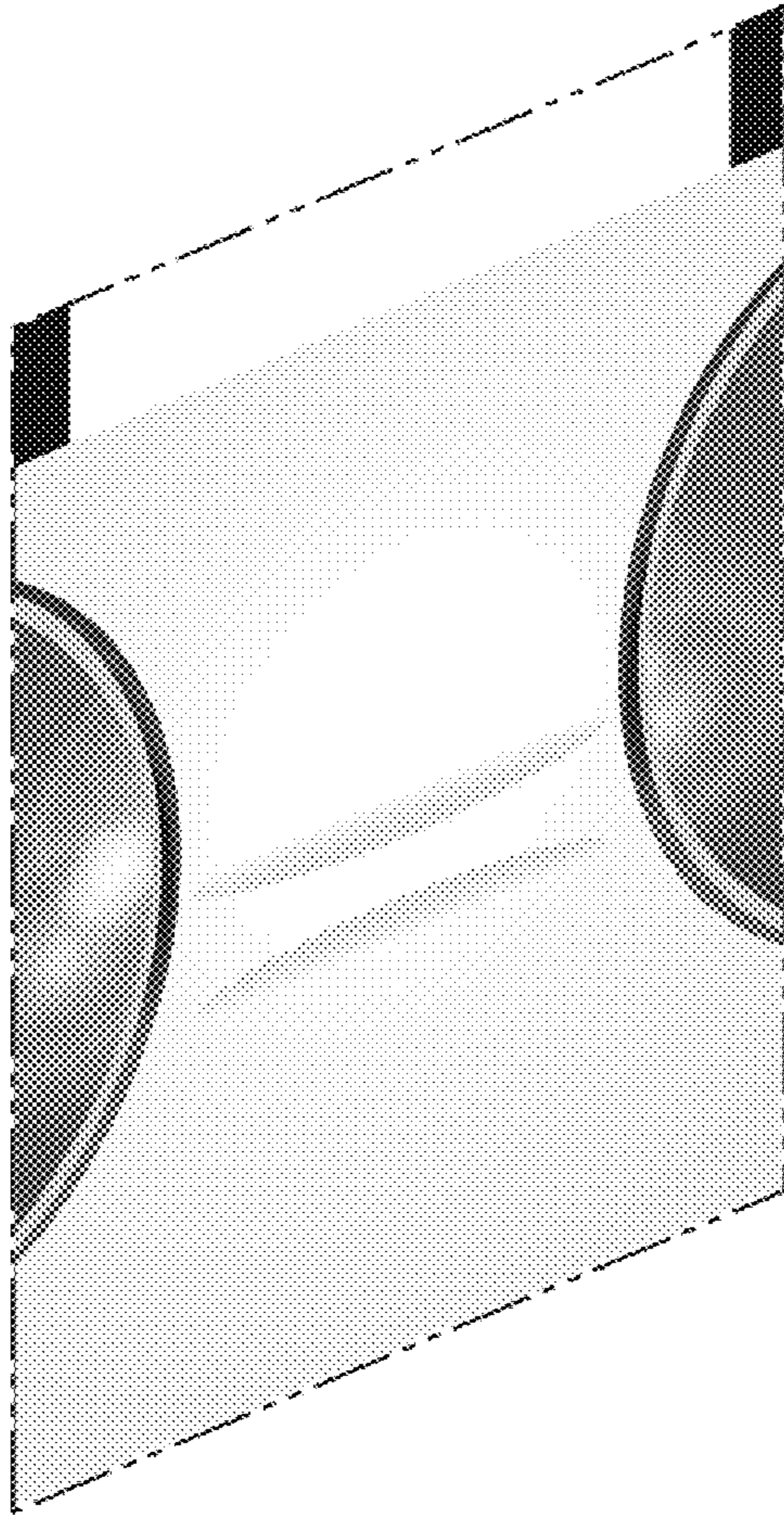

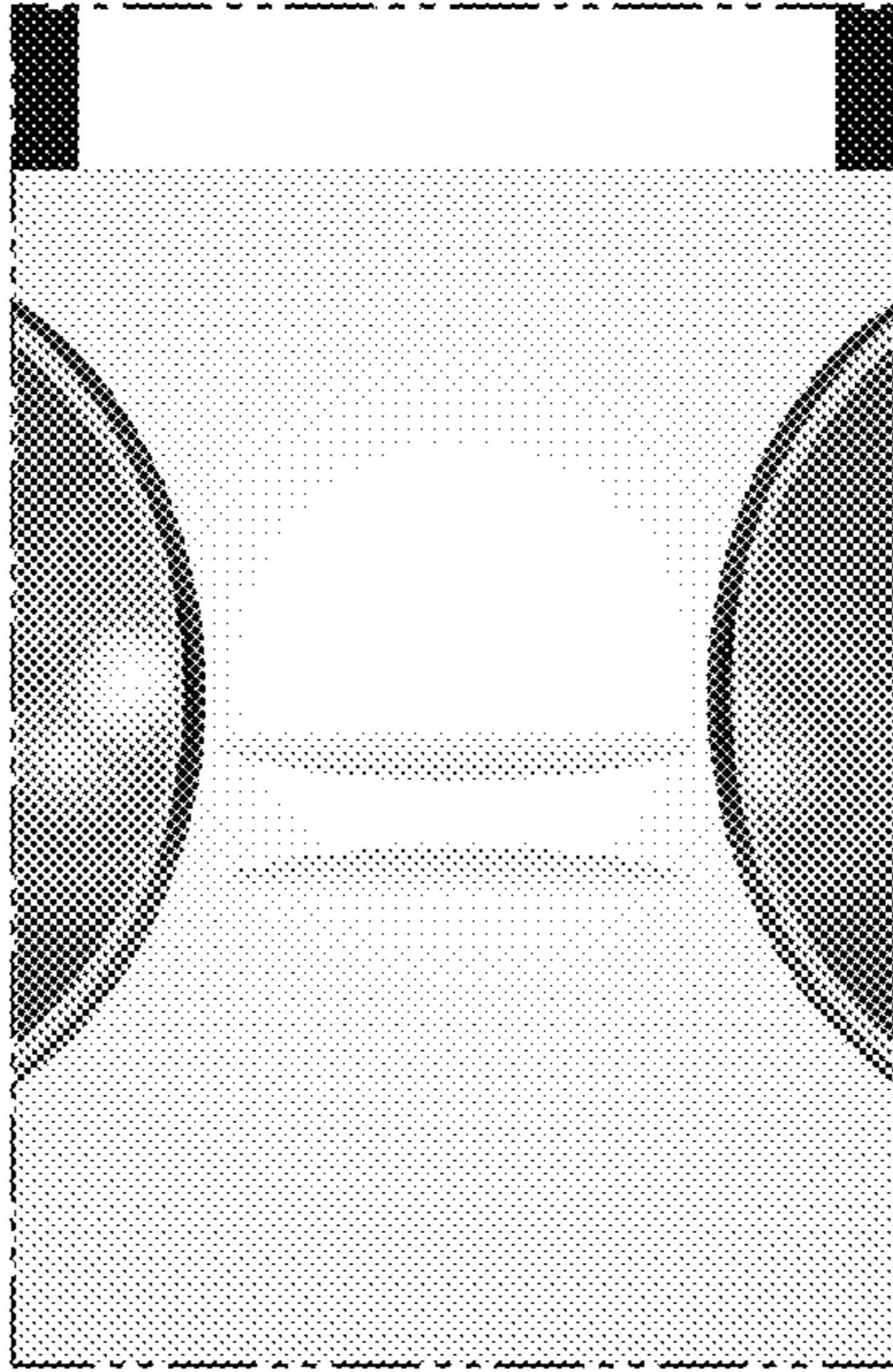

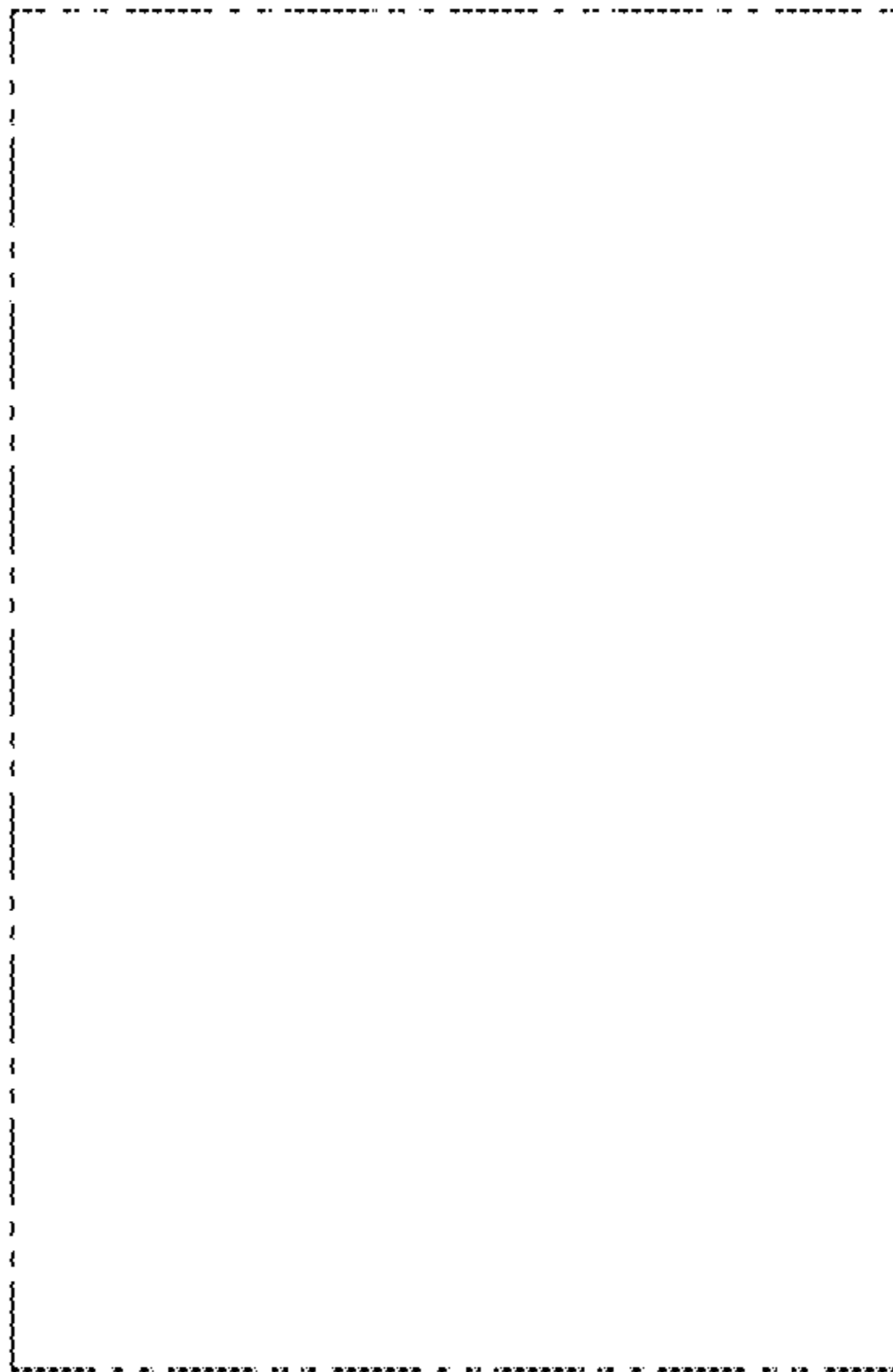

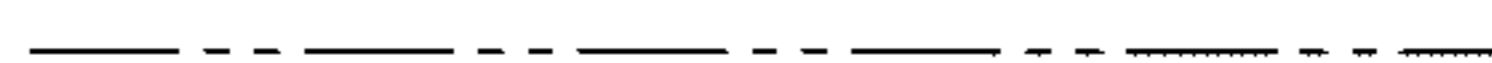
