The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a bottle showing my new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a rear elevation view thereof;

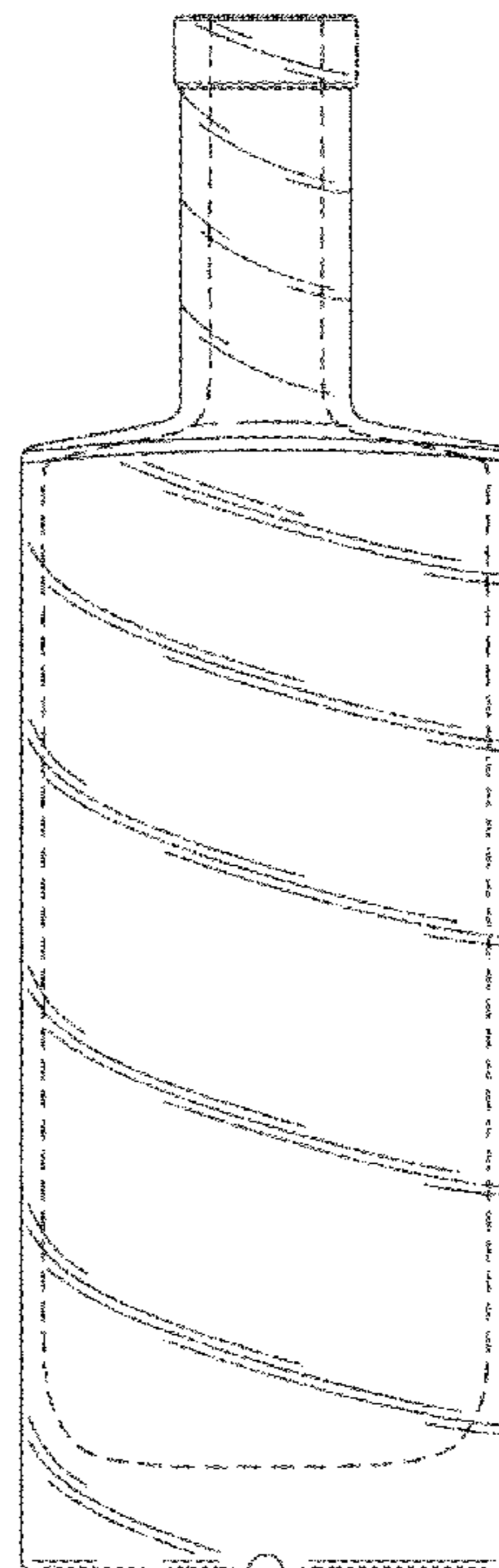
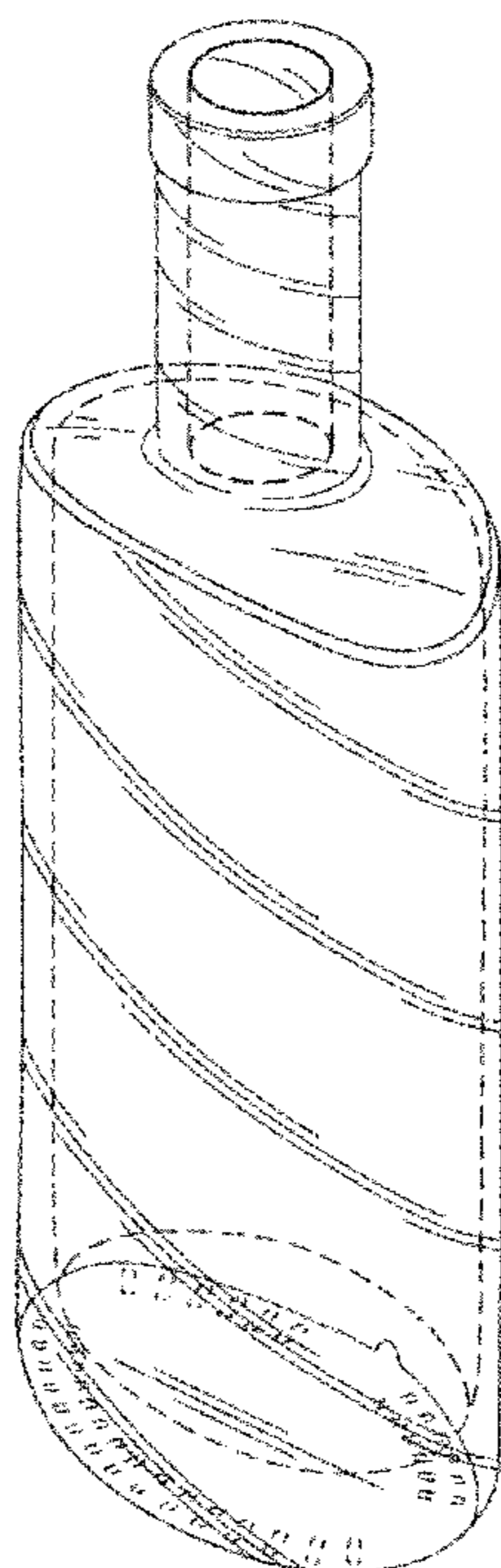
FIG. 4 is a side elevation view thereof;

FIG. 5 is a top plan view thereof, the opposing side details seen through the transparent surface not shown for ease of illustration; and,

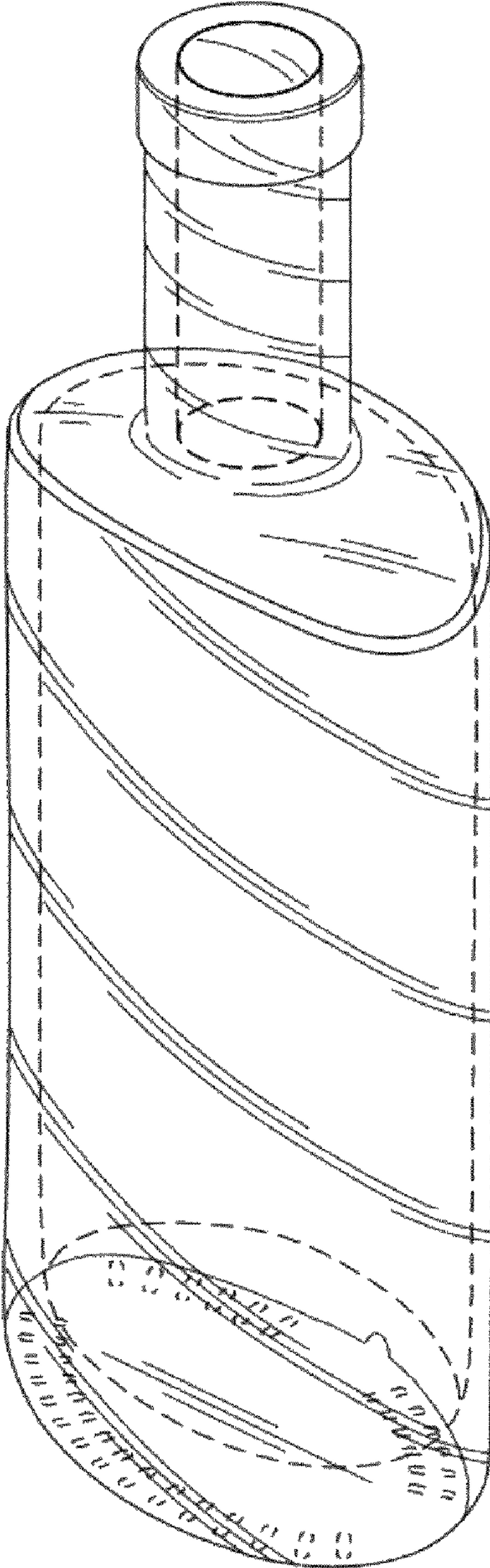

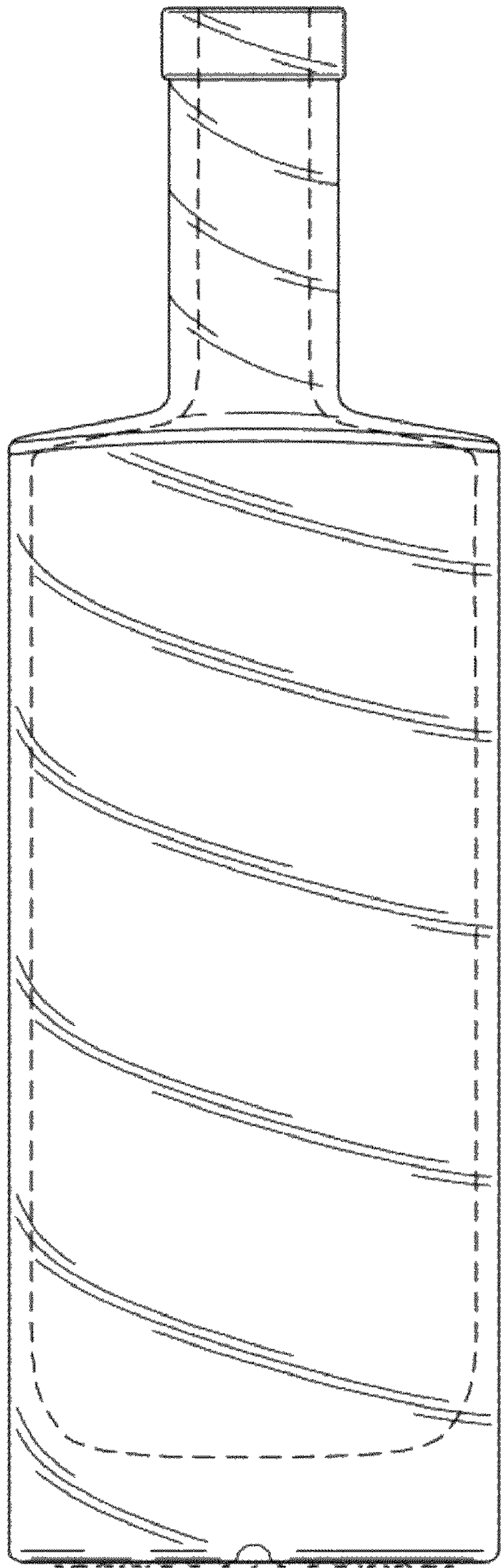

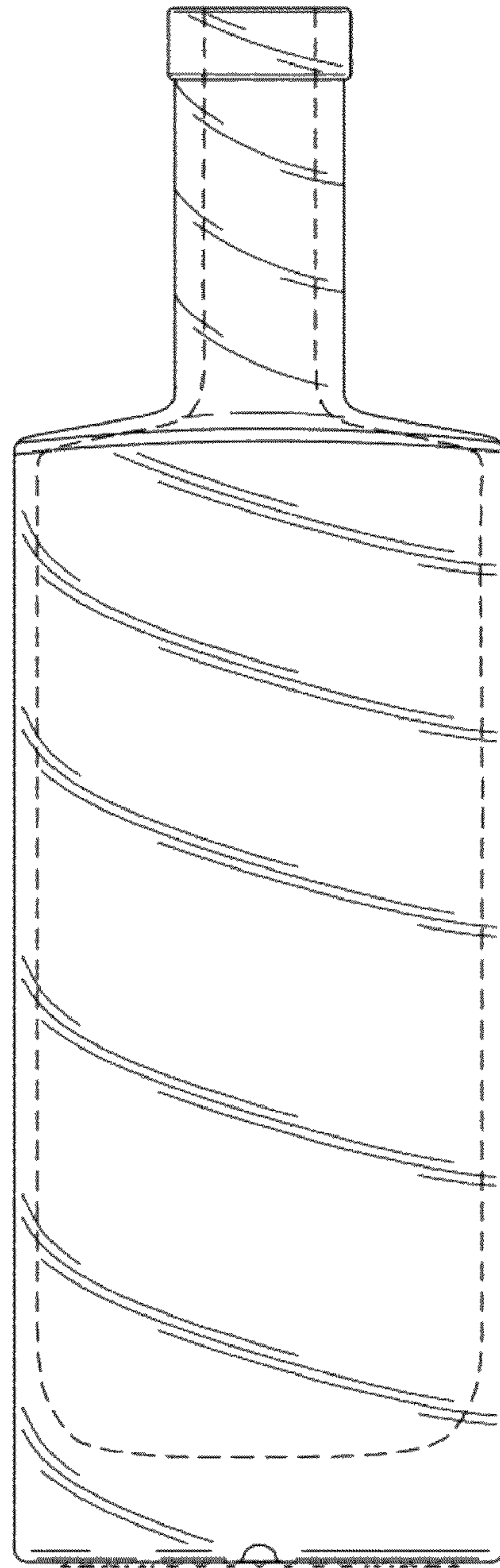

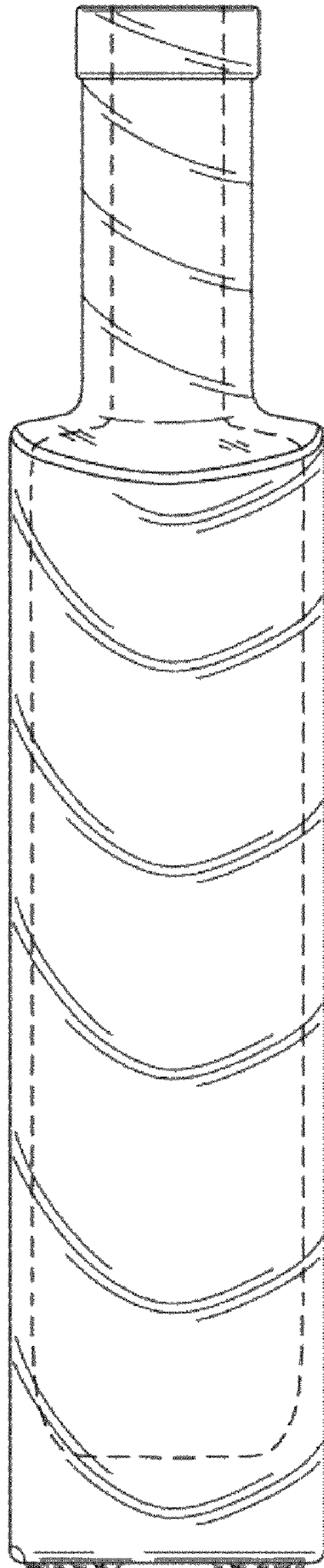

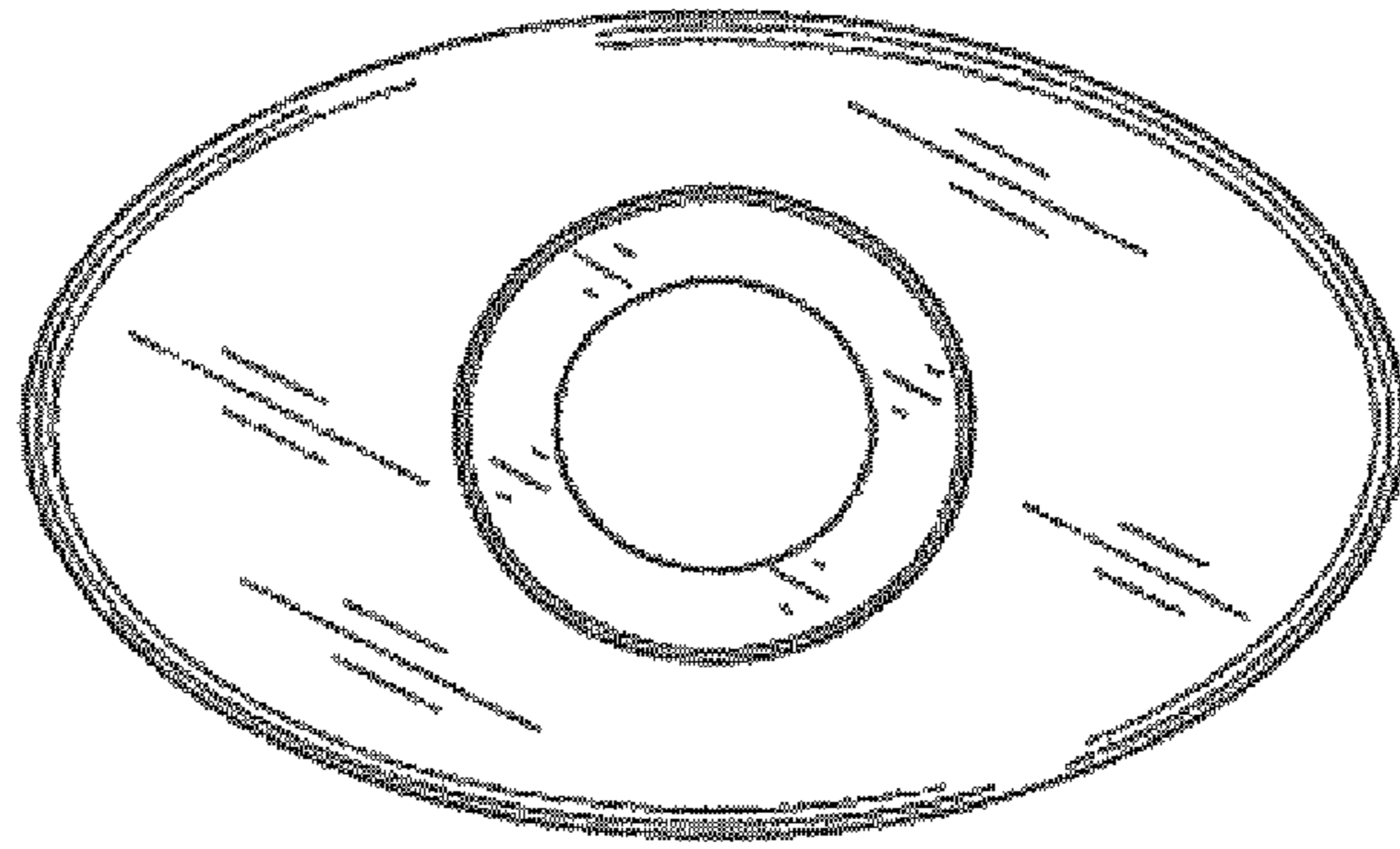

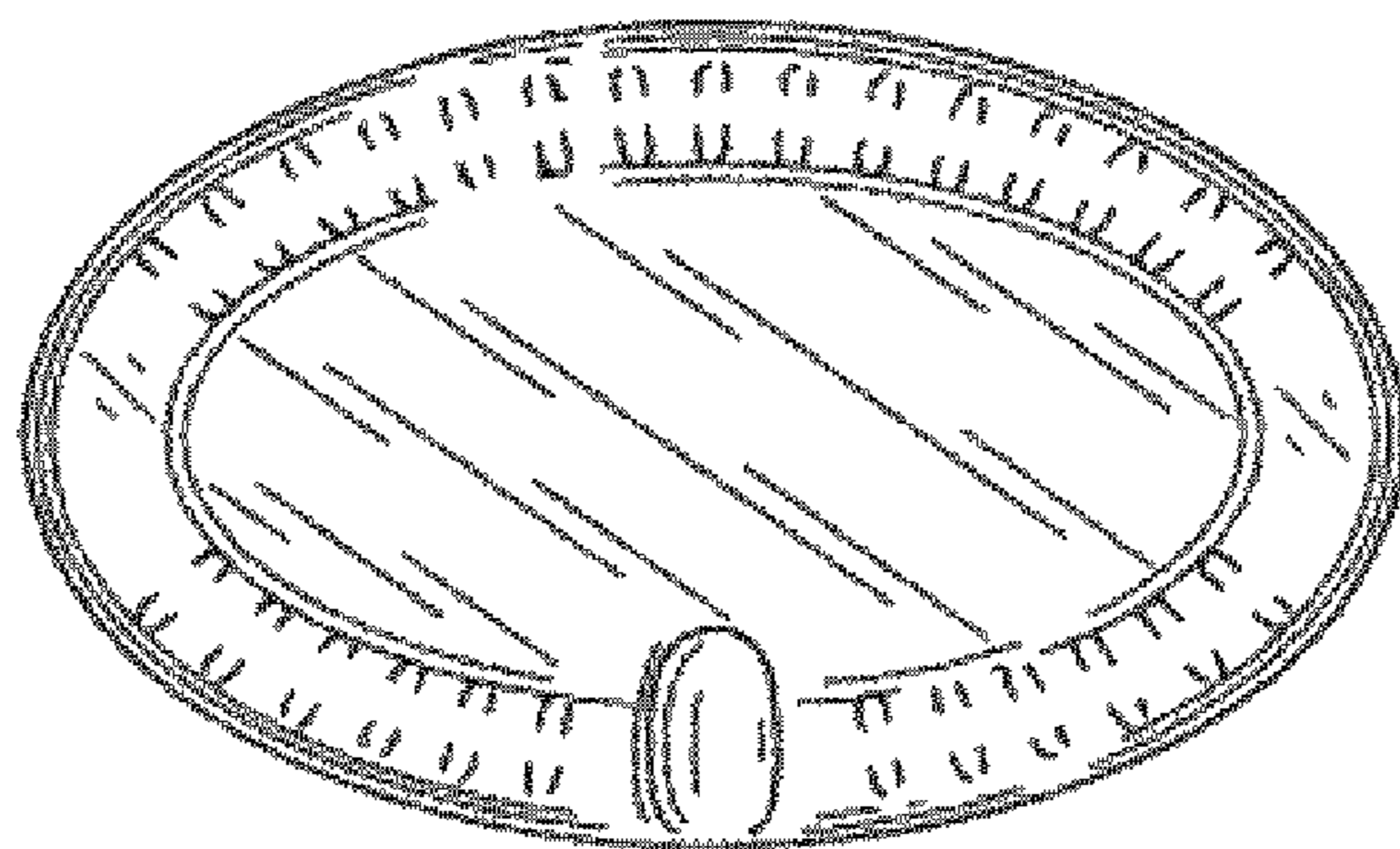
