DESCRIPTION

FIG. 1 is a front, top, and right side perspective view of a bottle;

FIG. 2 is a left side elevational view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

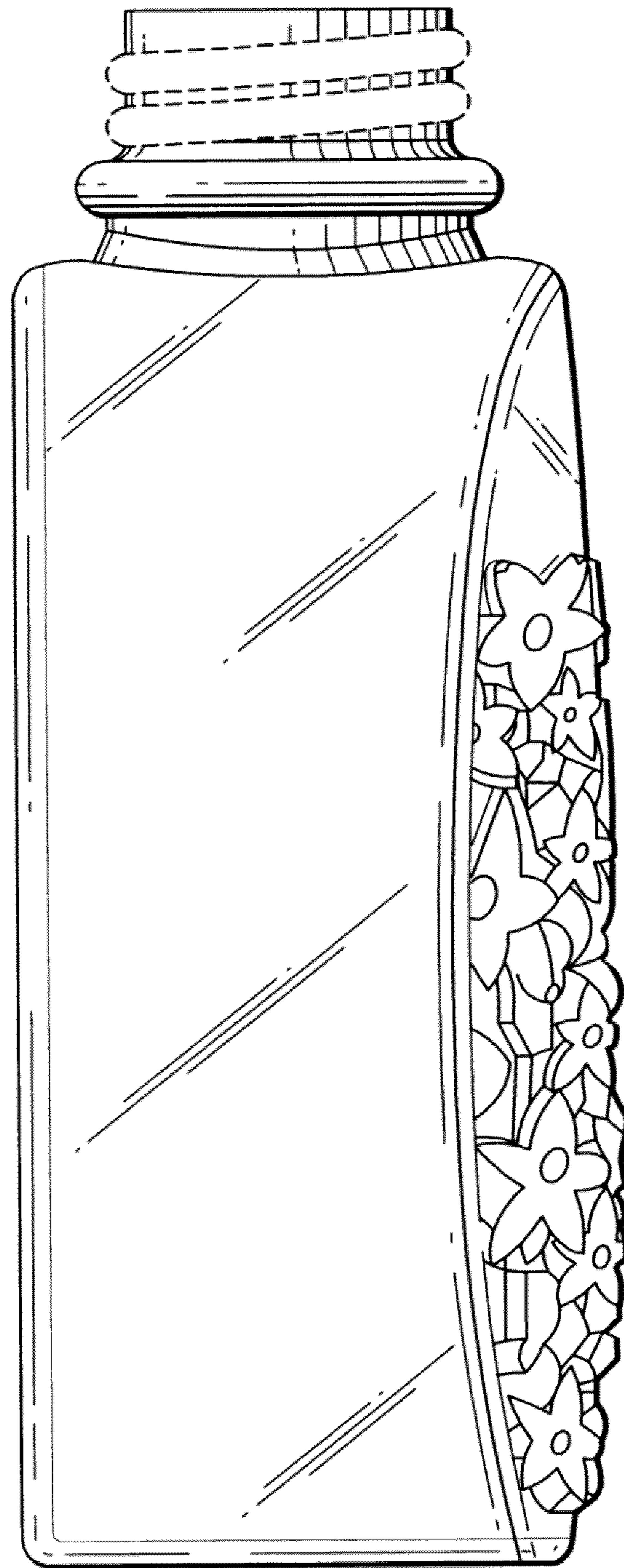

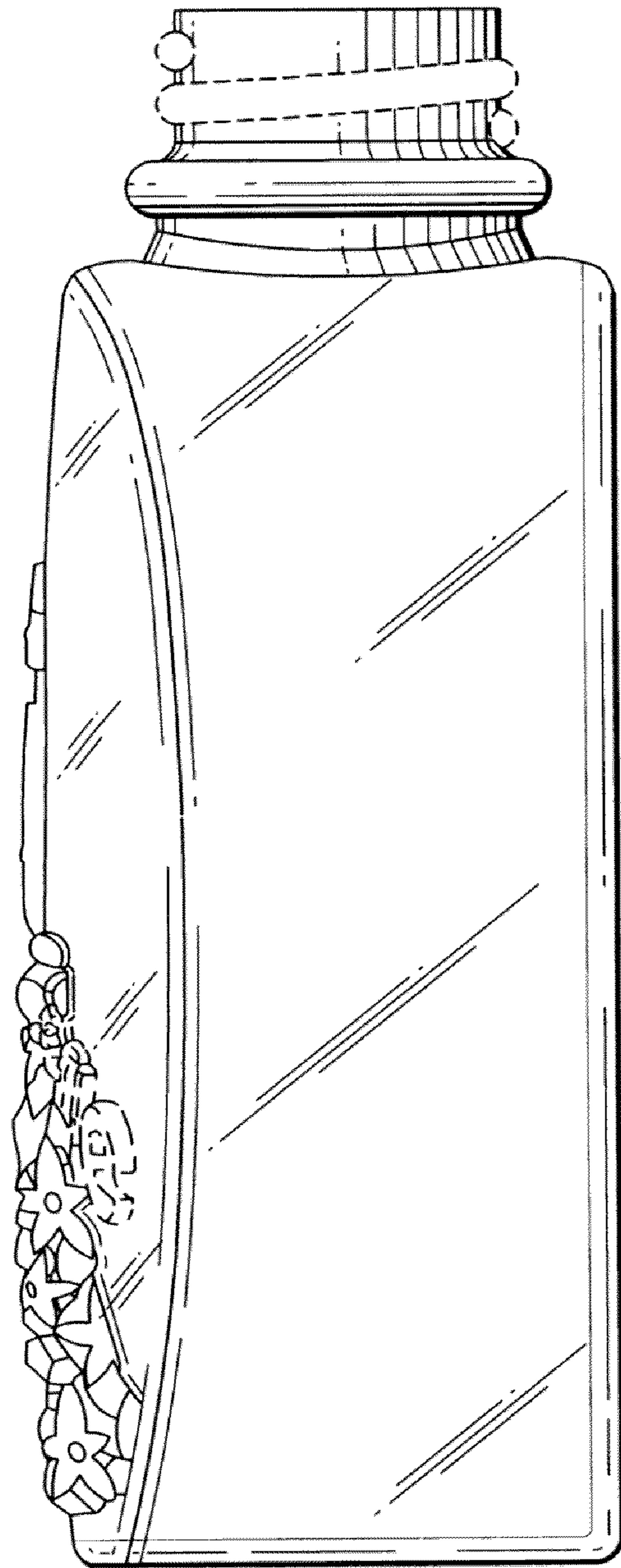

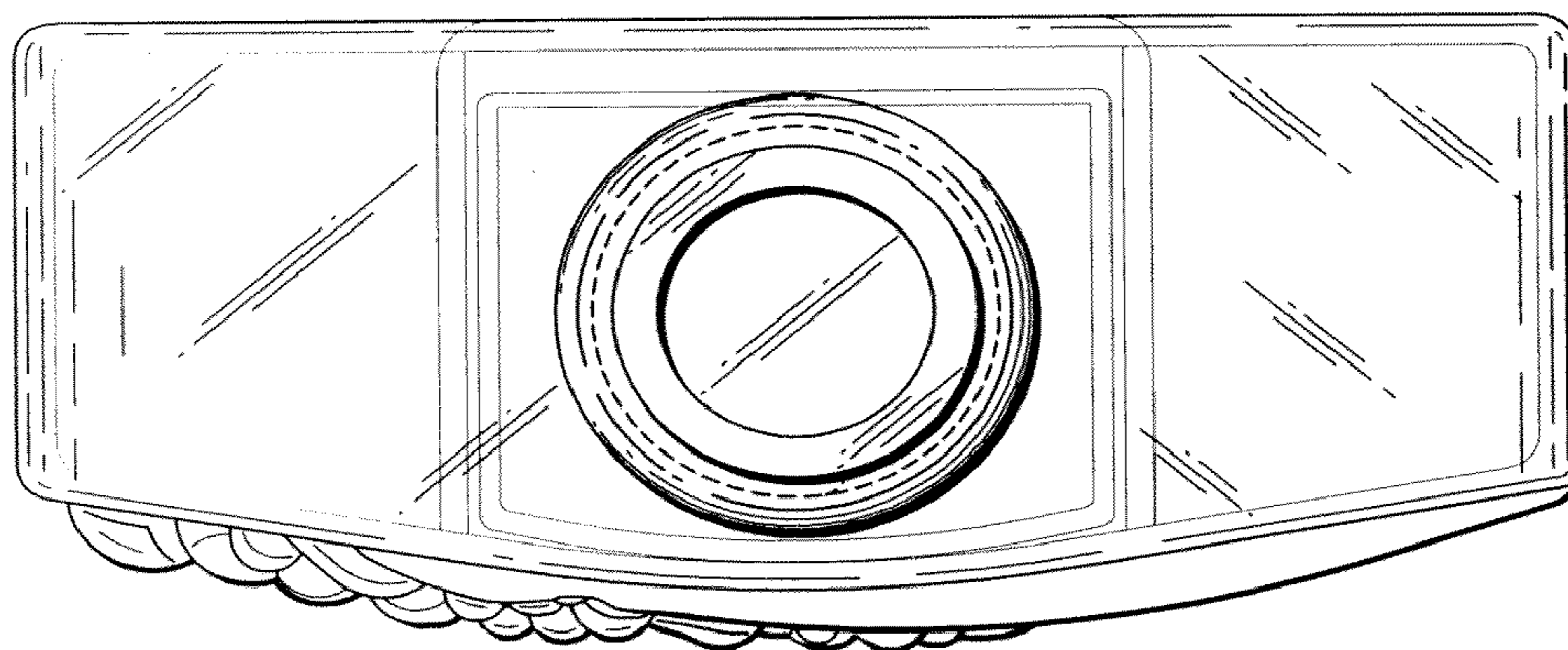

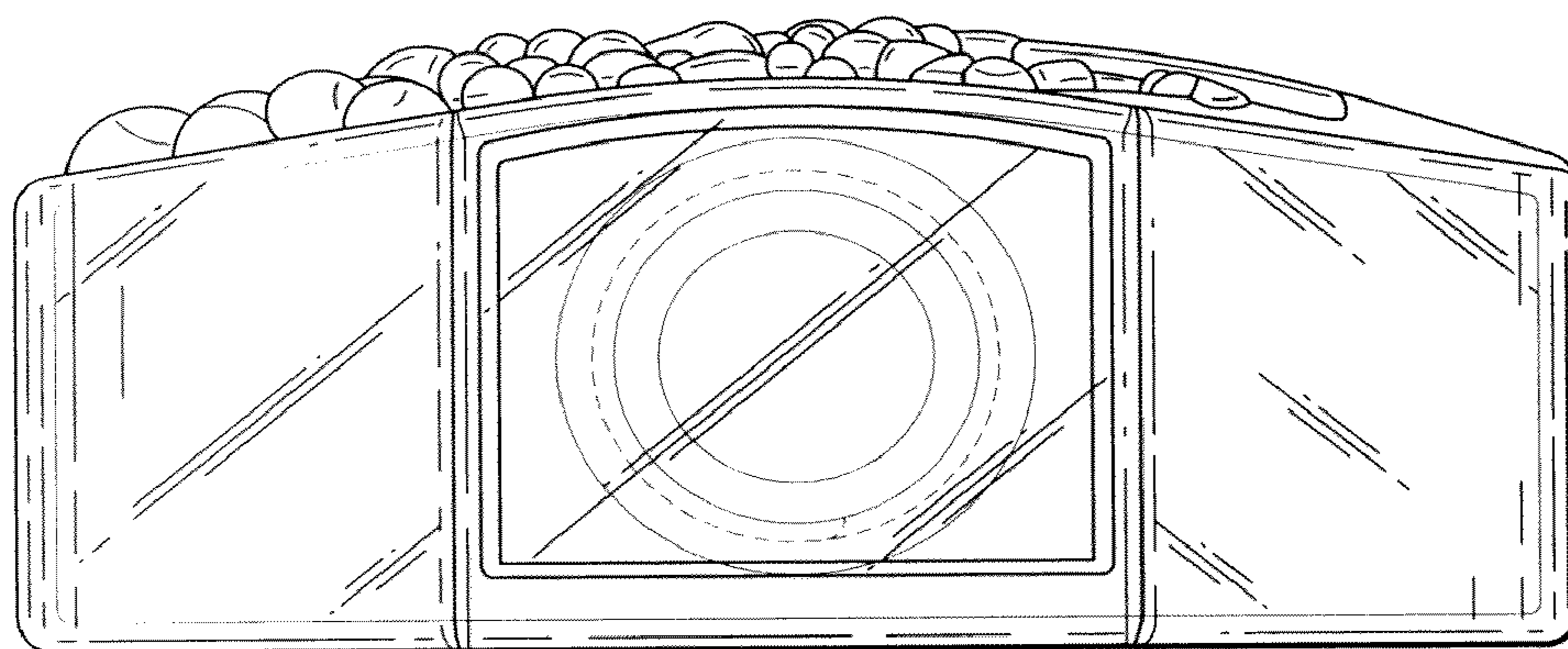
