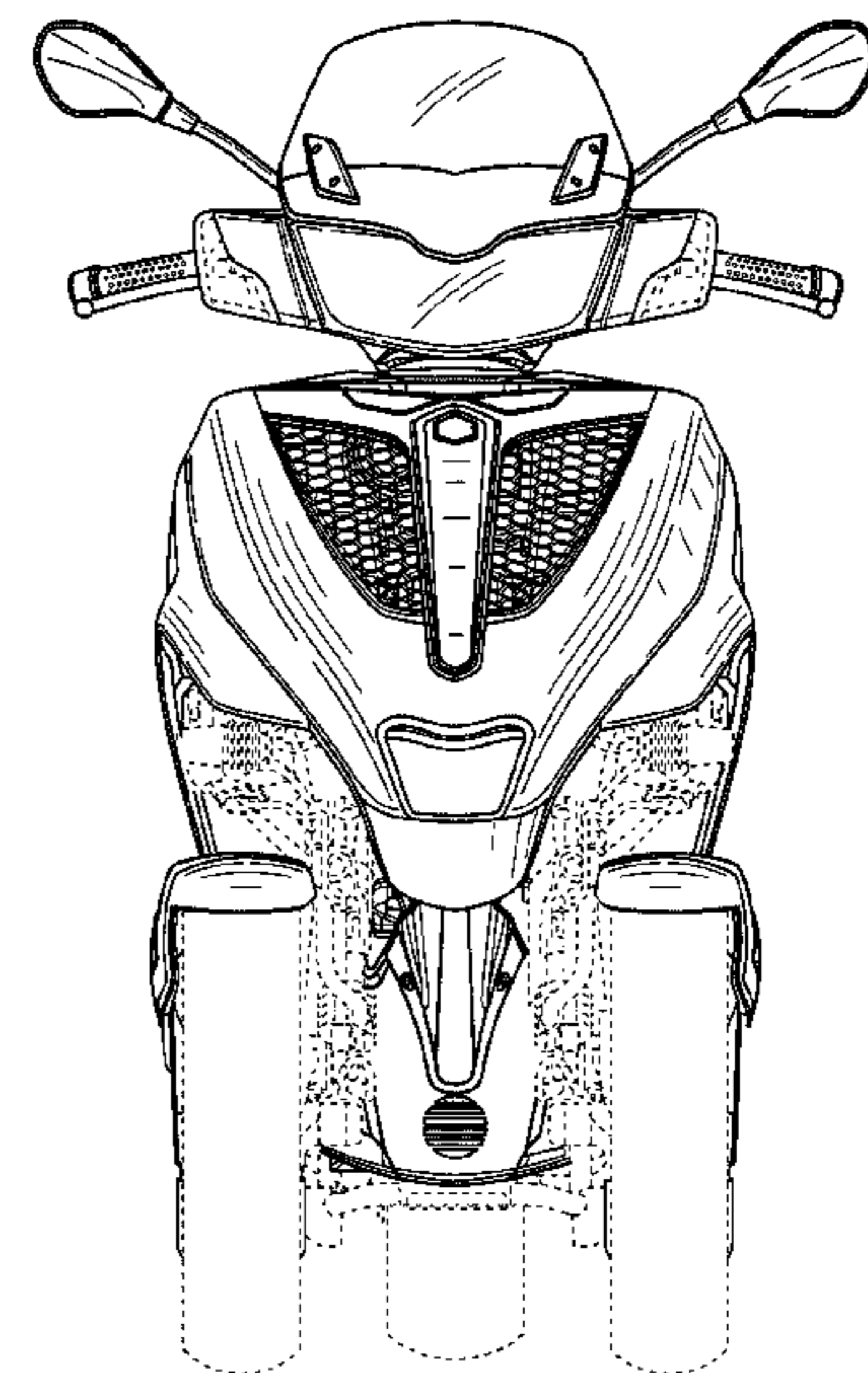
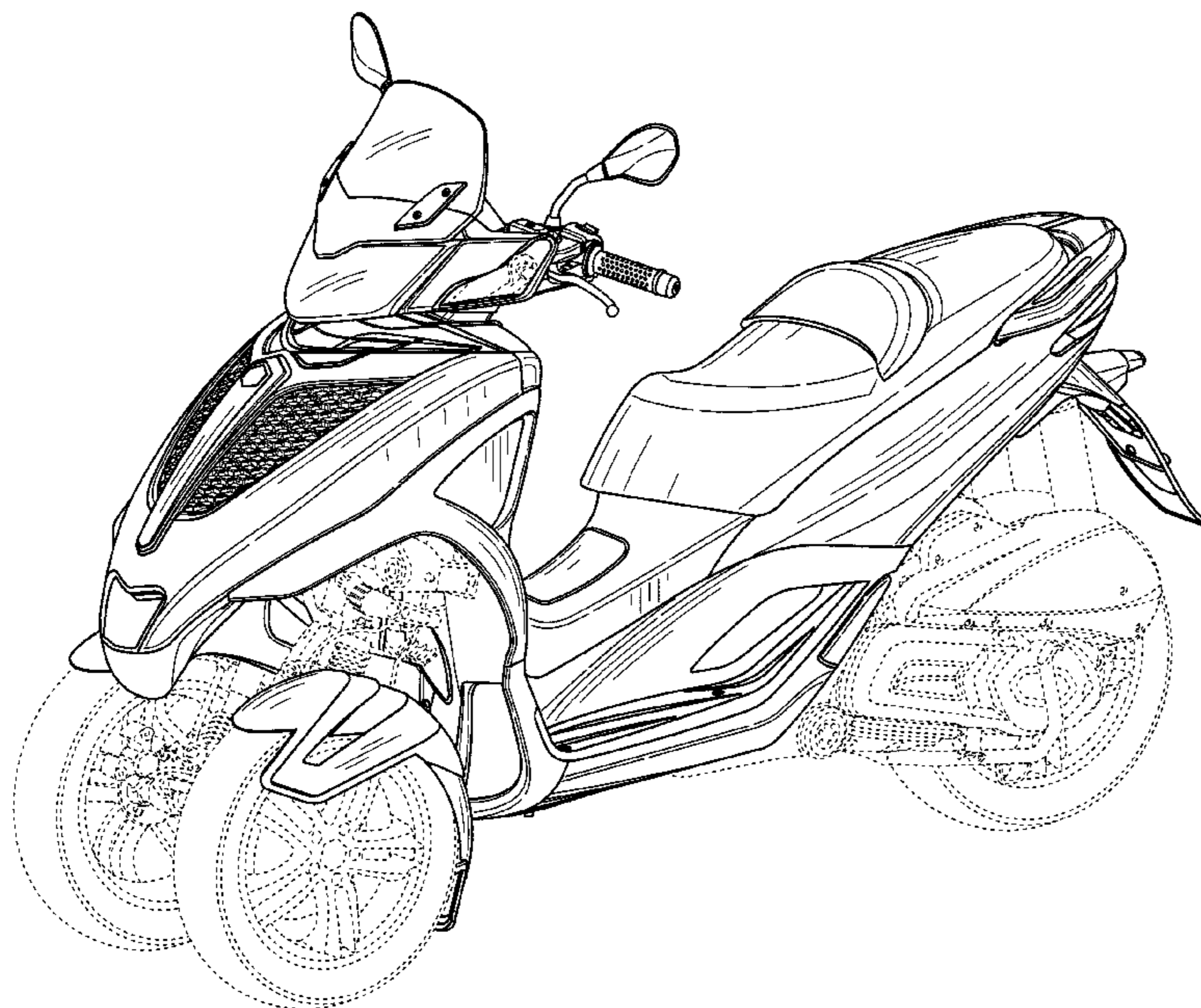
The ornamental design for a motor scooter, as shown and described.

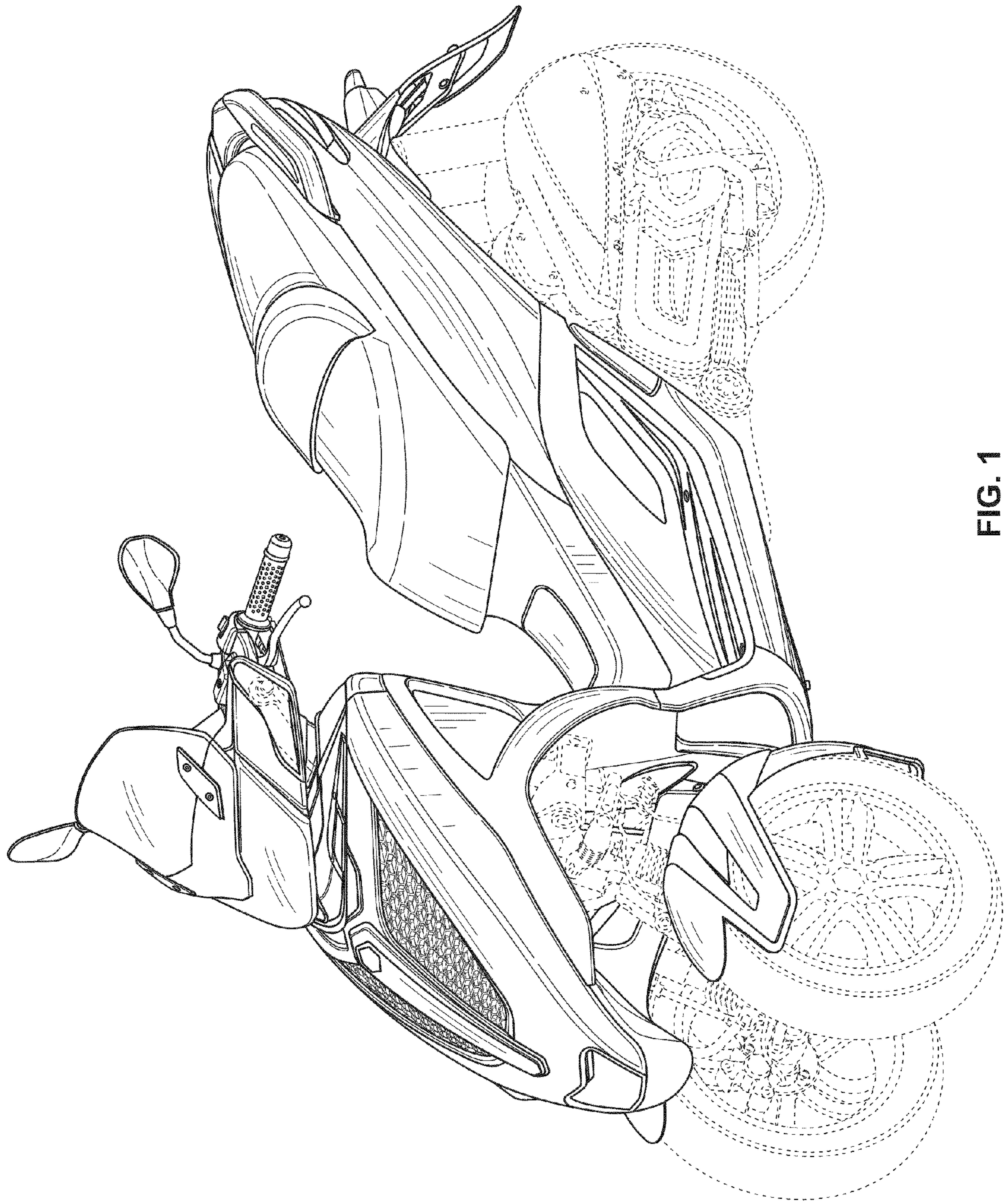

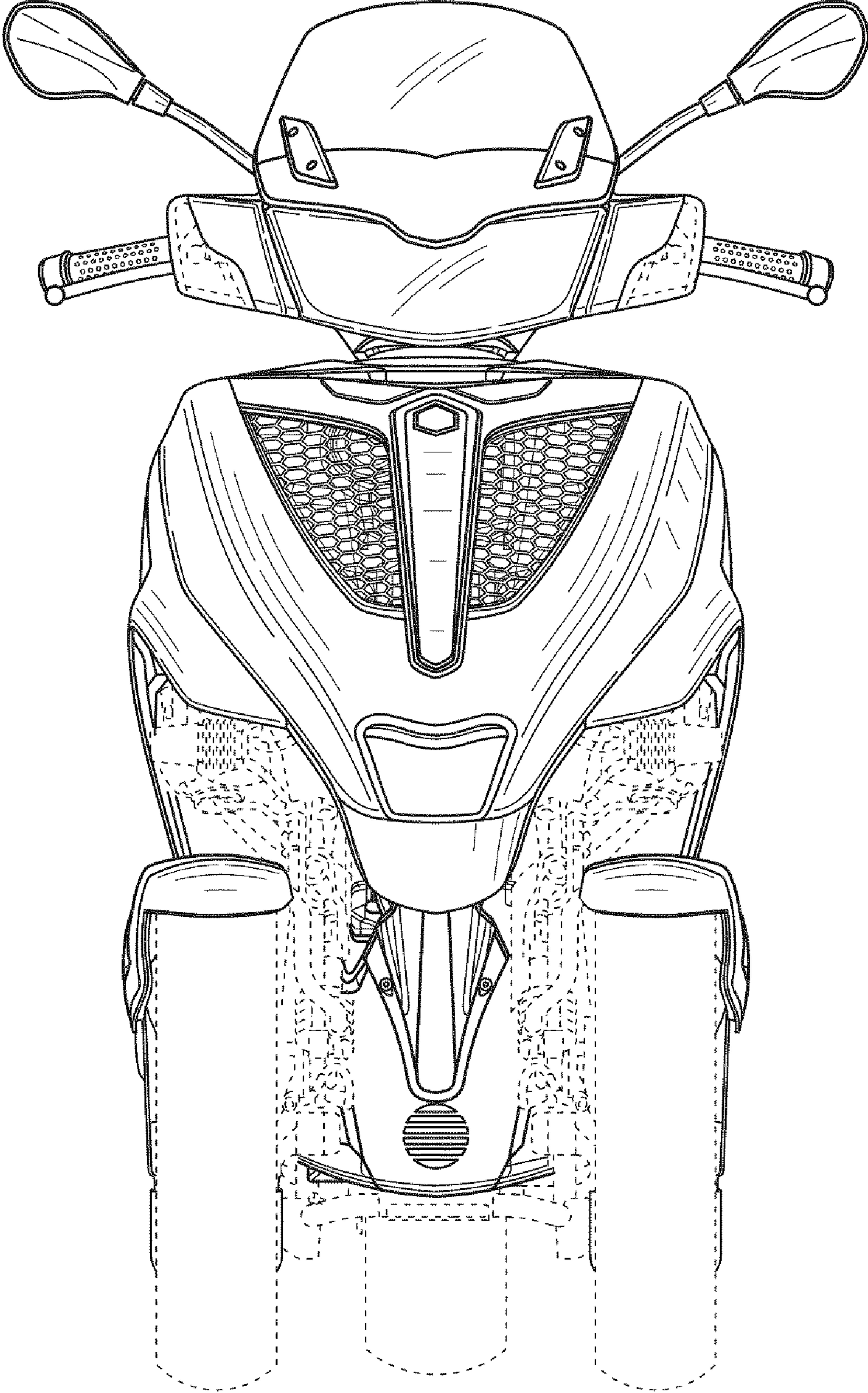

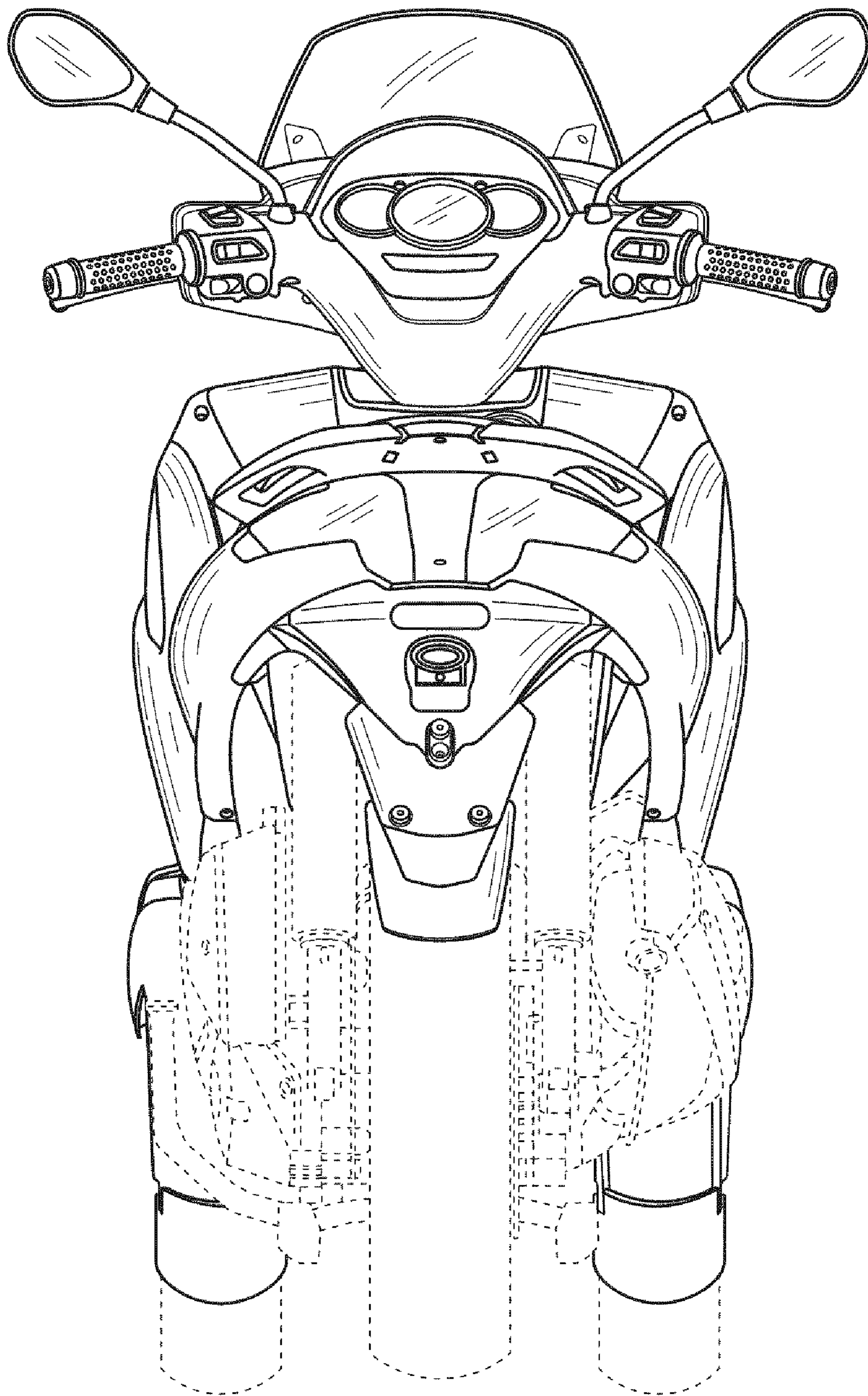

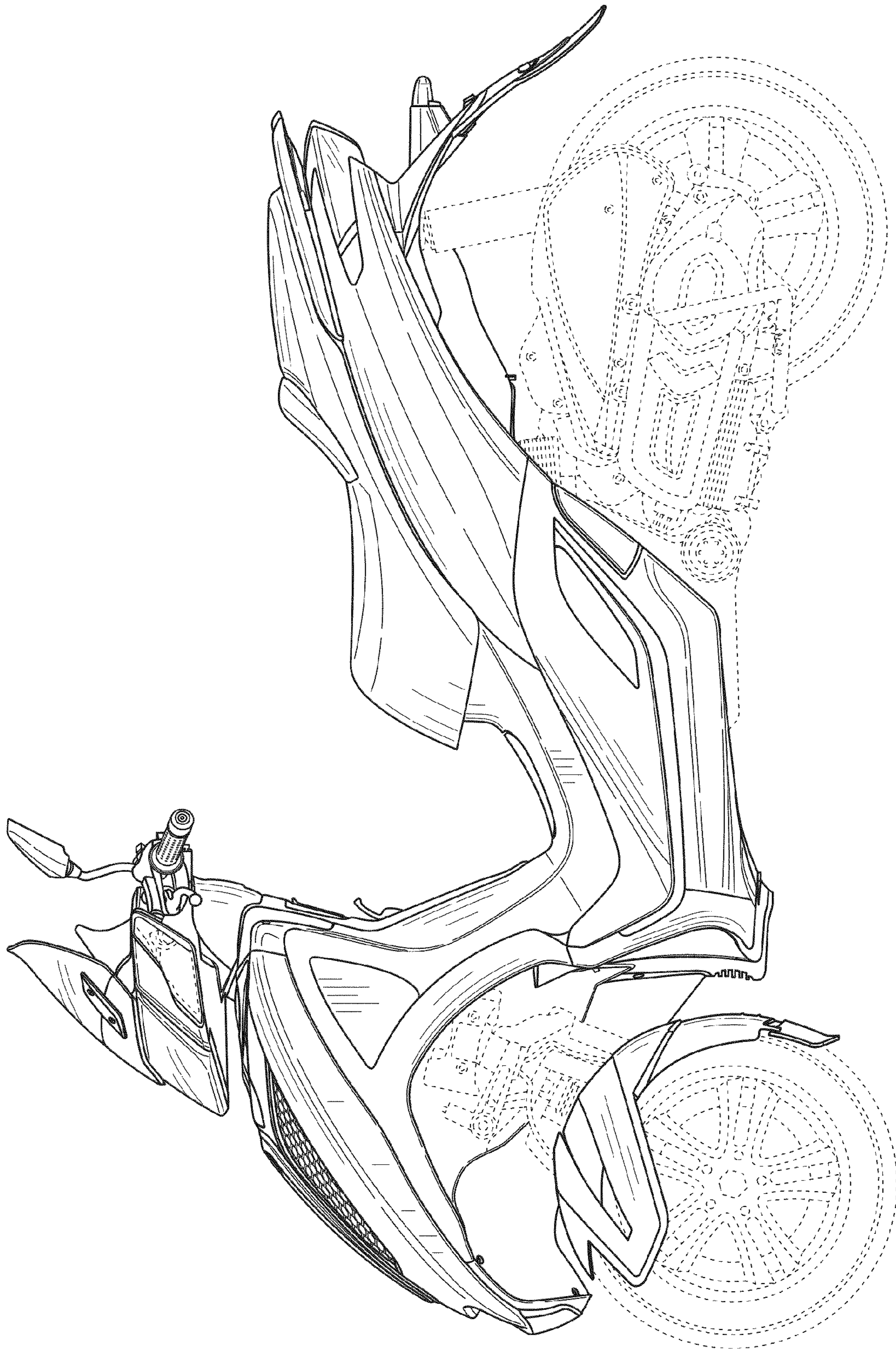

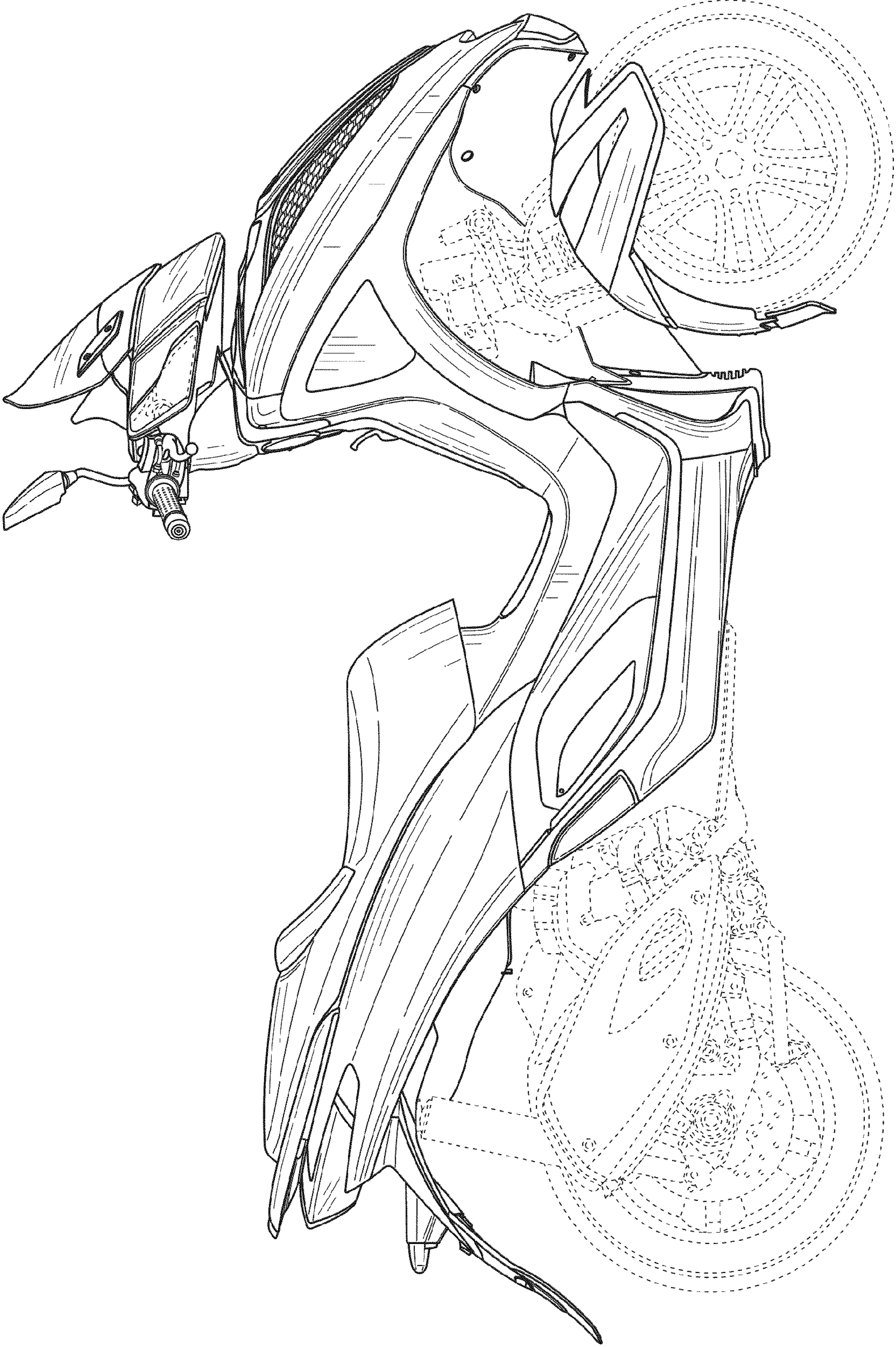

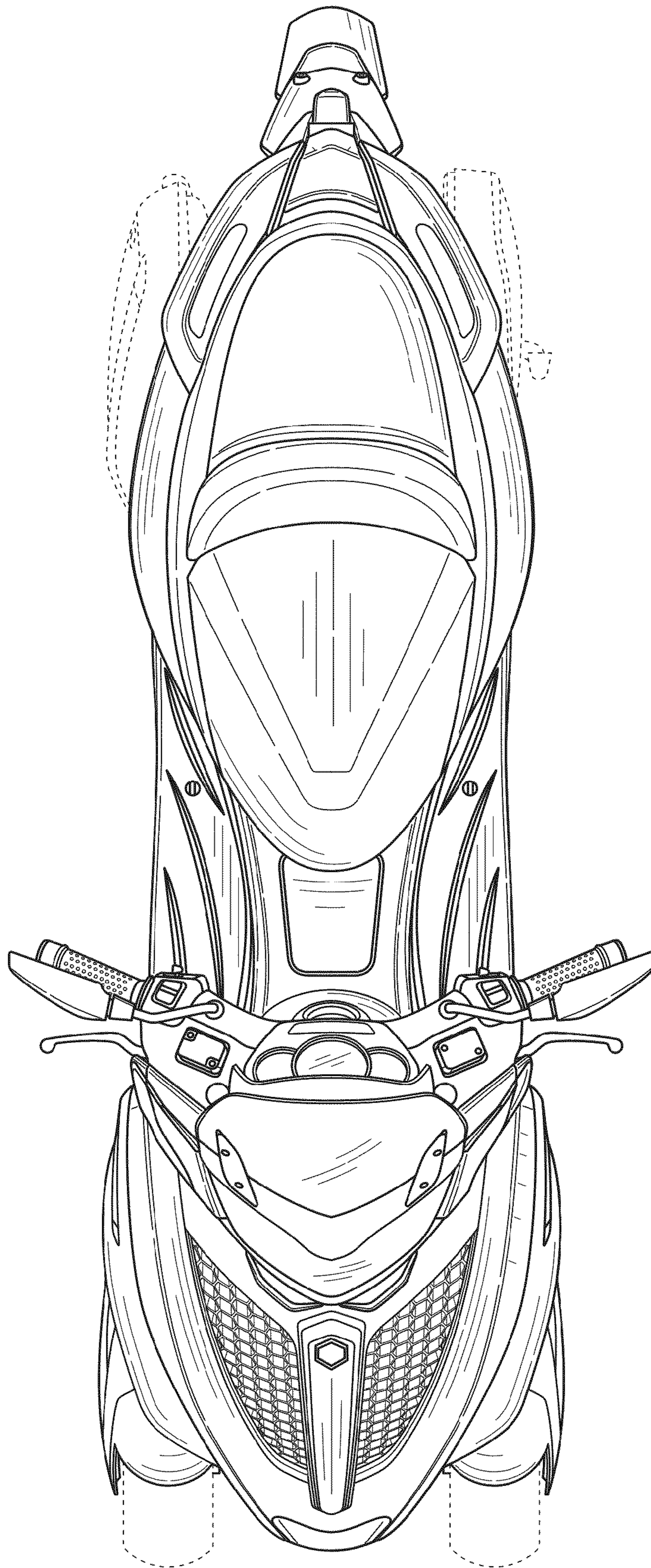

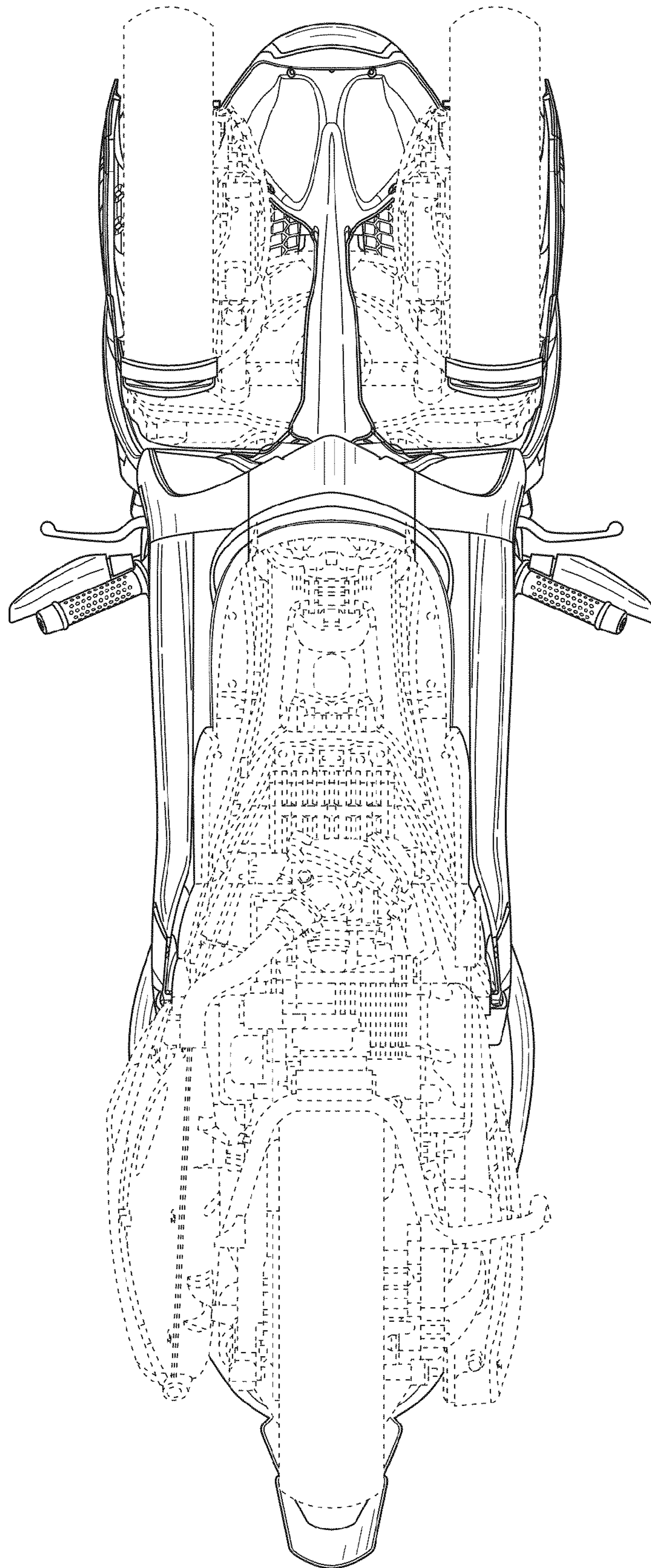
