(57) **CLAIM**

The ornamental design for a cover, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a cover showing our new design, with an environmental electronic device shown removed from the cover;

FIG. 2 is a front perspective view thereof, shown without the environmental electronic device;

FIG. 3 is a rear perspective view thereof;

FIG. 4 is a front view thereof;

FIG. 5 is a rear view thereof;

FIG. 6 is a left side view thereof;

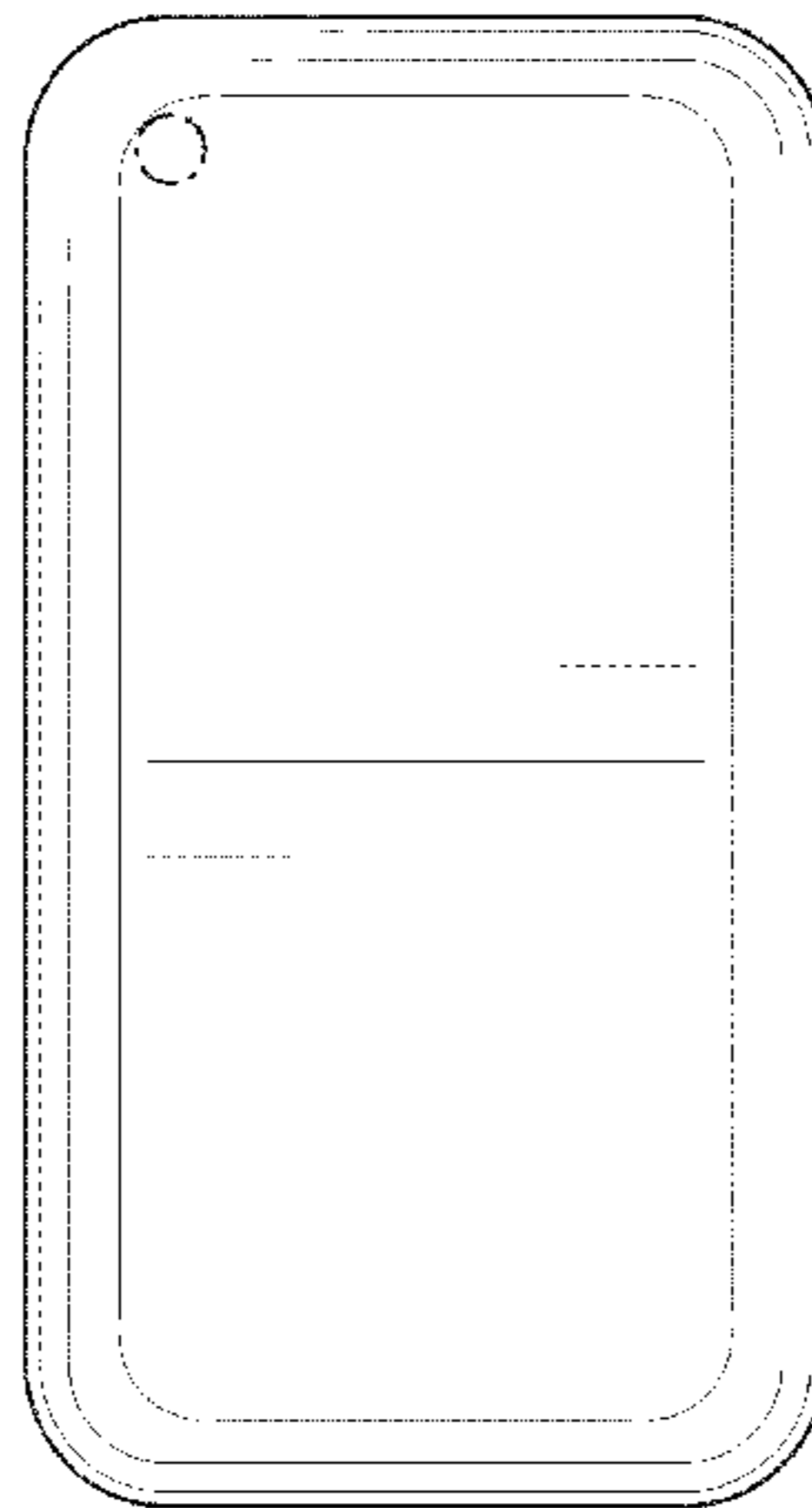
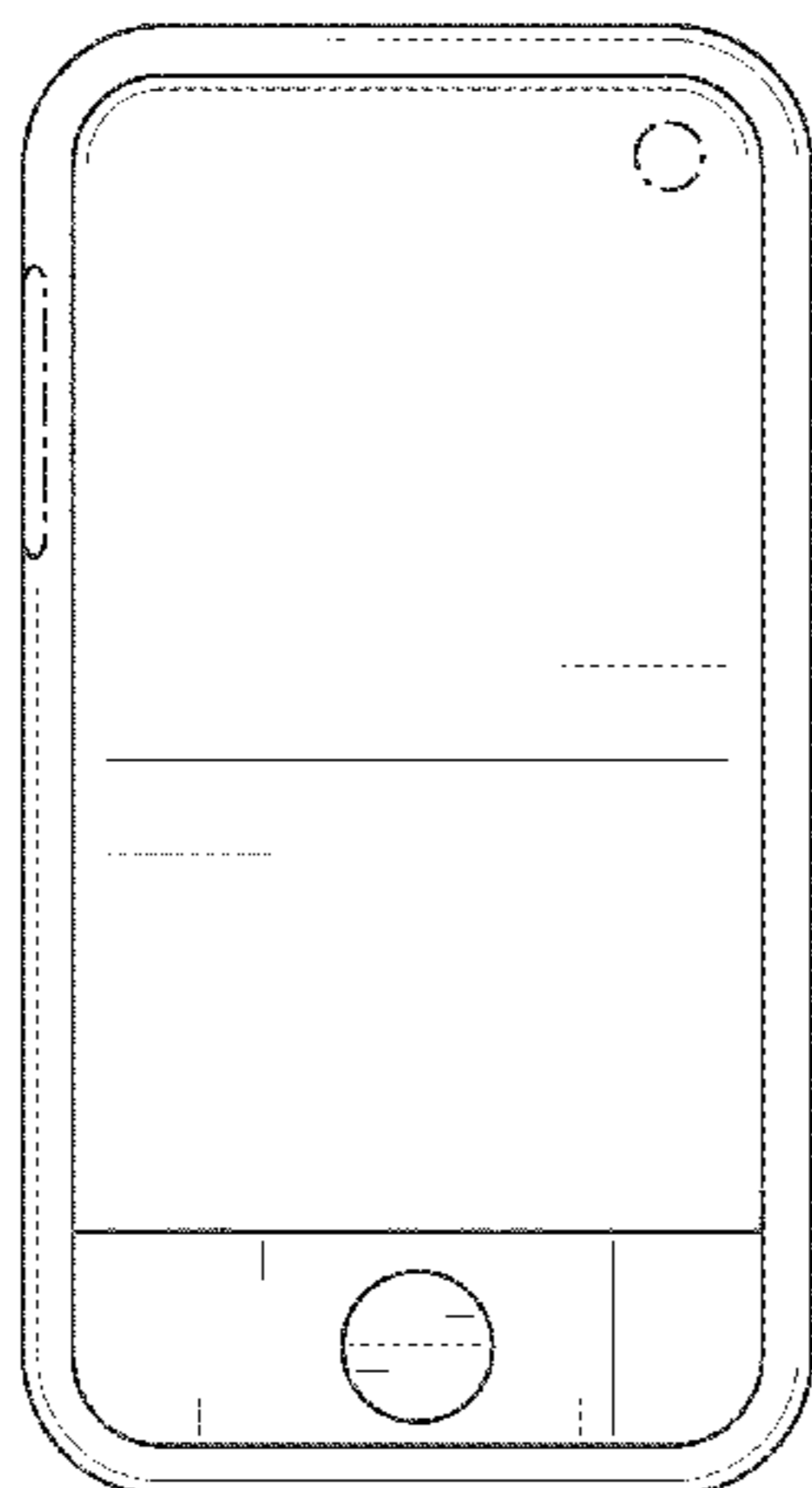
FIG. 7 is right side view thereof;

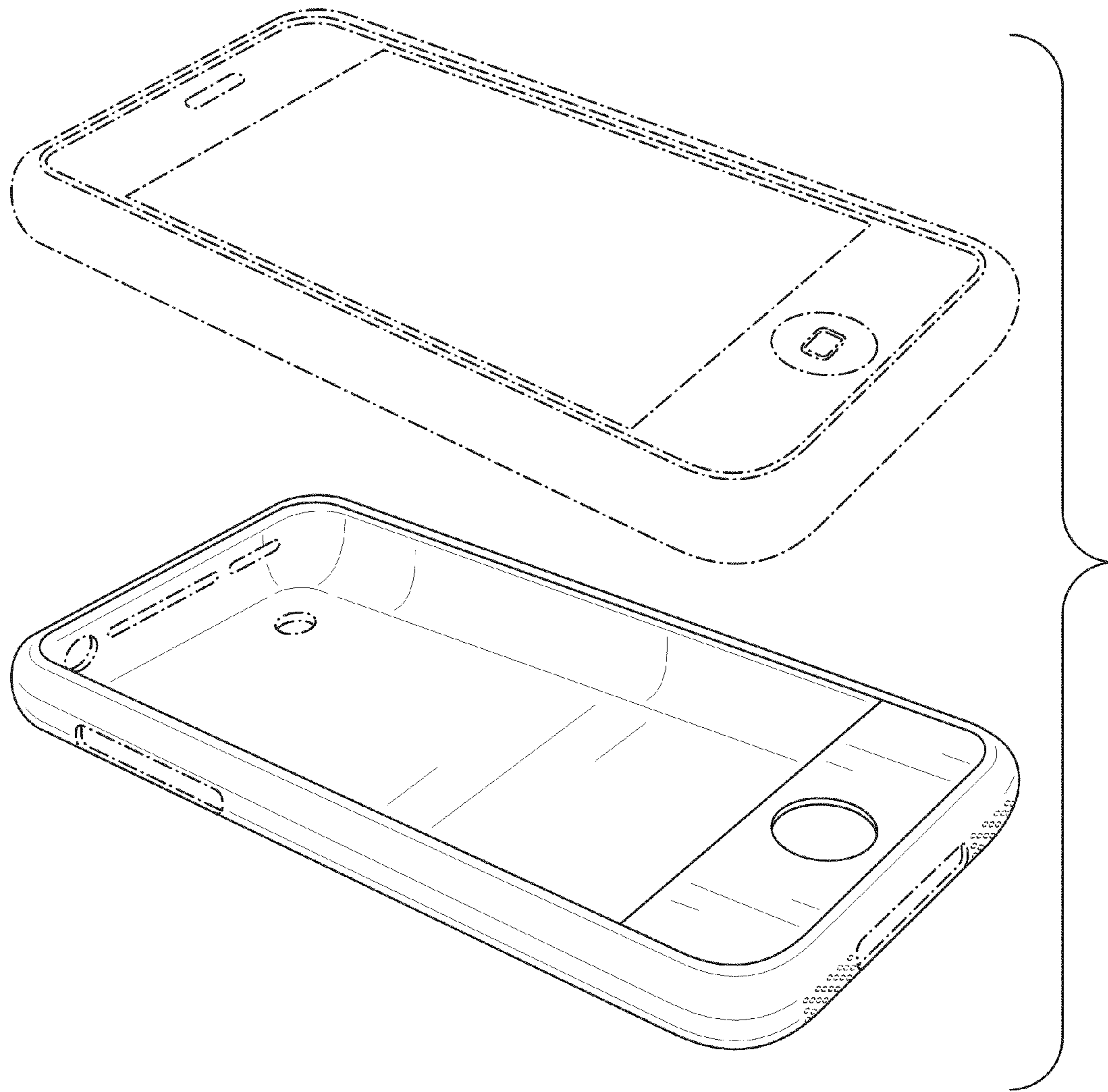

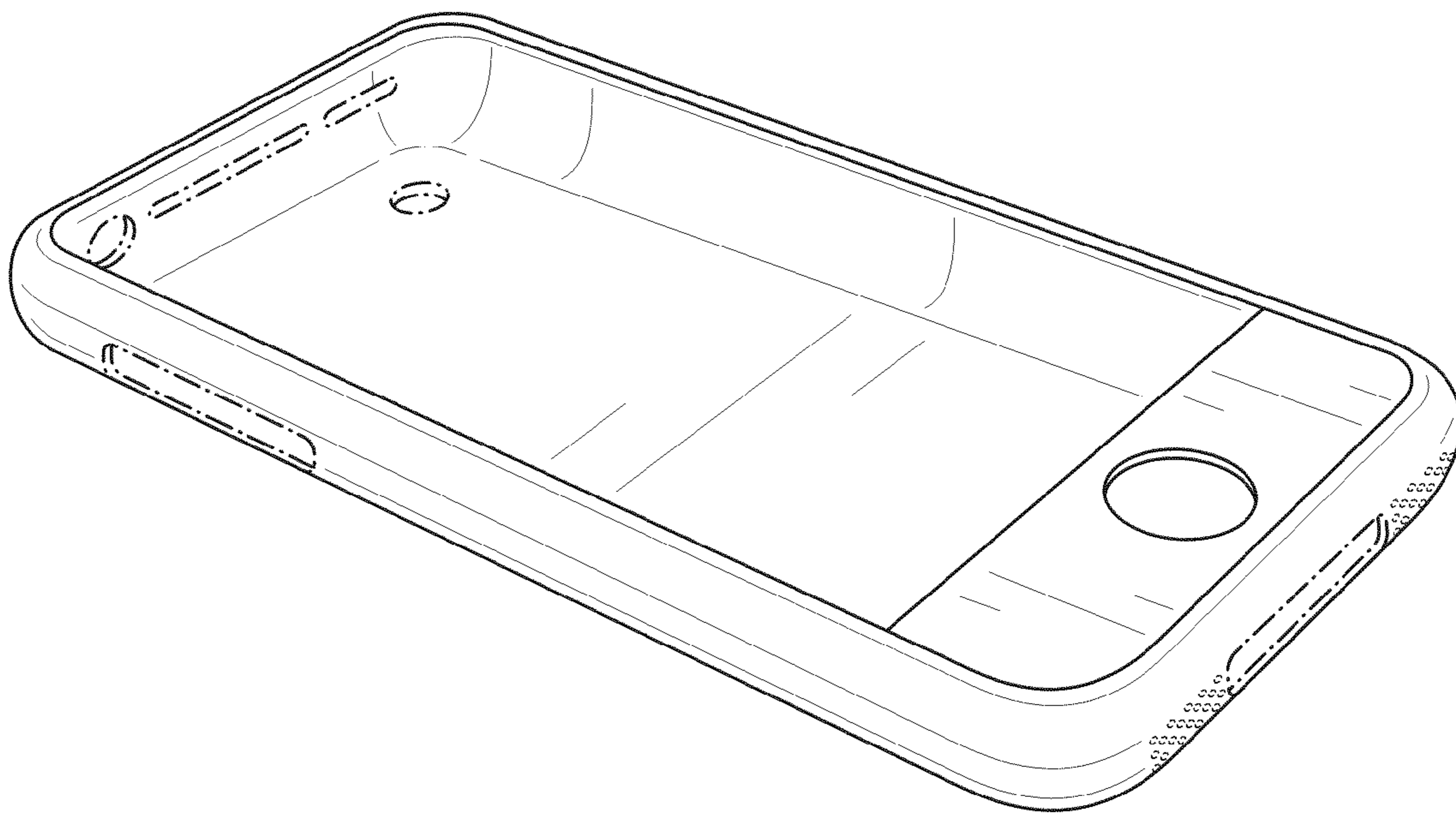

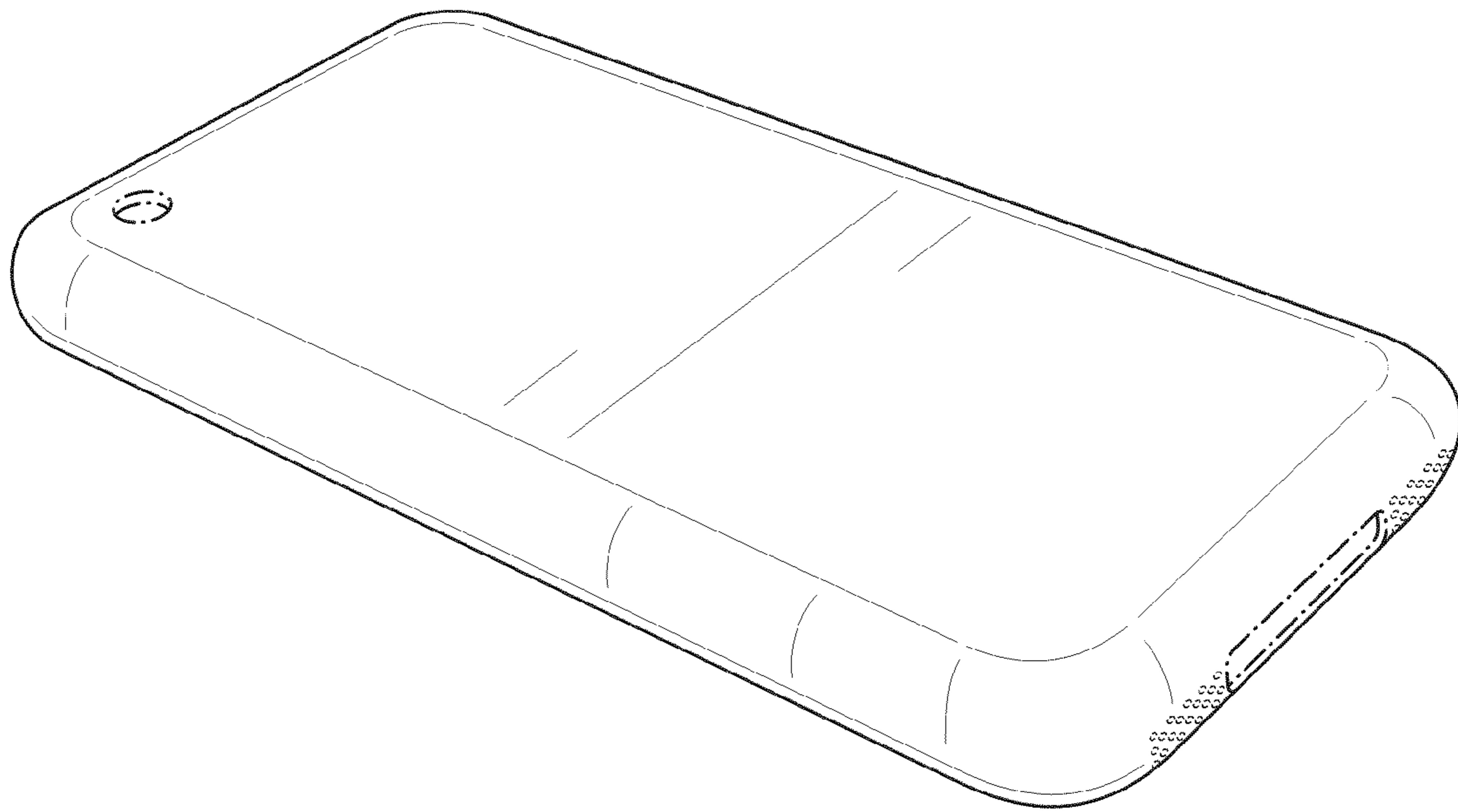

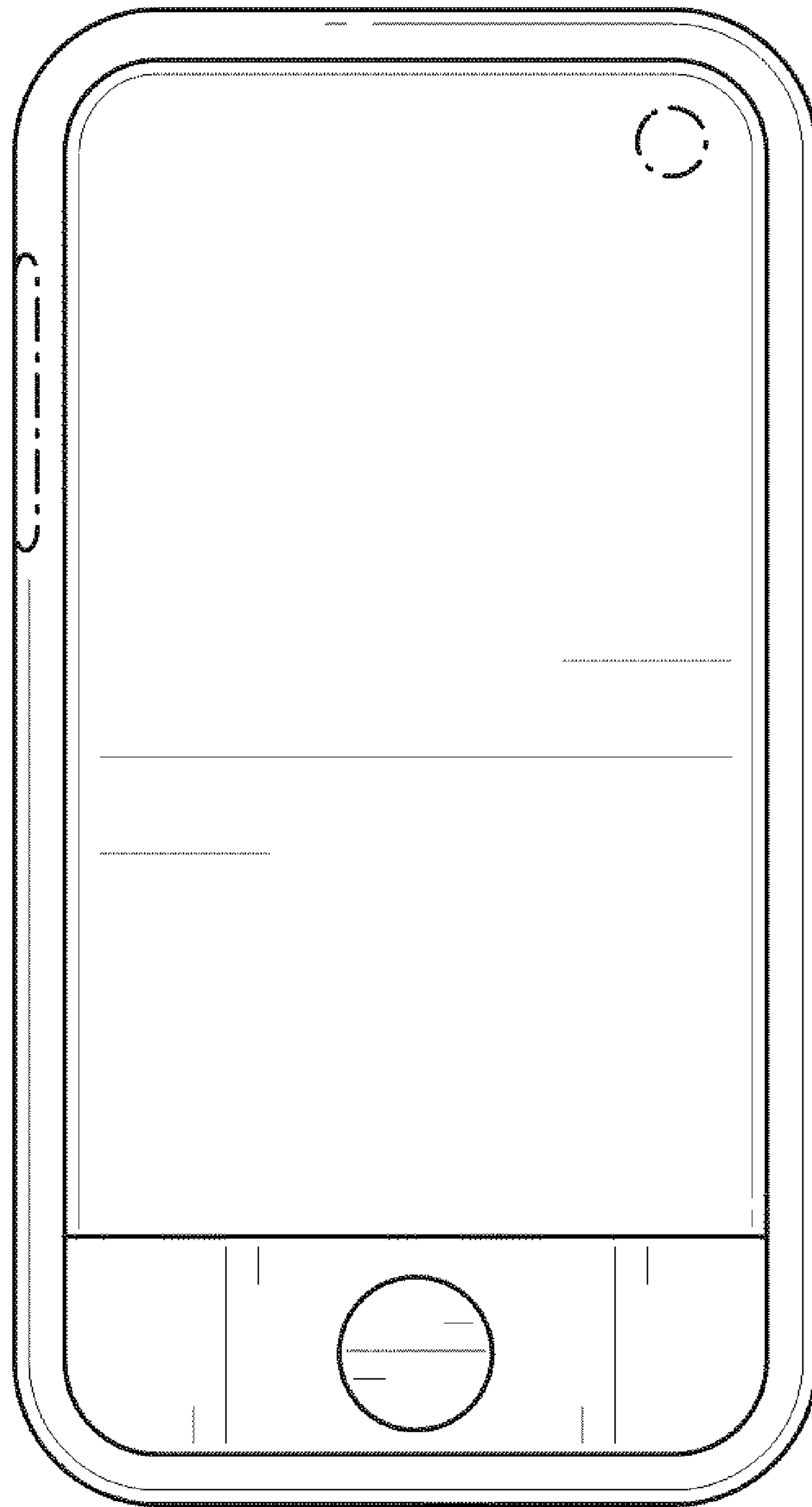

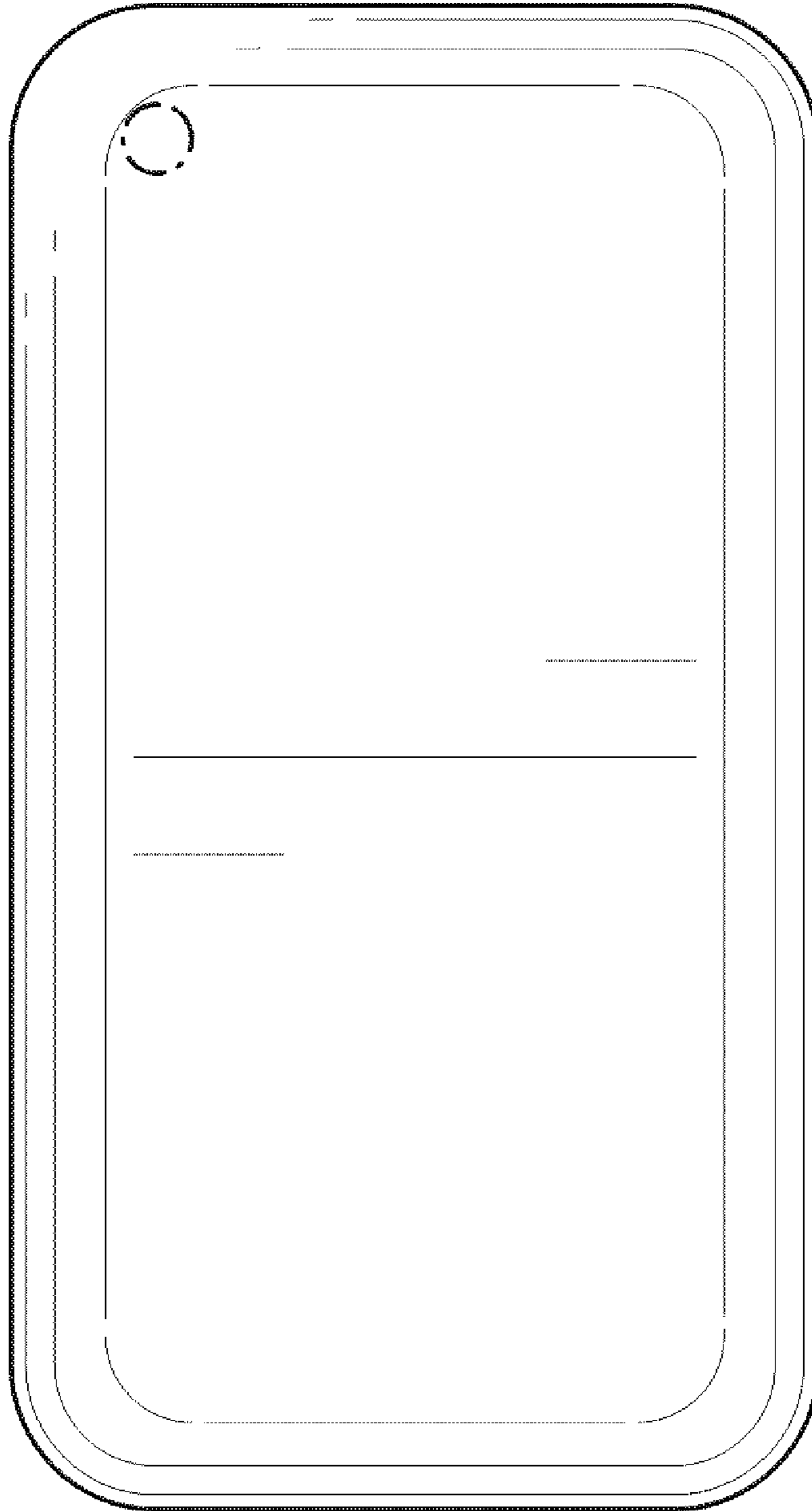

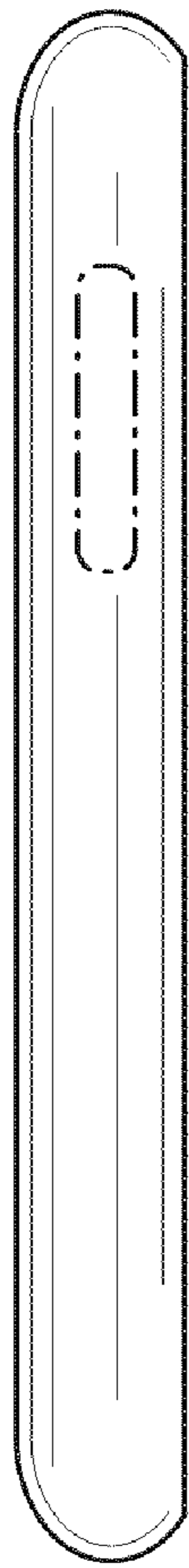

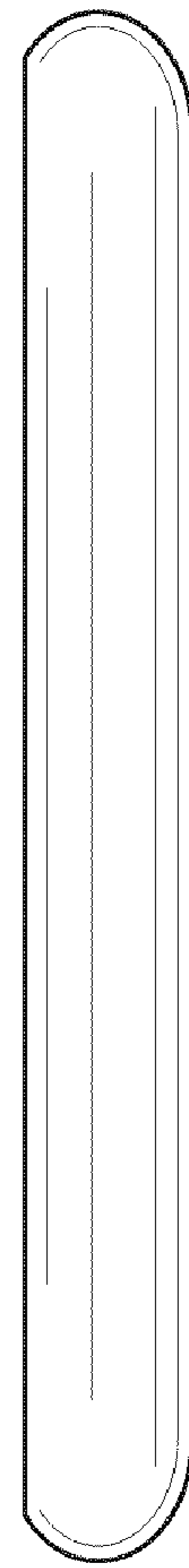

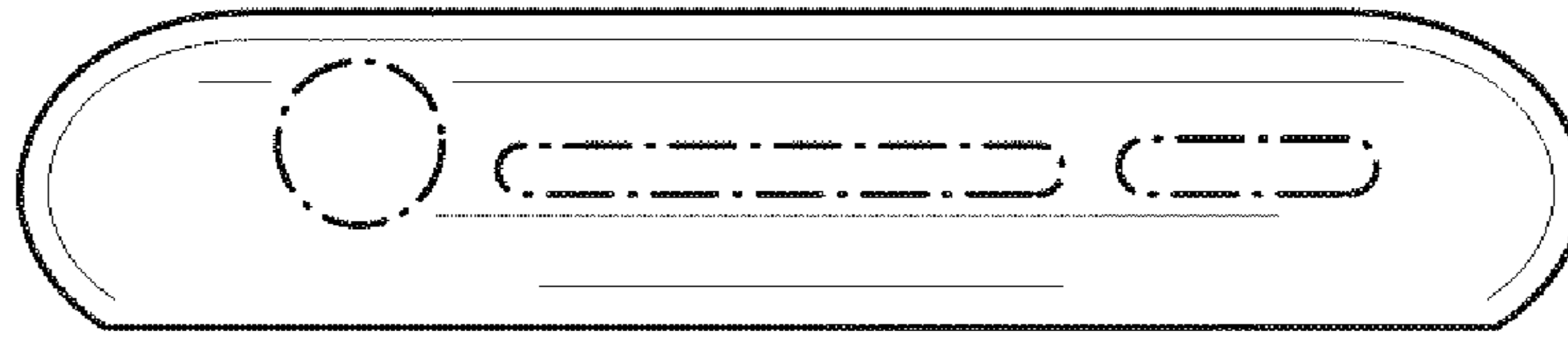

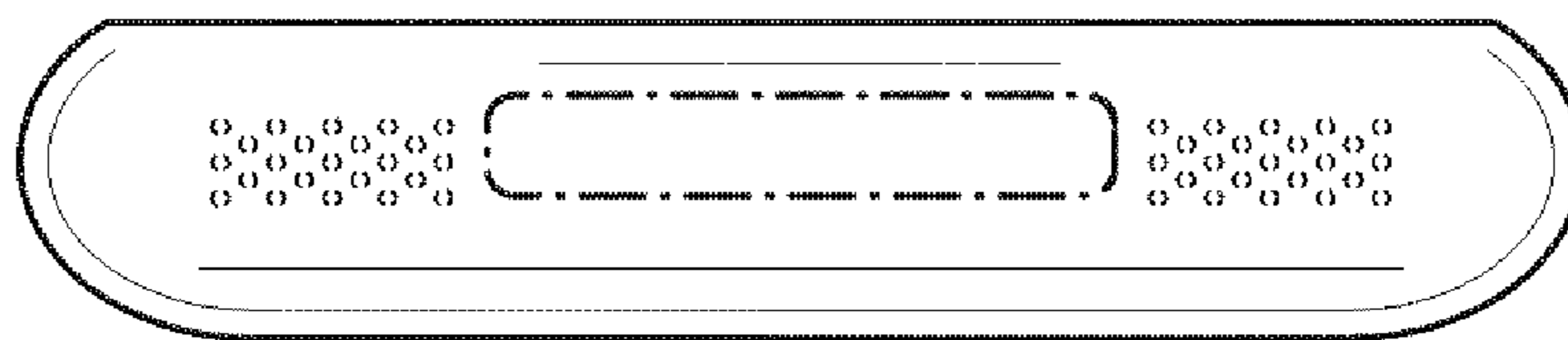
